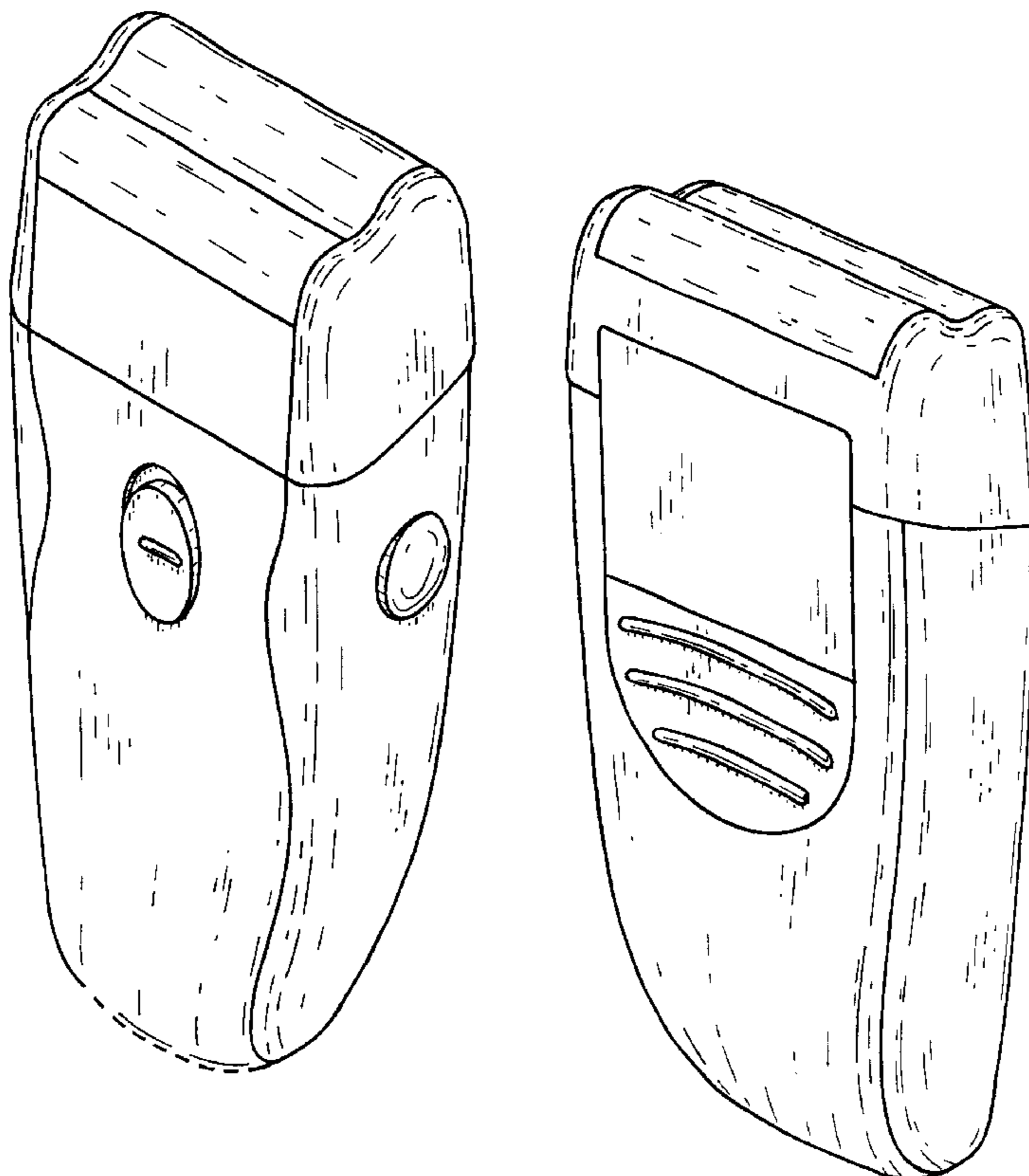
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a front perspective view of the present shaver; FIG. 2 is a rear perspective view of the shaver of FIG. 1; FIG. 3 is a front elevational view thereof; FIG. 4 is a top view thereof; FIG. 5 is a right side view of the present shaver; FIG. 6 is a left side view thereof; FIG. 7 is a rear view of the shaver of FIG. 1; and, FIG. 8 is a bottom view thereof.

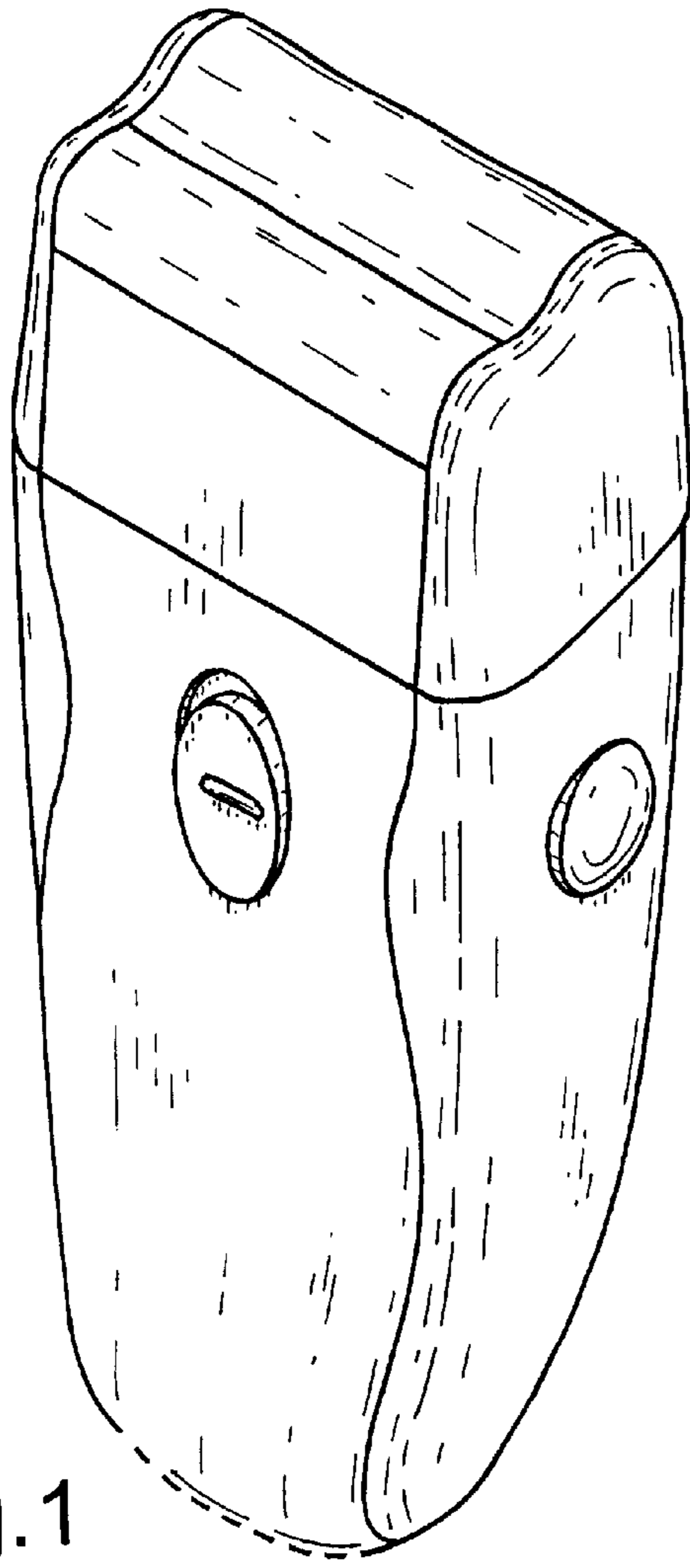

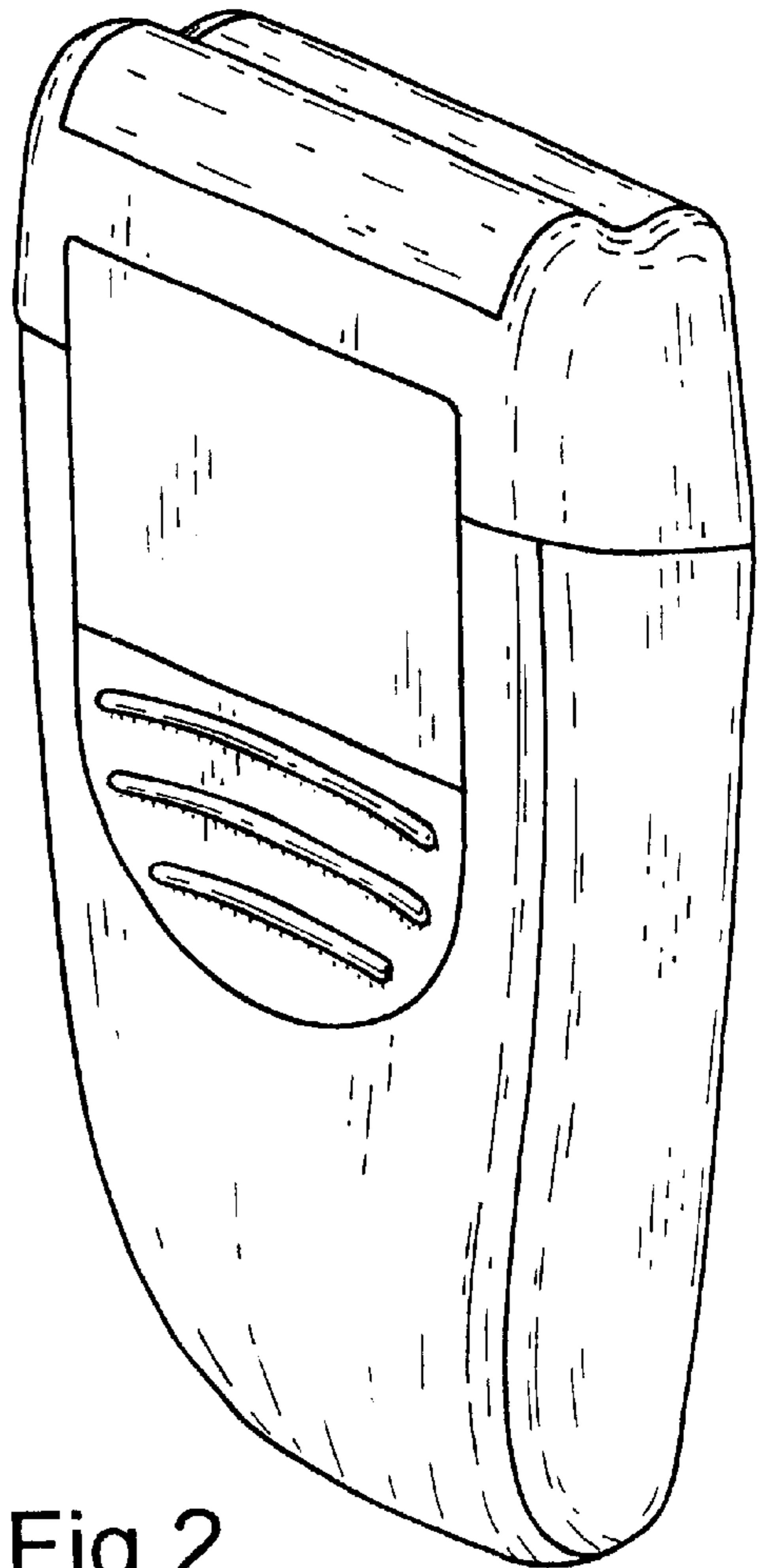

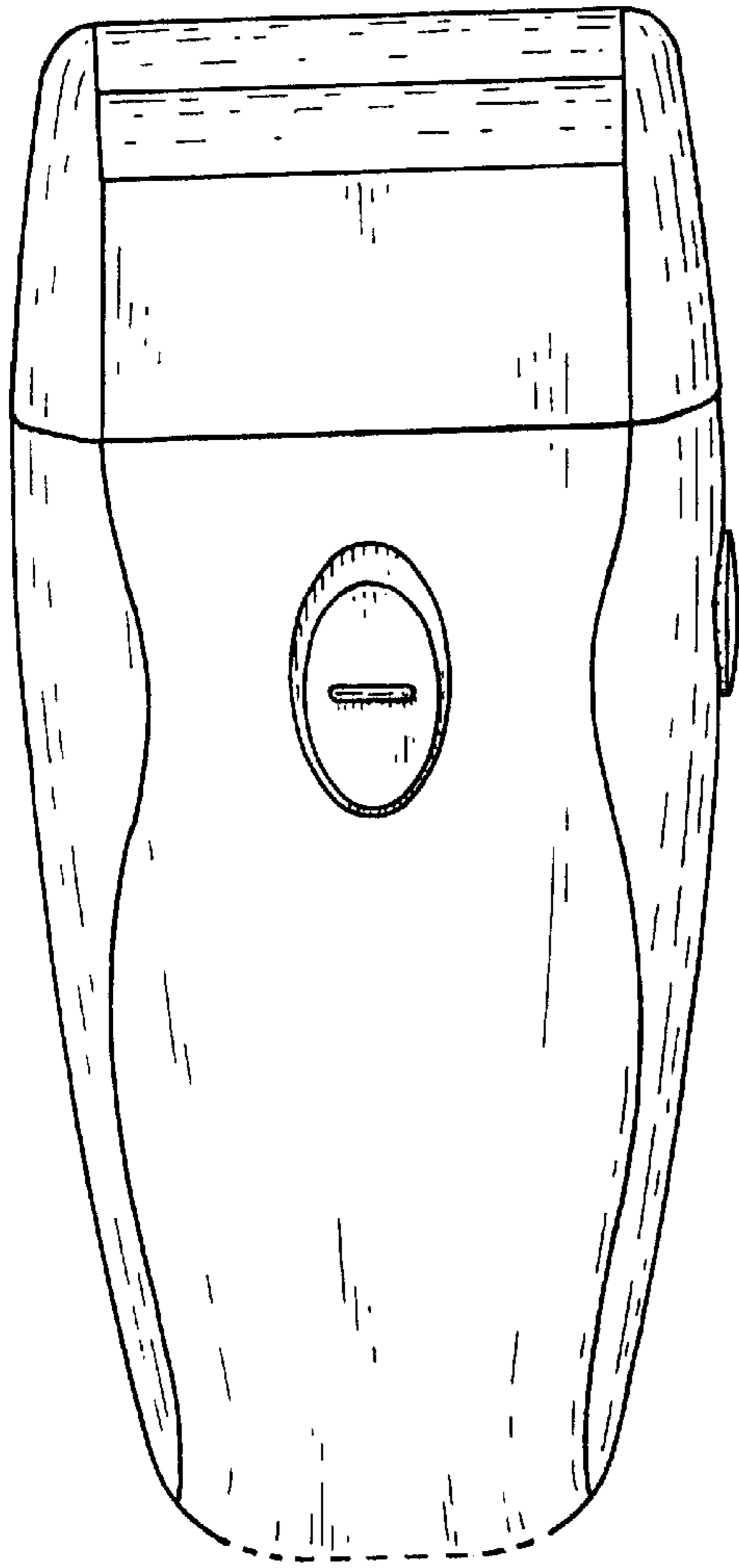

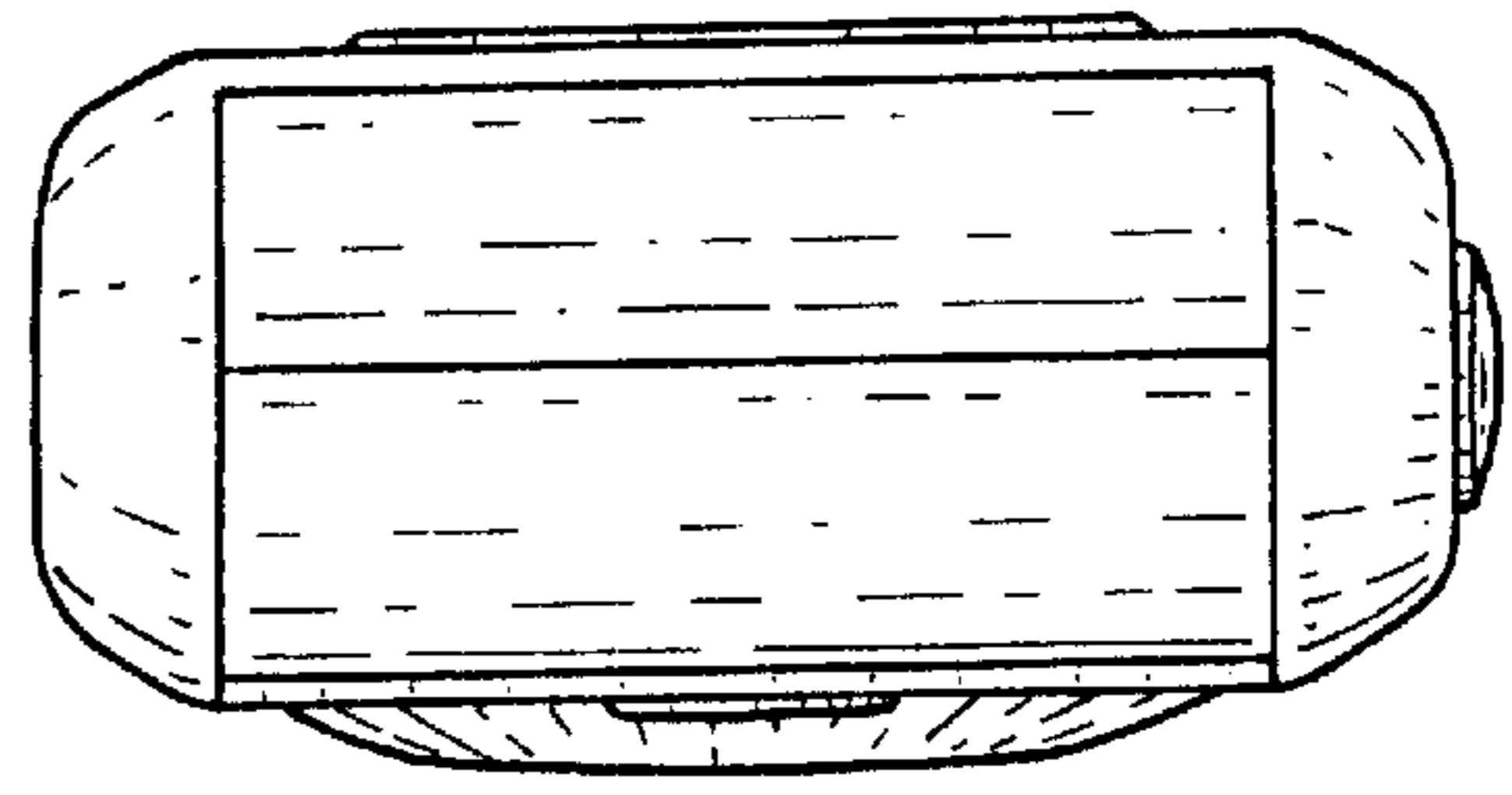

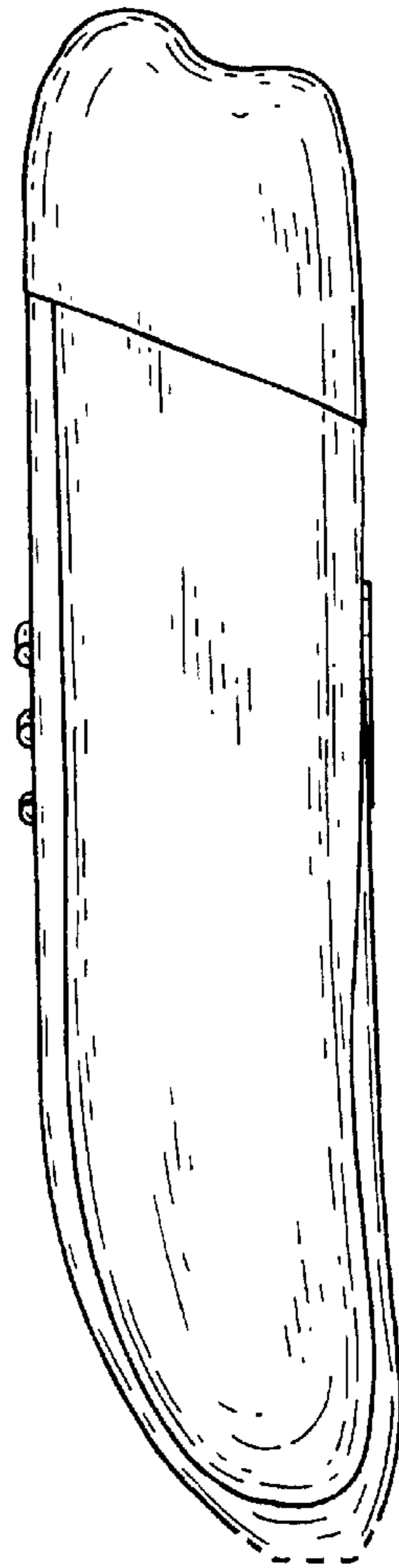

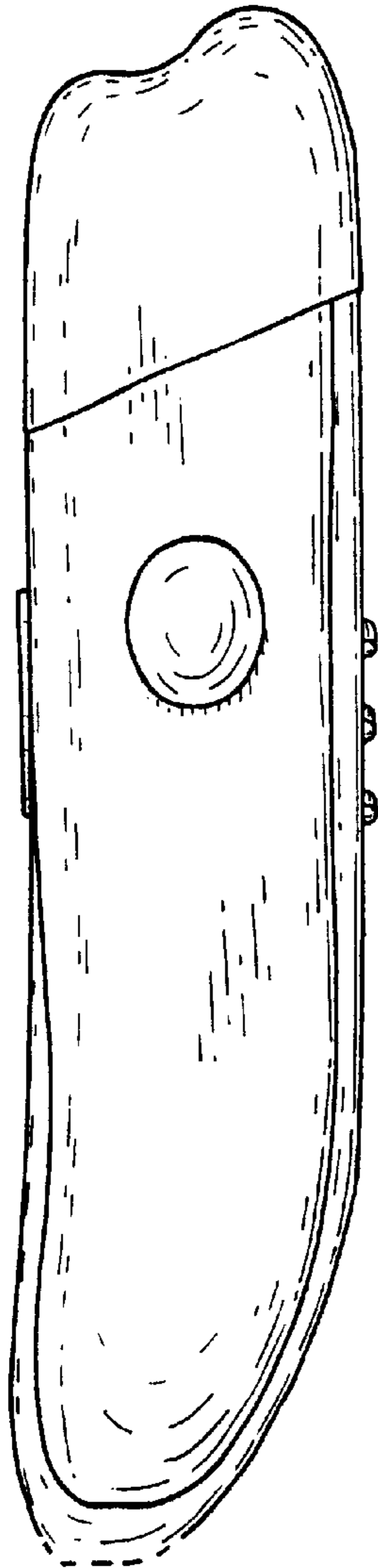

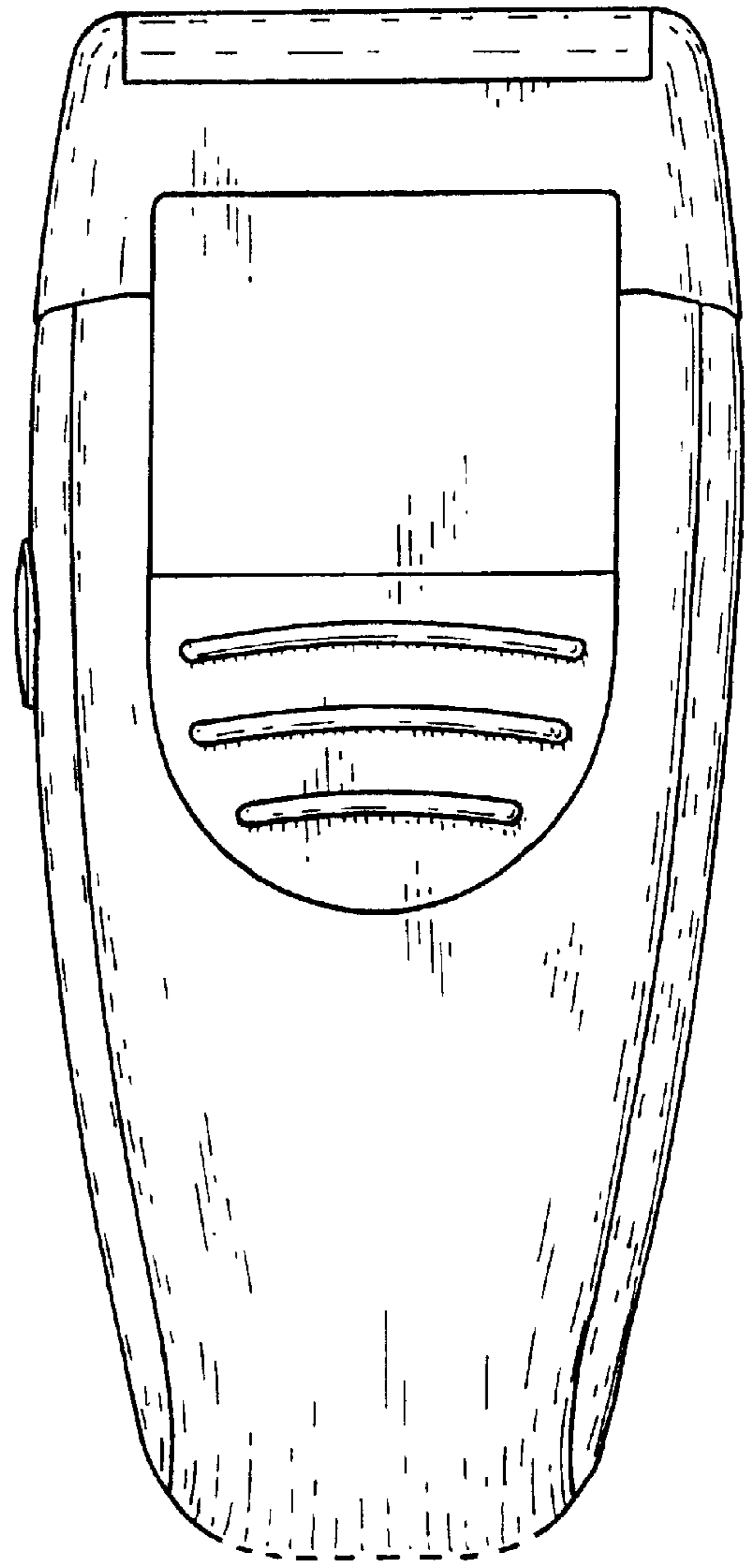

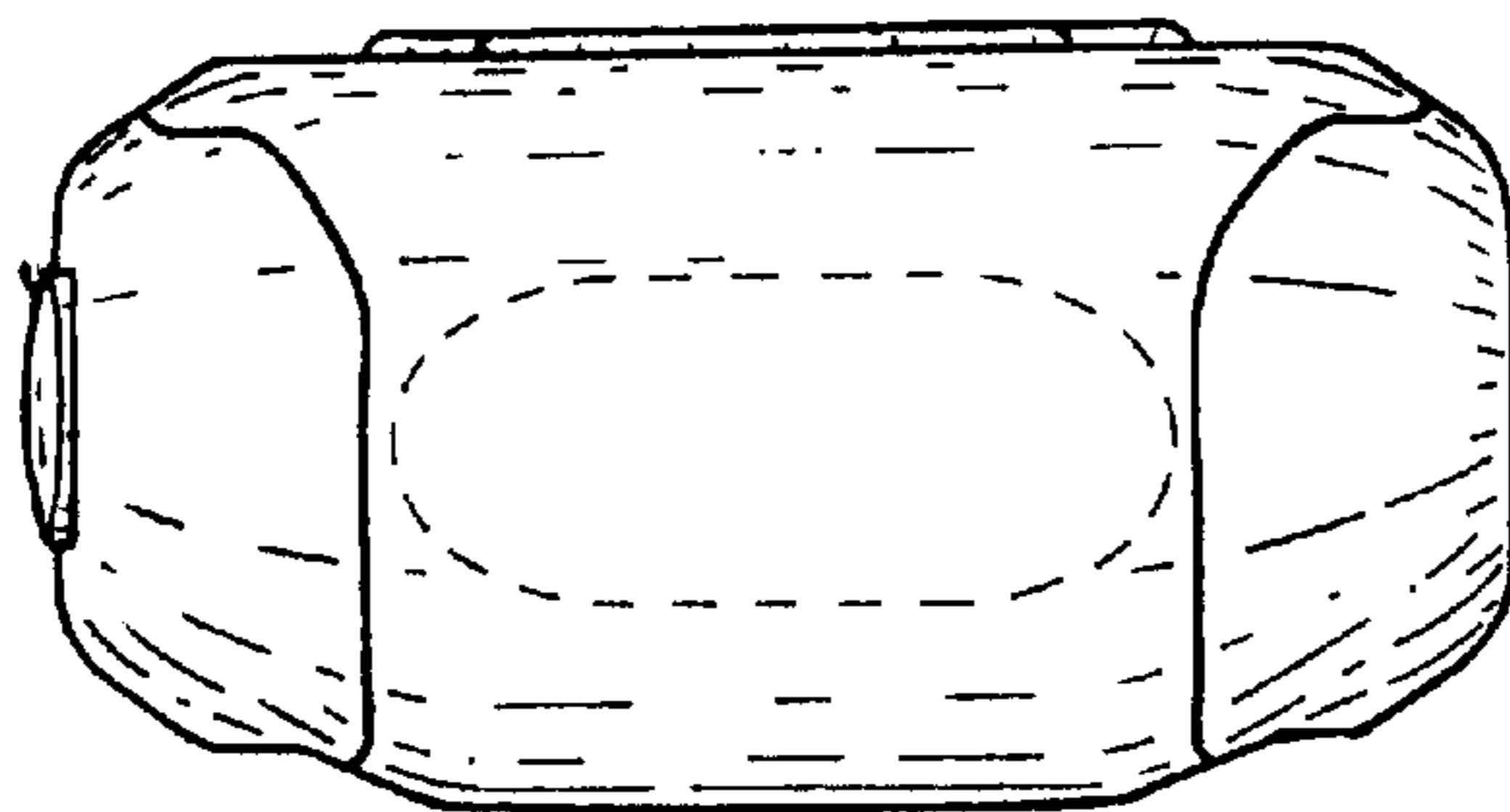
