(57) **CLAIM**

An ornamental design for a candy cane with pouch combination, as shown and described.

DESCRIPTION

FIG. 1 is a front elevation view of a candy cane with pouch combination;

FIG. 2 is a front plan view of the candy cane with pouch combination shown in FIG. 1;

FIG. 3 is a rear plan view of the candy cane with pouch combination shown in FIG. 1;

FIG. 4 is a side view of the candy cane with pouch combination shown in FIG. 1;

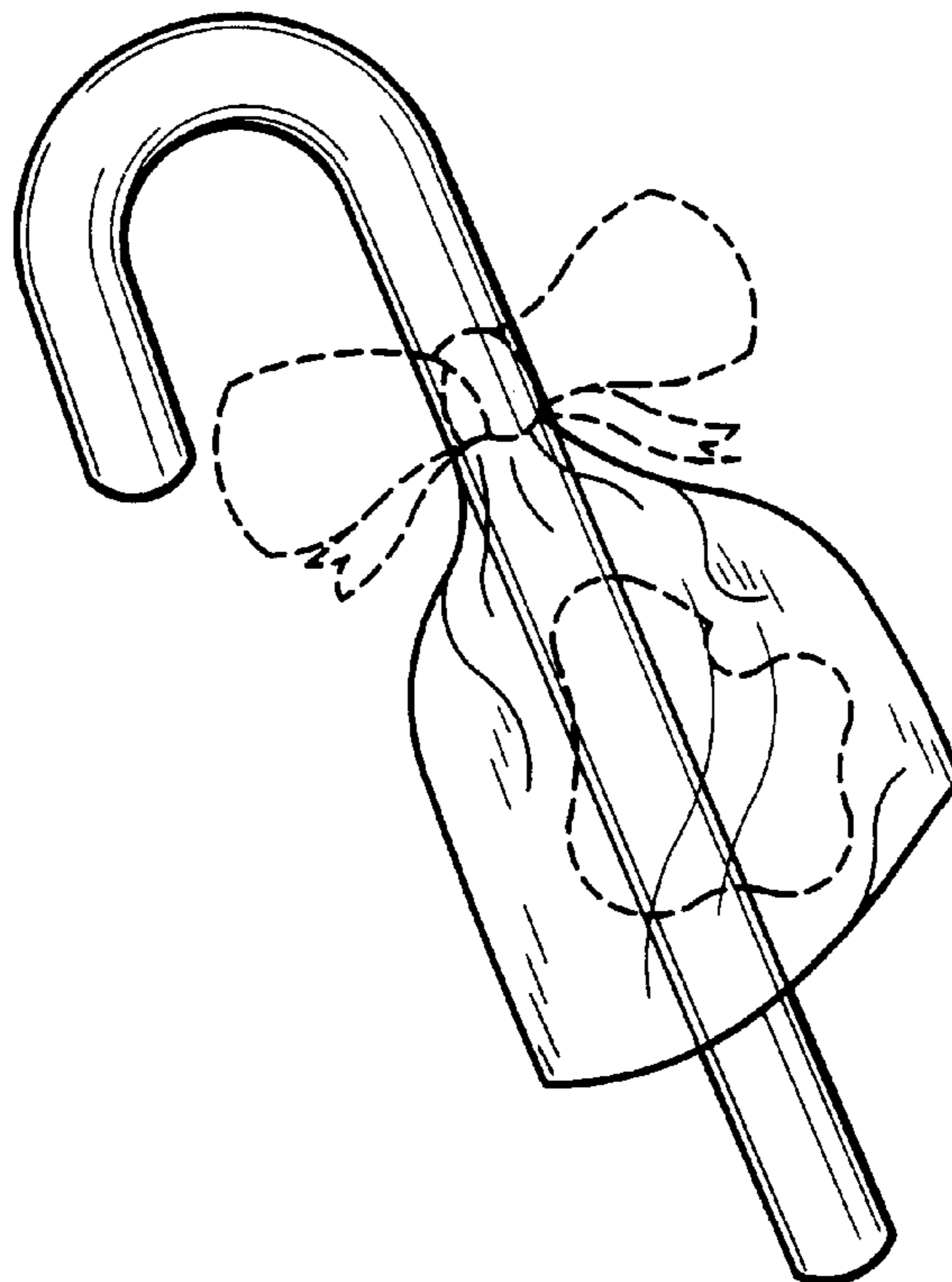
FIG. 5 is the opposing side of the view of the candy cane with pouch combination shown in FIG. 4;

FIG. 6 is a top view of the candy cane with pouch combination shown in FIG. 1; and,

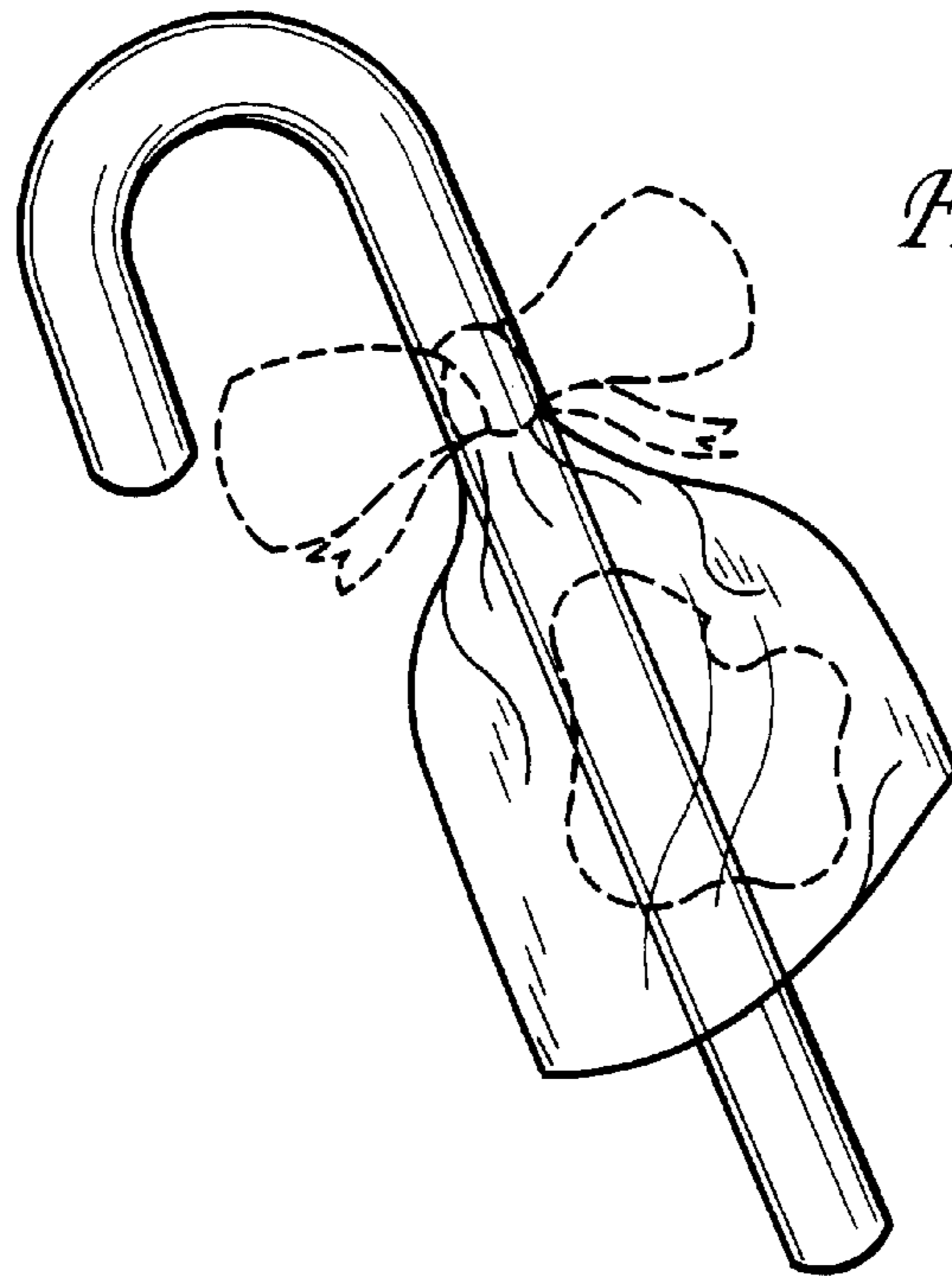

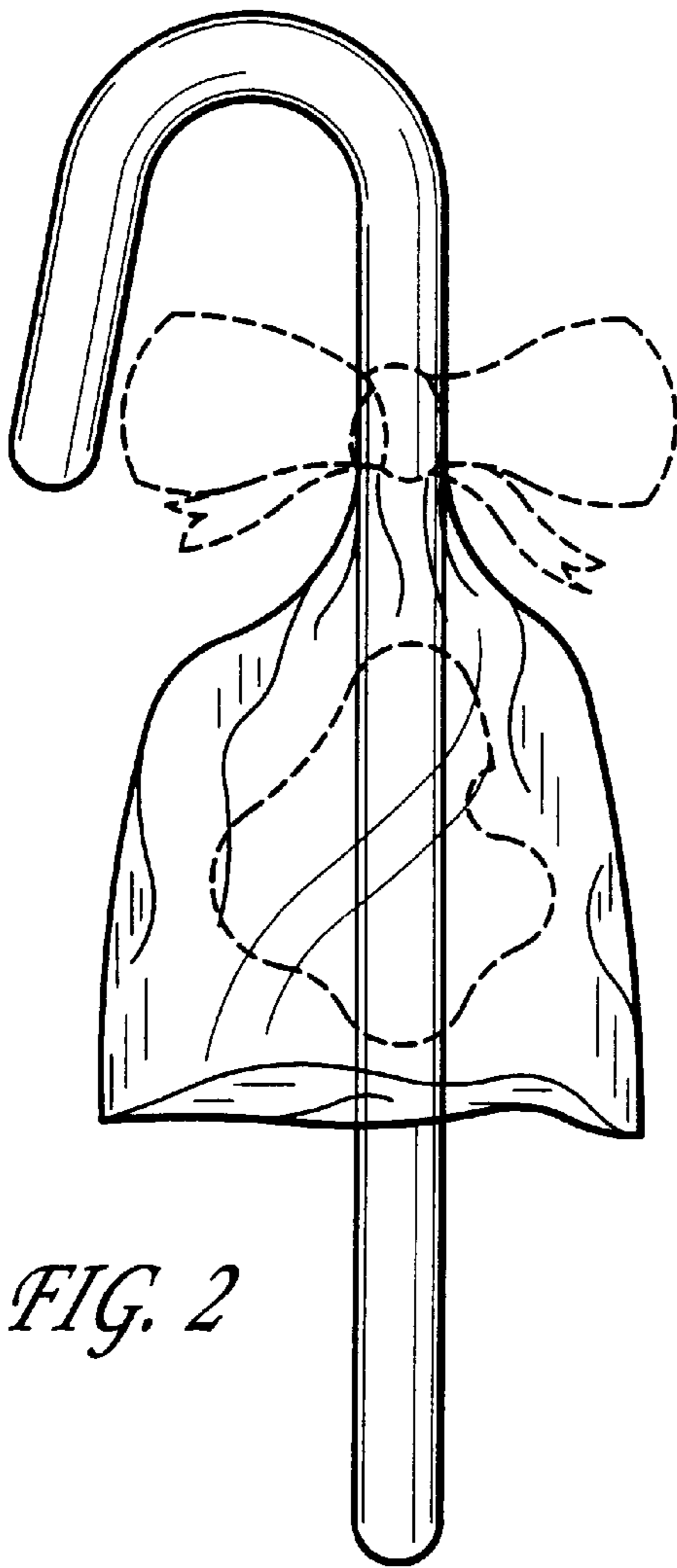

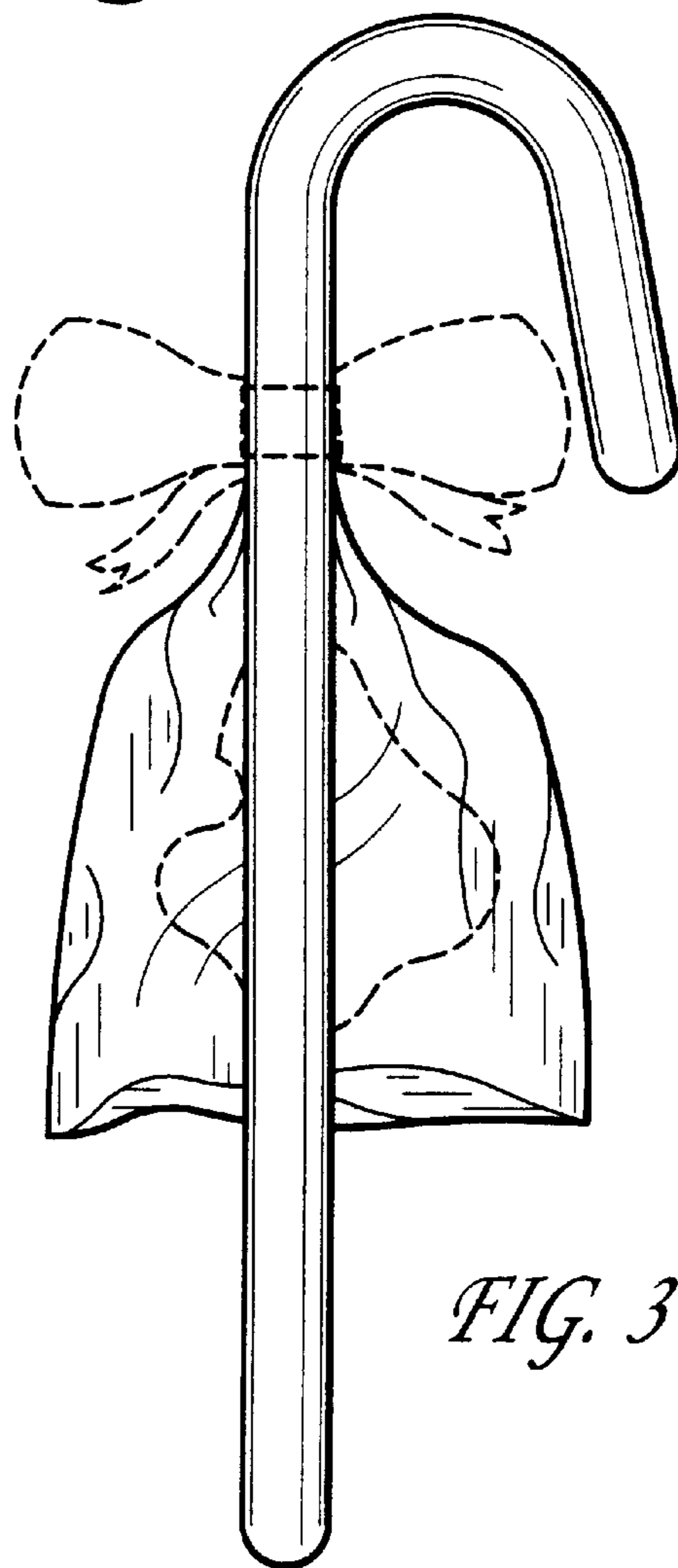

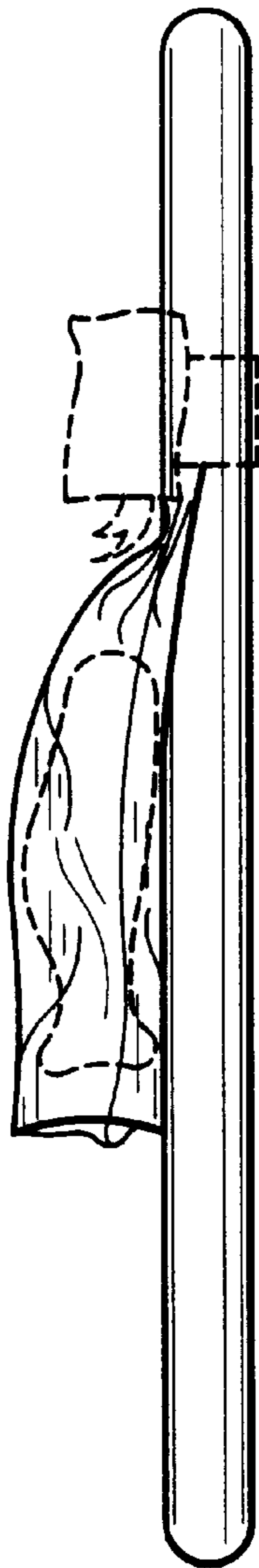

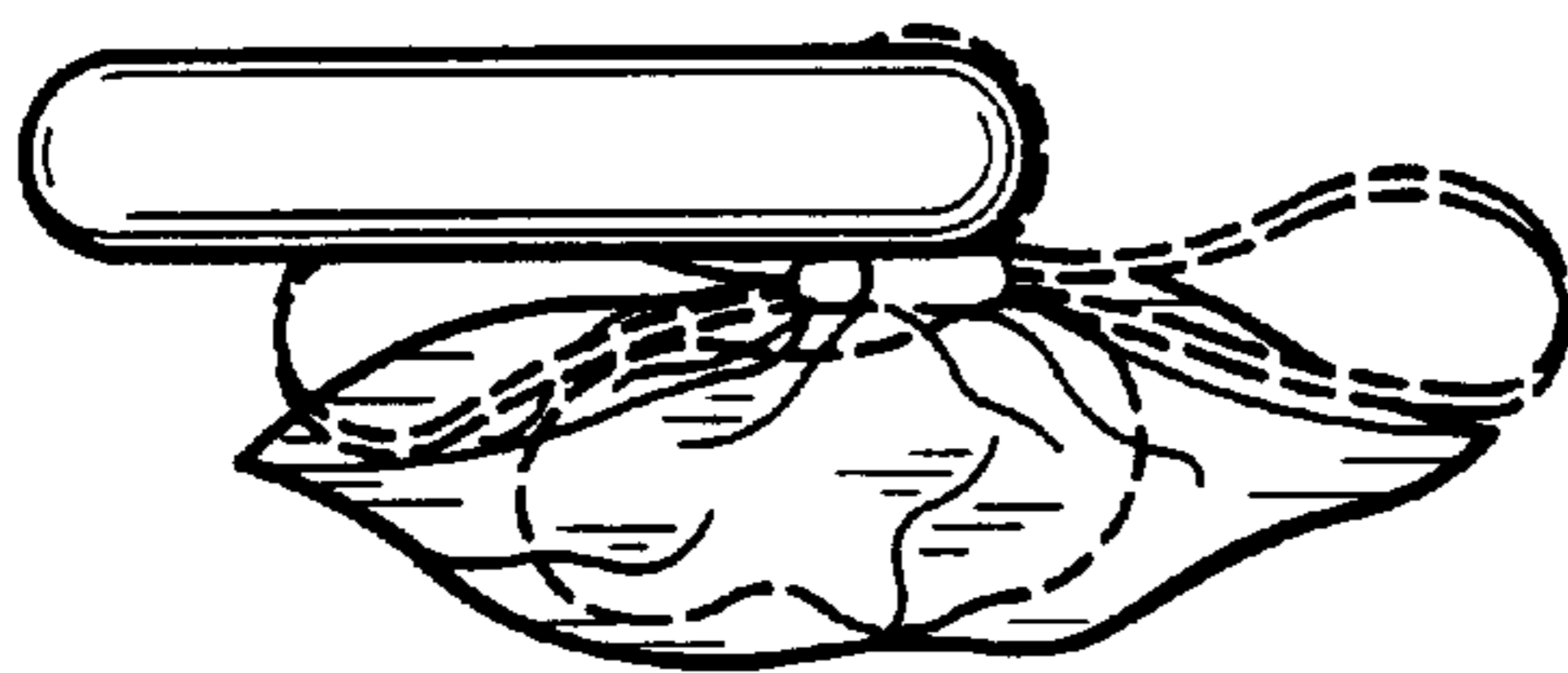

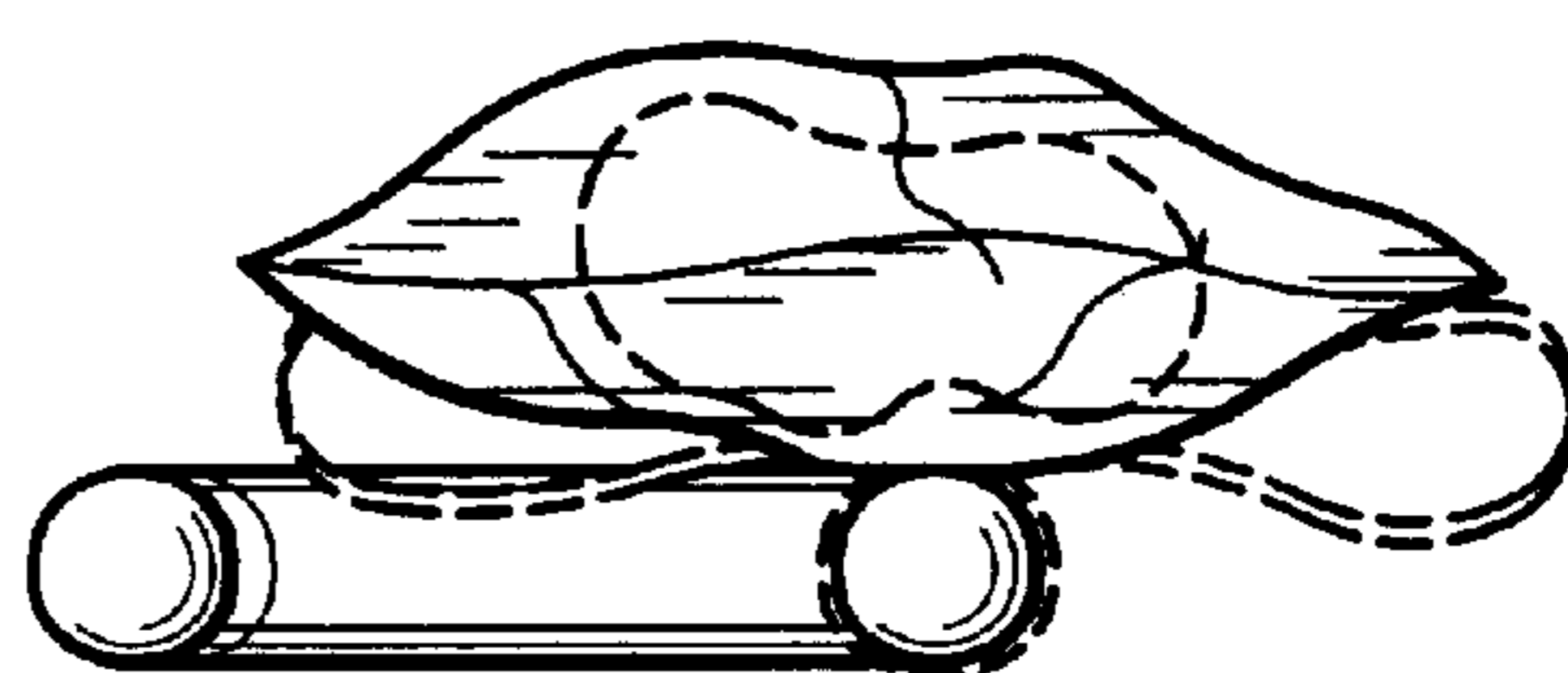
