FIG. 2 is a top view of a ground coffee dispenser, in accordance with the present invention.

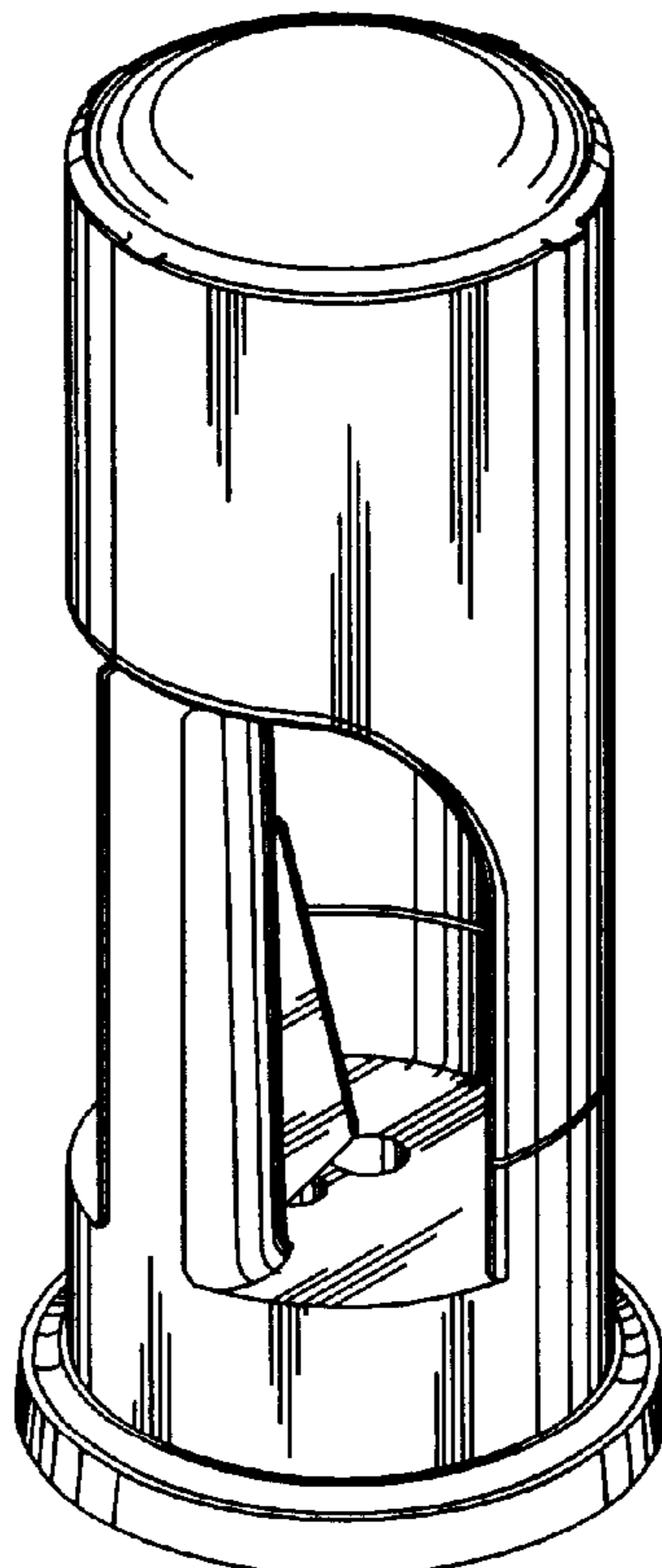
FIG. 3 is a front view of a ground coffee dispenser, in accordance with the present invention.

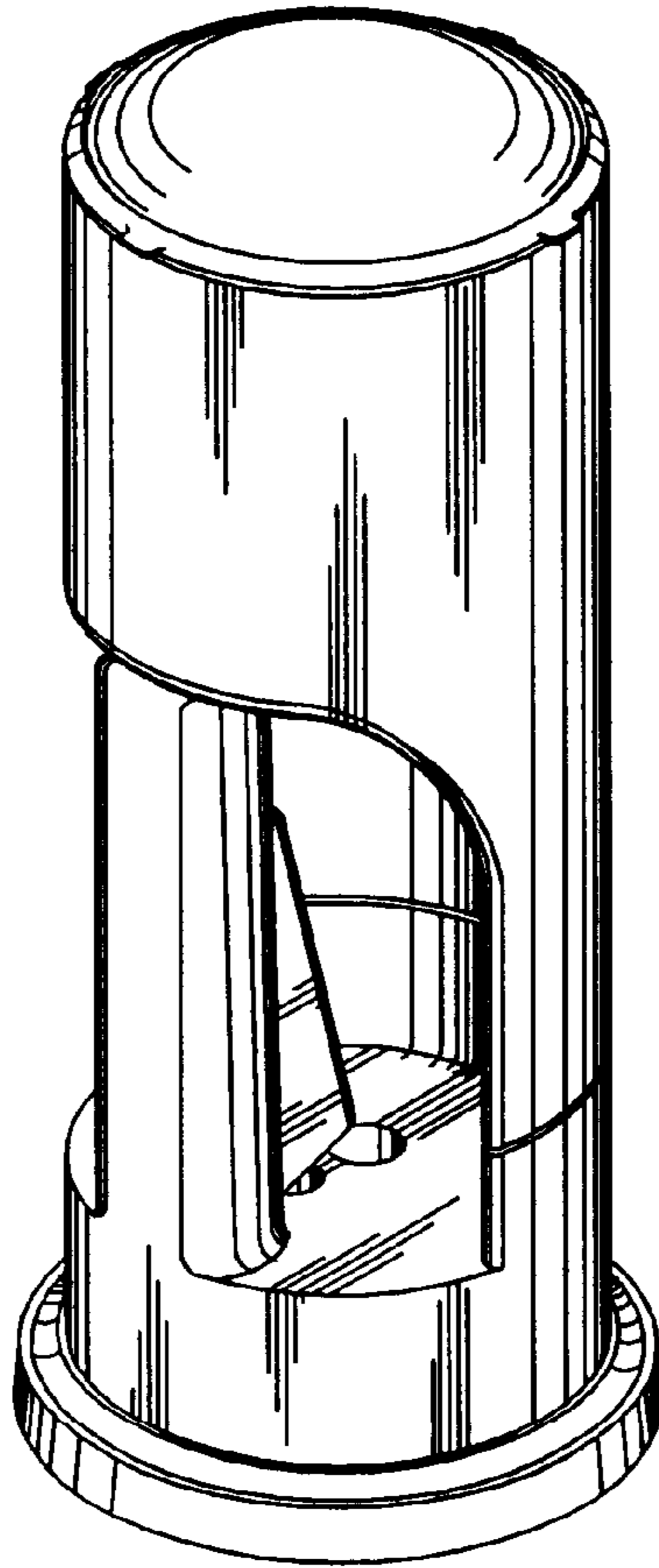

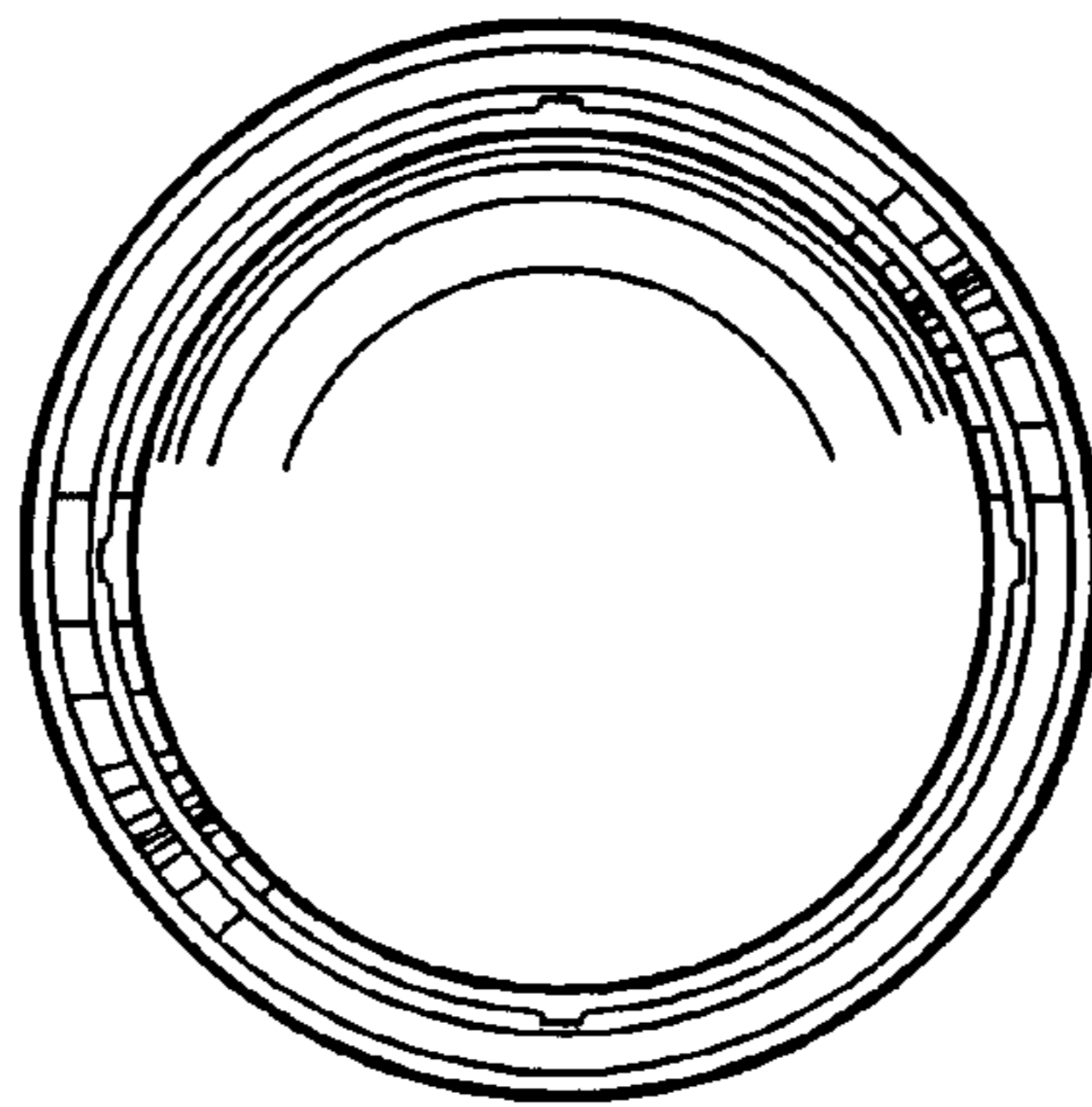

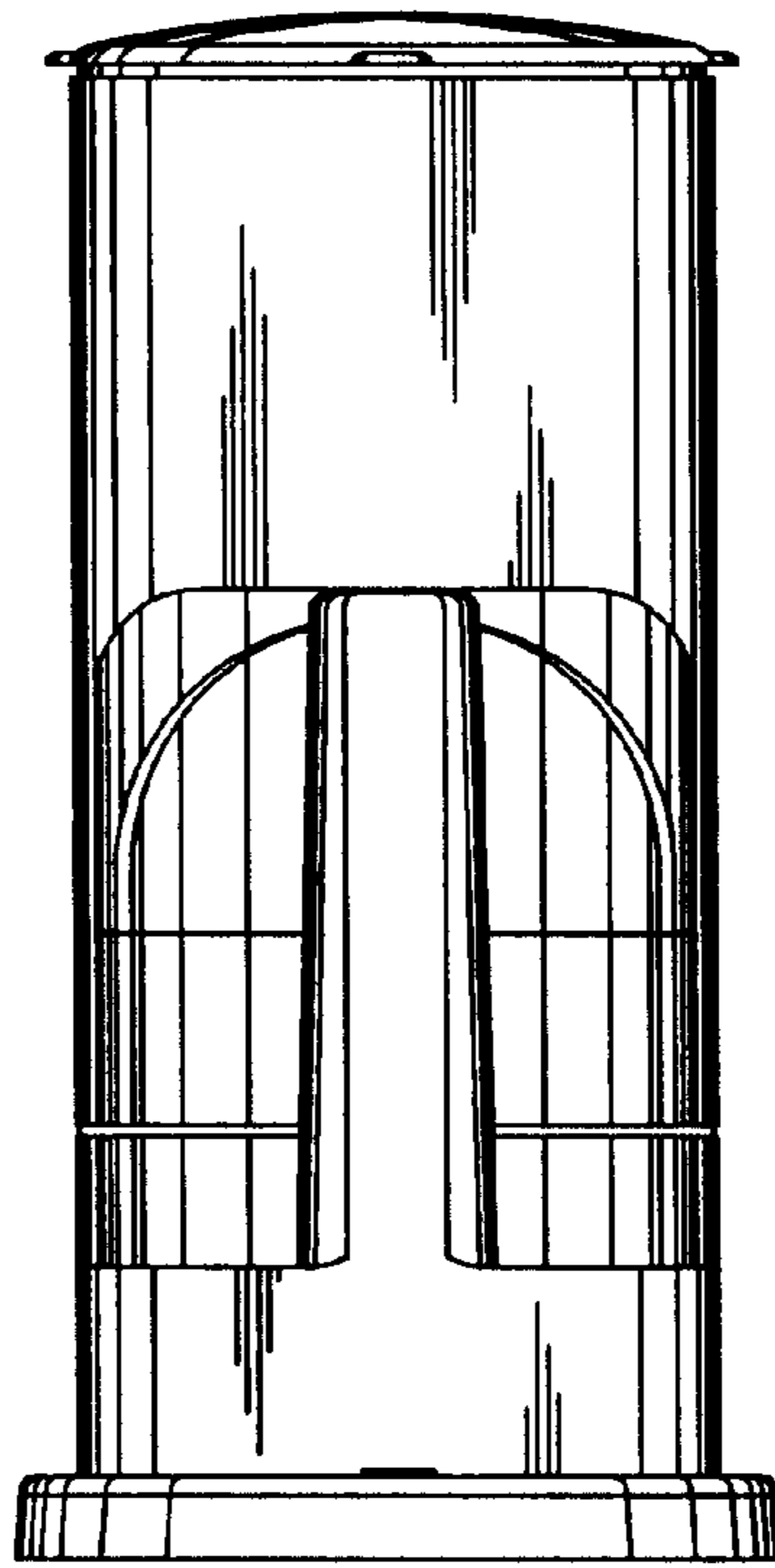

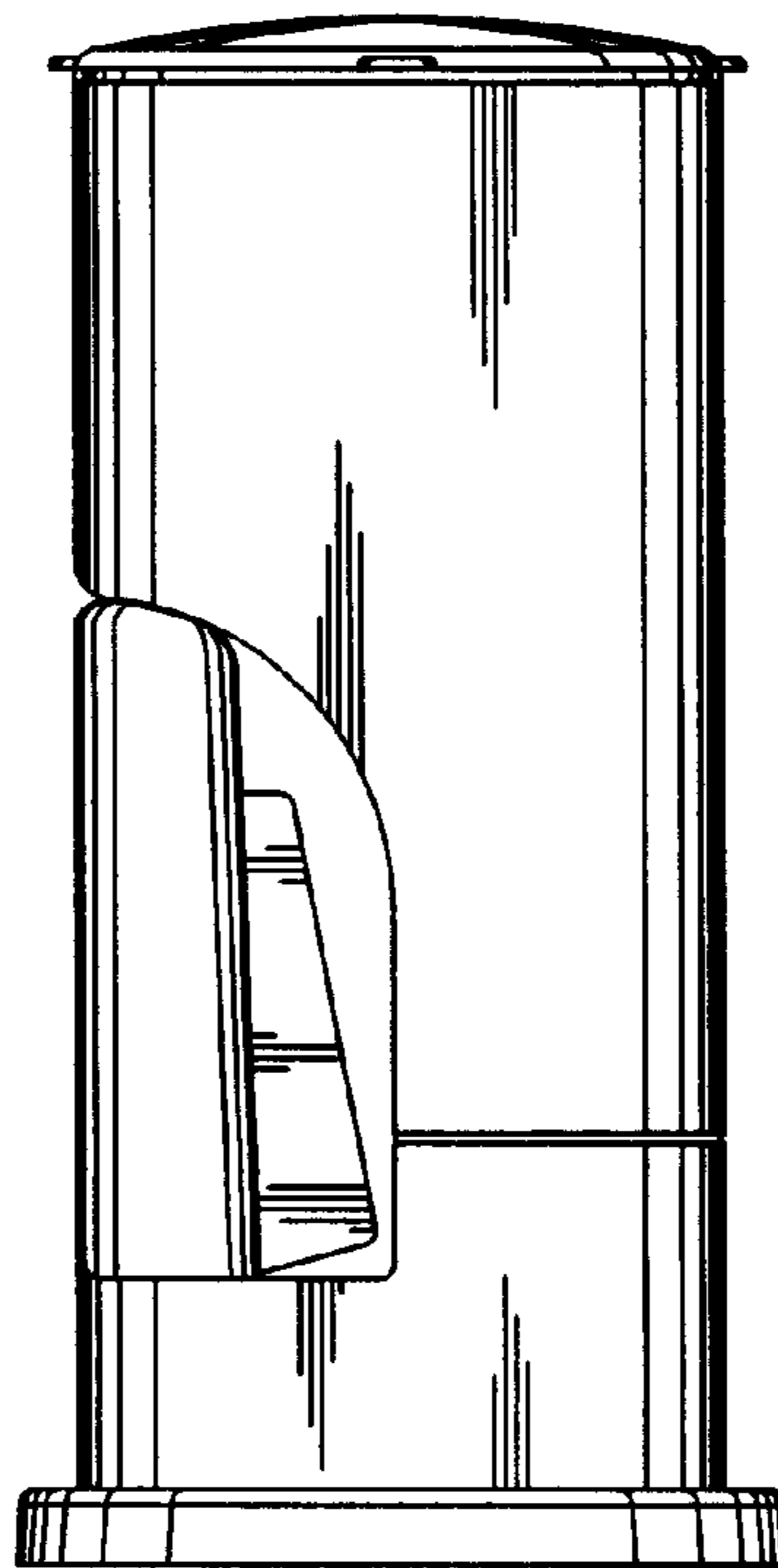

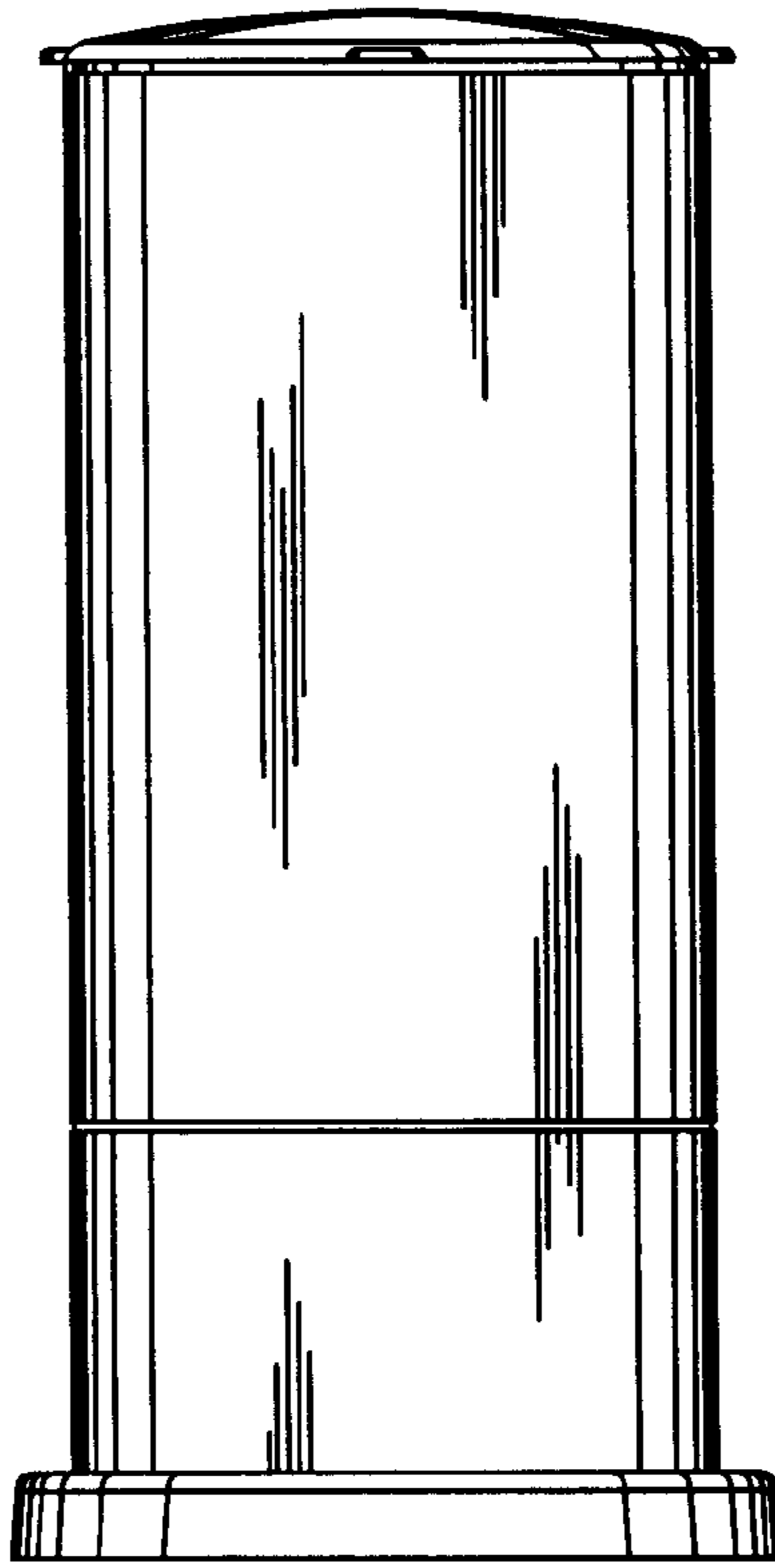

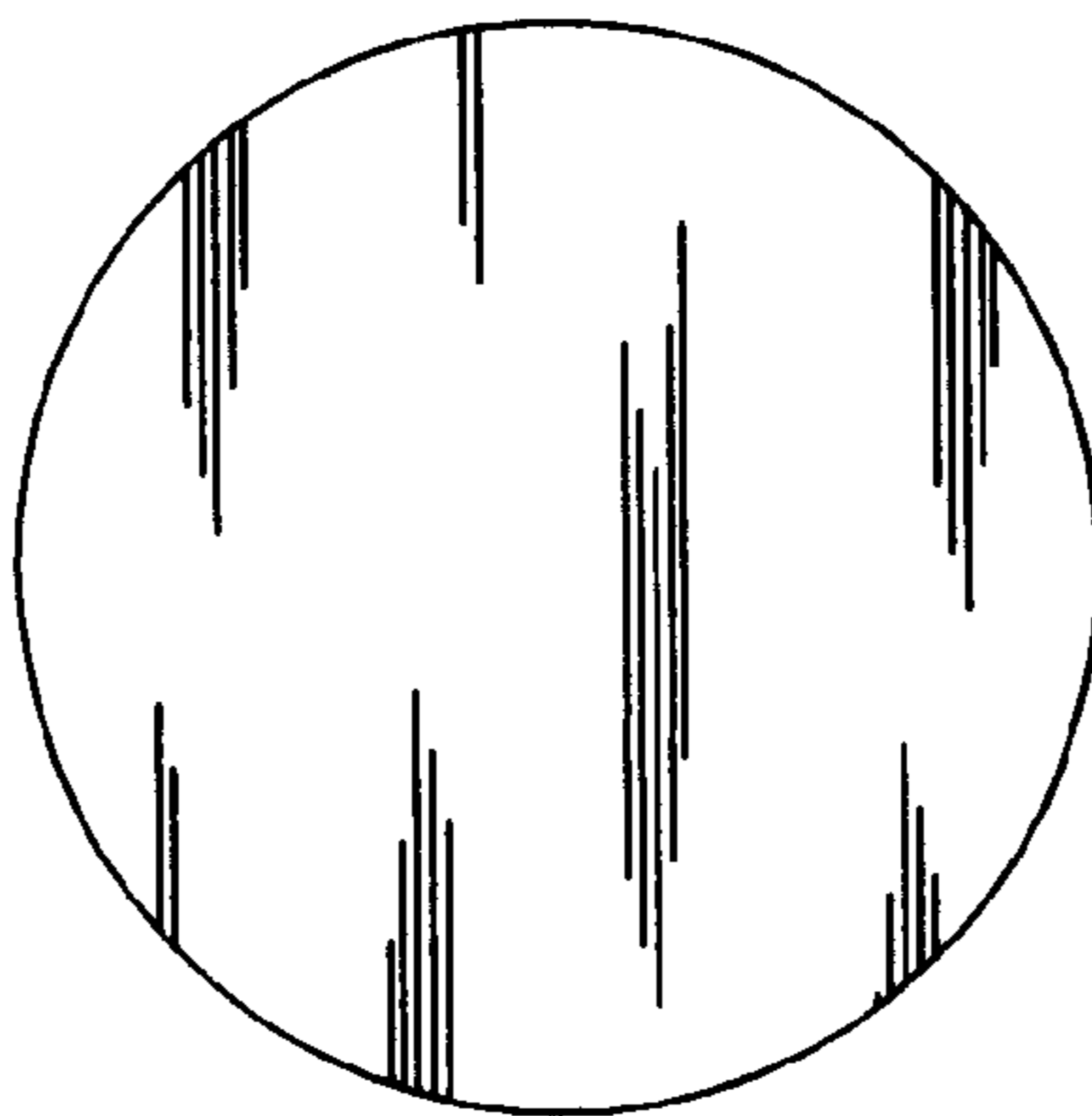
