FIG. 6 is a top view thereof.

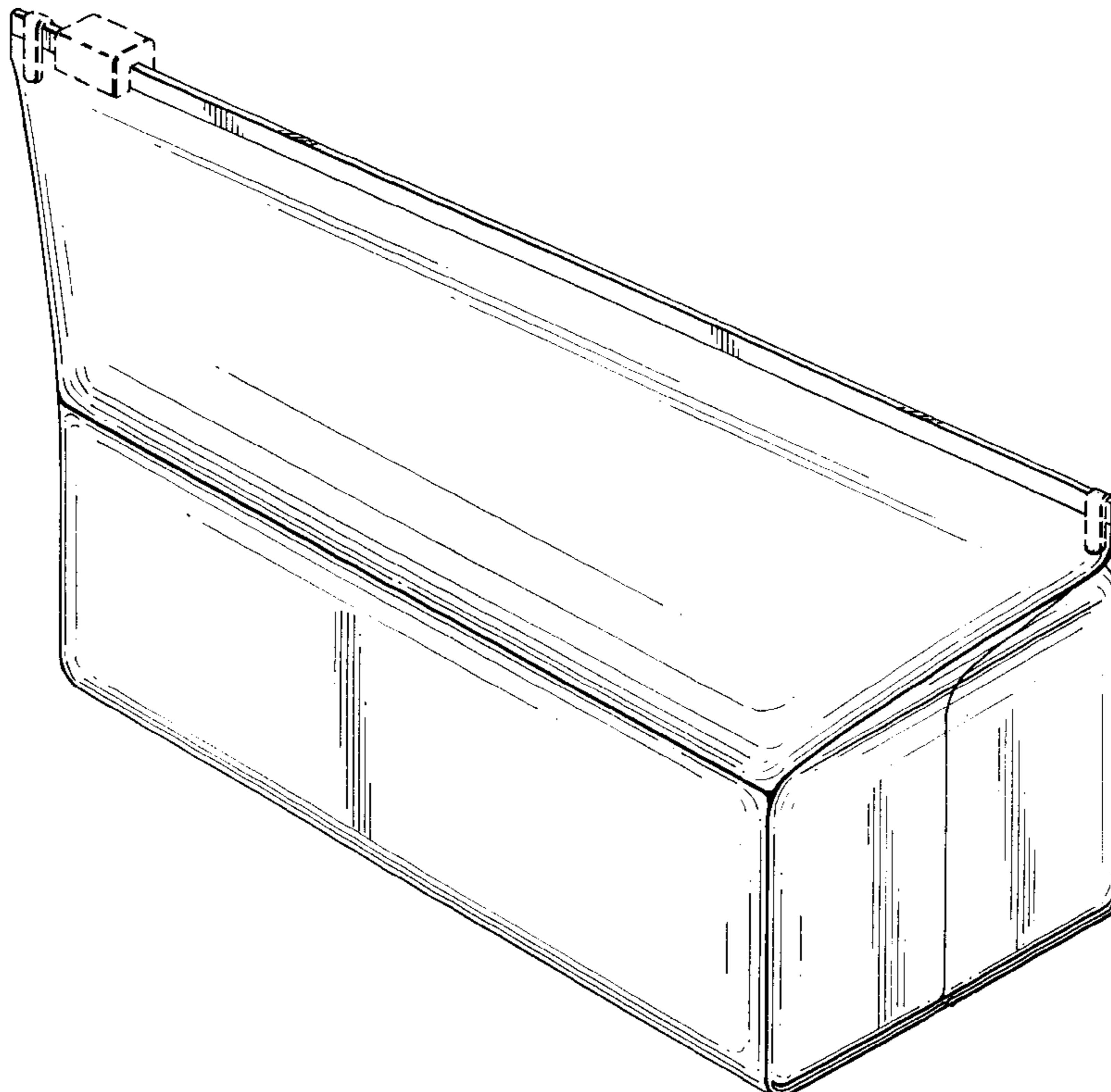
FIG. 7 is a bottom view thereof.

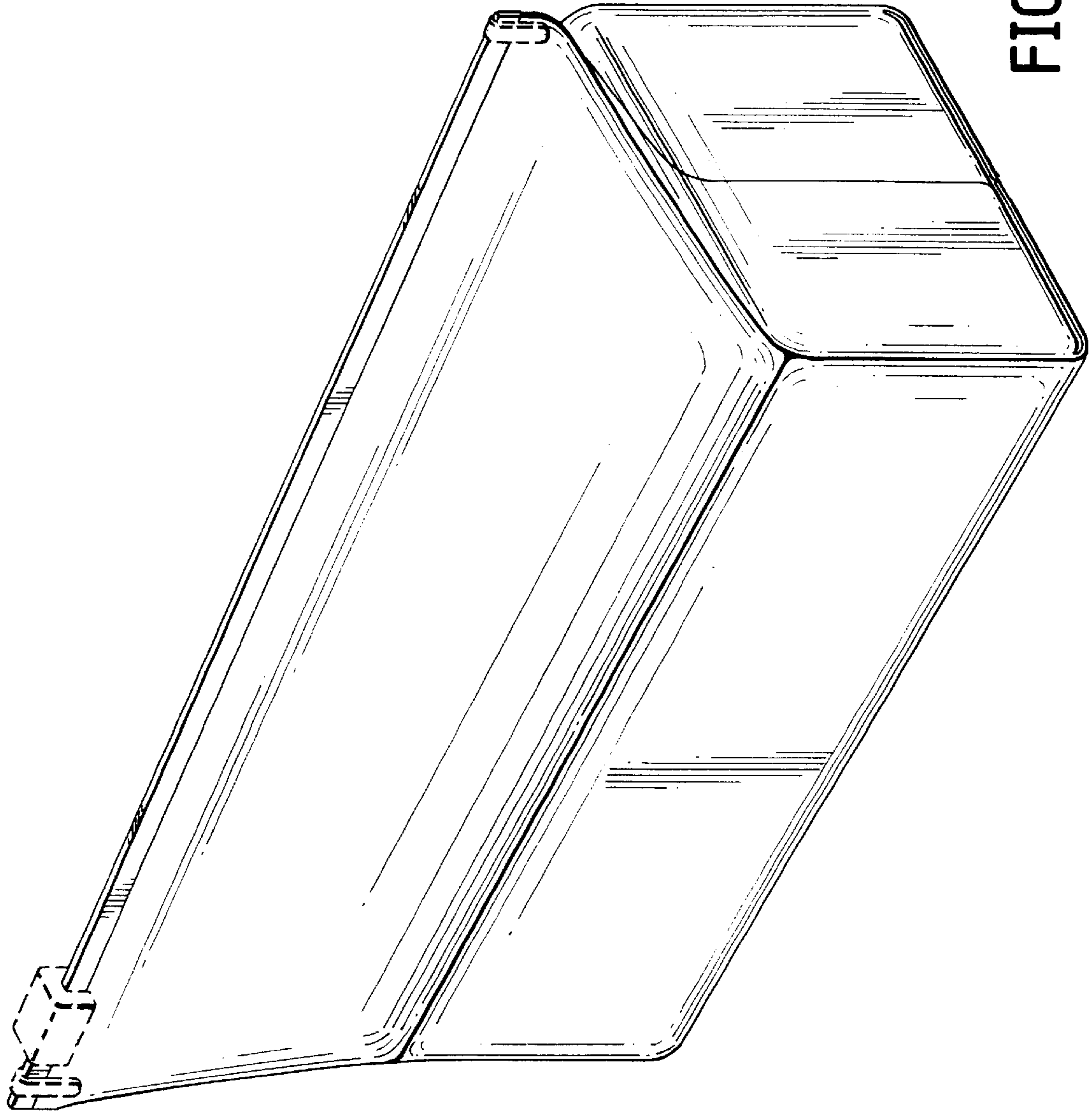

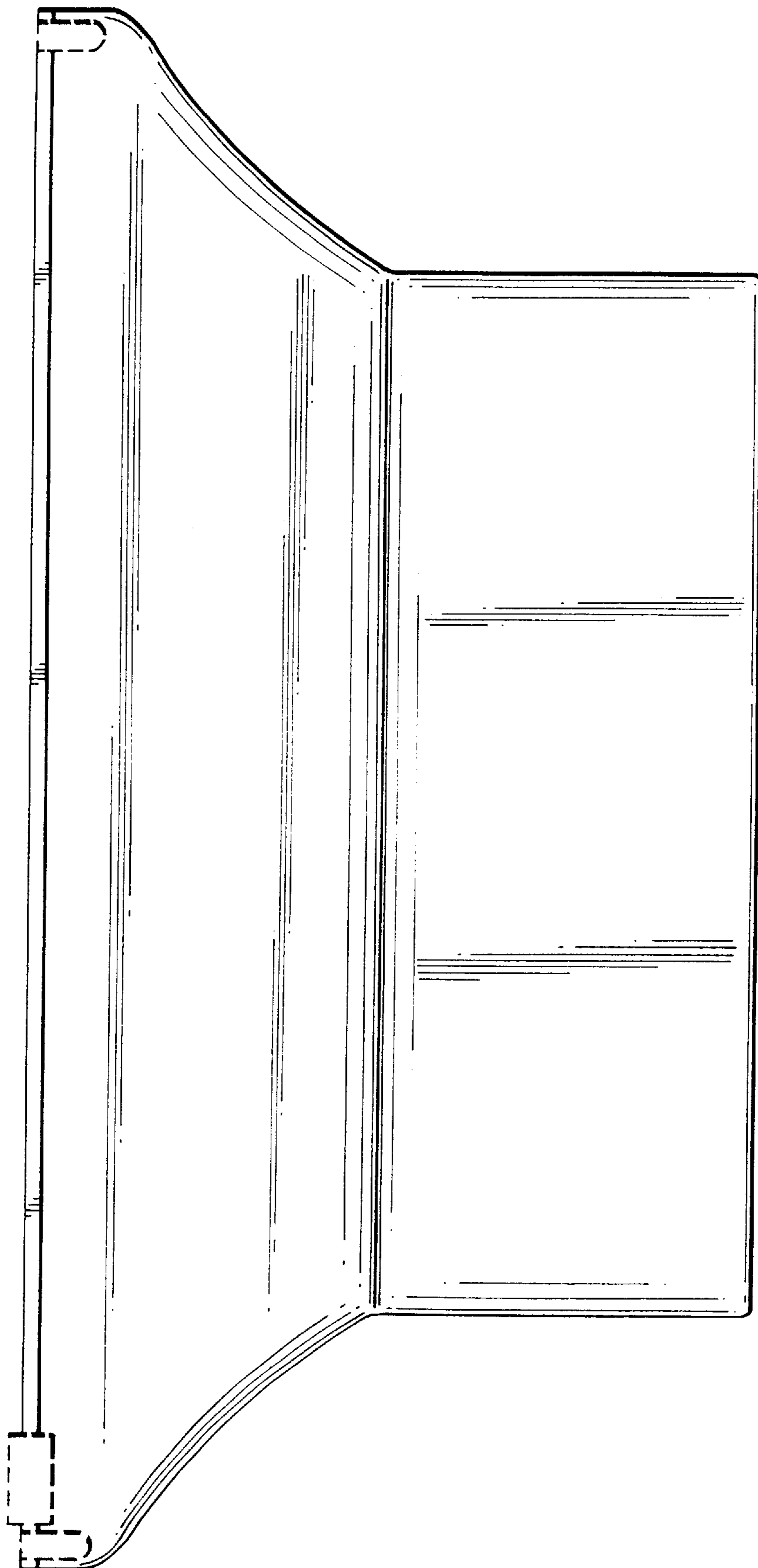

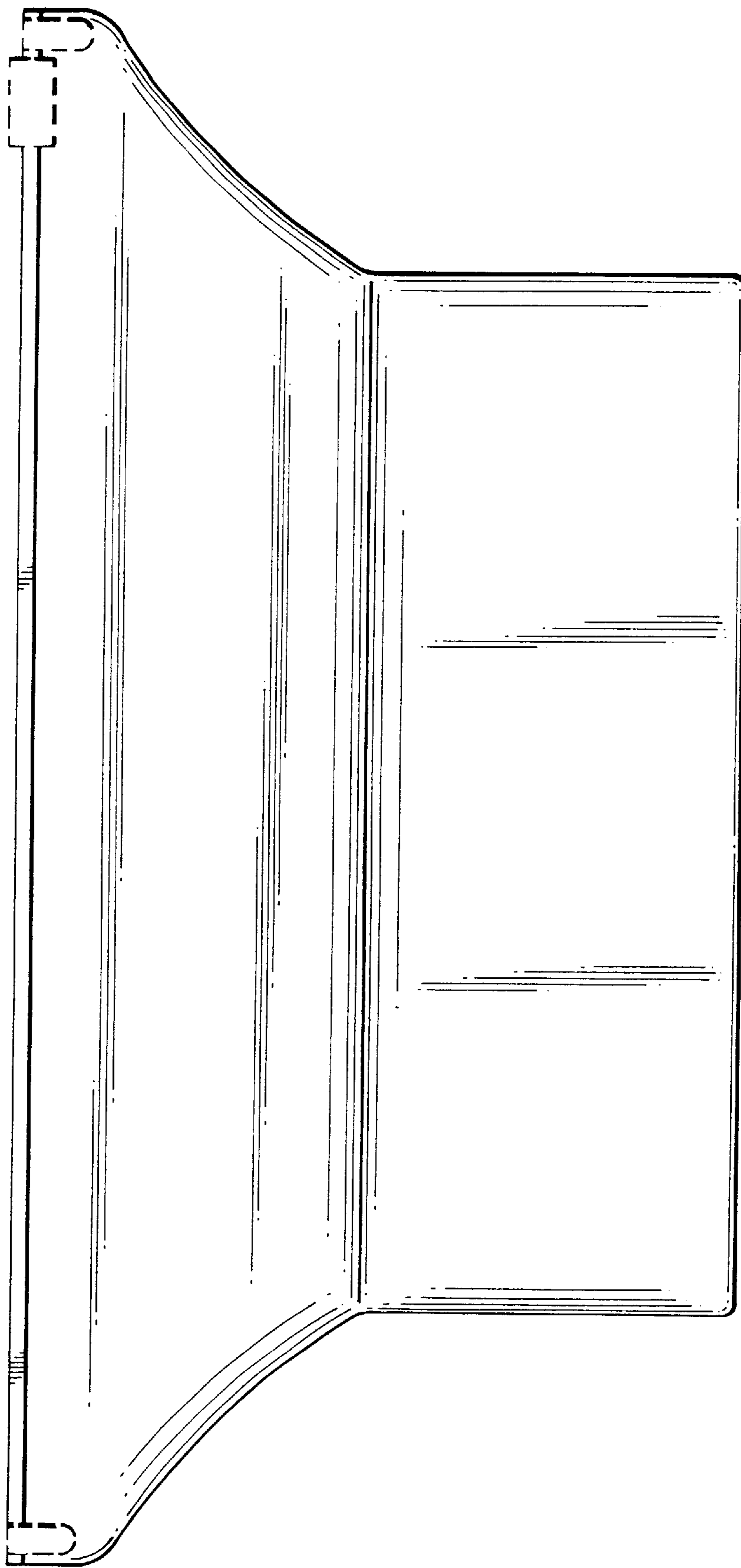

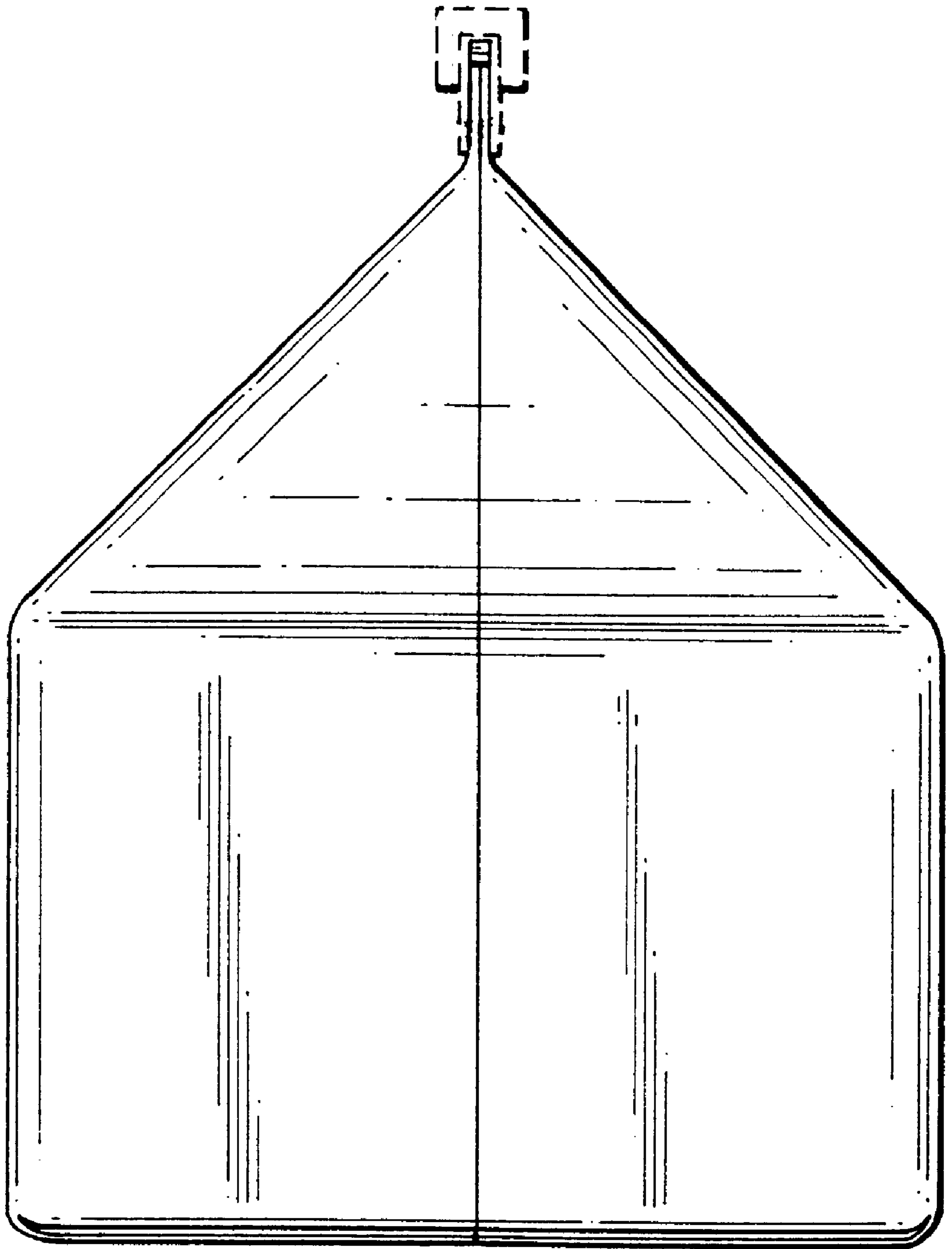
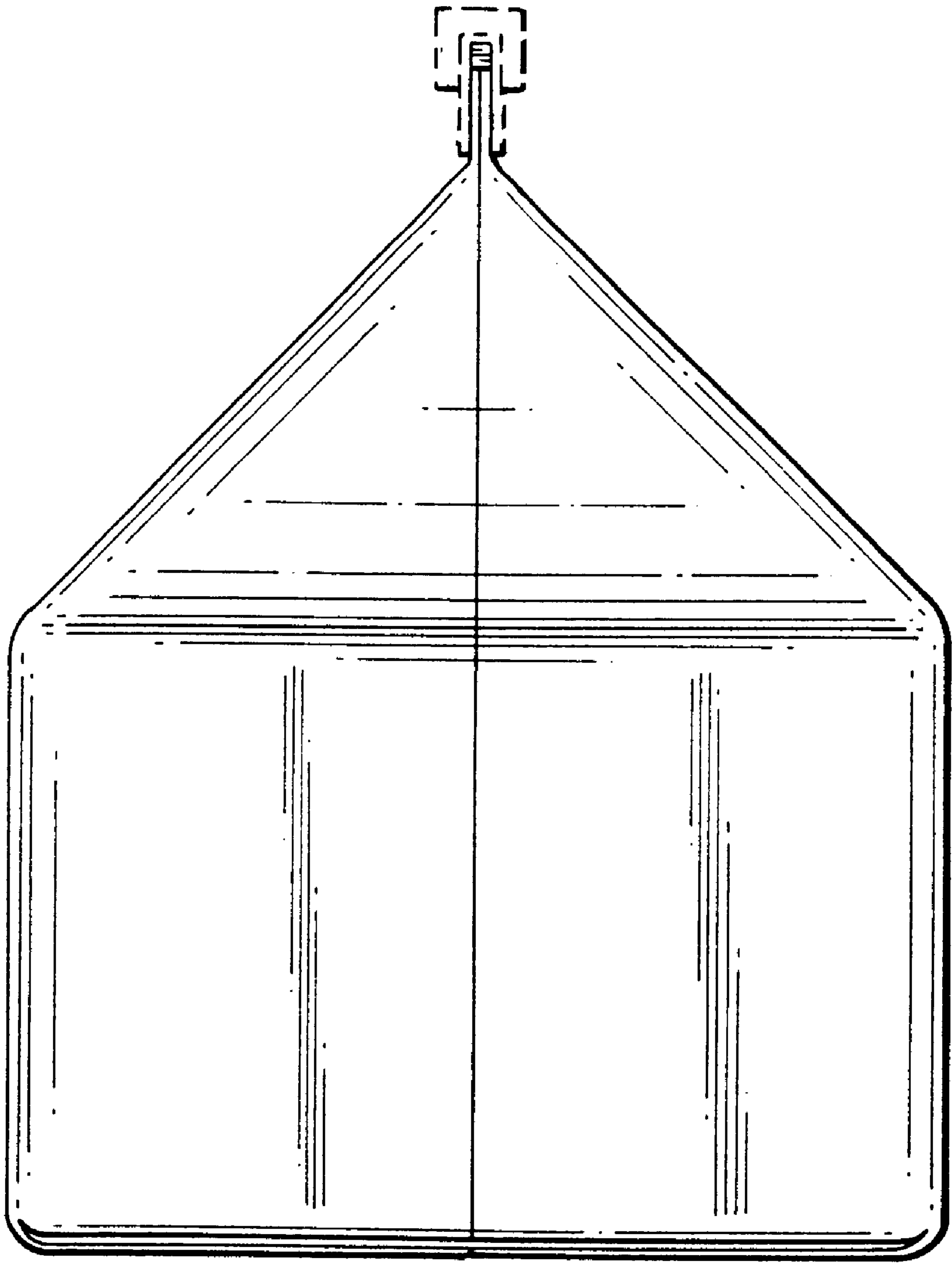

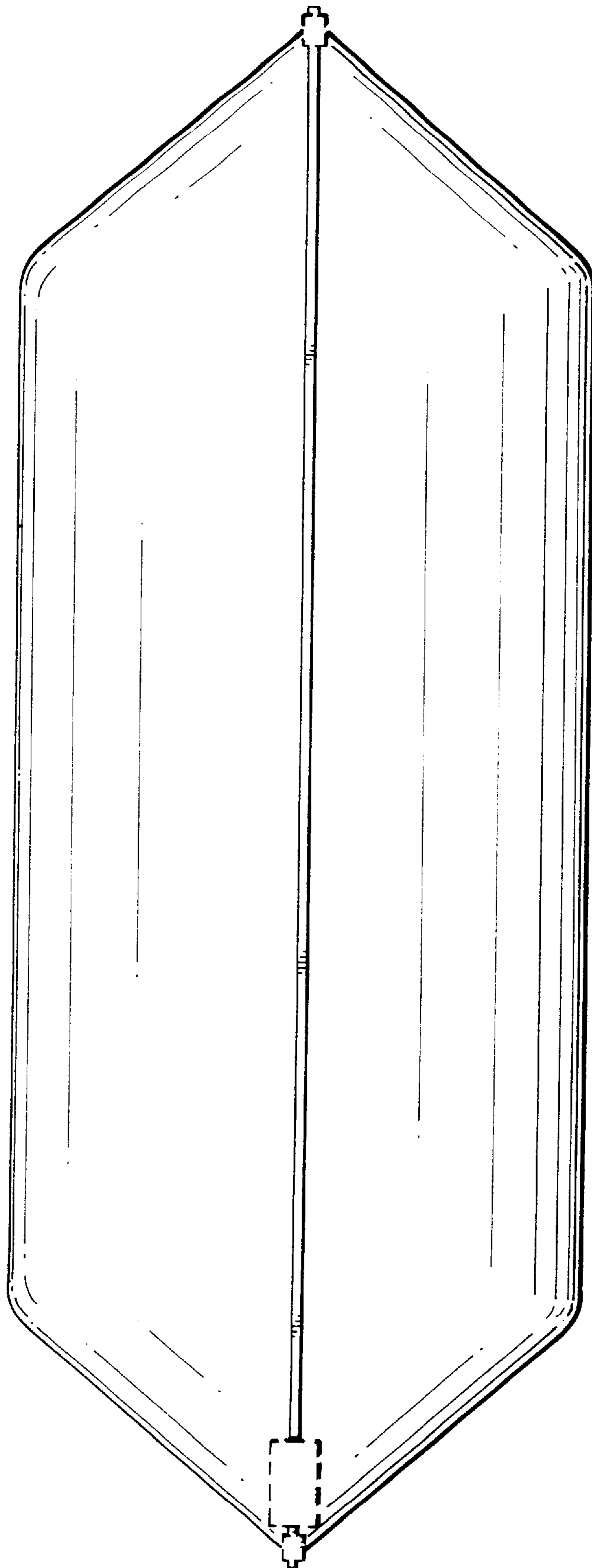

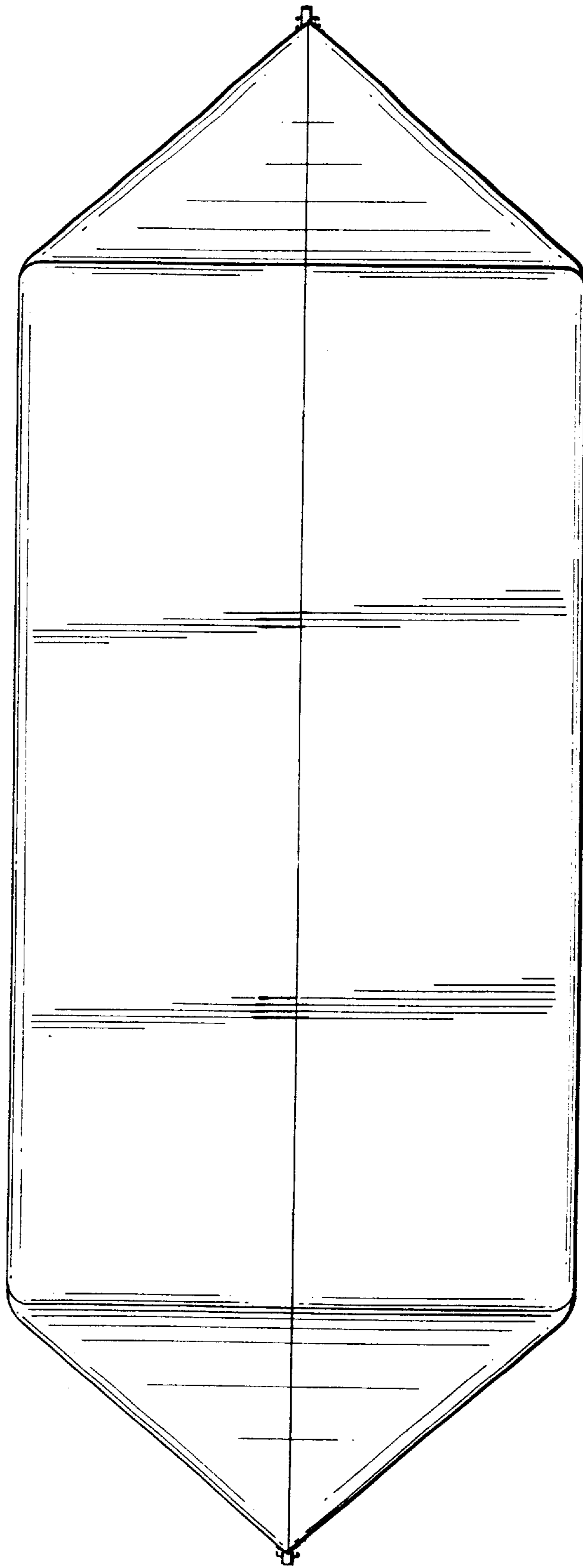

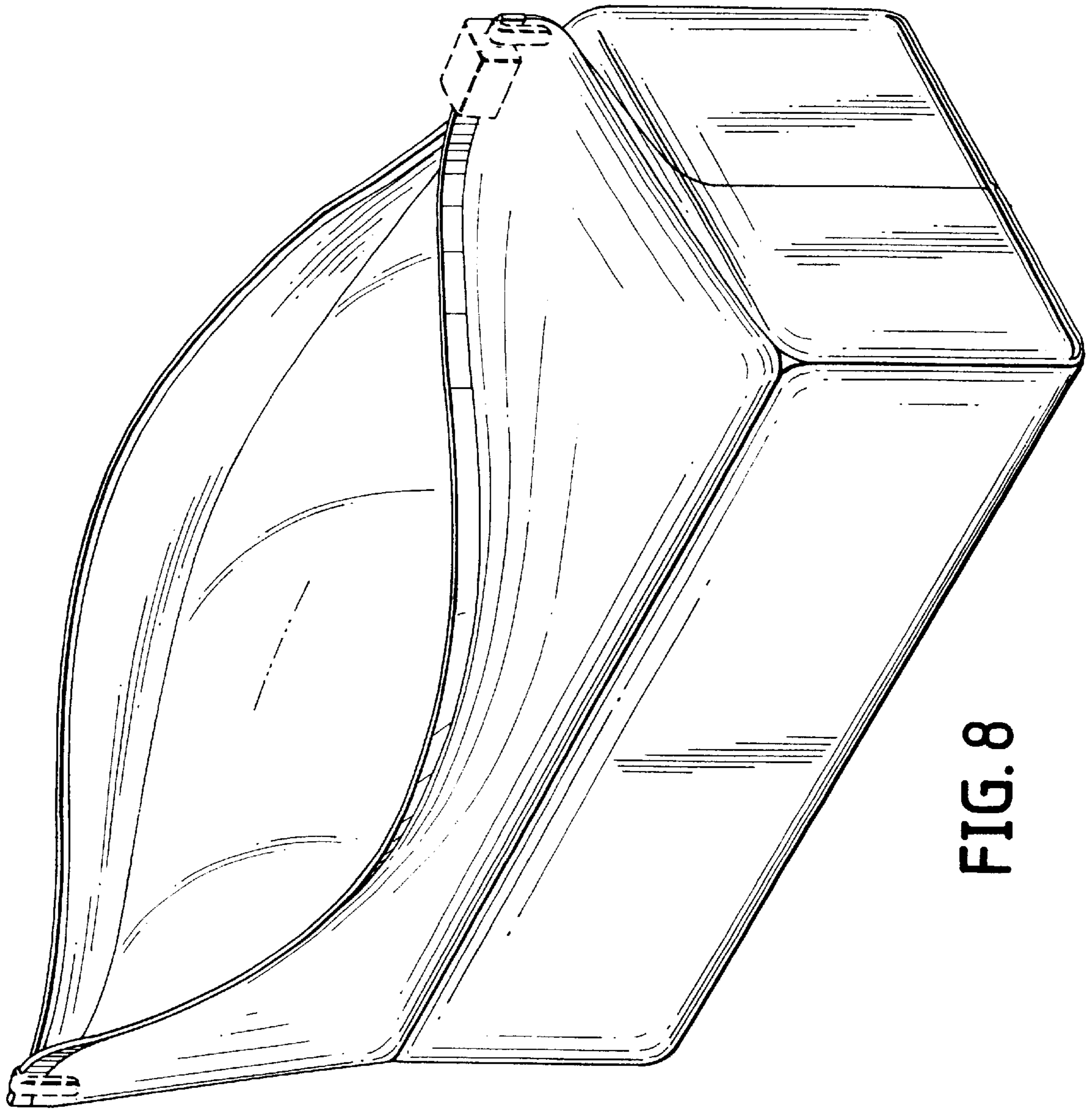

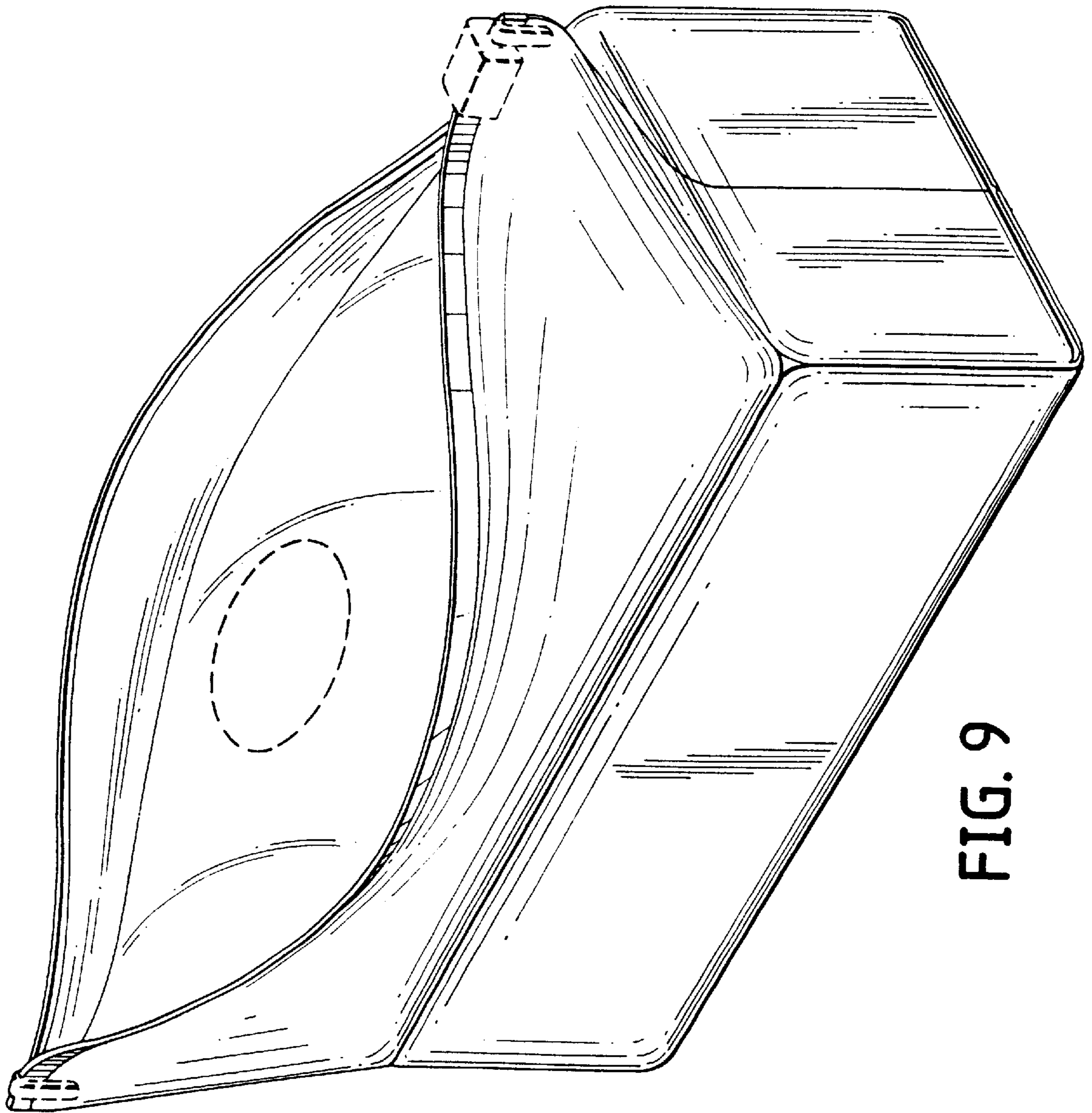
