(57) **CLAIM**

The ornamental design for a beverage container body portion, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a beverage container body portion showing the new design; FIG. 2 is an elevational view thereof; FIG. 3 is a top plan view thereof; and, FIG. 4 is a bottom plan view thereof. The dot-dot-dash lines shown in the drawing are for illustrative purposes only and form no part of the claimed design. The dash-dash-dash lines shown in the drawing define the upper boundary of the claimed design.

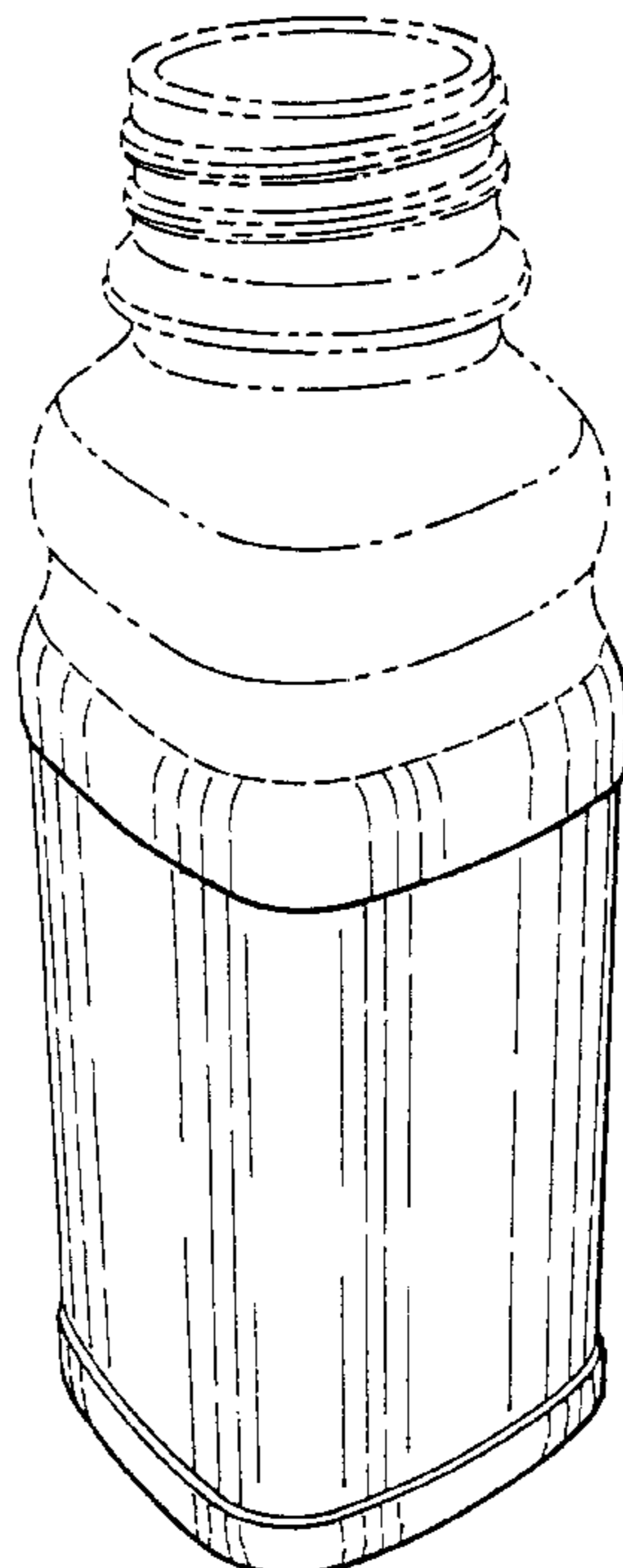

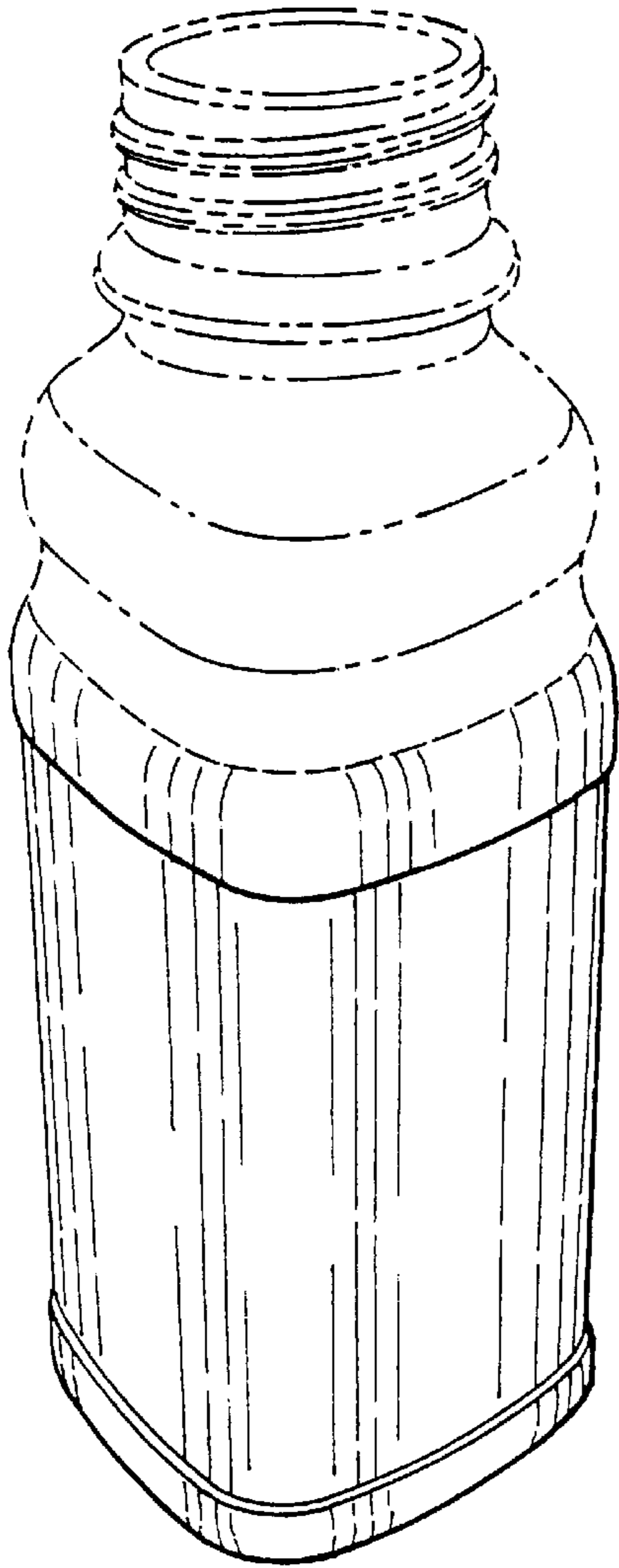

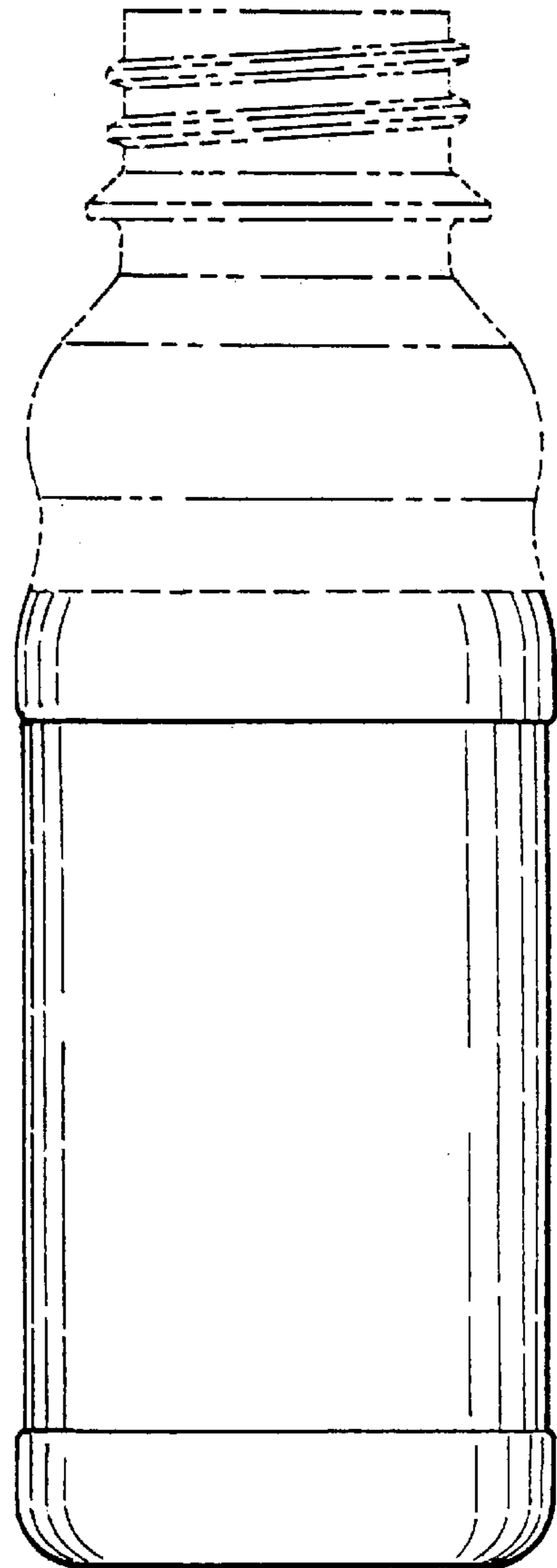

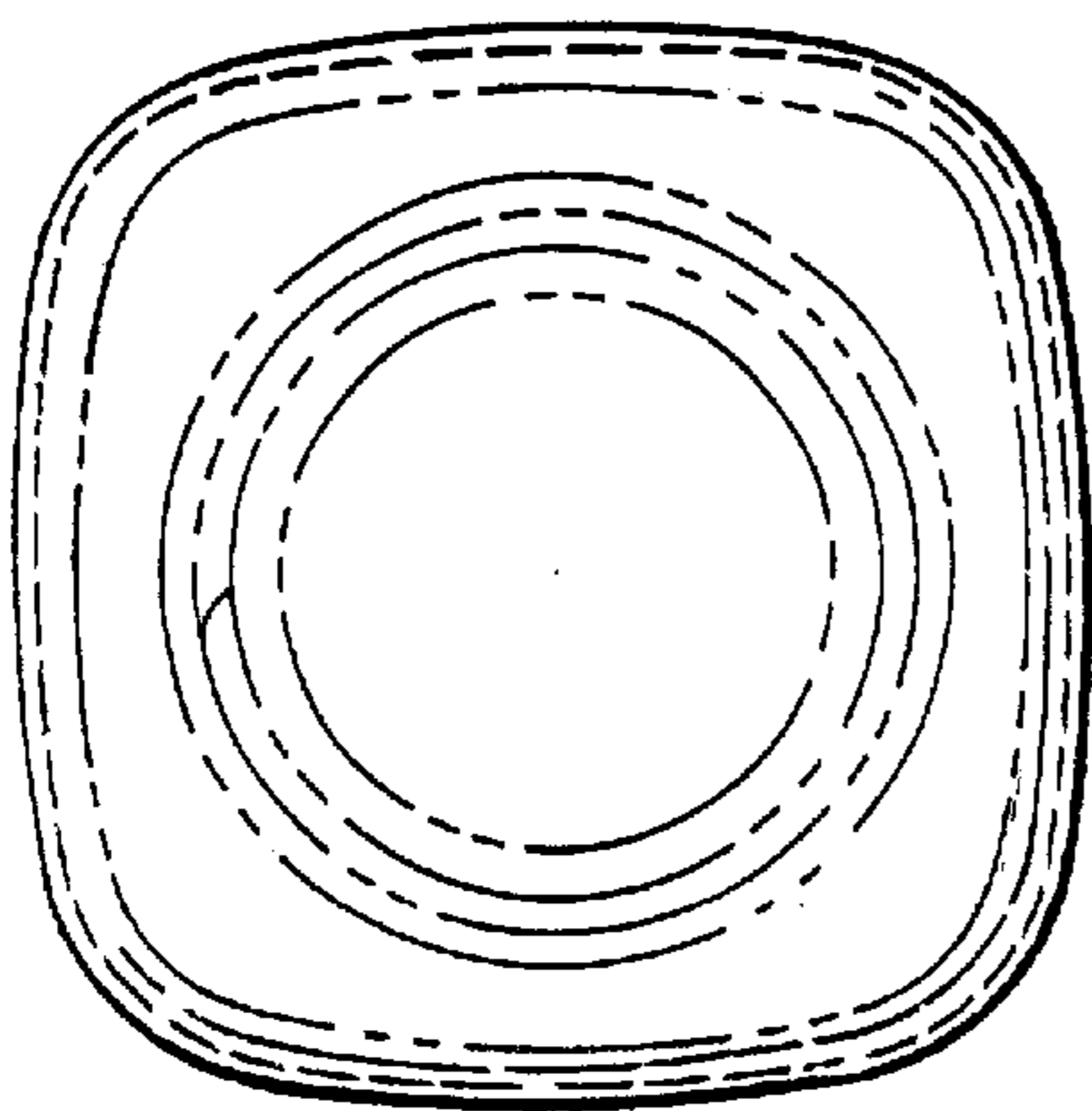
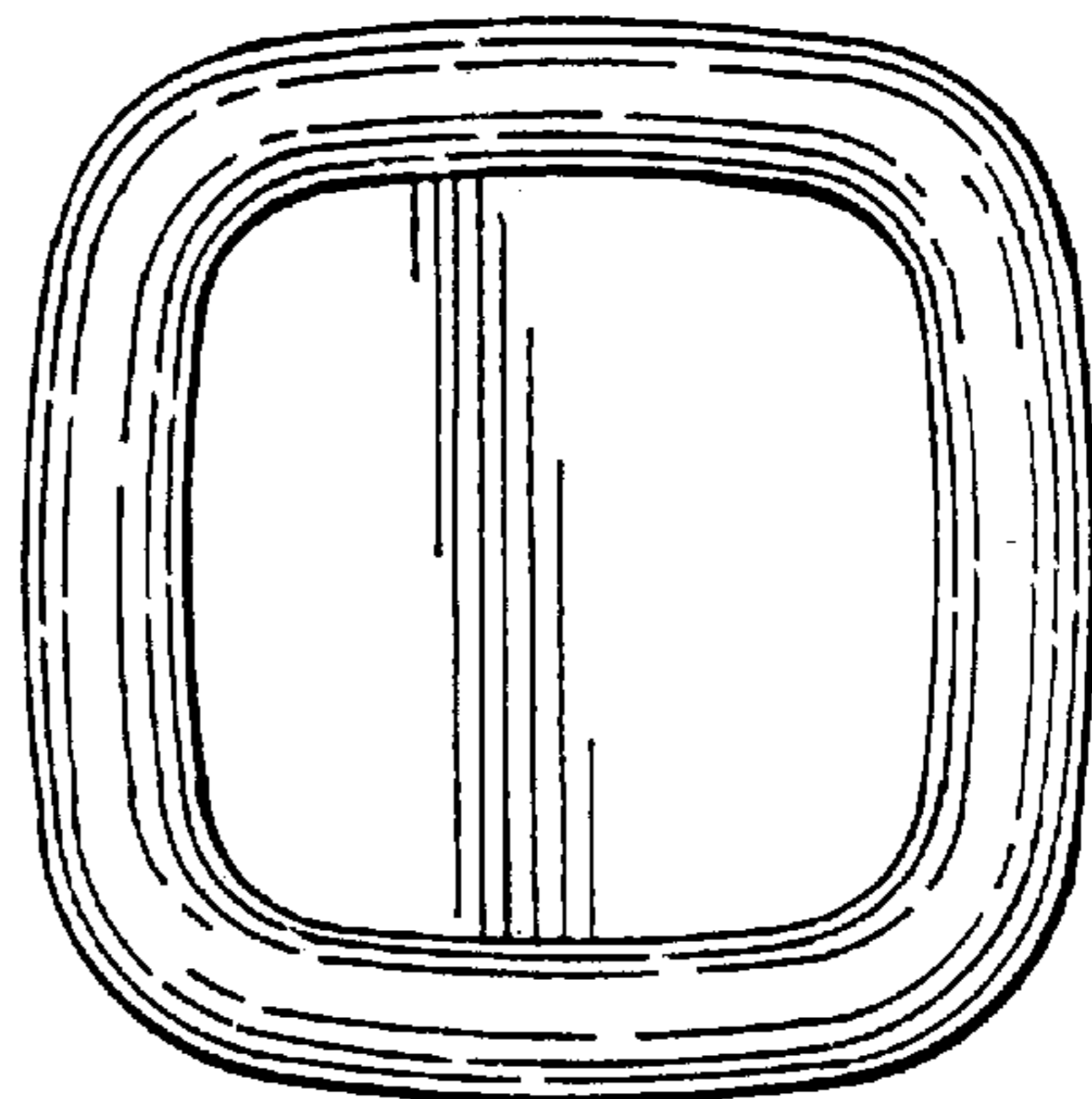
