(57) **CLAIM**

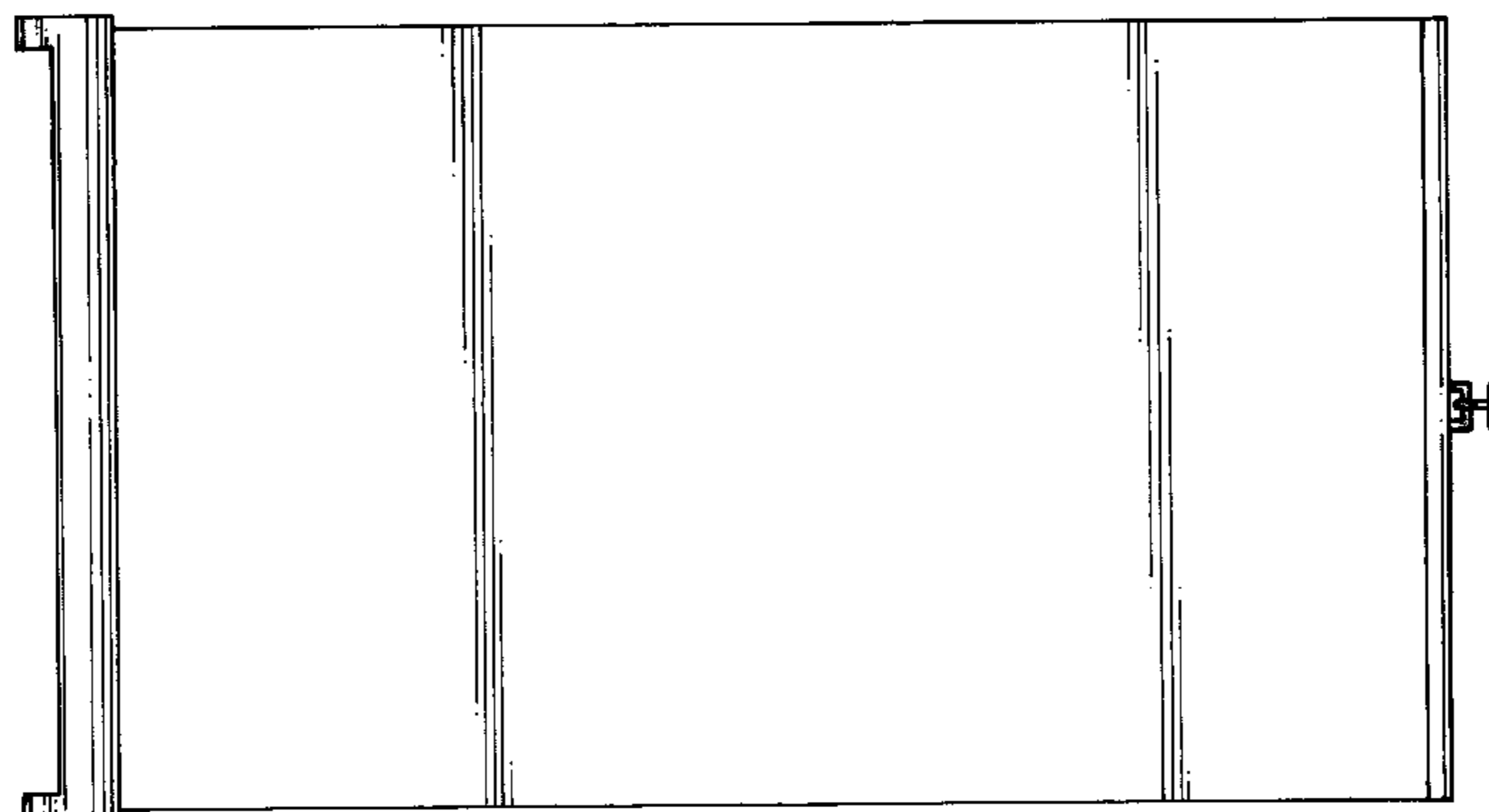
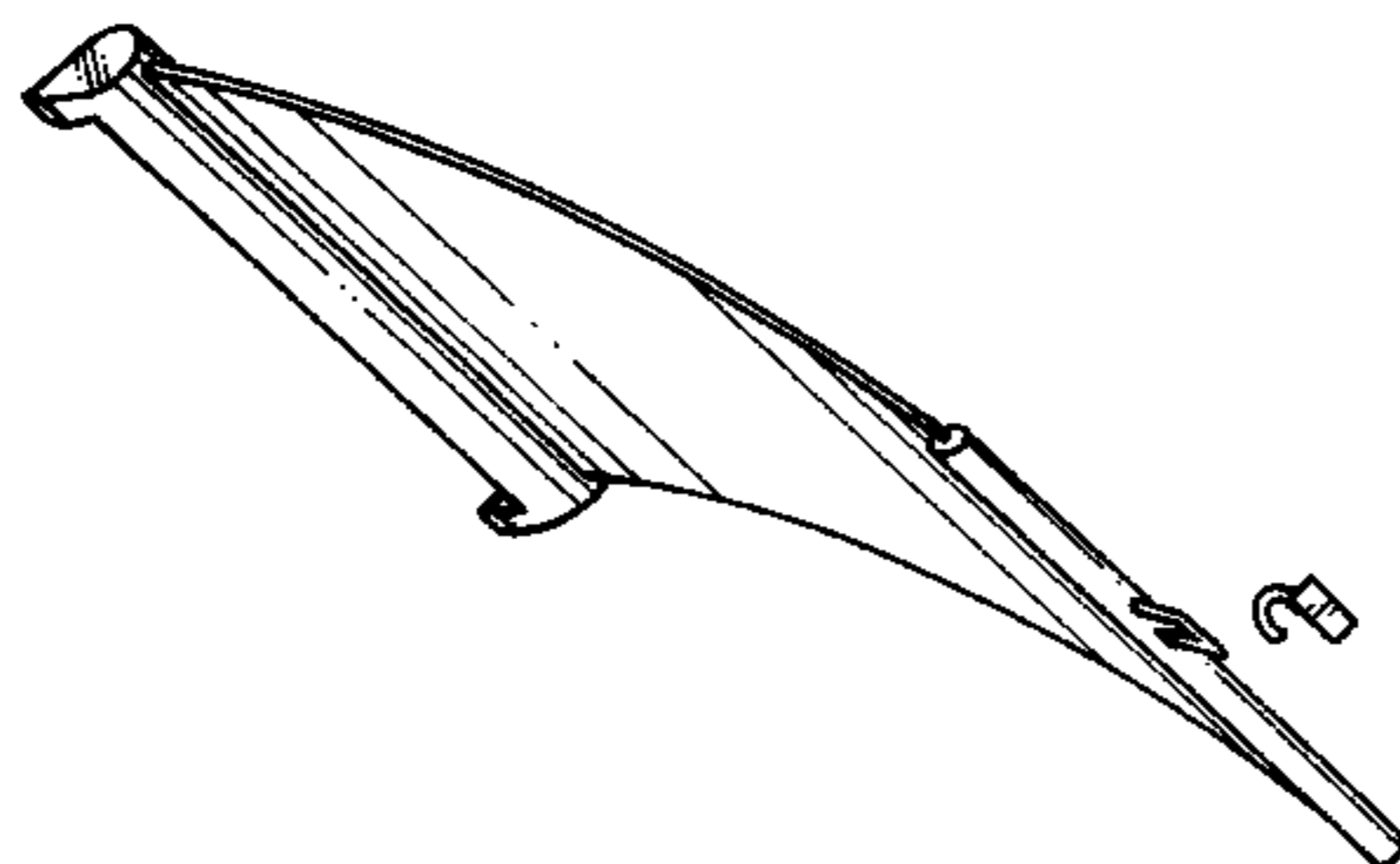
The ornamental design for a retractable horizontal extending sun screen for vehicle, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the retractable horizontally extending sun screen for vehicle embodying the design of the present invention shown in exploded condition; FIG. 2 is a front elevational view thereof; FIG. 3 is a rear elevational view thereof; FIG. 4 is a left side elevational view thereof; FIG. 5 is a right side elevational view thereof; FIG. 6 is a top plan view thereof; the bottom plan view being a mirror image thereof; and, FIG. 7 is a reduced perspective view showing the retractable horizontally extending sun screen for vehicle in use; the broken lines depict environmental structure and form no part of the claimed design.

The sun screen shown in FIGS. 2-7 is shown in assembled position.

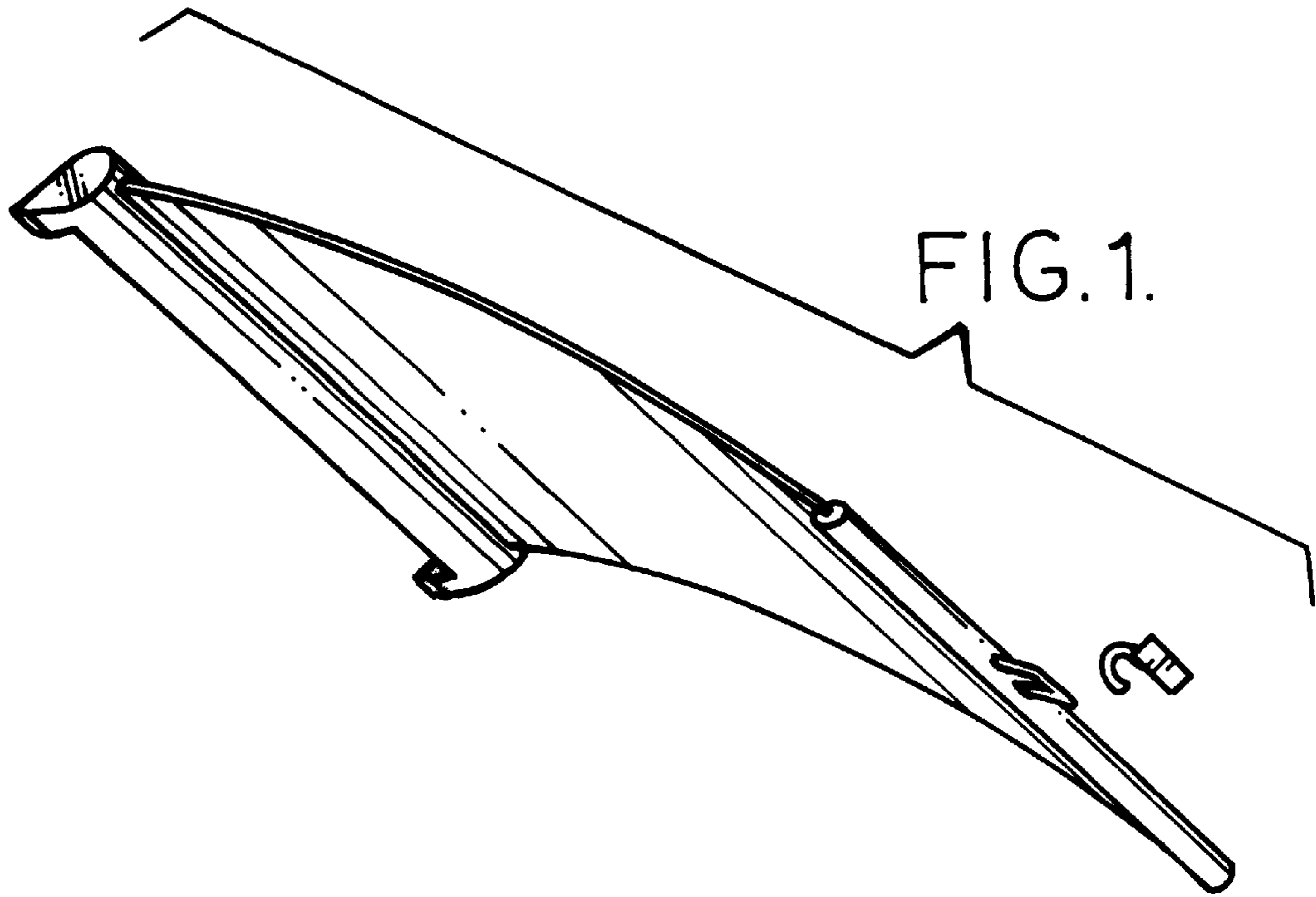
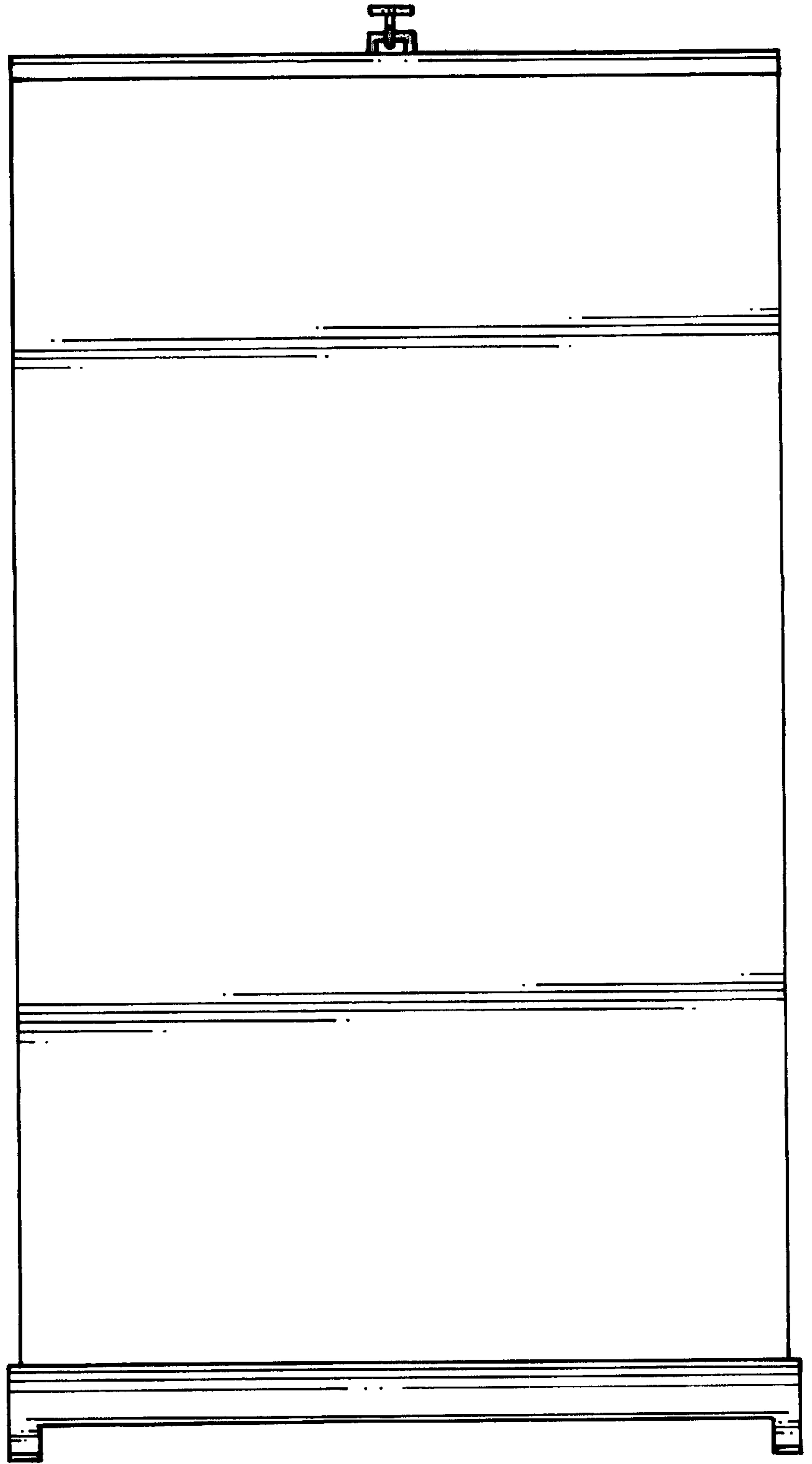

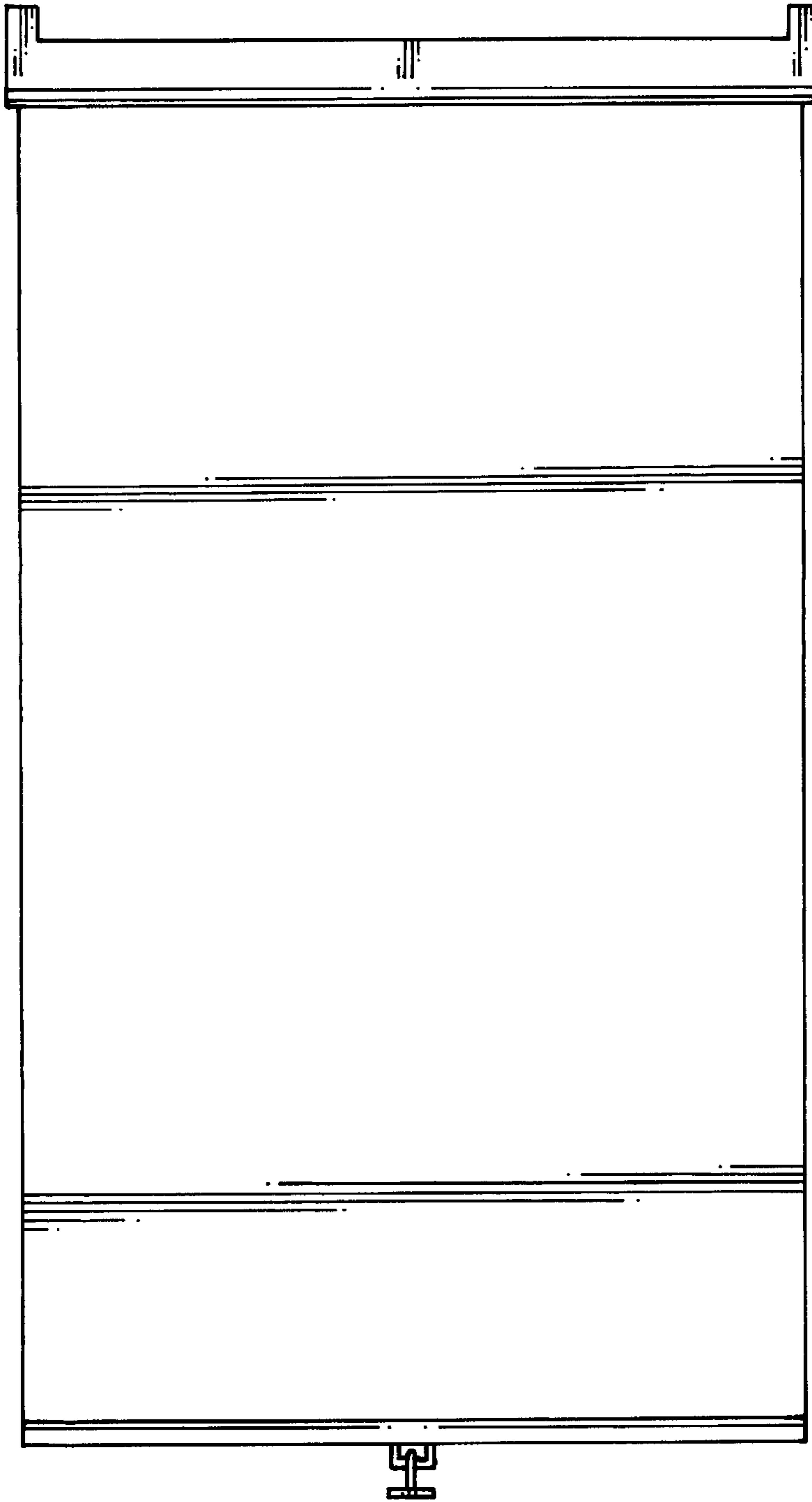

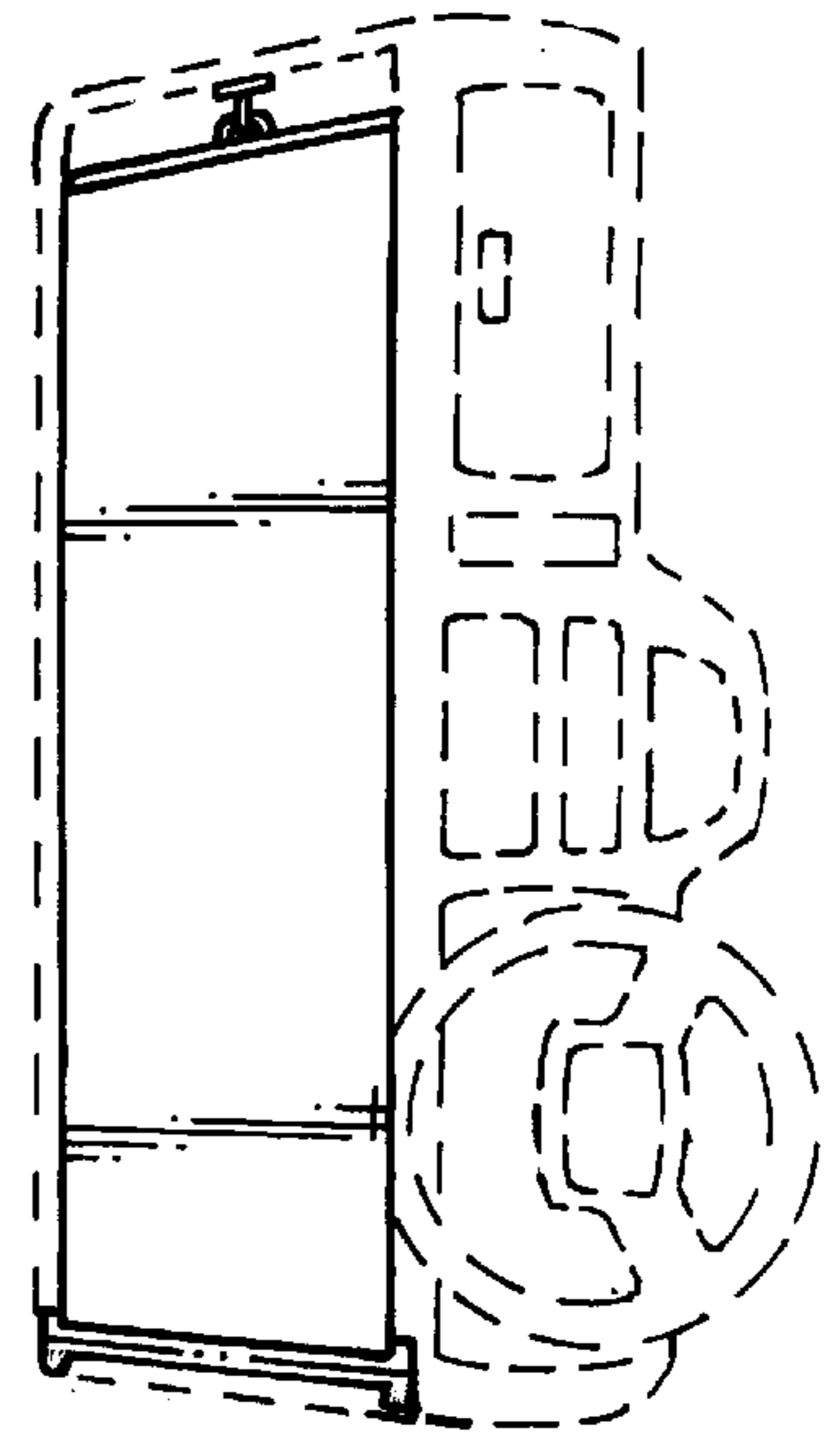
