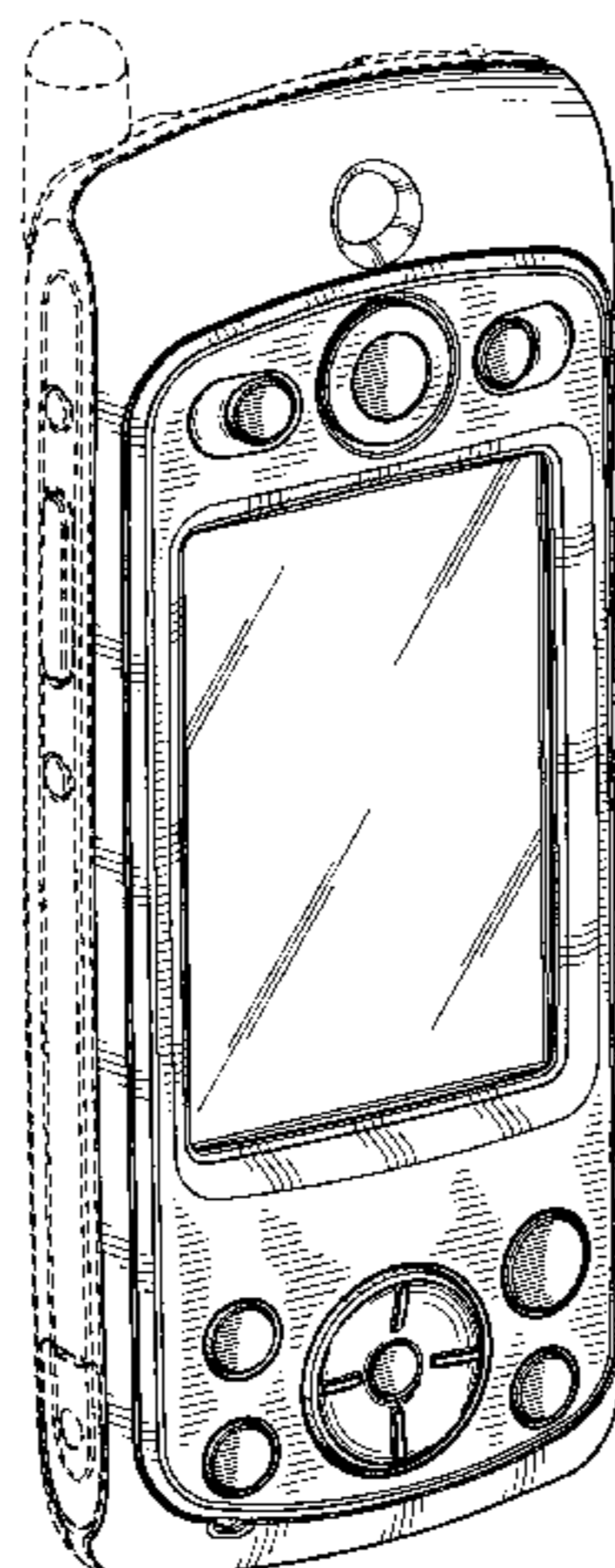
(57) **CLAIM**

The ornamental design for a housing for communications devices or similar articles, substantially as shown.

**DESCRIPTION**

FIG. 1 is a front, side and top perspective view of an ornamental housing for communications devices or similar articles.  
FIG. 2 is a first side elevation view according to FIG. 1.  
FIG. 3 is a front elevation view according to FIG. 1.  
FIG. 4 is a bottom plan view according to FIG. 1.  
FIG. 5 is a top plan view according to FIG. 1; and,  
FIG. 6 is a second side elevation view according to FIG. 1.

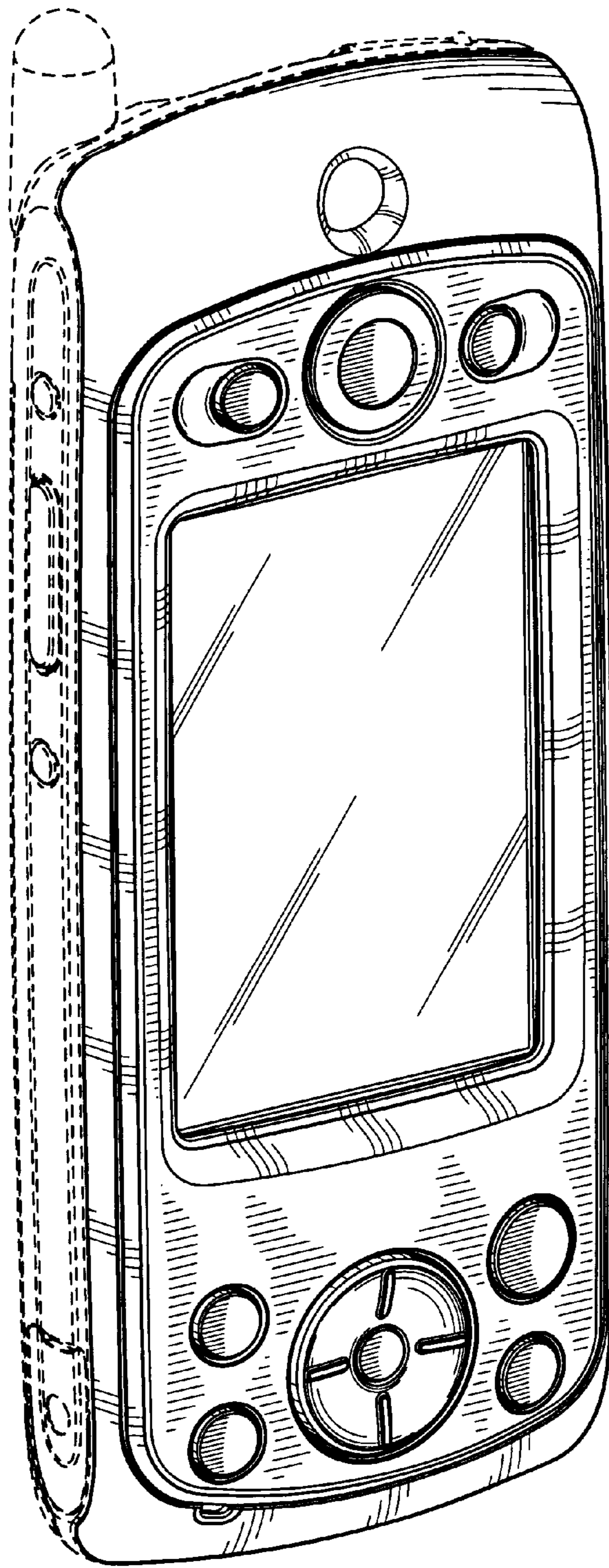

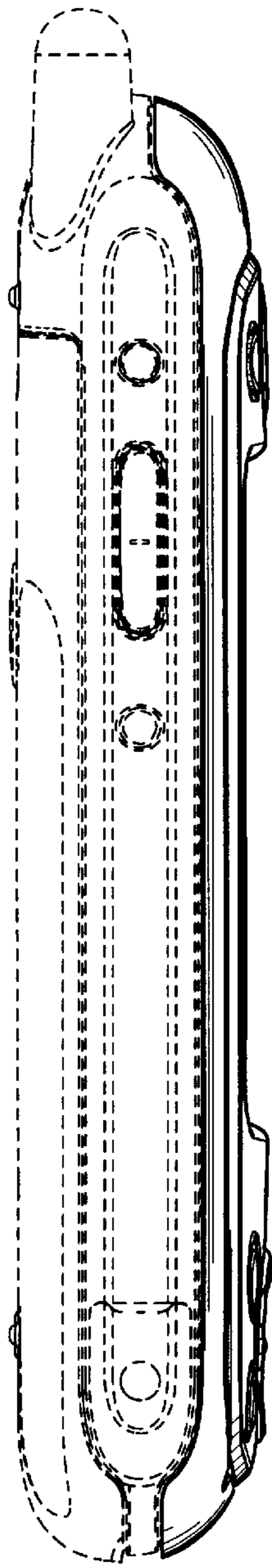

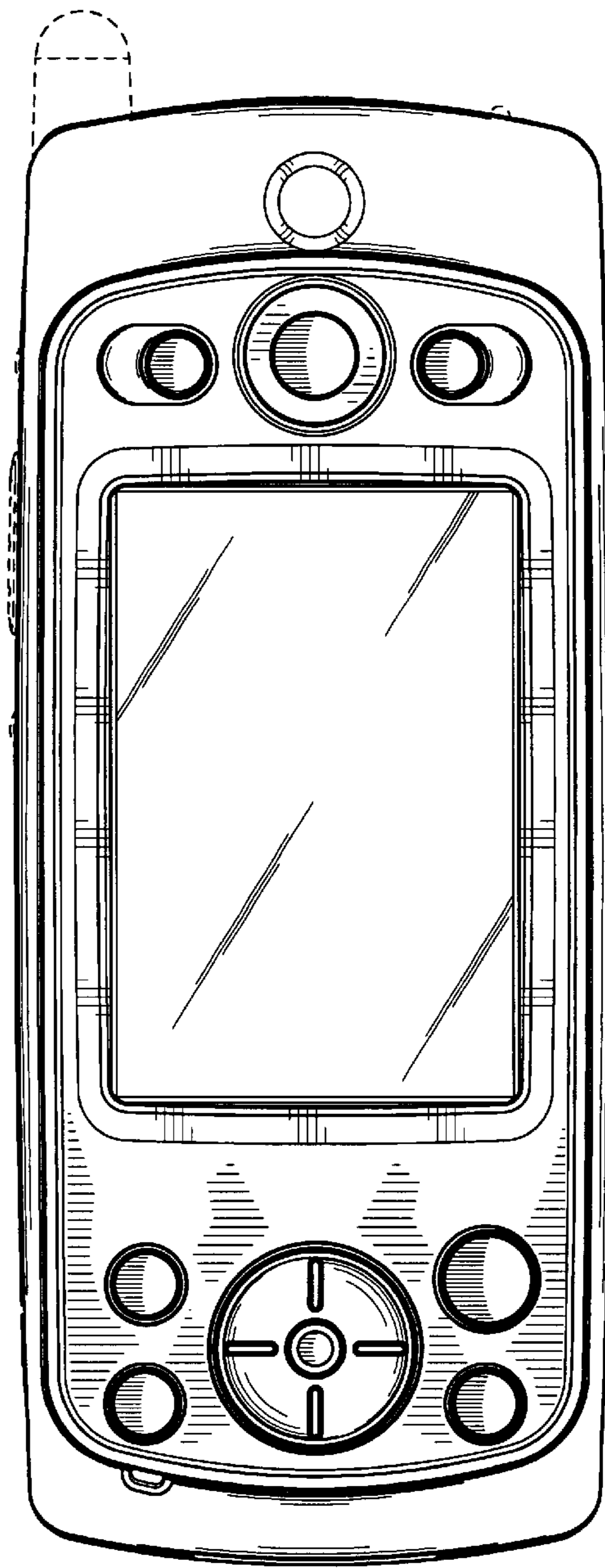

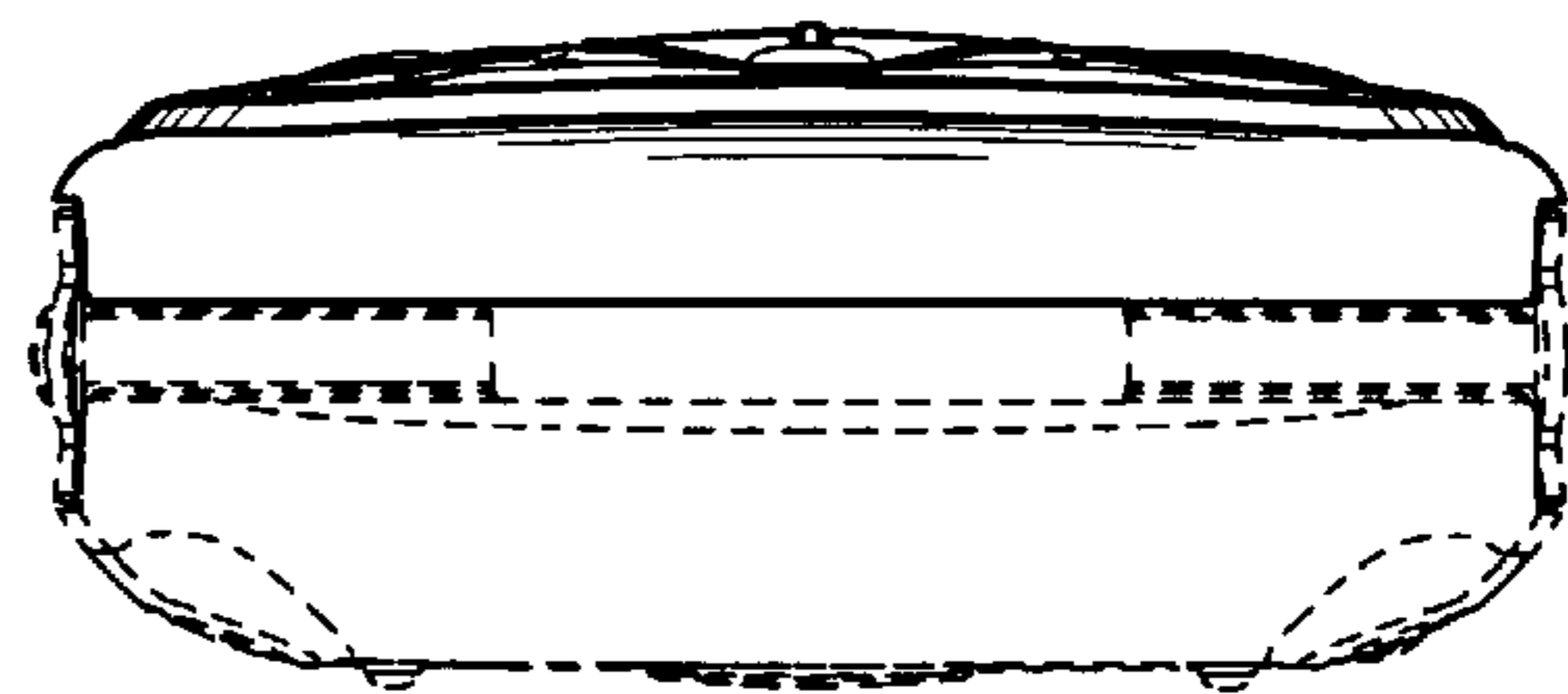

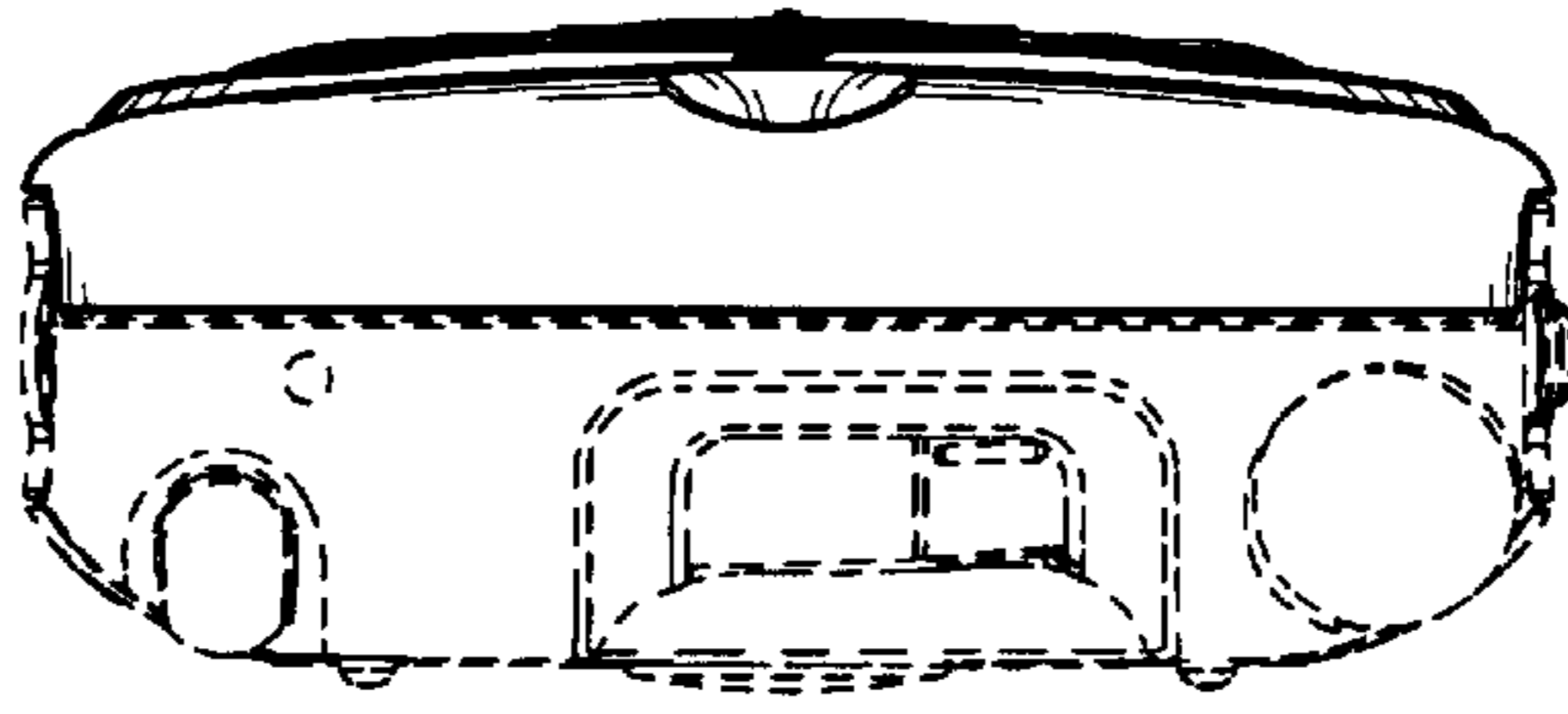

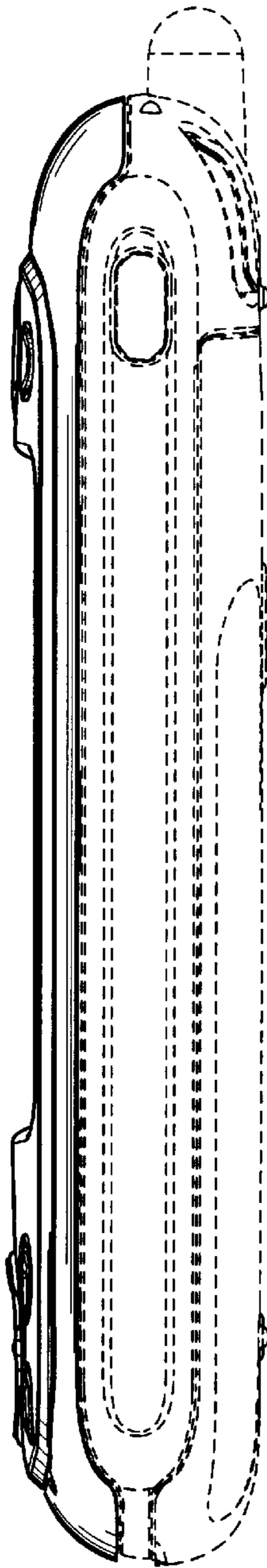
