(57) **CLAIM**

I claim the ornamental design for lighted house number box, as shown and described.

**DESCRIPTION**

FIG. 1 is a side elevational view of the lighted house number box wherein the numbers in phantom do not form part of the design.

FIG. 2 is a top view of the lighted house number box.

FIG. 3 is a right side view of the lighted house number box wherein the left side is a mirror image of the right side view.

FIG. 4 is bottom view of the lighted house number box.

FIG. 5 is a rear view of the lighted house number box.

FIG. 6 is a side elevational view of another embodiment of the lighted house number box wherein the numbers in phantom do not form part of the design.

FIG. 7 is a top view of the lighted house number box shown in FIG. 6.

FIG. 7 is a top view of the lighted house number box shown in FIG. 6.

FIG. 9 is a bottom view of the lighted house number box shown in FIG. 6.

FIG. 10 is a rear view of the lighted house number box shown in FIG. 6.

FIG. 11 is a side elevational view of further embodiment of the lighted house number box wherein the numbers in phantom do not form part of the design.

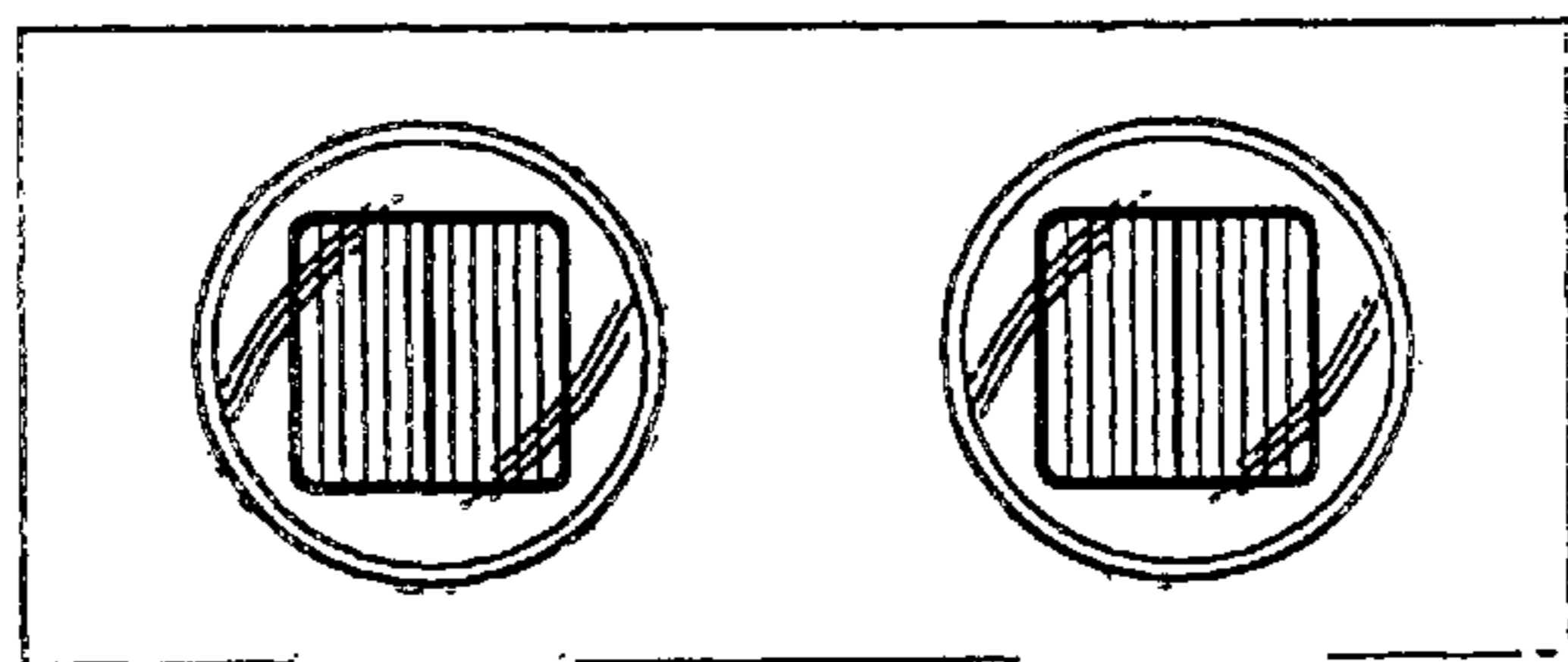
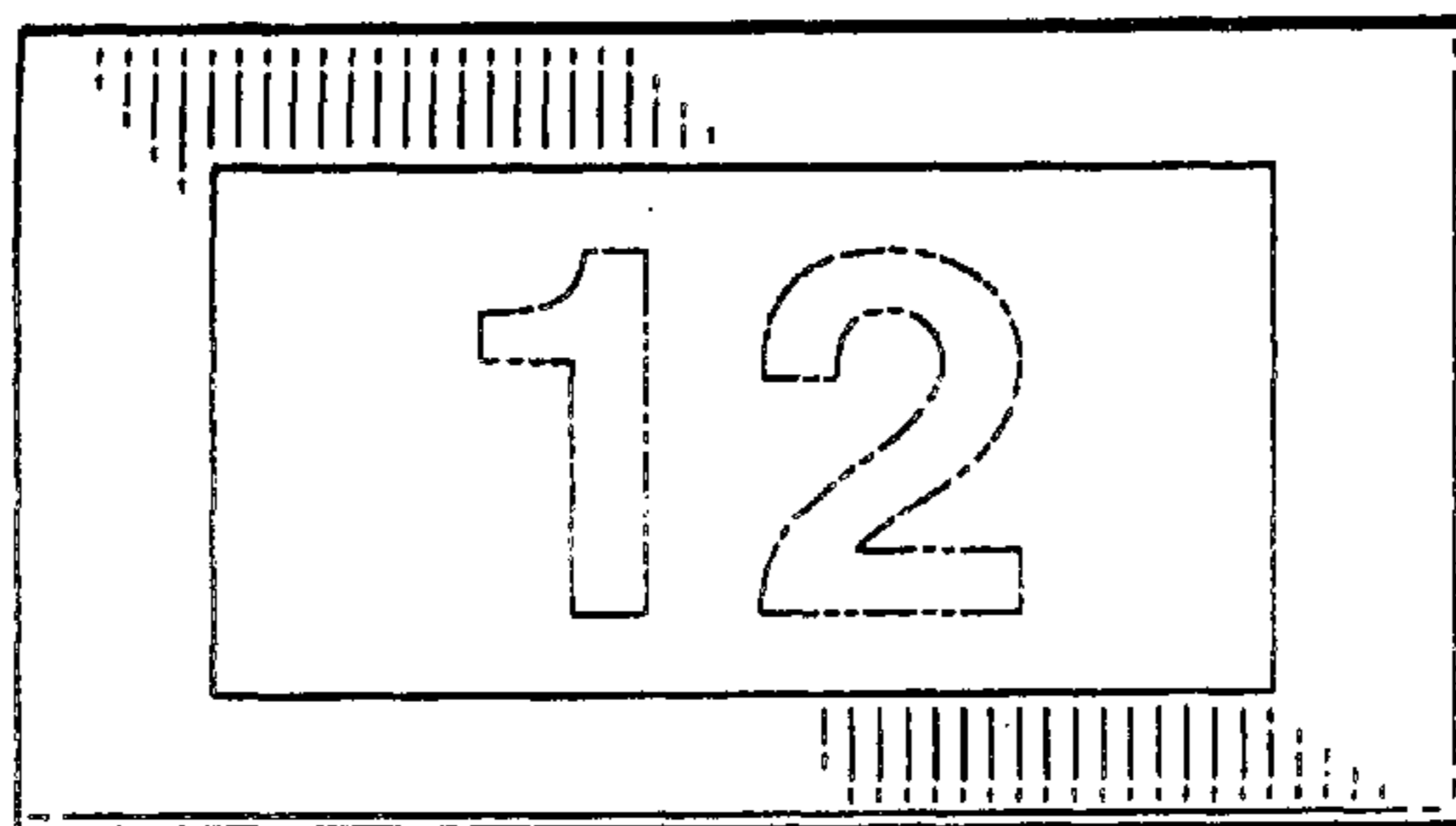
FIG. 12 is a top view of the lighted house number box shown in FIG. 11.

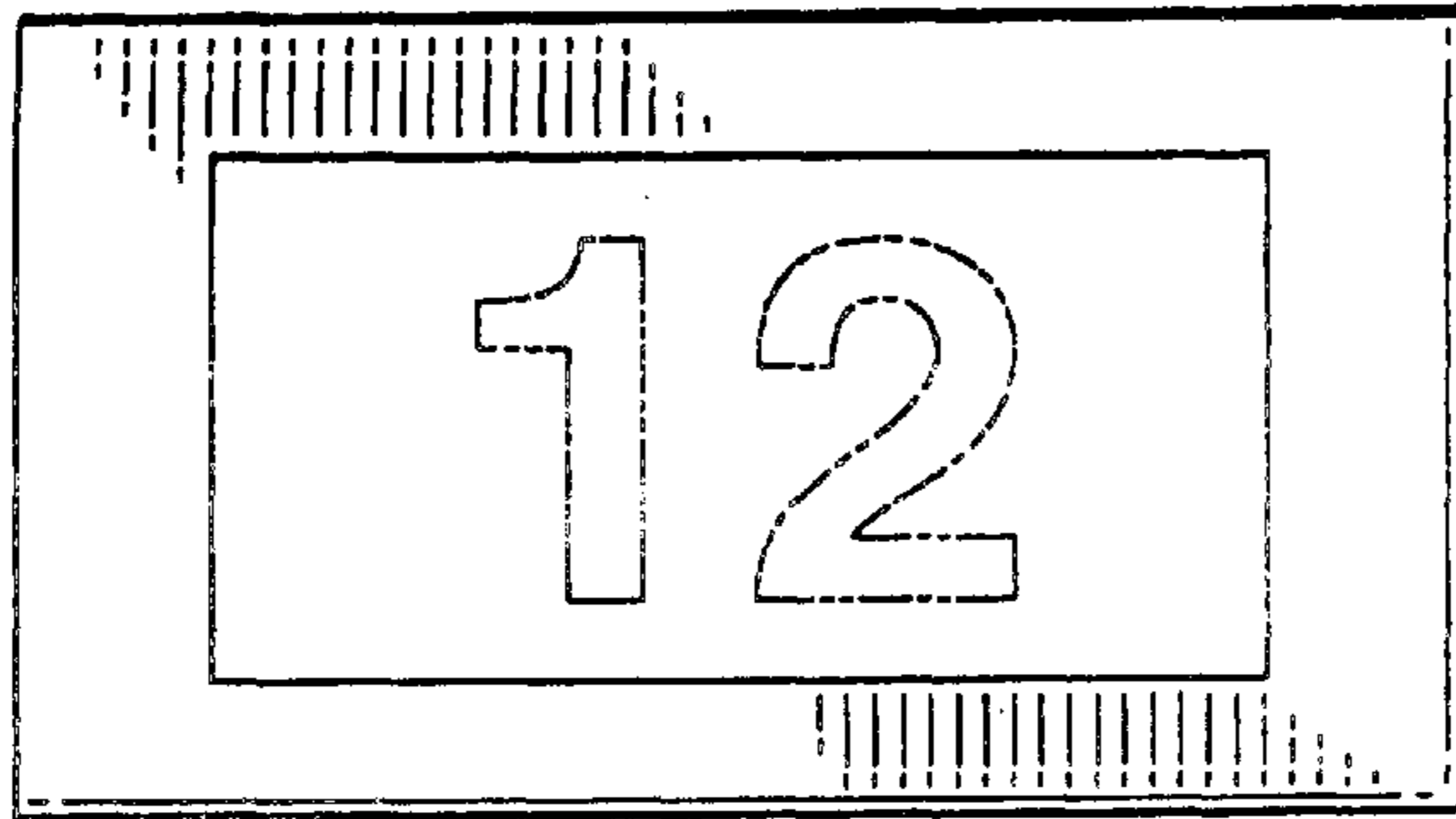

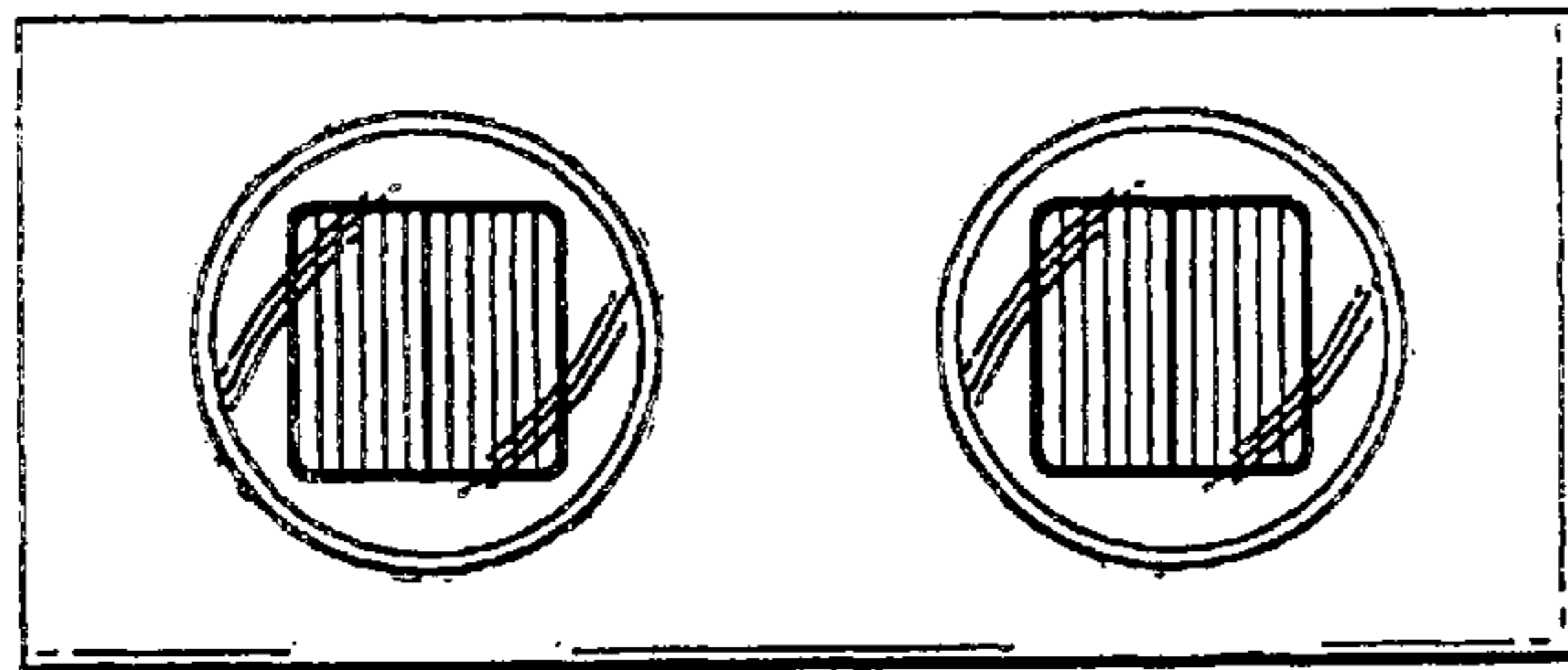

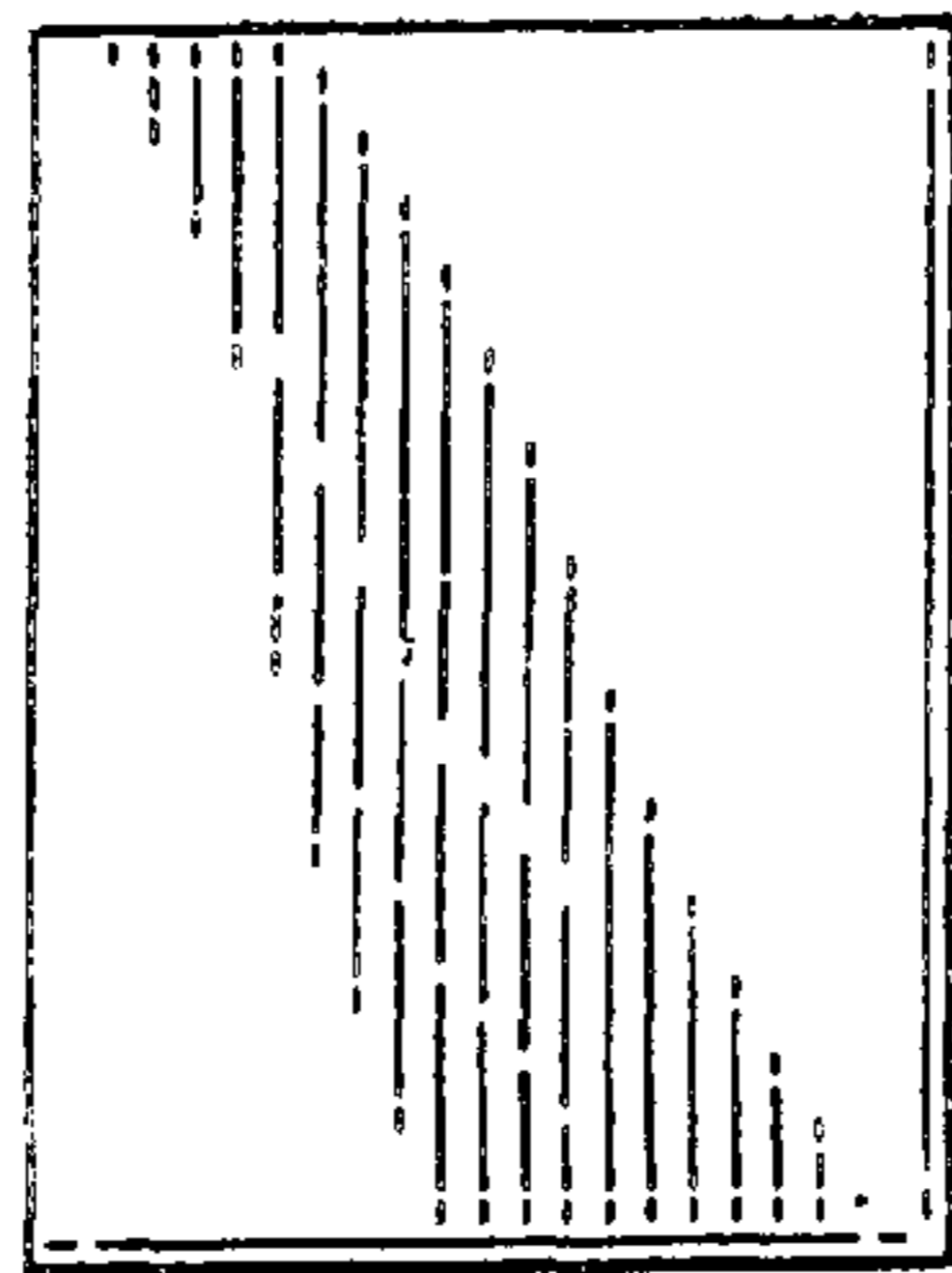

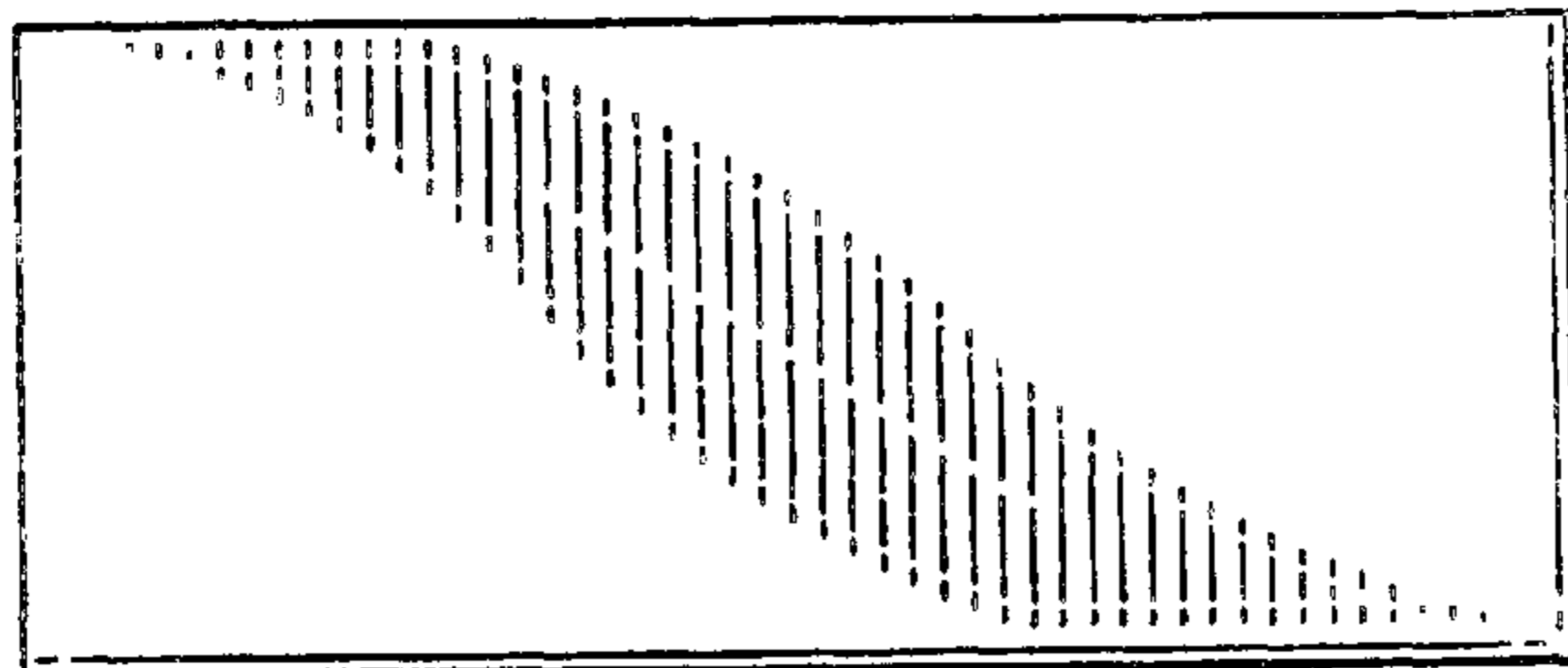

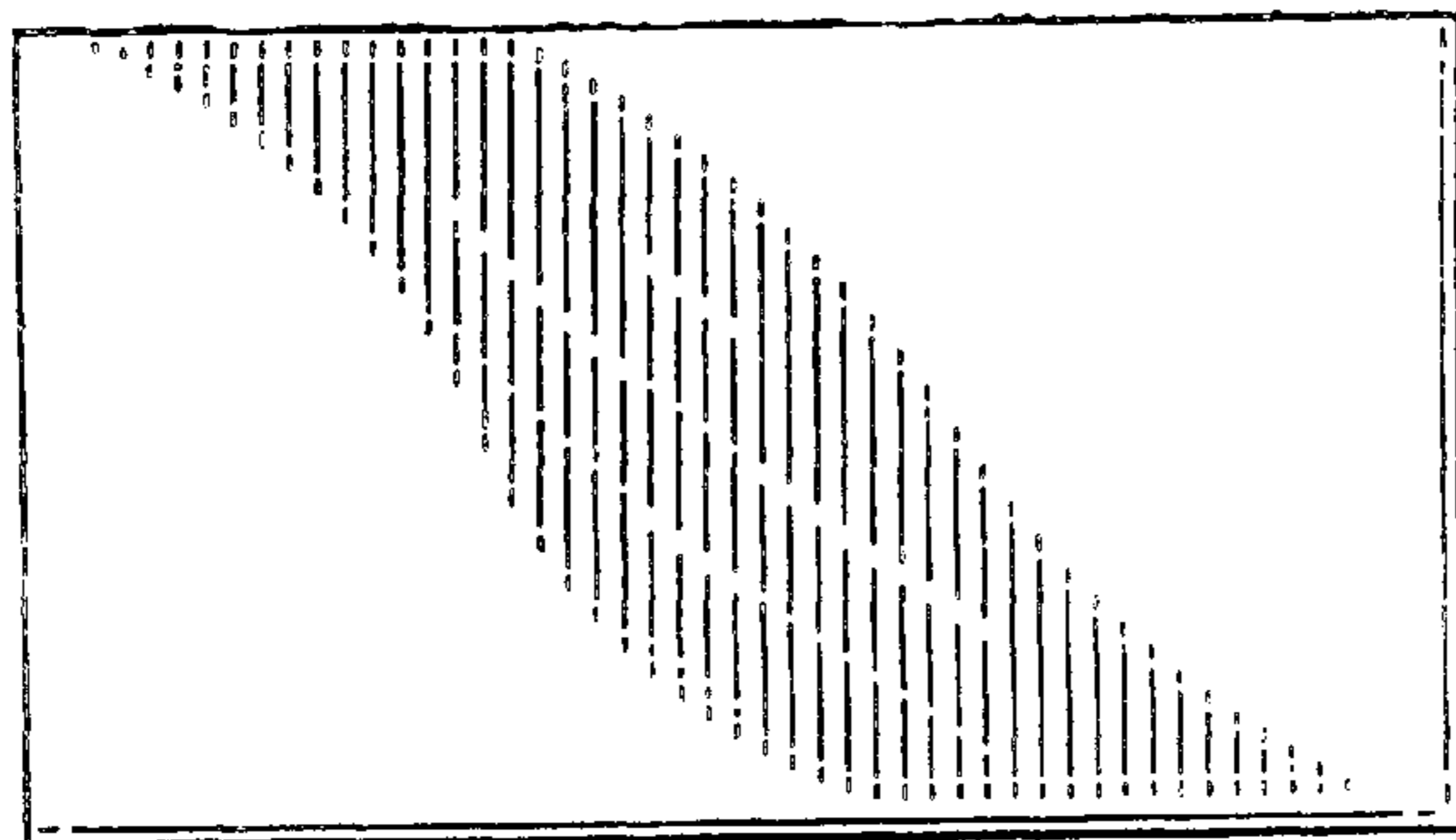

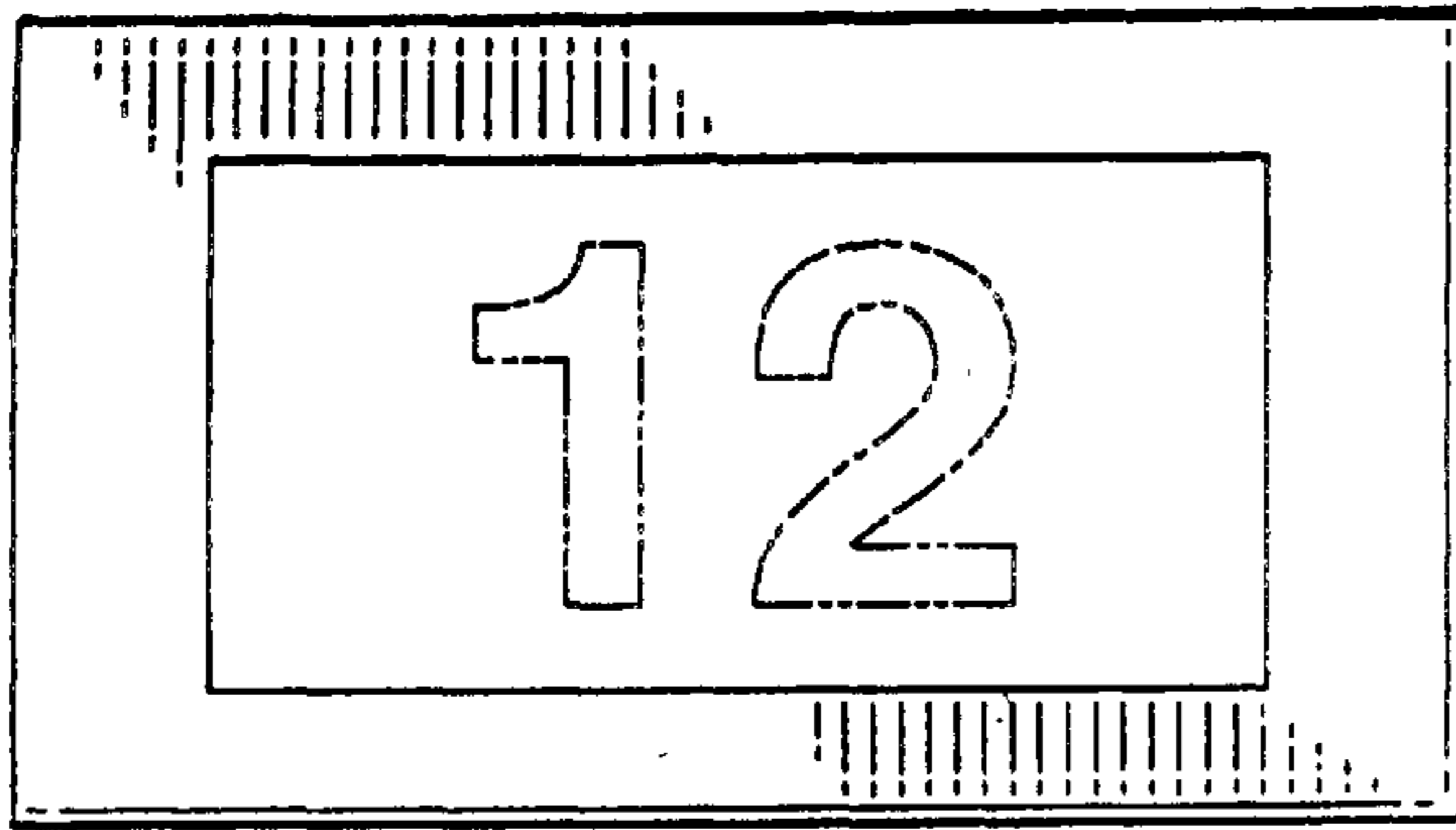

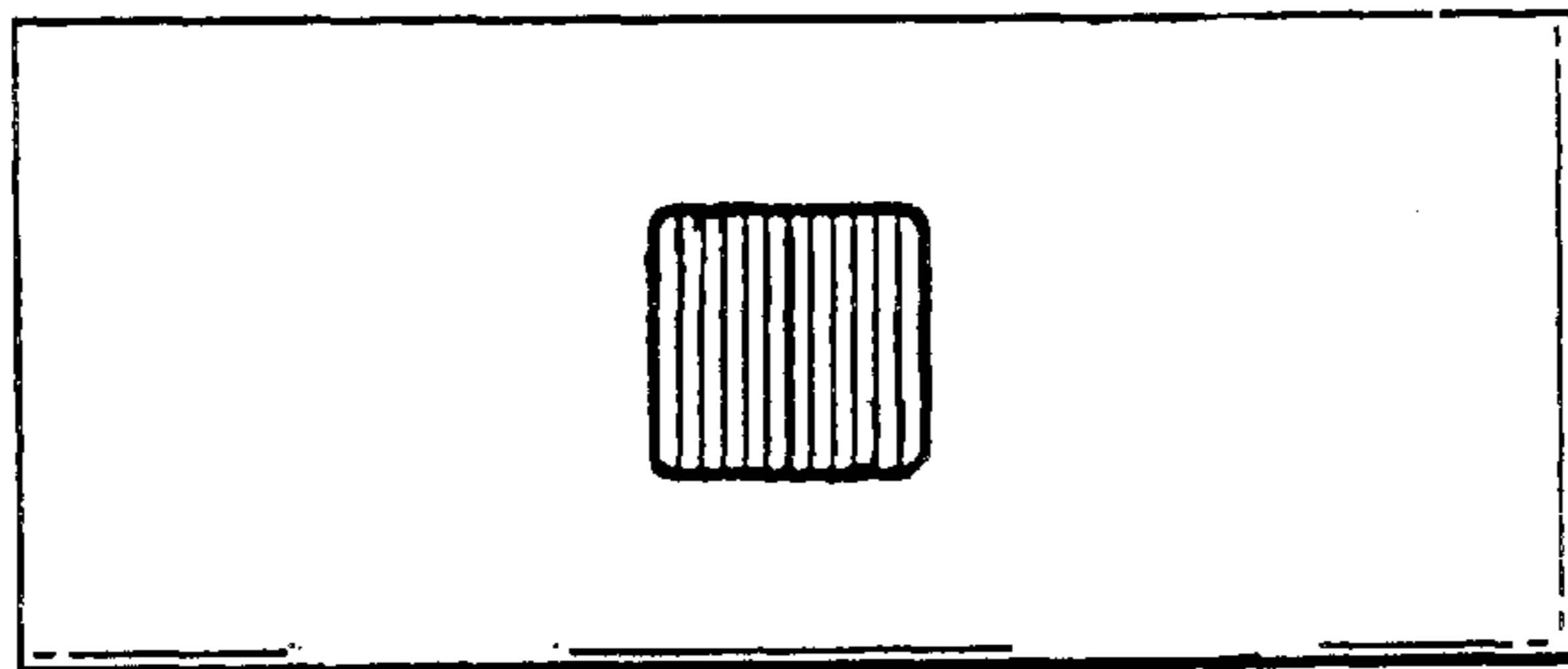

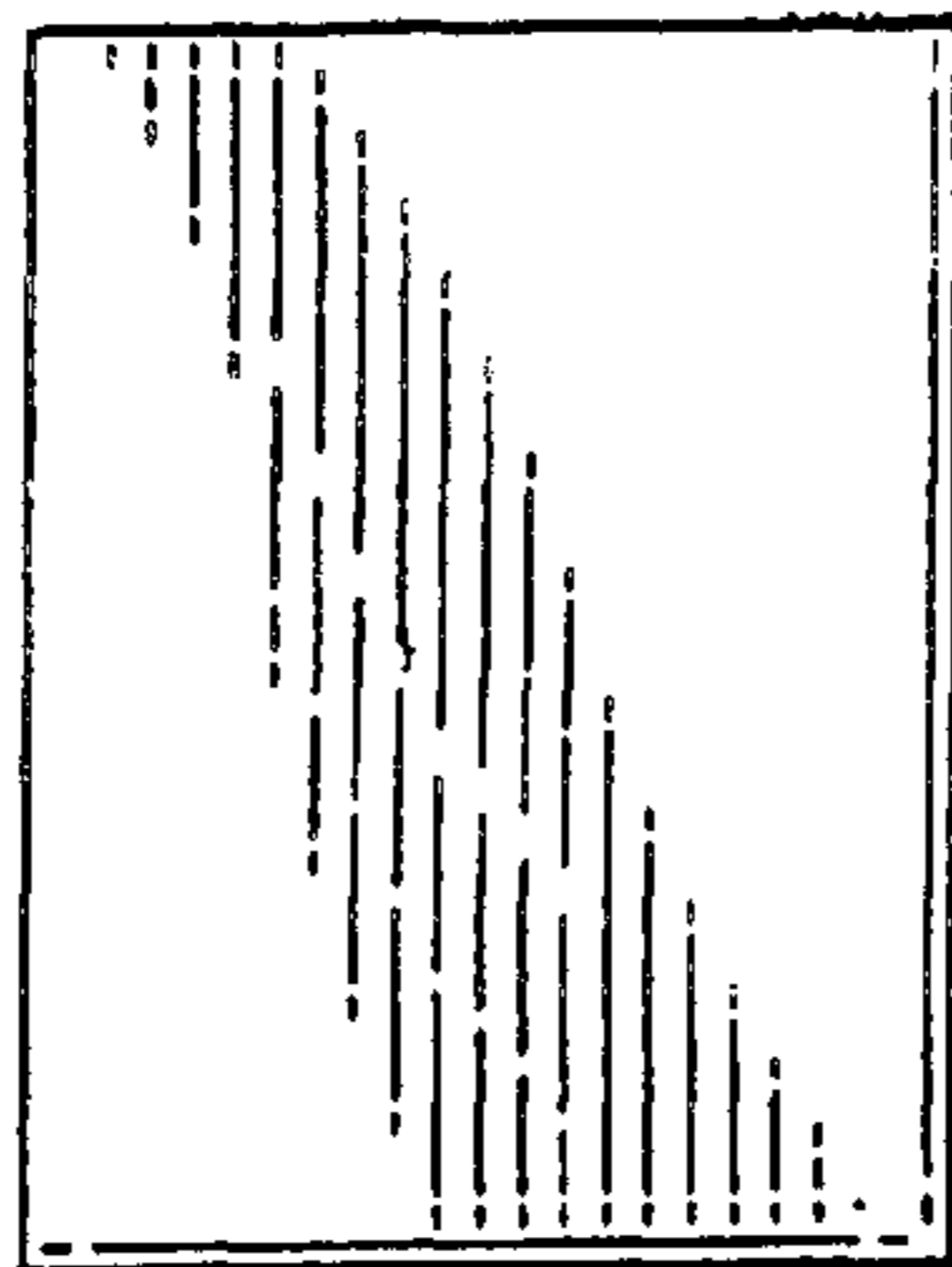

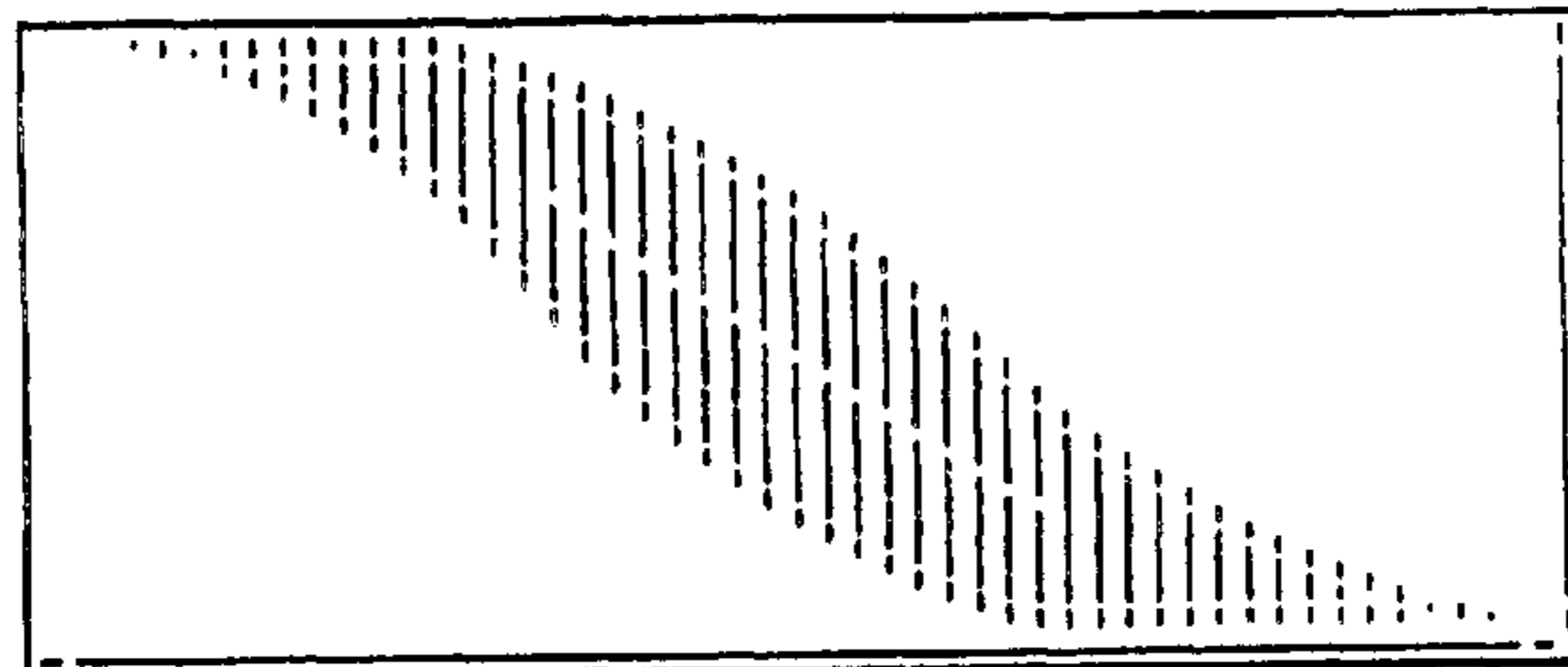

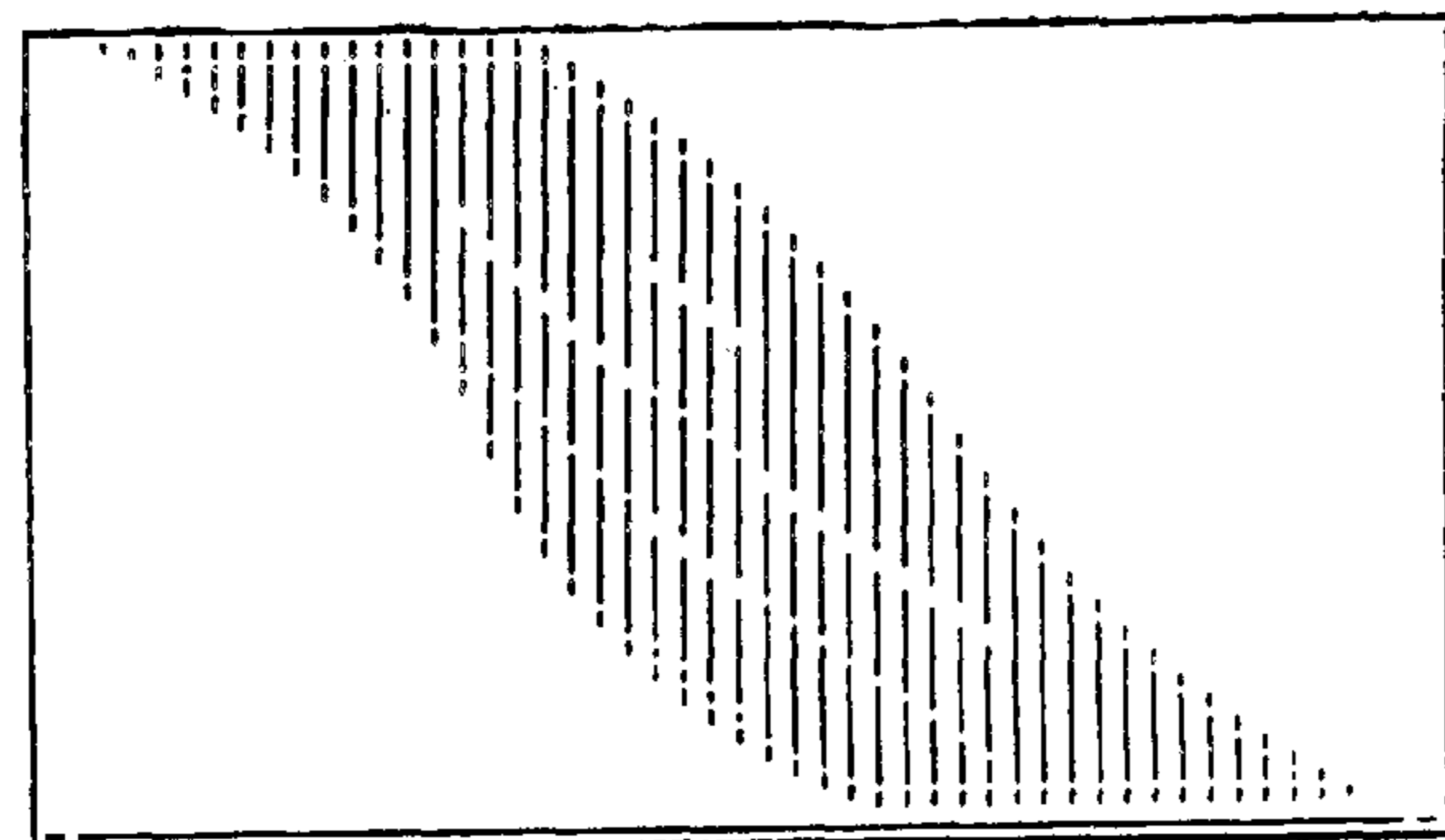

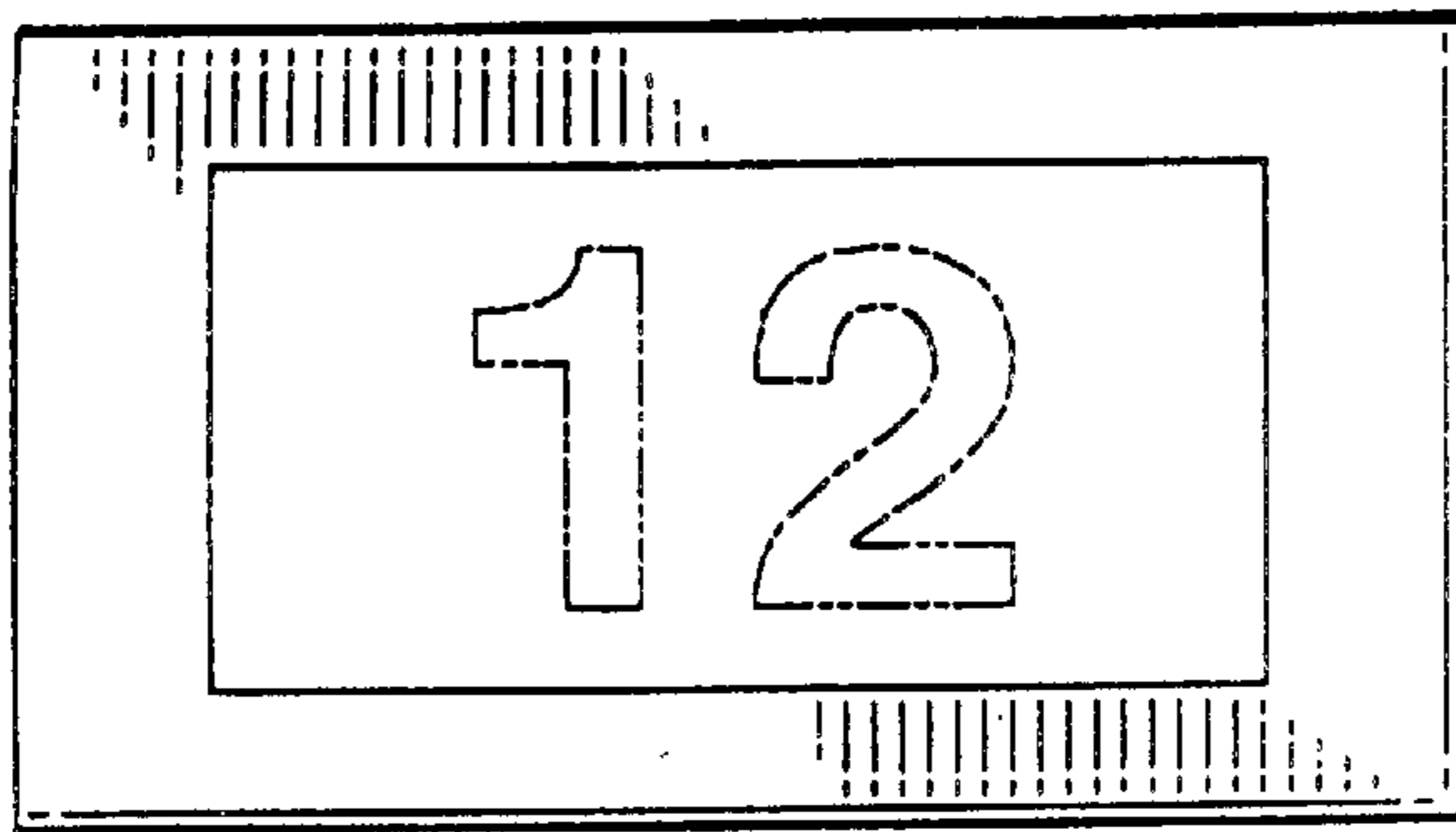

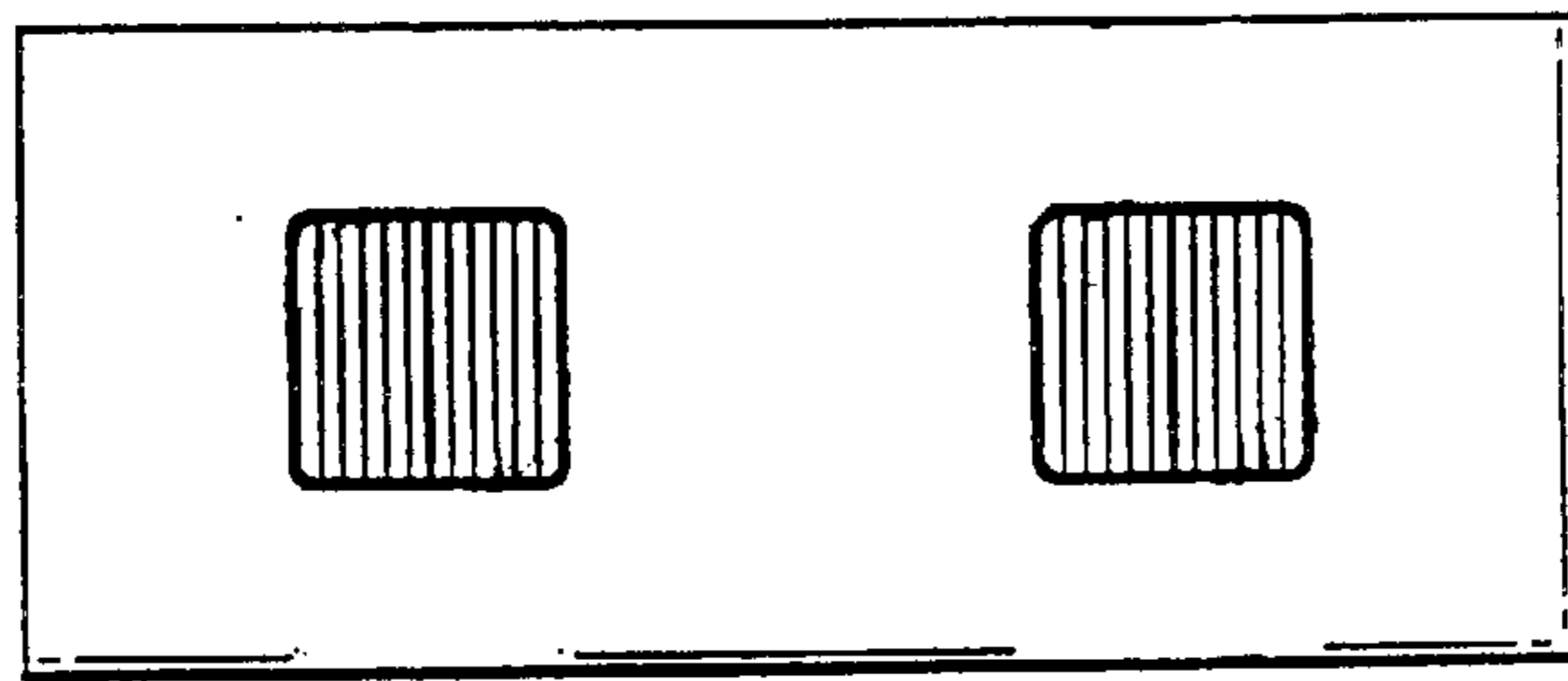

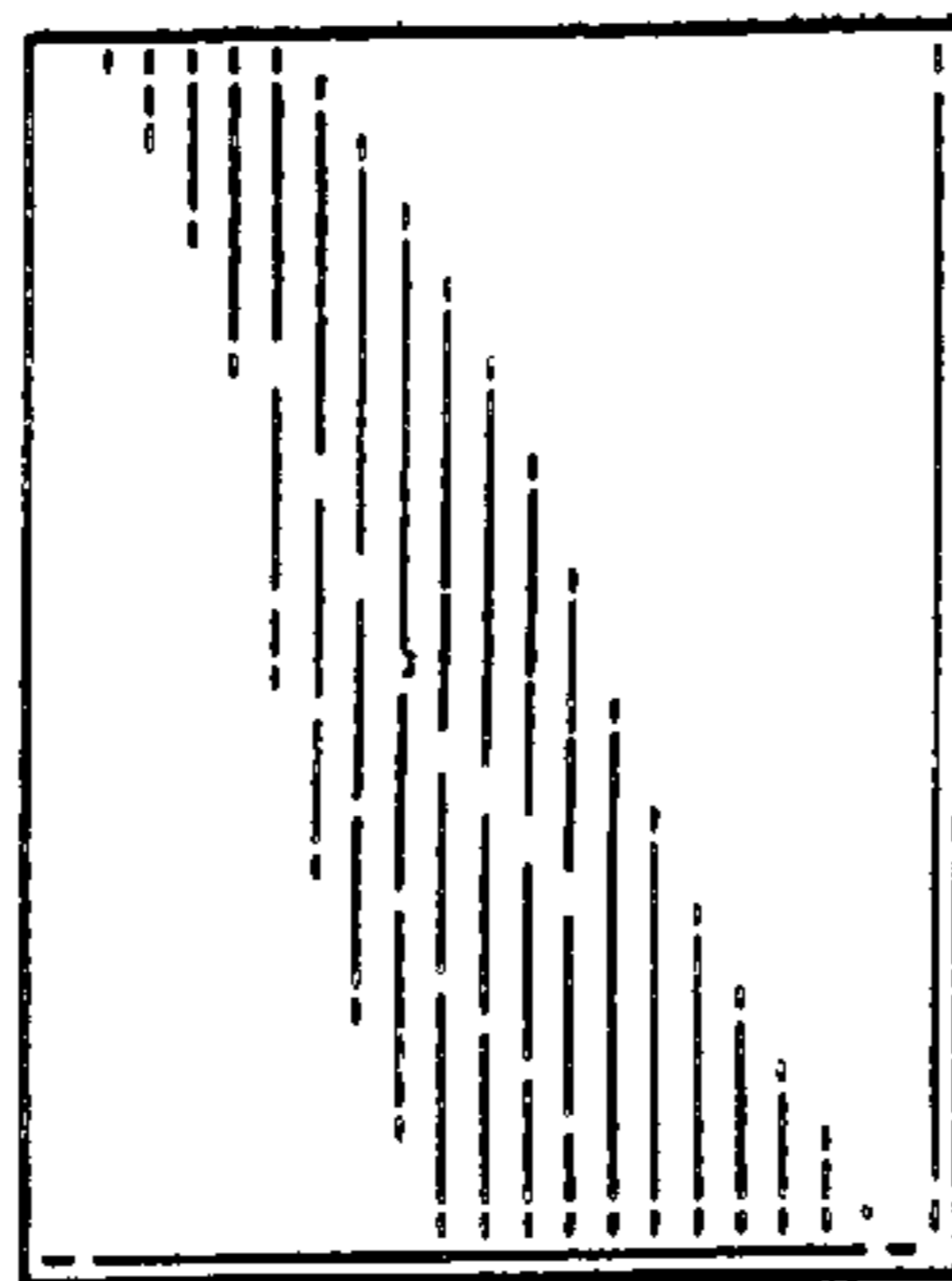

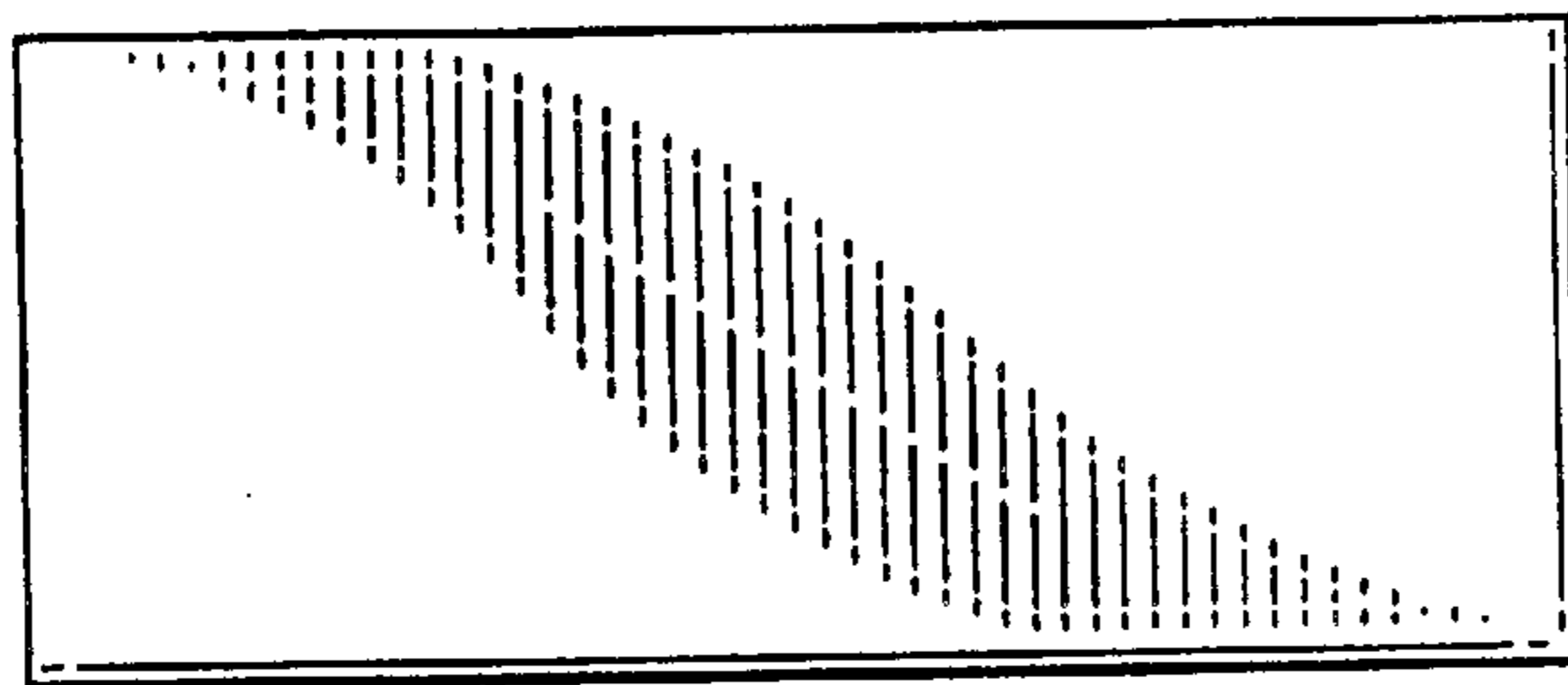

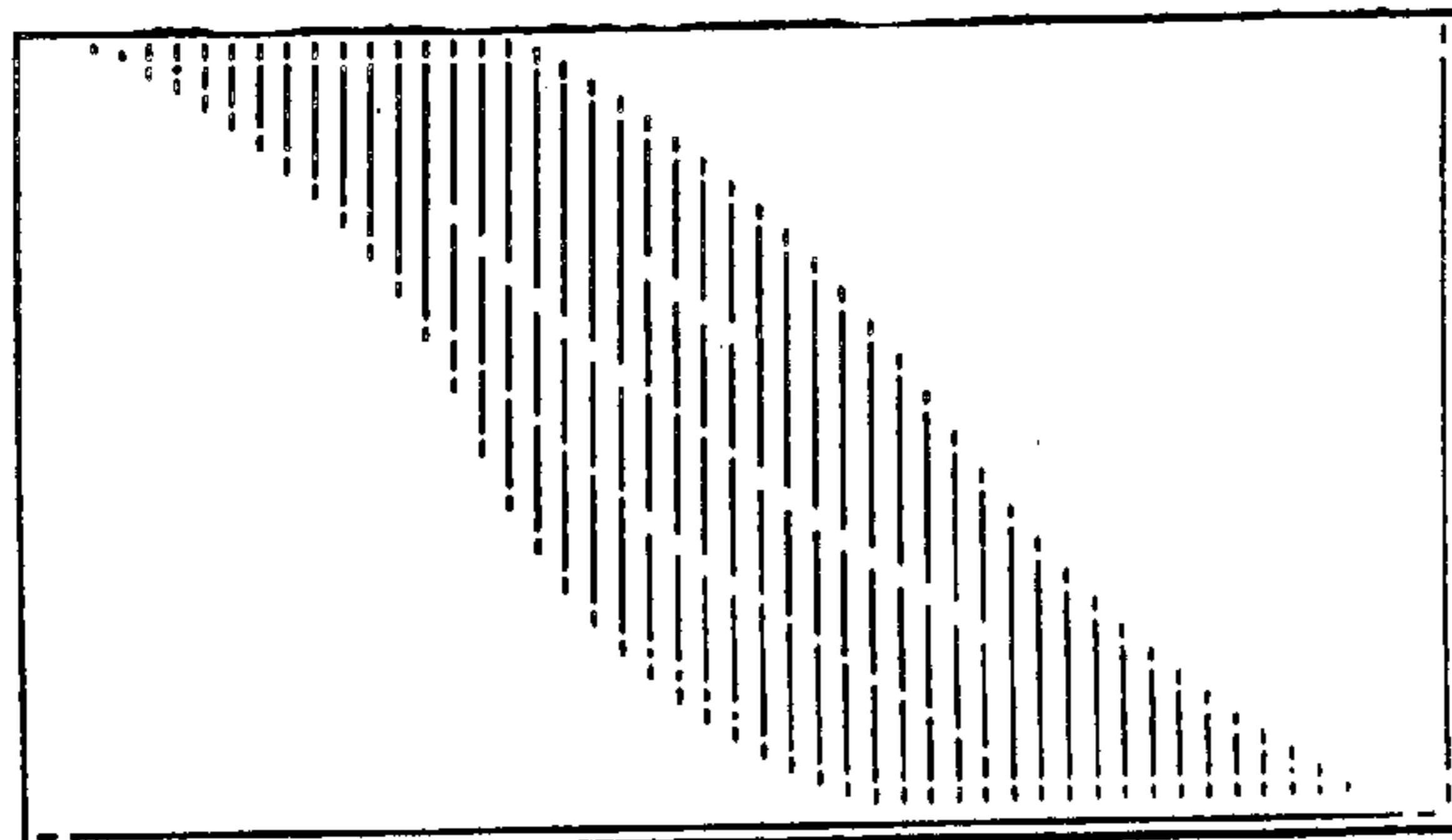
