DESCRIPTION

FIG. 17 is a rear elevation view thereof;

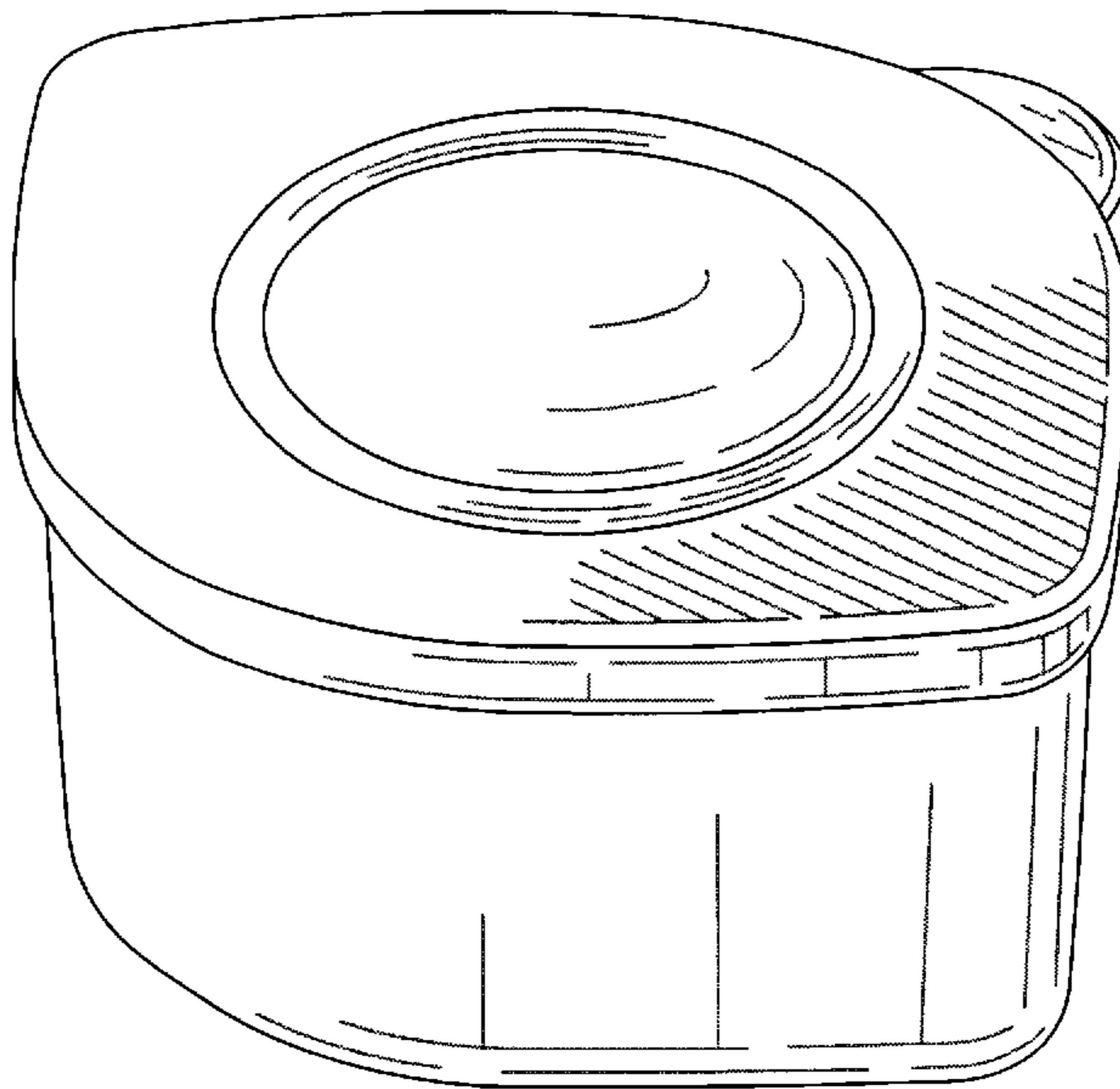
FIG. 18 is a right side elevation view thereof;

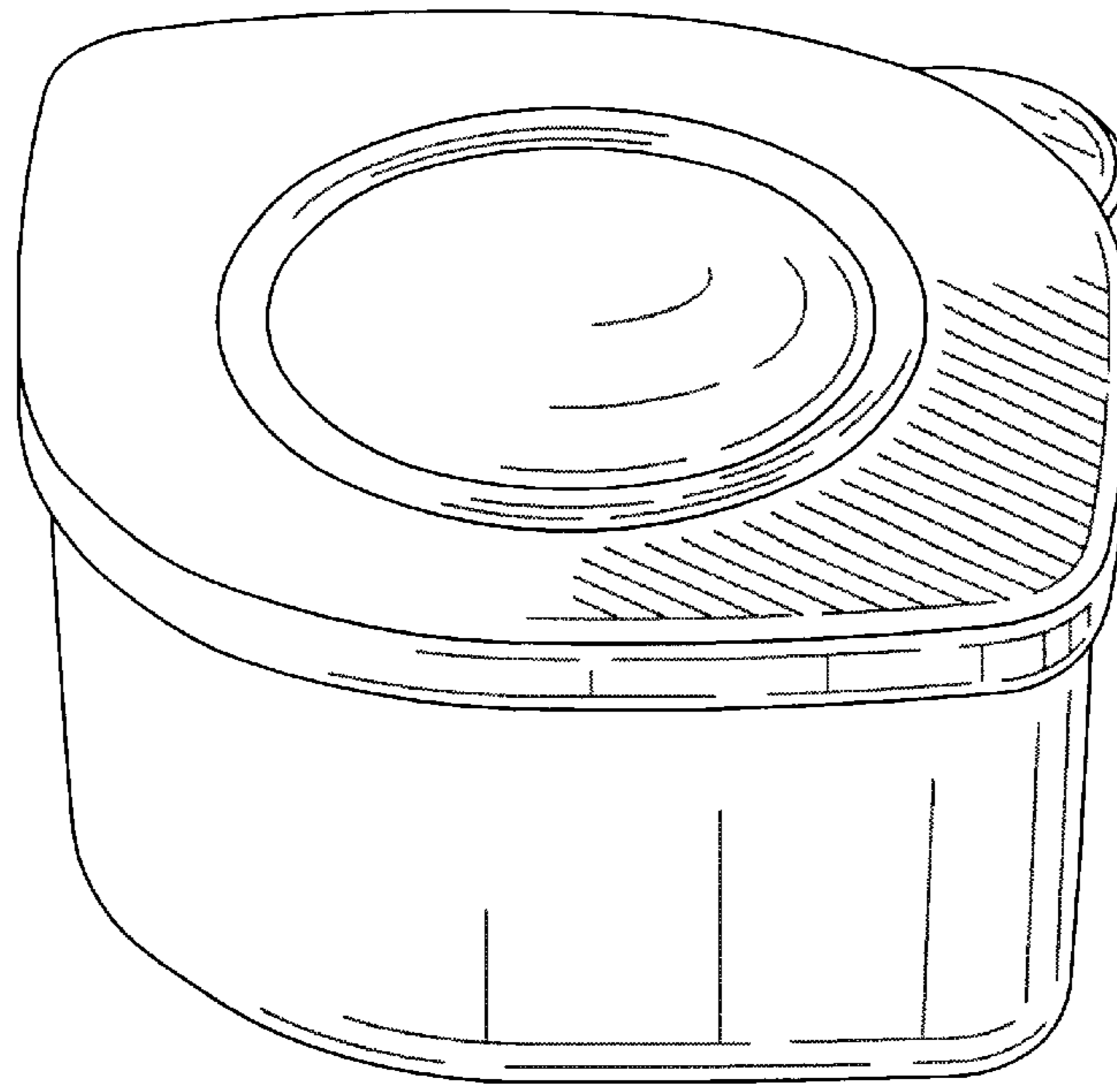

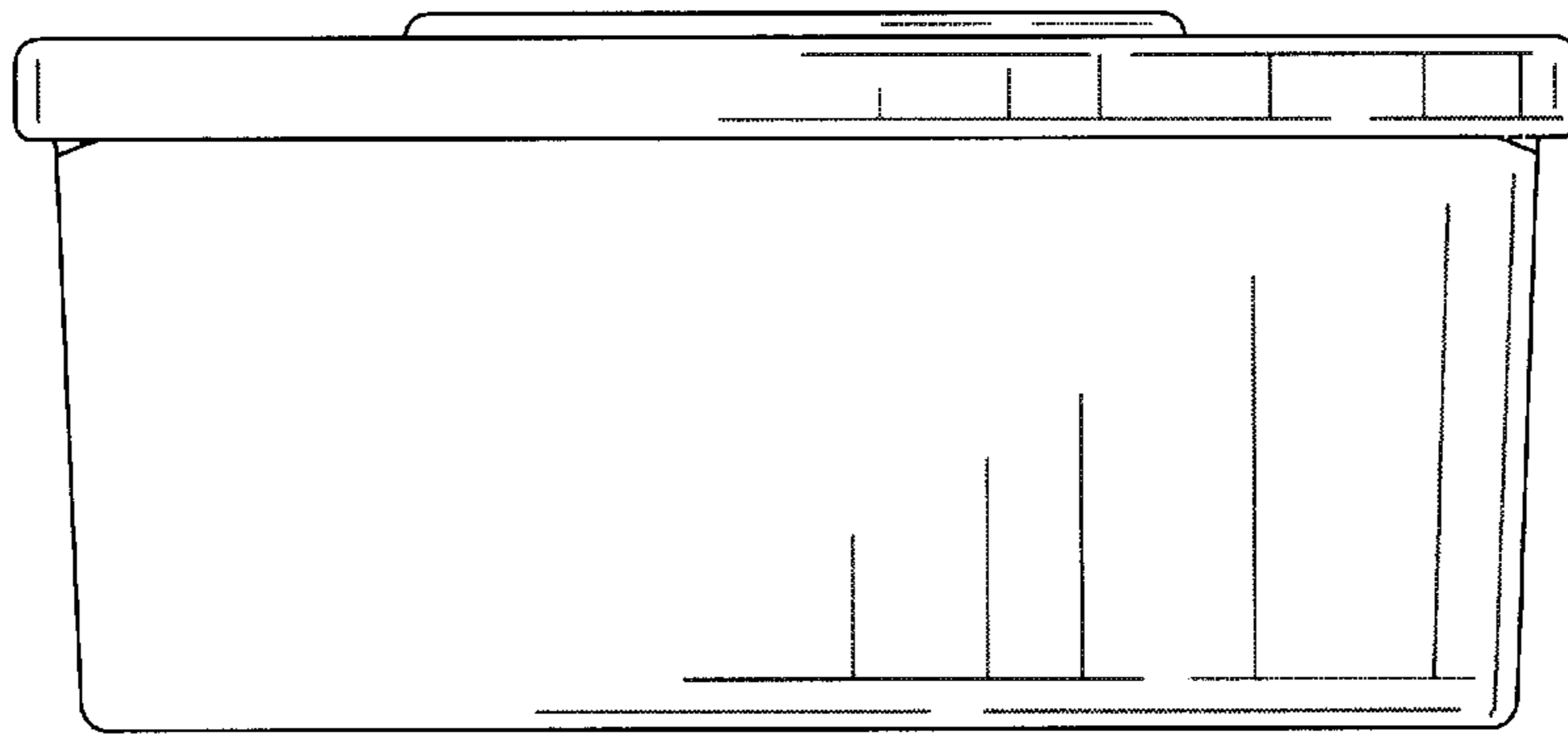

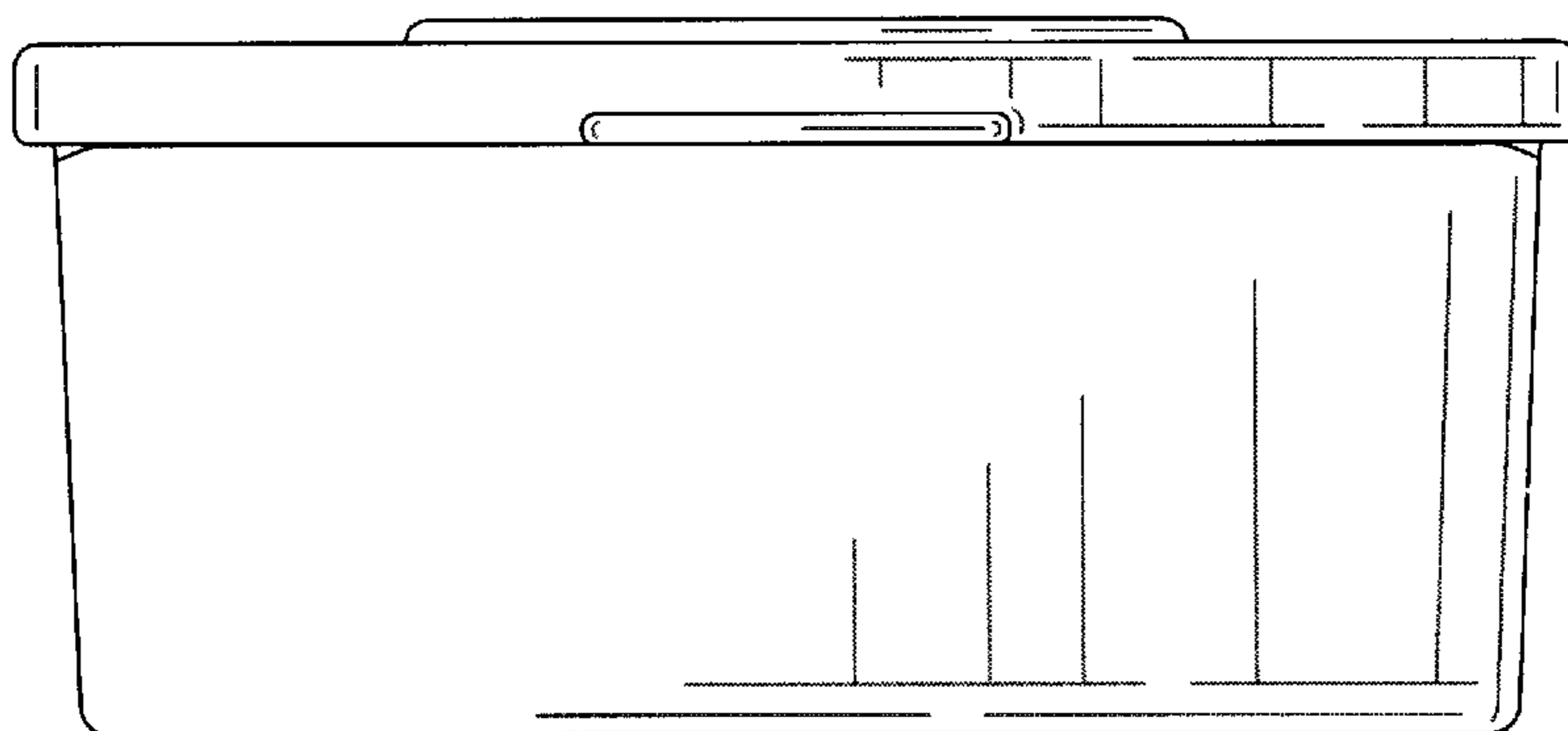

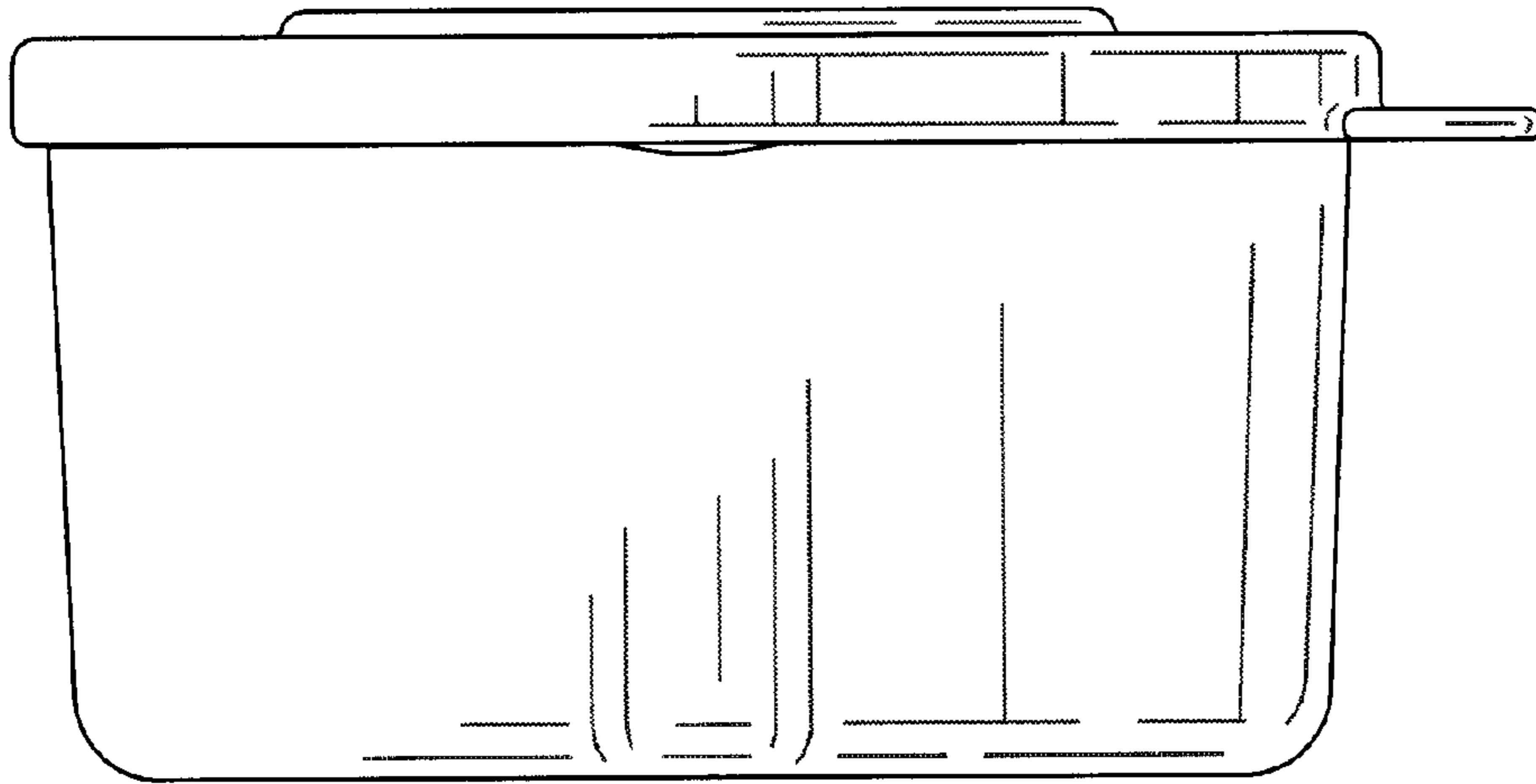

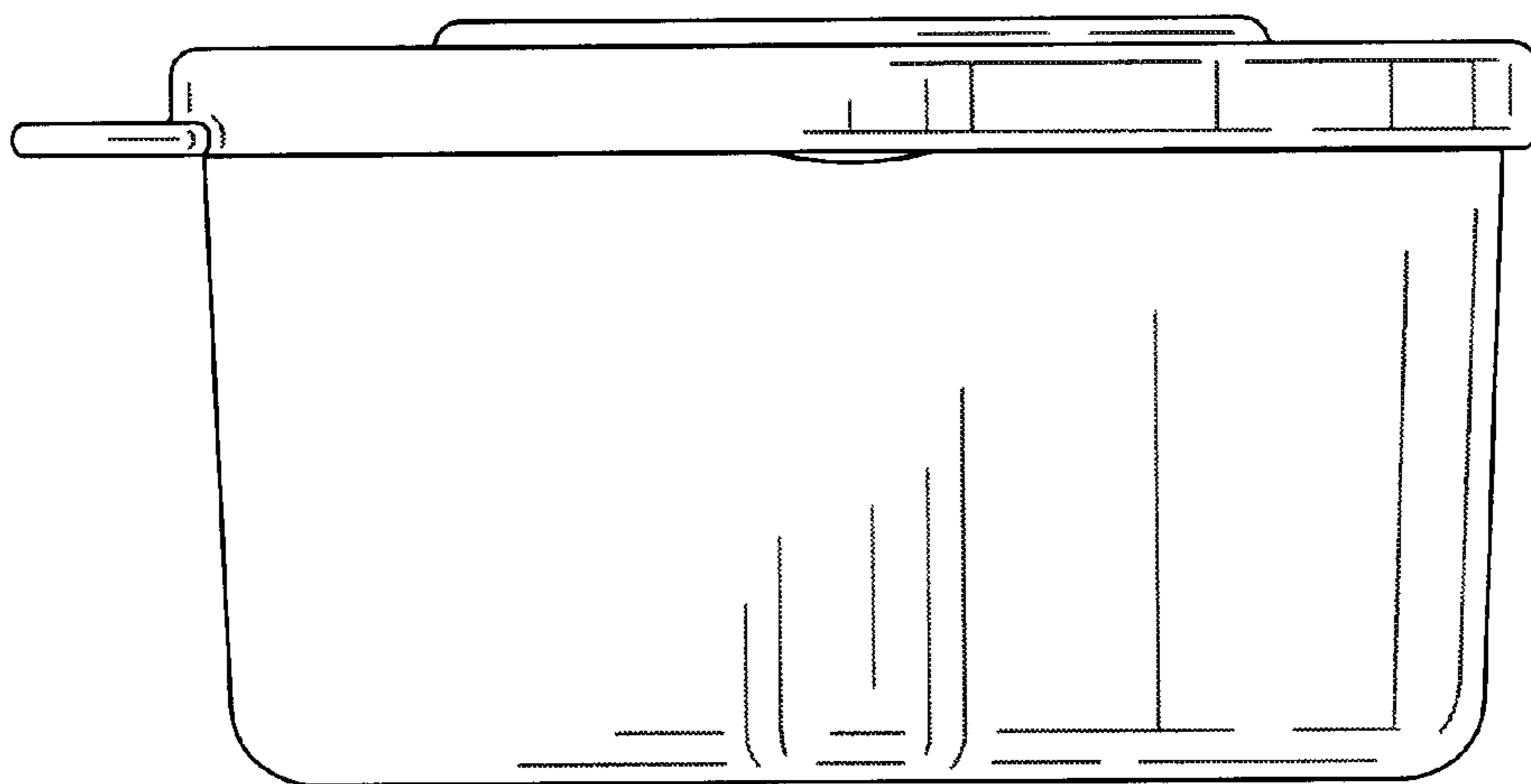

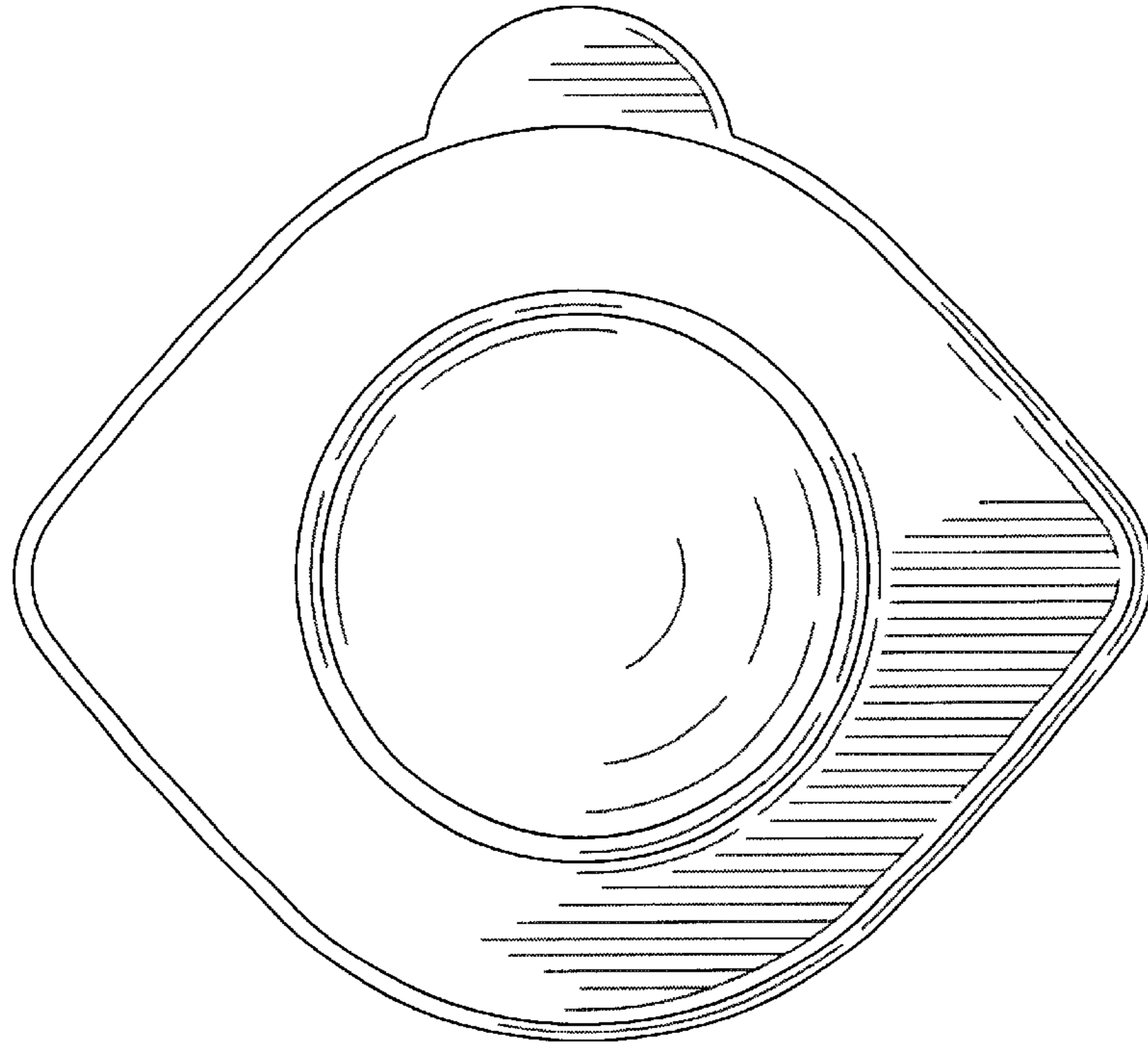

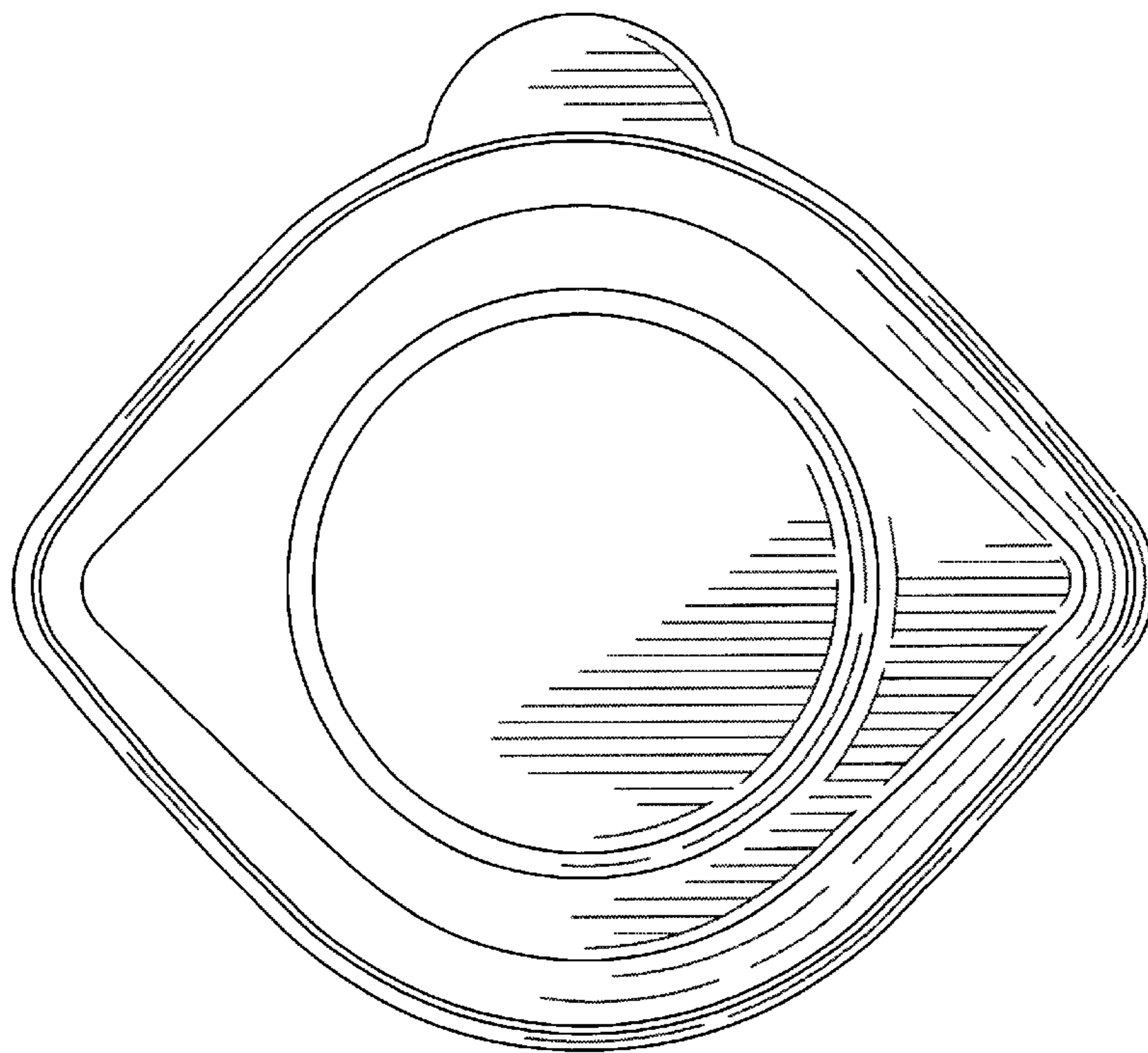

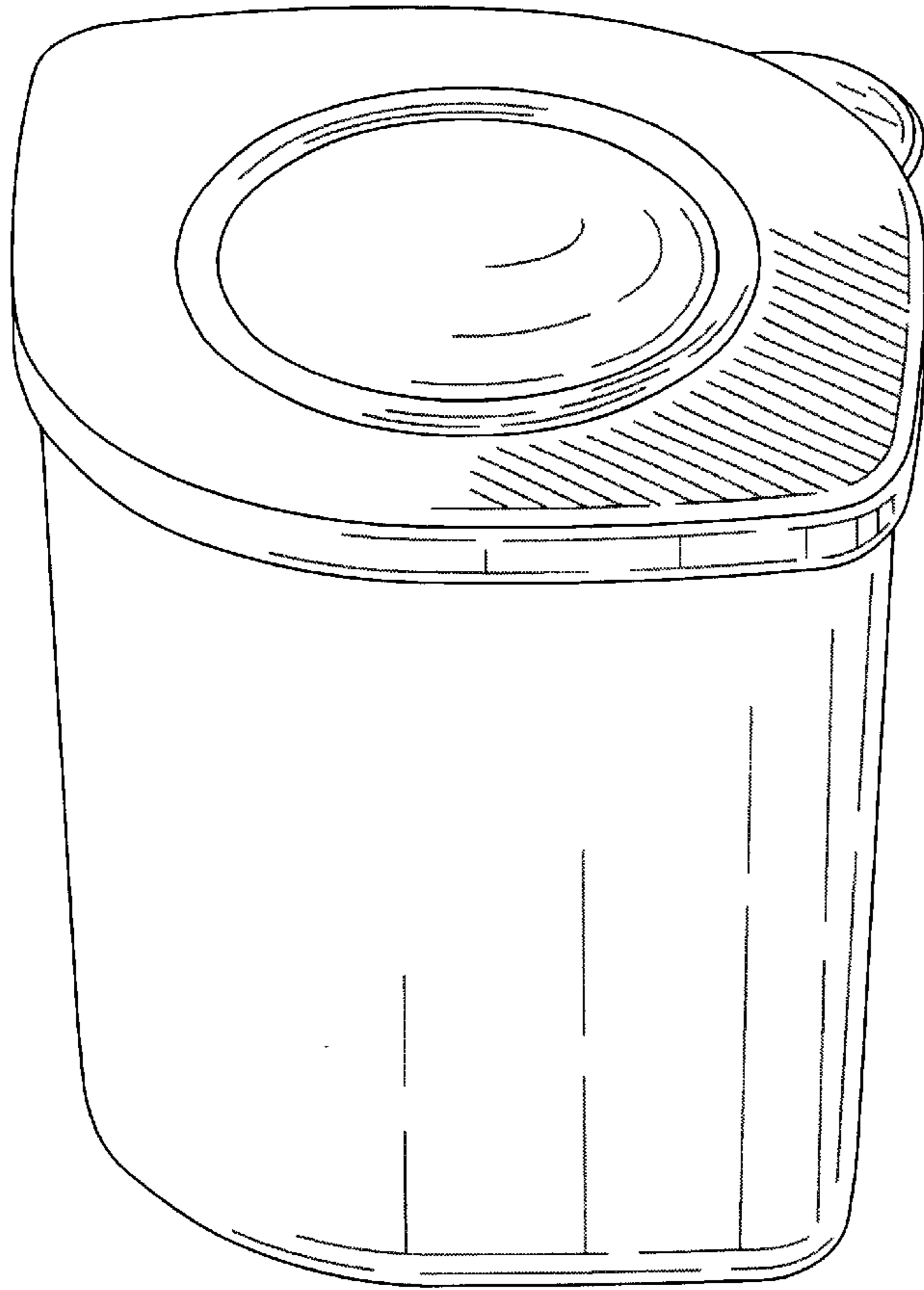

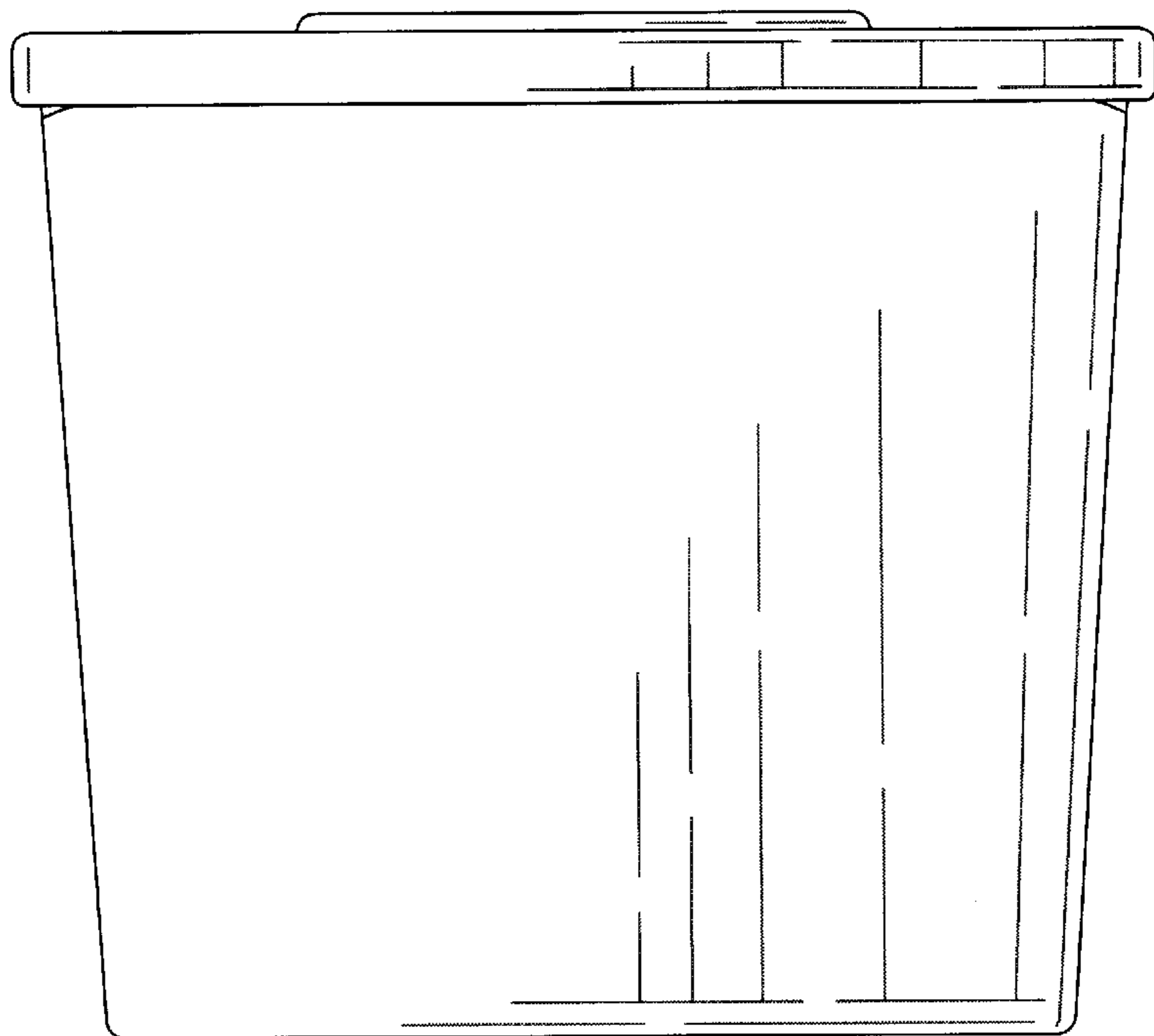

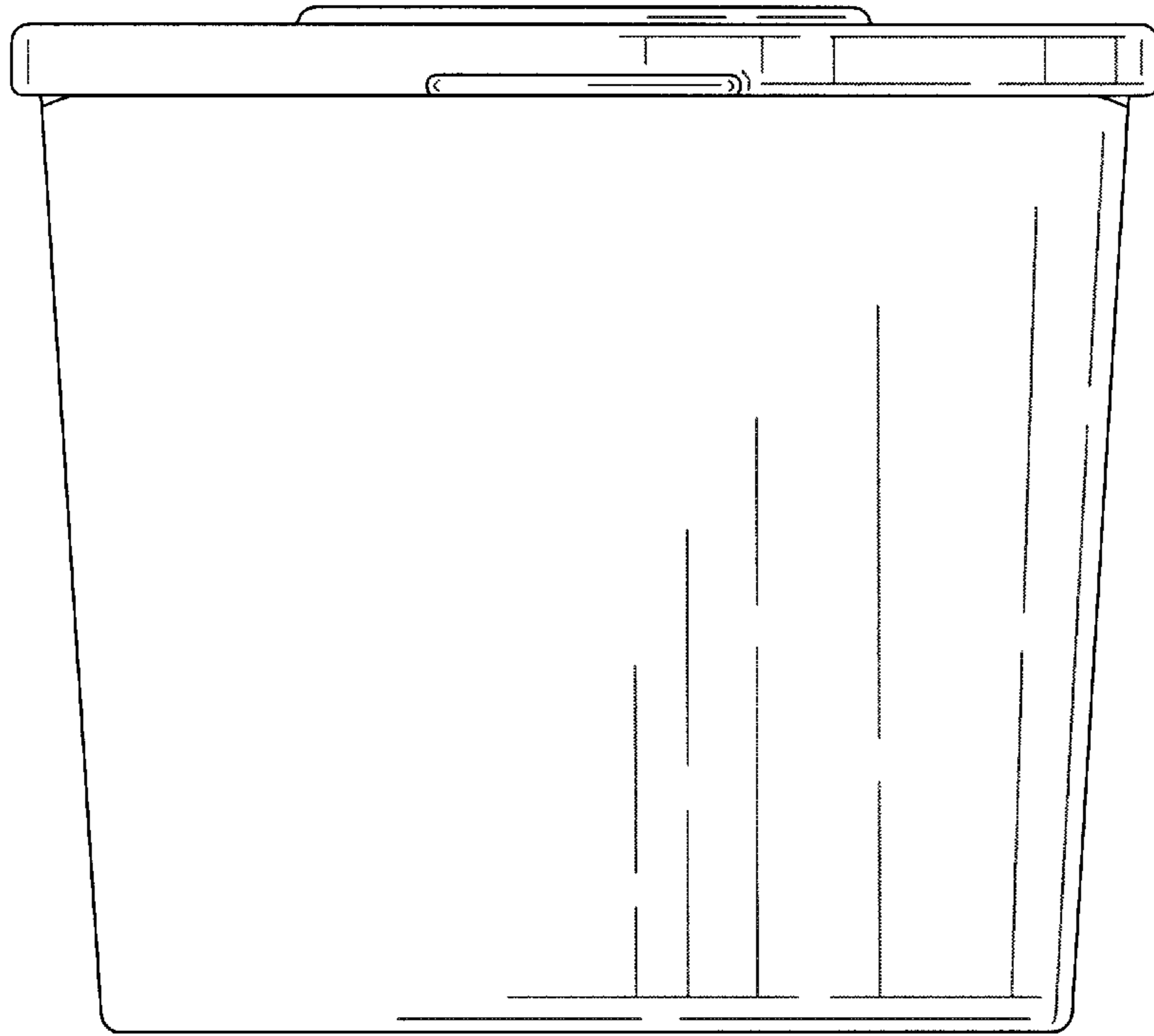

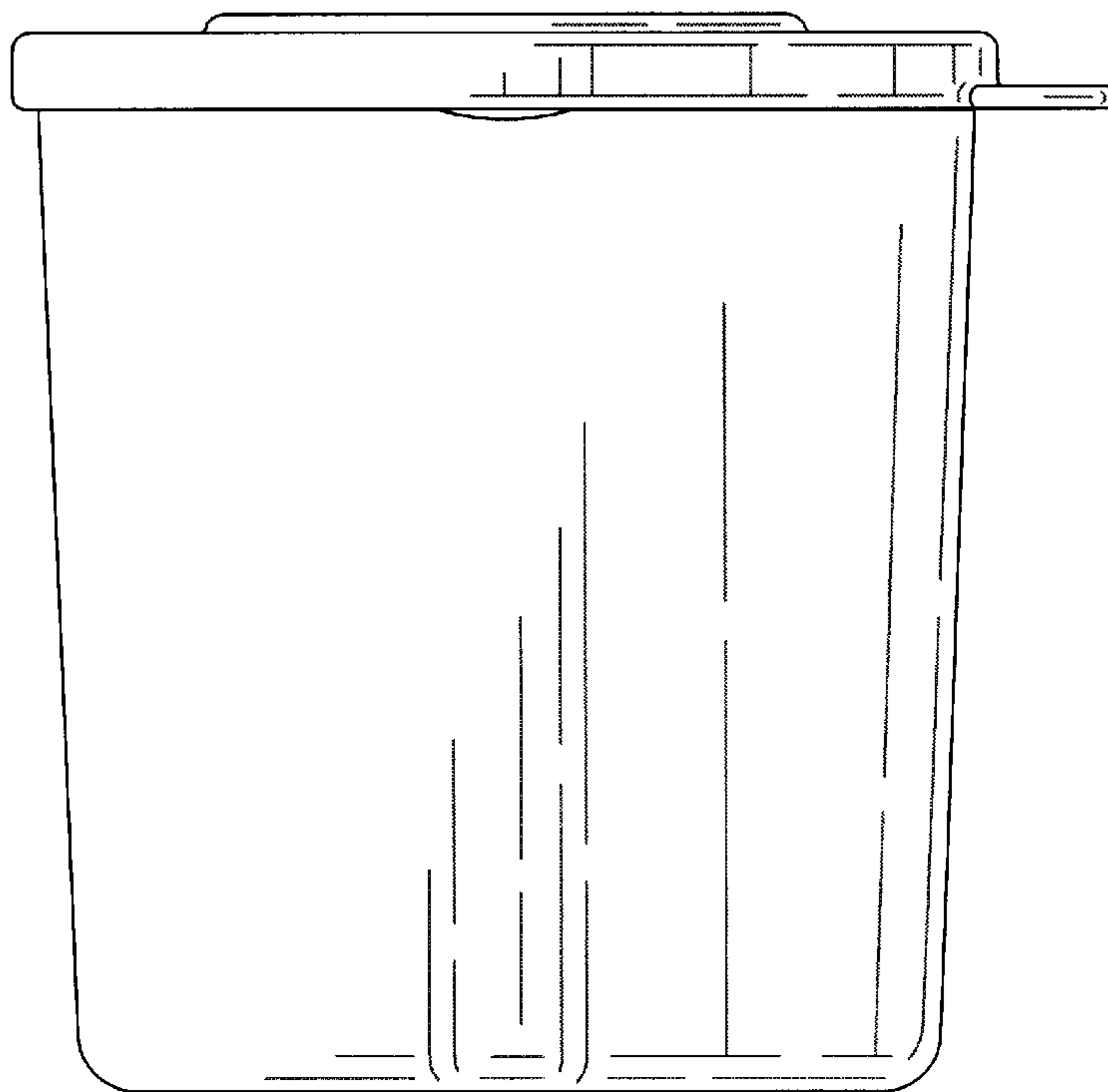

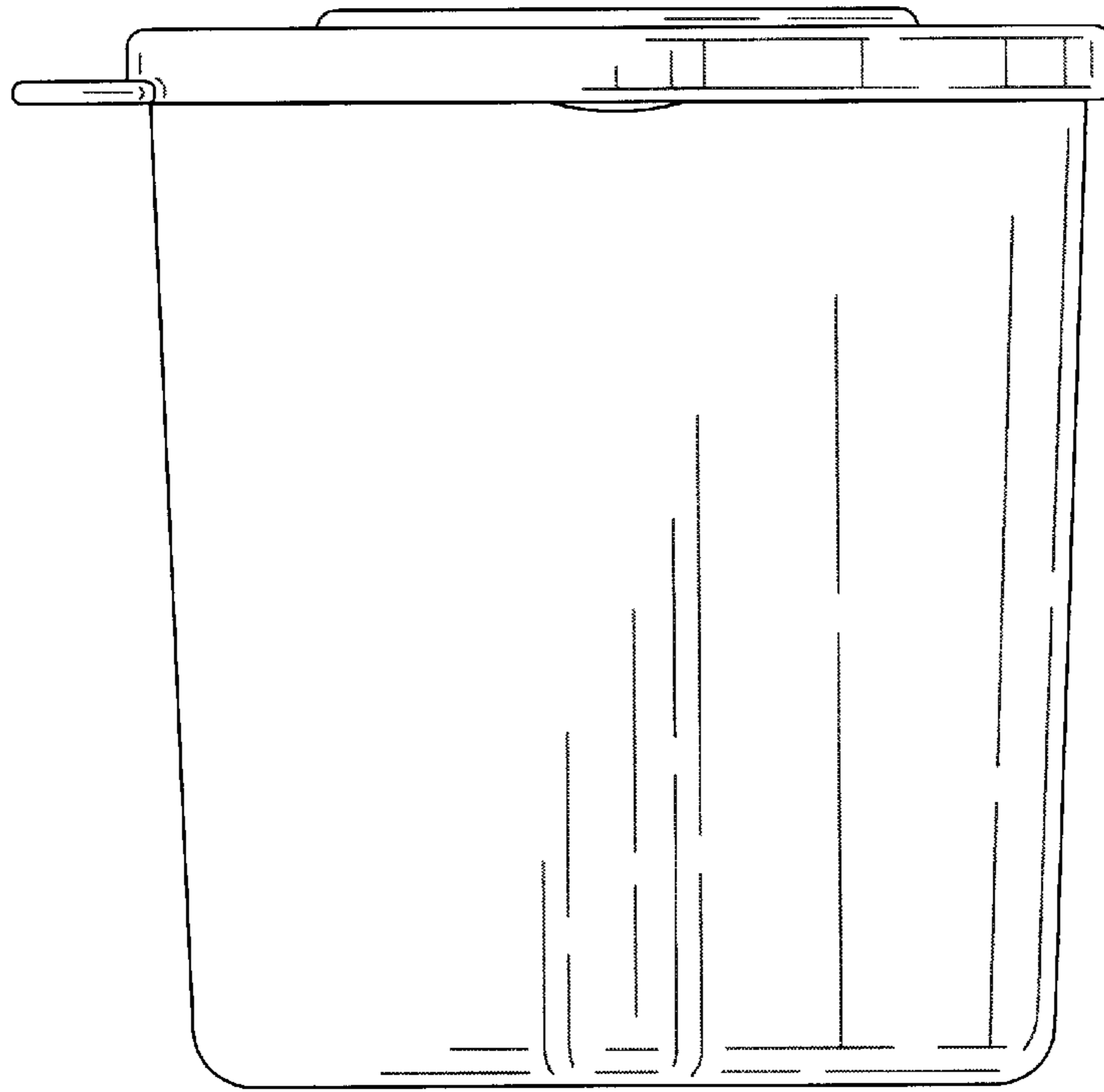

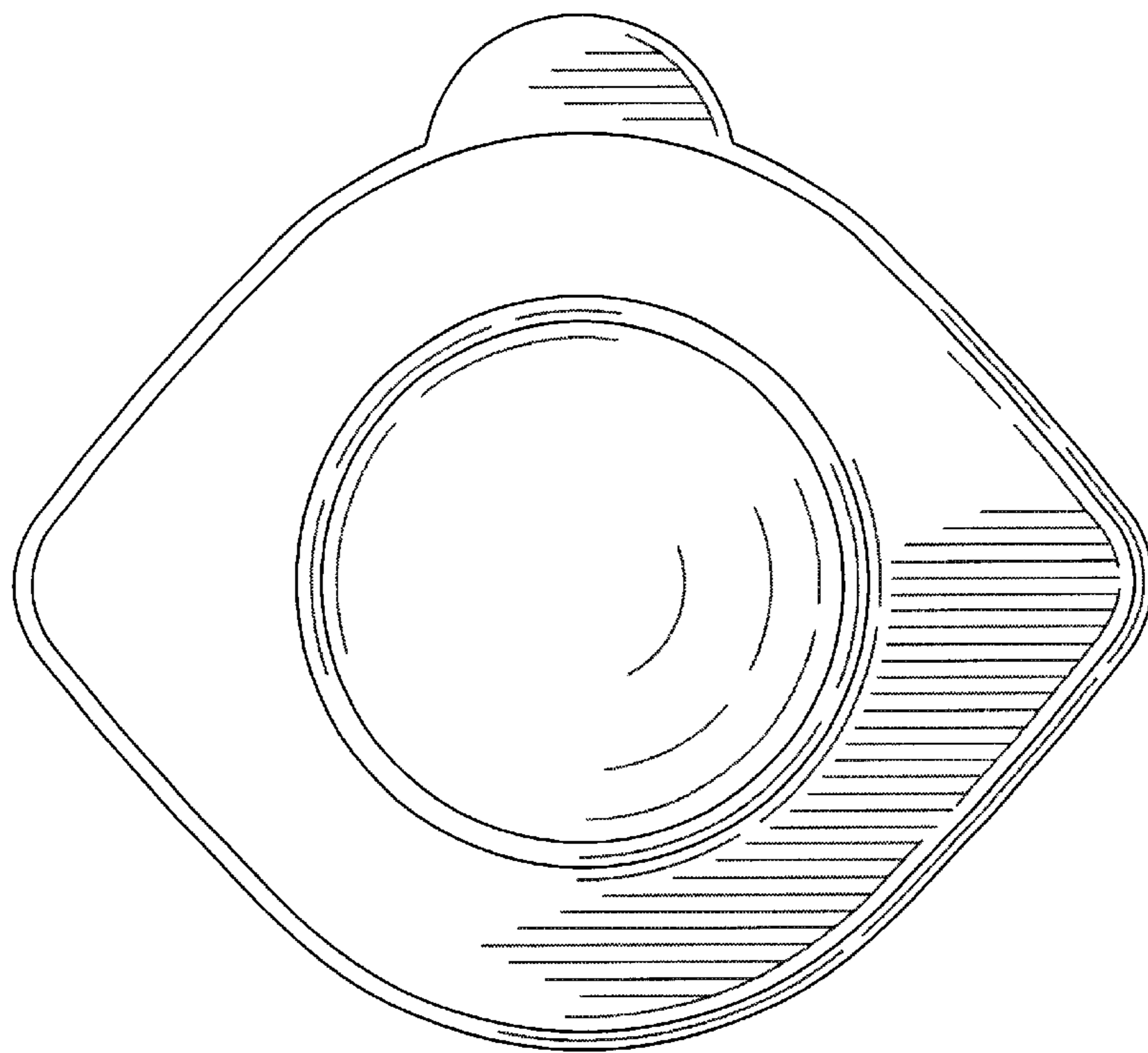

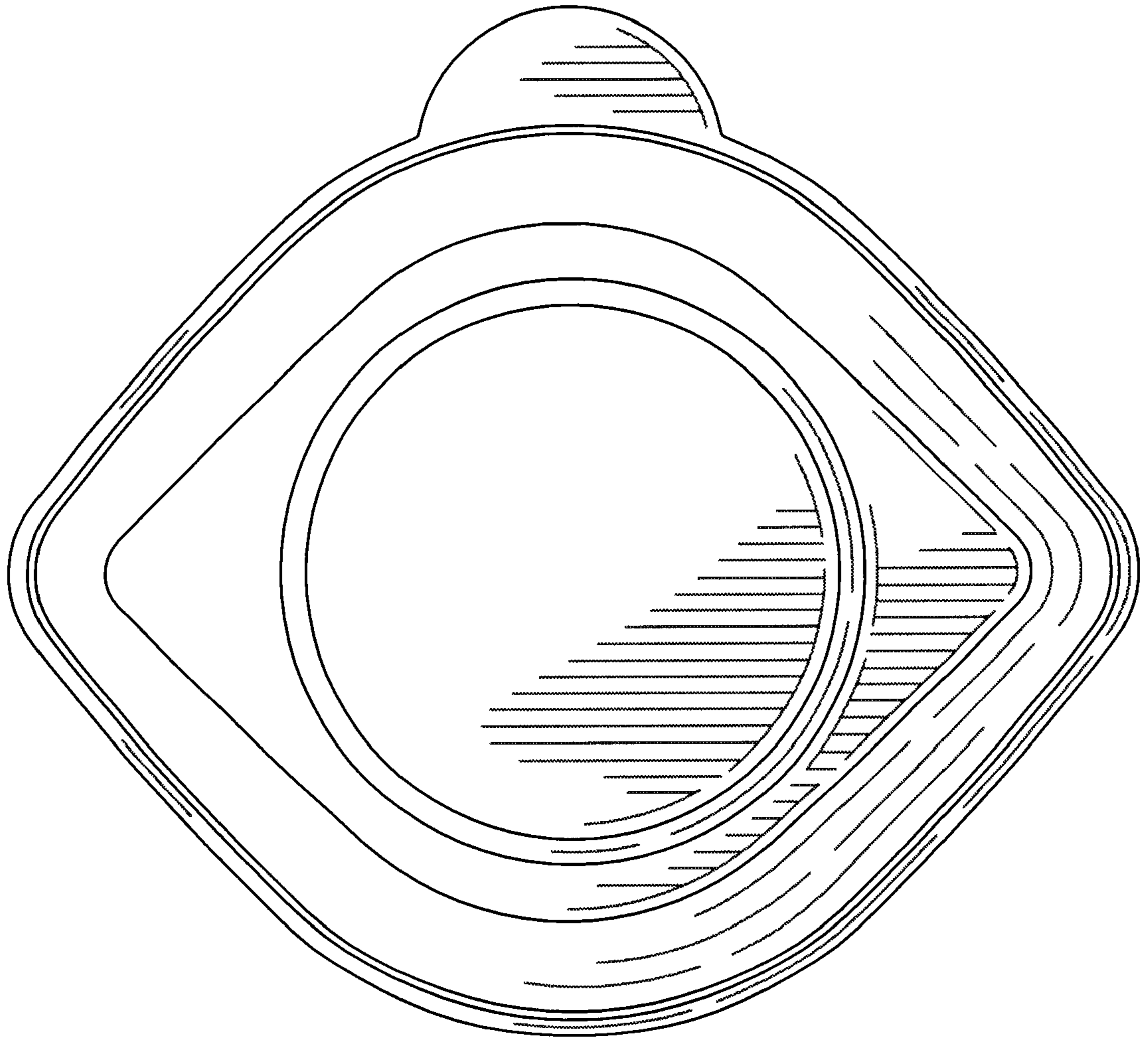

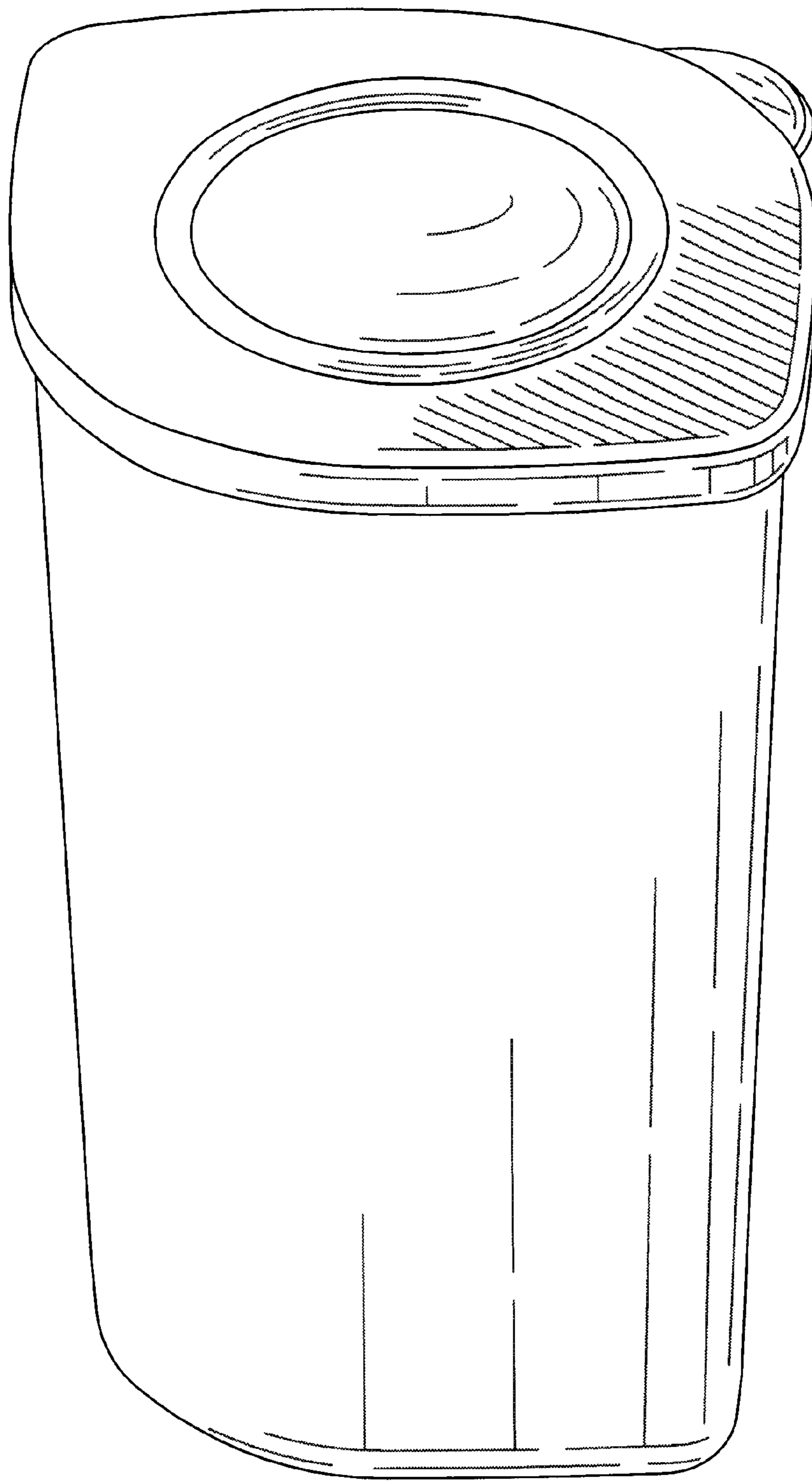

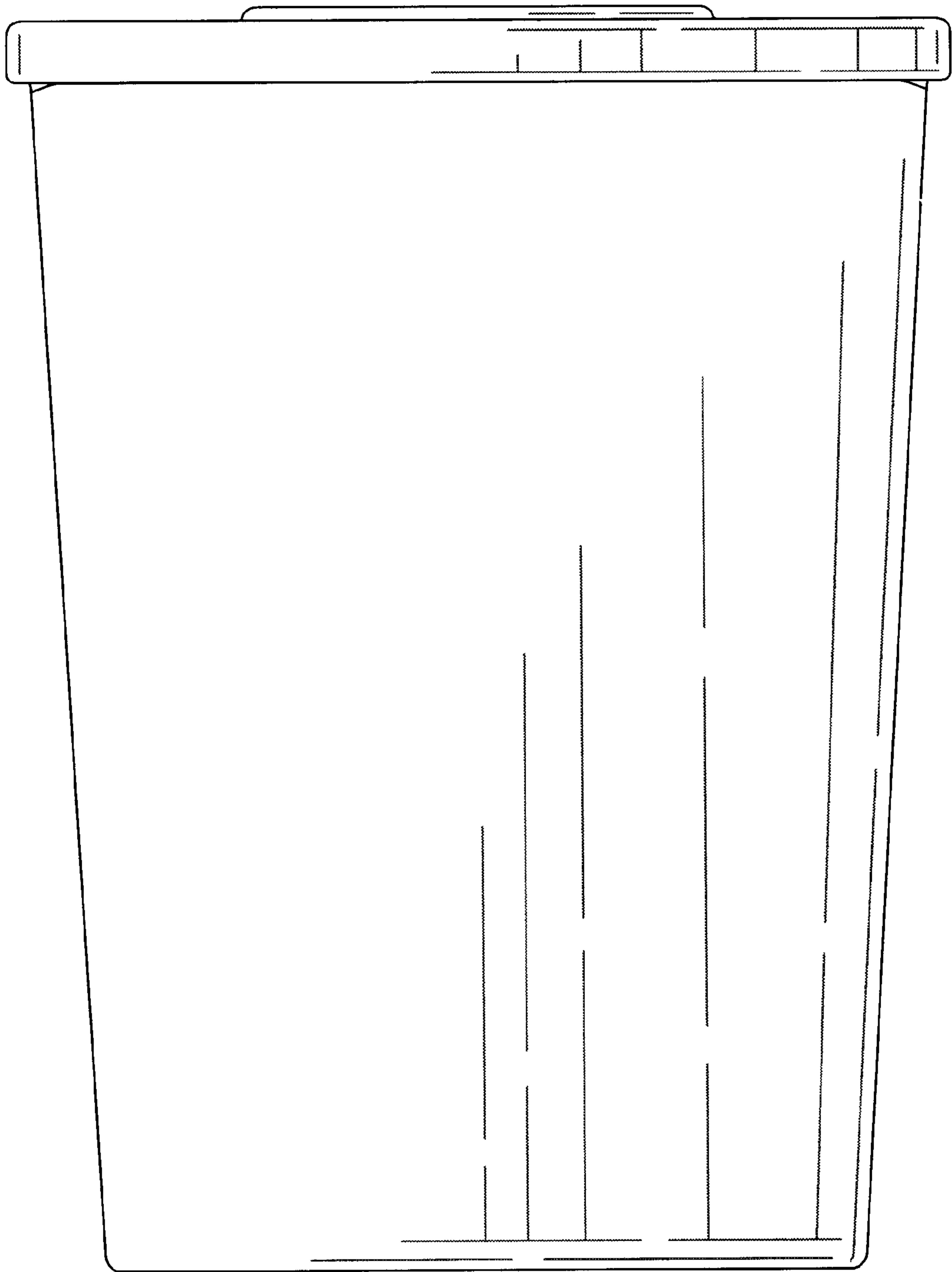

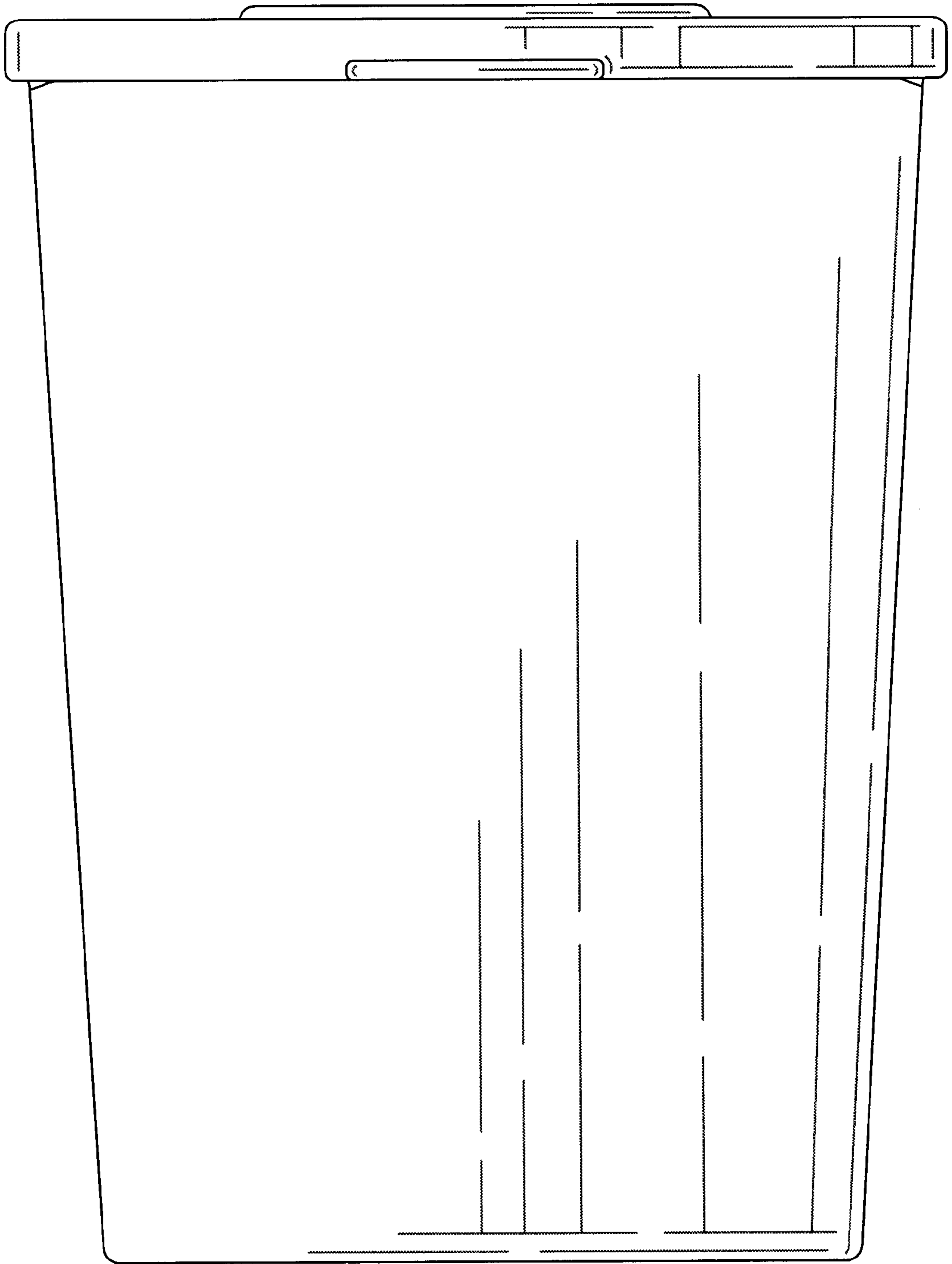

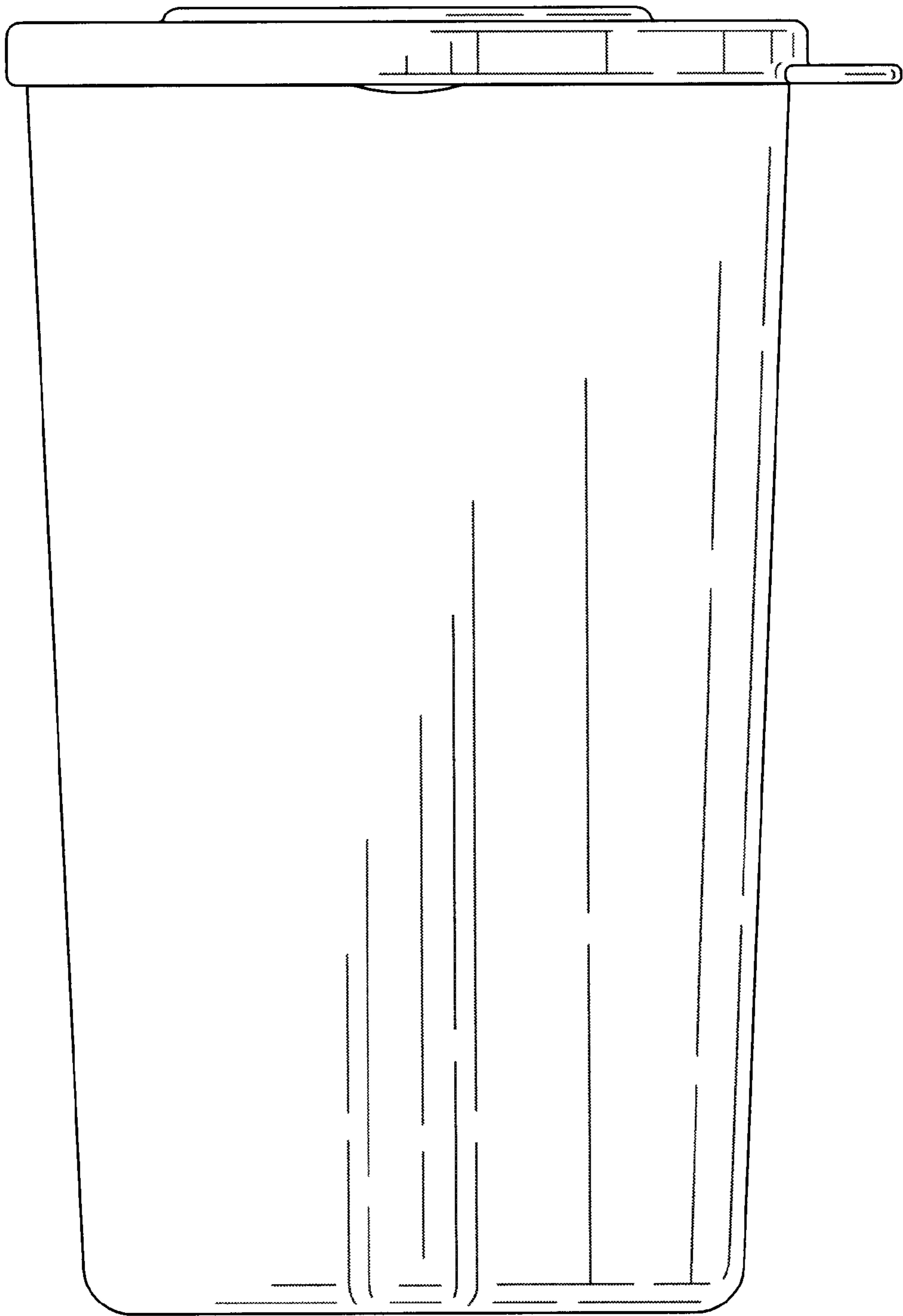

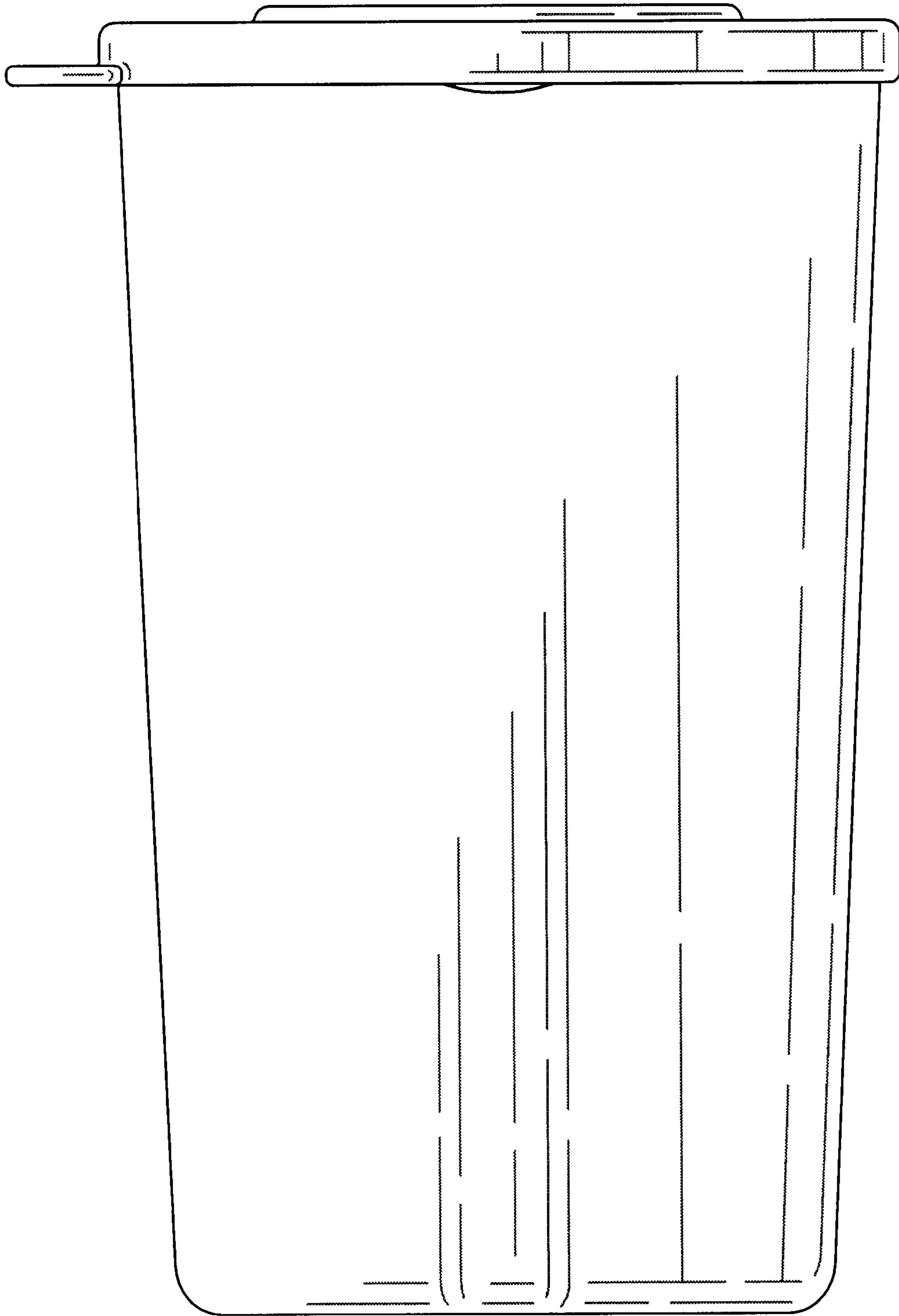

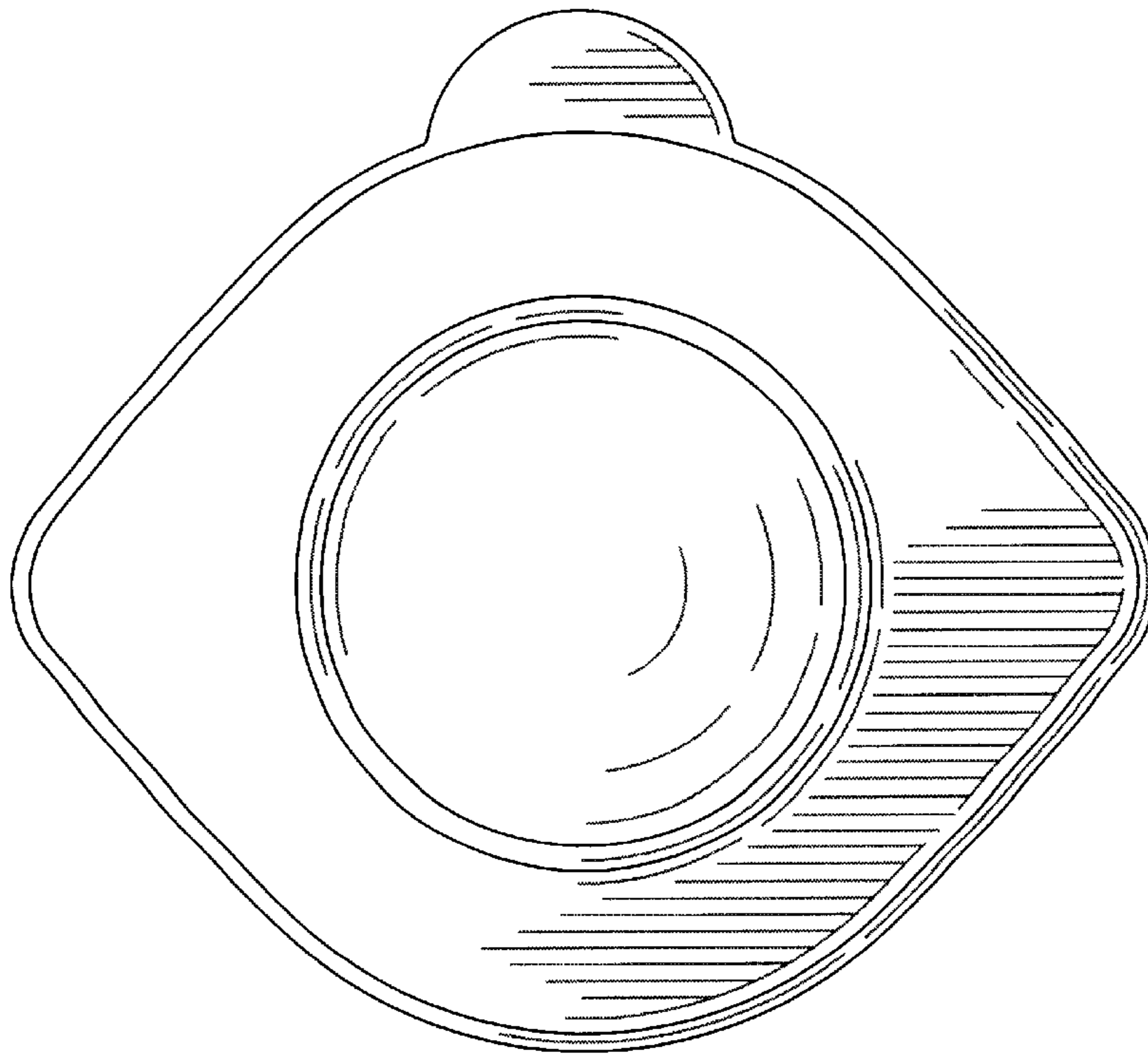

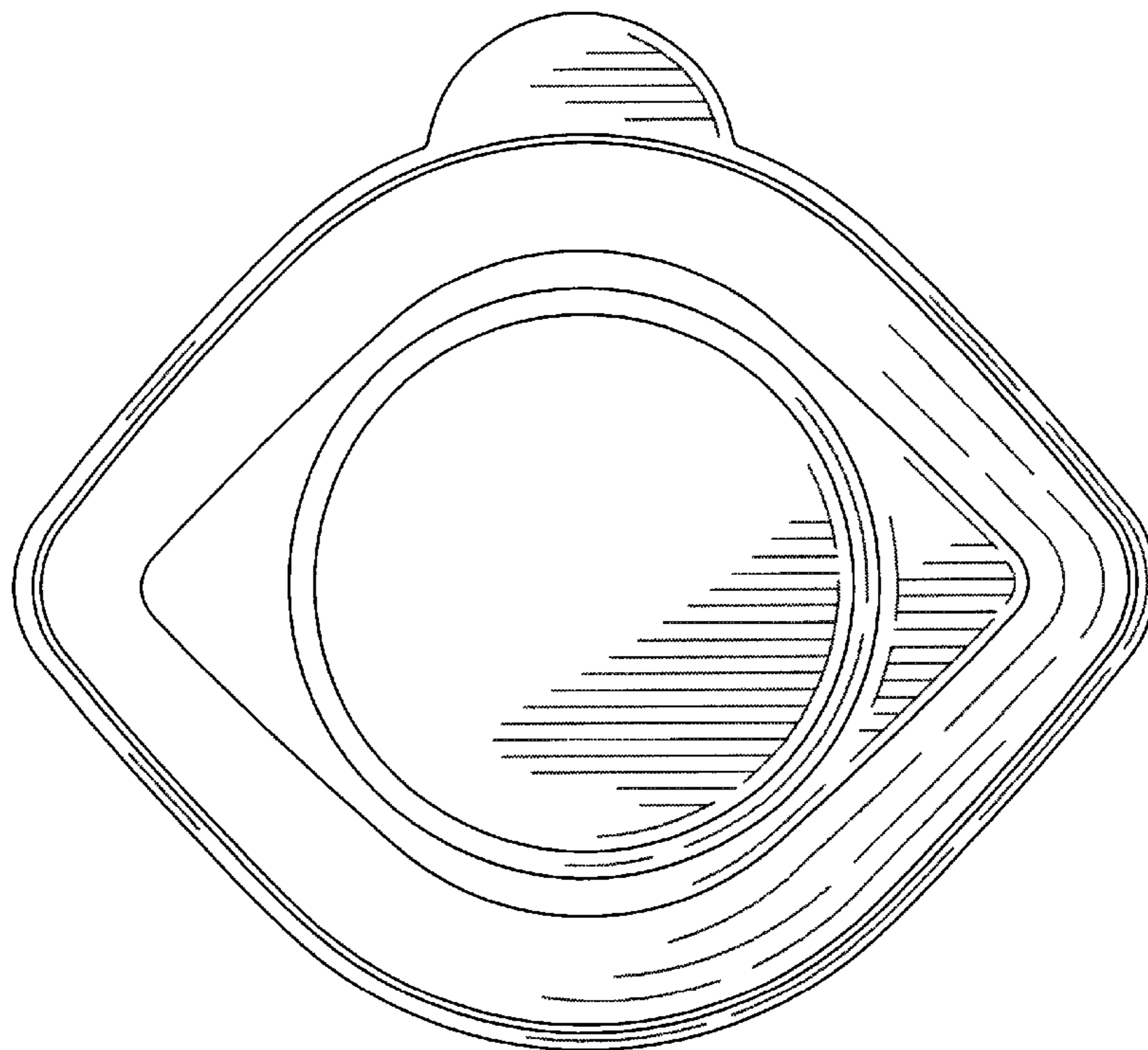
