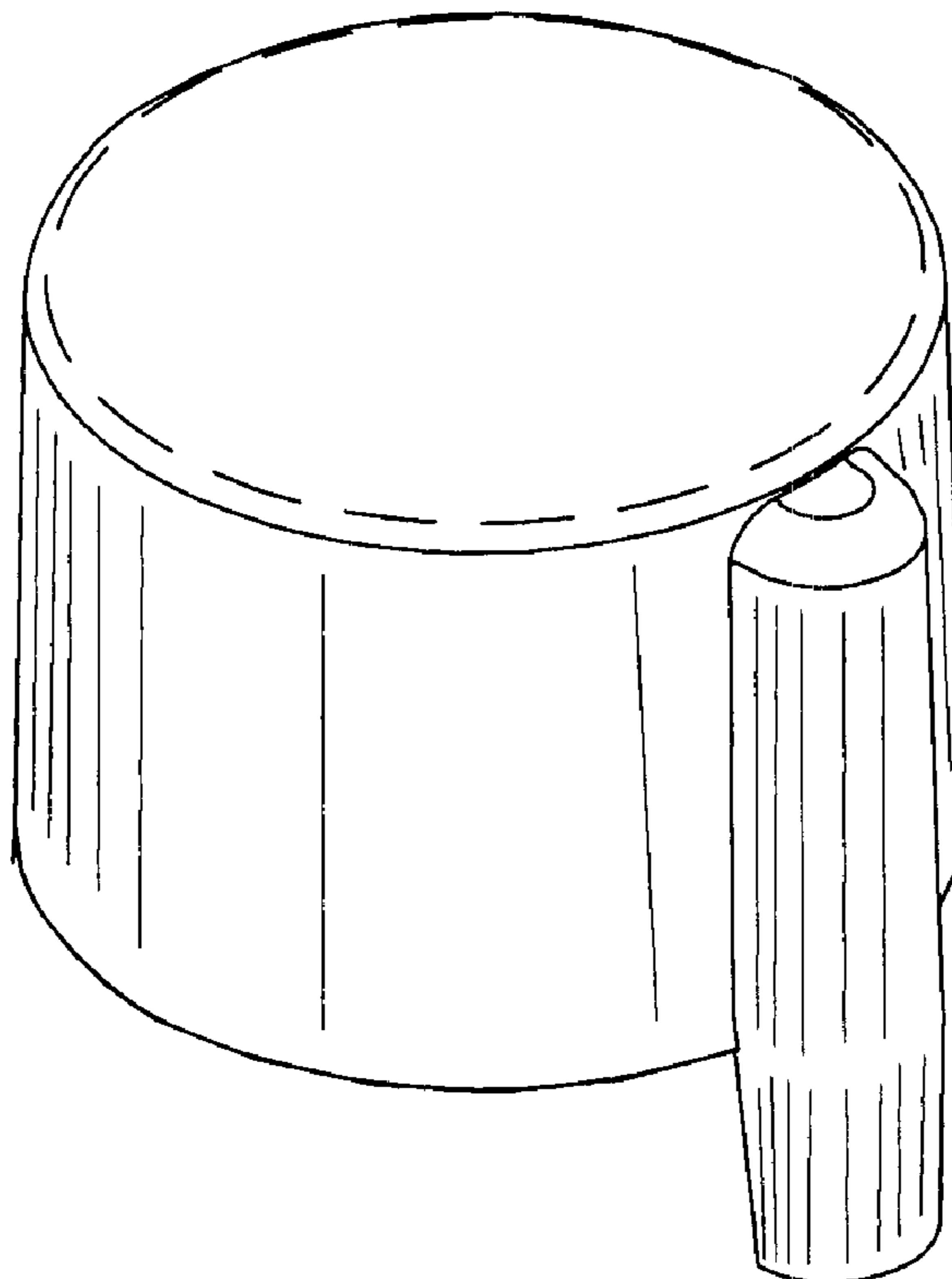

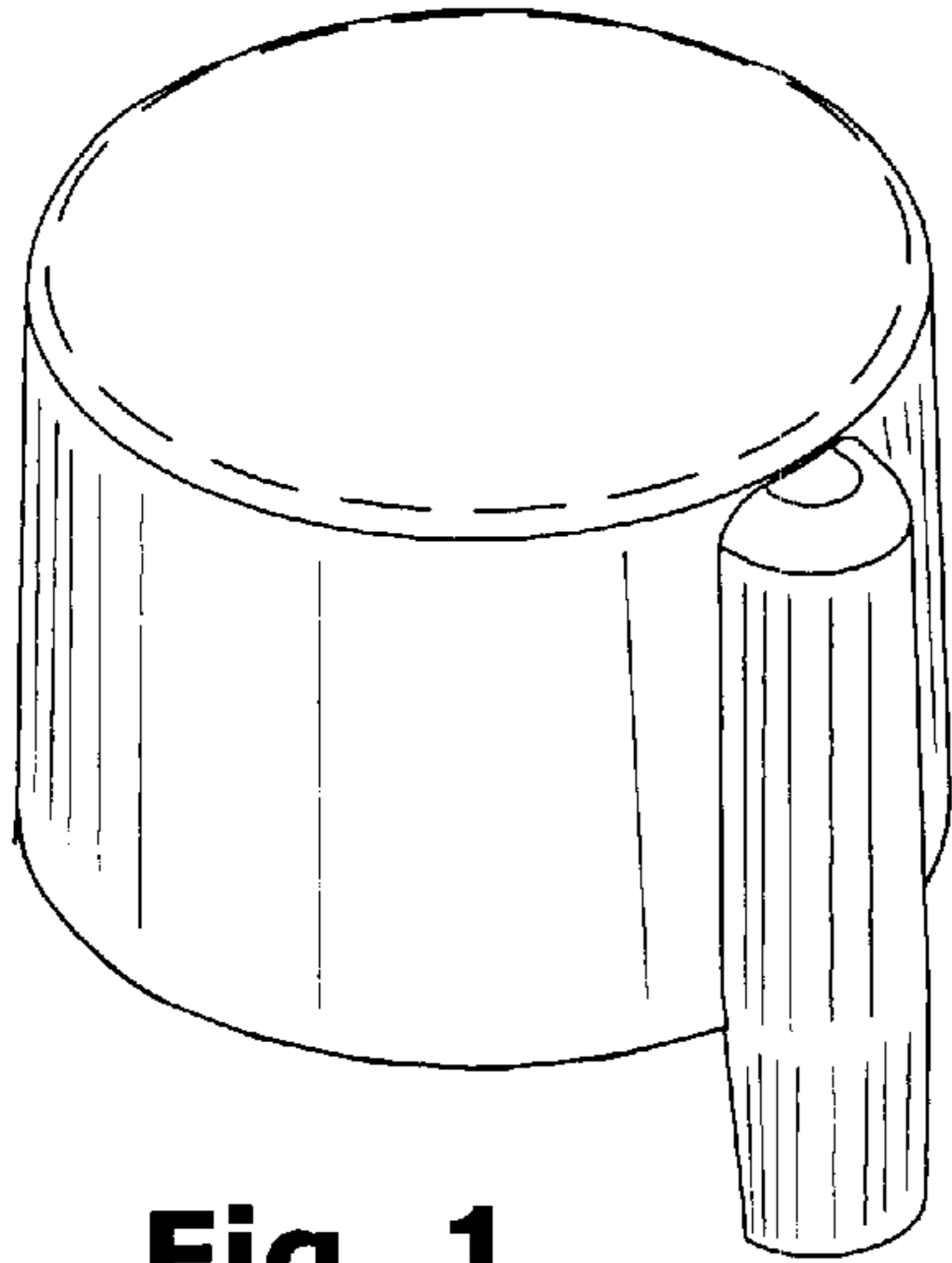
The ornamental design for an aerosol dispenser cap, as shown and described.

**DESCRIPTION**

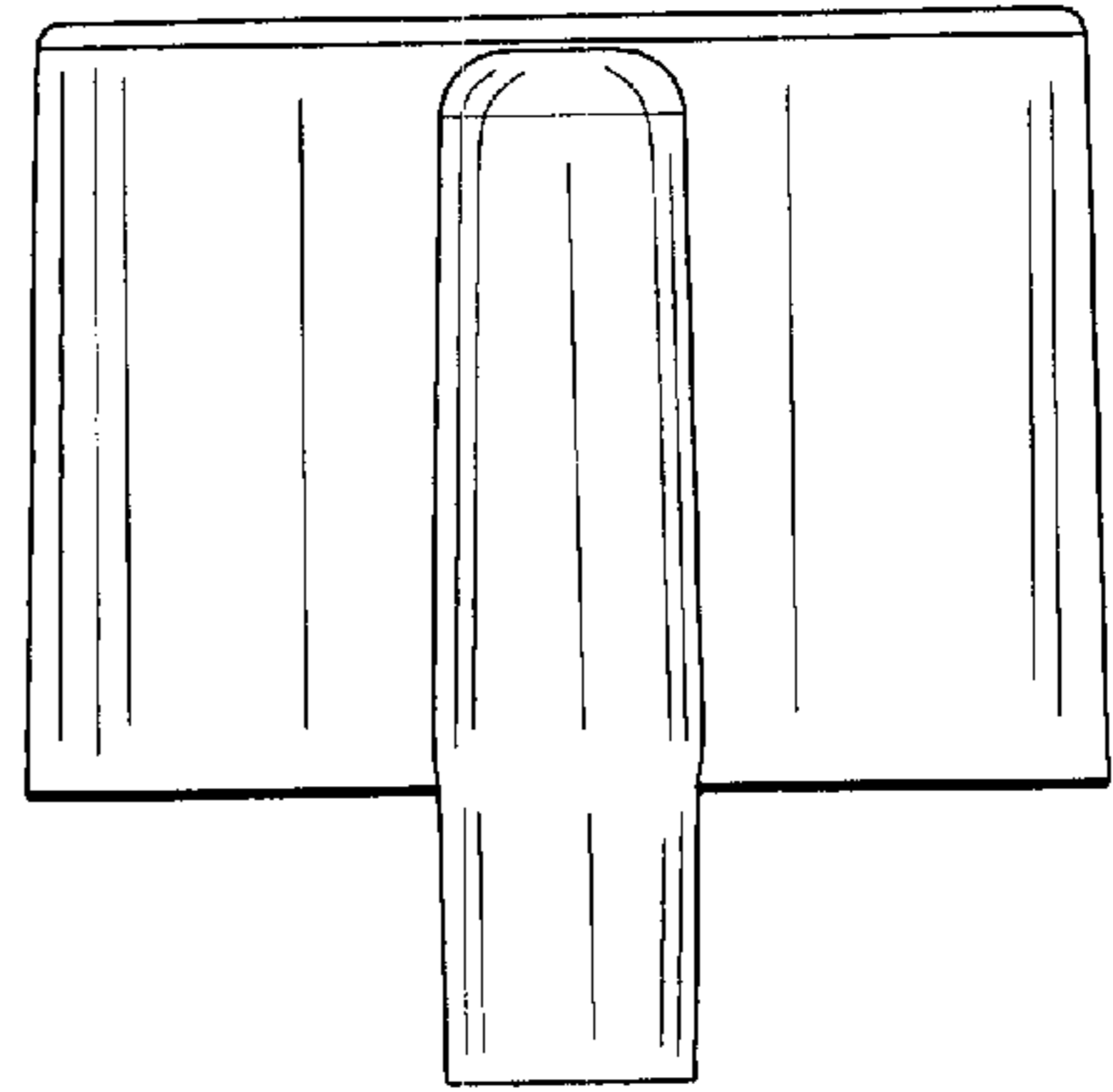
FIG. 1 is a perspective view of the aerosol dispenser cap of the claimed design;  
FIG. 2 is a front elevational view of the article shown in FIG. 1;  
FIG. 3 is a rear elevational view of the article shown in FIG. 1;  
FIG. 4 is a side elevational view of the article shown in FIG. 1, the opposite side view being a mirror image thereof;

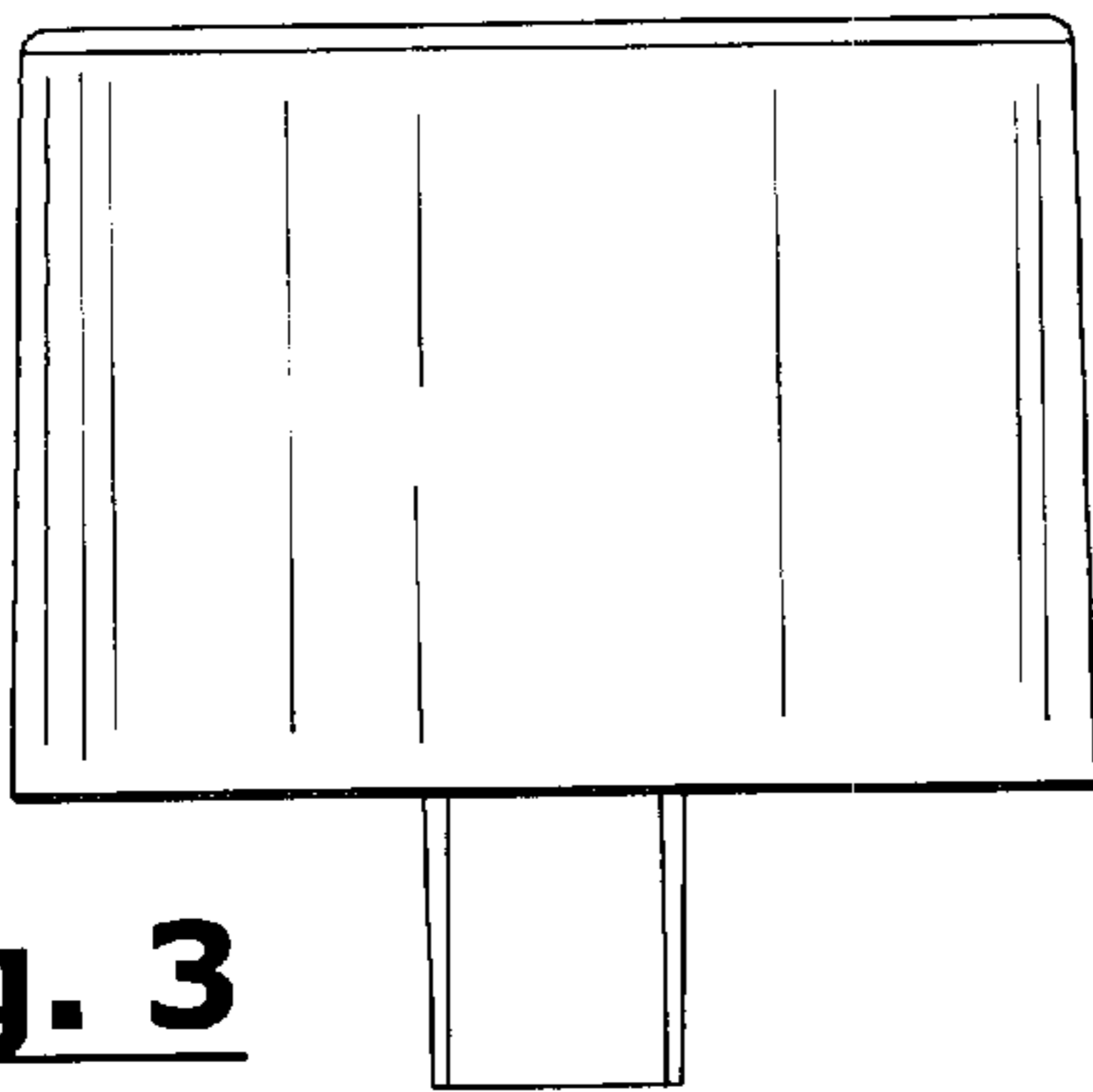




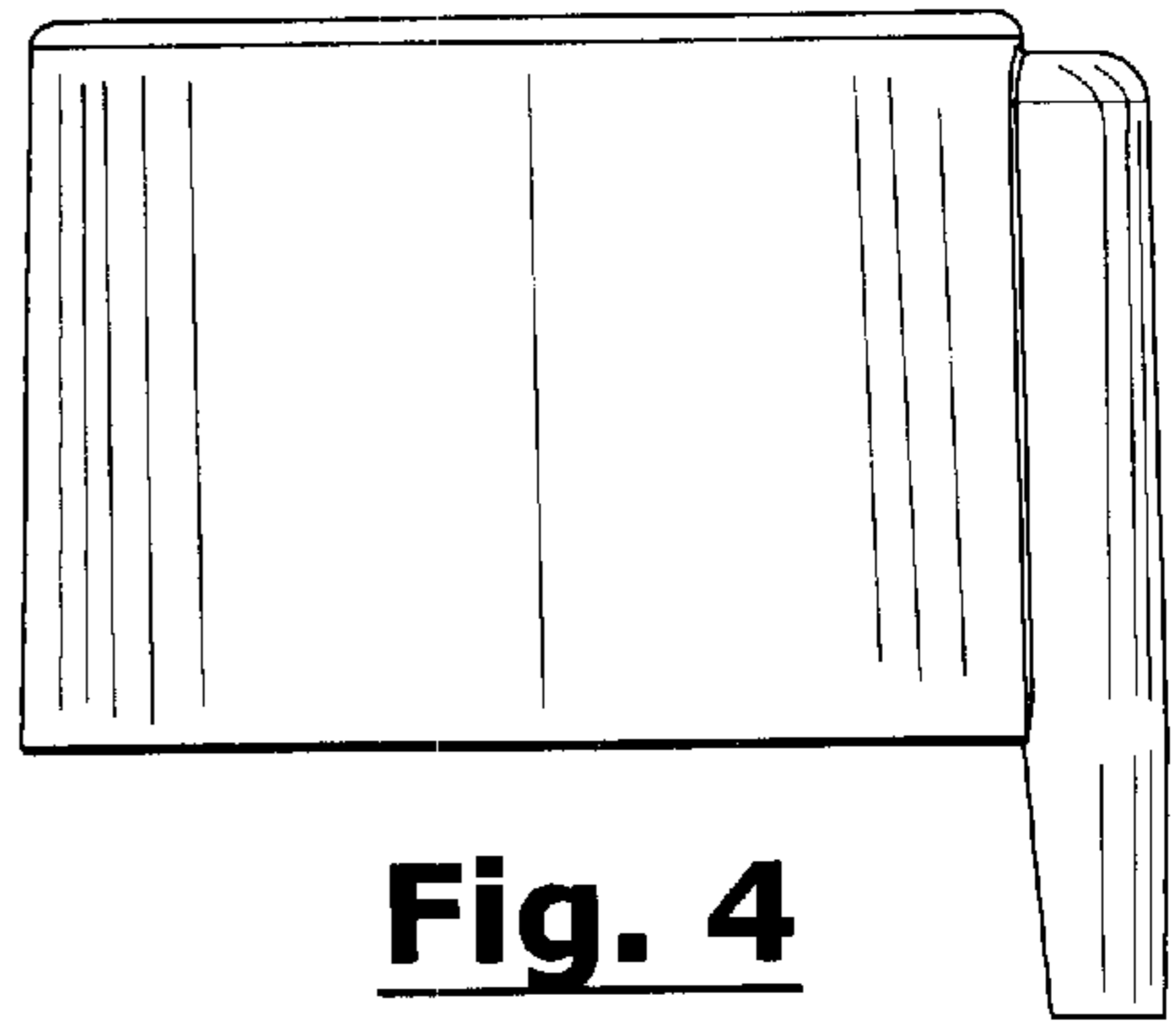

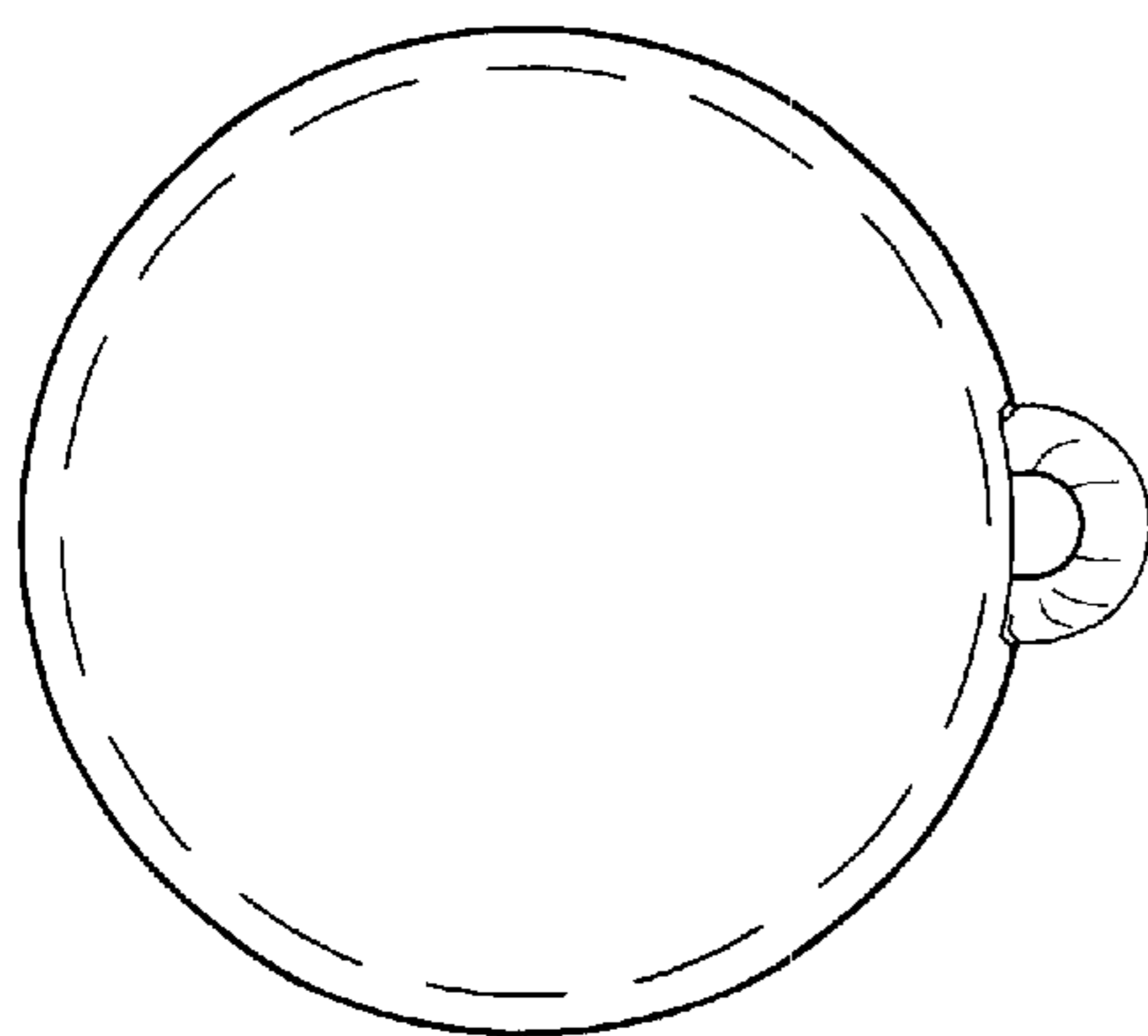

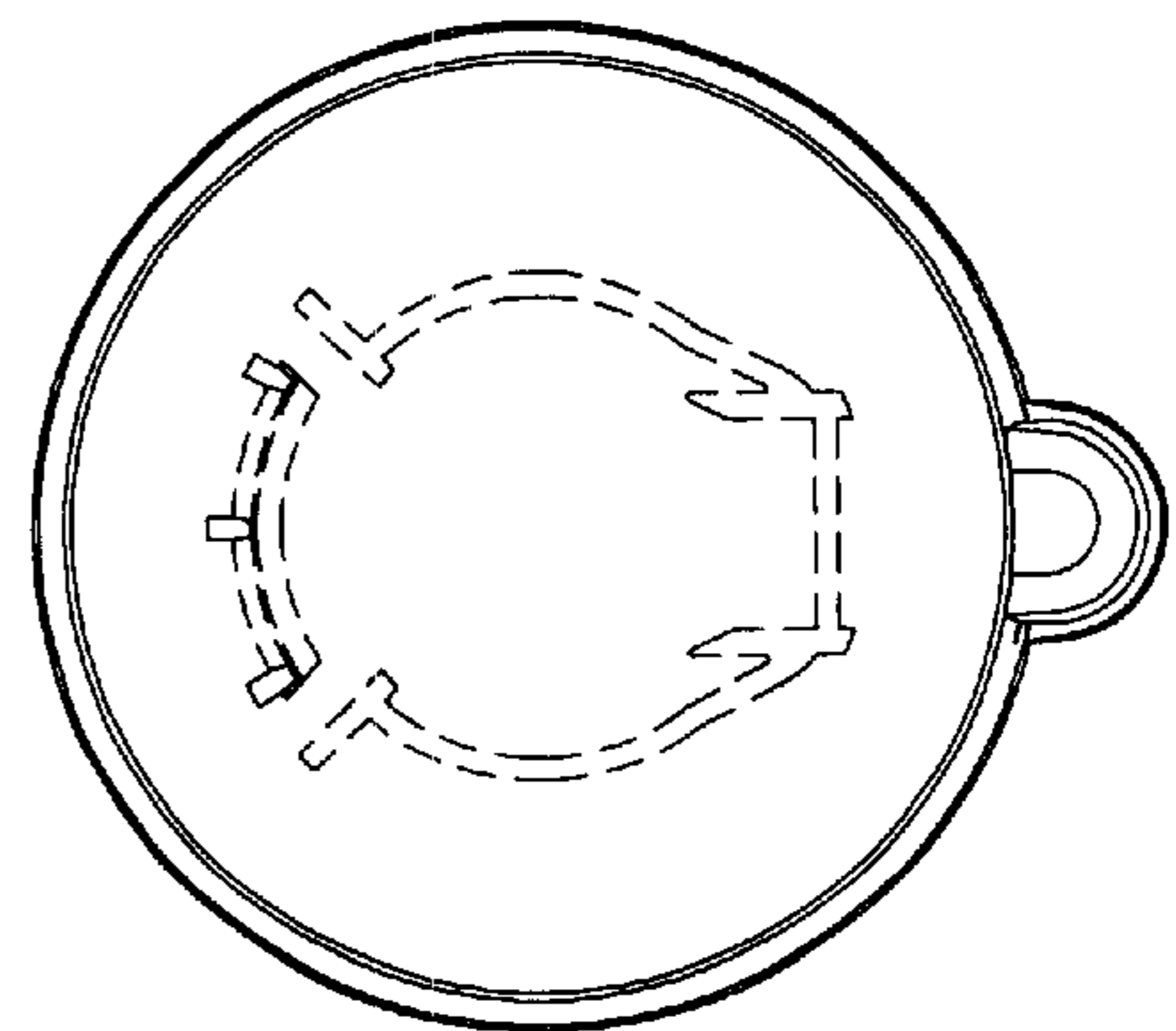
