FIG. 5 is a back elevational view thereof; and,

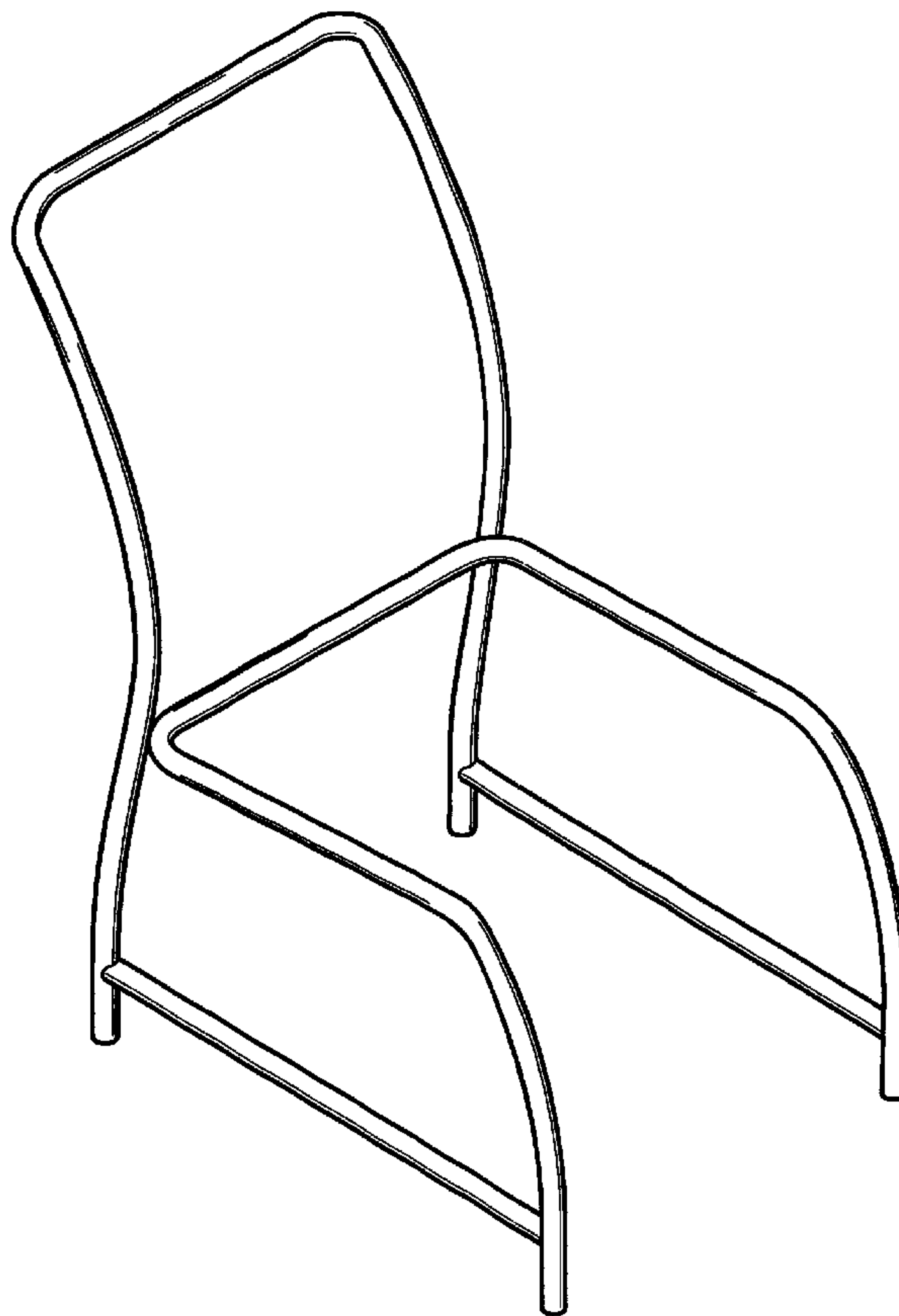
FIG. 6 is a front elevational view thereof.

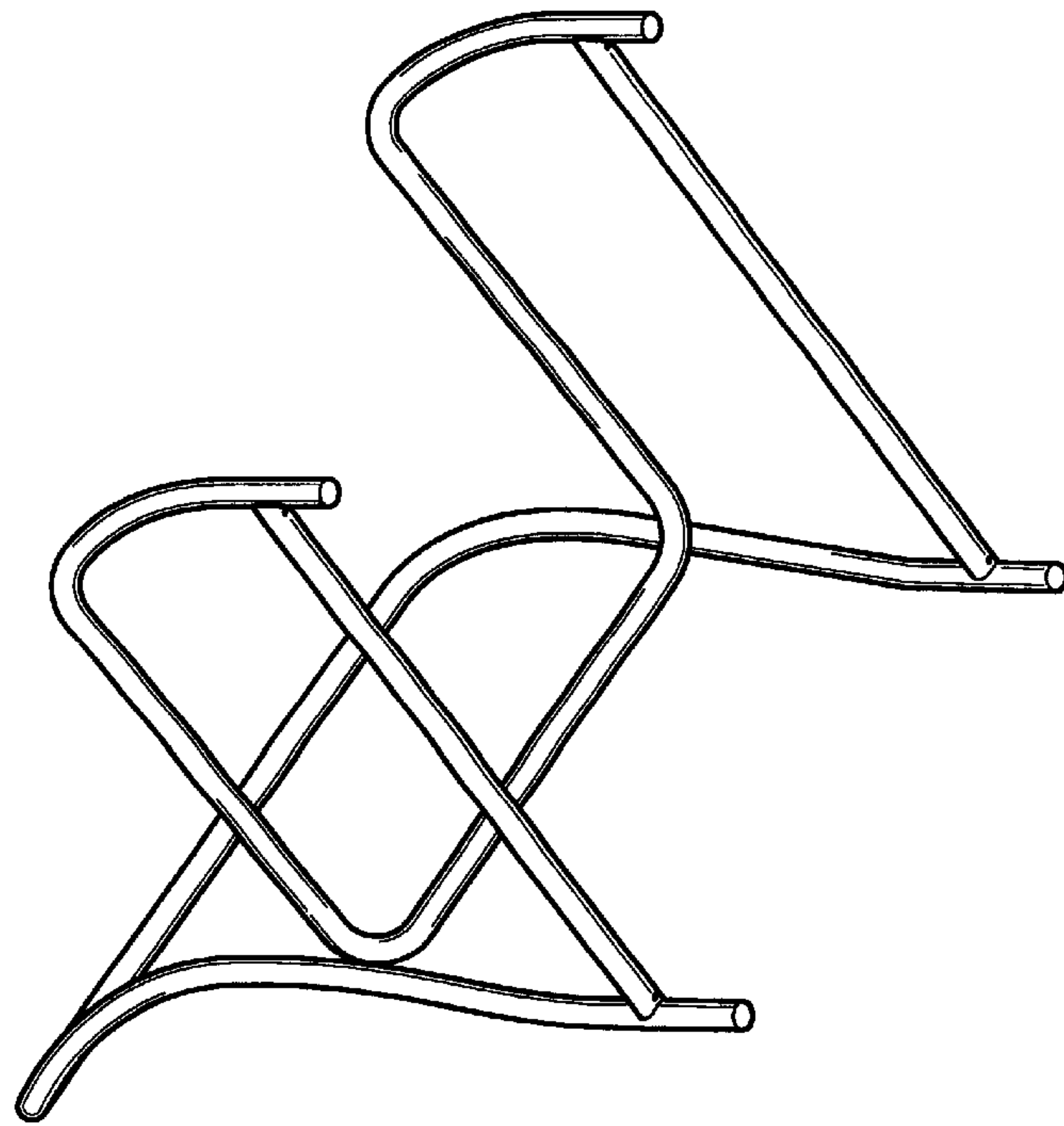

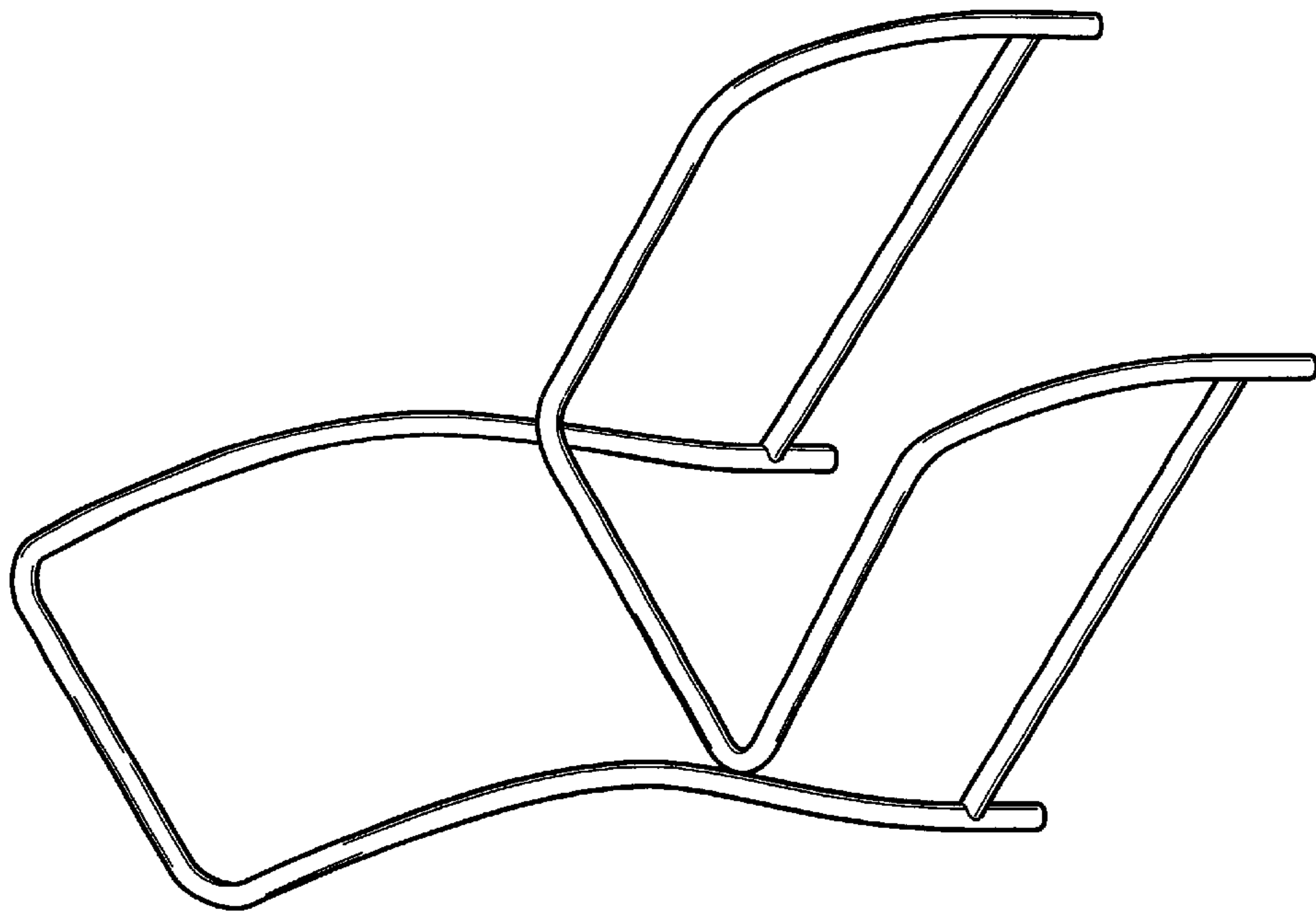

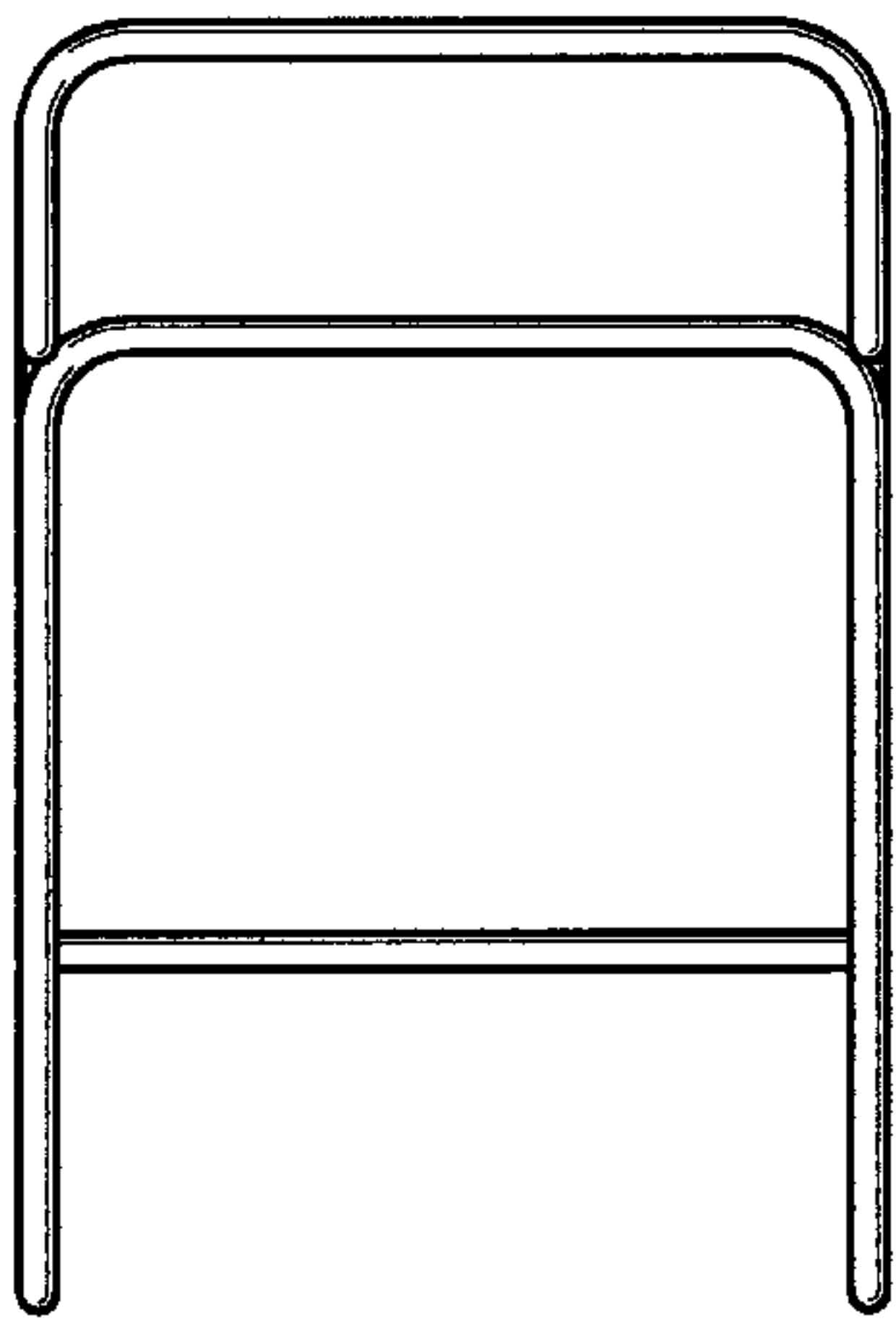

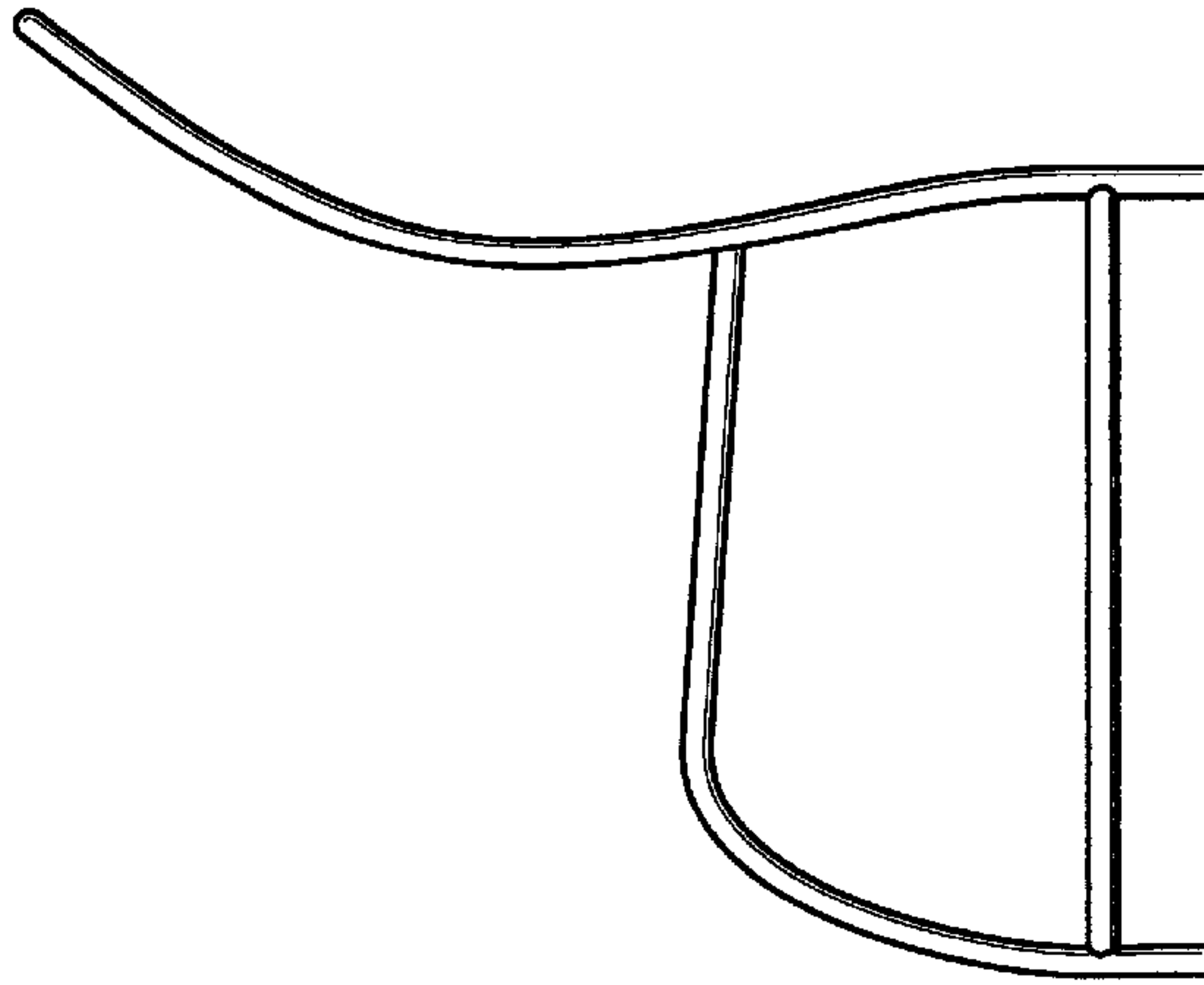

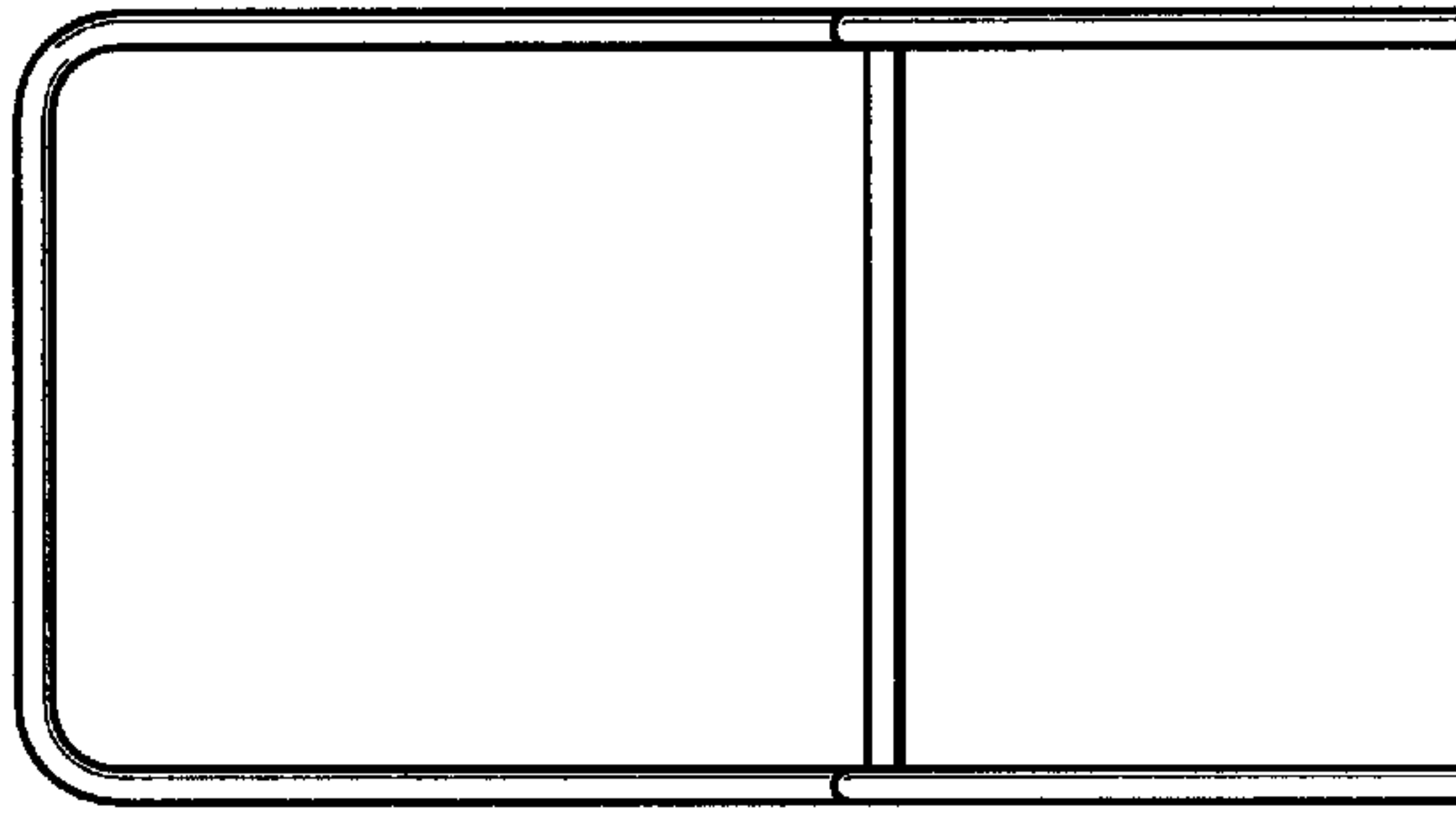

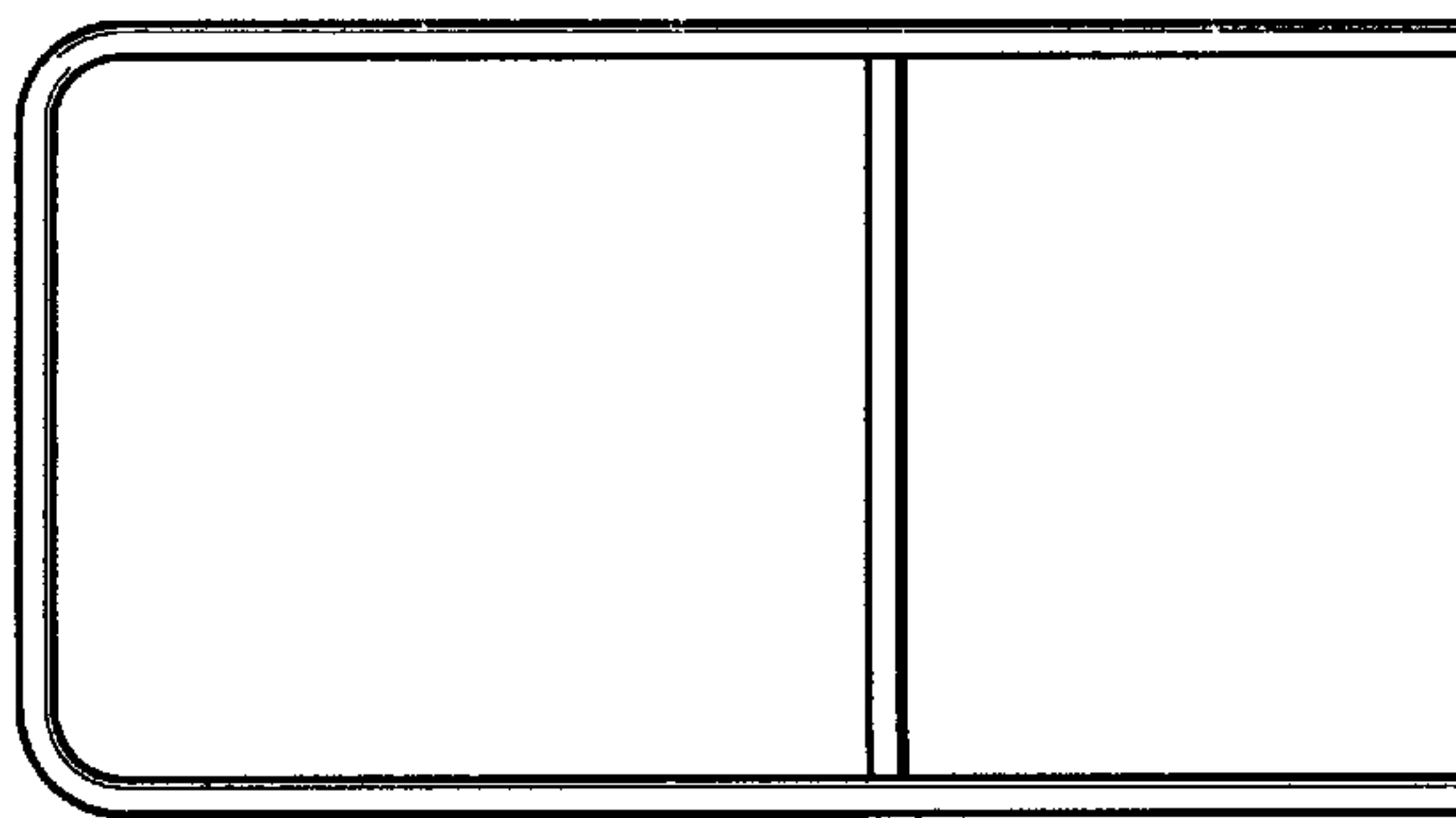
