(57) **CLAIM**

The ornamental design for a housing for communications devices or similar articles, substantially as shown.

**DESCRIPTION**

FIG. 4 is a front elevation view of FIG. 1.

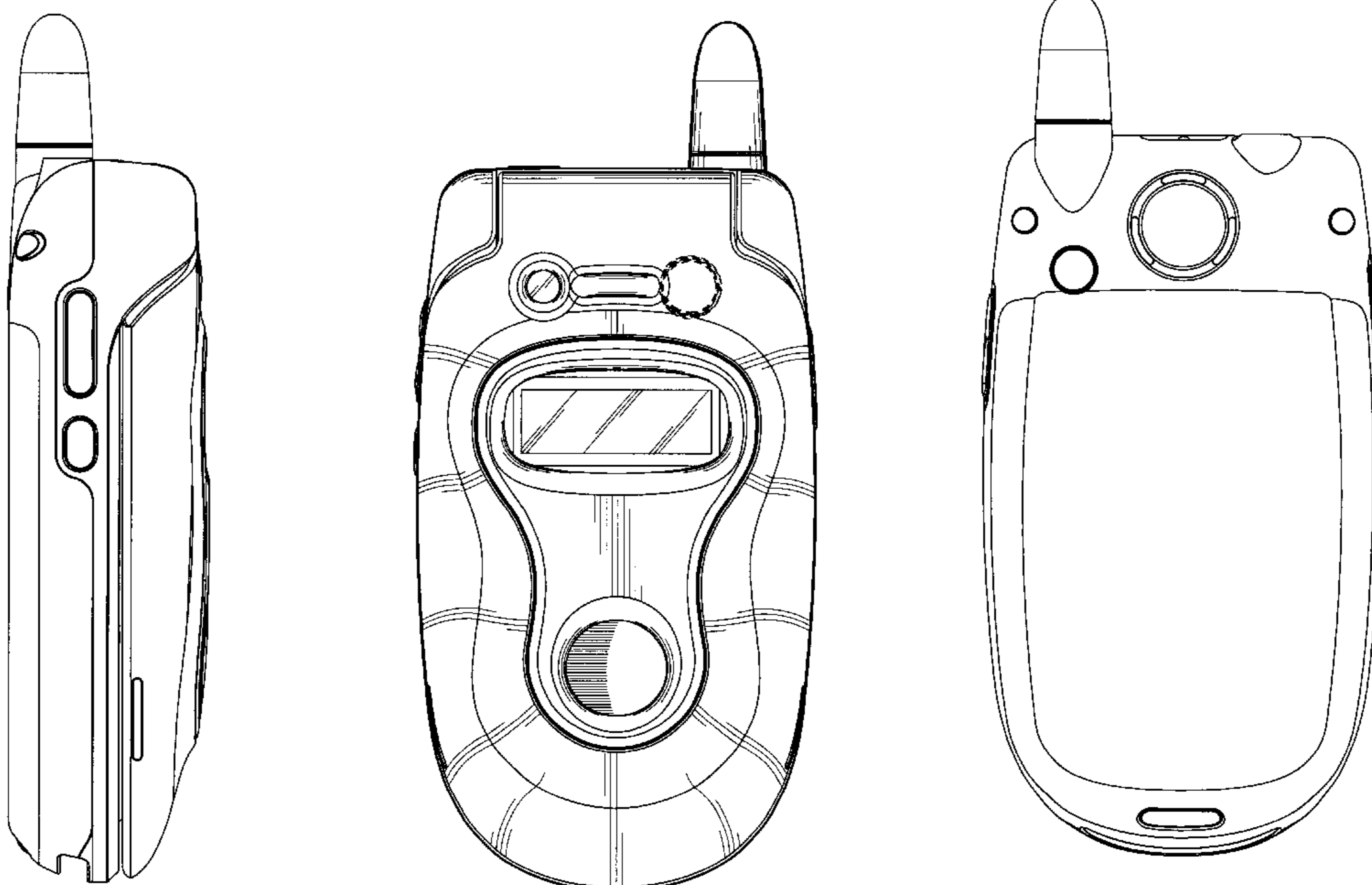
FIG. 5 is a first side elevation view of FIG. 1.

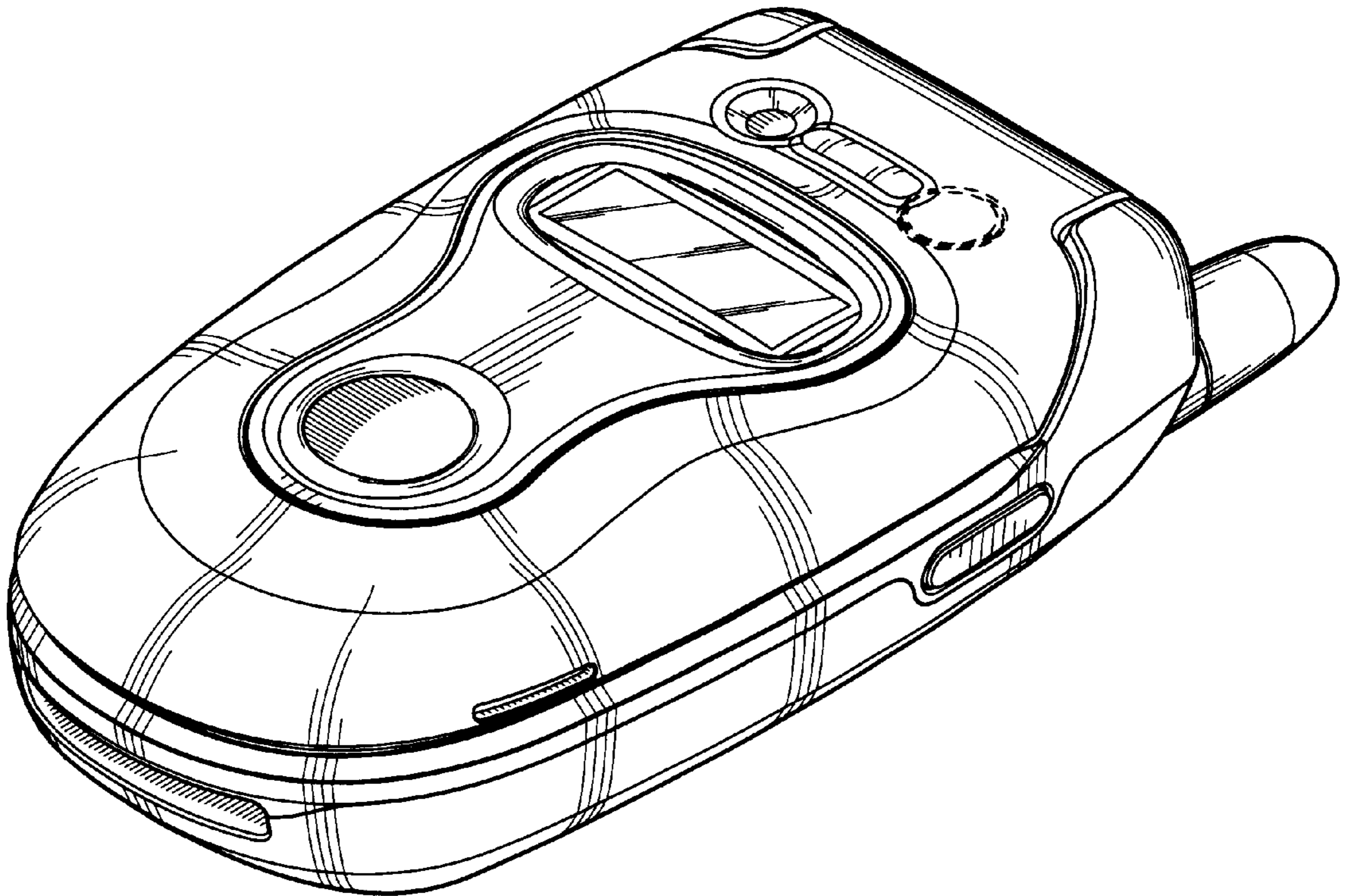
FIG. 6 is a rear elevation view of FIG. 1; and,

FIG. 7 is a bottom plan view of FIG. 1.

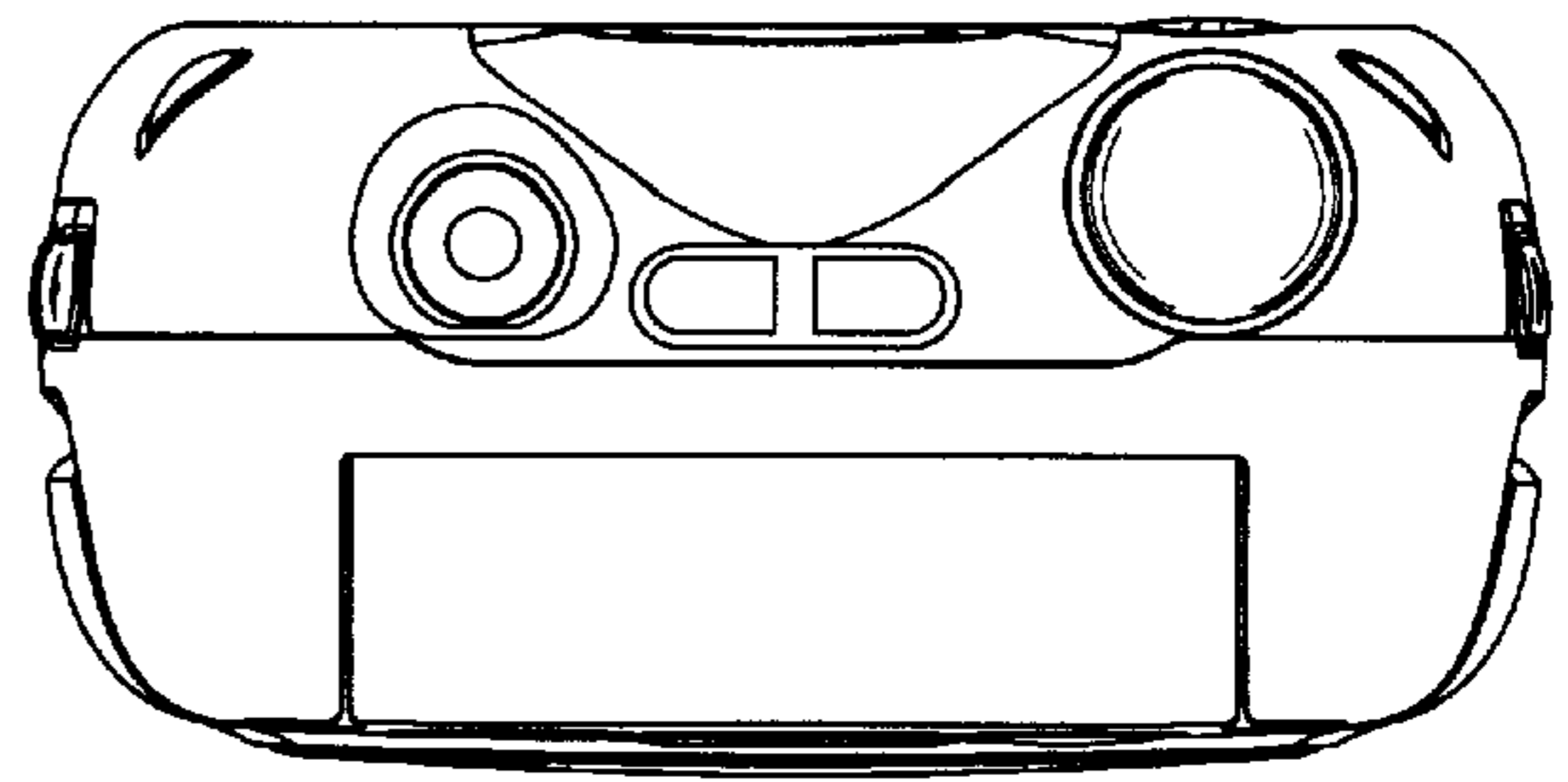

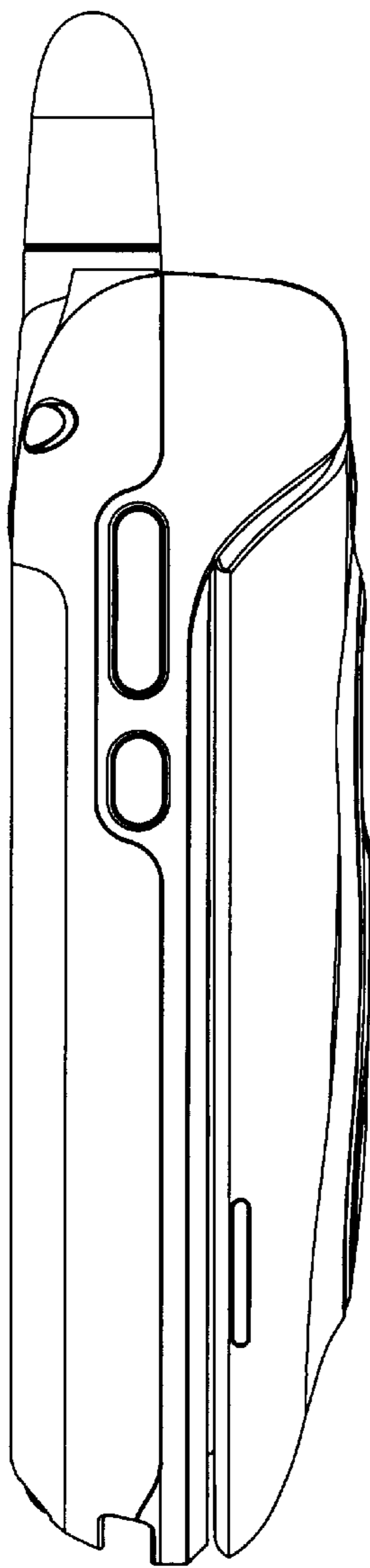




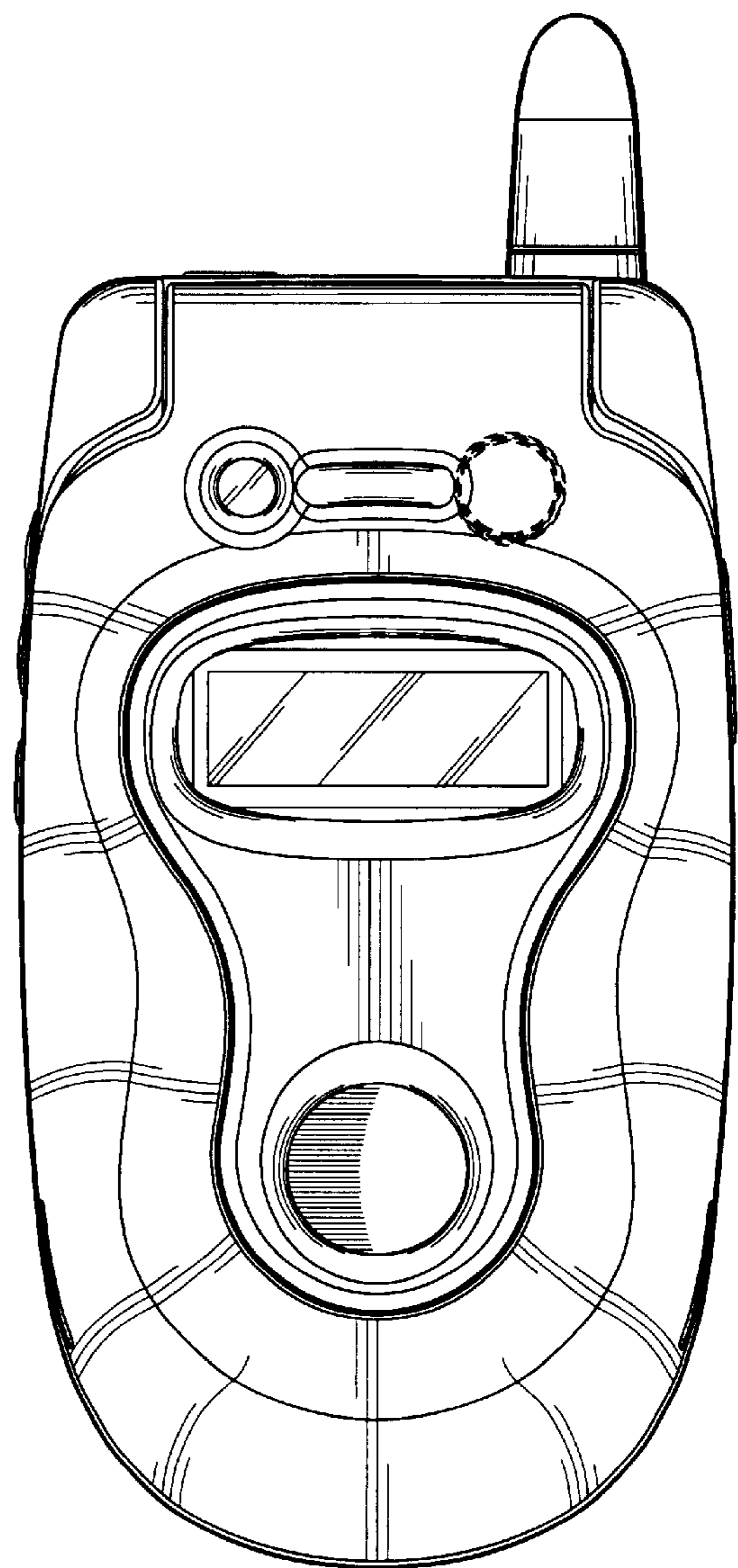

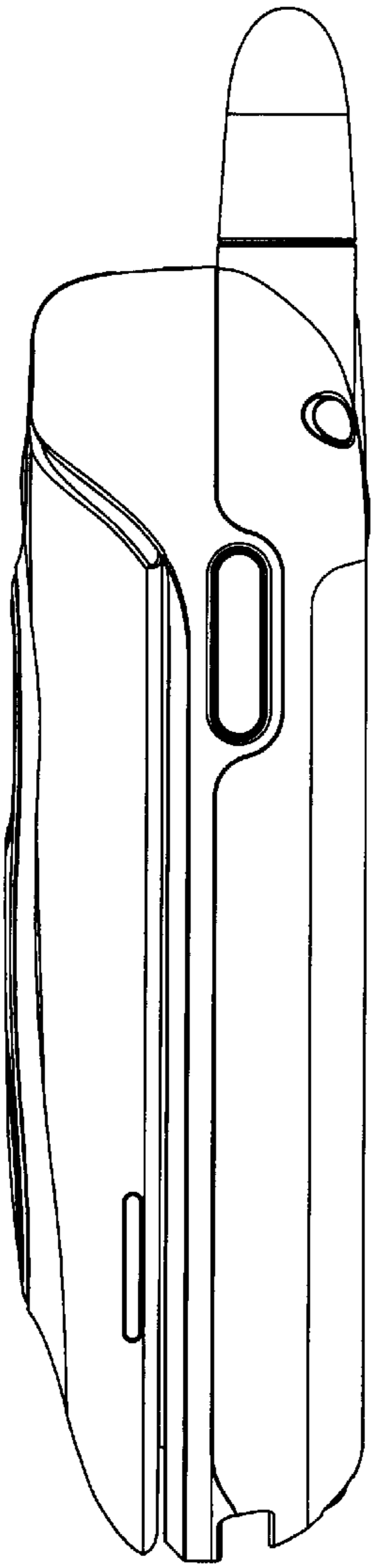

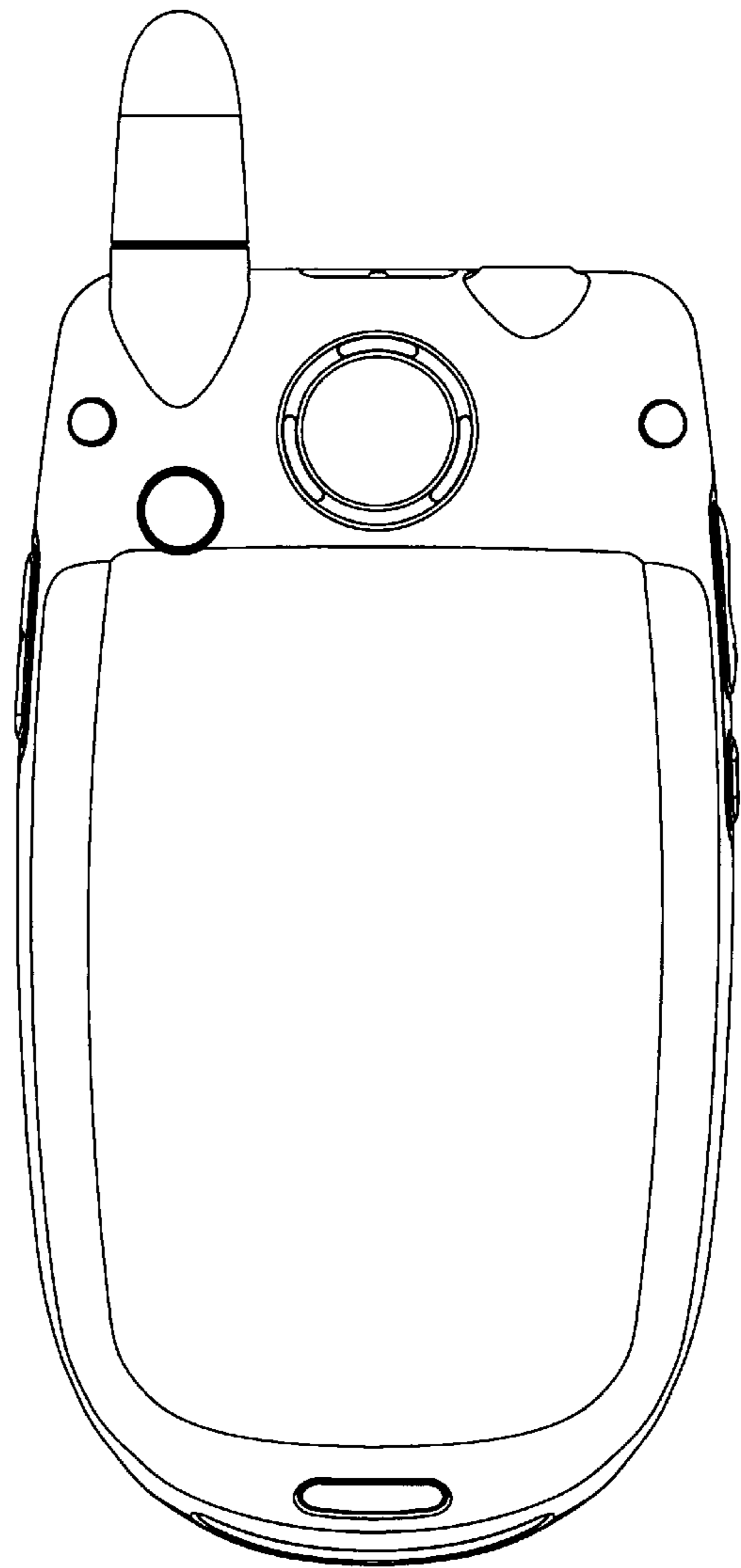

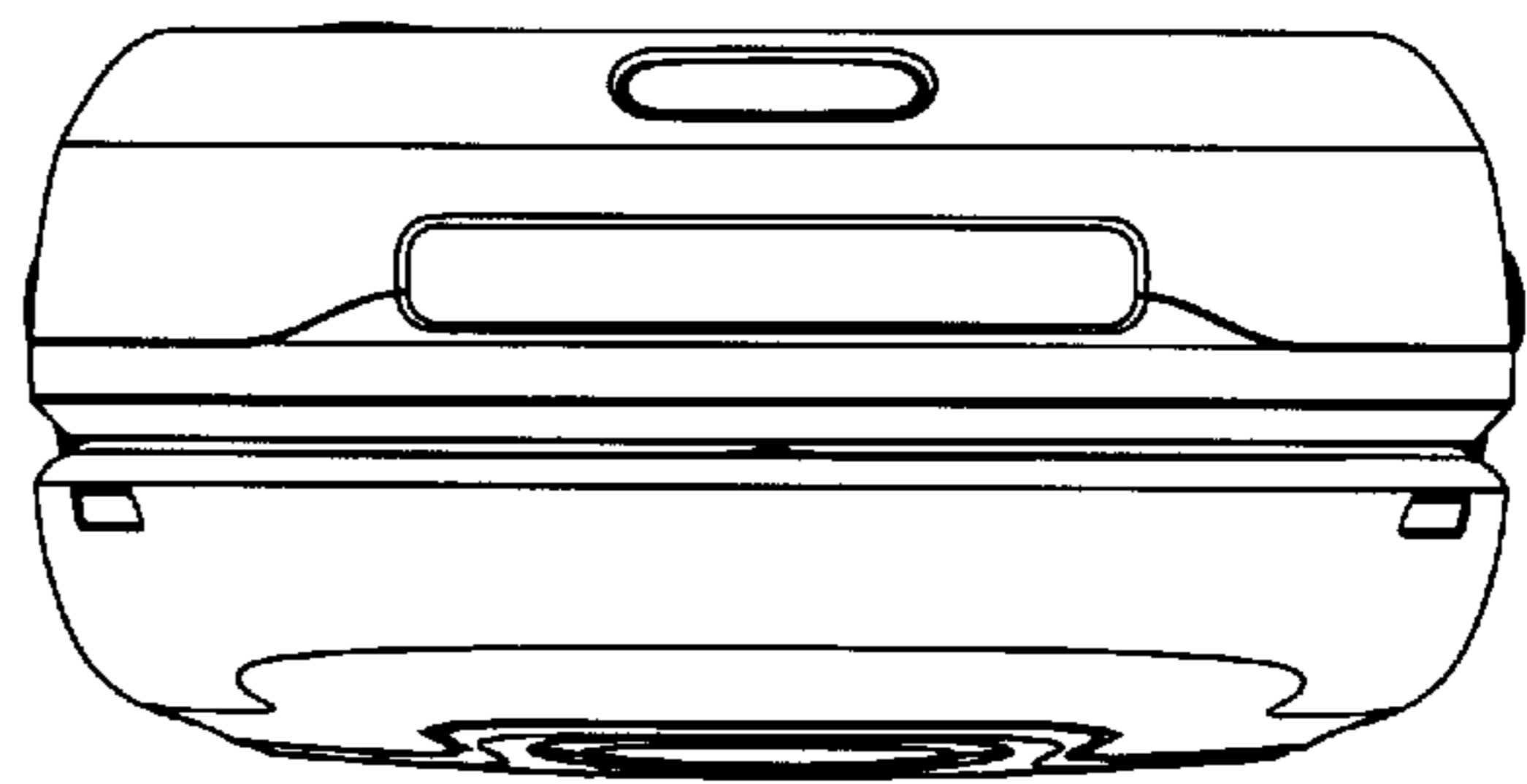
