FIG. 3 is a back view thereof, the broken lines are for illustrative purposes only and form no part of the claimed design;

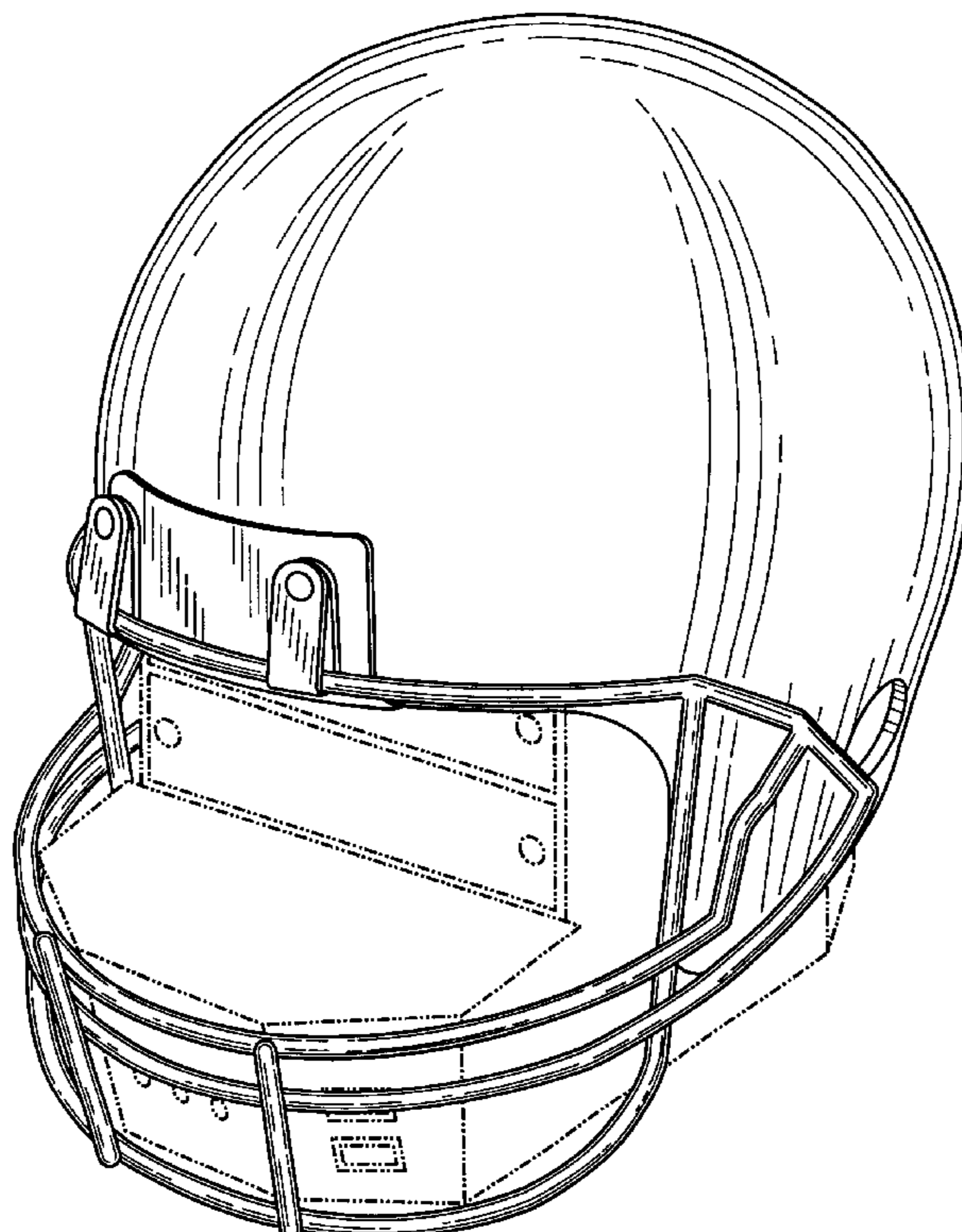
FIG. 4 is a left side view thereof, the broken lines are for illustrative purposes only and form no part of the claimed design;

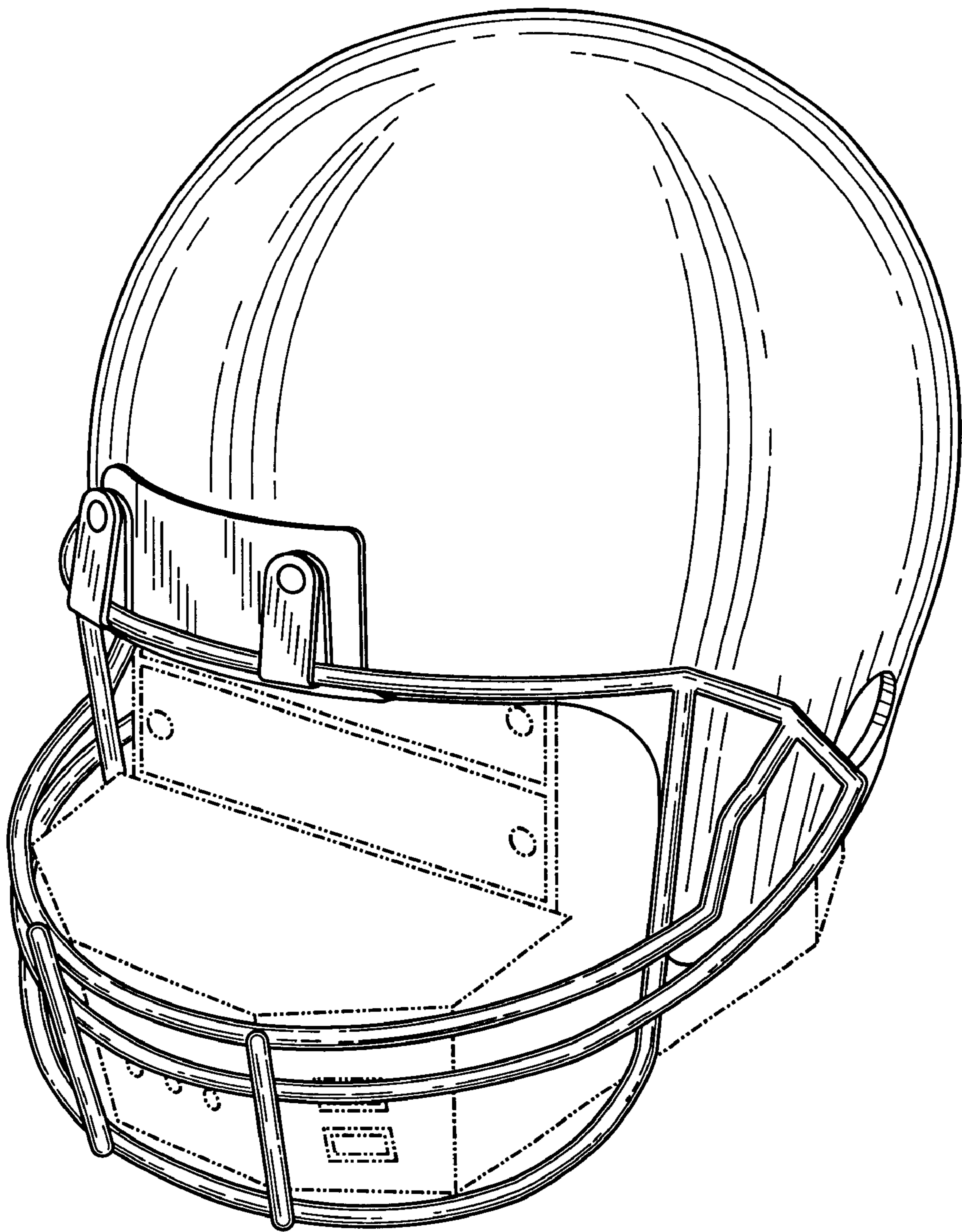

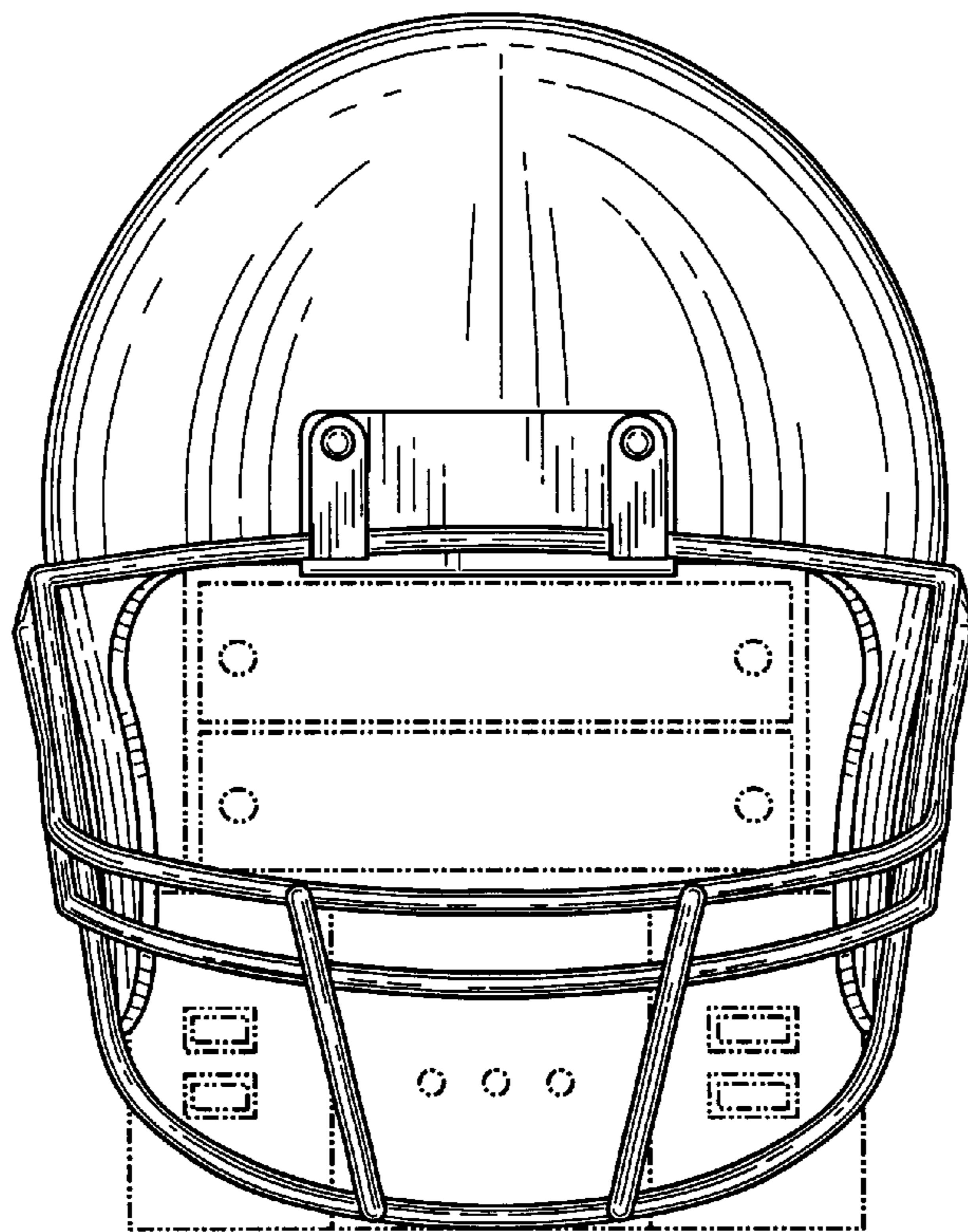

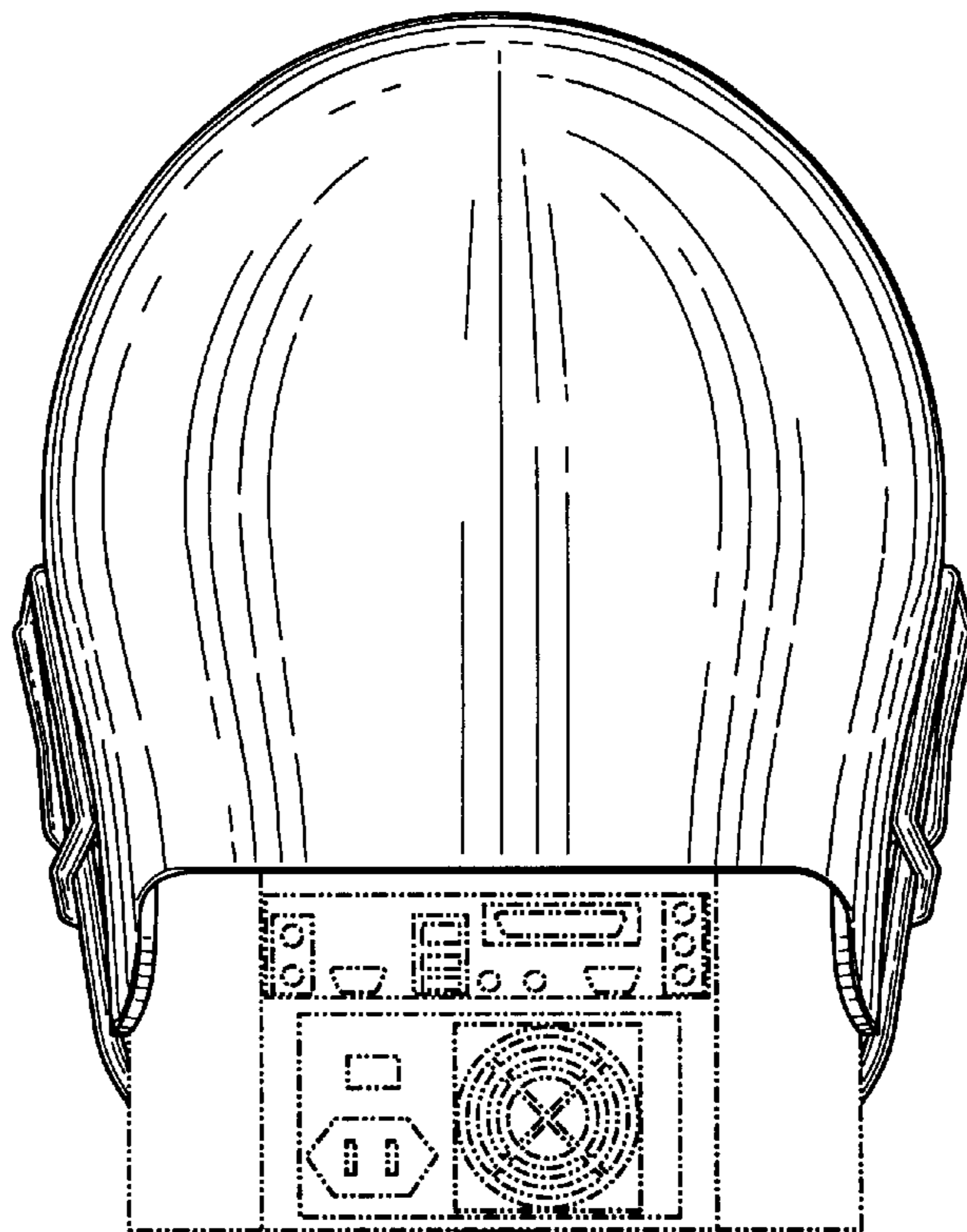

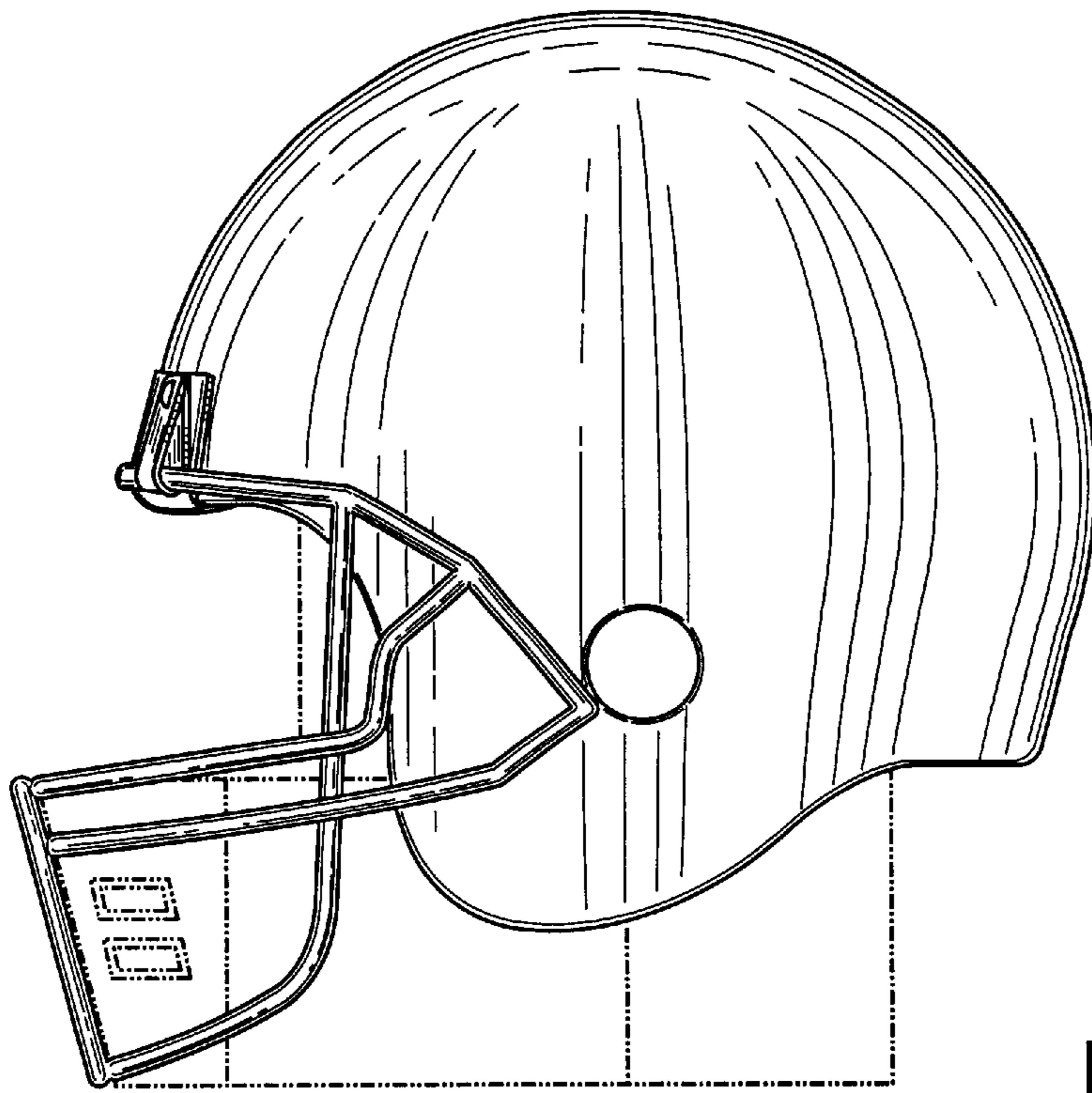

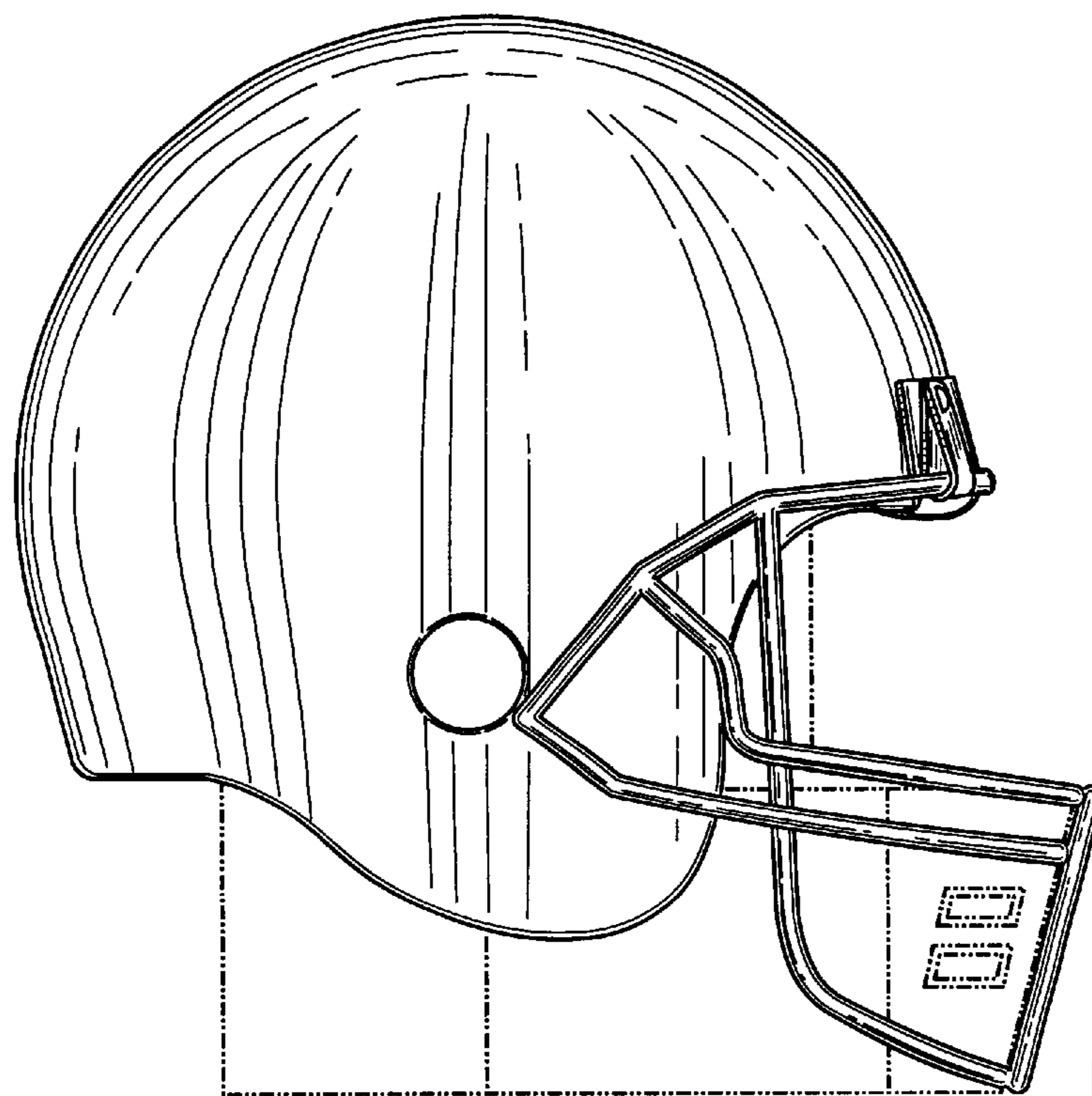

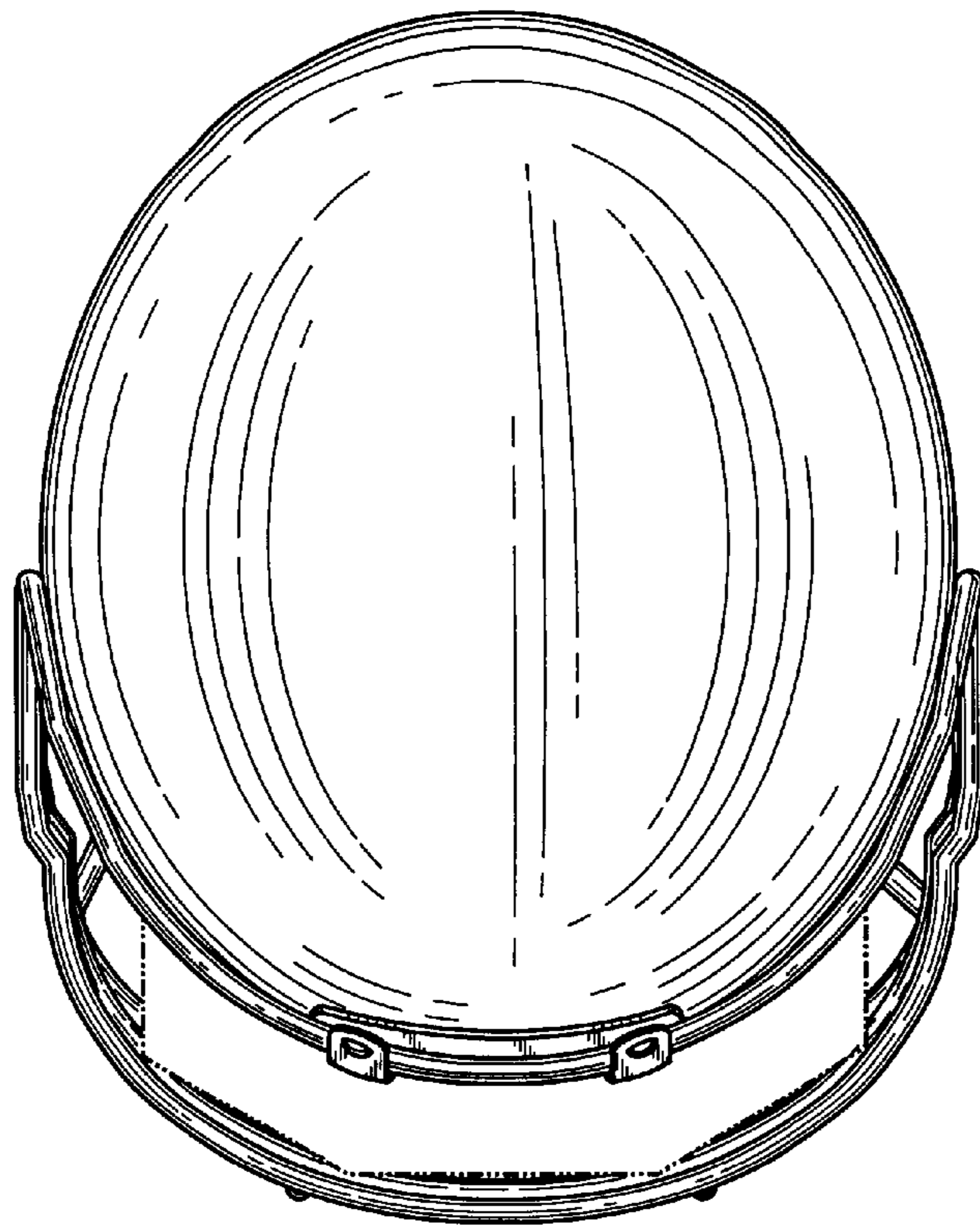

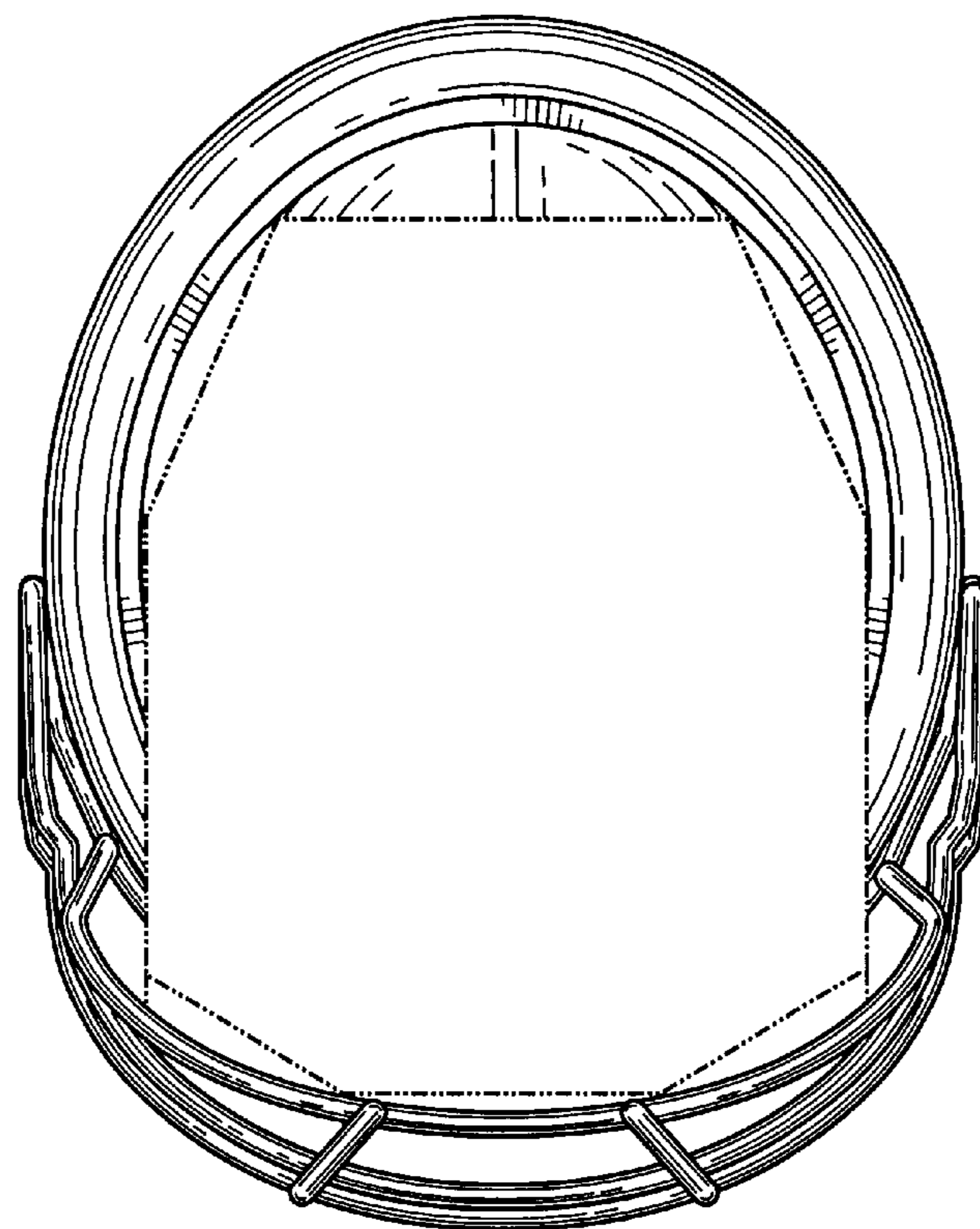
