(57) **CLAIM**

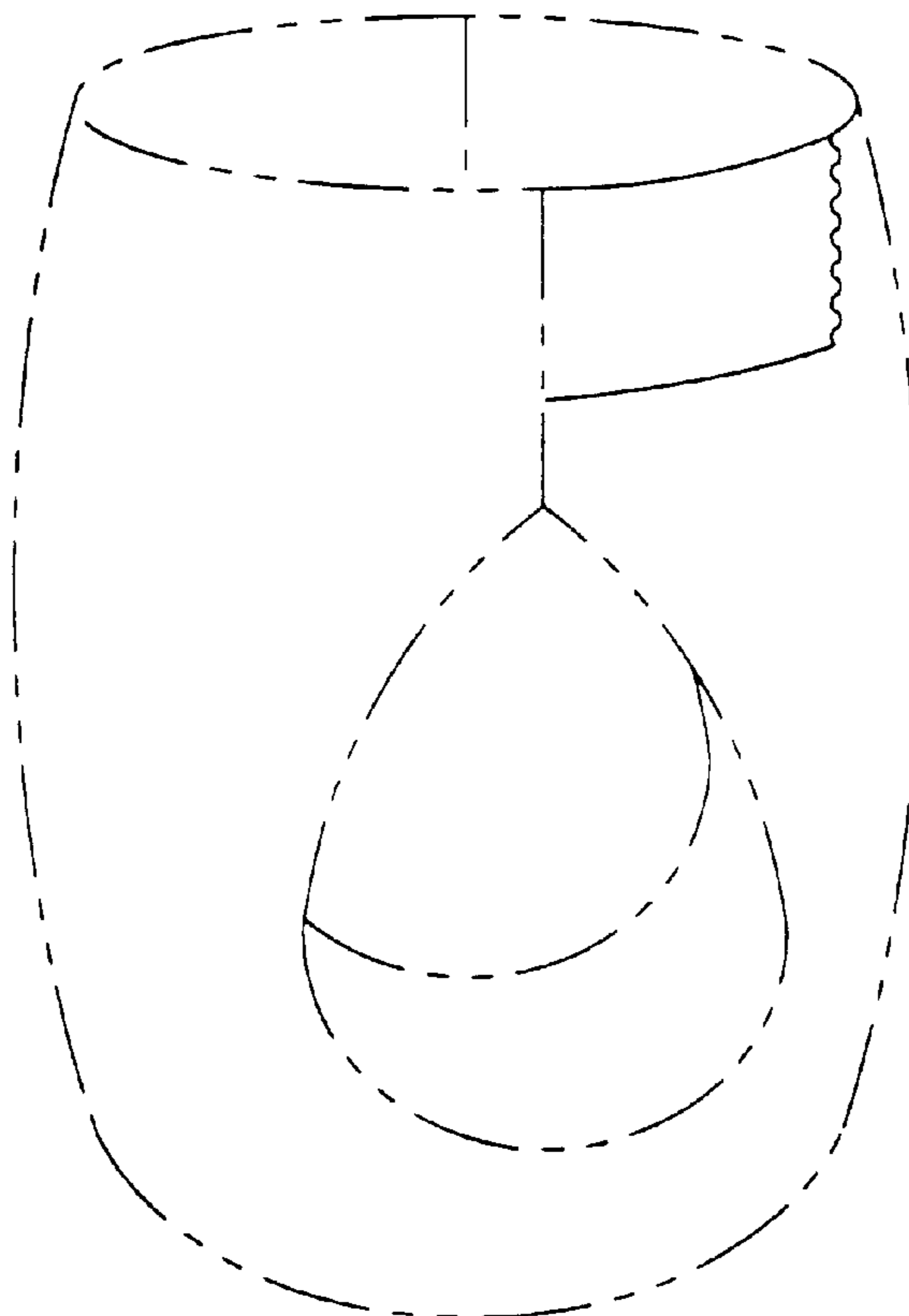
The ornamental design for a fastener tab for a disposable absorbent article, as shown and described.

**DESCRIPTION**

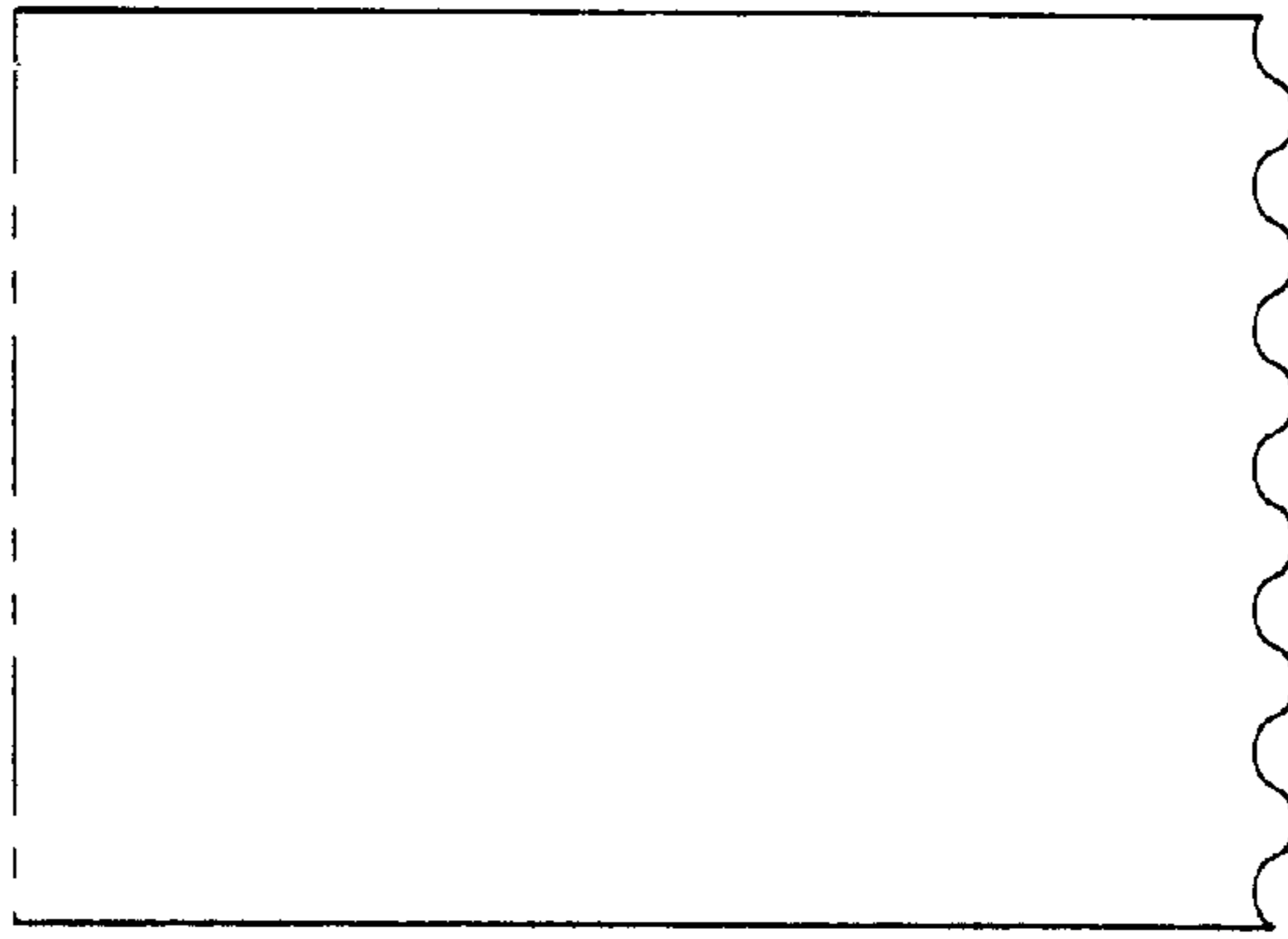

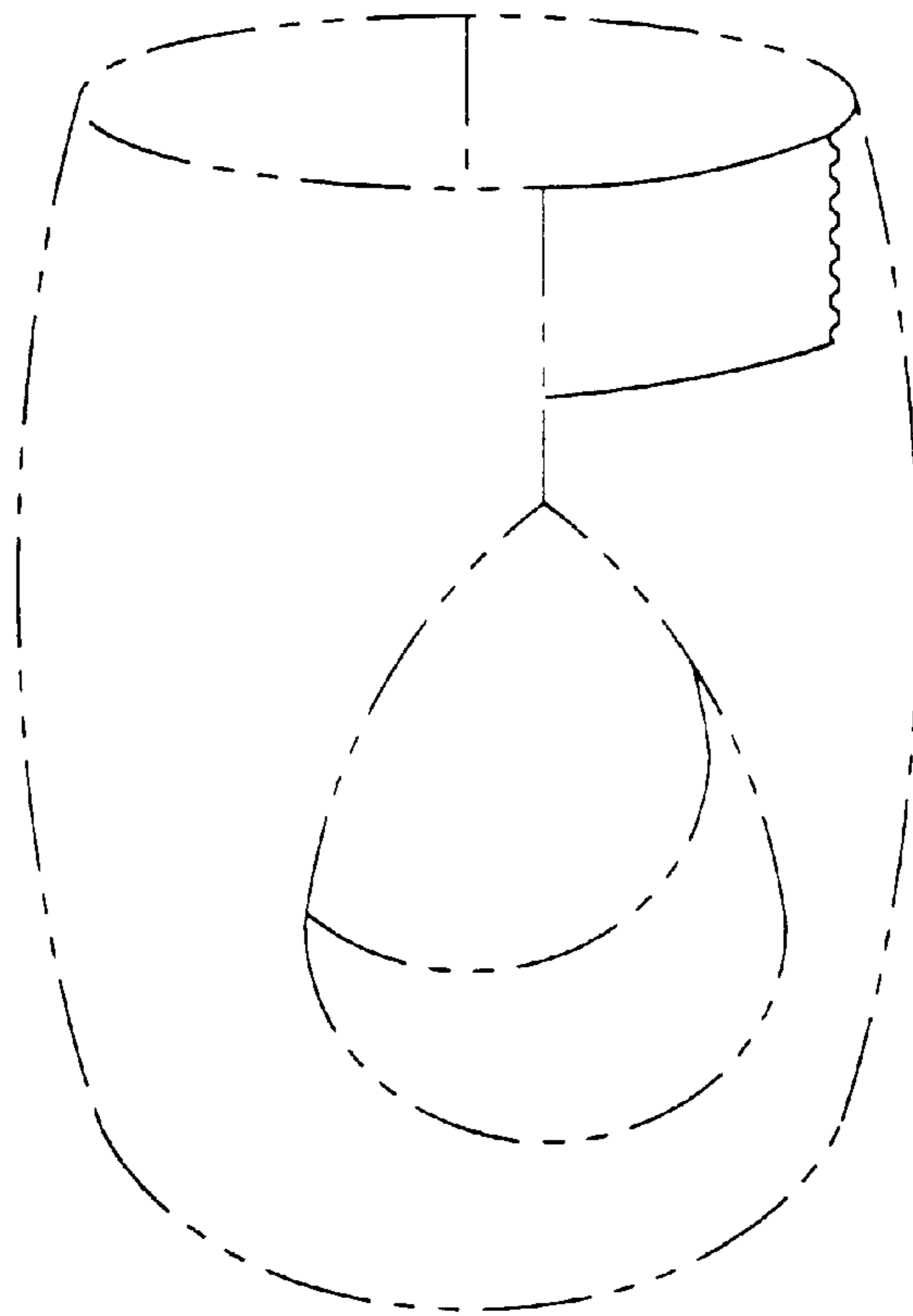
