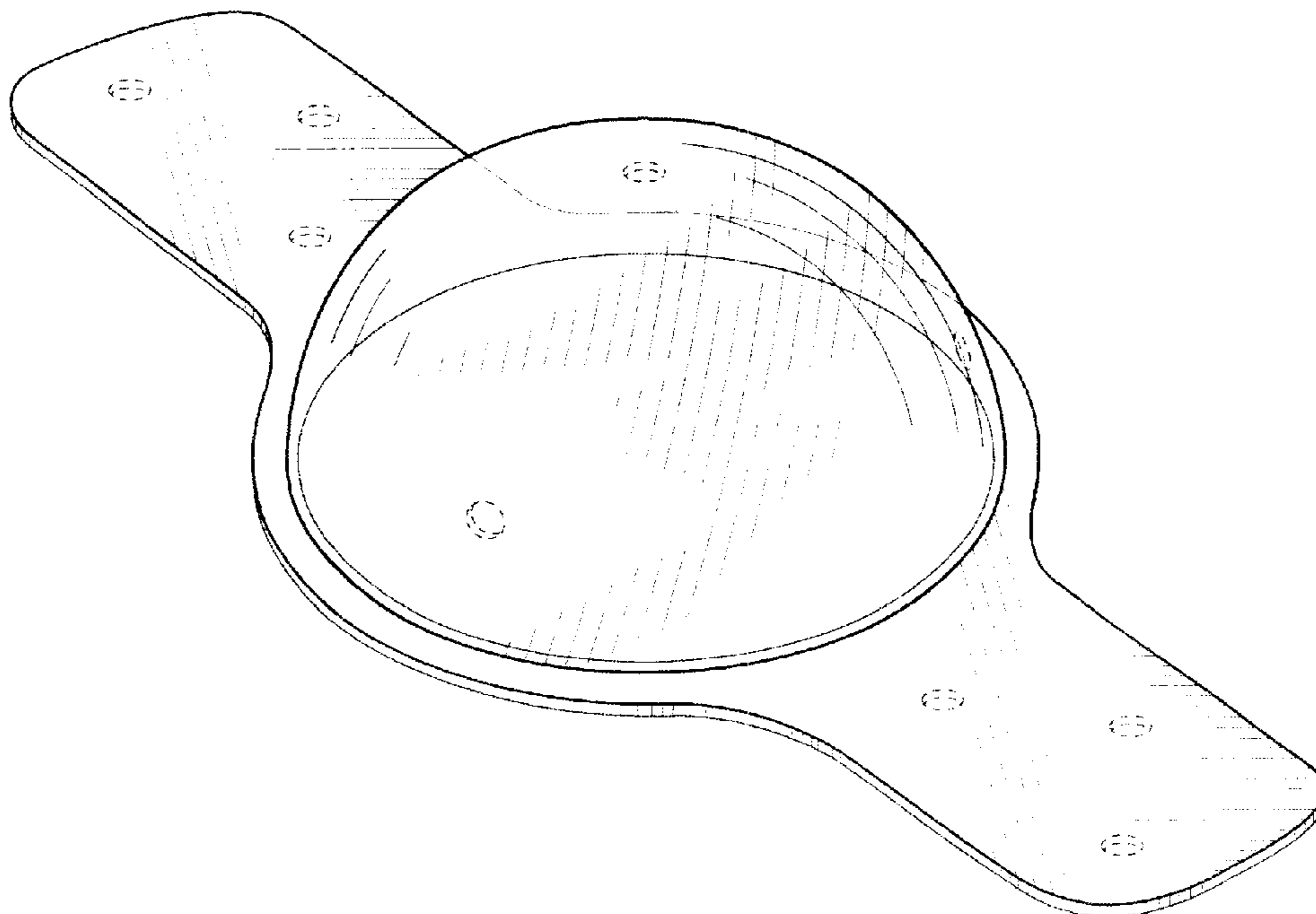

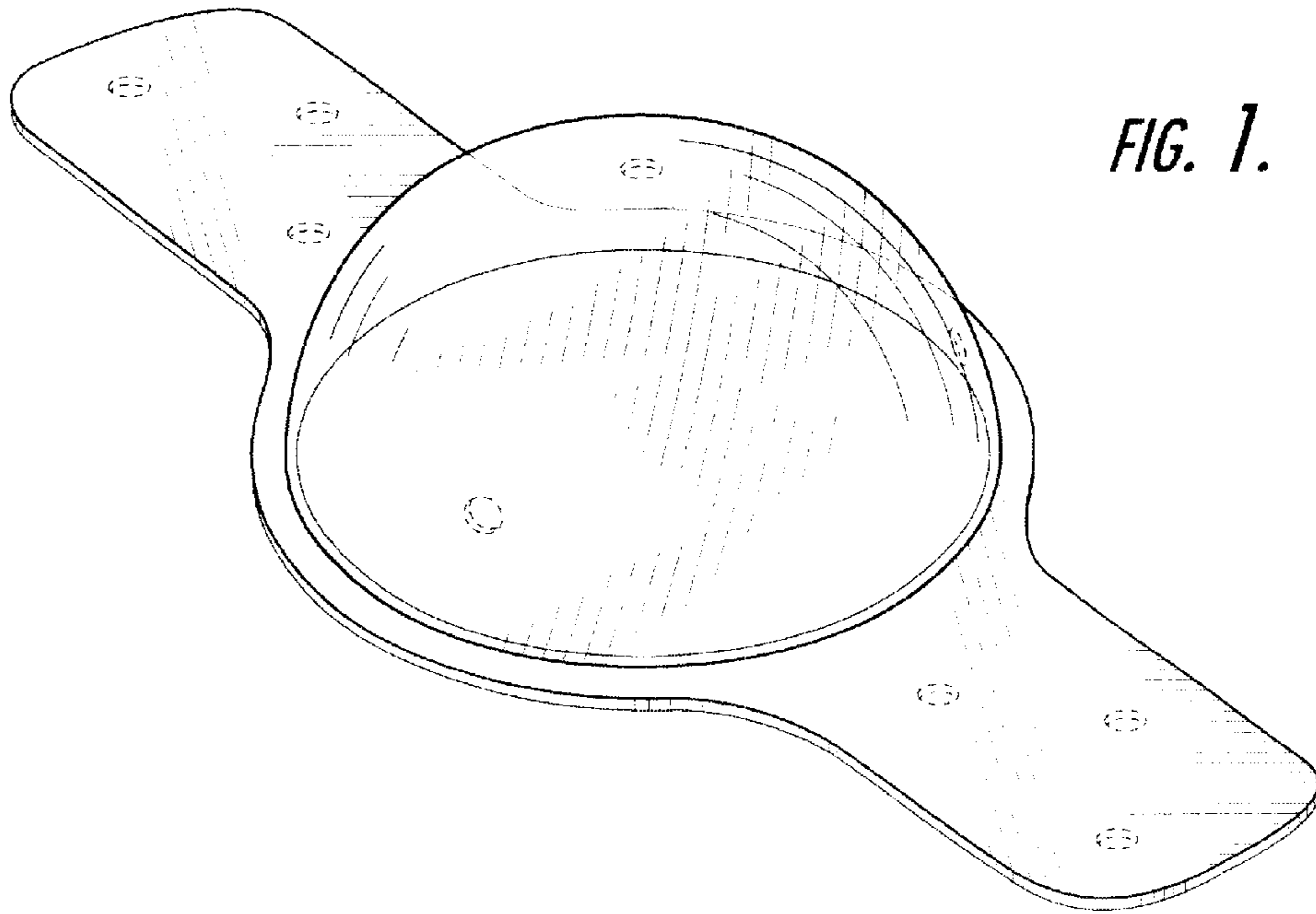
FIG. 1 is a perspective view of a post treatment protector device, showing our new design;

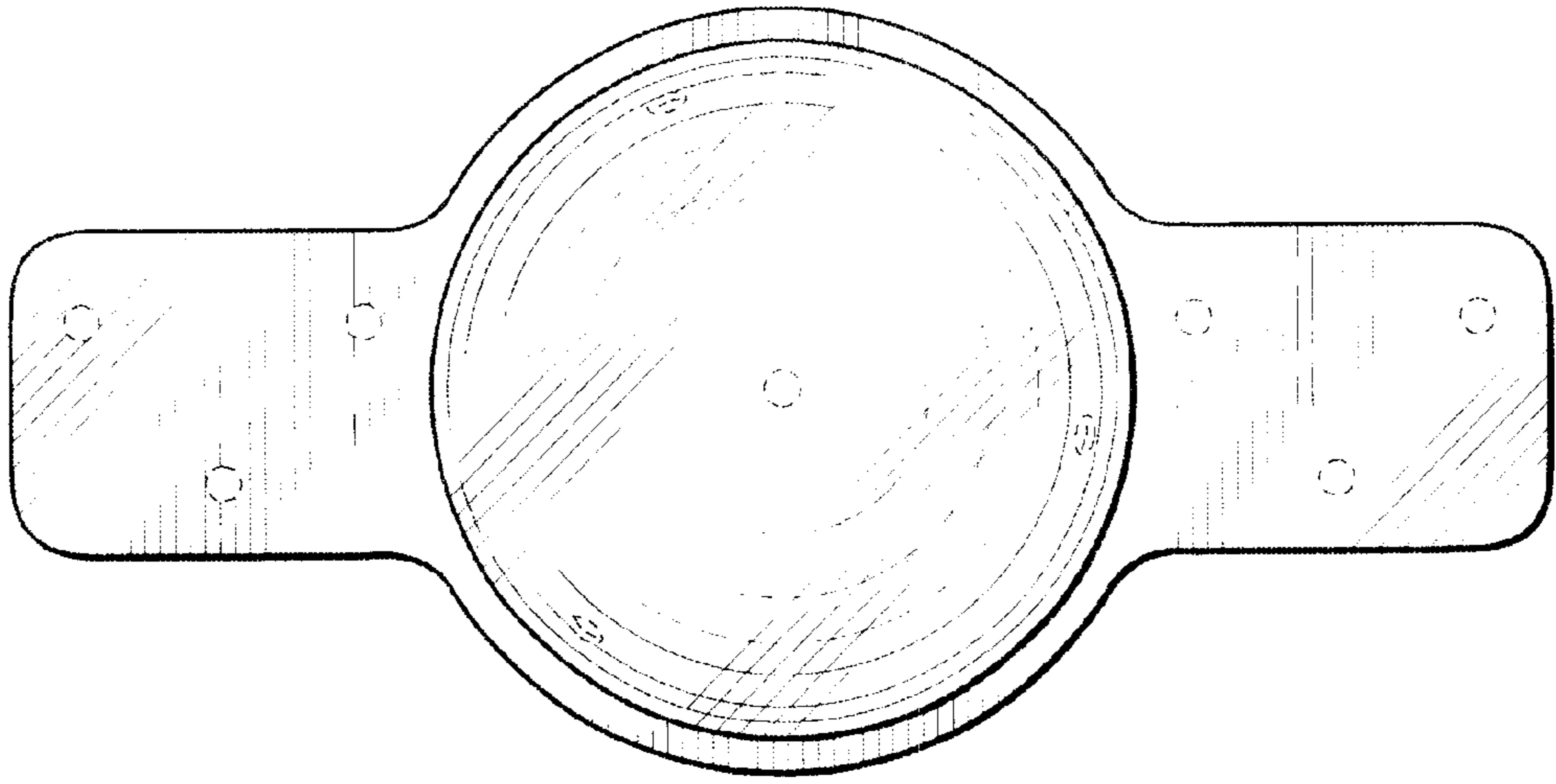

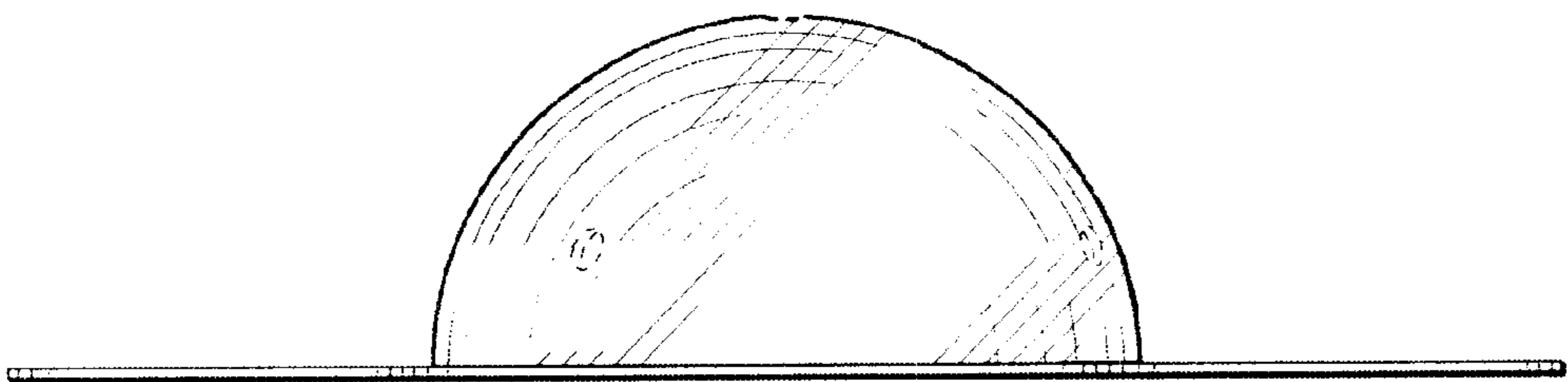

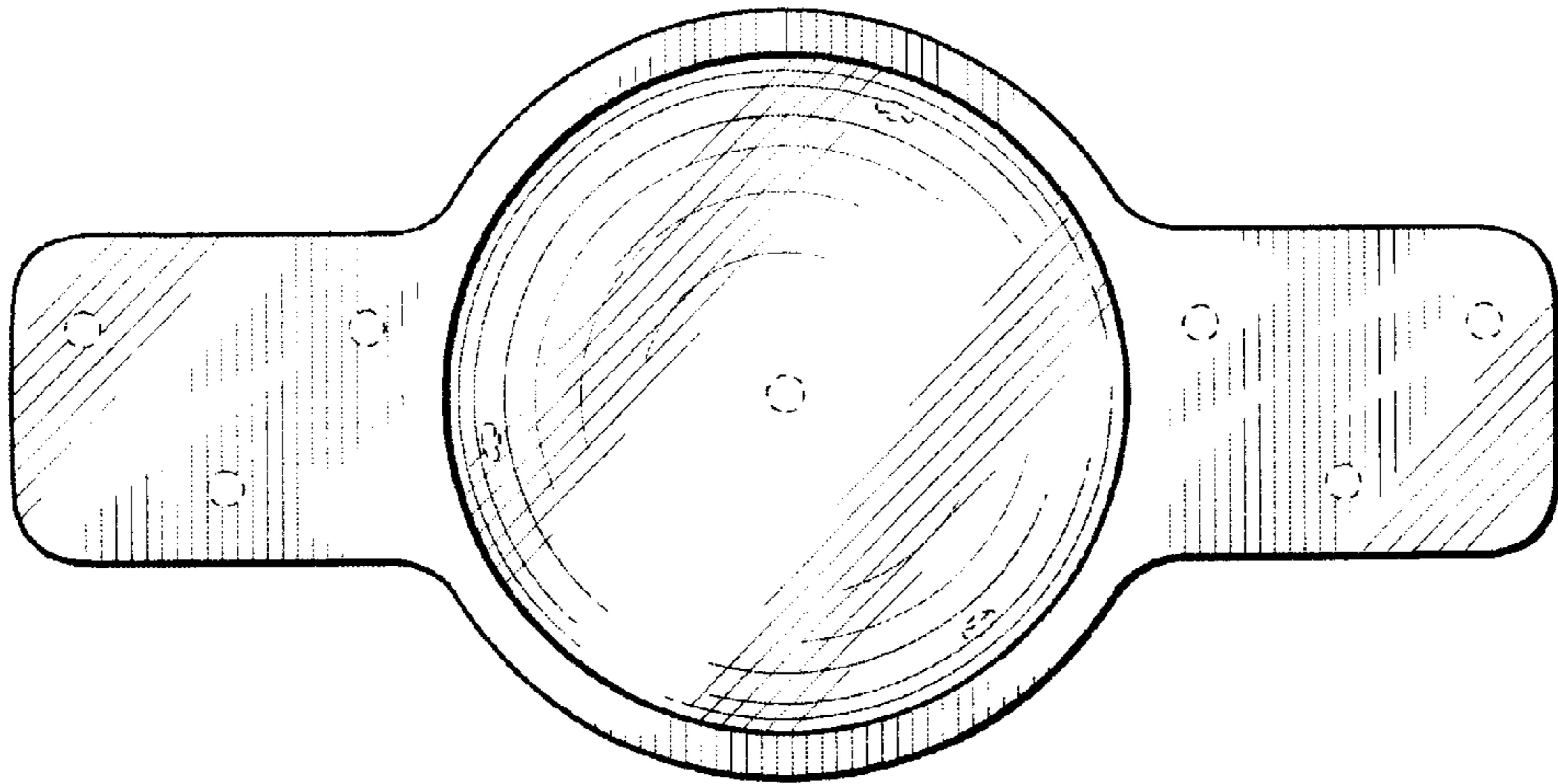

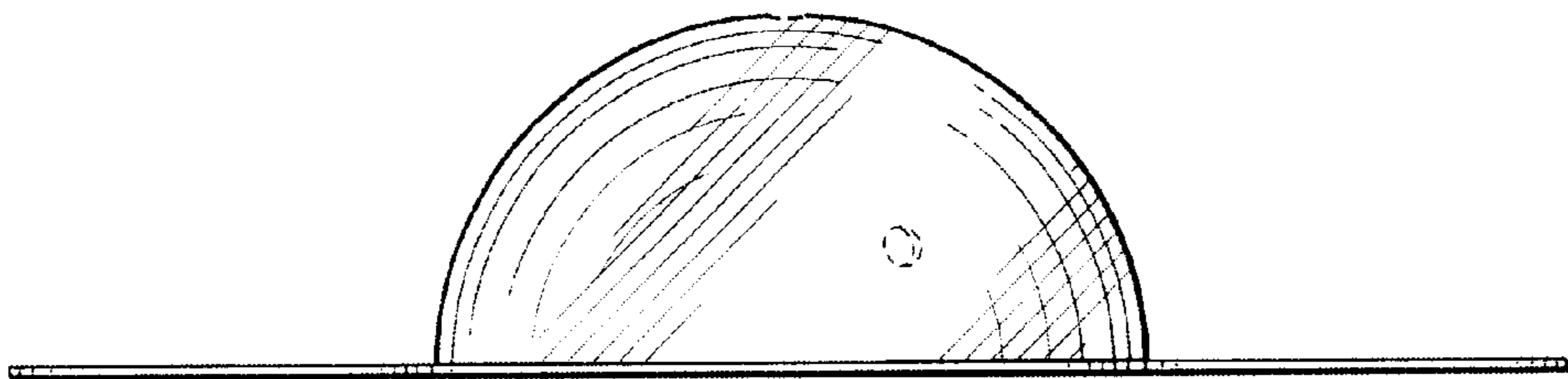

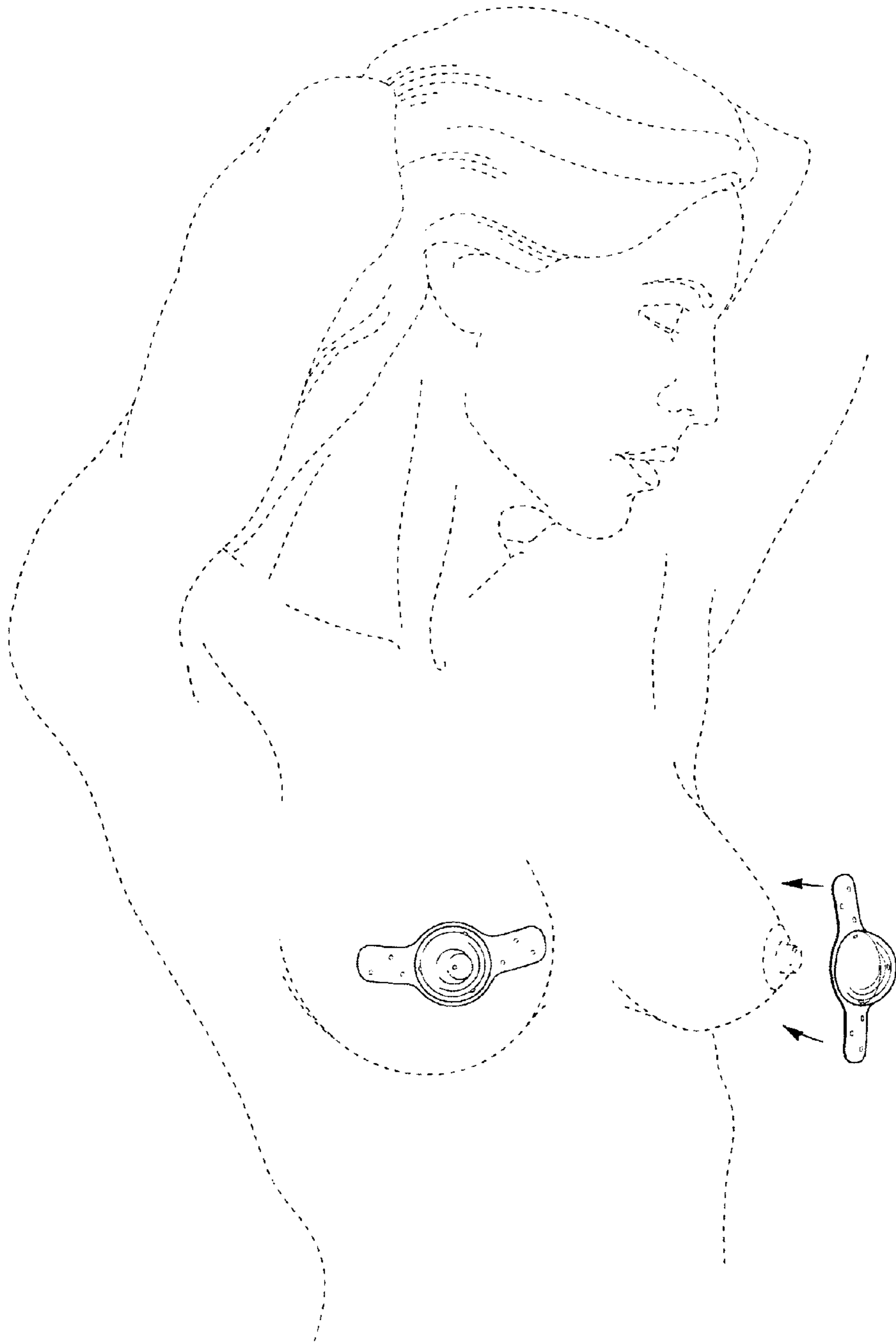
