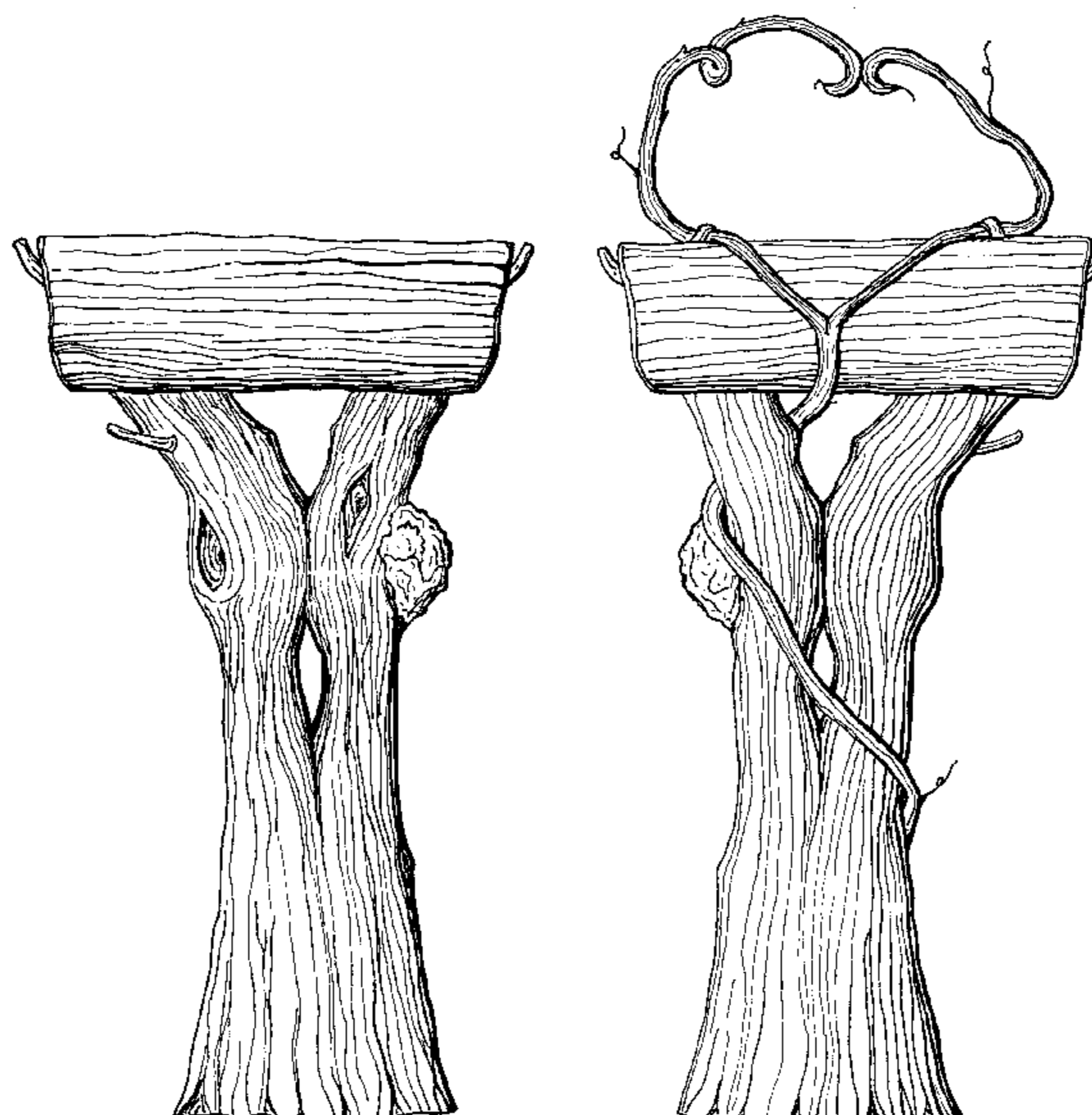
(57) **CLAIM**

The ornamental design for a mailbox assembly having a bifurcated post, as shown and described.

DESCRIPTION

FIG. 1 is a right side elevational view of a mailbox assembly having a bifurcated post showing my new design;
 FIG. 2 is a left side elevational view of the mailbox assembly;
 FIG. 3 is a front elevational view of the mailbox assembly;
 FIG. 4 is a top plan view;
 FIG. 5 is a rear elevational view;
 FIG. 6 is a right side elevational view of an alternative embodiment of the mailbox assembly having a bifurcated post showing my new design;
 FIG. 7 is a left side elevational view of the alternative mailbox assembly;
 FIG. 8 is a front elevational view of the alternative mailbox assembly;
 FIG. 9 is a top plan view of the alternative mailbox assembly; and,
 FIG. 10 is a rear elevational view of the alternative mailbox assembly.

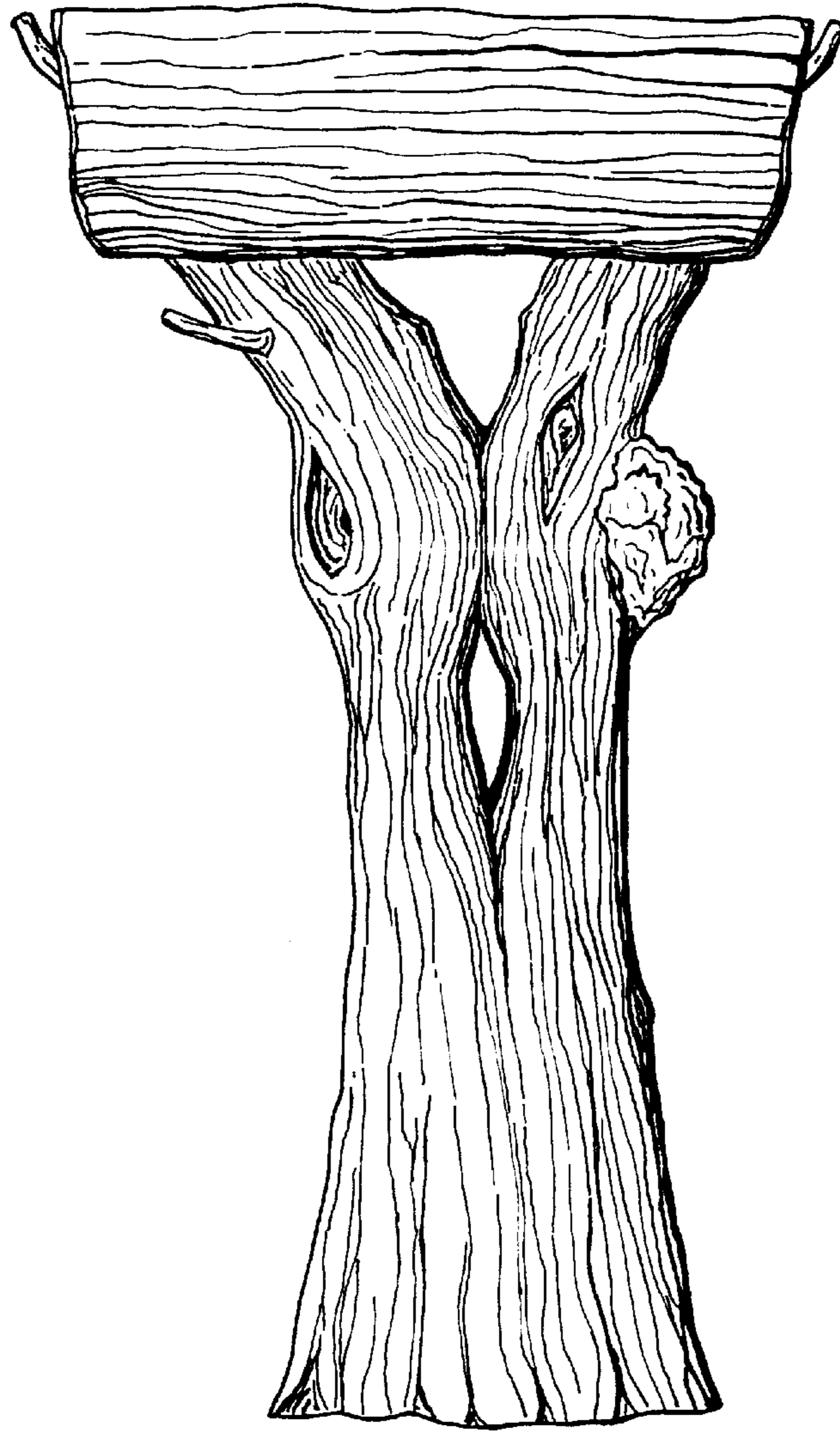

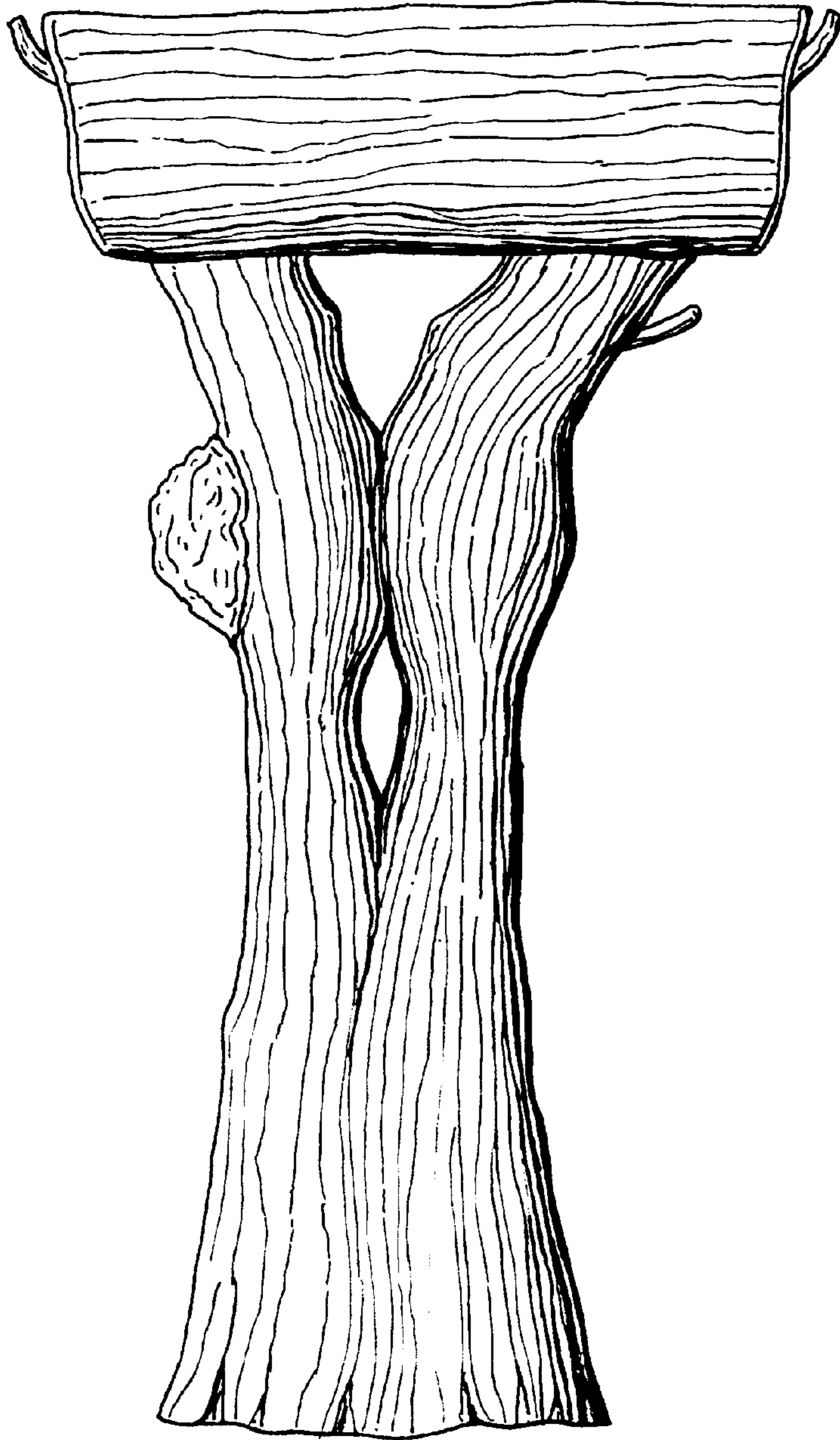

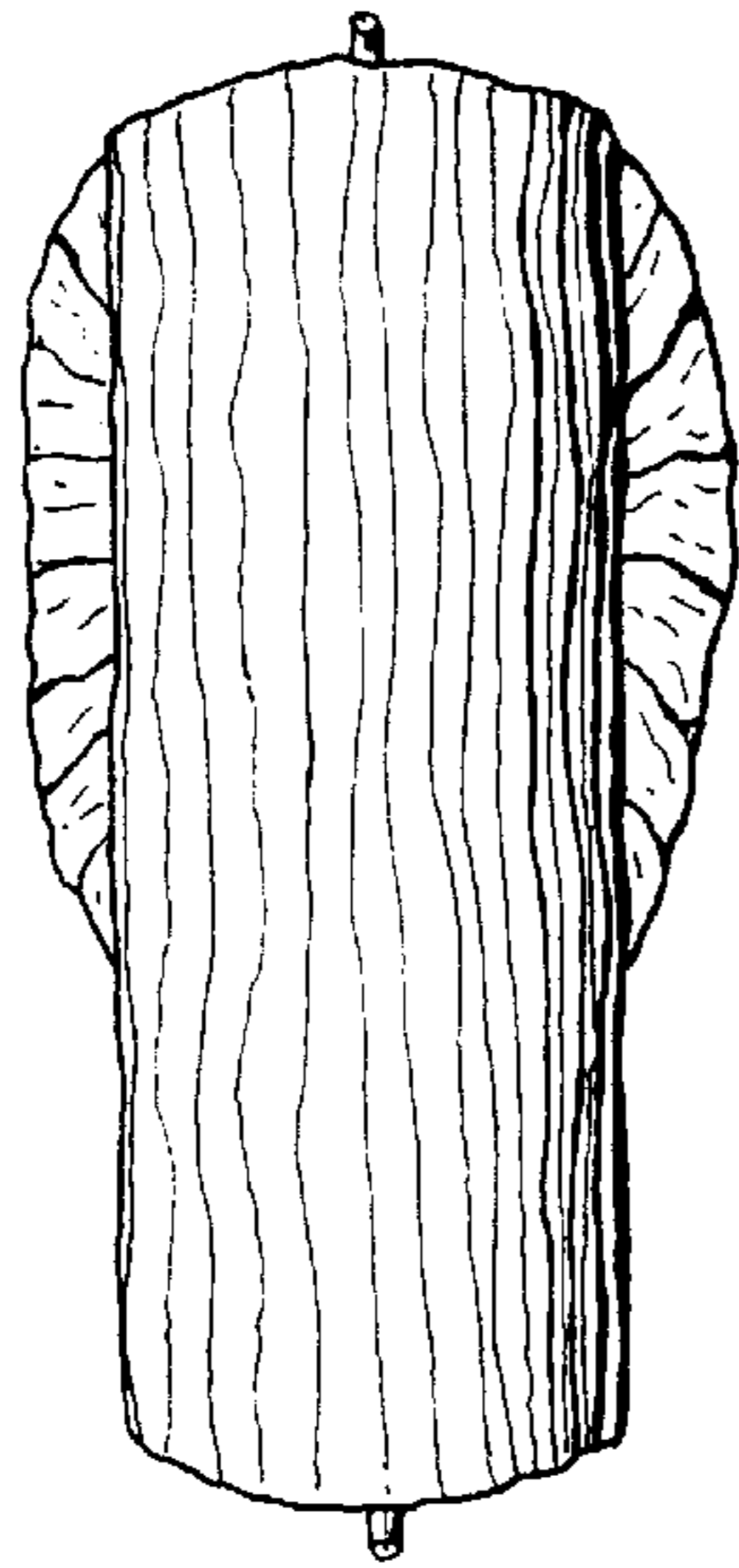

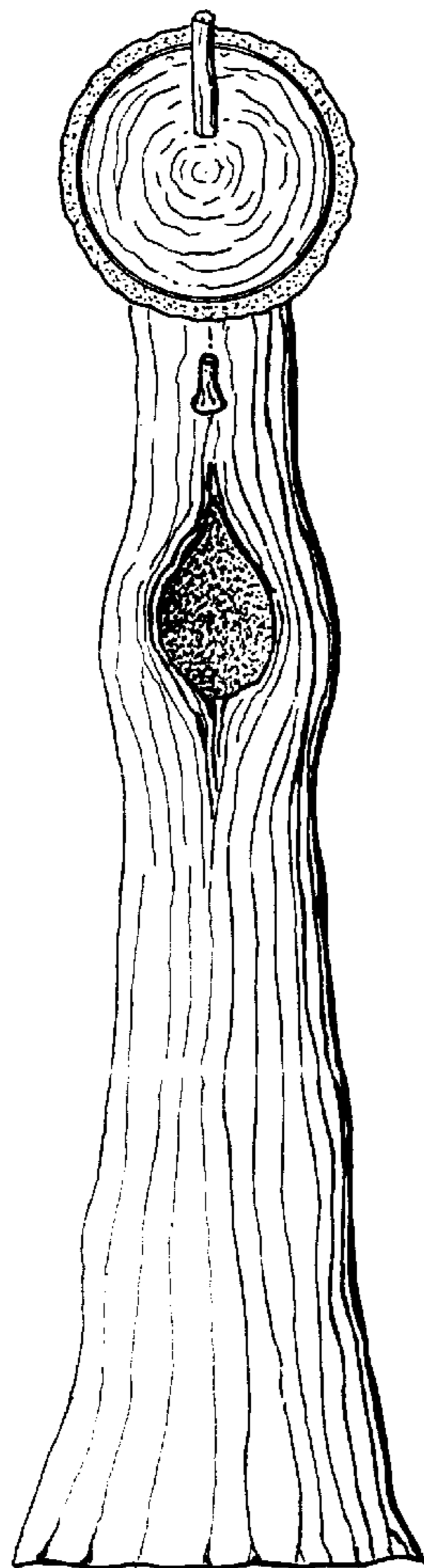

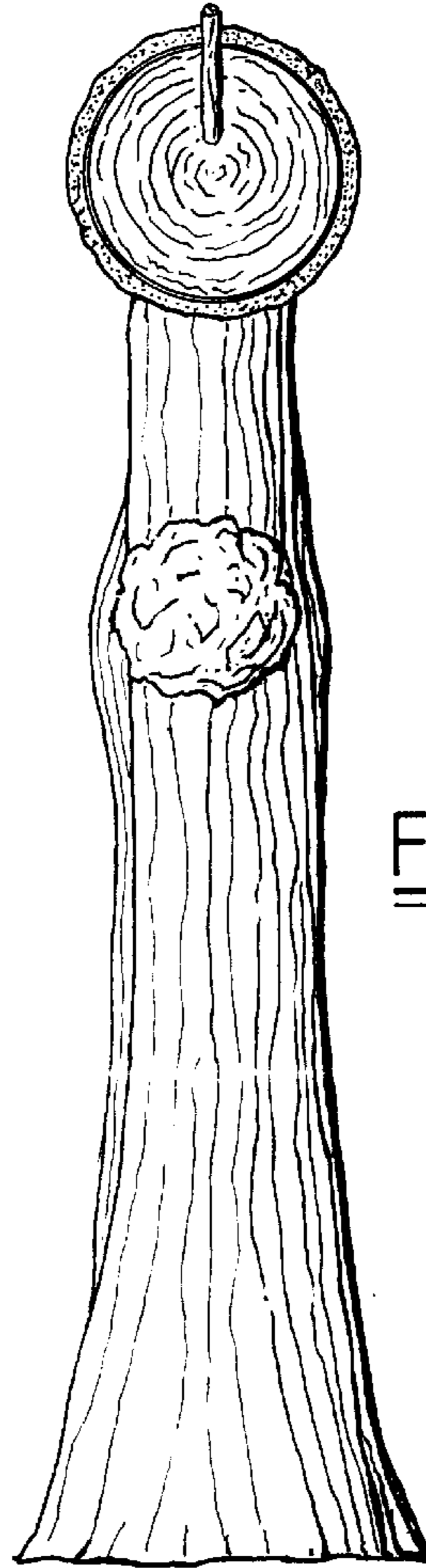

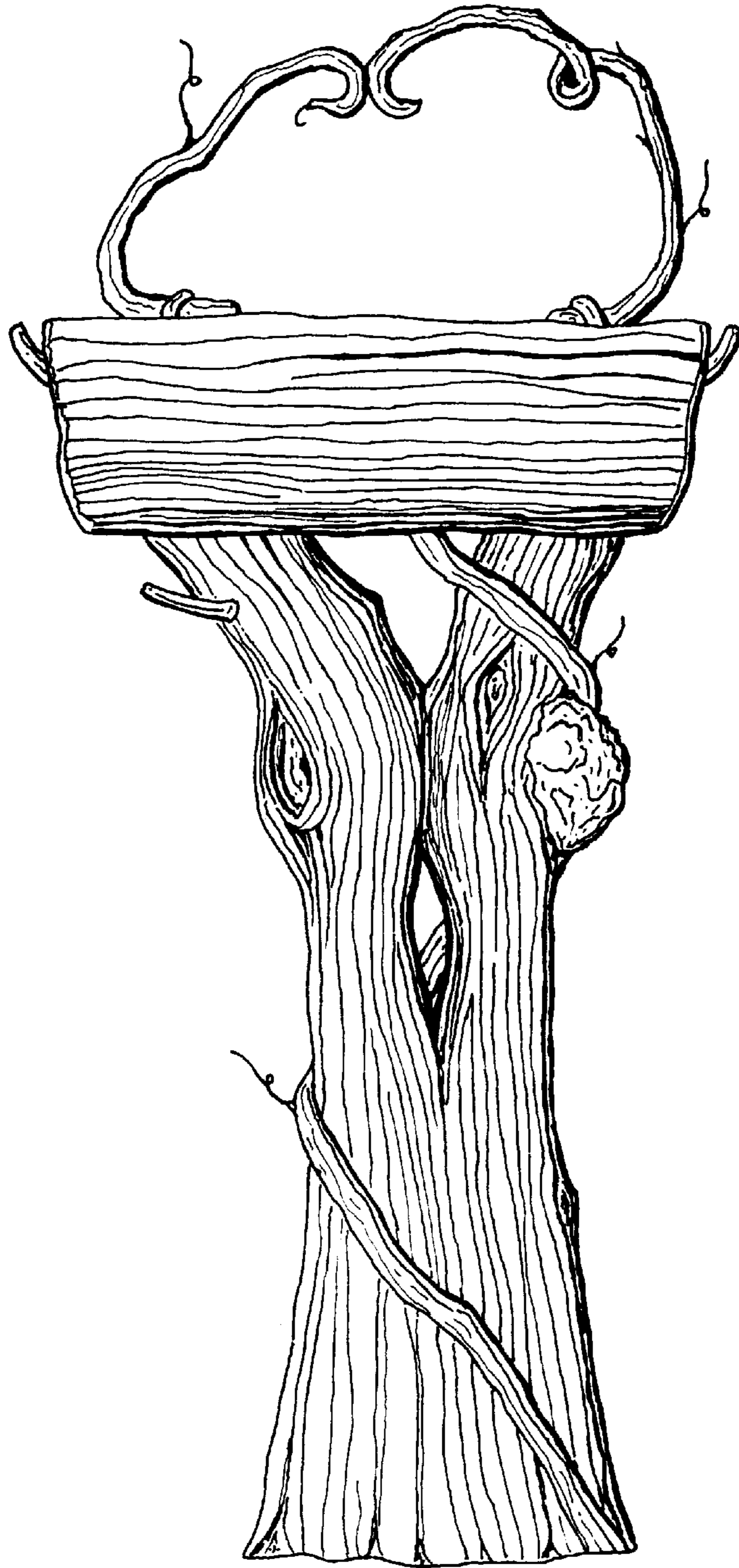

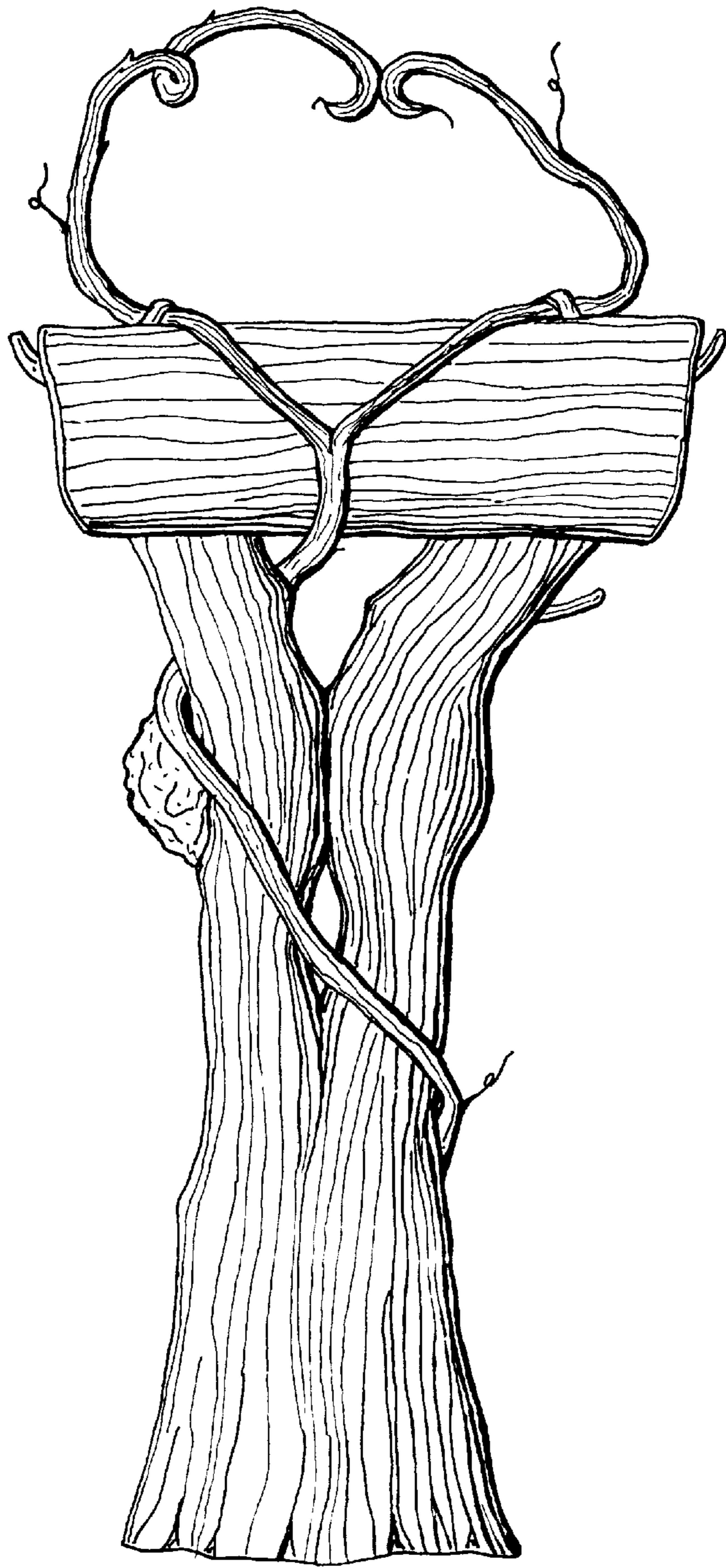

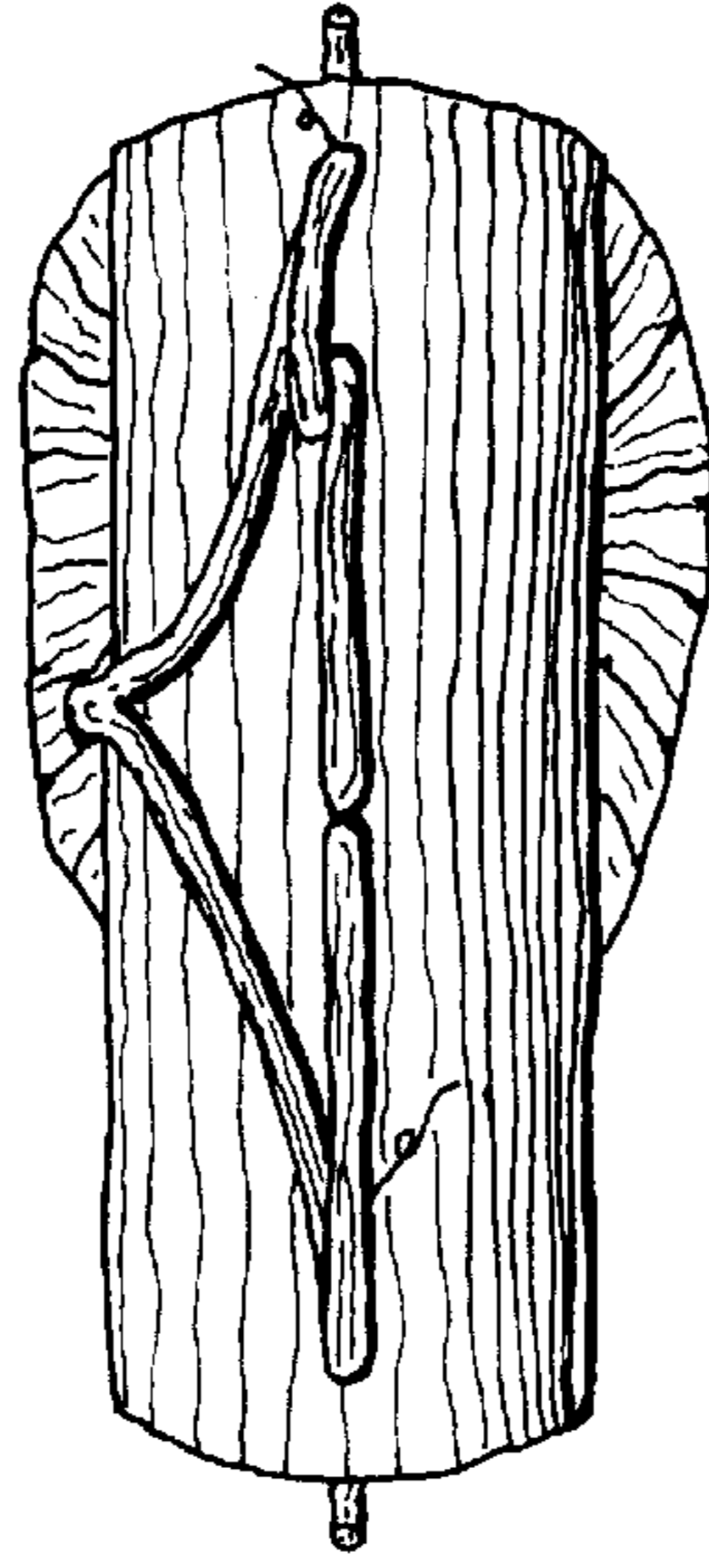

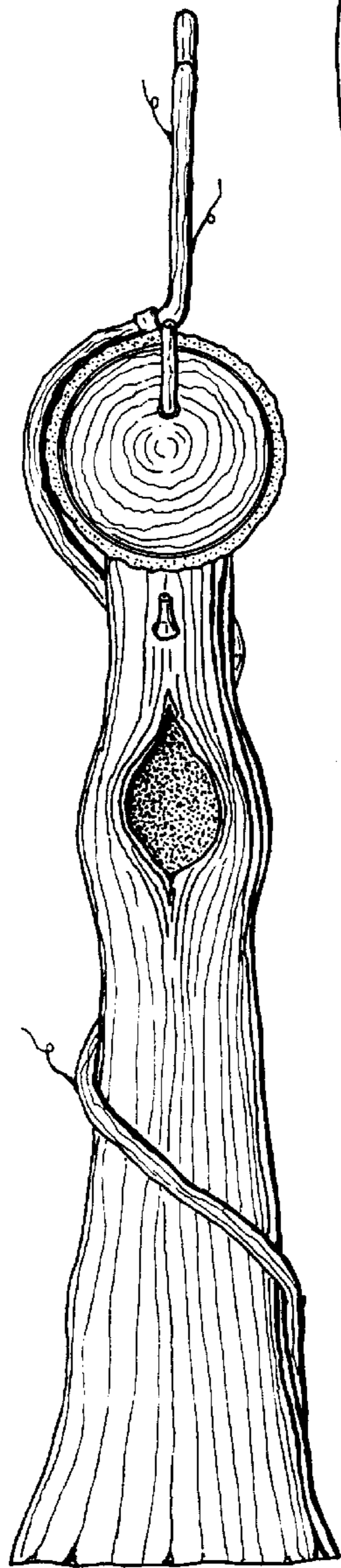
