(57) **CLAIM**

The ornamental design for a drink dispensing column, as shown and described.

DESCRIPTION

FIG. 1 is a front, perspective view of a drink dispensing column in accordance with the present invention with the tap shown in phantom view;

FIG. 2 is a front, elevational view of the drink dispensing column shown in FIG. 1;

FIG. 3 is a rear, elevational view of the drink dispensing column shown in FIG. 1;

FIG. 4 is a left-side, elevational view of the drink dispensing column shown in FIG. 1;

FIG. 5 is a right-side, elevational view of the drink dispensing column shown in FIG. 1;

FIG. 6 is a top, elevational view of the drink dispensing column shown in FIG. 1; and,

FIG. 7 is a bottom, elevational view of the drink dispensing column shown in FIG. 1.

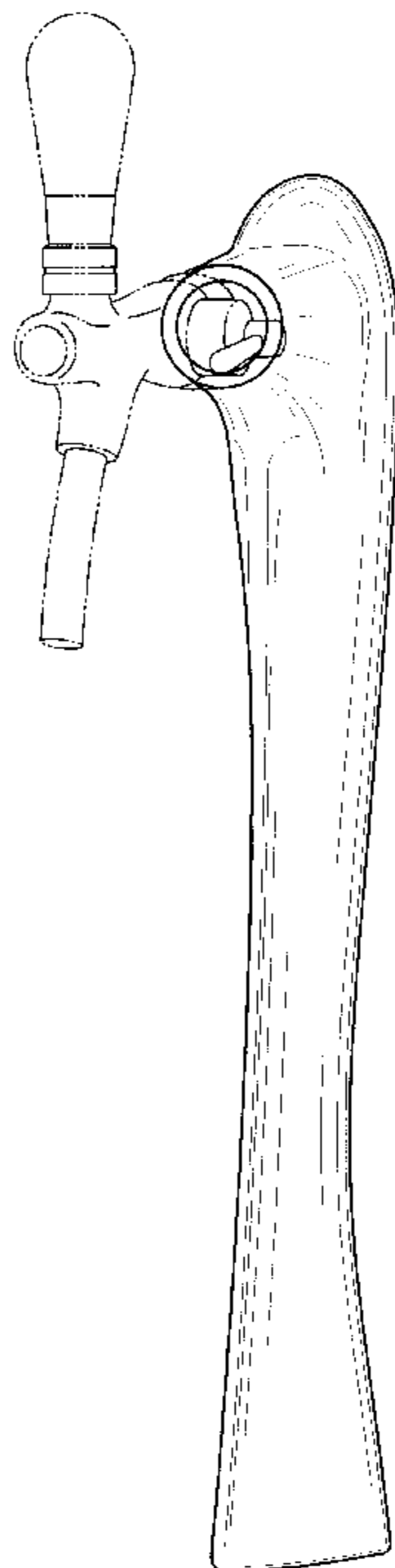

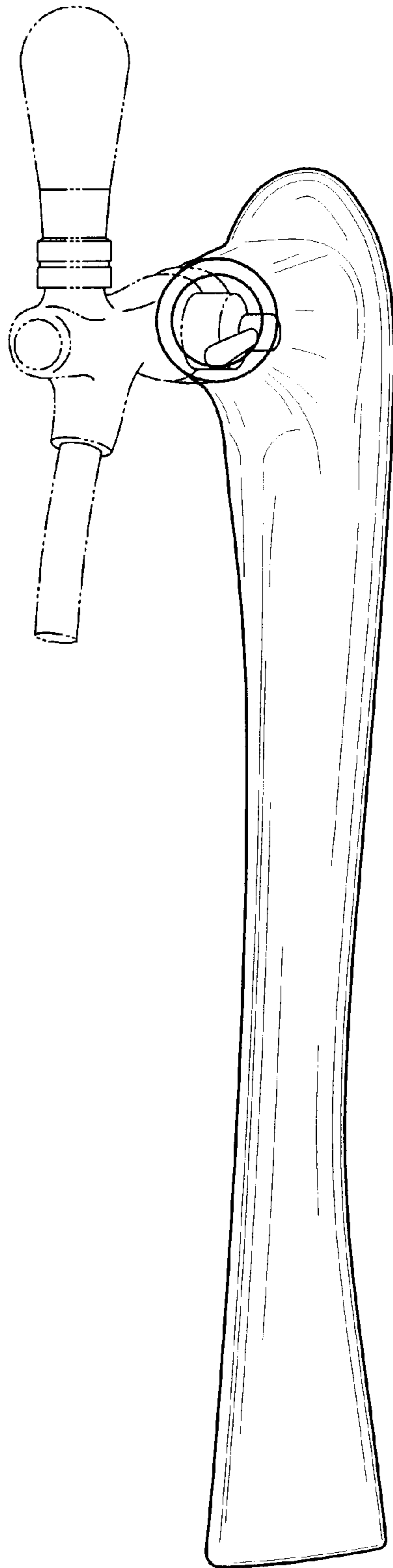

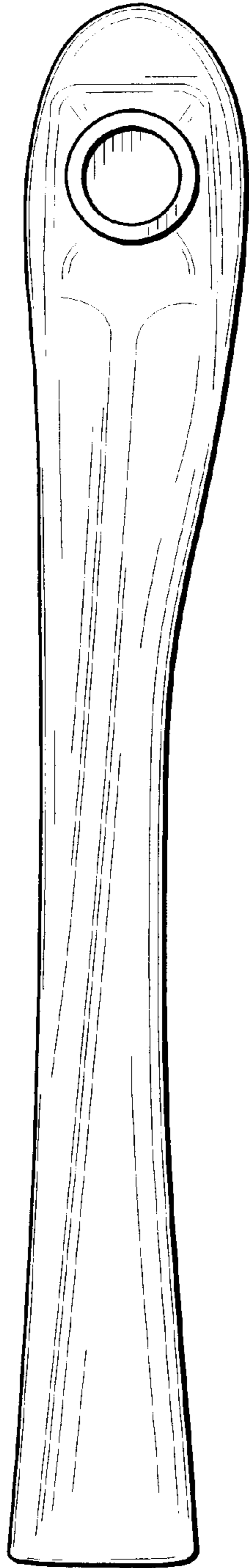

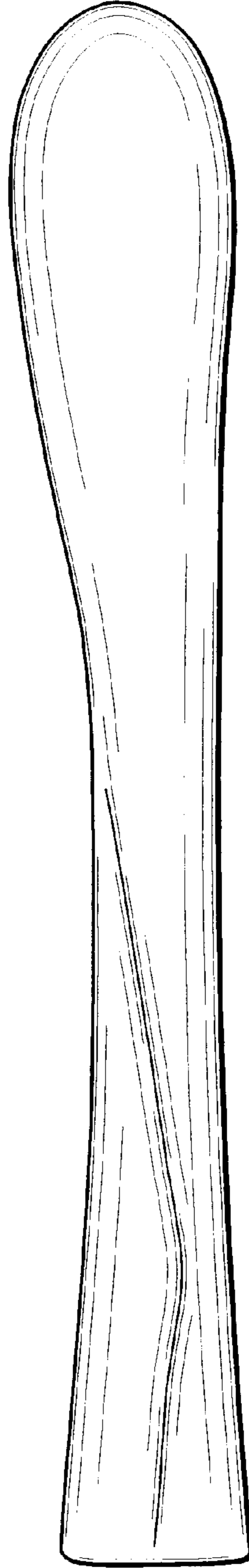

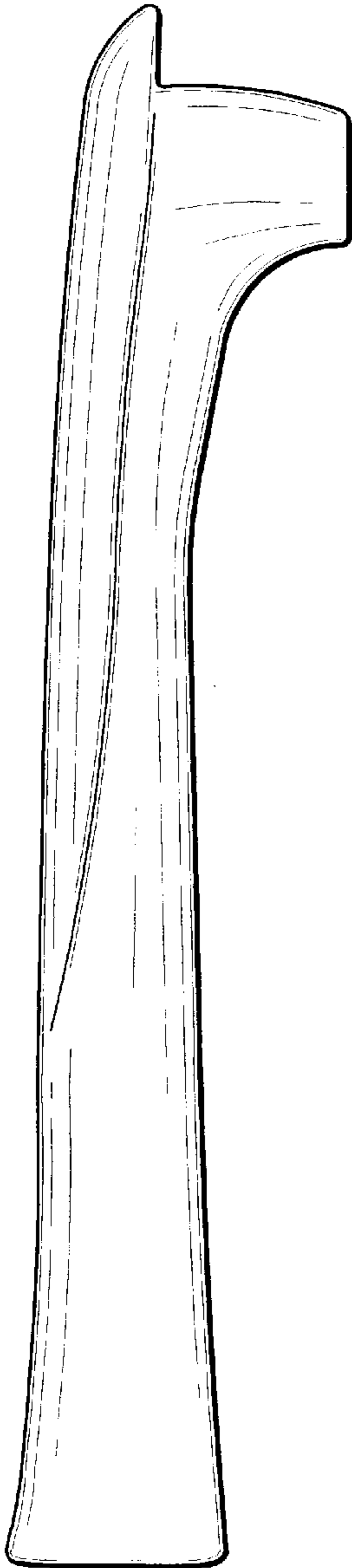

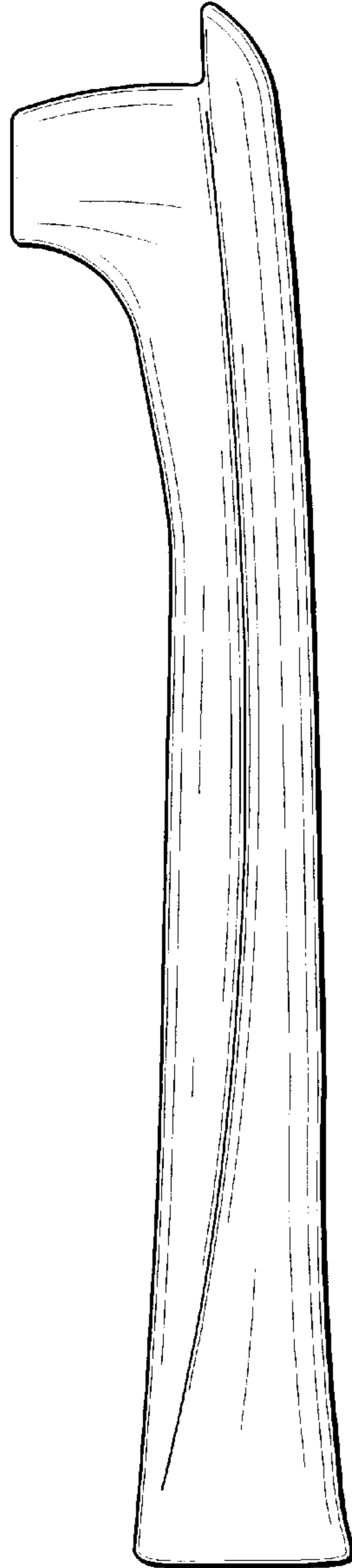

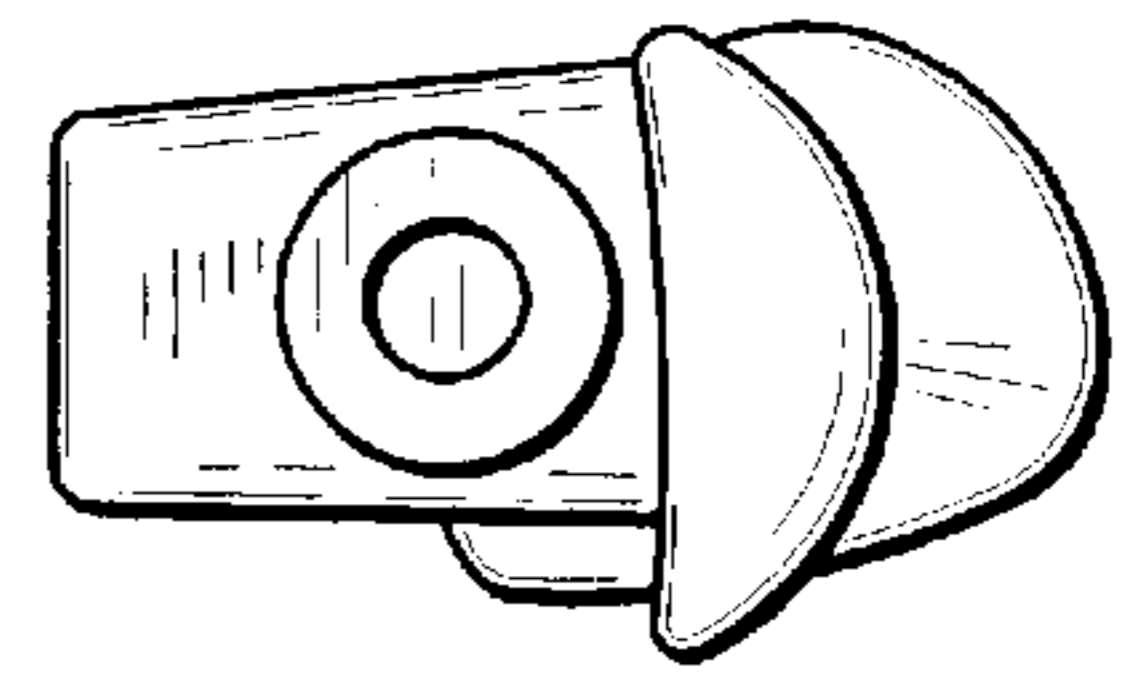
