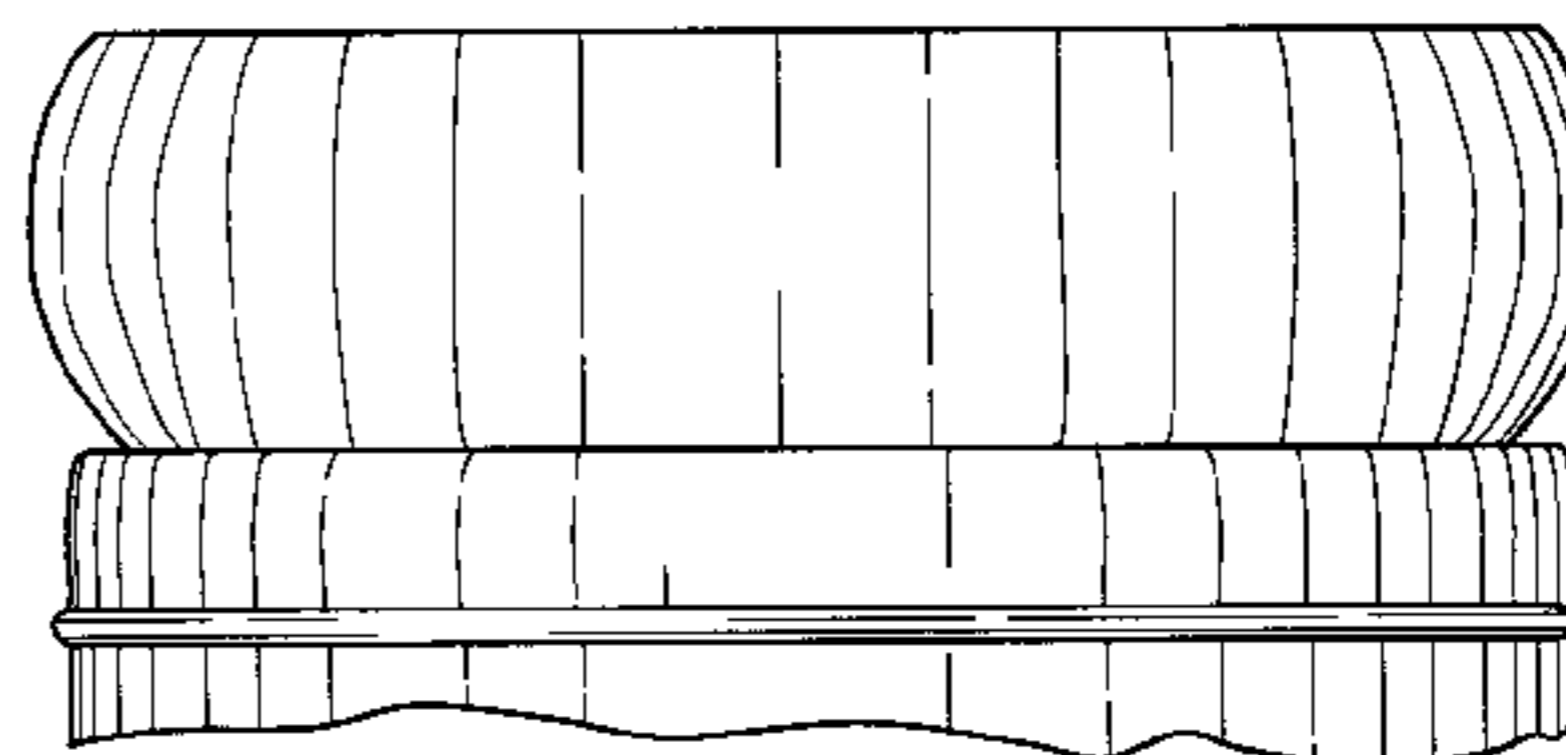
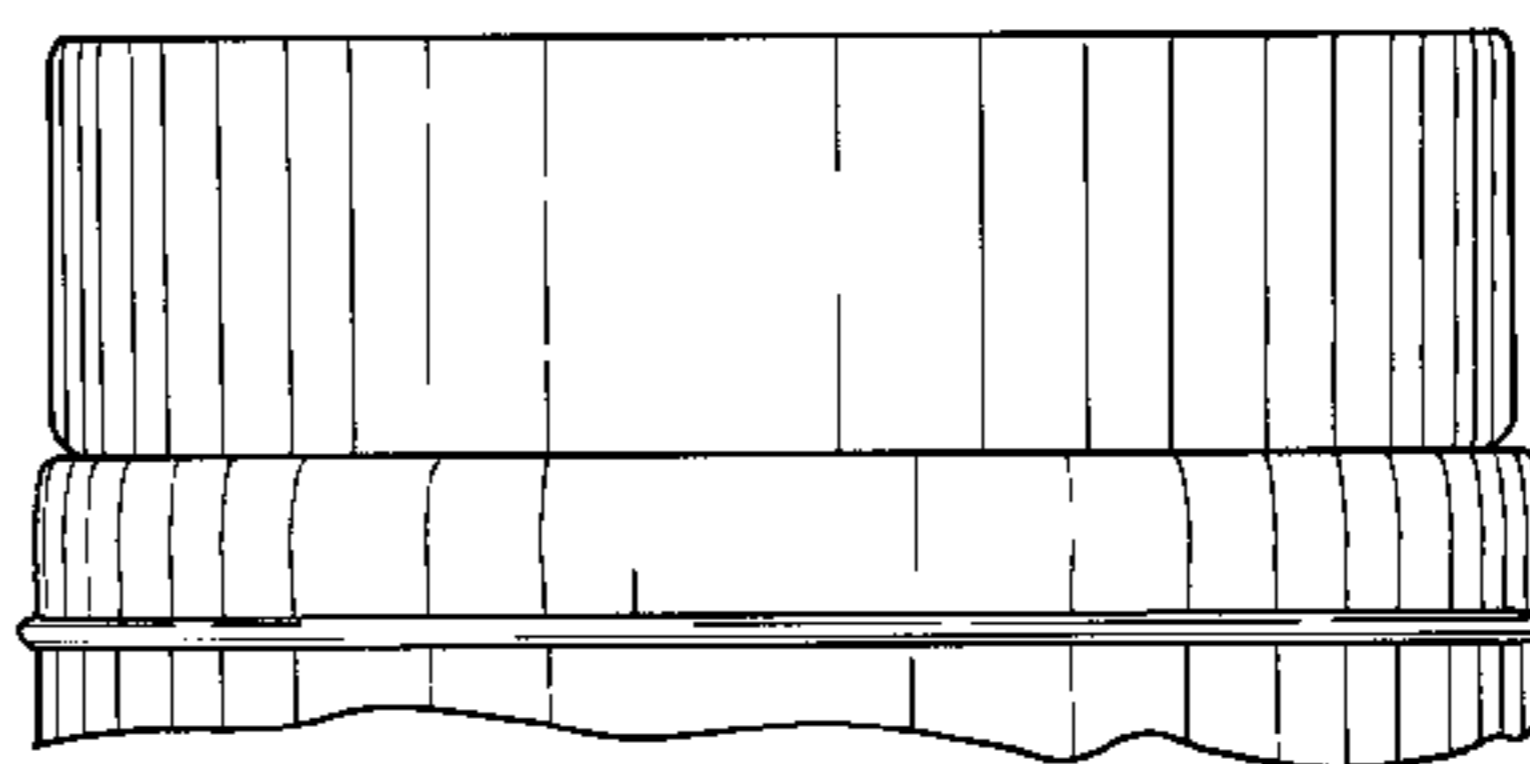
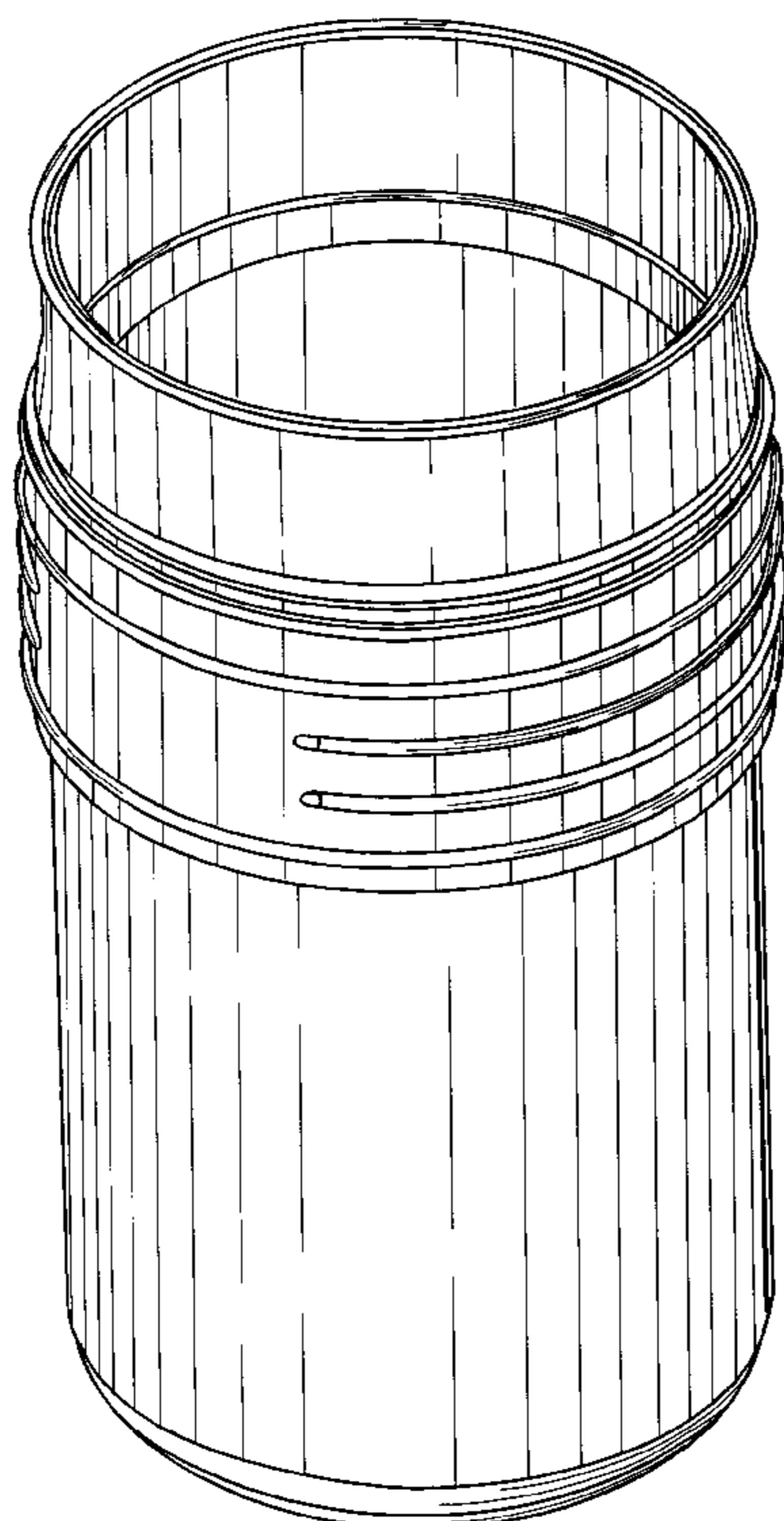
(57) **CLAIM**

The ornamental design for a glass holder containing a beverage glass, as shown and described.

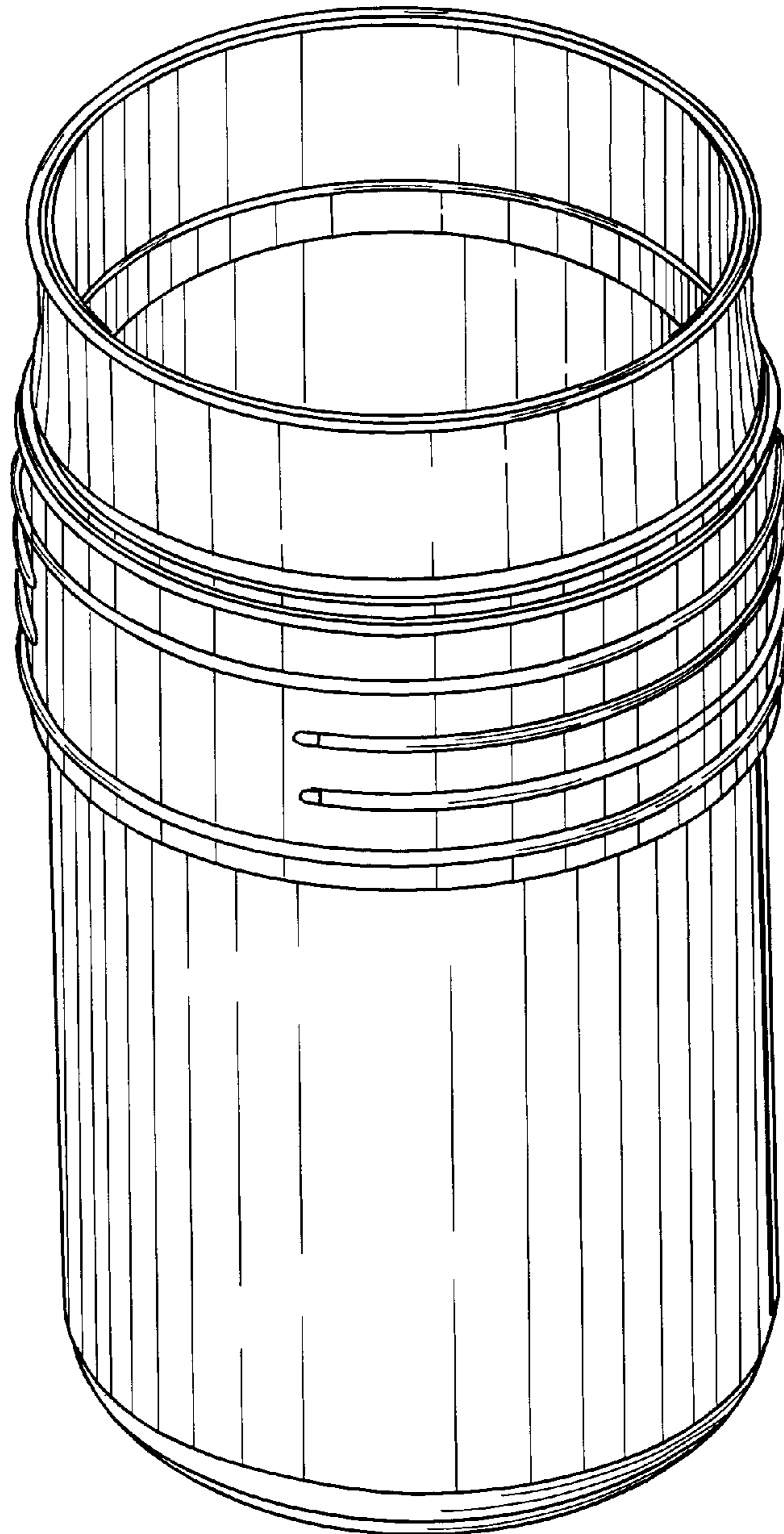
**DESCRIPTION**

FIG. 1 is a perspective view of our glass holder containing a beverage glass Design from the upper side thereof; FIG. 2 is a perspective view of our glass holder containing a beverage glass Design from the lower side thereof; FIG. 3 is an elevation of our glass holder containing a beverage glass Design as seen from one side thereof; FIG. 4 is an elevation of our glass holder containing a beverage glass Design taken at 90° to the illustration in FIG. 3; FIG. 5 is a plan view of our glass holder containing a beverage glass Design; FIG. 6 is a bottom view of our glass holder containing a beverage glass Design; FIG. 7 is a fragmentary view of the upper part of a modified embodiment of our glass holder containing a beverage glass Design illustrating its appearance taken from any angle, it being understood that the lower part of this embodiment is identical to that shown in FIGS. 1-6 inclusive; and, FIG. 8 is a fragmentary elevation of the upper part of still another modified embodiment of our glass holder containing a beverage glass Design illustrating its appearance taken from any angle, it being again understood that the bottom part of the elevation is identical to that illustrated in FIGS. 1-6, inclusive.

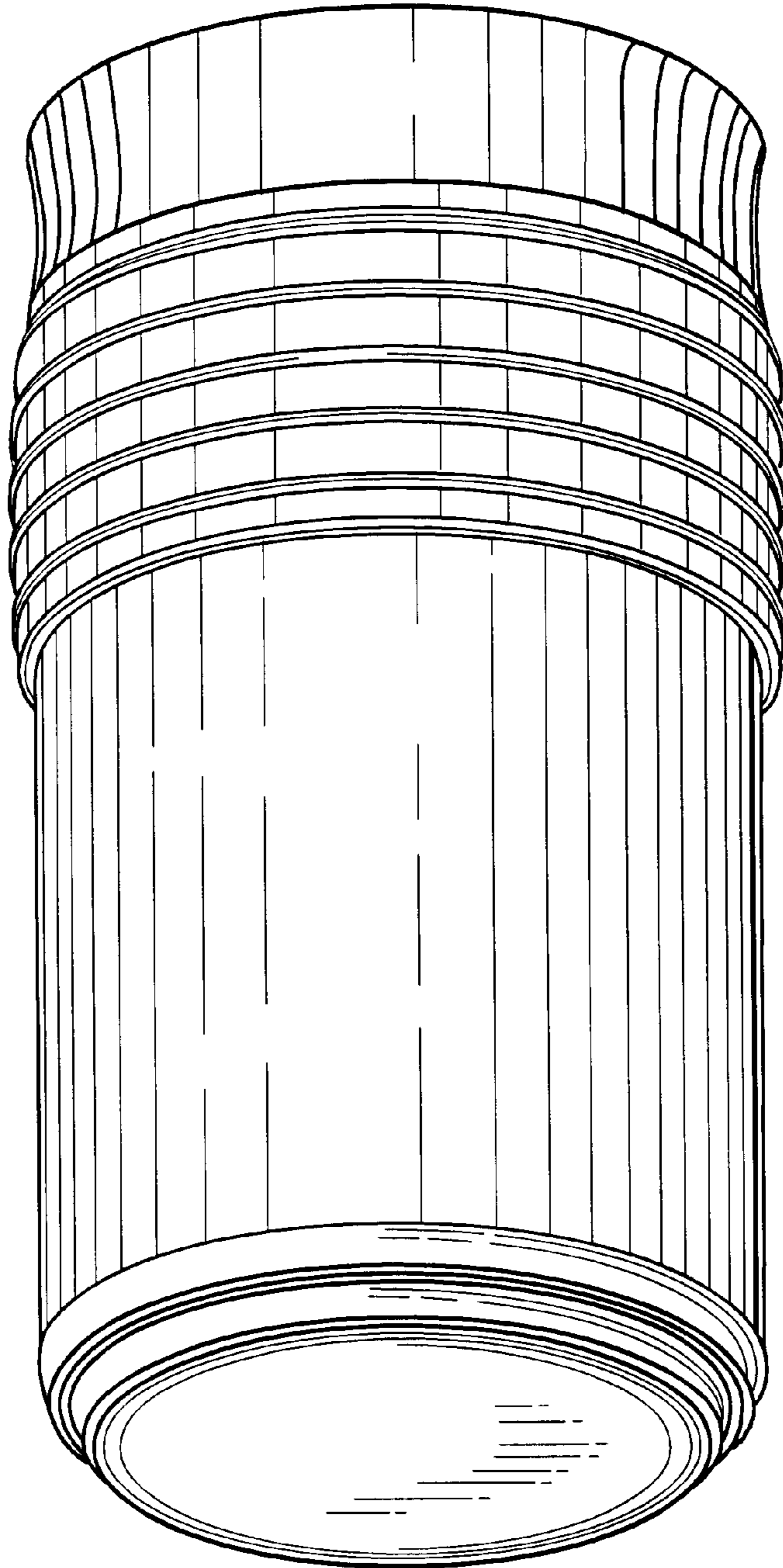

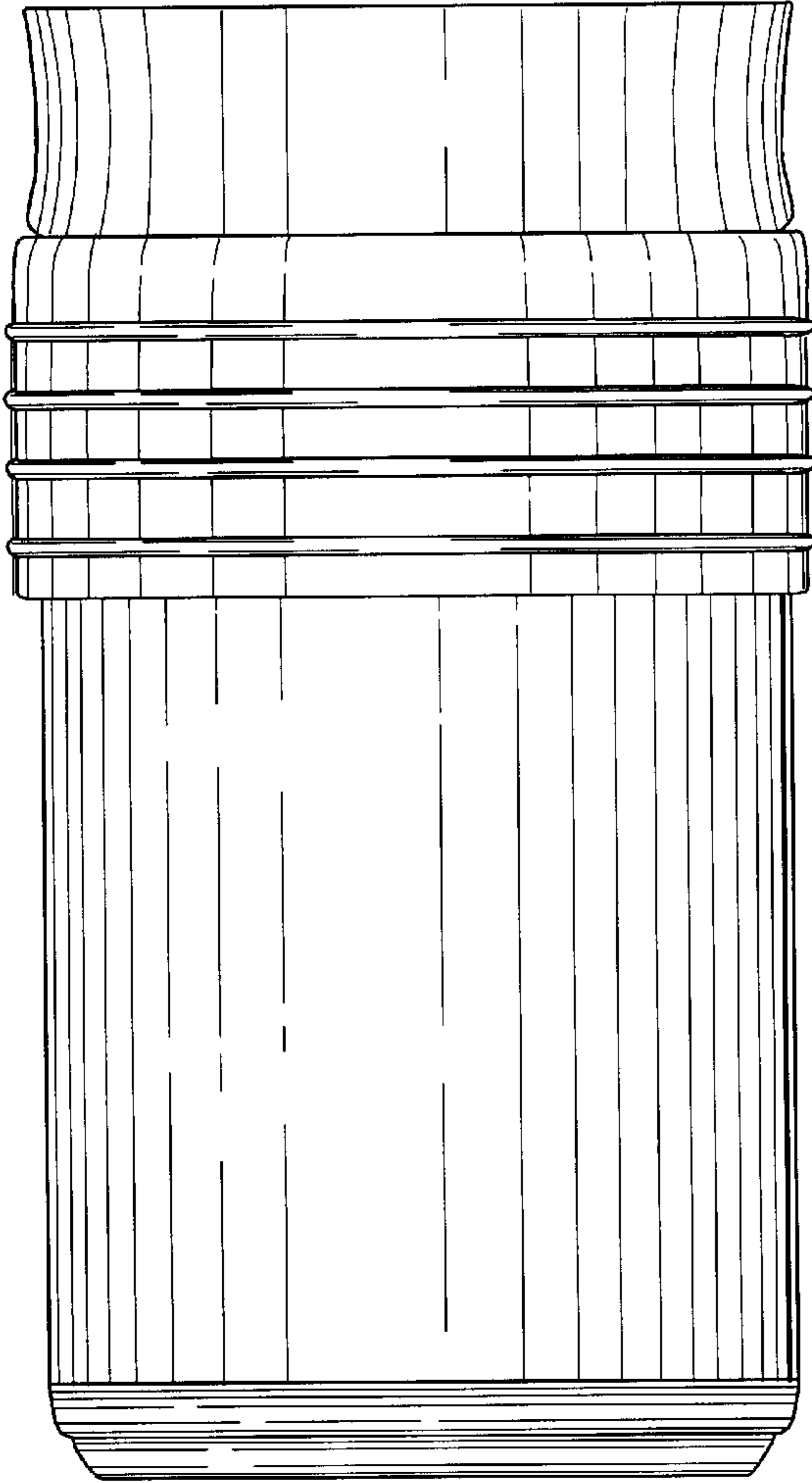

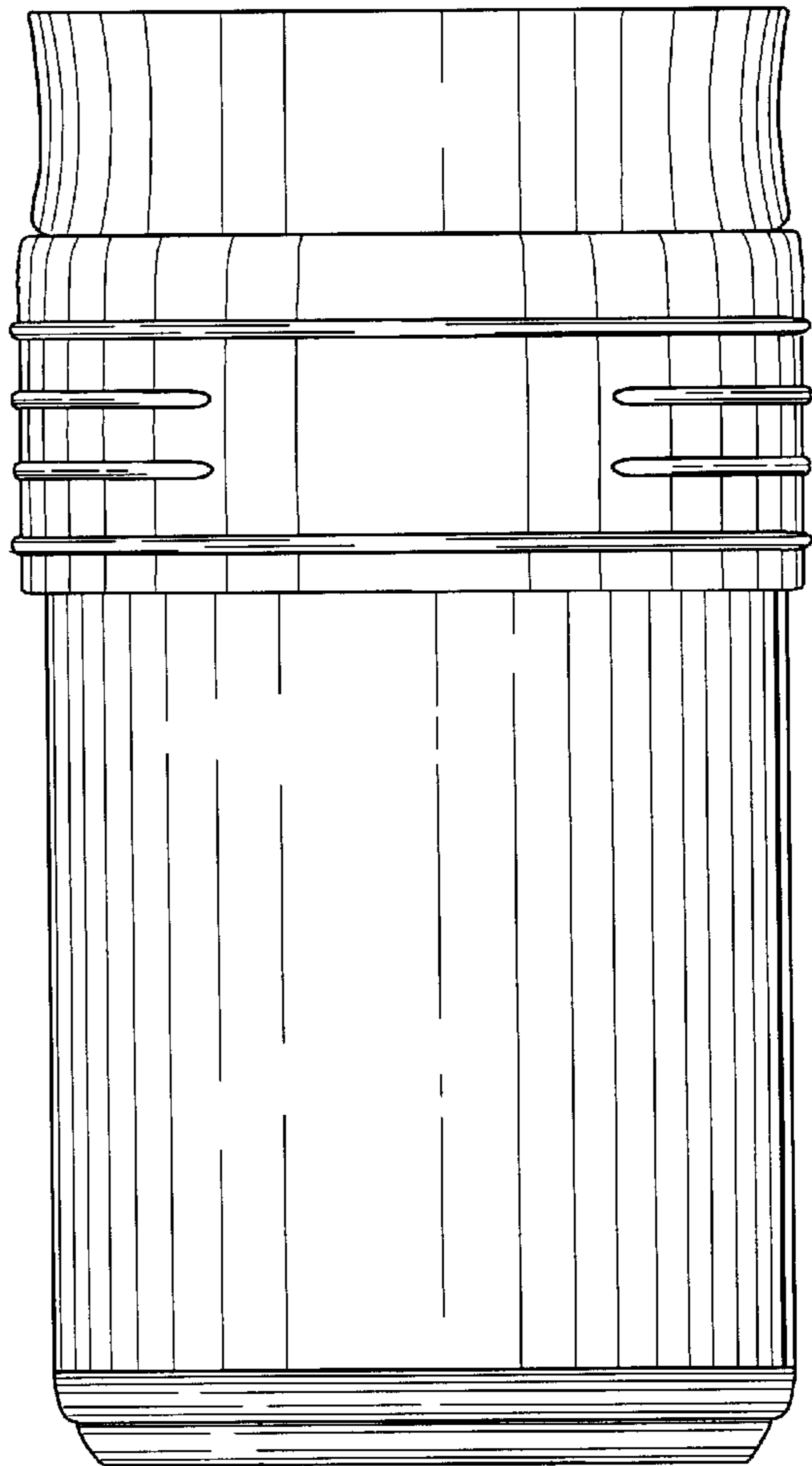

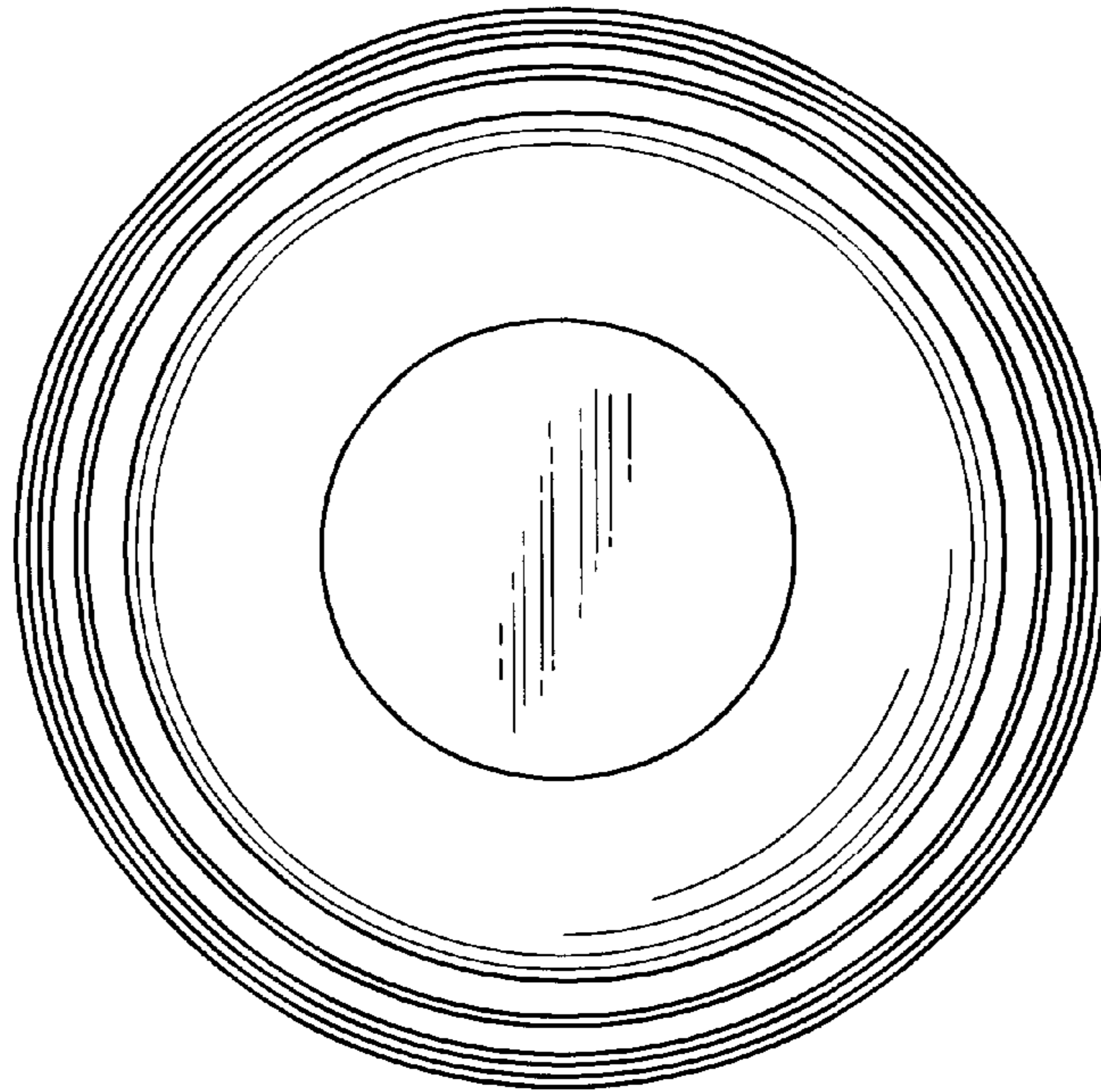

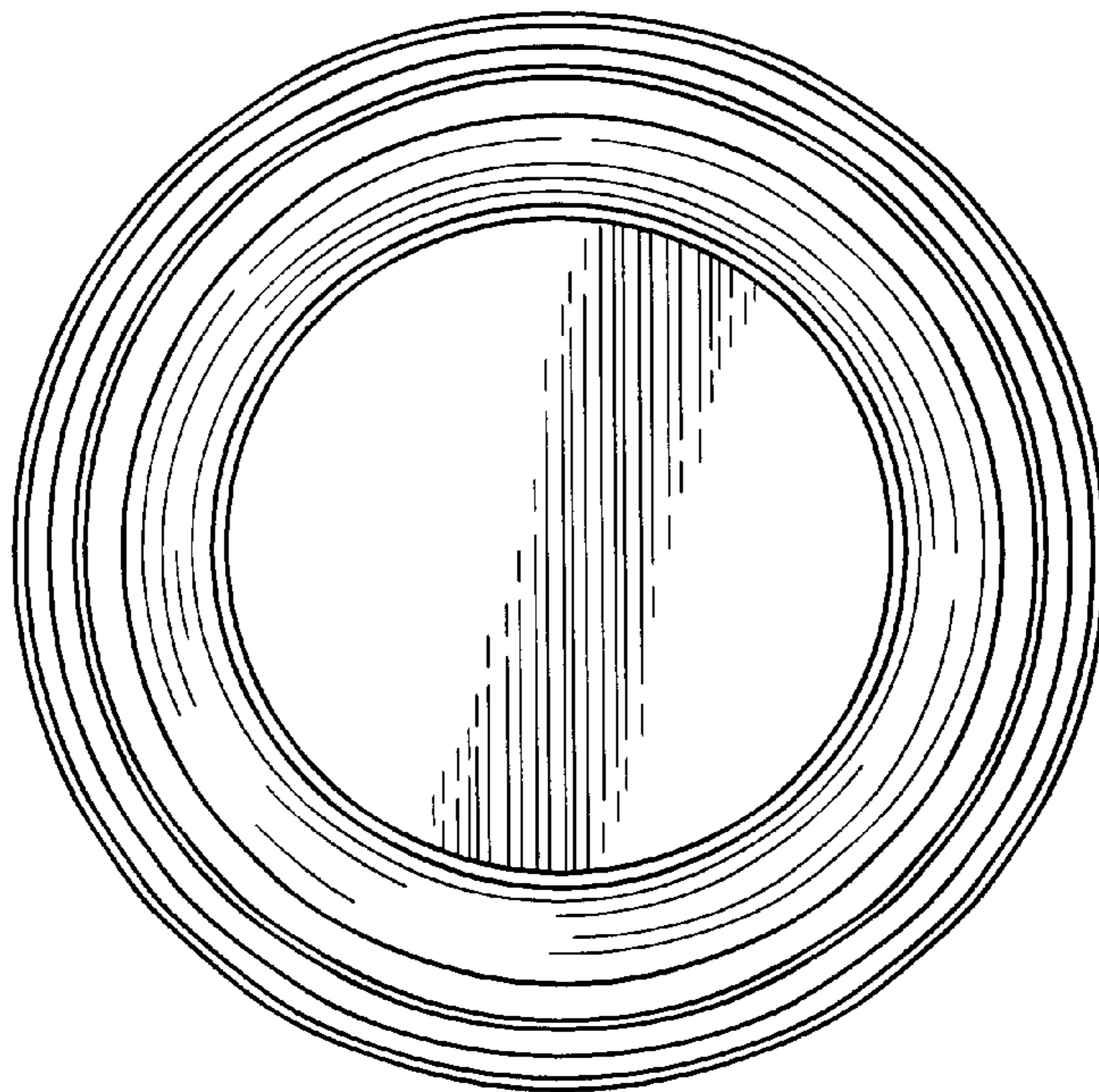

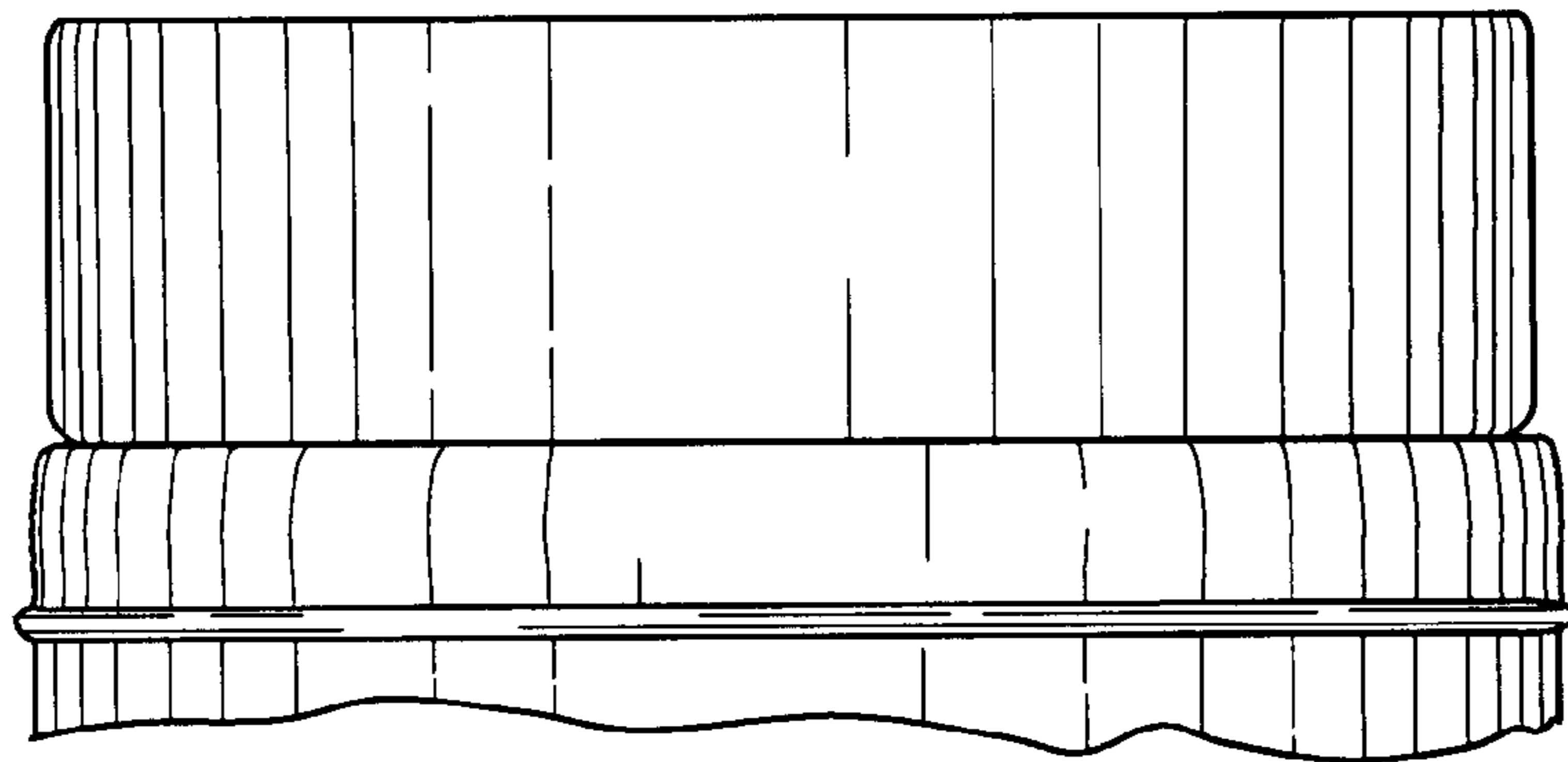
