(57) **CLAIM**

The ornamental design for a belt adjuster, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a belt adjuster of the claimed design.

FIG. 2 is a front elevational view of the belt adjuster of FIG. 1.

FIG. 3 is a rear elevational view of the belt adjuster of FIG. 1.

FIG. 4 is a top plan view of the belt adjuster of FIG. 1.

FIG. 5 is a bottom plan view of the belt adjuster of FIG. 1.

FIG. 6 is a right side view of the belt adjuster of FIG. 1, and the left side view is a mirror image thereof.

FIG. 7 is a cross-sectional view taken along the line 7—7 of FIG. 2;

FIG. 8 is a cross-sectional view taken along the line 8—8 of FIG. 2;

FIG. 9 is the cross-sectional view of FIG. 7 shown in a position of use with a belt. The broken line showing of a belt is for illustrative purposes only and forms no part of the claimed design; and,

FIG. 10 is a reference, right side view of the belt adjuster of FIG. 1 showing a state of movement of the belt adjuster.

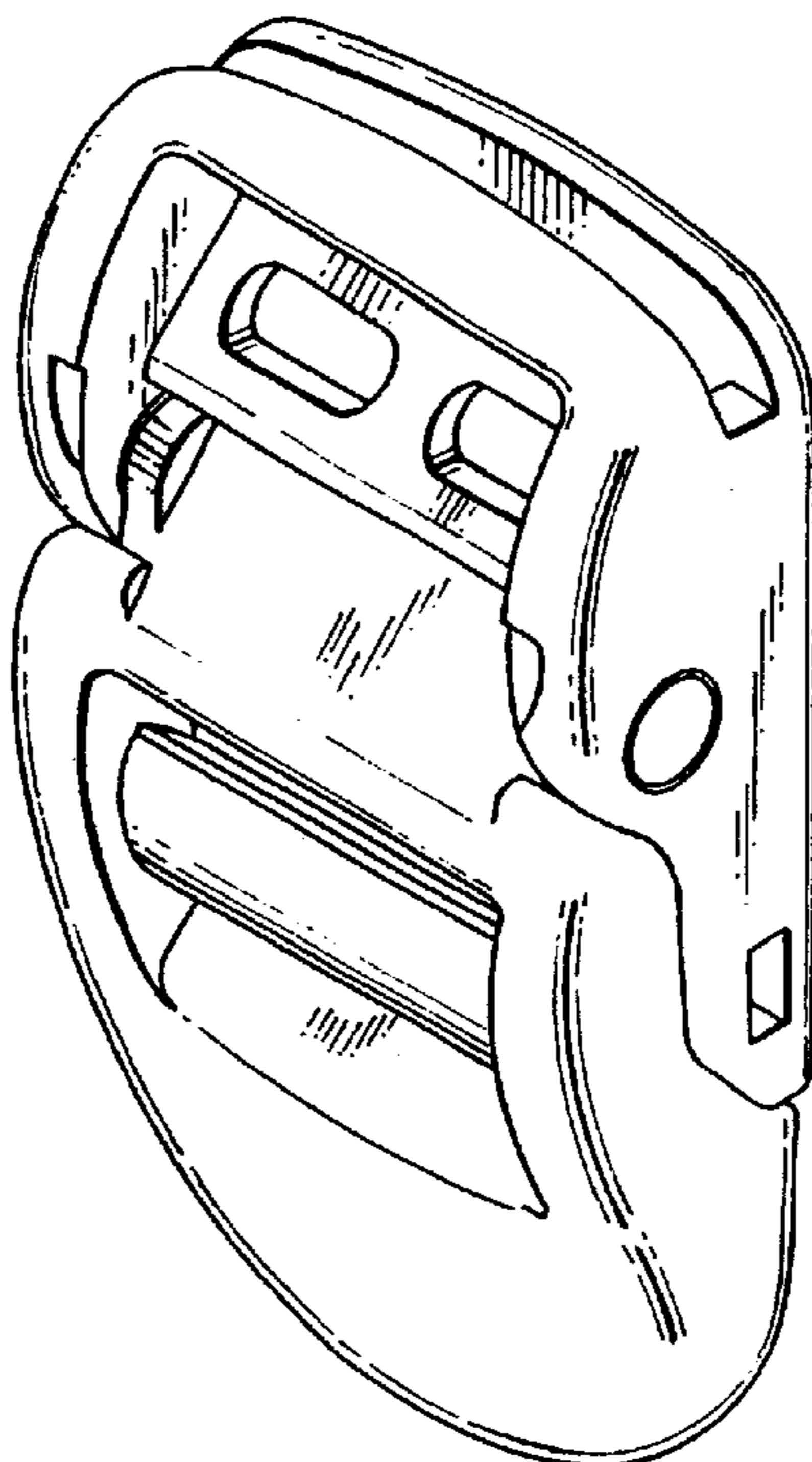

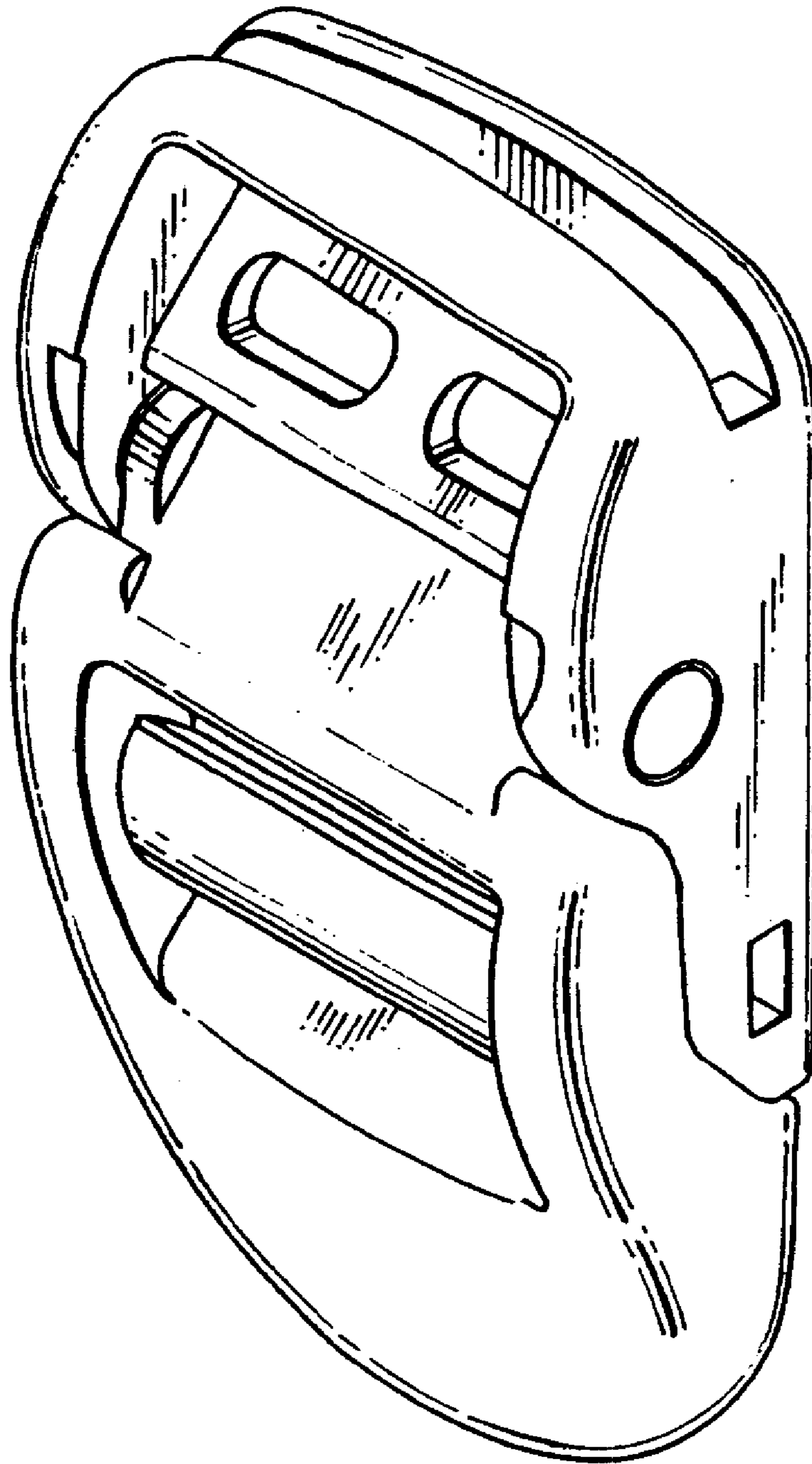

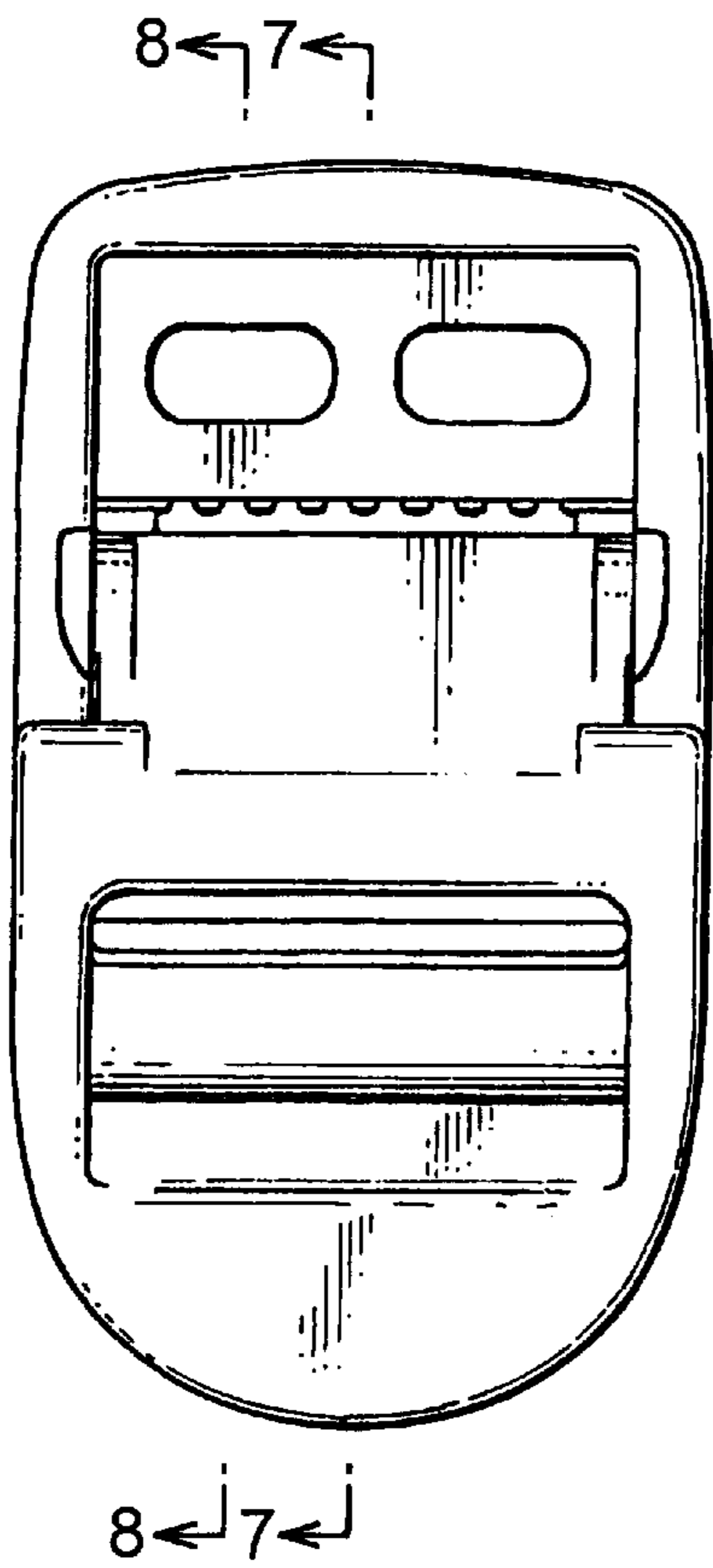

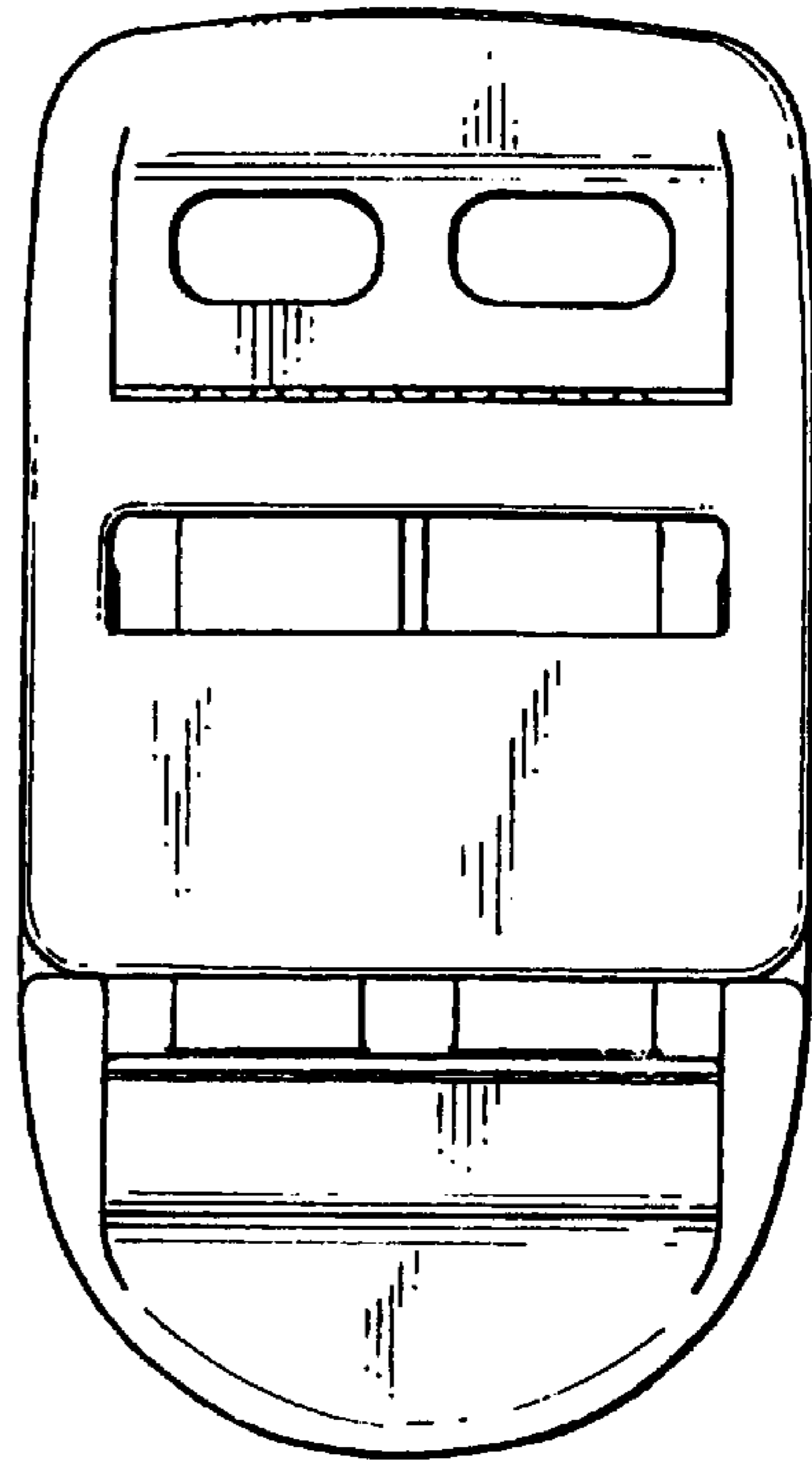

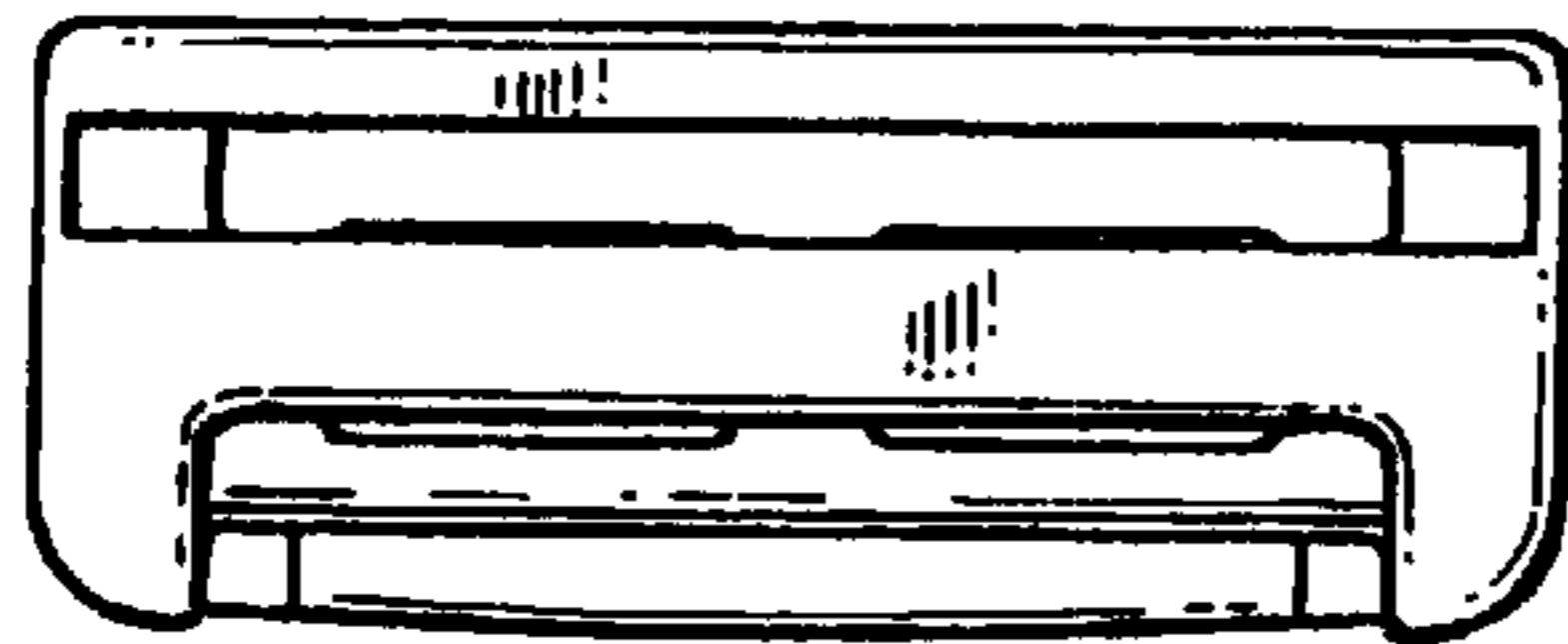

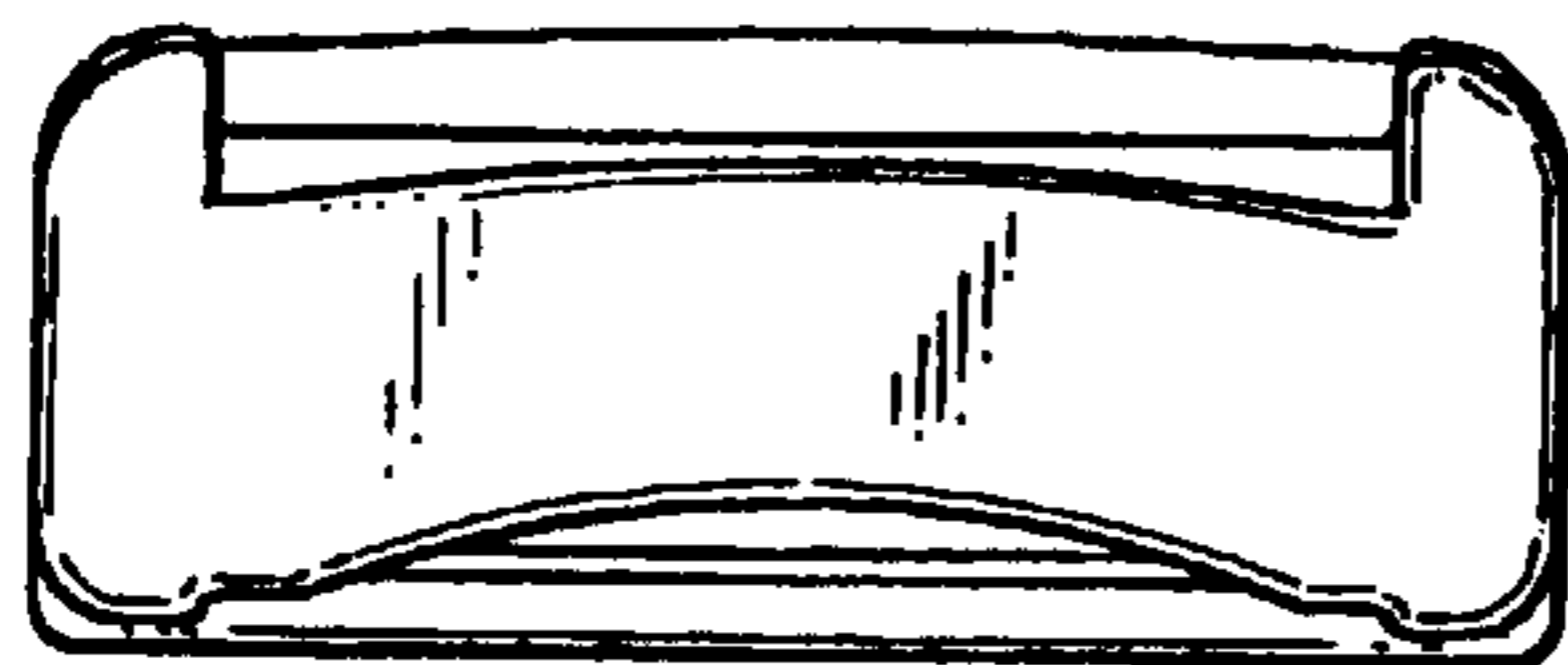

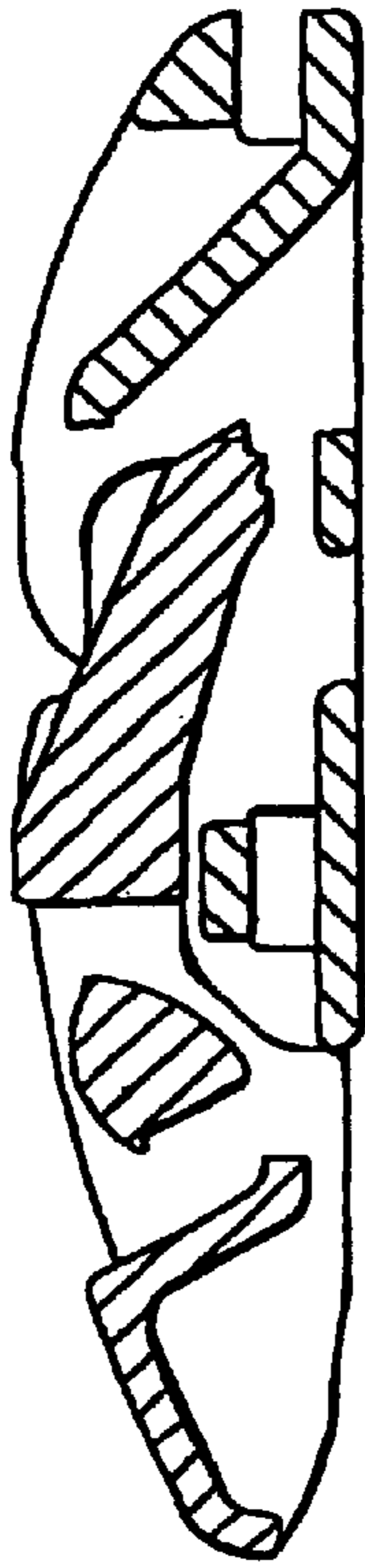

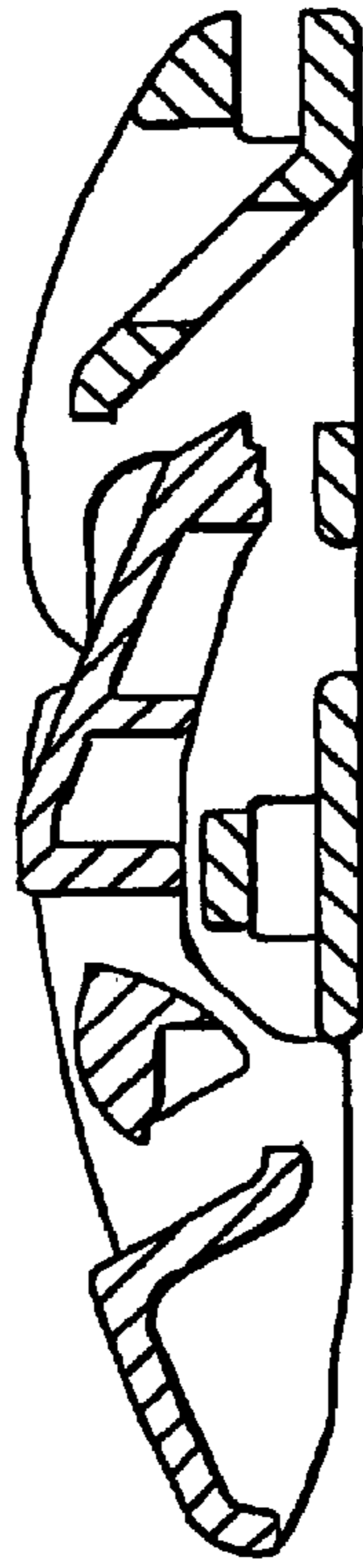

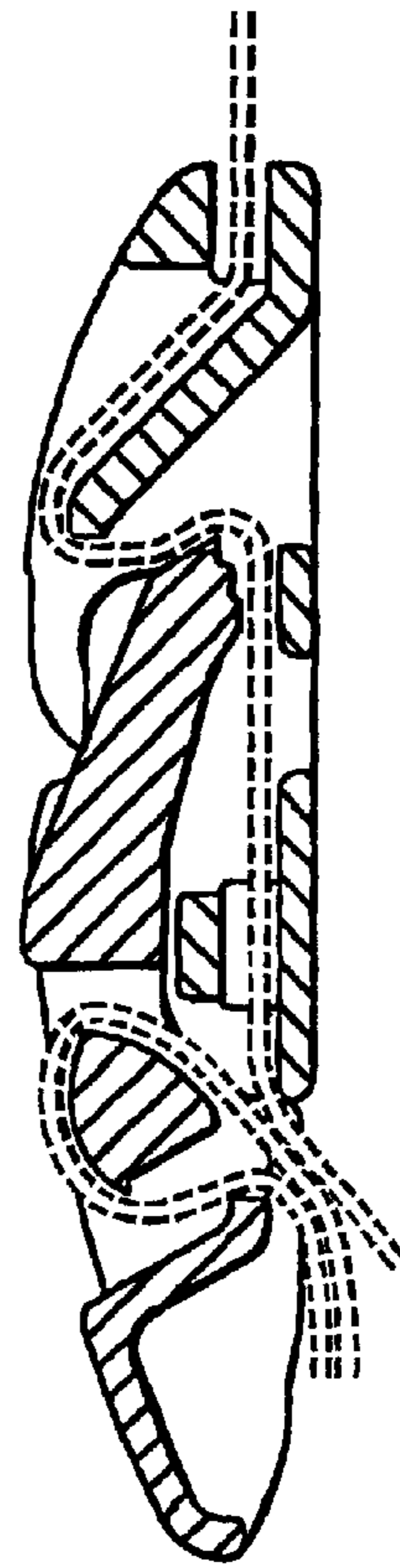
