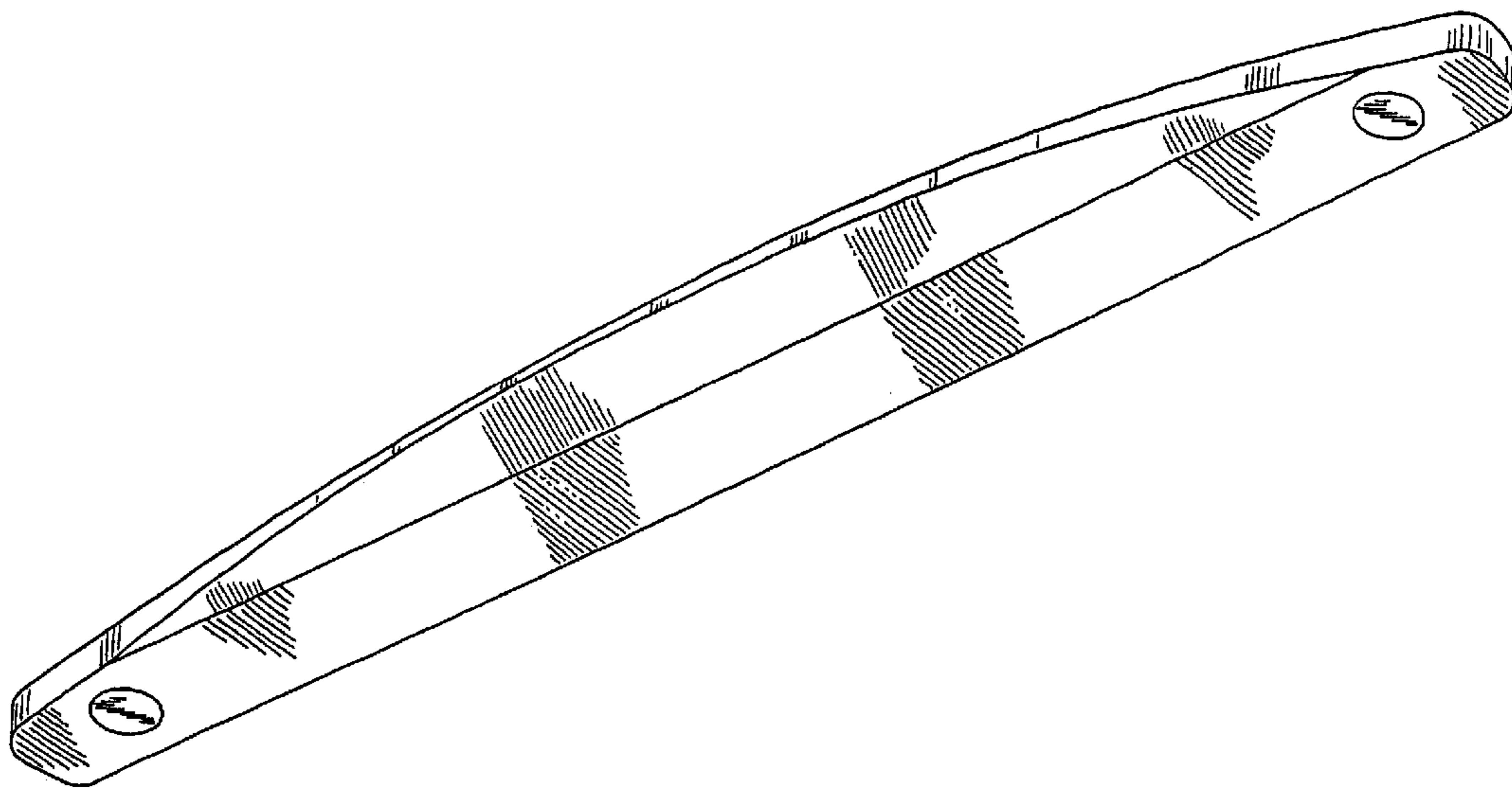
(57) **CLAIM**

DESCRIPTION

- FIG. 1 is a perspective view of a magnetic clip showing our new design;
- FIG. 2 is a front elevational view thereof;
- FIG. 3 is a top plan view thereof;
- FIG. 4 is a bottom plan view thereof;
- FIG. 5 is a side elevational view taken from the right of FIG. 2;
- FIG. 6 is a side elevational view taken from the left of FIG. 2; and,
- FIG. 7 is a rear elevational view thereof.

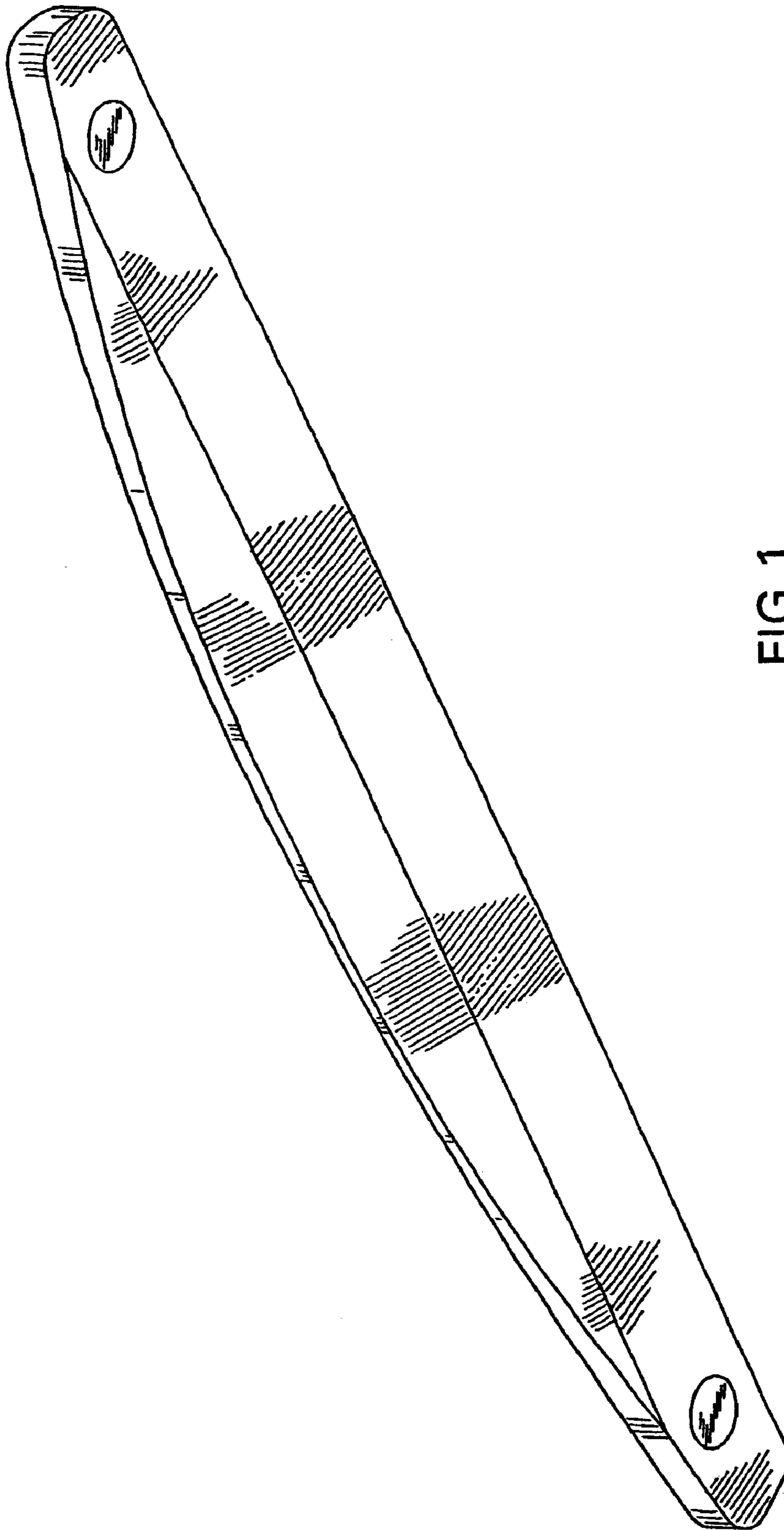

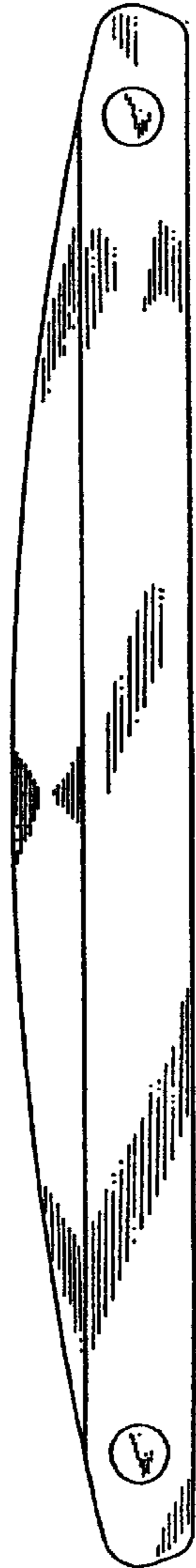
