(57) **CLAIM**

The ornamental design for a tail lens assembly, as shown and described.

DESCRIPTION

FIG. 1 is a front-right perspective view of a preferred embodiment of the tail lens assembly according to the present design;

FIG. 2 is a front-right perspective view of another preferred embodiment of the tail lens assembly according to the present design;

FIG. 3 is a partially exploded front-right perspective view of the tail lens assembly of FIG. 1, illustrating the cover of the tail lens assembly removed;

FIG. 4 is a partially exploded front-right perspective view of the tail lens assembly of FIG. 2, illustrating the cover of the tail lens assembly removed;

FIG. 5 is a front elevational view of the tail lens assembly of FIG. 1;

FIG. 6 is a front elevational view of the tail lens assembly of FIG. 2;

FIG. 7 is a right-side elevational view of the tail lens assembly of FIG. 1;

FIG. 8 is a right-side elevational view of the tail lens assembly of FIG. 2;

FIG. 9 is a top plan view of the tail lens assembly of FIG. 1;

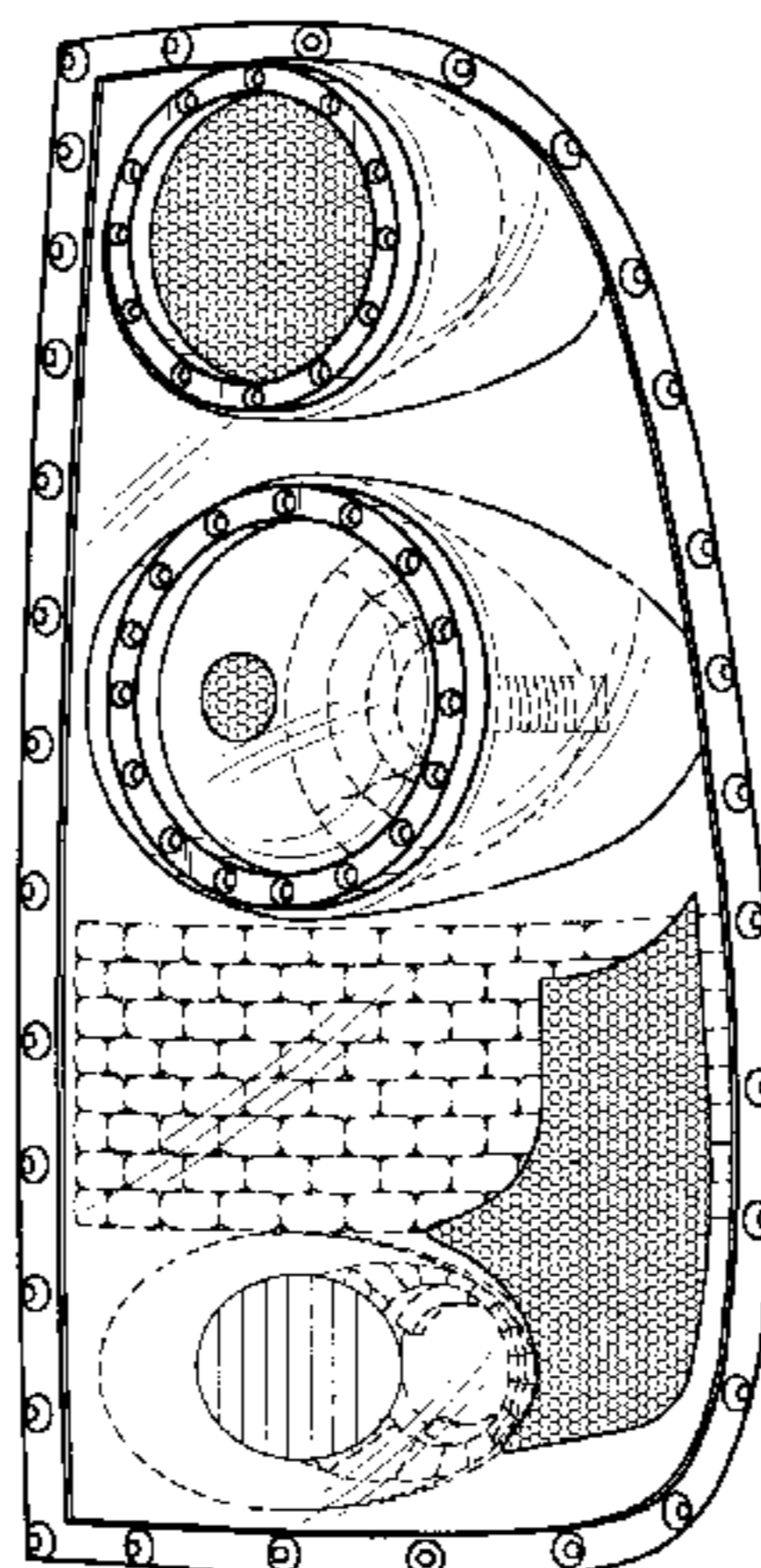
FIG. 10 is a top plan view of the tail lens assembly of FIG. 2;

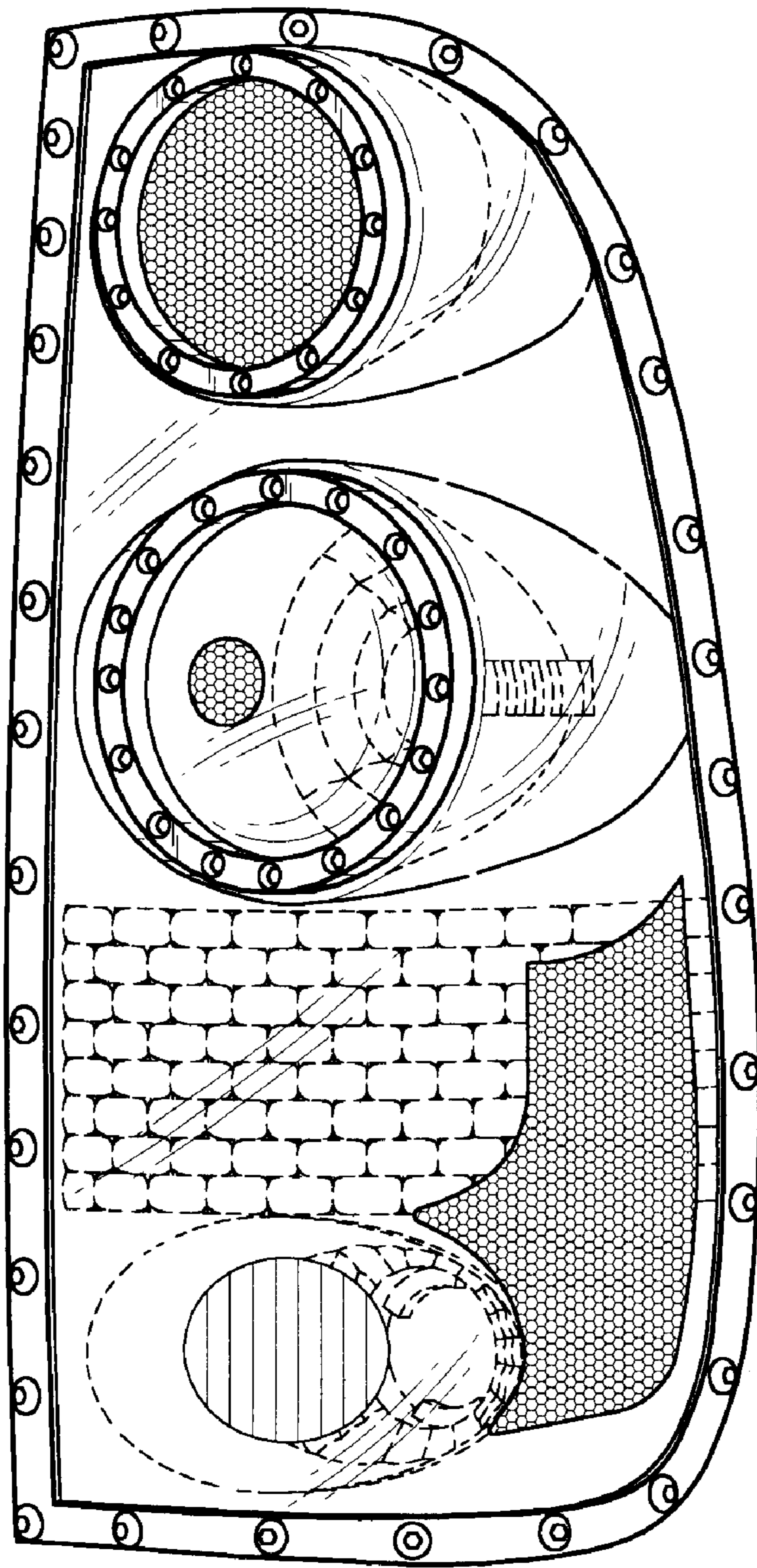

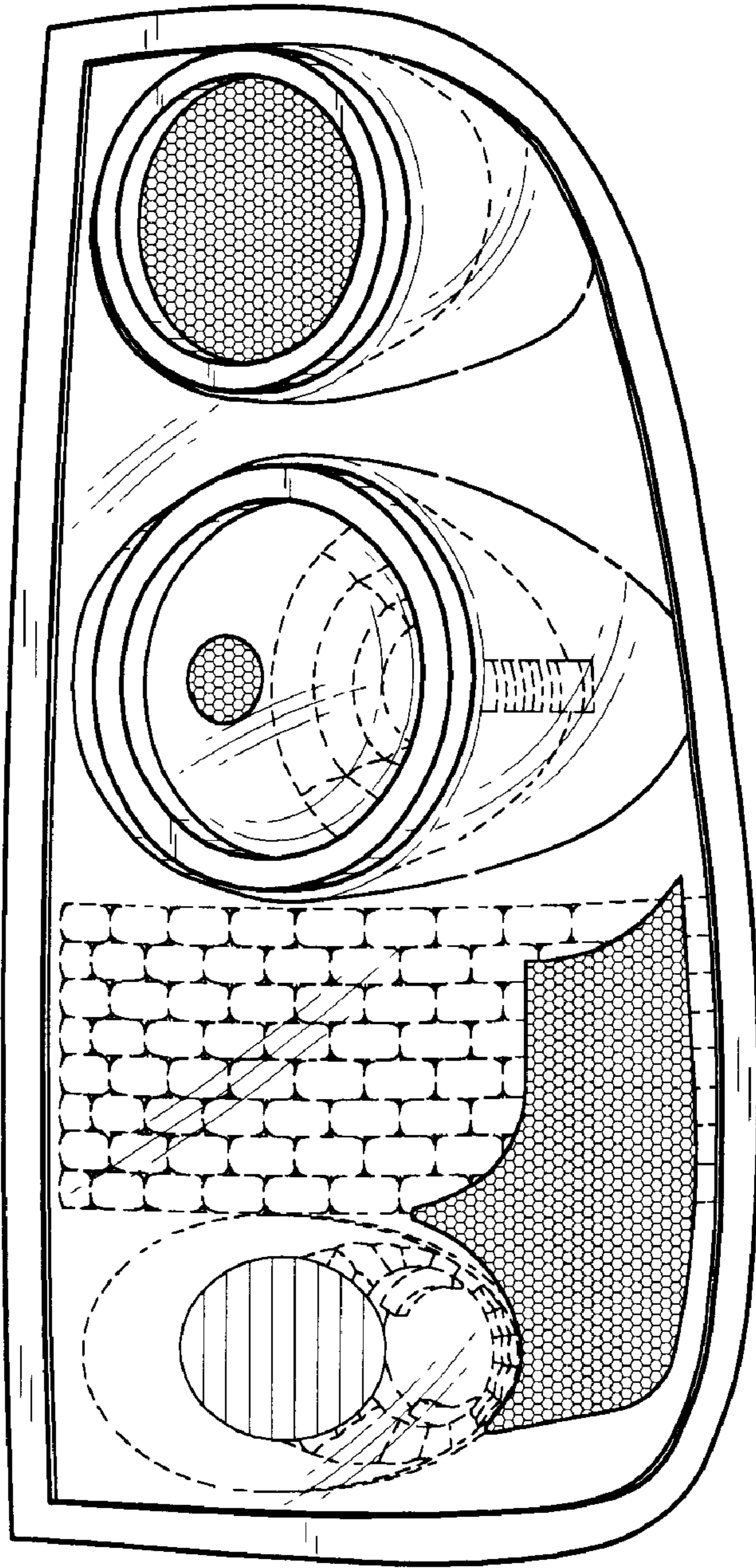

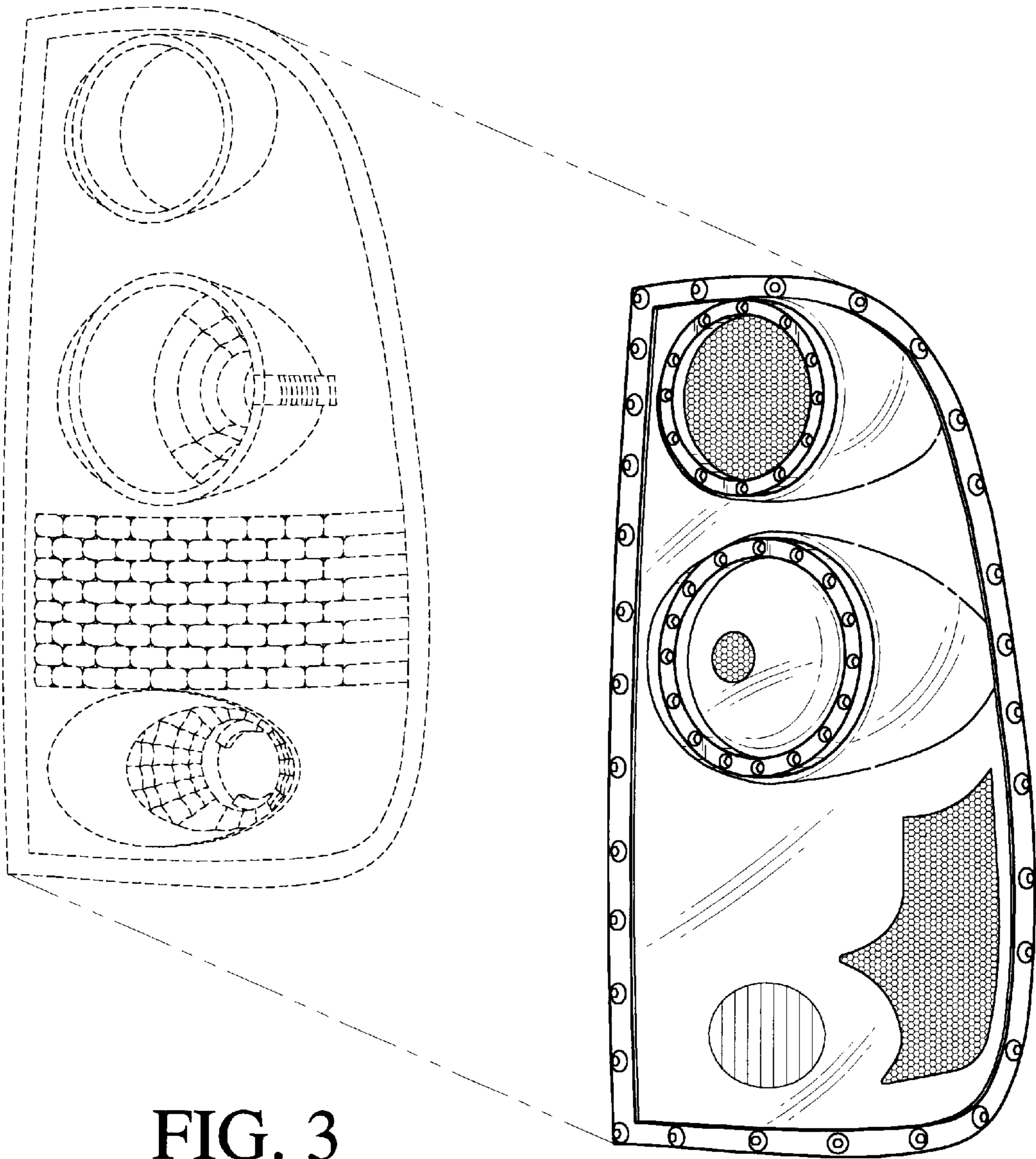

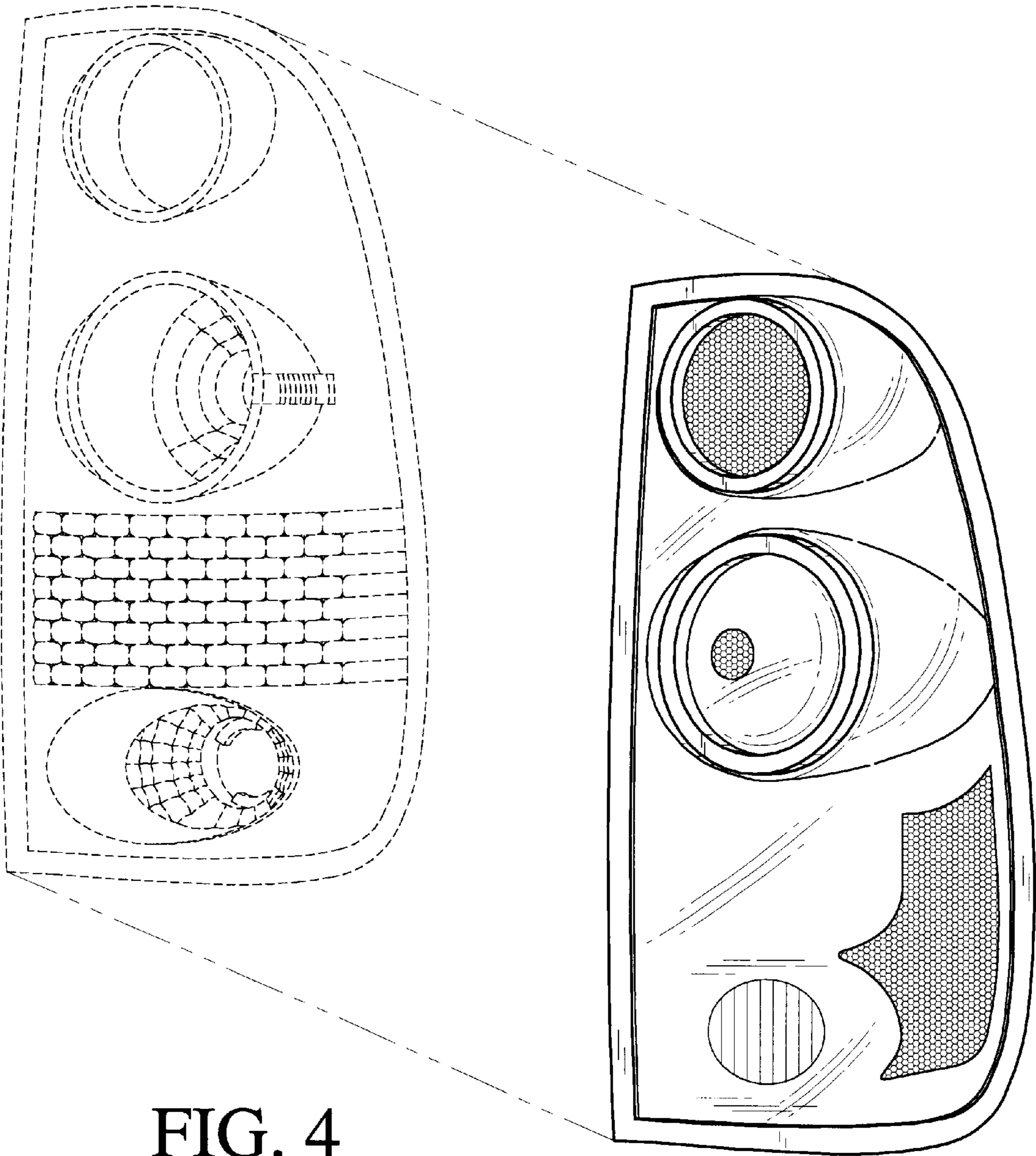

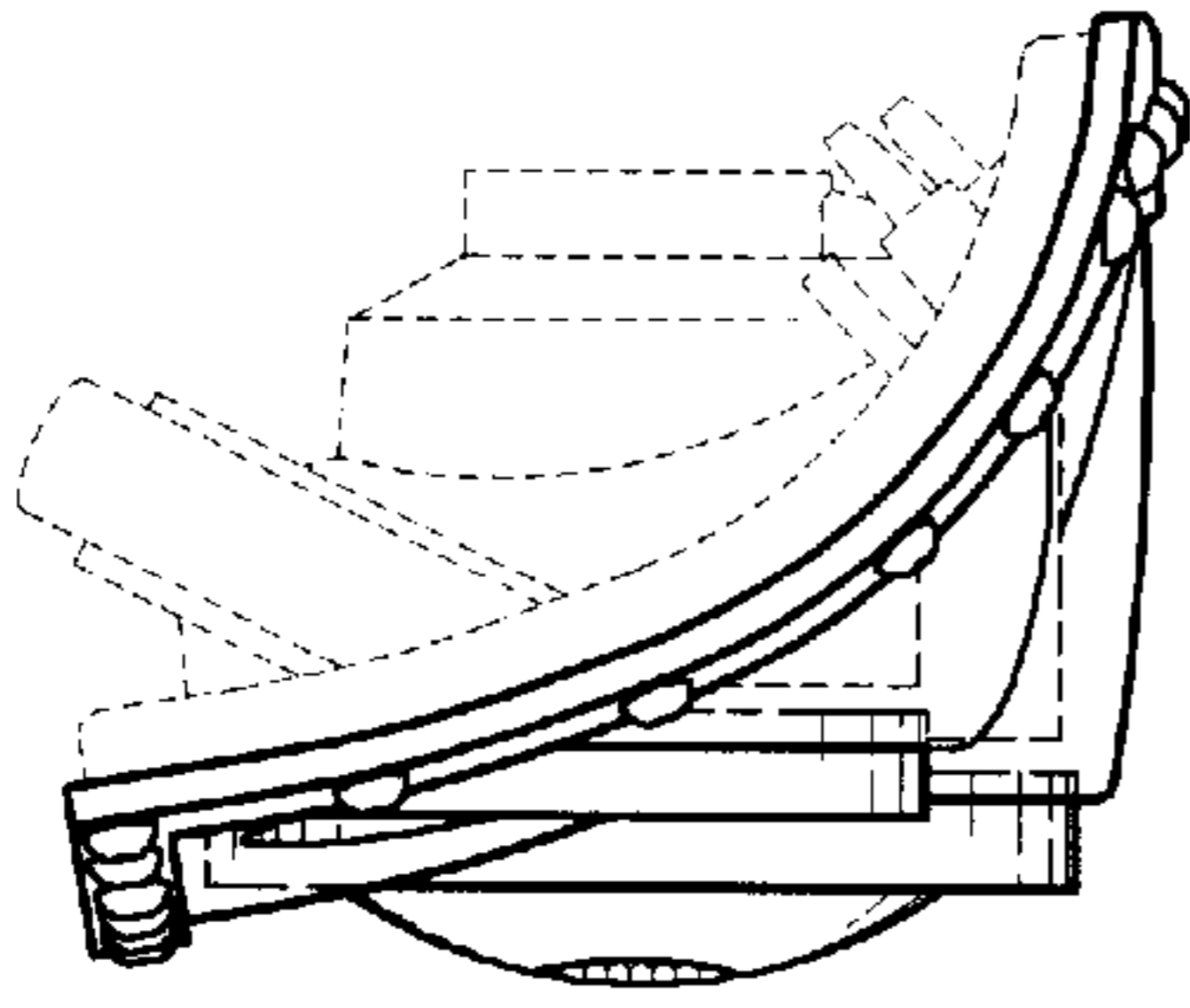

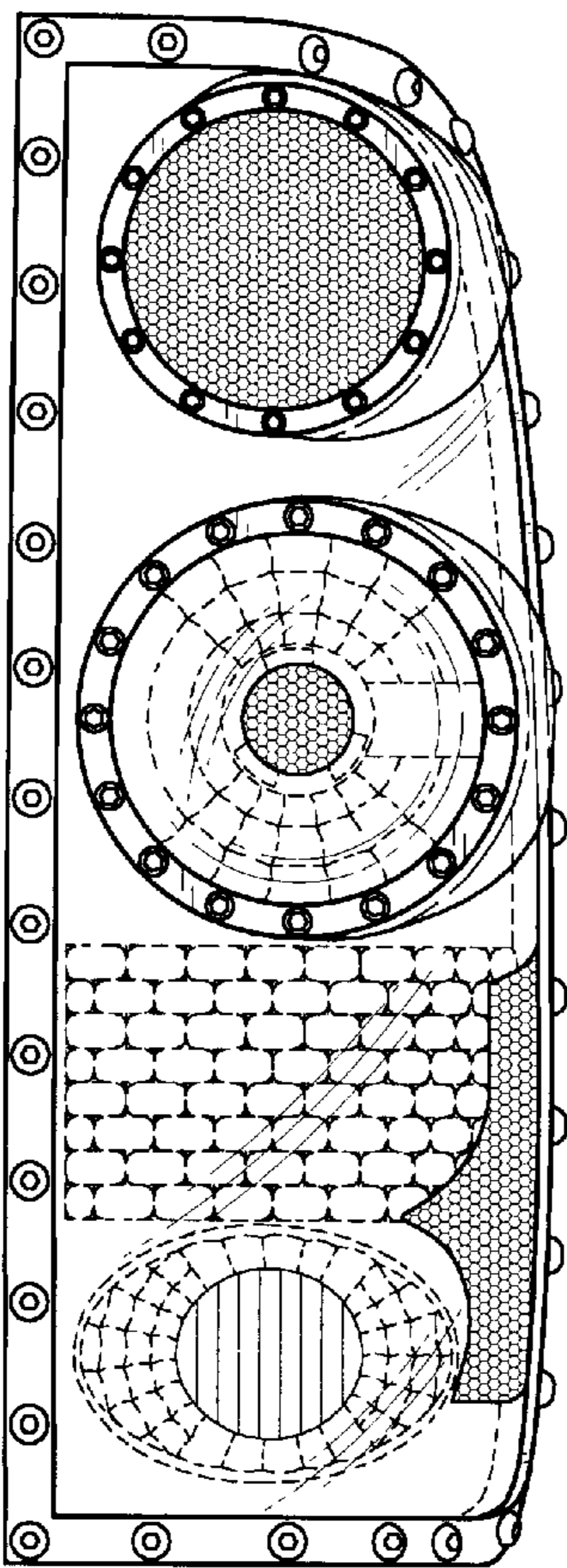

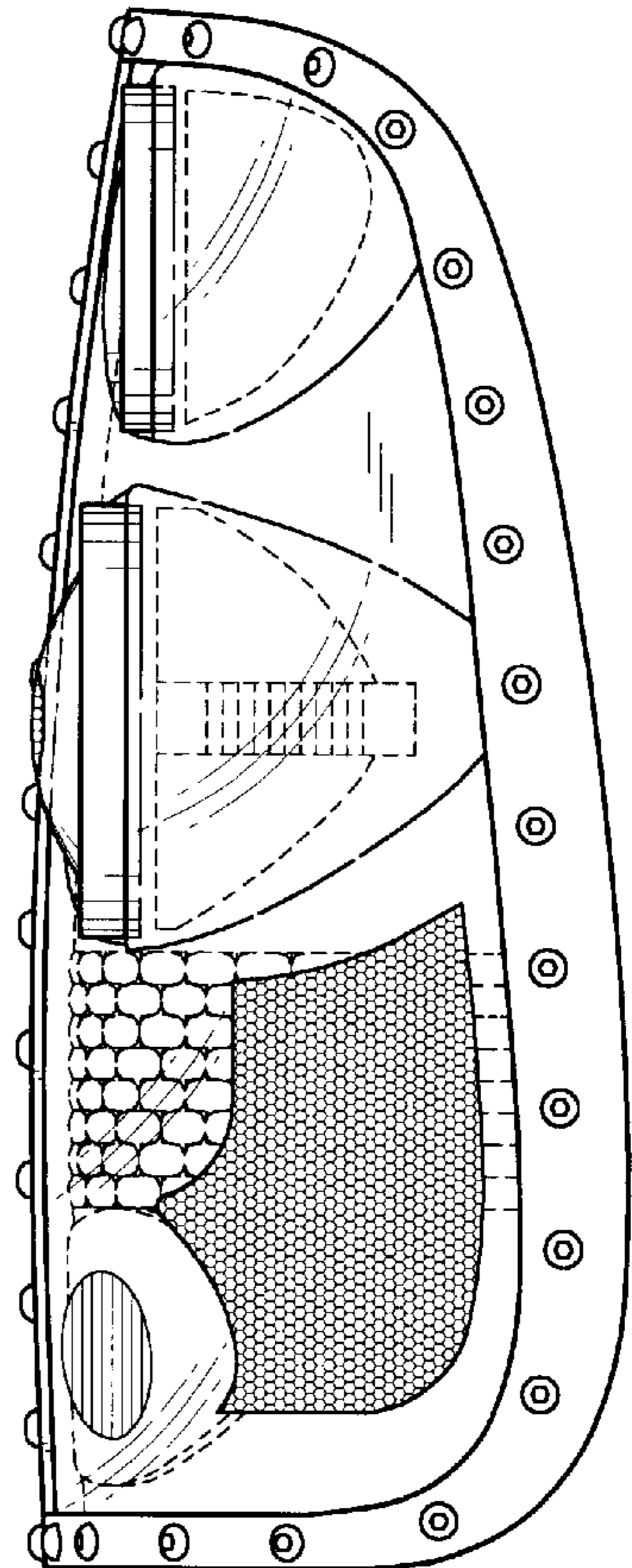

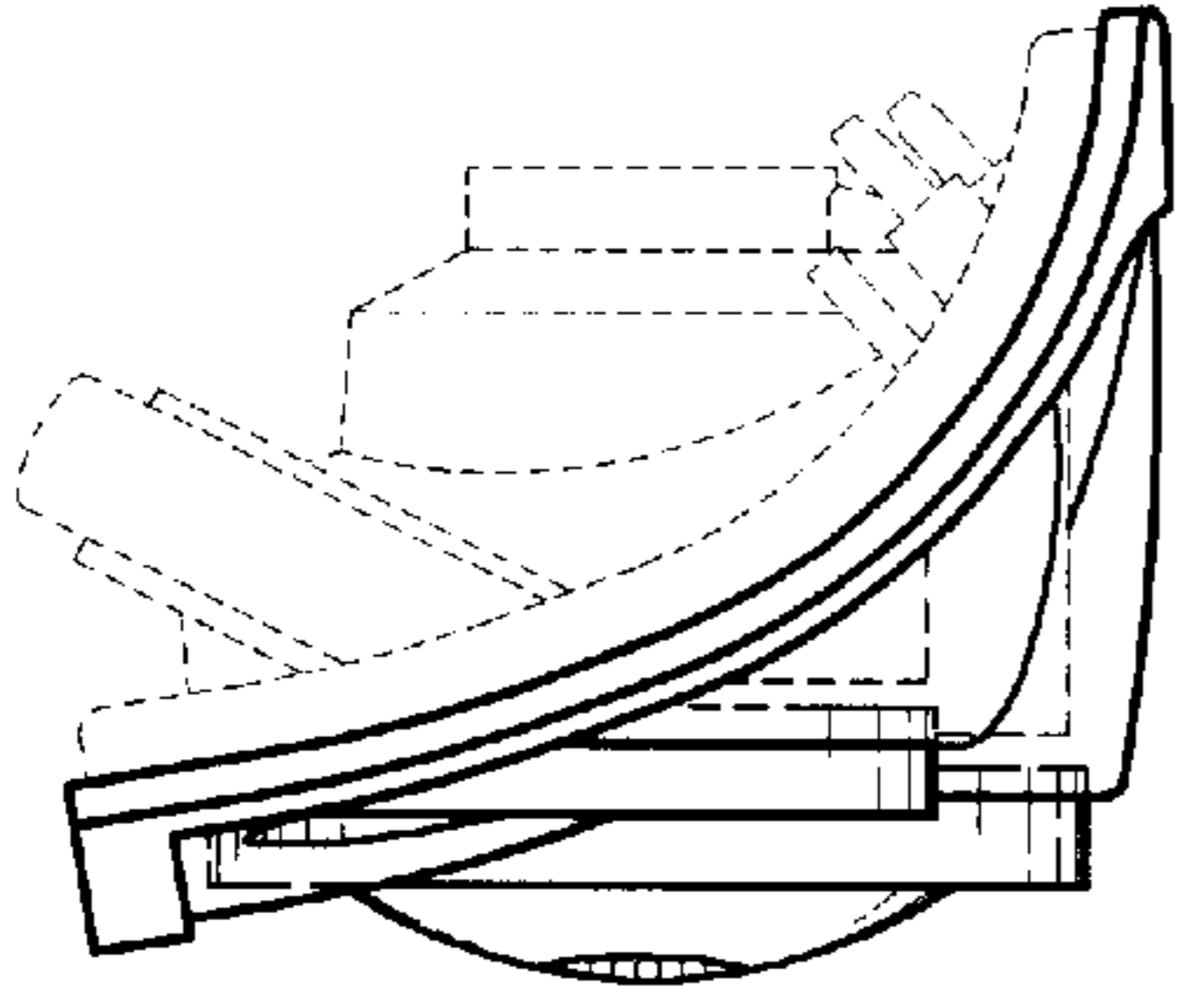

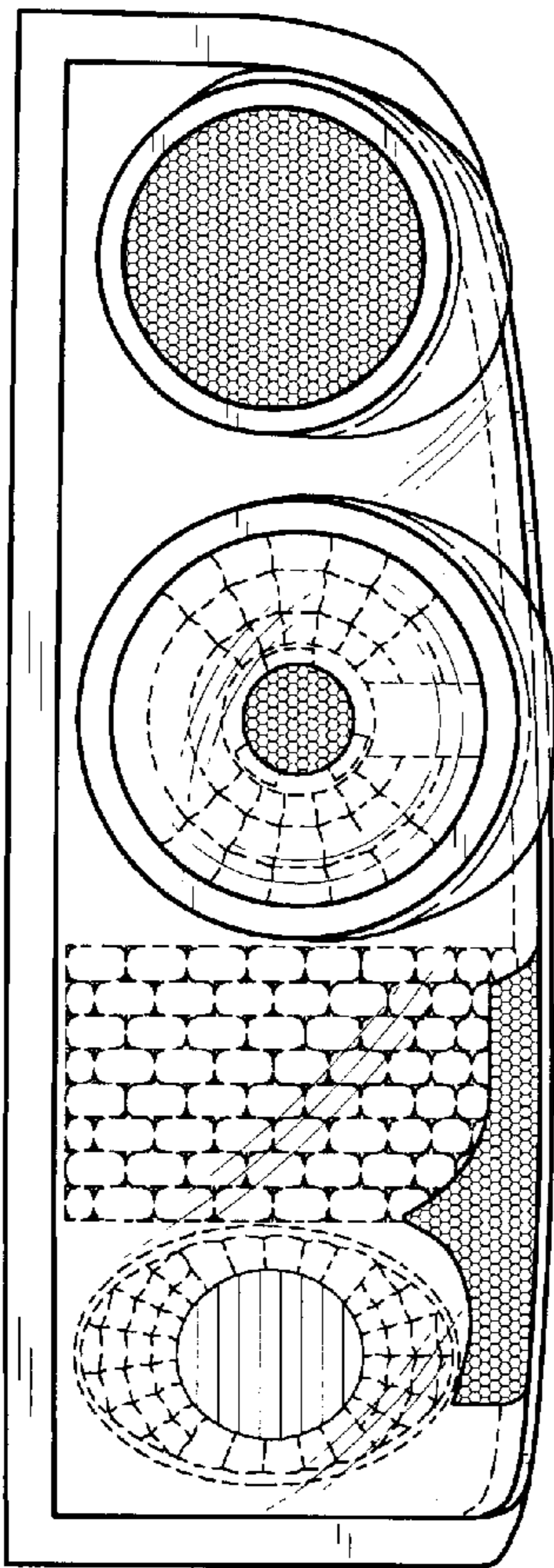

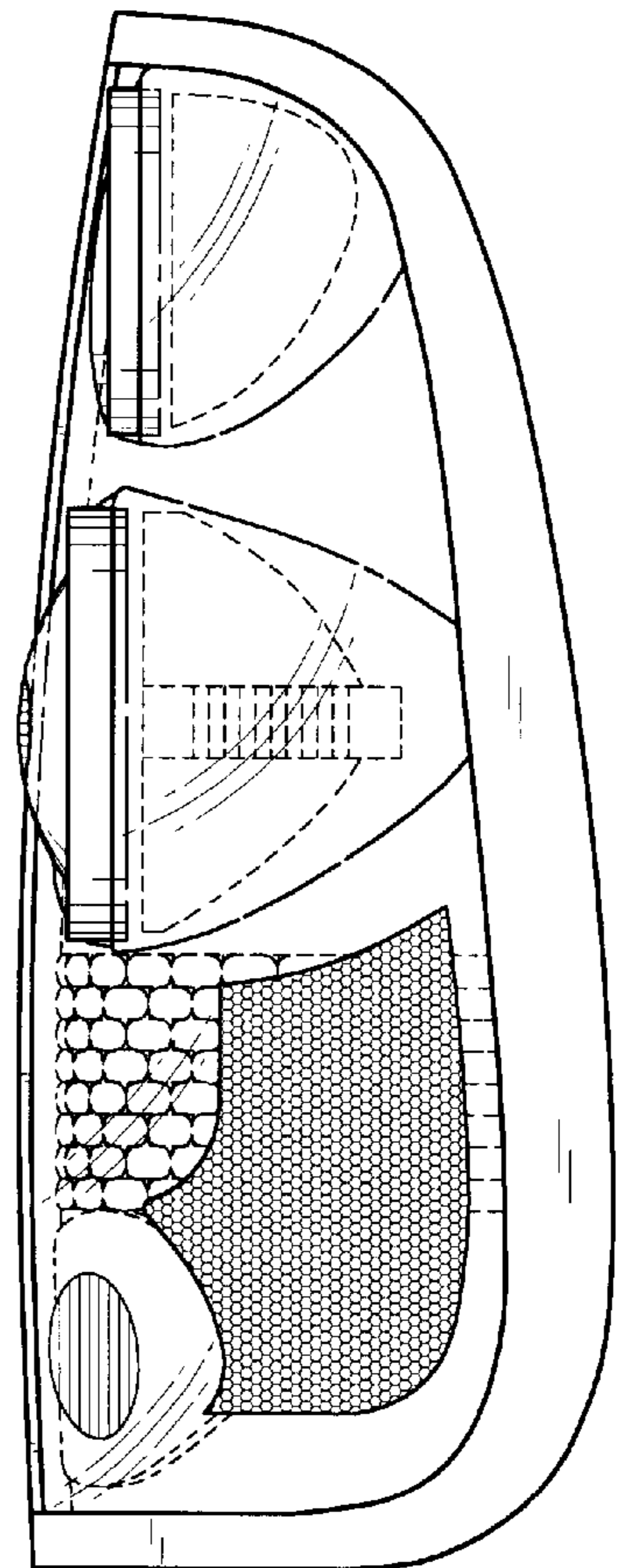

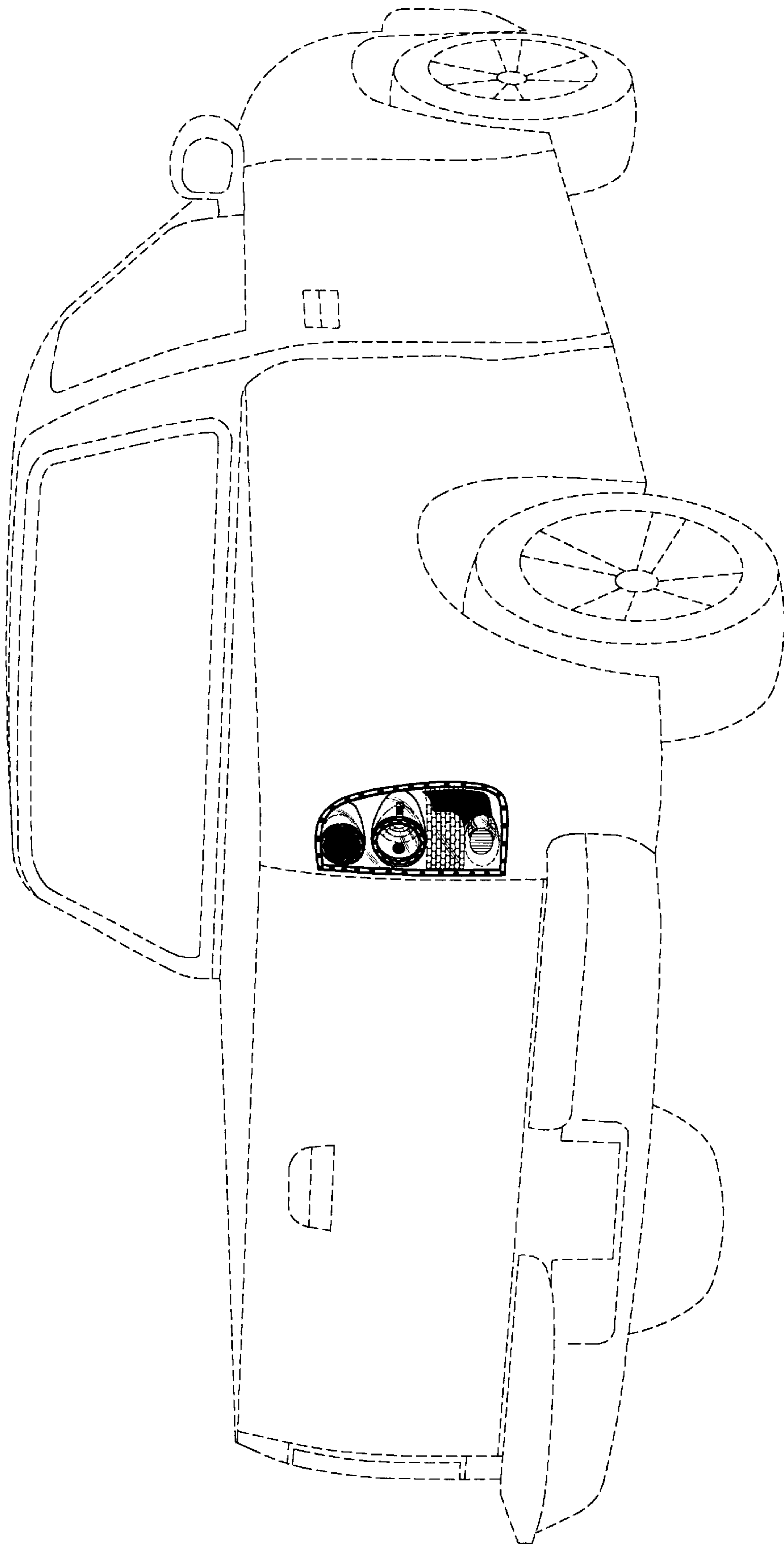

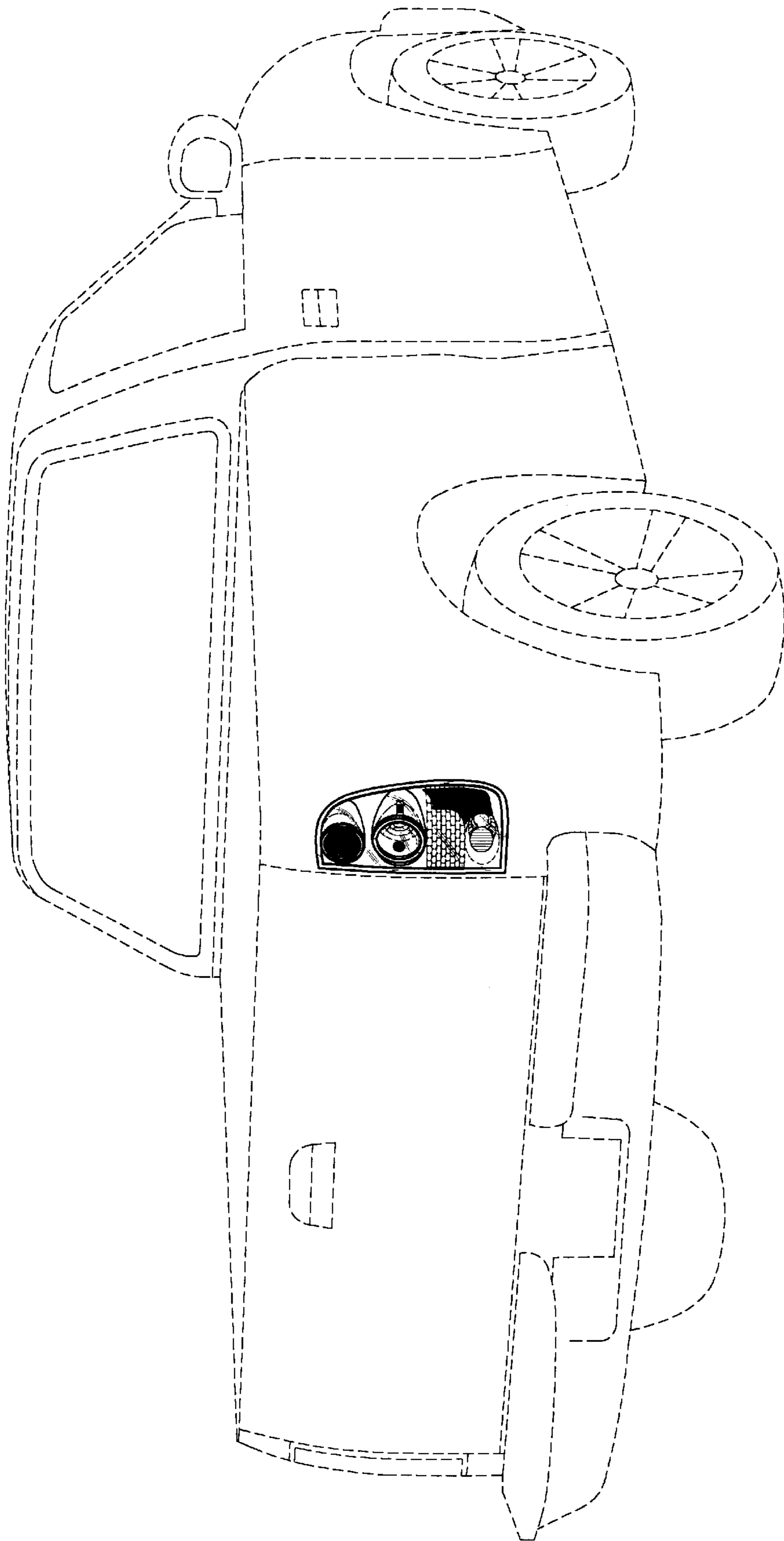
