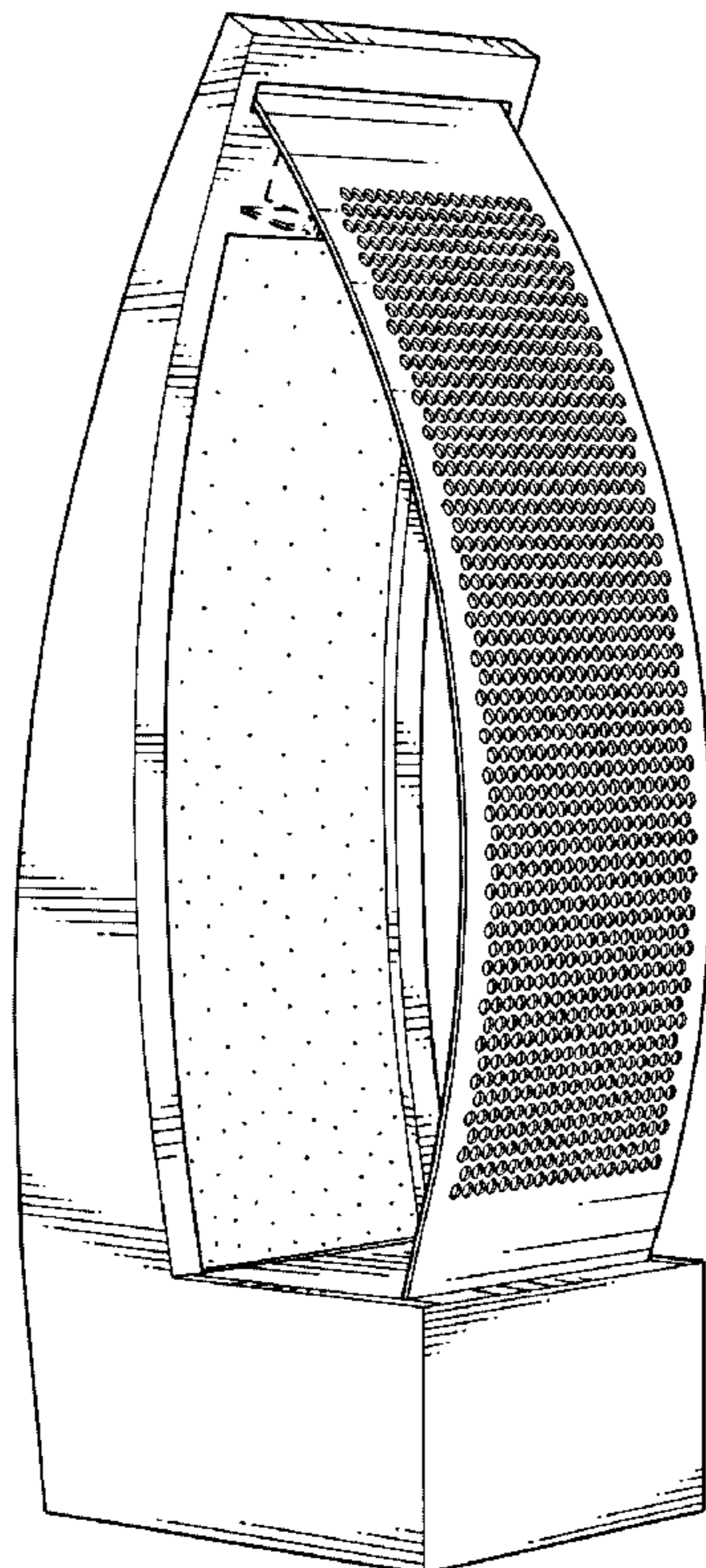

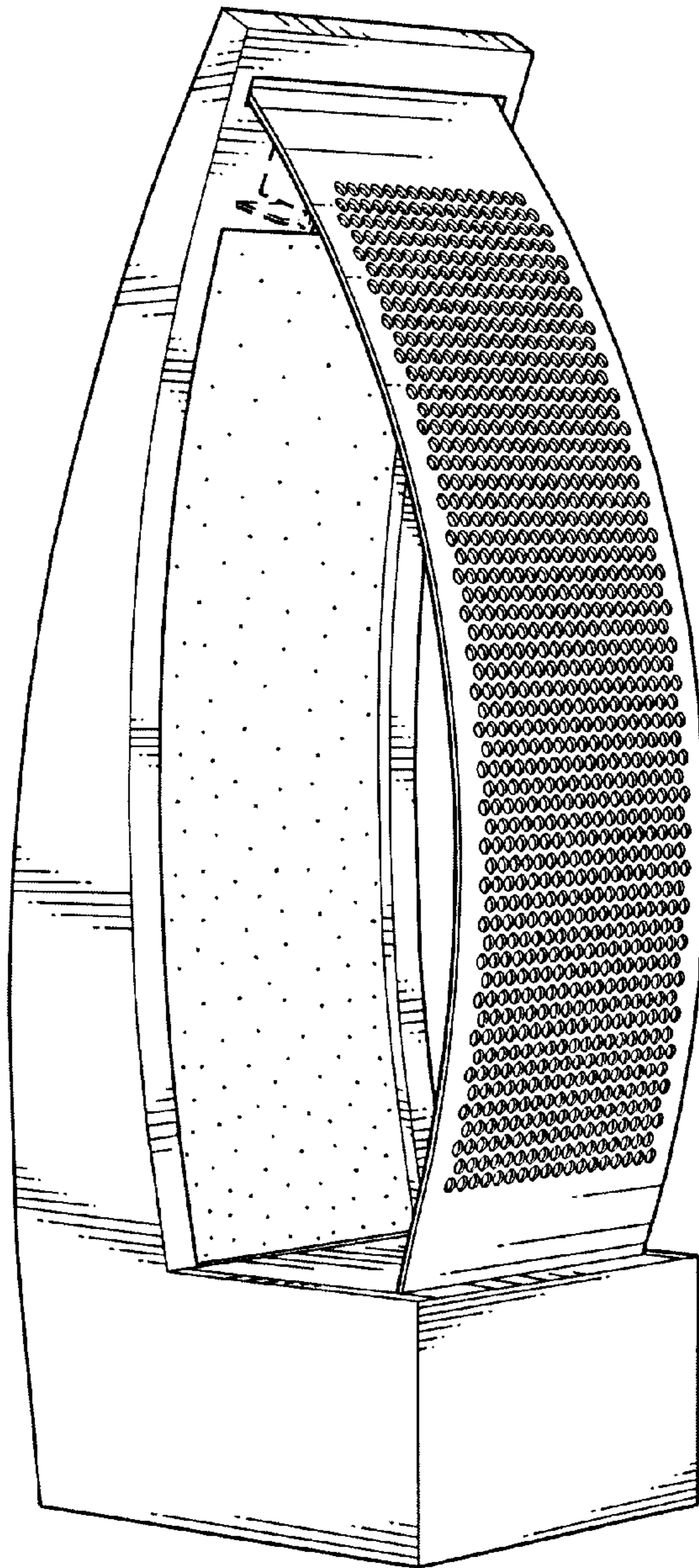

FIG. 6 is a top view thereof.

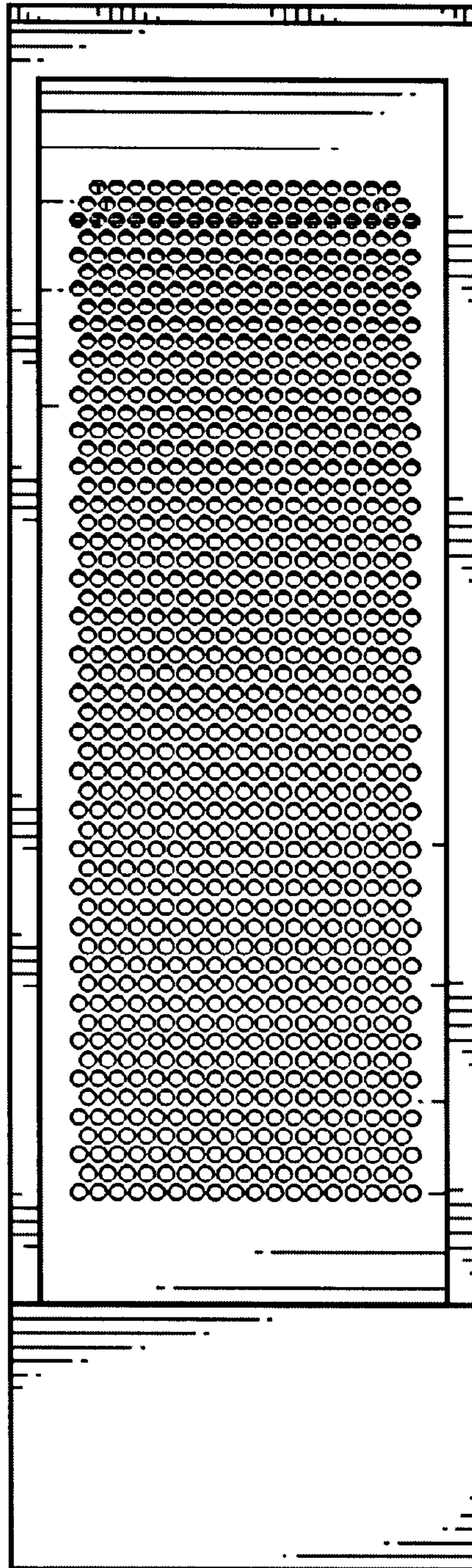
The broken lines are for illustrative purposes only and do not form any part of the claimed design. The unshown bottom of the housing also forms no part of the claimed design.

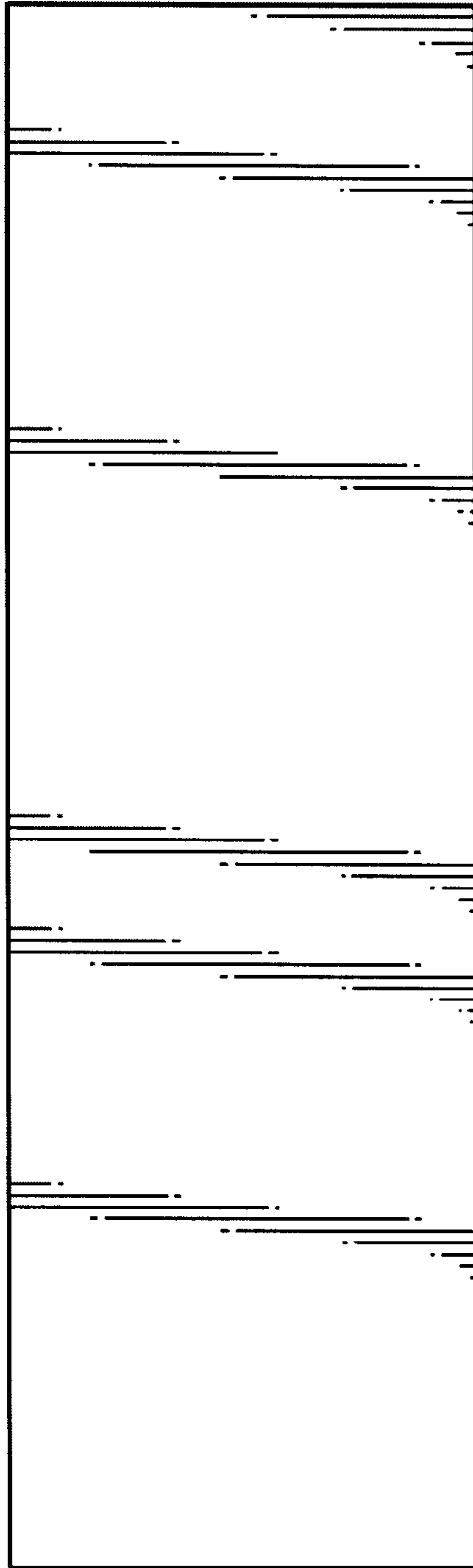




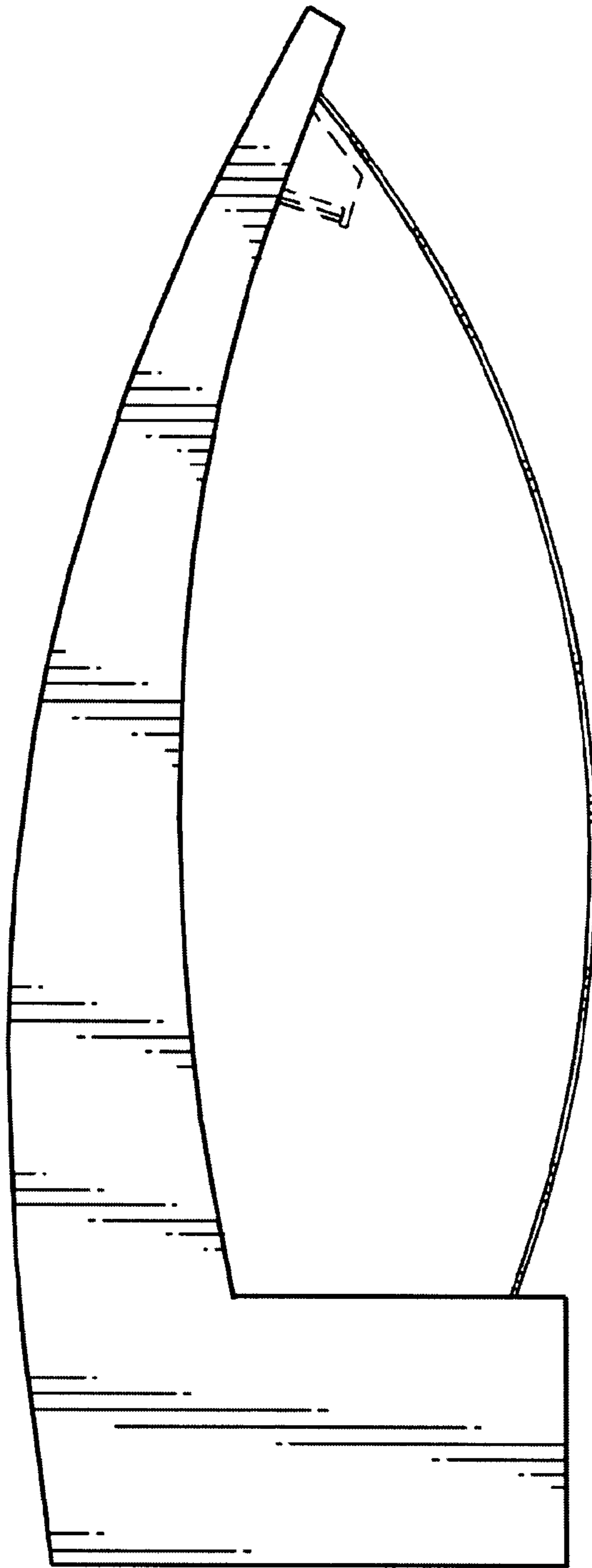

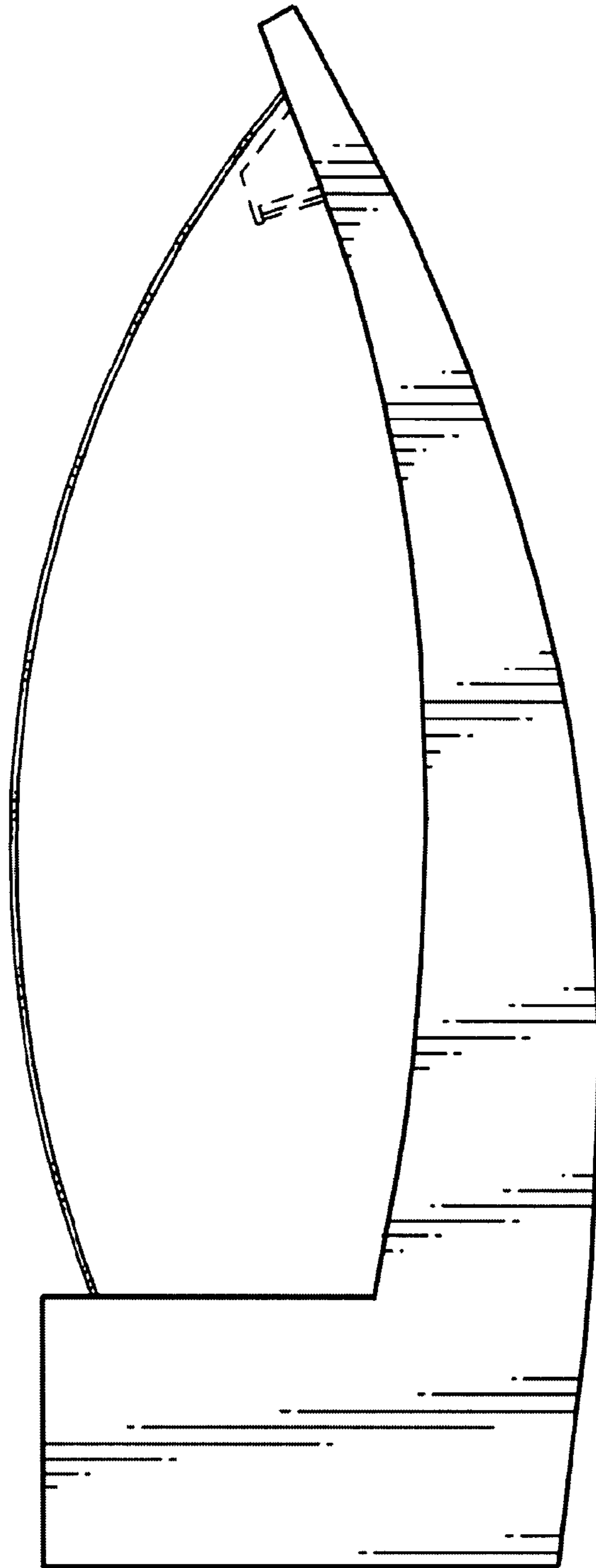

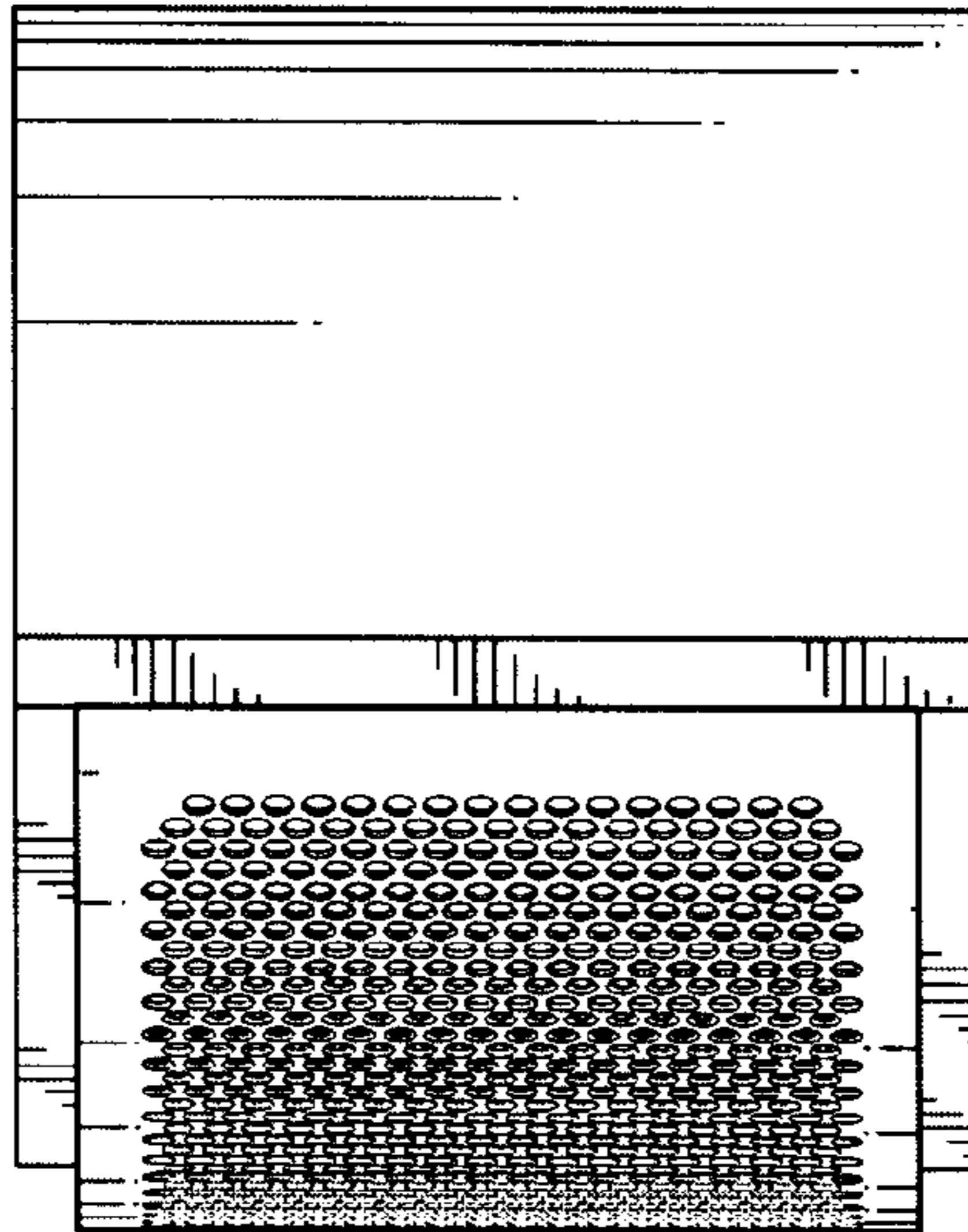
