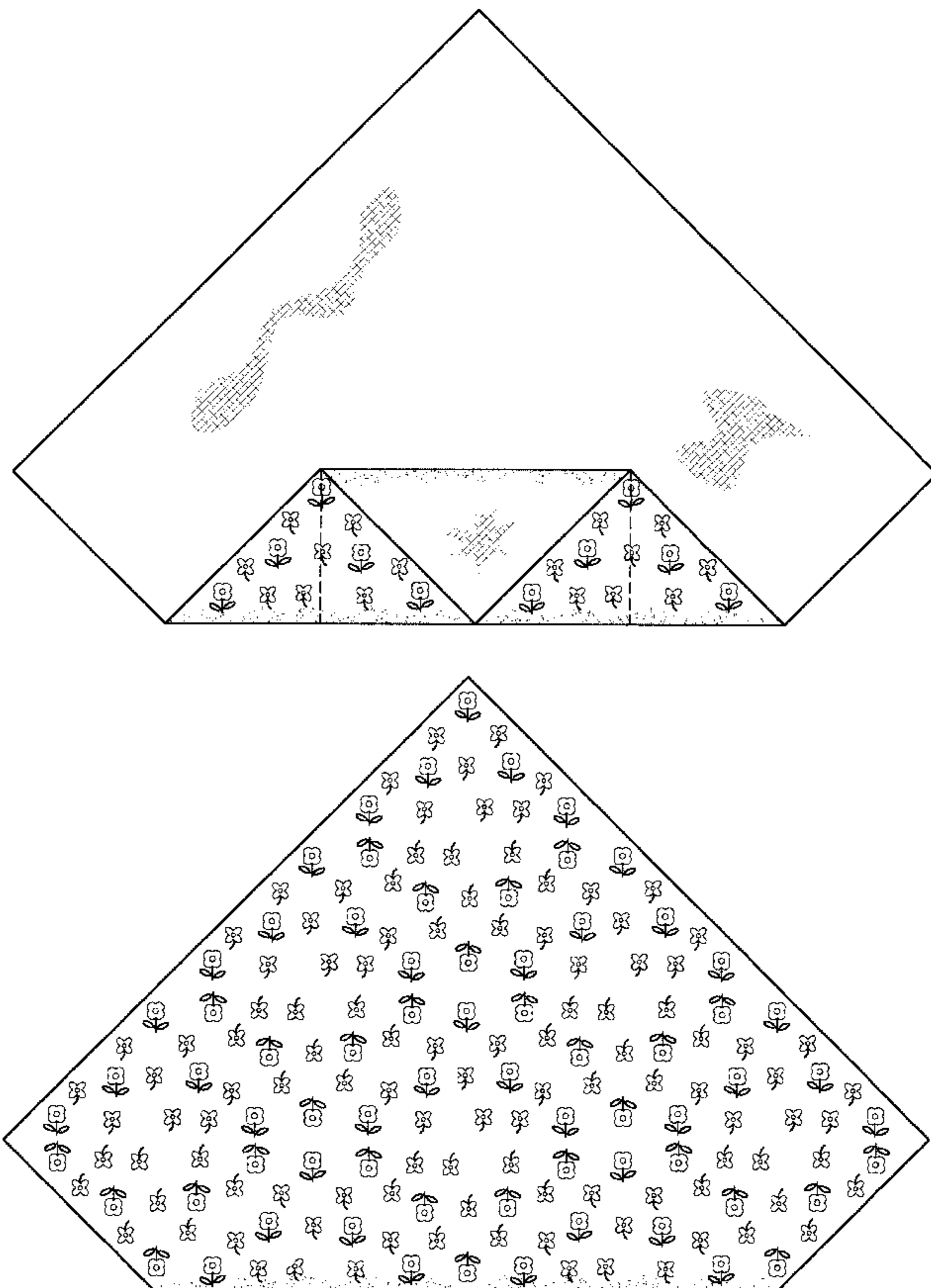
(57) **CLAIM**

The ornamental design for a infant bunting, as shown and described.

DESCRIPTION

FIG. 1 is a front elevational view of a infant bunting showing my new design;
FIG. 2 is a rear elevational view thereof;
FIG. 3 is a side view, taken from the left side of FIG. 1, the right side view being a mirror image thereof;
FIG. 4 is a top plan view thereof; and,
FIG. 5 is a bottom plan view thereof.
The broken lines shown in FIG. 1 are understood to represent stitching.

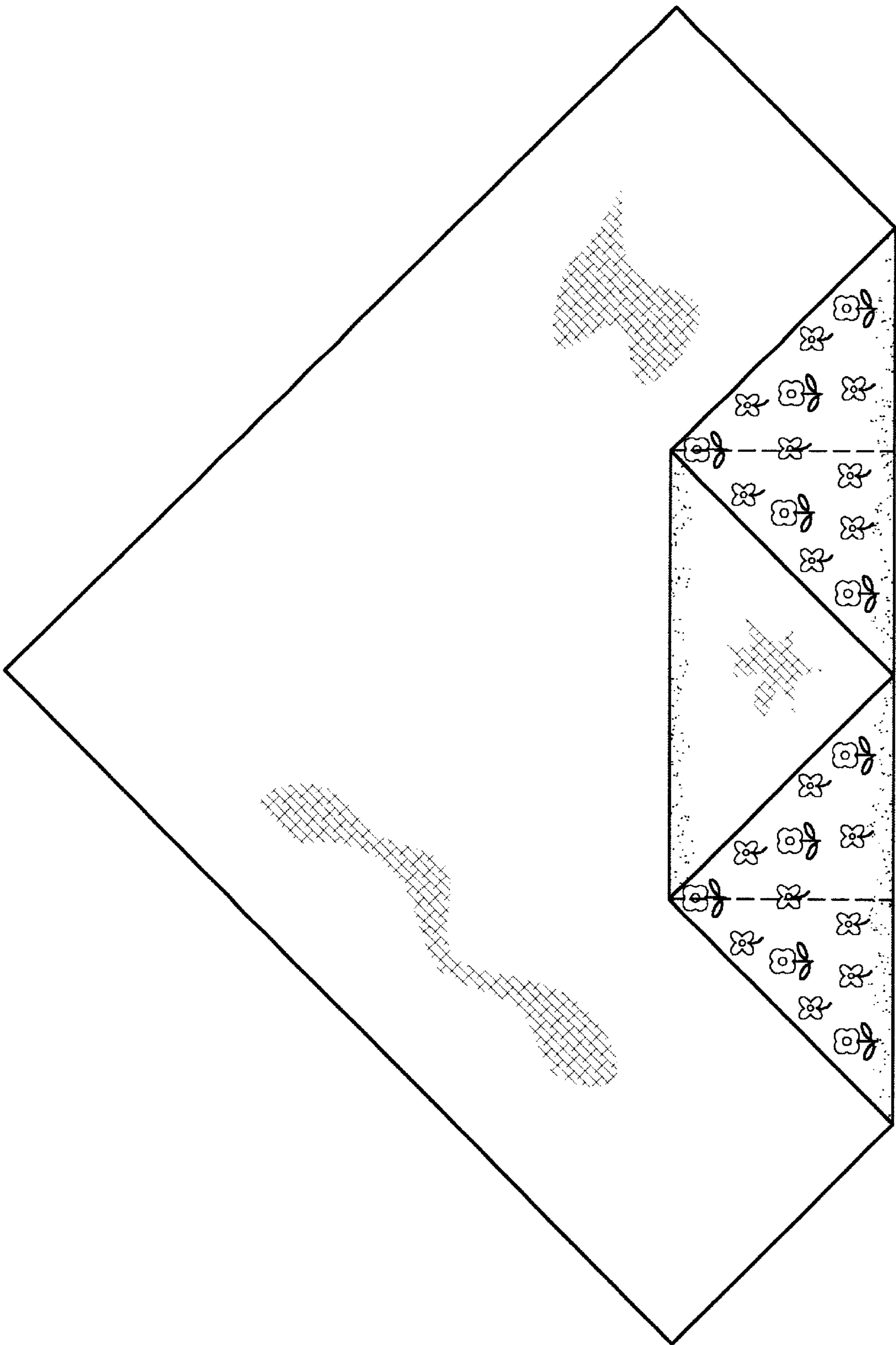

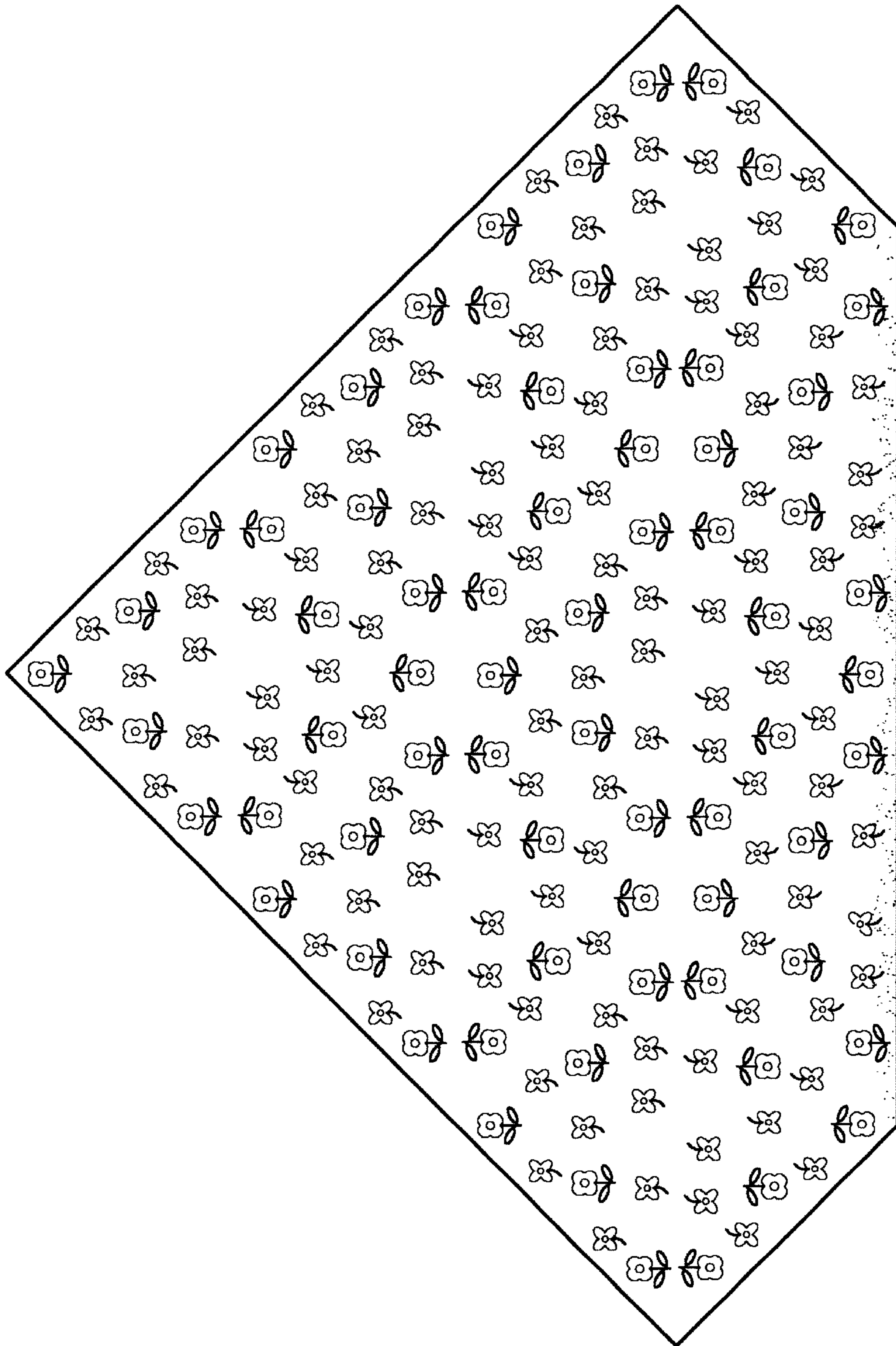

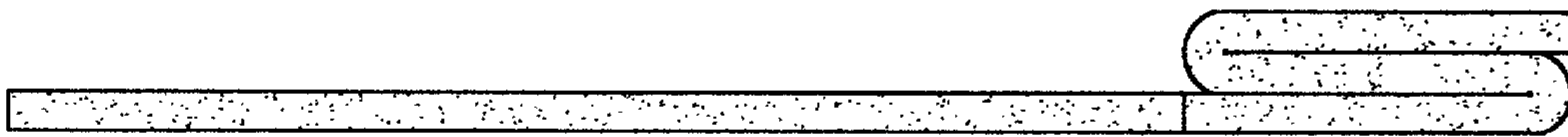
