DESCRIPTION

FIG. 1 is a first perspective view of a portion of a shoe showing my new design; FIG. 2 is a second perspective view thereof; and, FIG. 3 is a side view thereof.

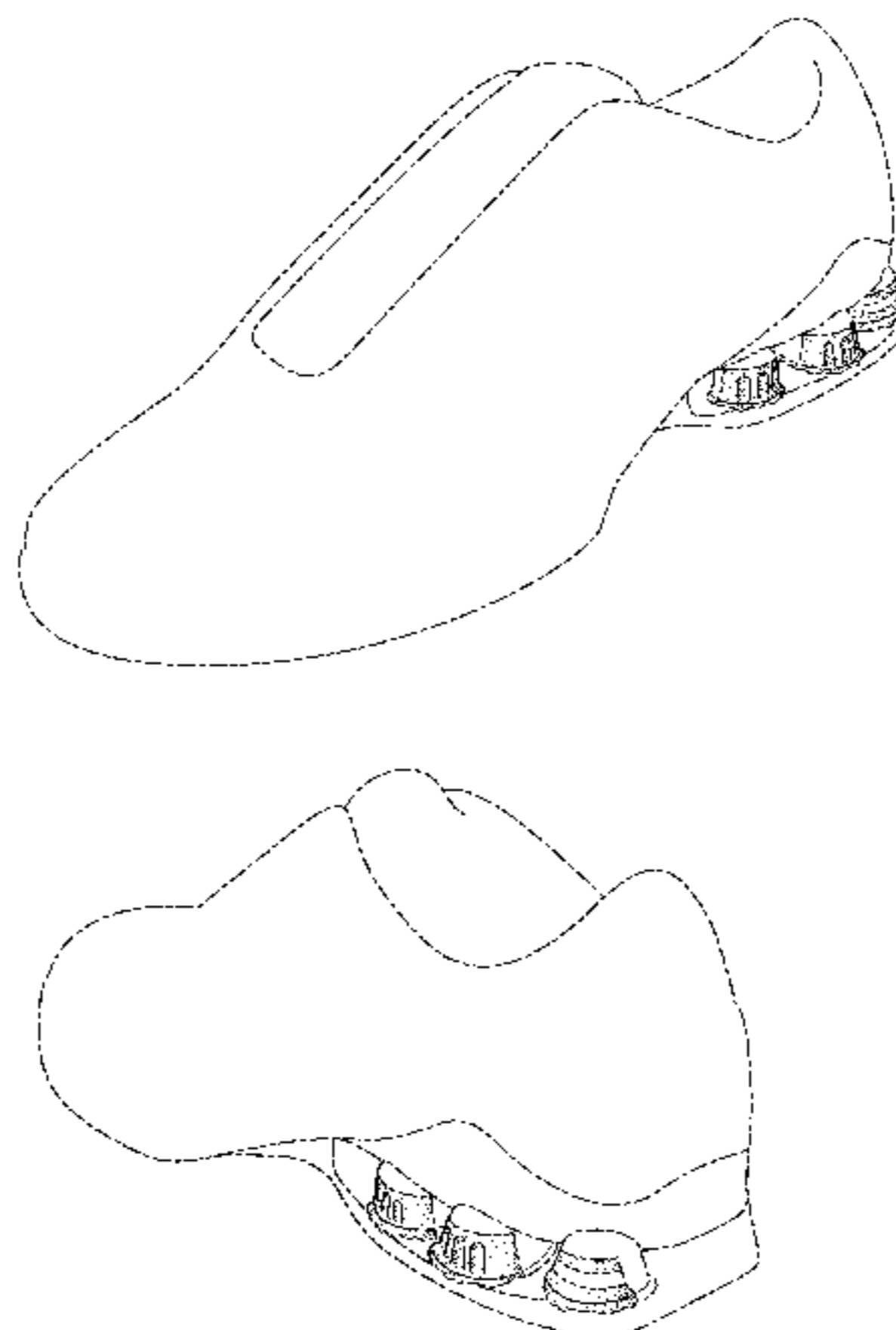

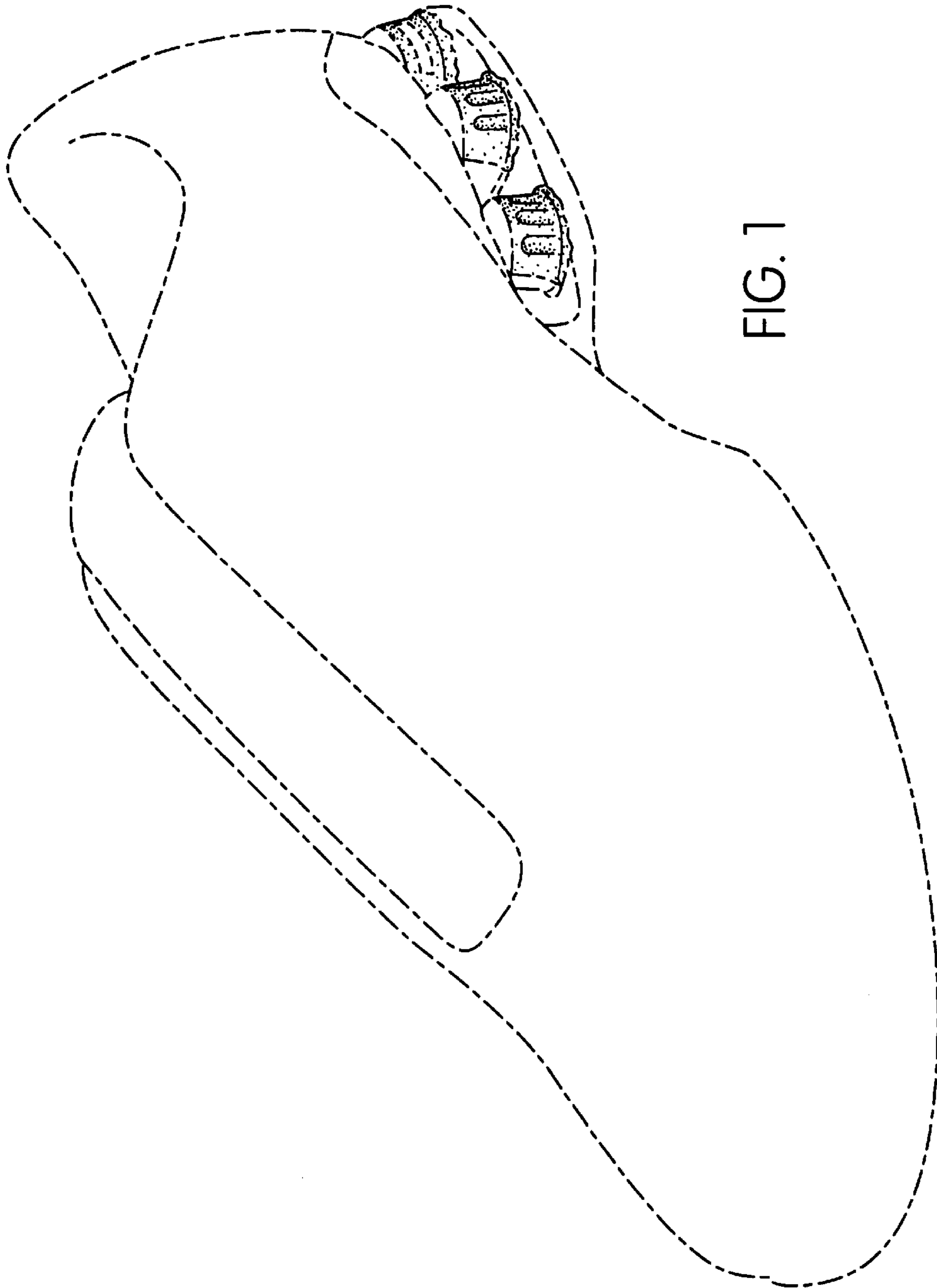

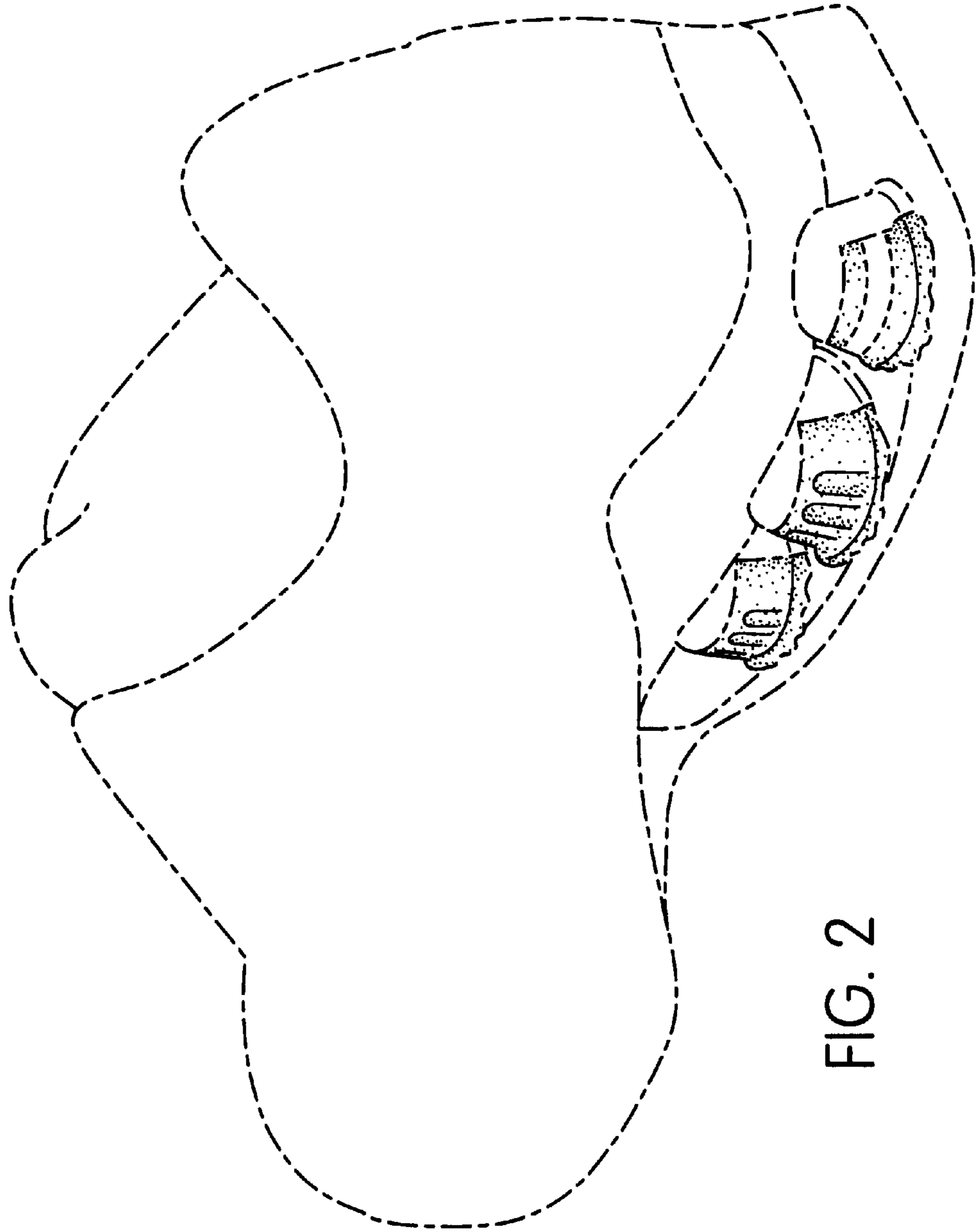

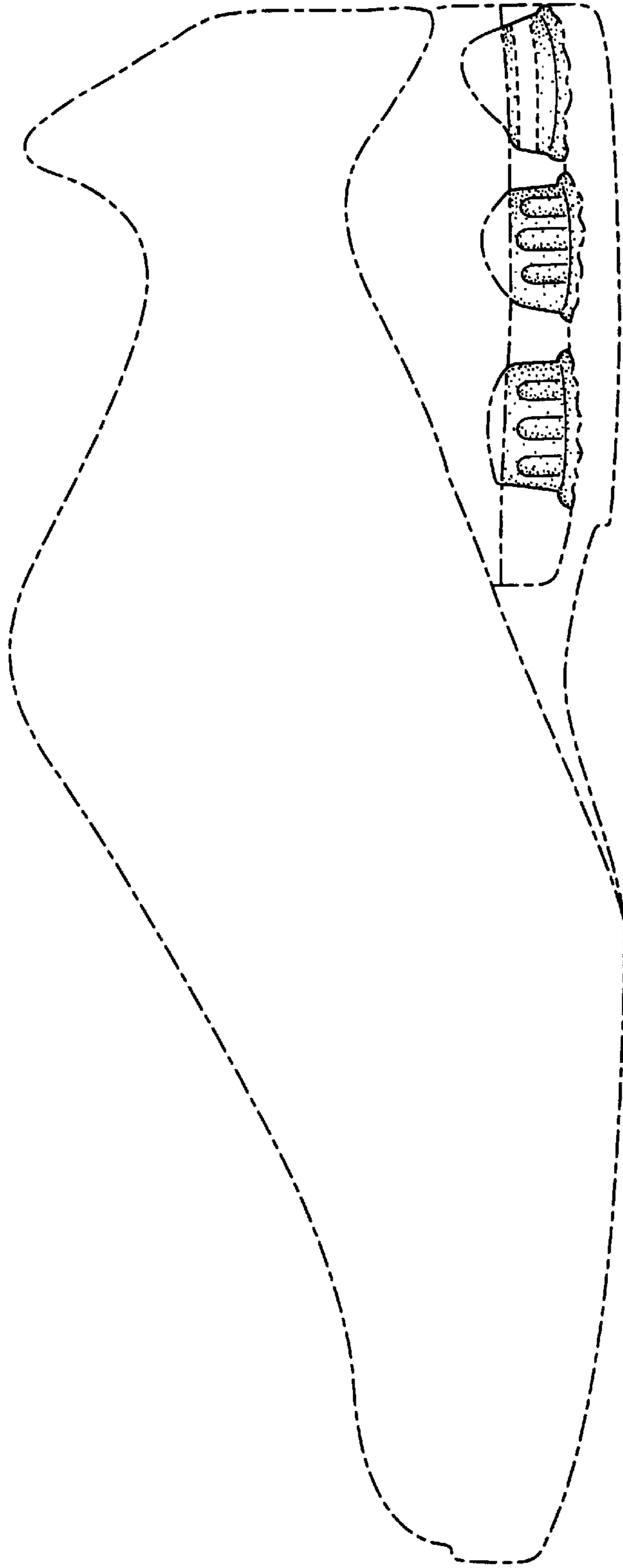
