I claim the ornamental design for a footwear upper portion, as shown and described.

### DESCRIPTION

FIG. 1 is a perspective view of a footwear upper portion, seen from the rear and right side thereof, showing my new design;

FIG. 2 is a side view thereof; and,

FIG. 3 is a perspective view thereof, seen from the front and right side thereof.

The broken line showing of the sole and other parts of the footwear upper is for illustrative purposes only and forms no part of the claimed design.

The double line detail is representative of either grooves or a surface pattern on the footwear upper portion of the invention.
