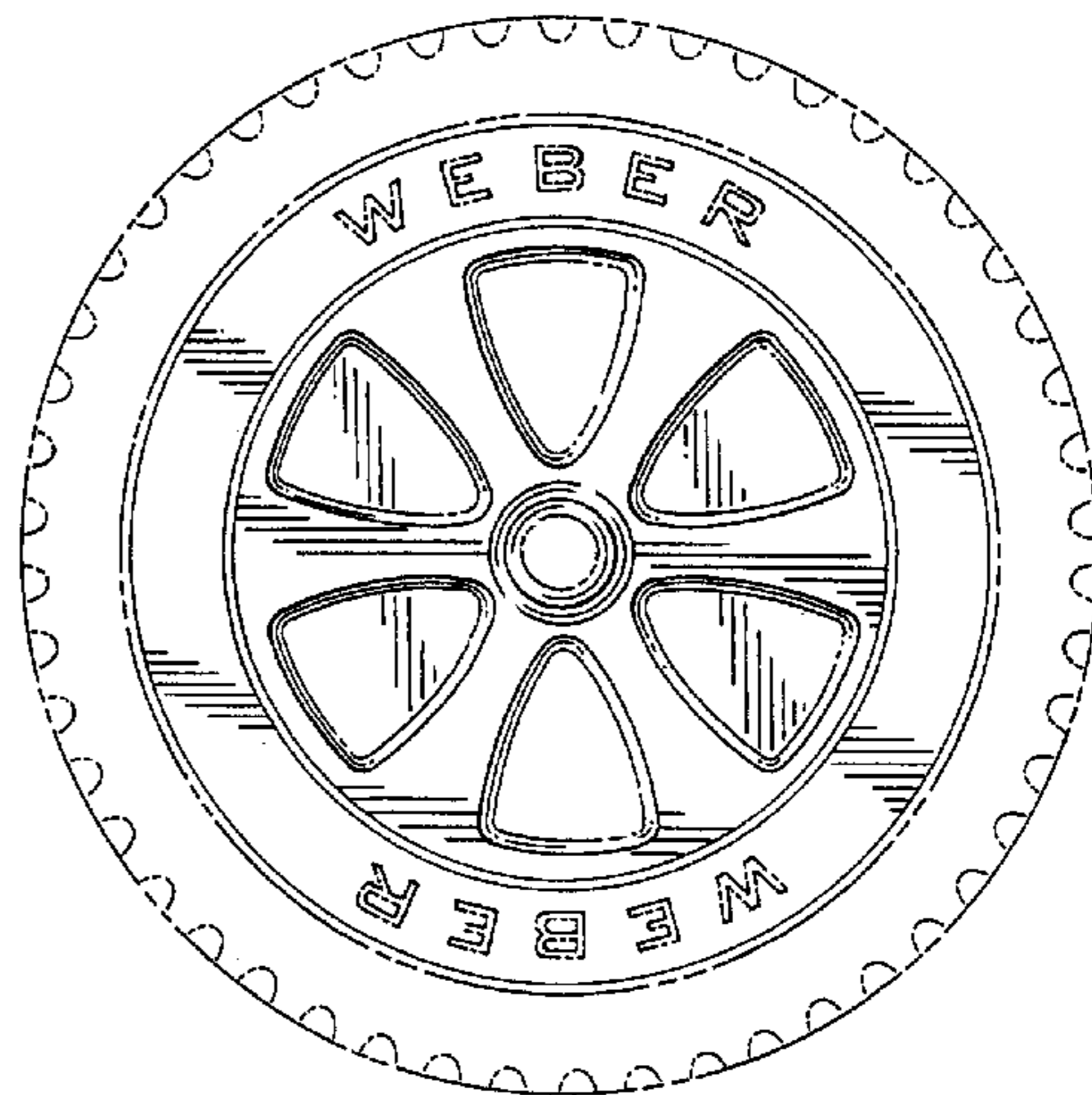
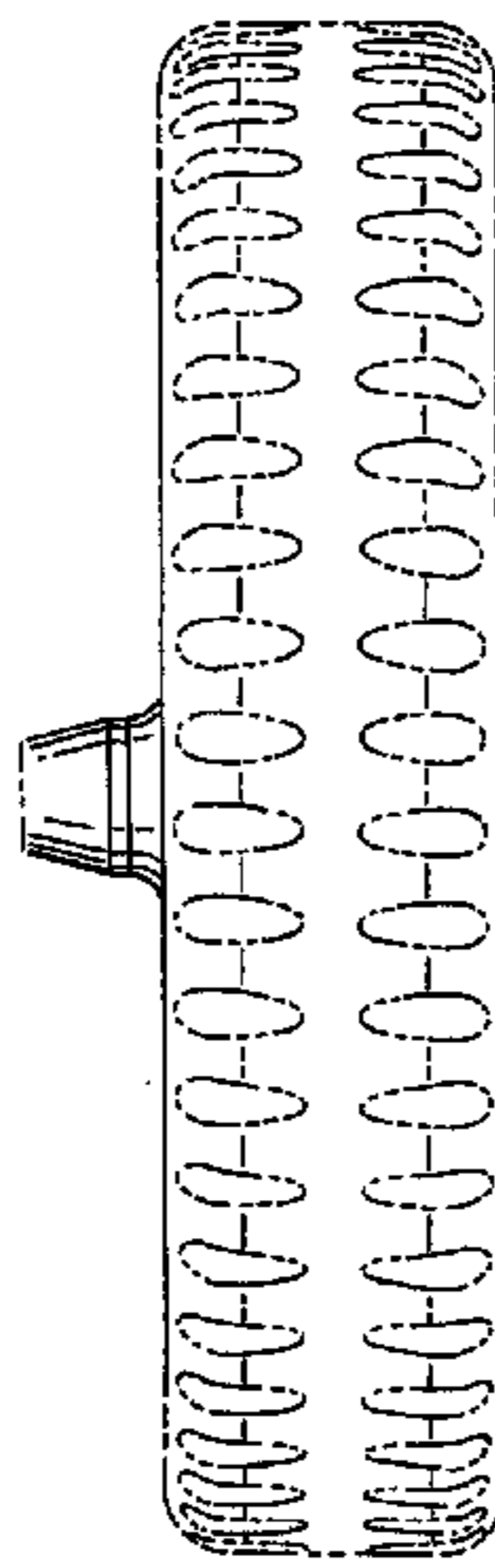
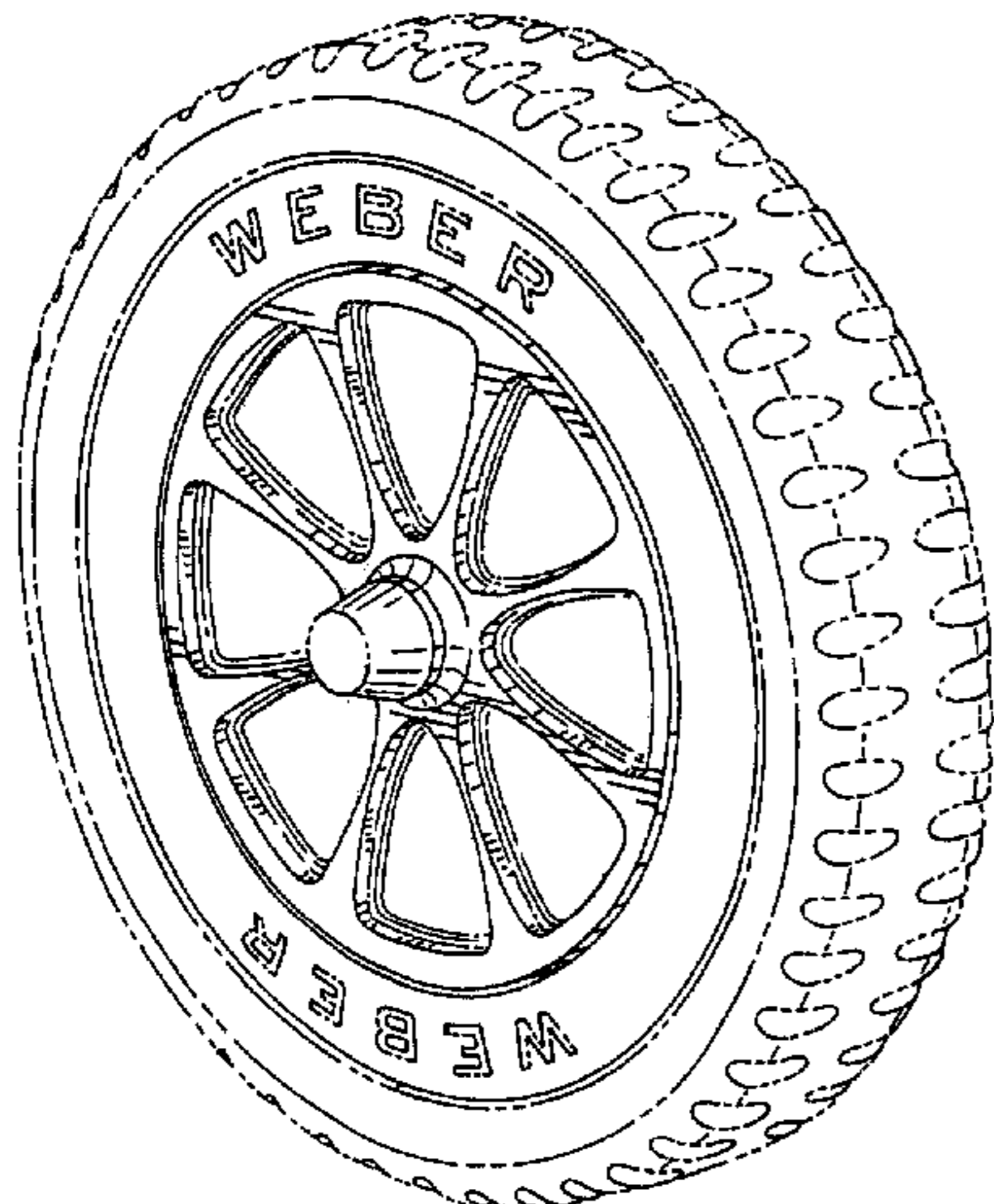
(57) **CLAIM**

We claim the ornamental Design for a wheel for outdoor cooking device, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a wheel for outdoor cooking device showing my new design;  
 FIG. 2 is a front view thereof;  
 FIG. 3 is a side view thereof; and,  
 FIG. 4 is a second embodiment thereof, the difference residing in the central portion.  
 The details shown in broken lines are for illustrative purposes only and form no part of the claimed design. The side view for the second embodiment is shown in FIG. 3.

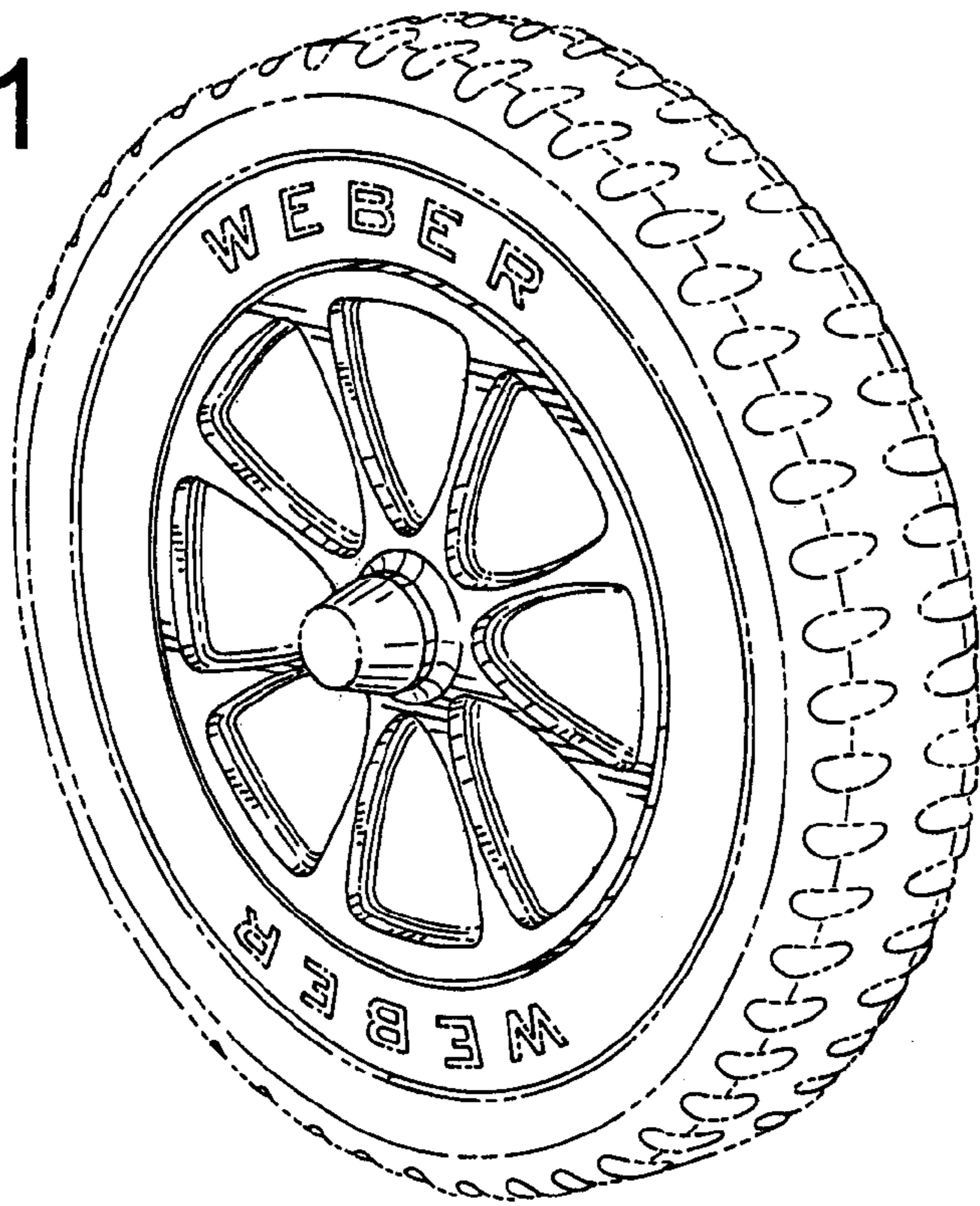

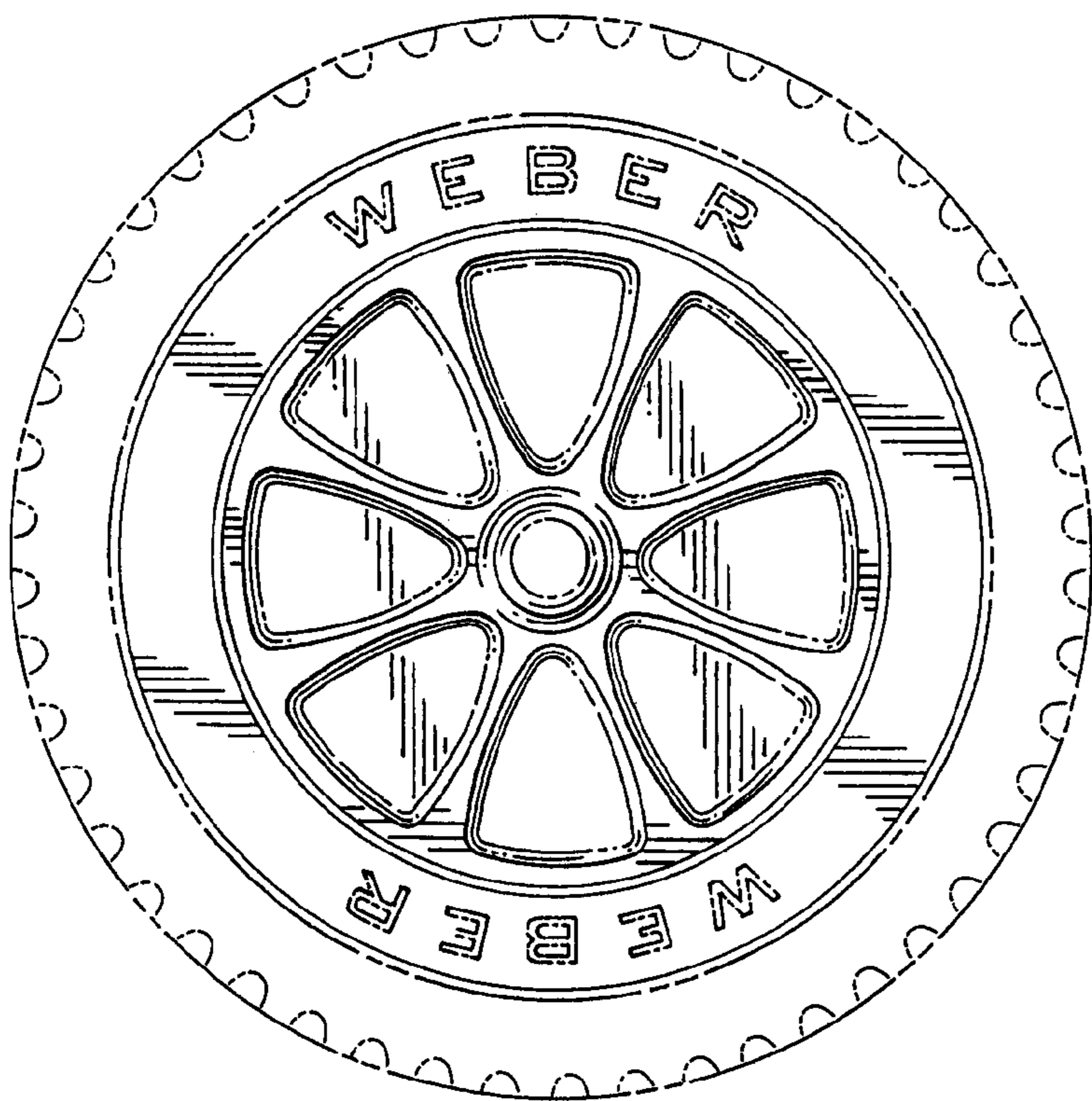

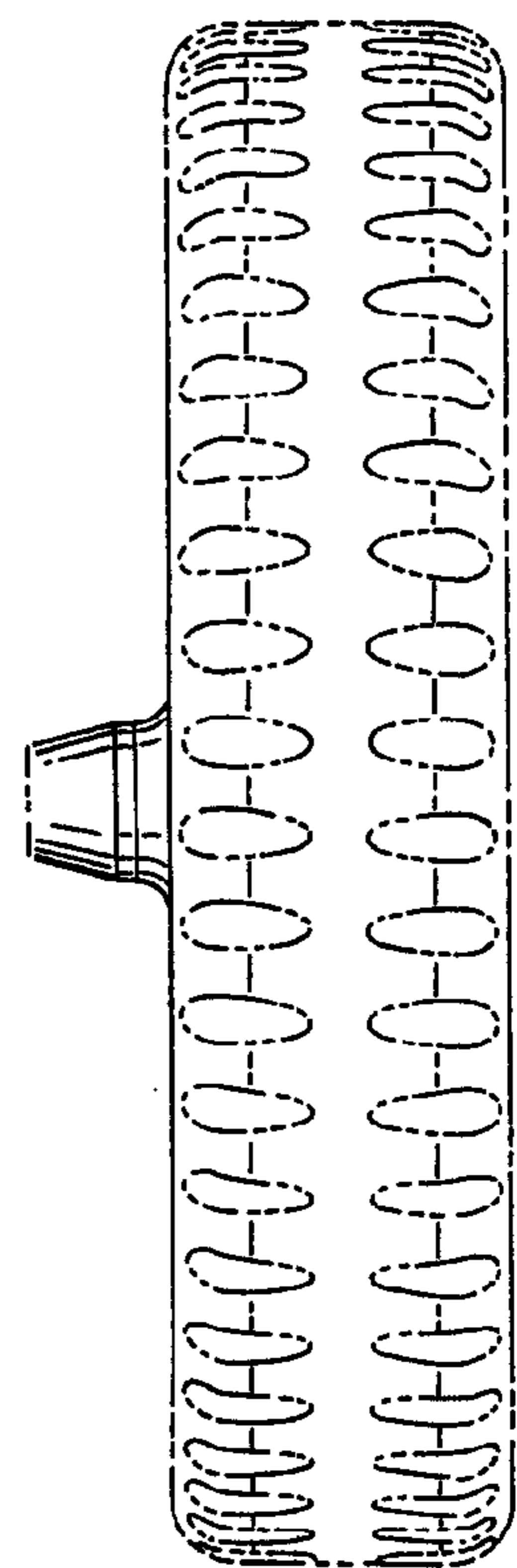
