FIG. 4 is a bottom view of the coupling nut for an electrical connector of FIG. 1; and,

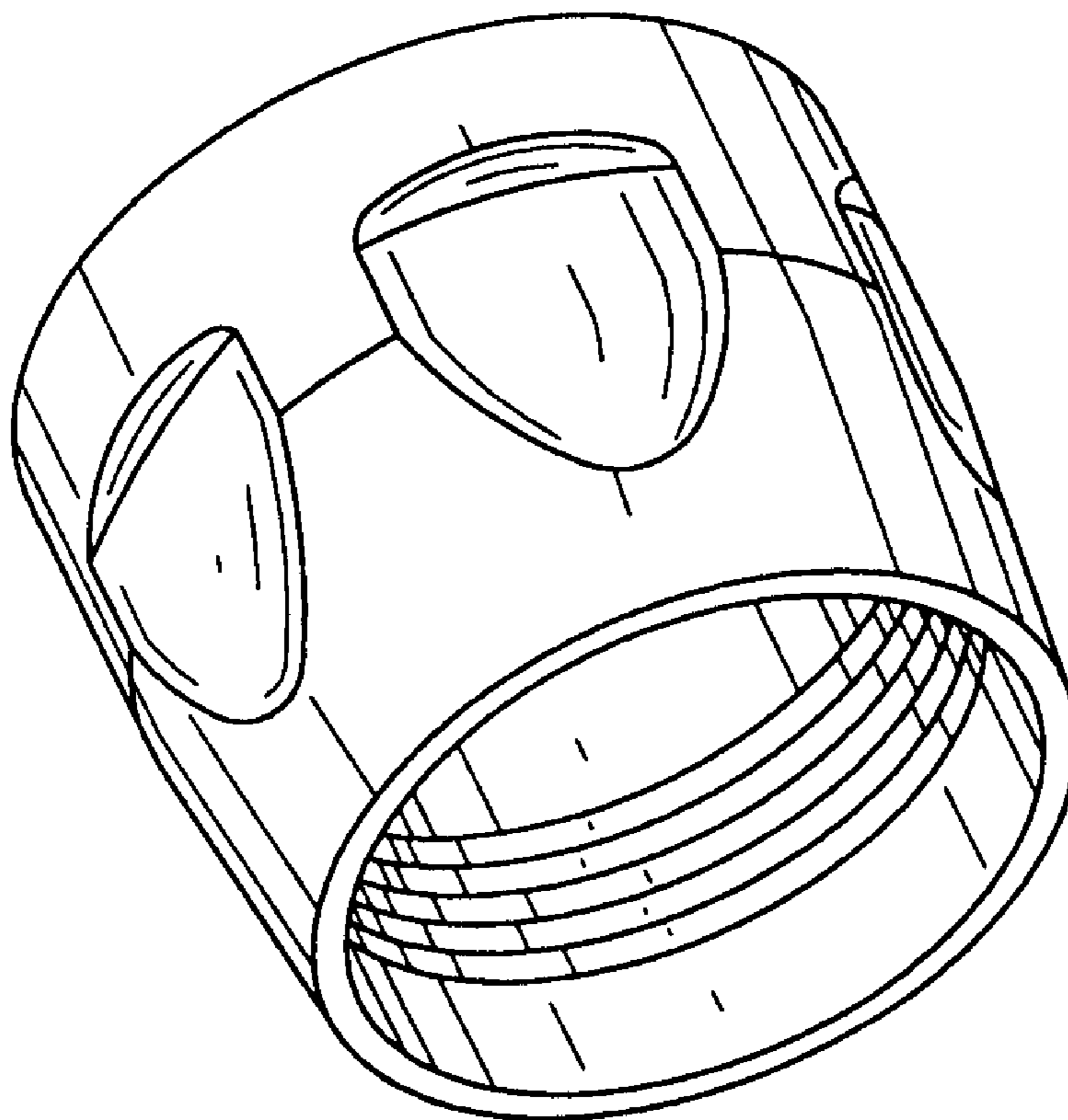
FIG. 5 is a perspective view of the coupling nut for an electrical connector of FIG. 1.

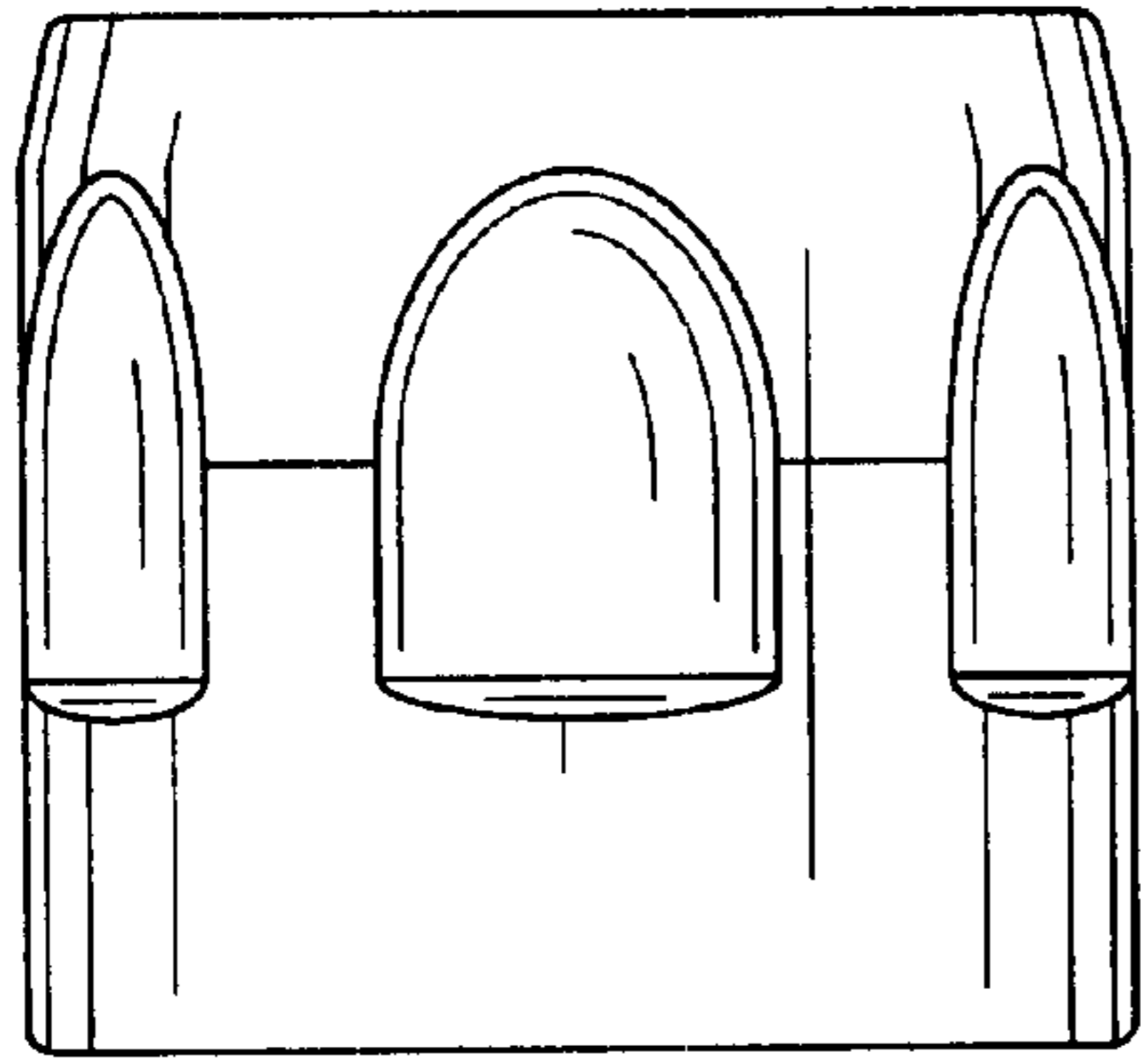

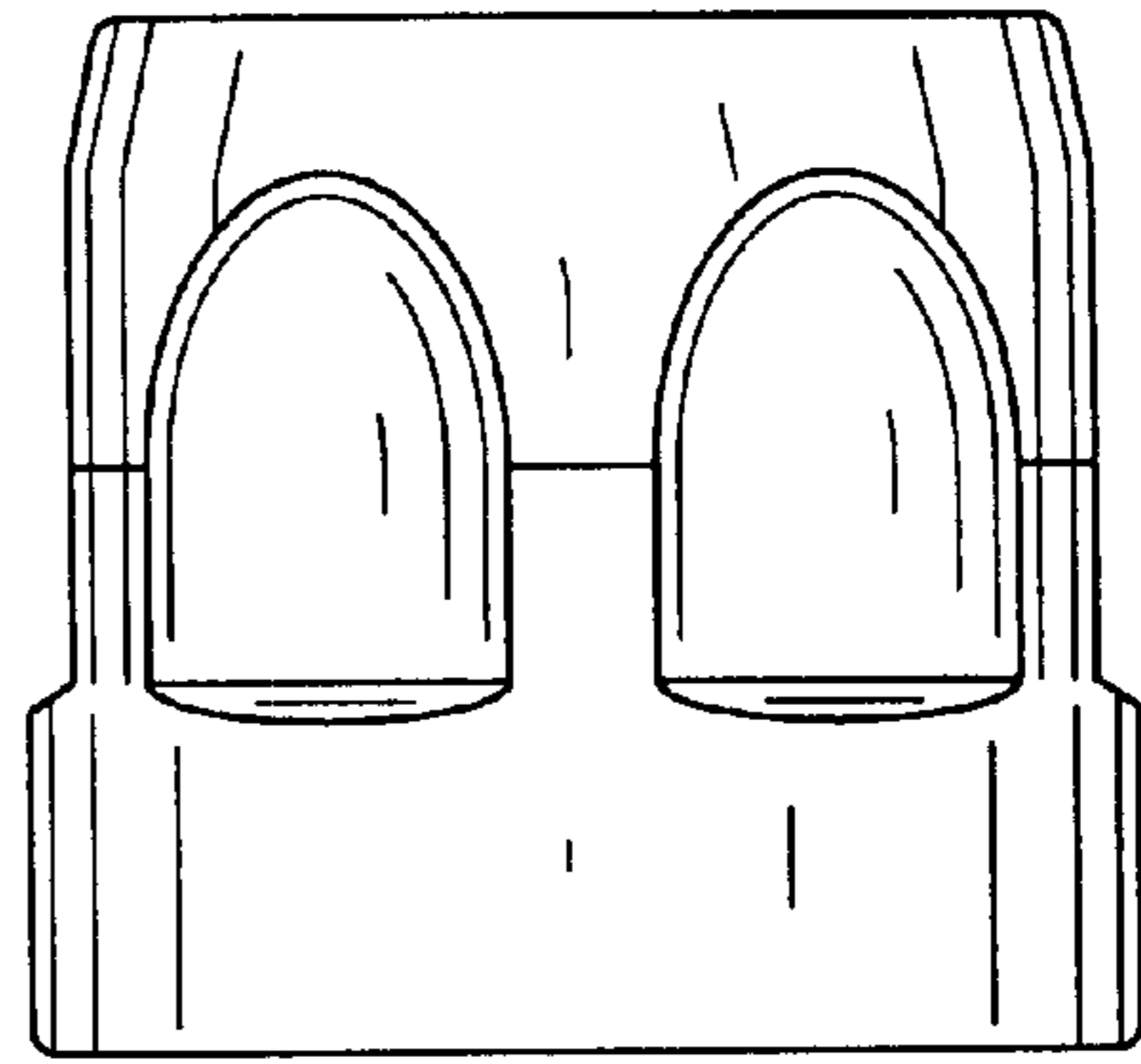

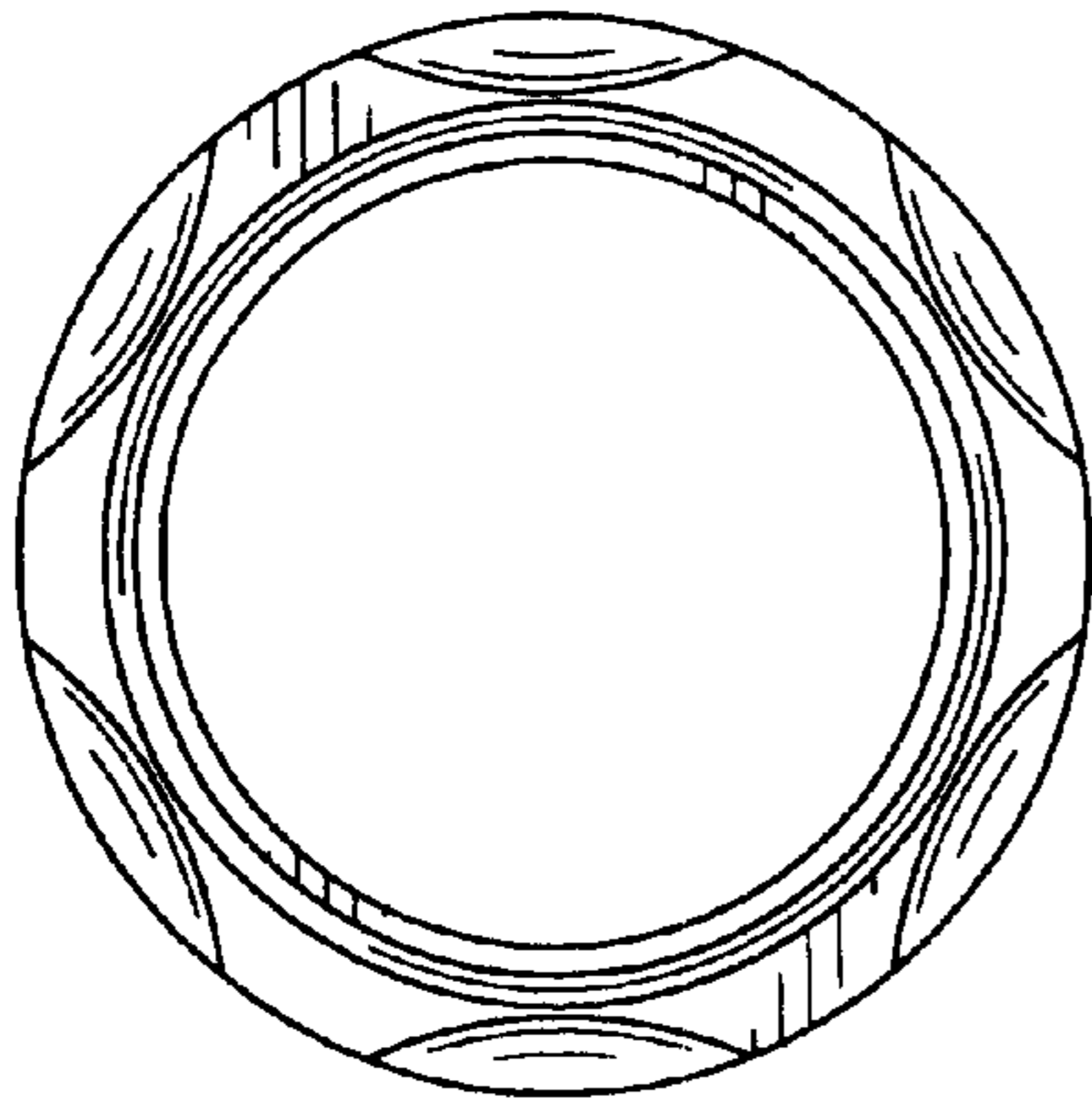

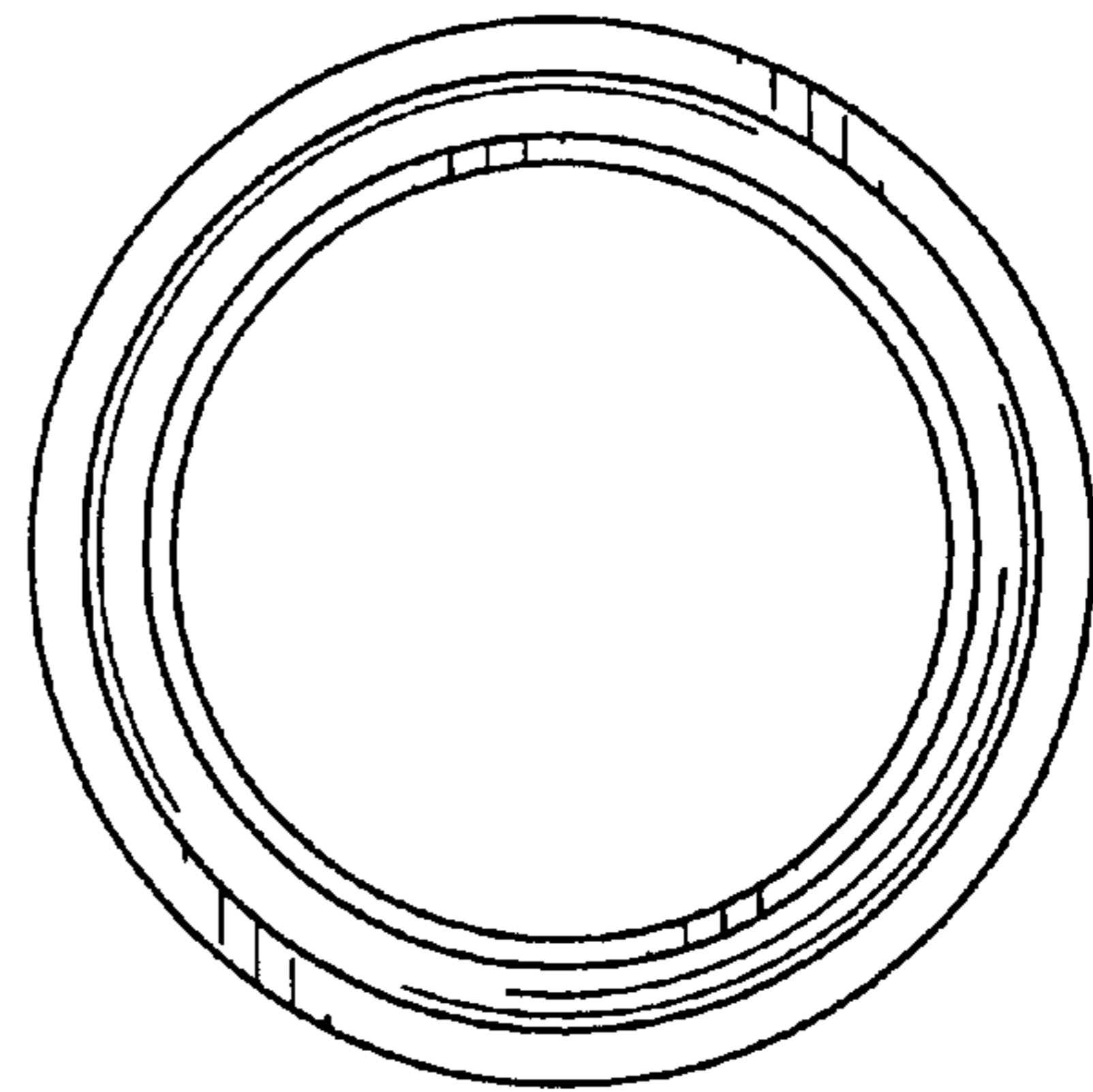

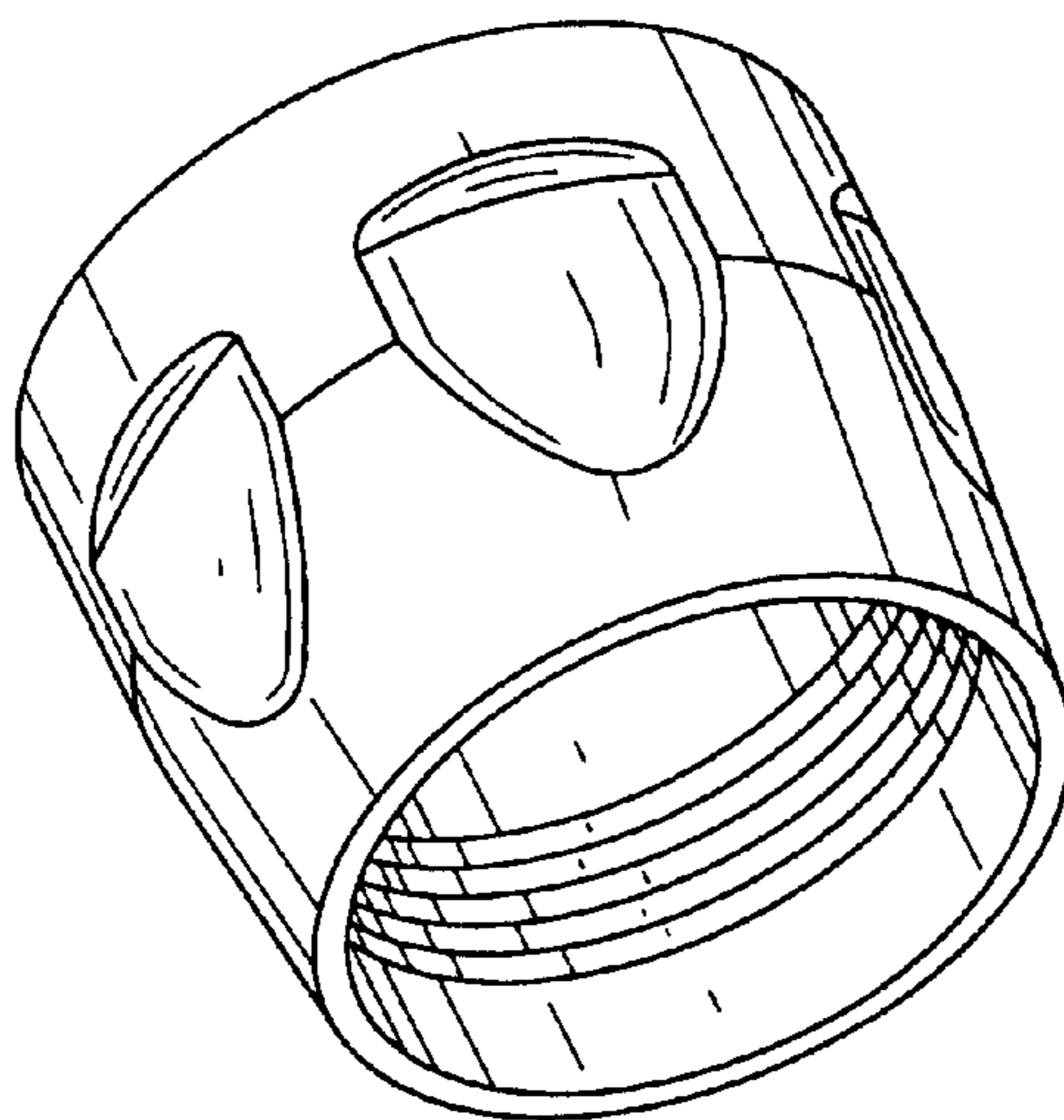
