FIG. 6 is a side view of the wall base with curved front face and flat back face as shown in FIG. 1, shown from the opposite side of that shown in FIG. 4; and,

FIG. 7 is a bottom end view of the wall base with curved front face and flat back face as shown in FIG. 1.

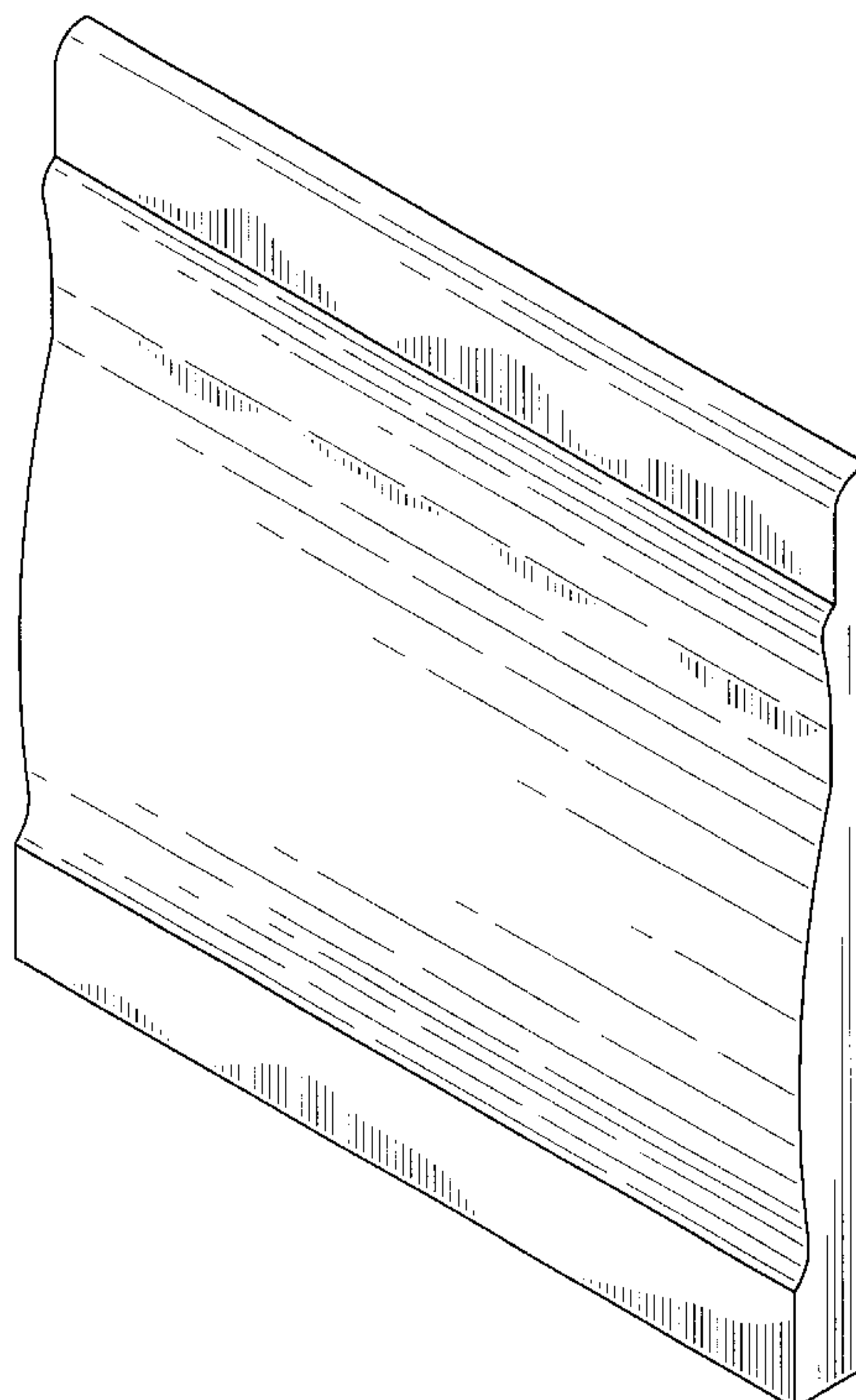

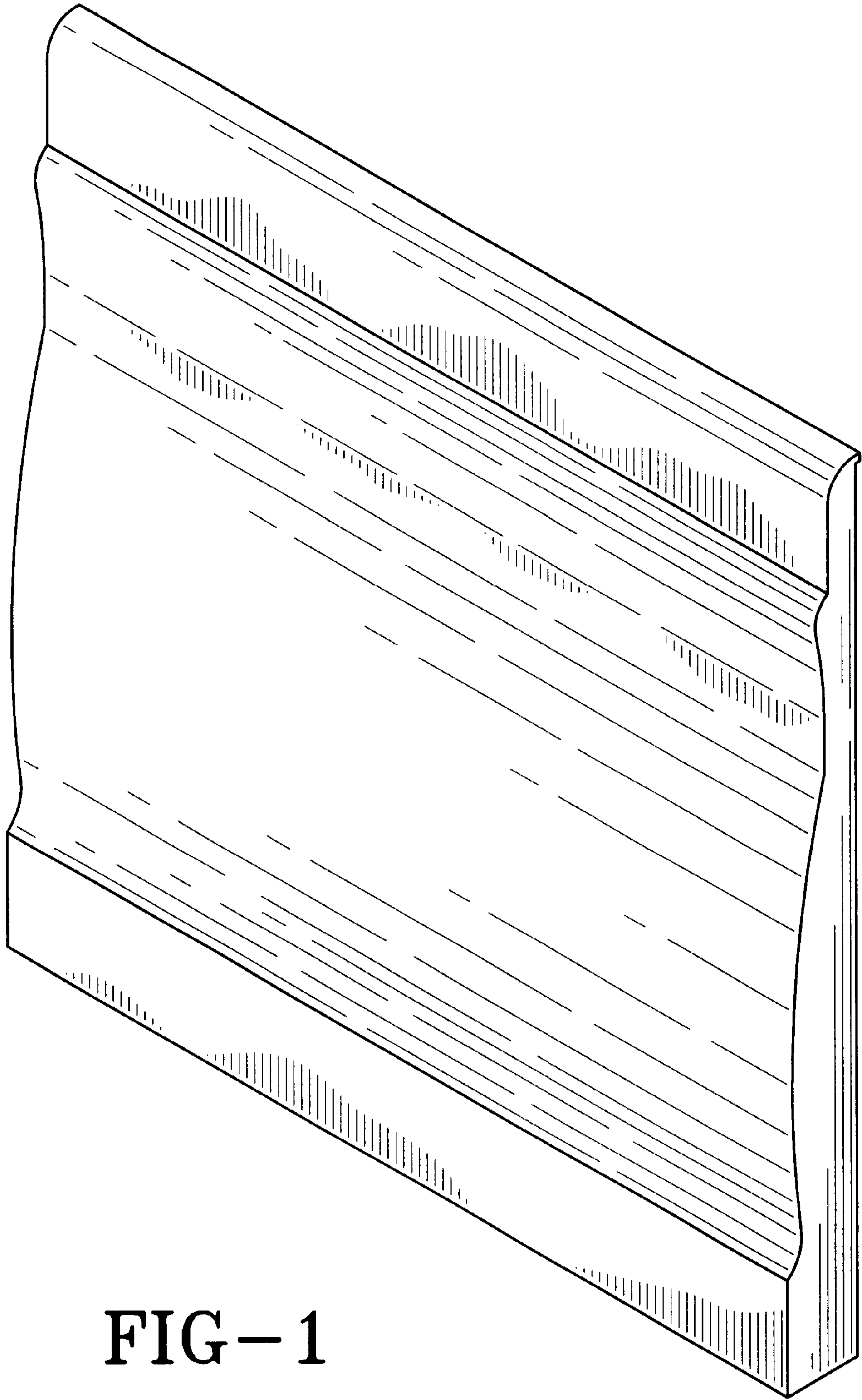

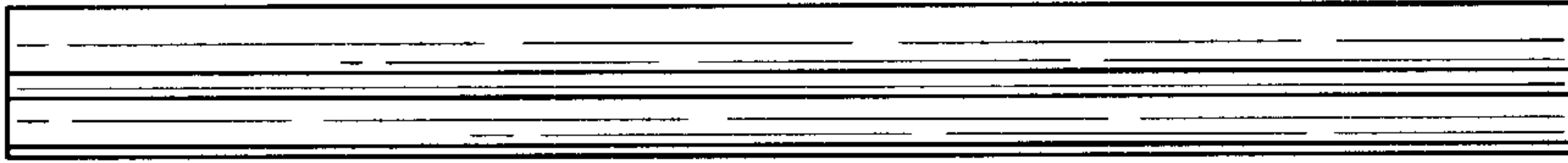

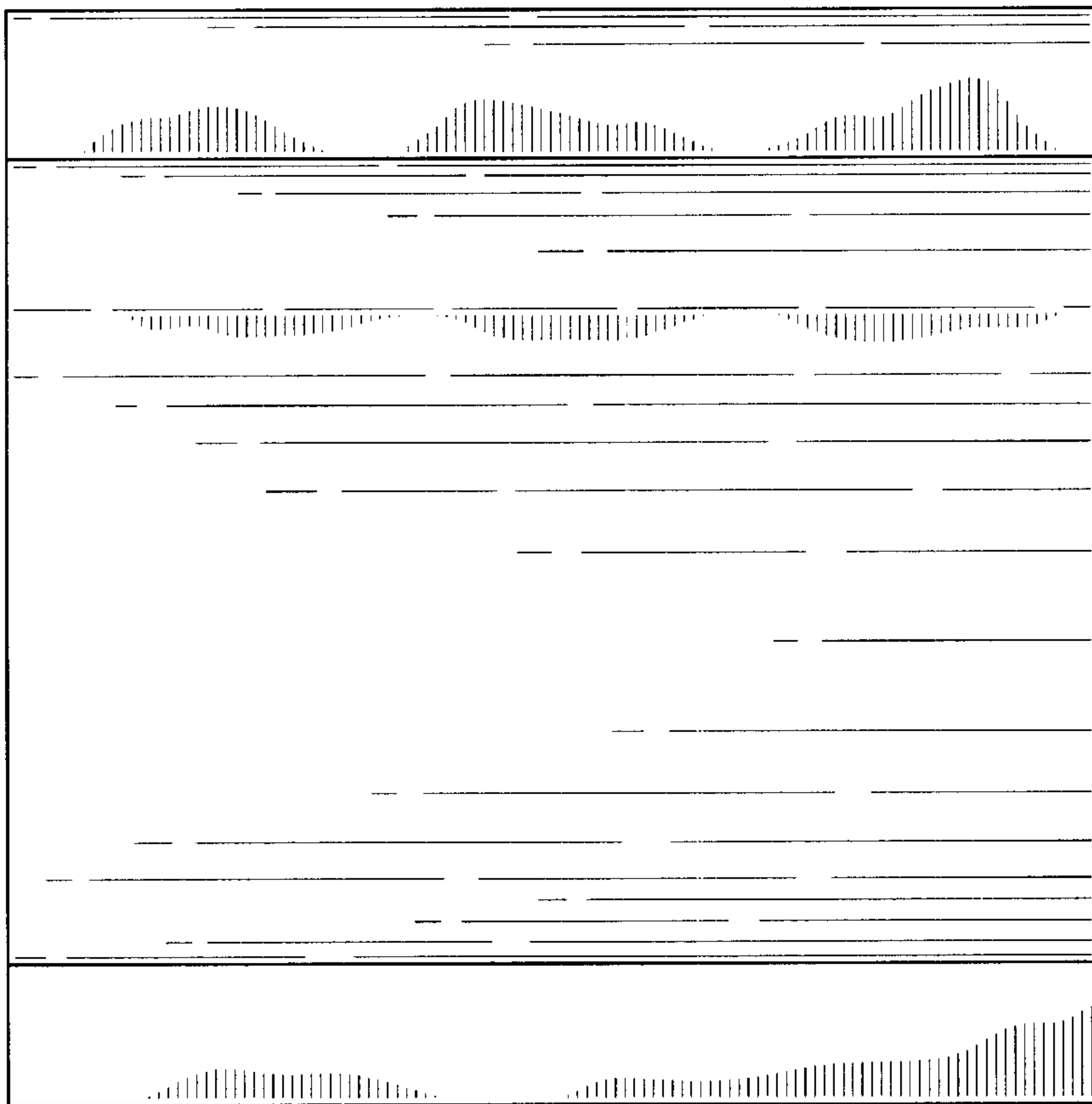

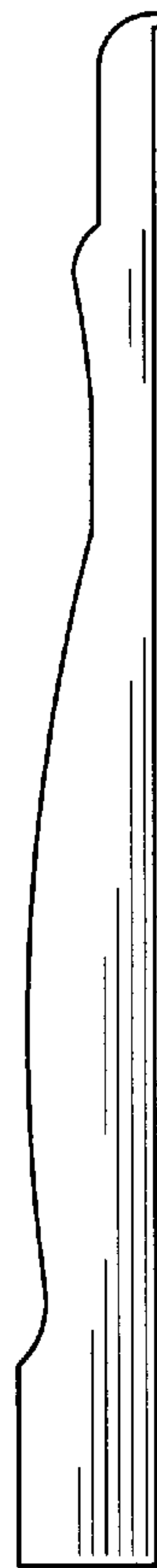

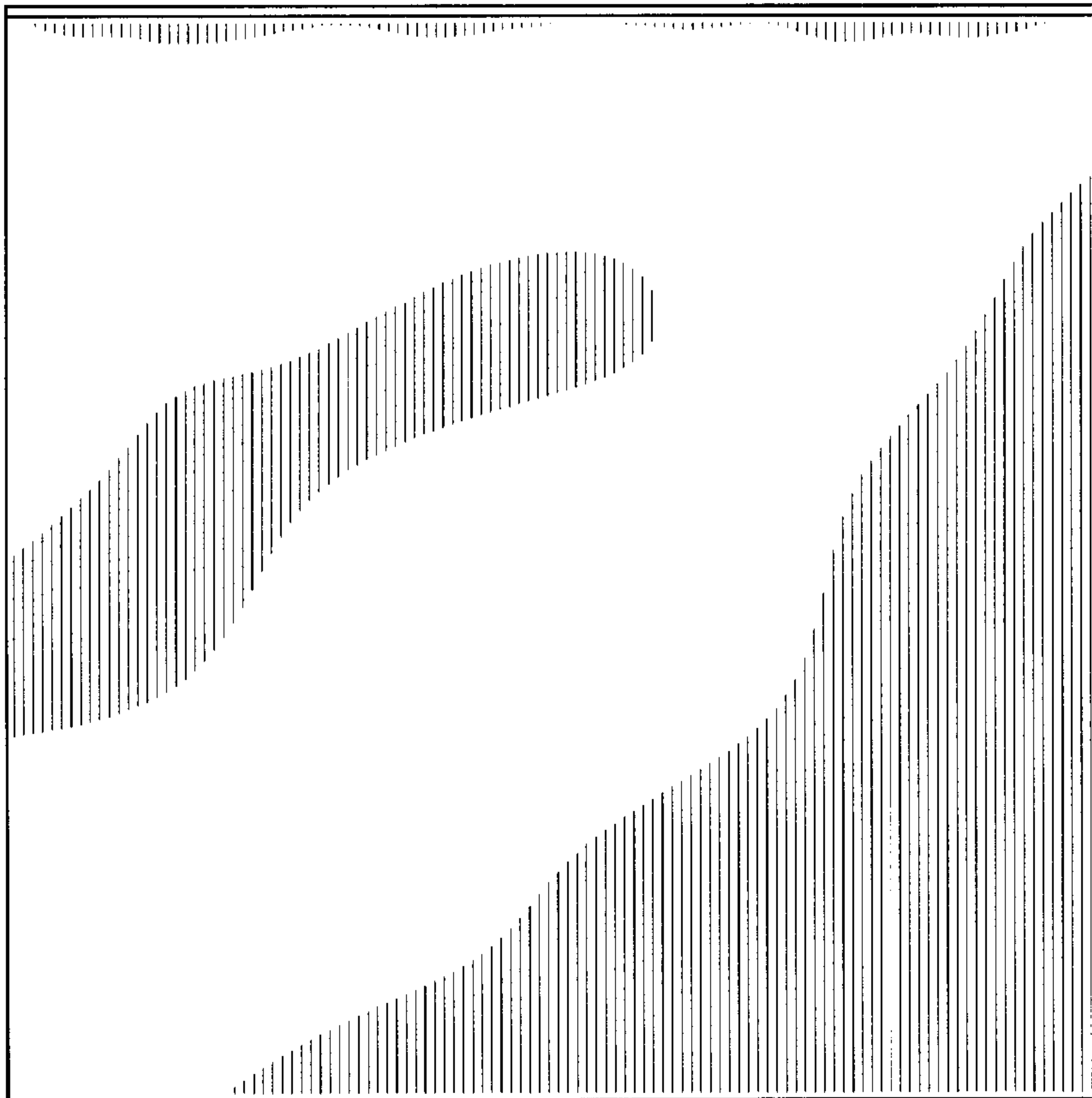

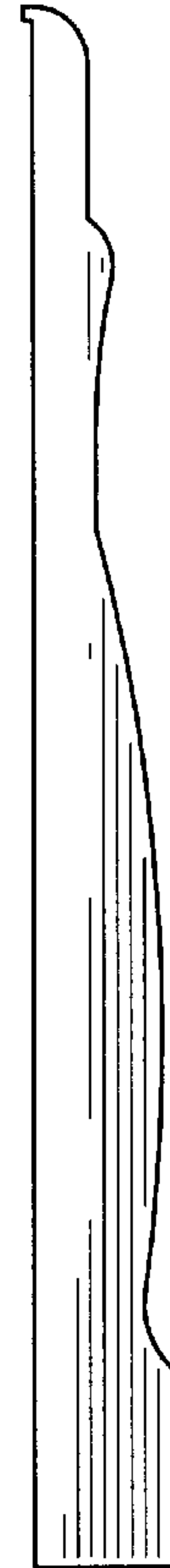

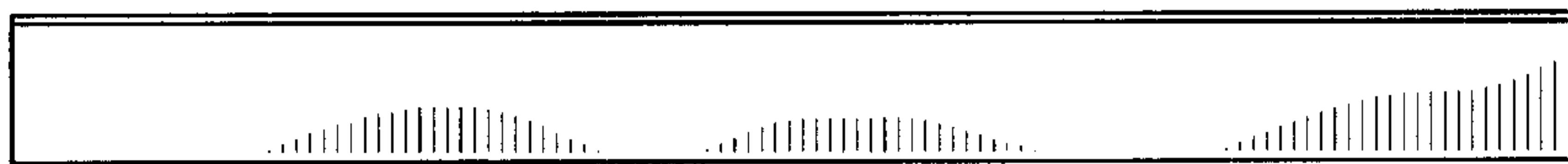
