(57) **CLAIM**

The ornamental design for a cat exercise wheel, as shown and described.

DESCRIPTION

FIG. 1 is a left front perspective view of a cat exercise wheel, showing our new design;

FIG. 2 is an elevational view of the right side thereof, the elevational view of the left side being a mirror image thereof;

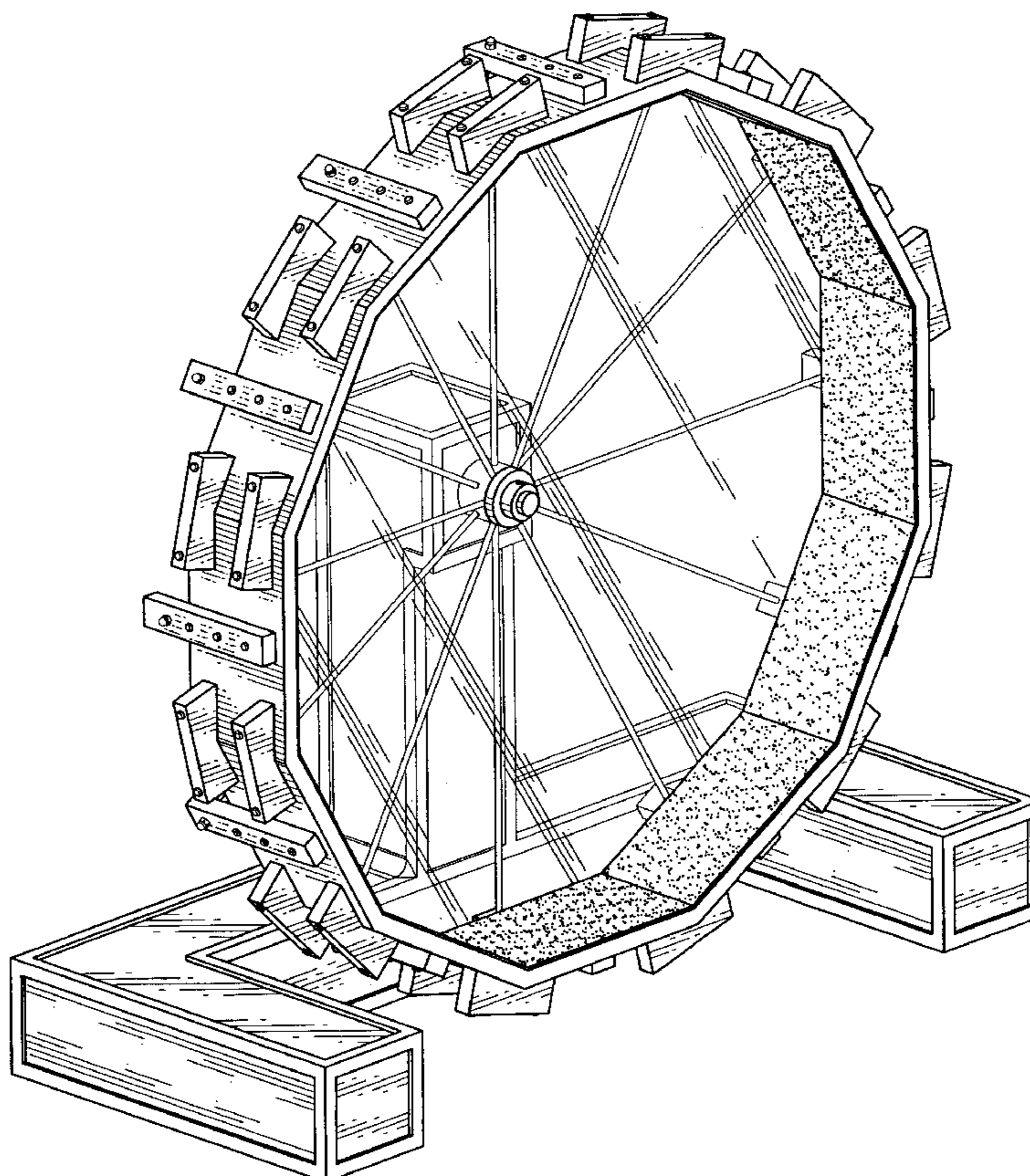
FIG. 3 is a top plan view, thereof;

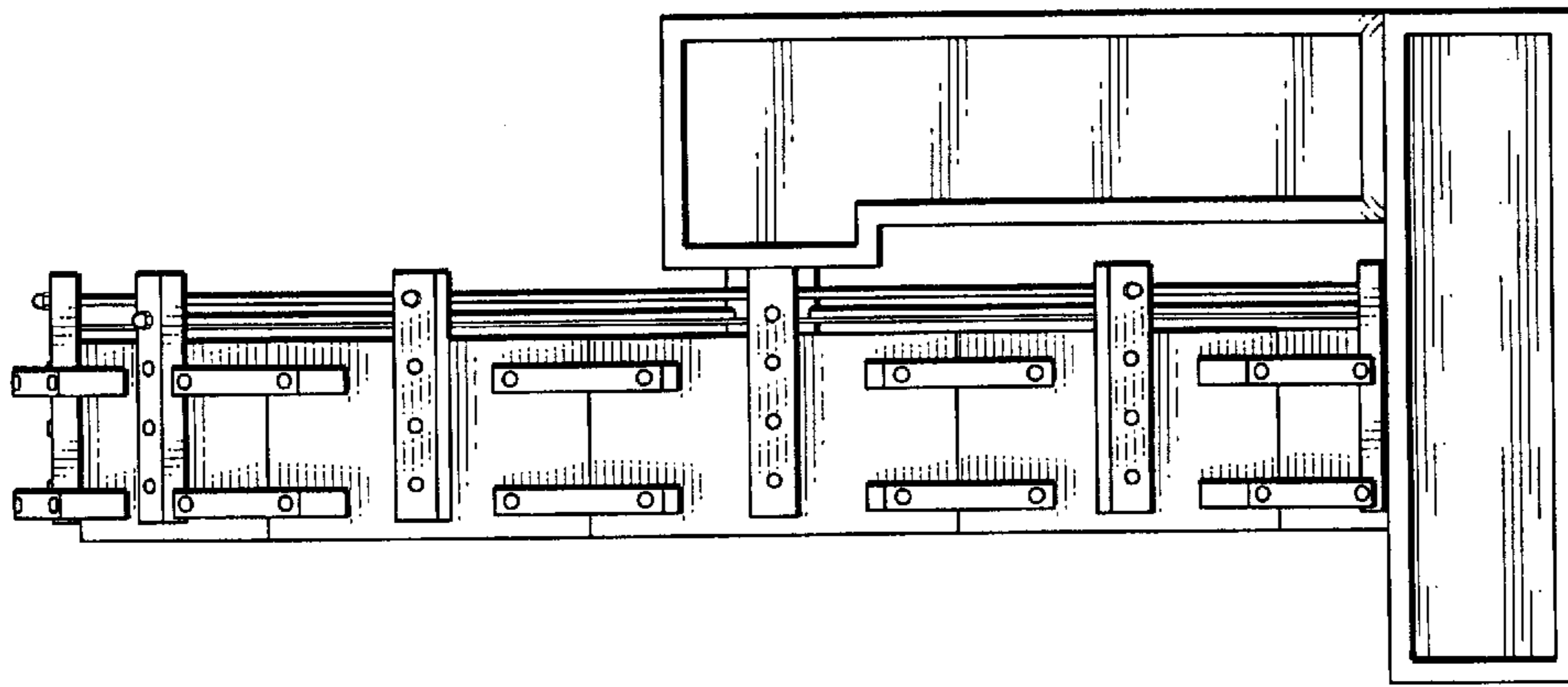

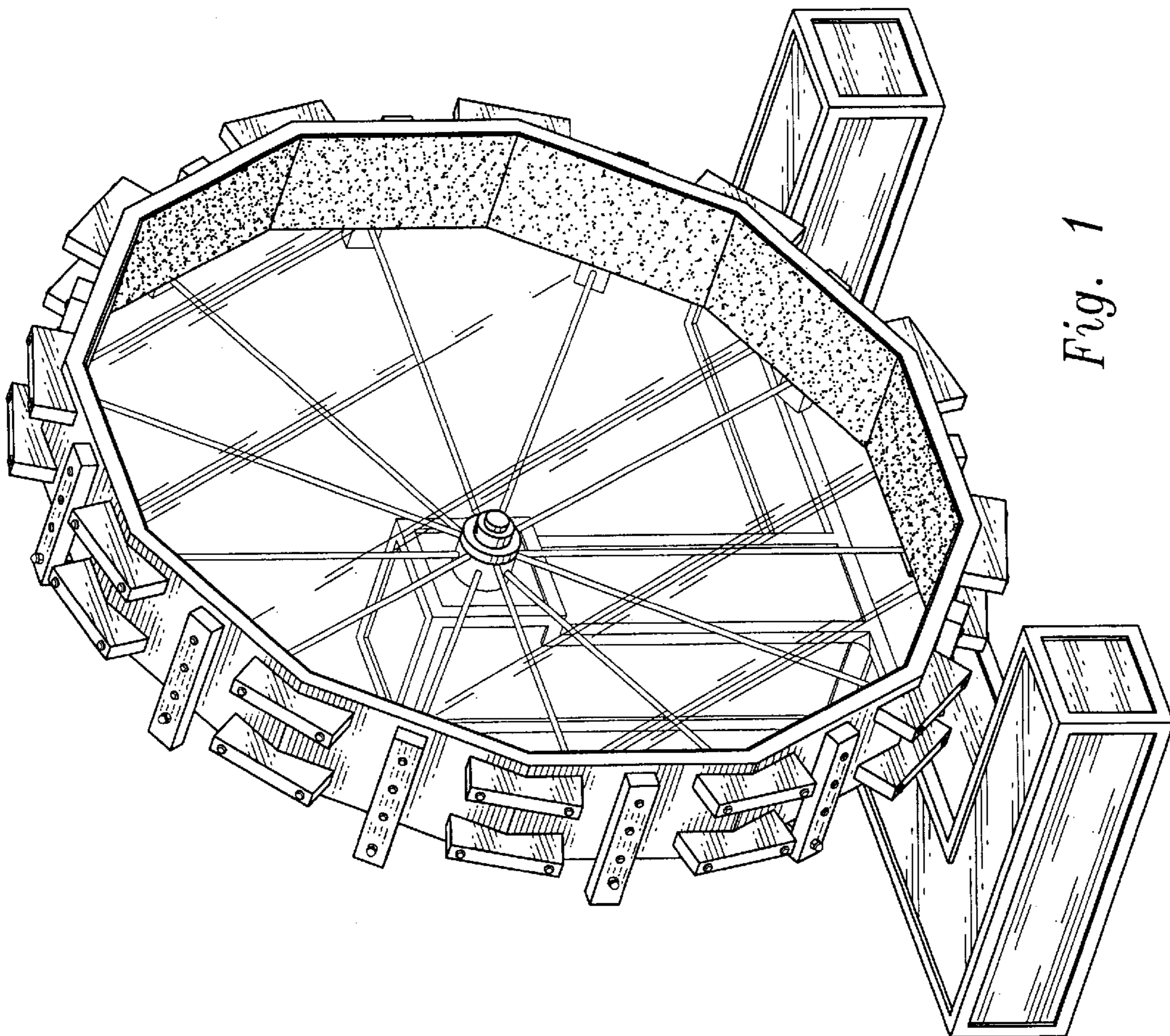

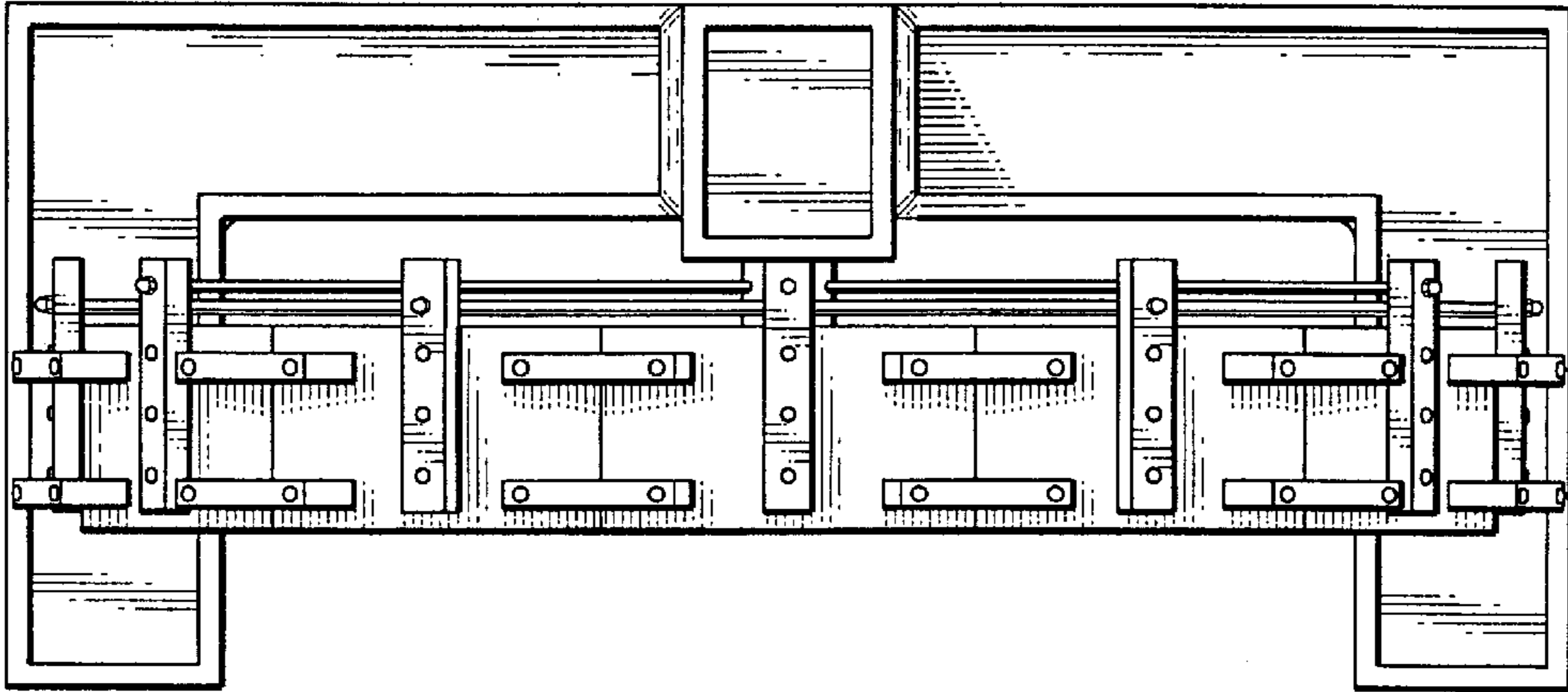

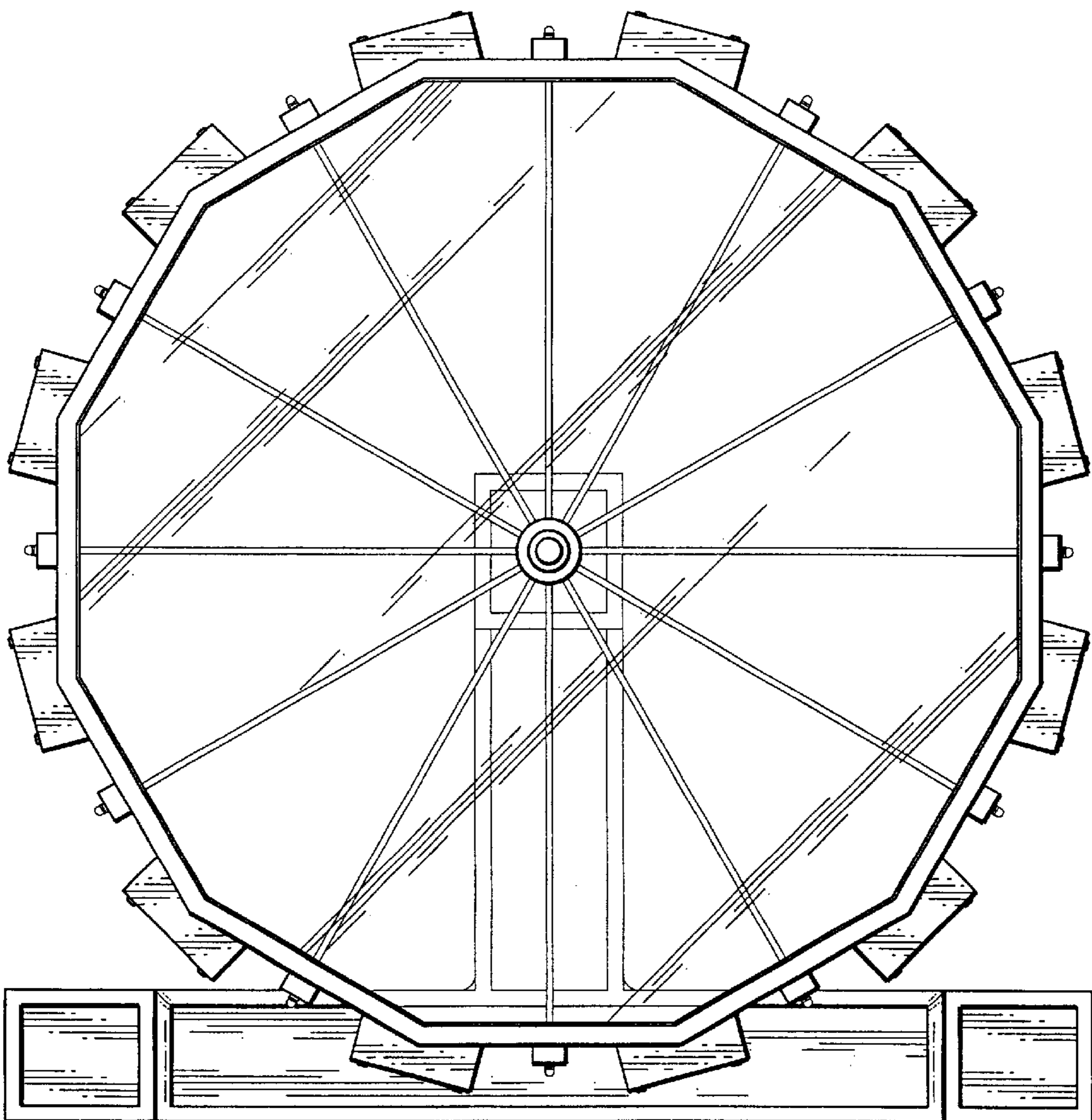

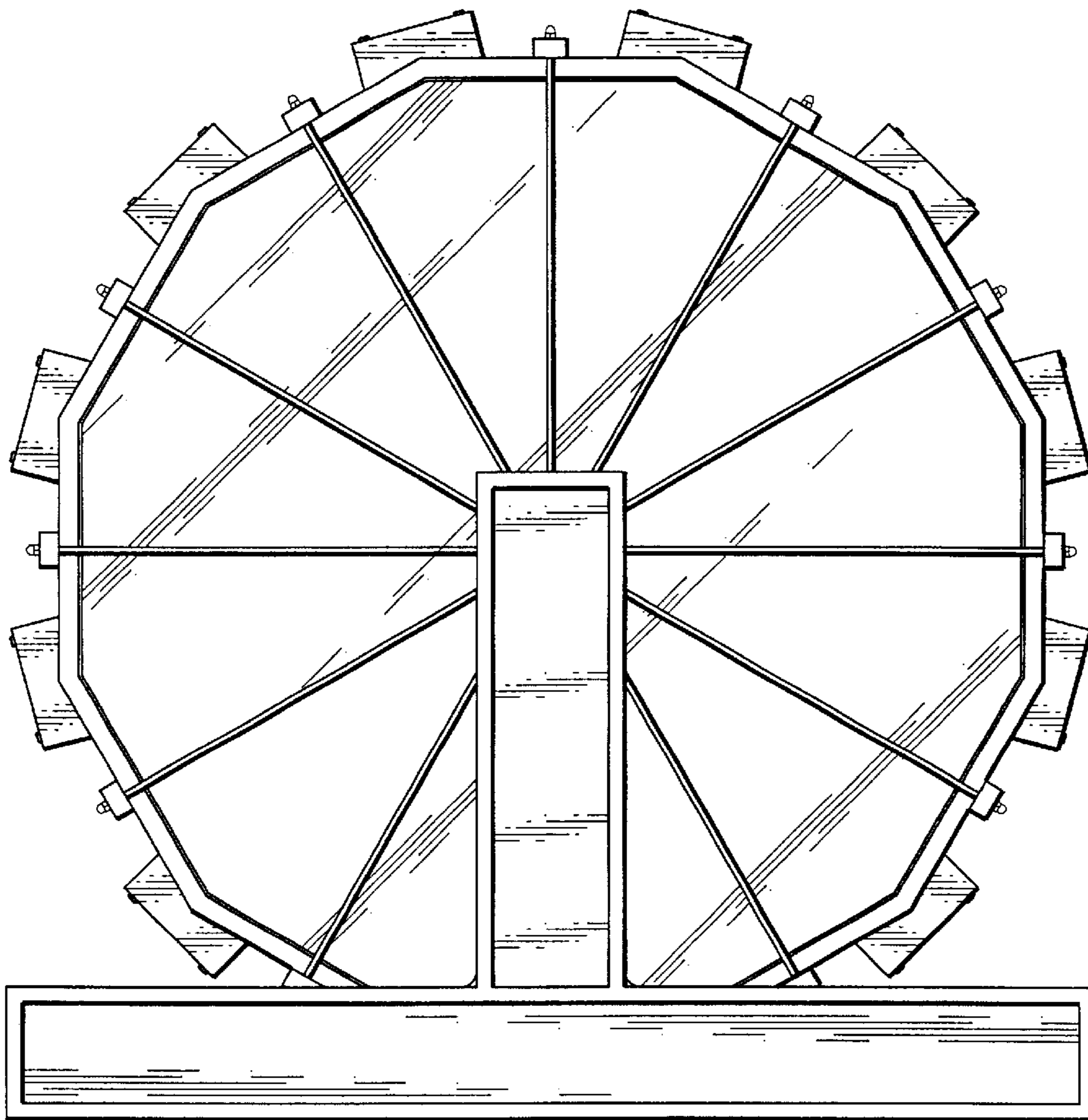

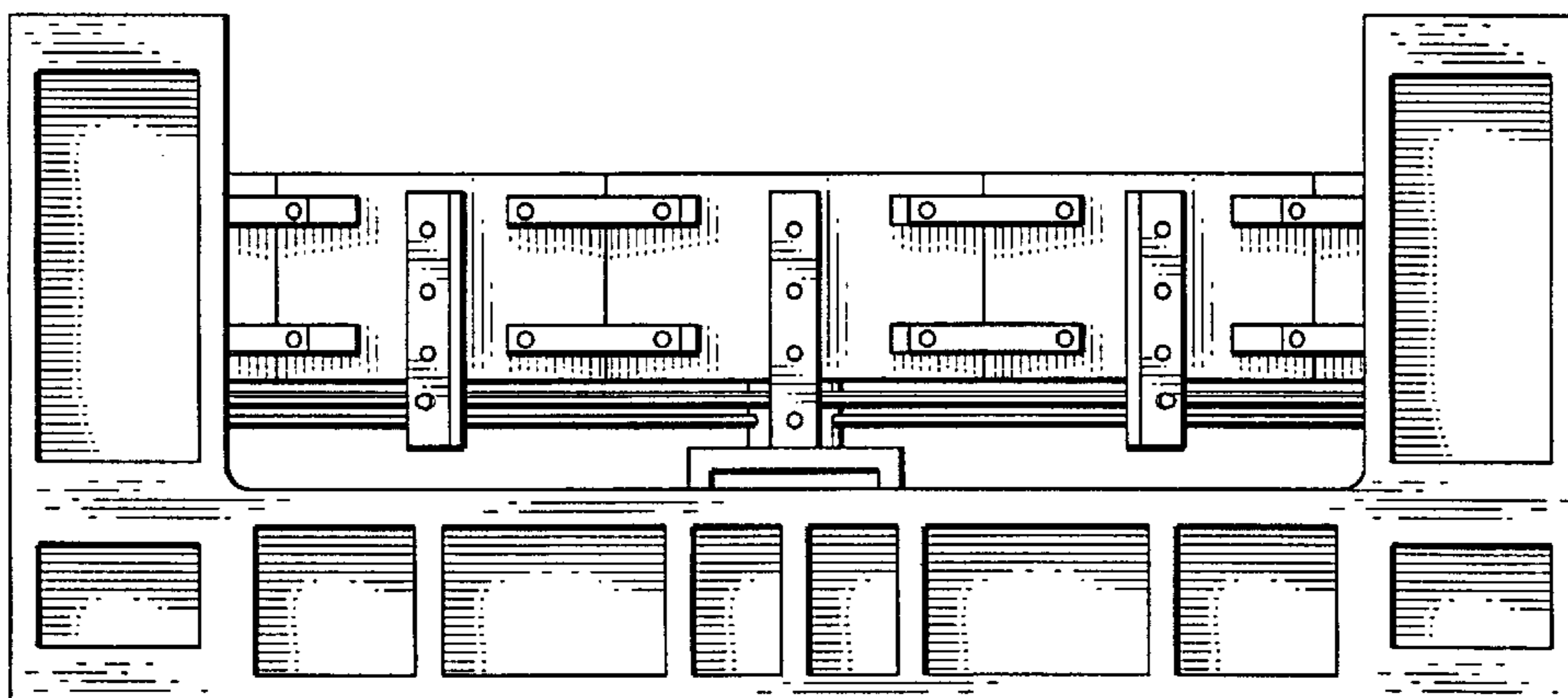
