(57) **CLAIM**

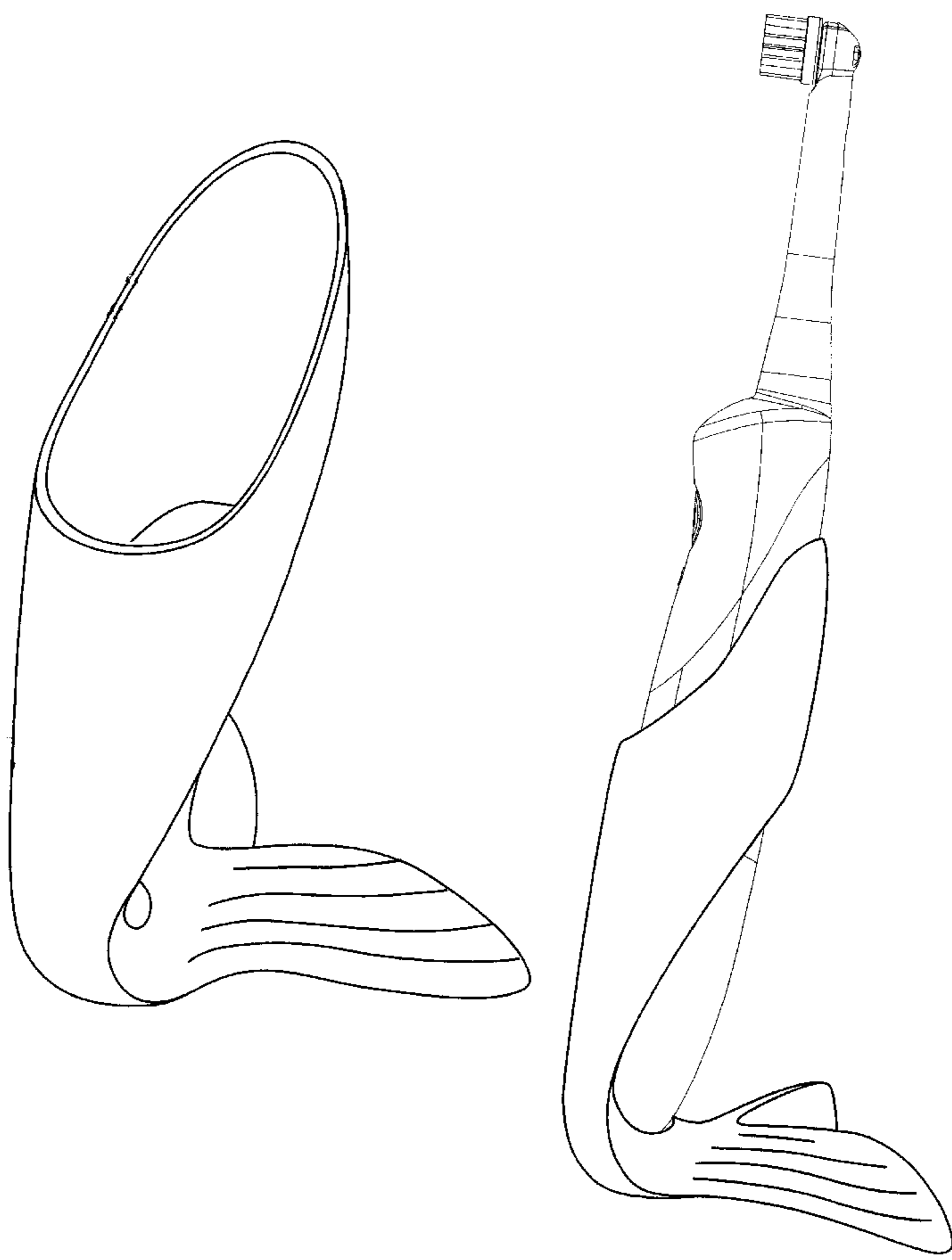
The ornamental design for “a toothbrush holder”, as shown.

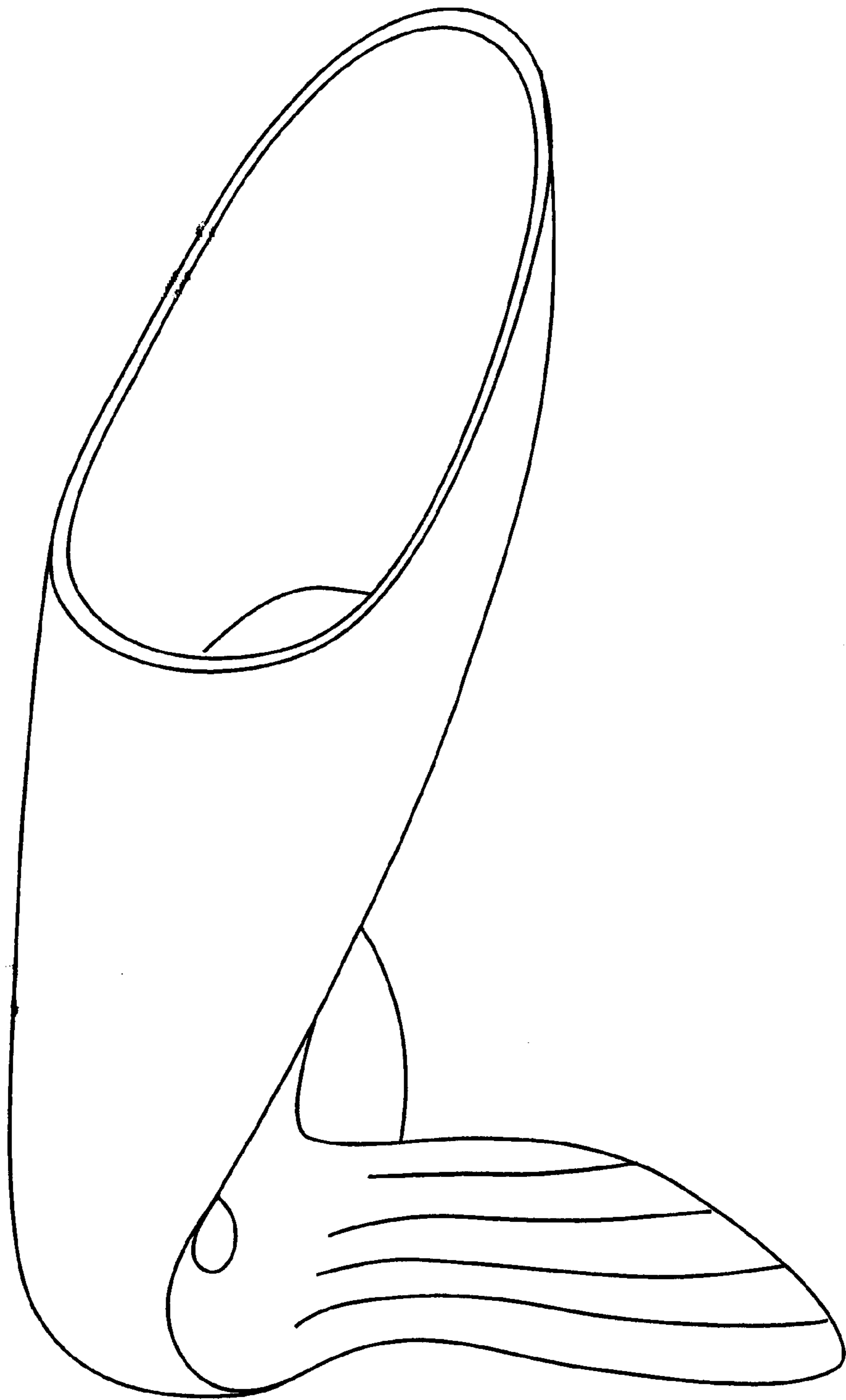

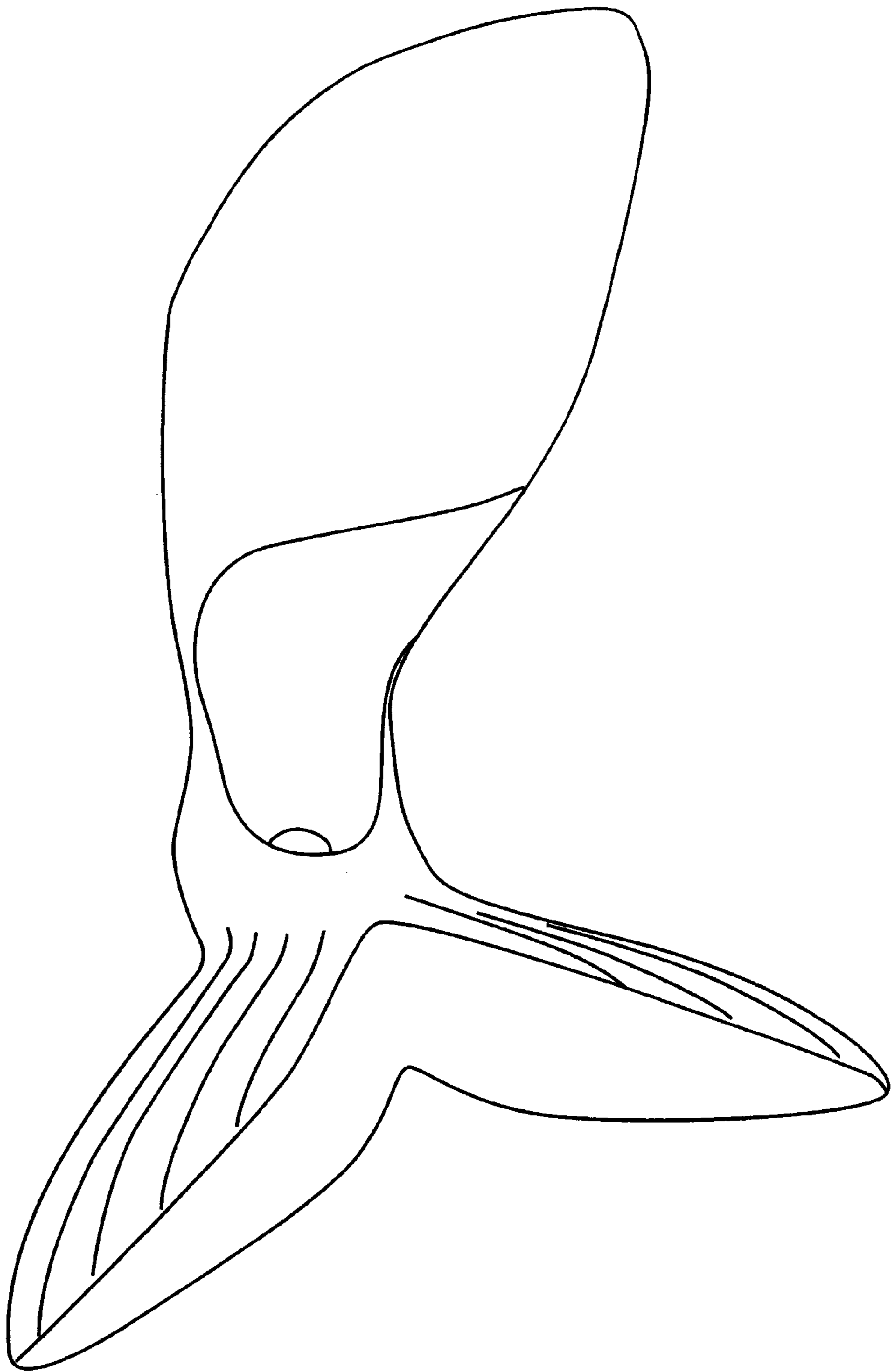

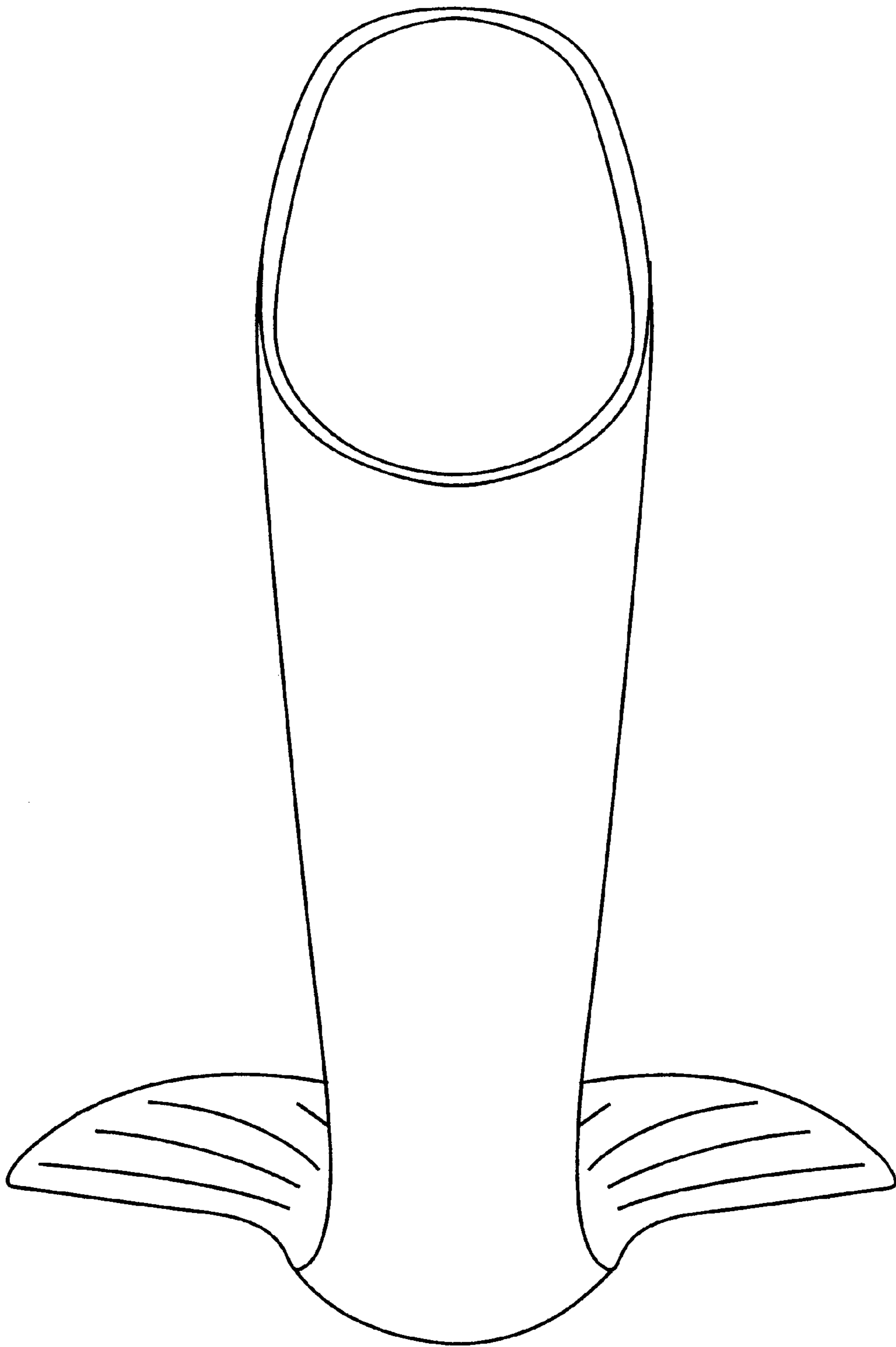

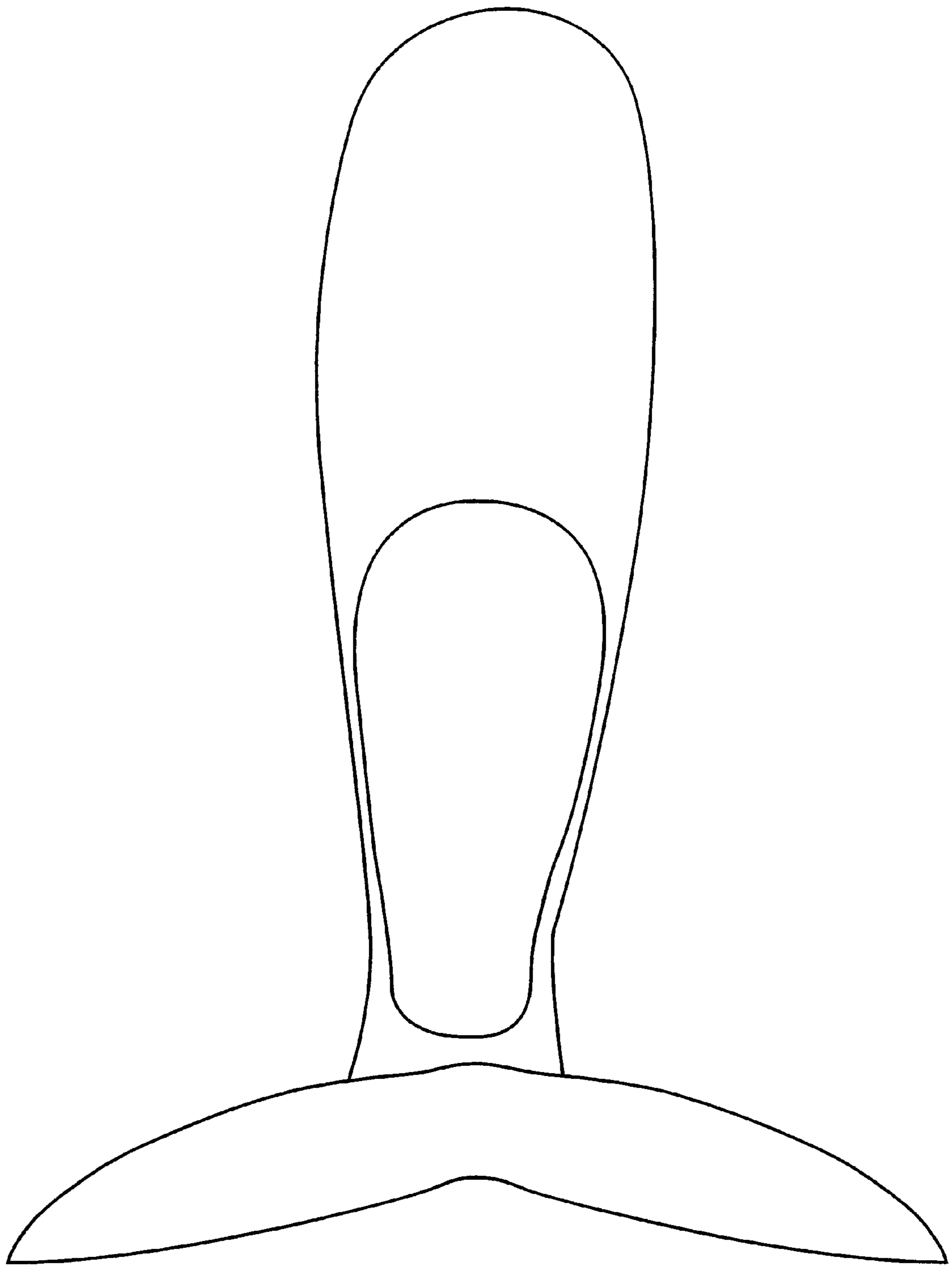

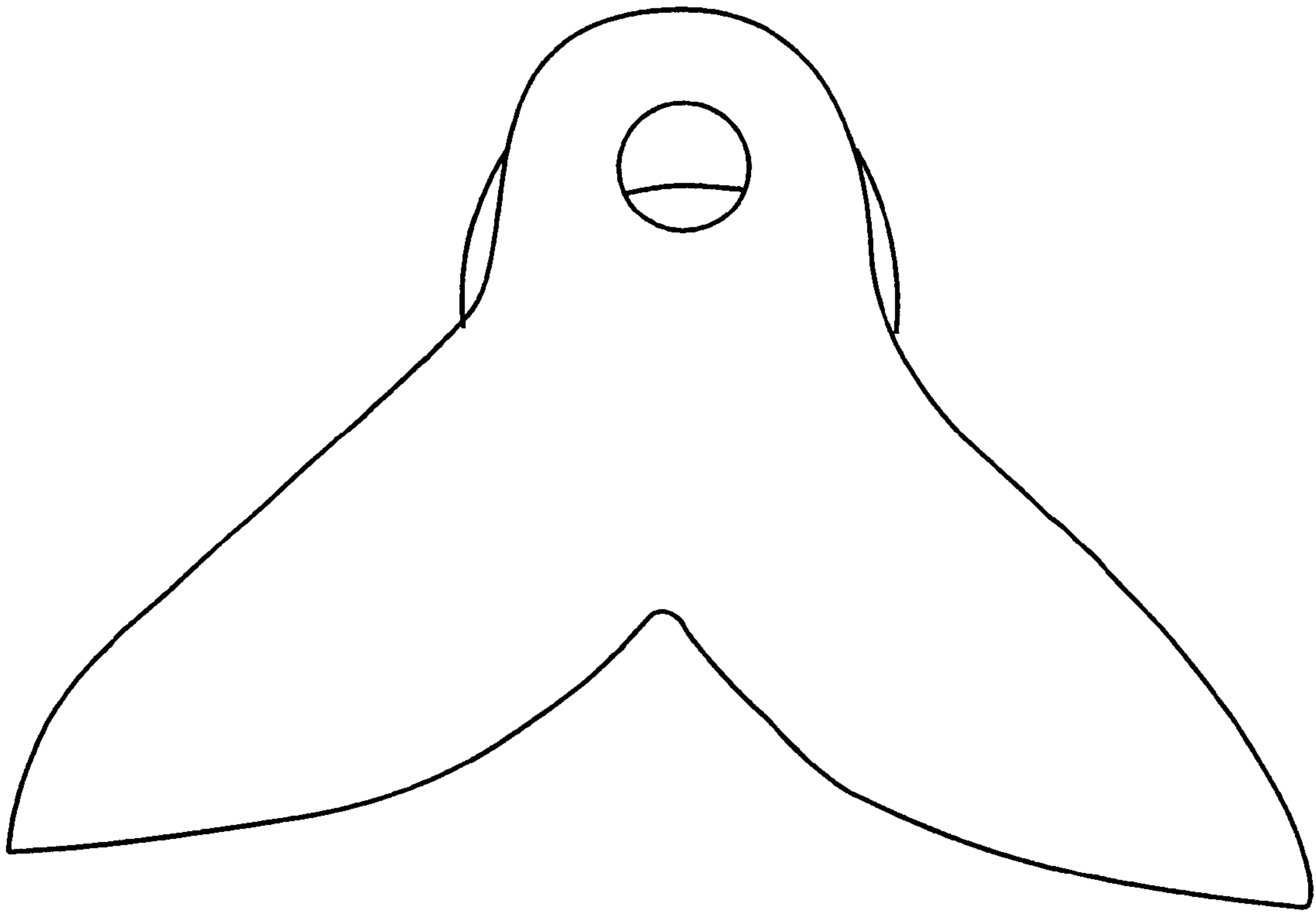

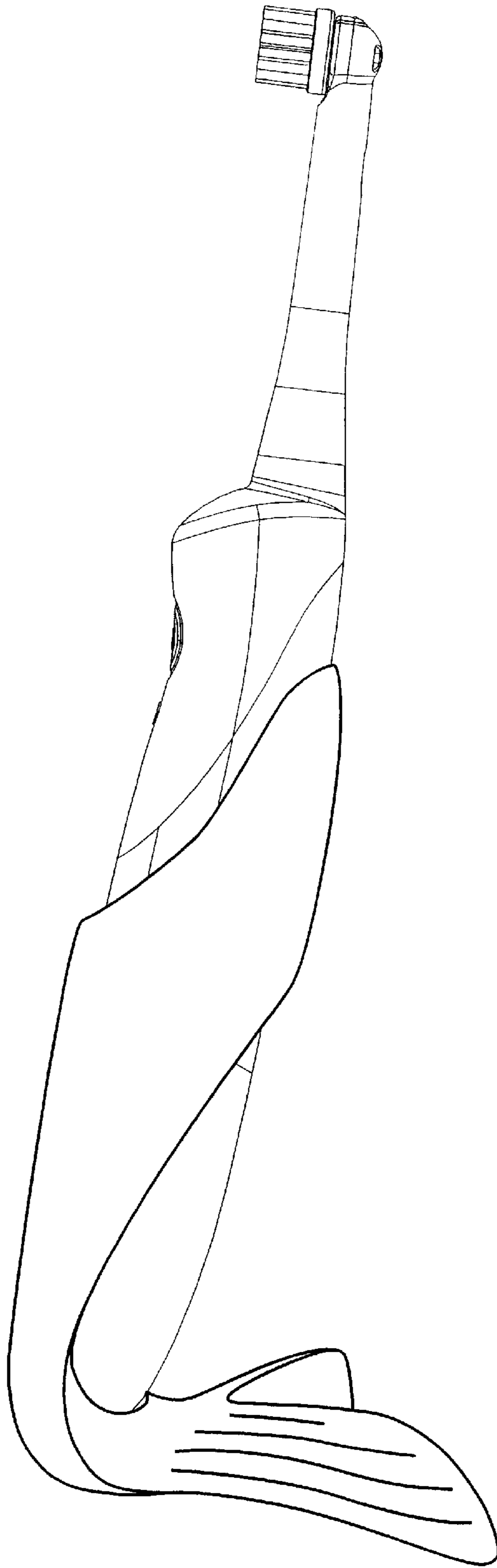
