The ornamental design for a pillow made with a shirt, as shown and described.

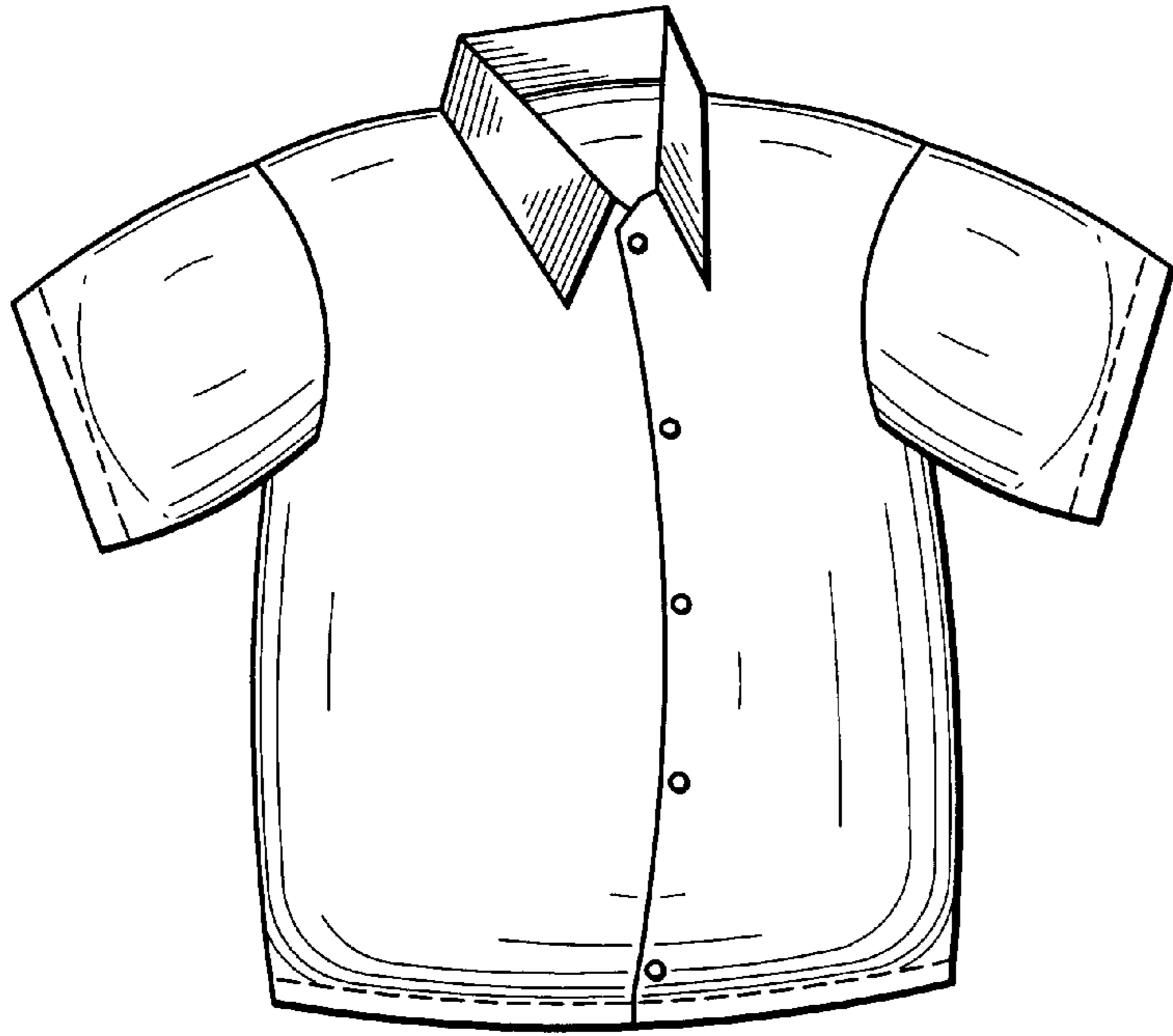

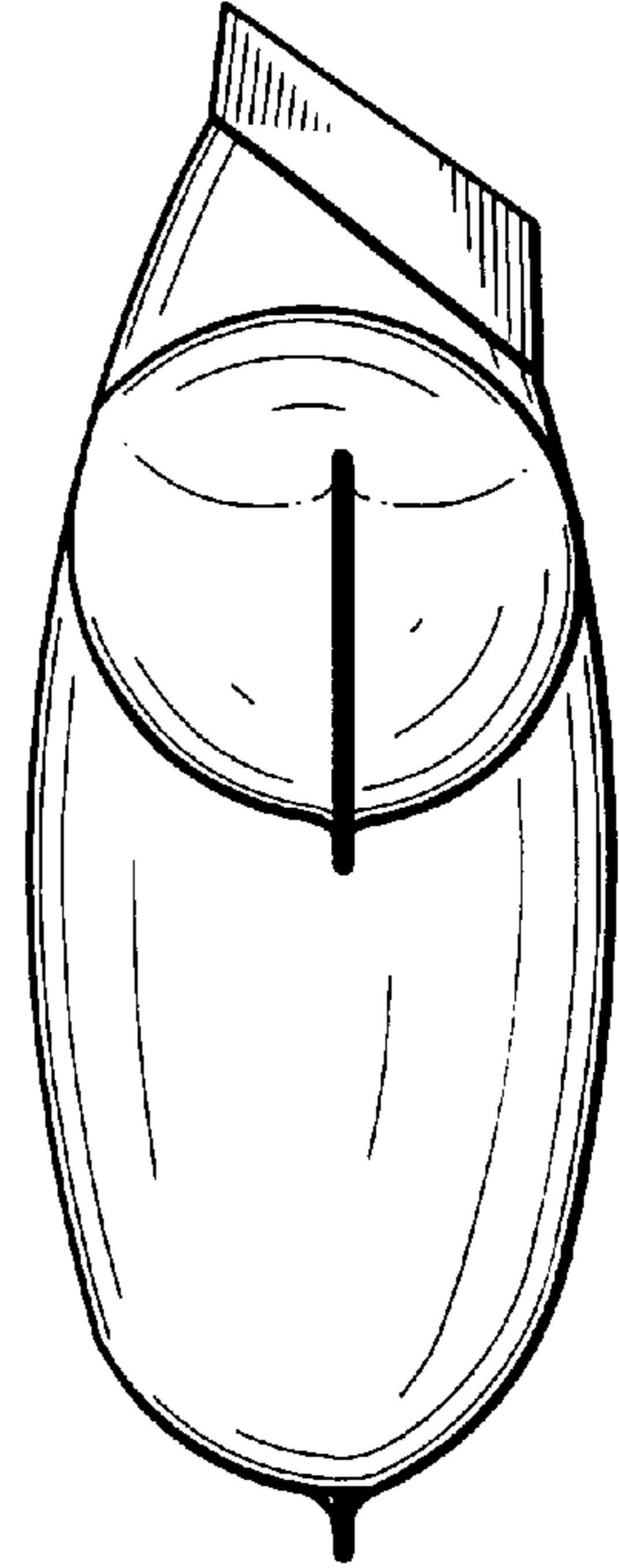

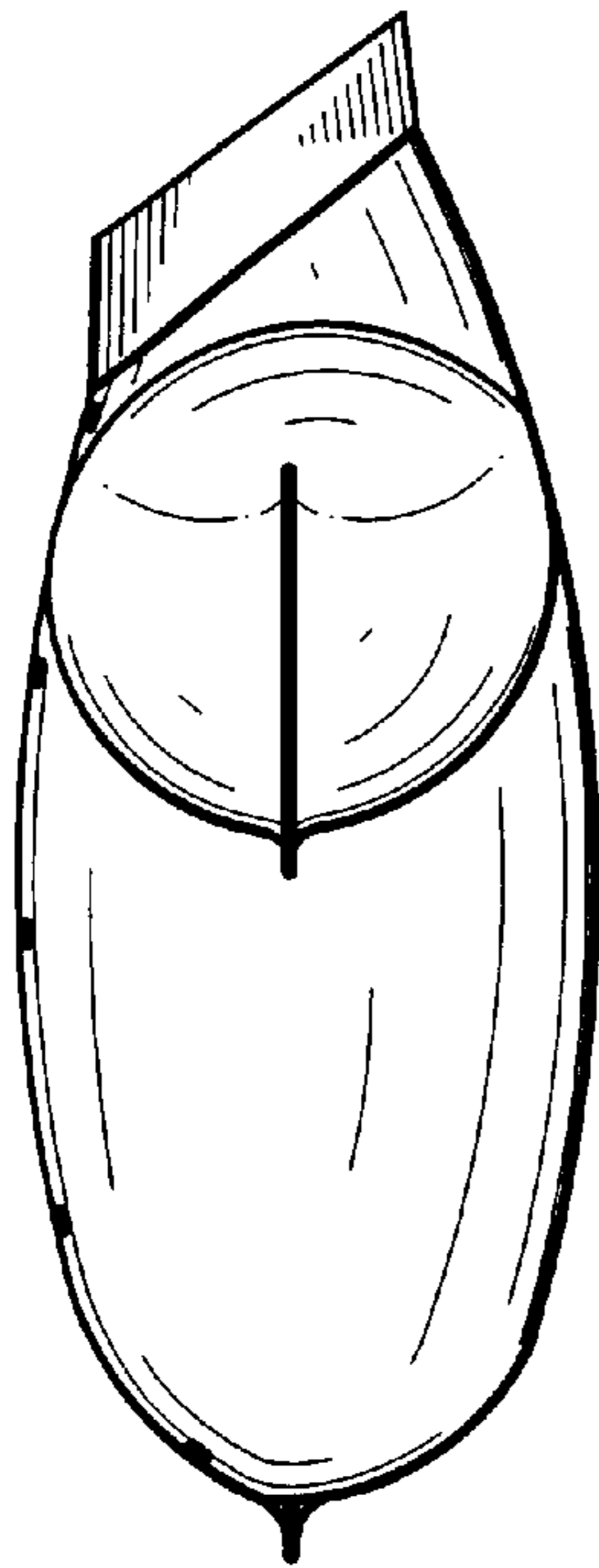

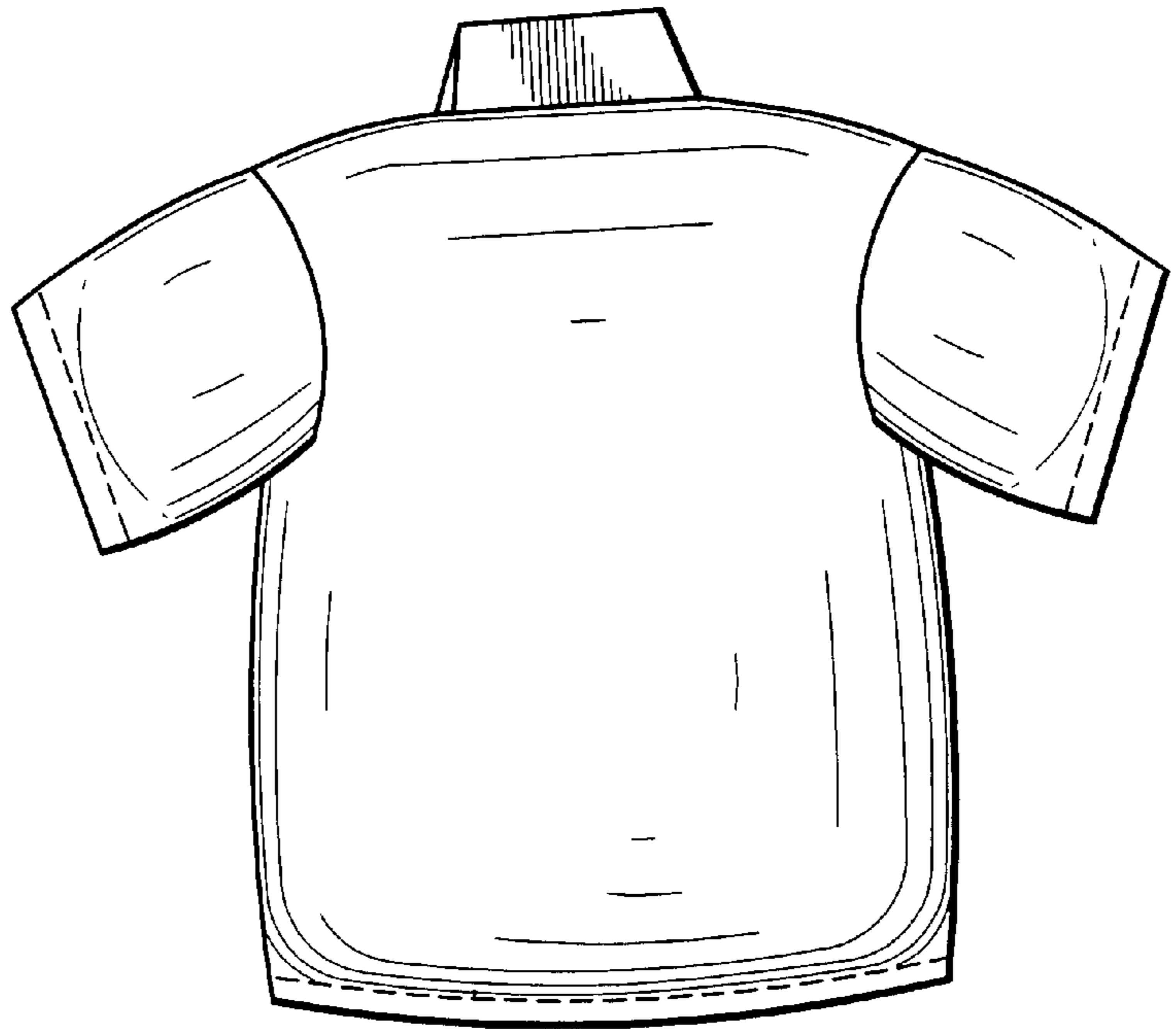

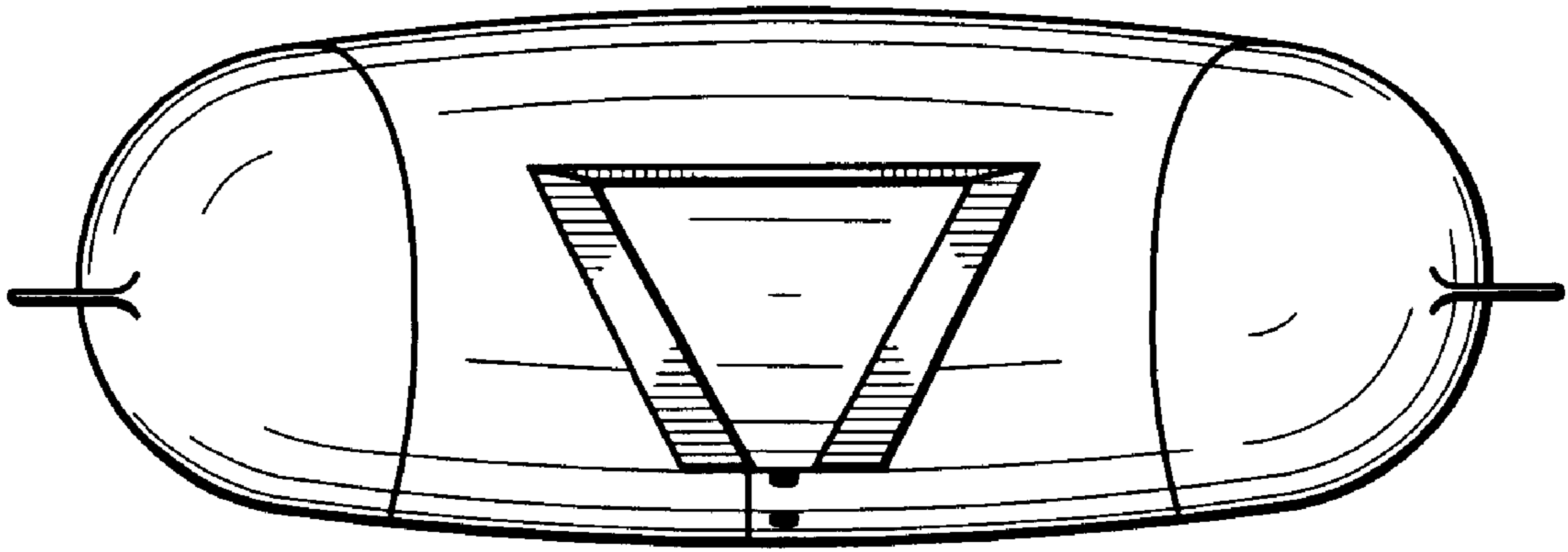
