The ornamental design for a cup, as shown.

DESCRIPTION

FIG. 1 is a top front side perspective view of a first embodiment of a cup showing our new design;

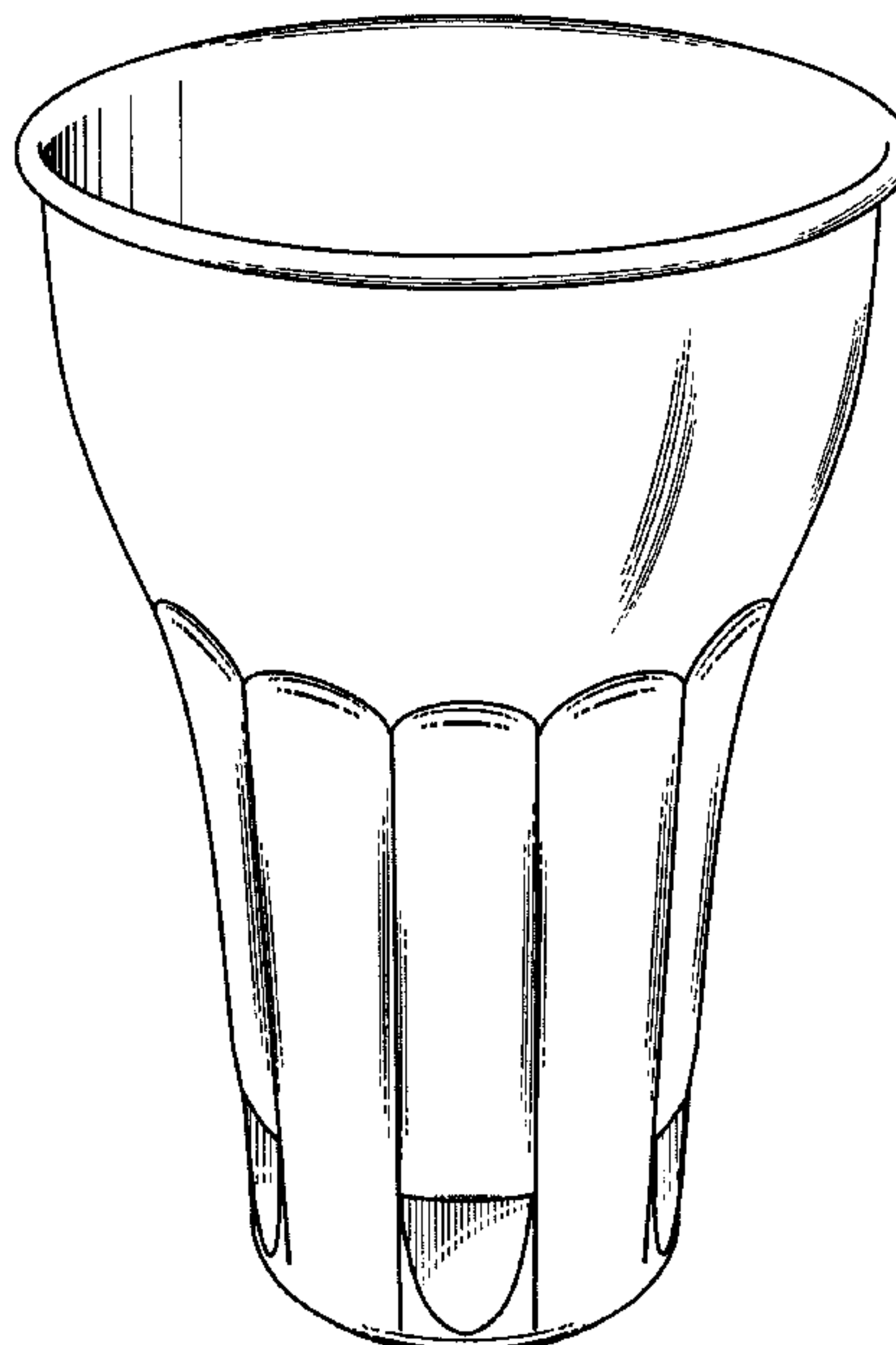

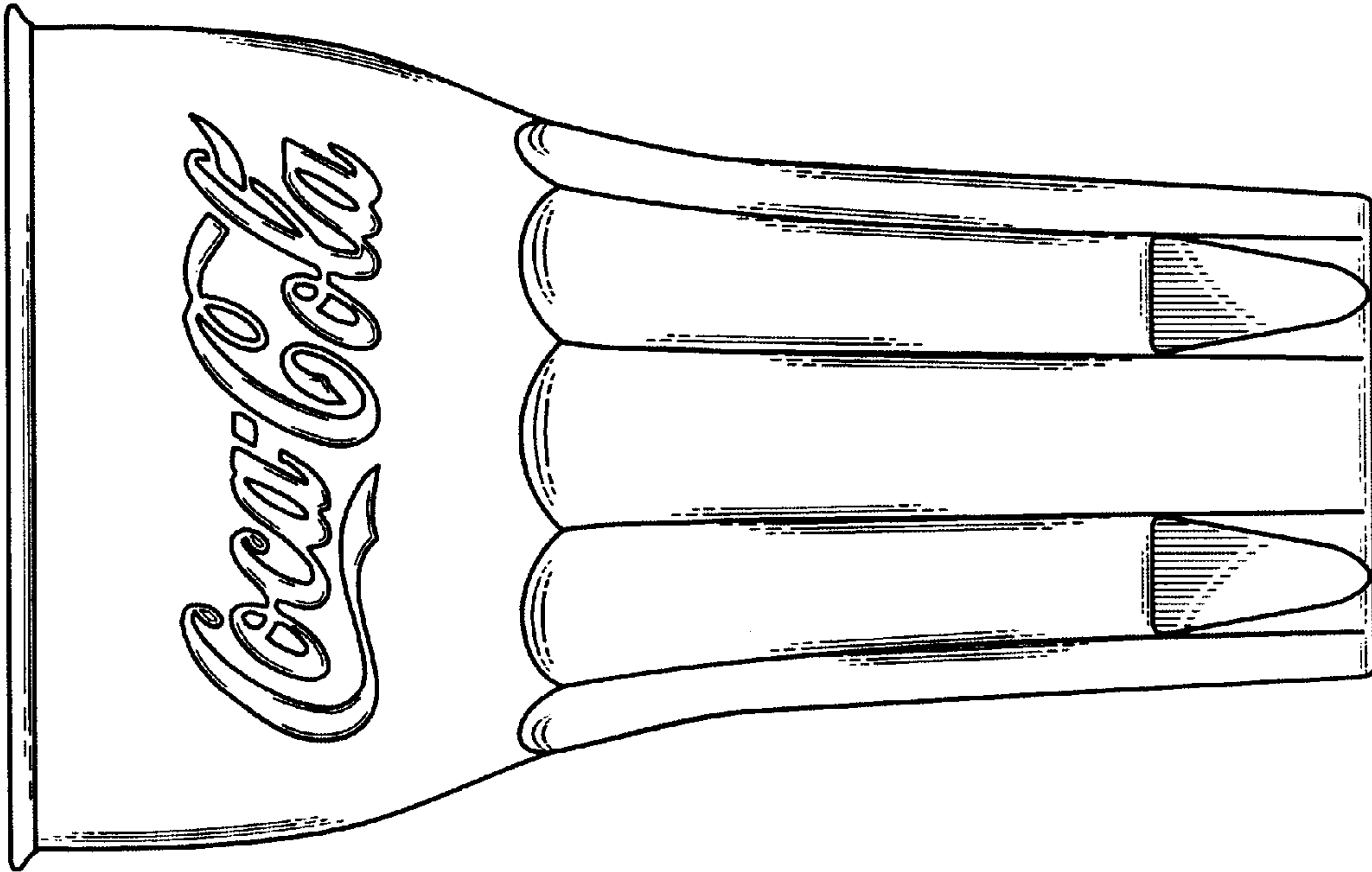

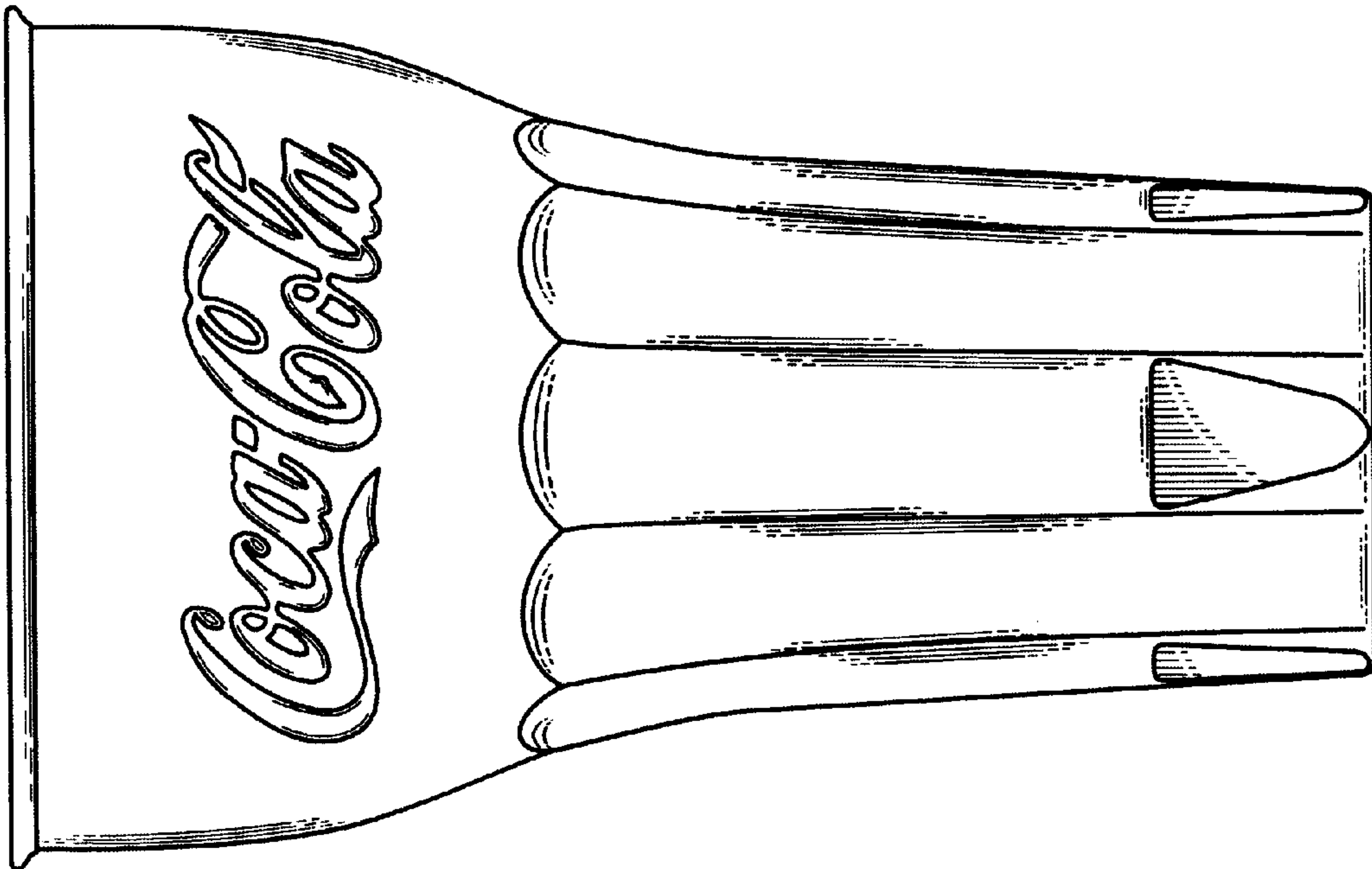

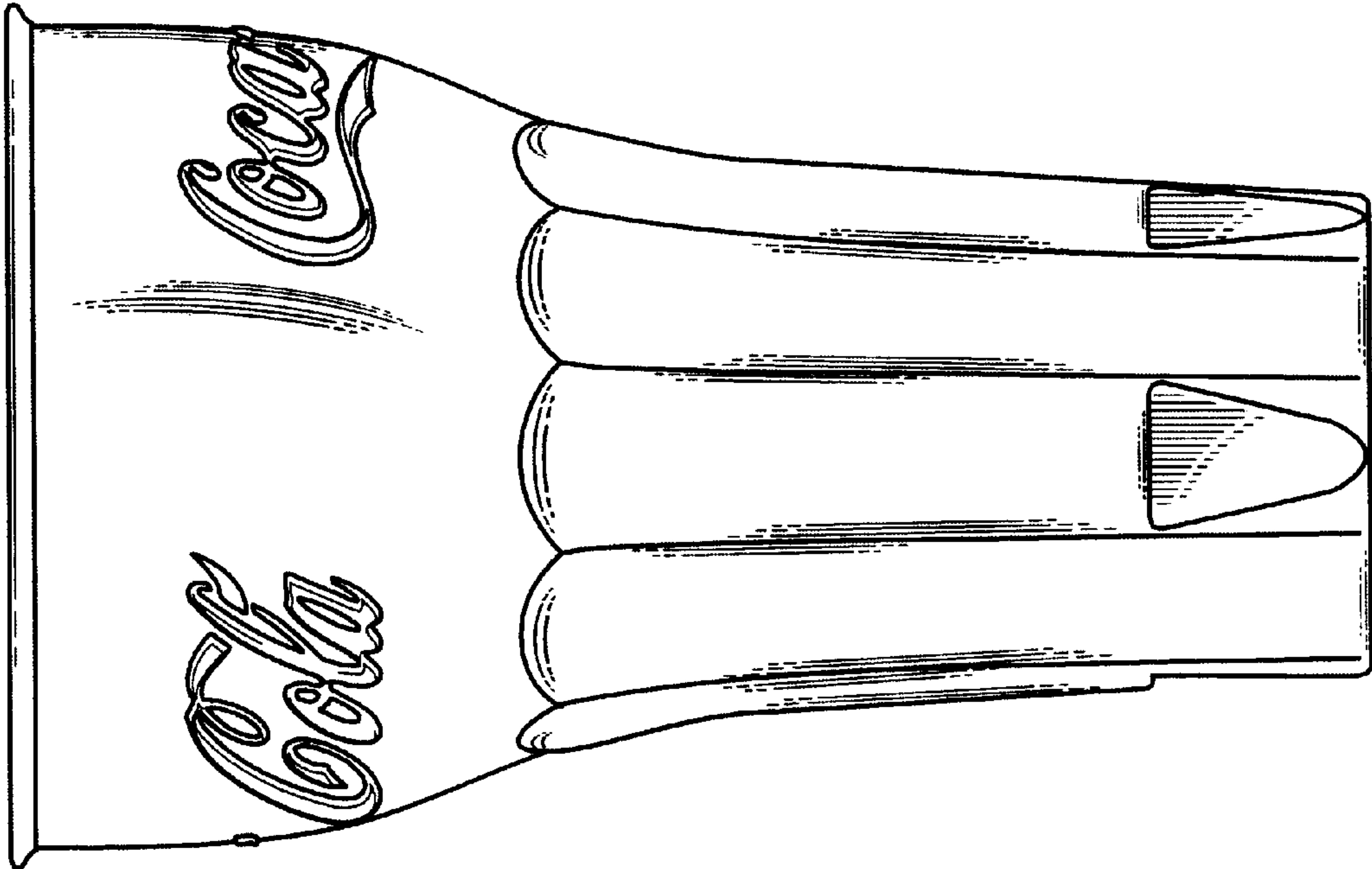

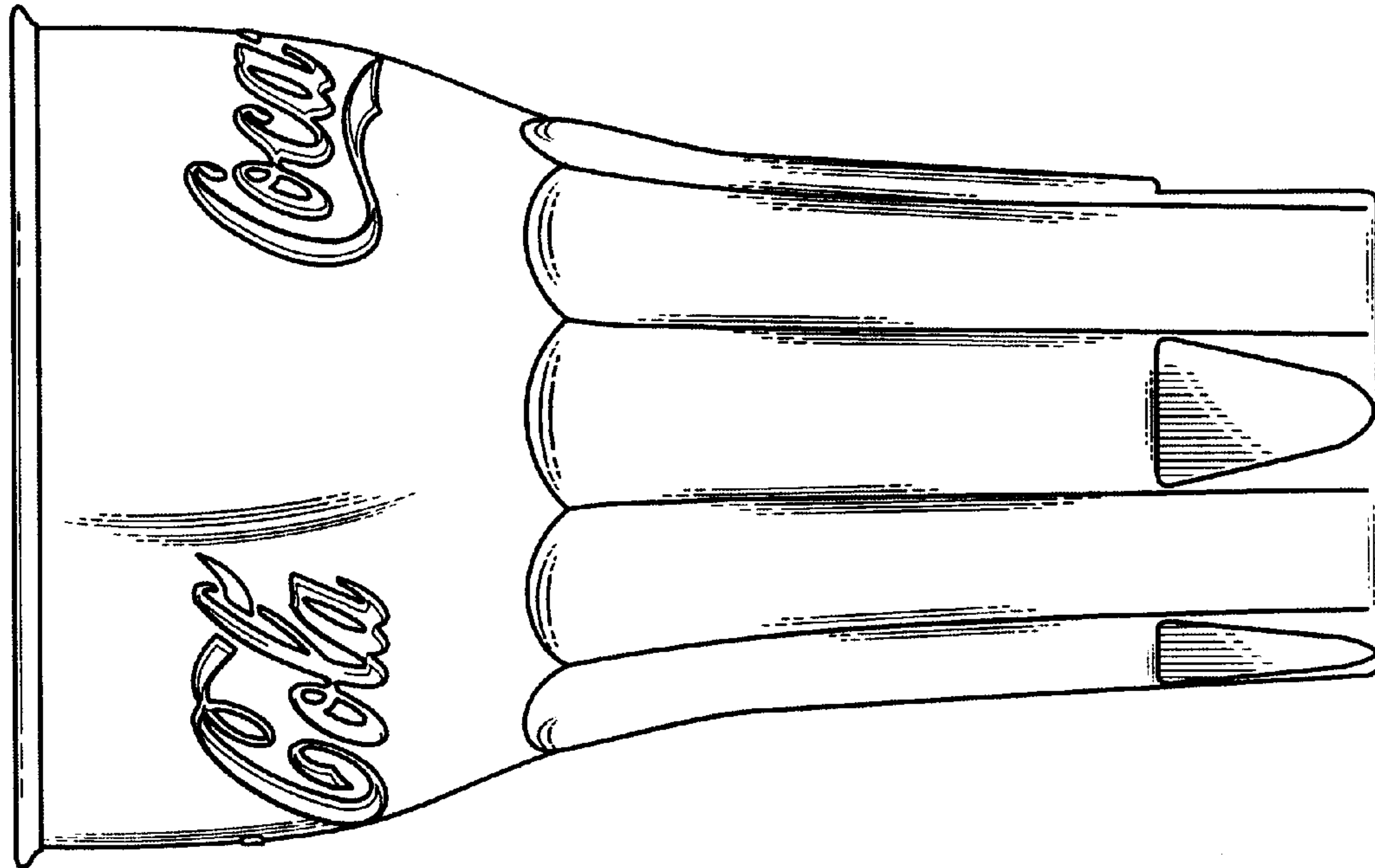

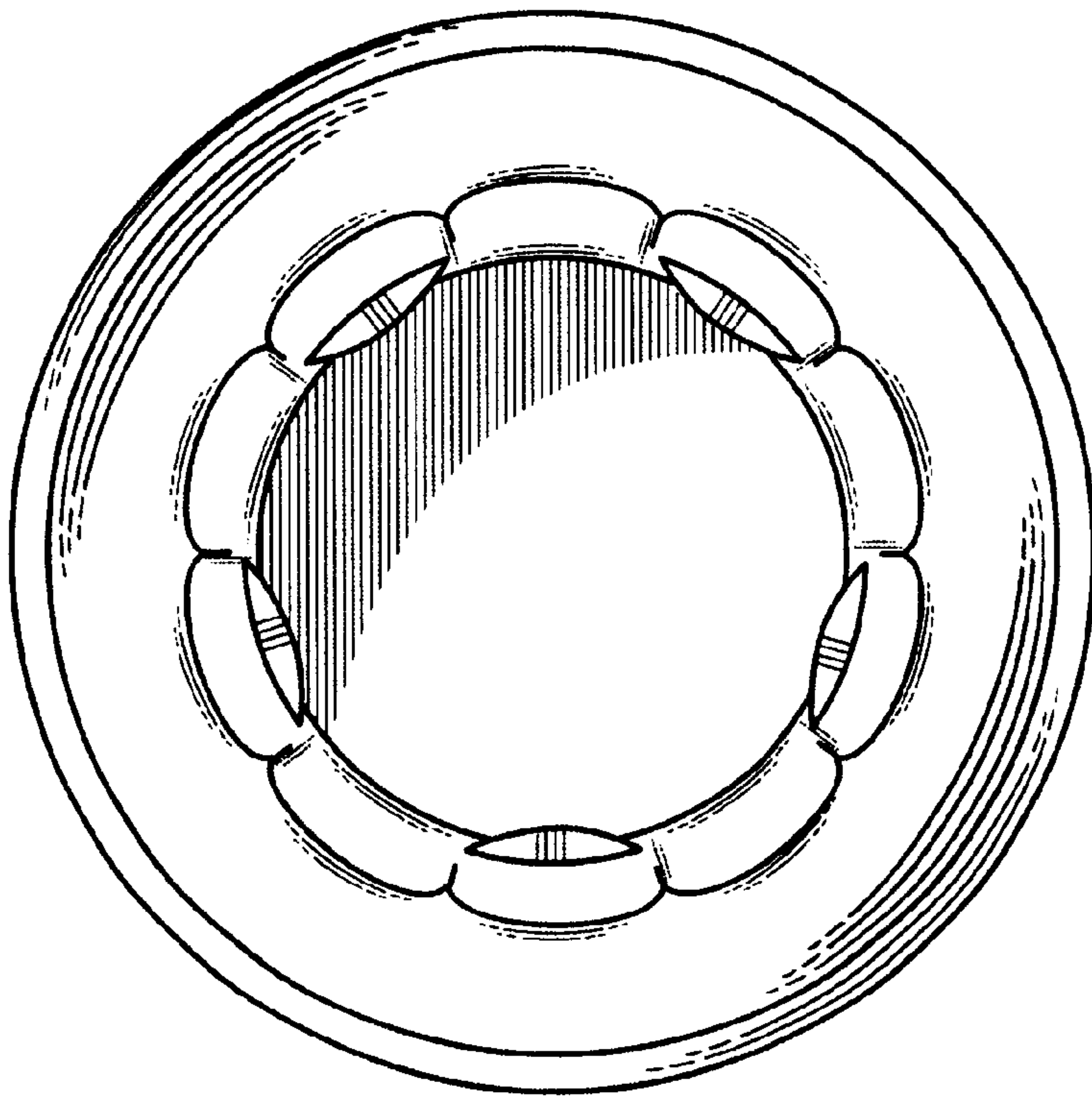

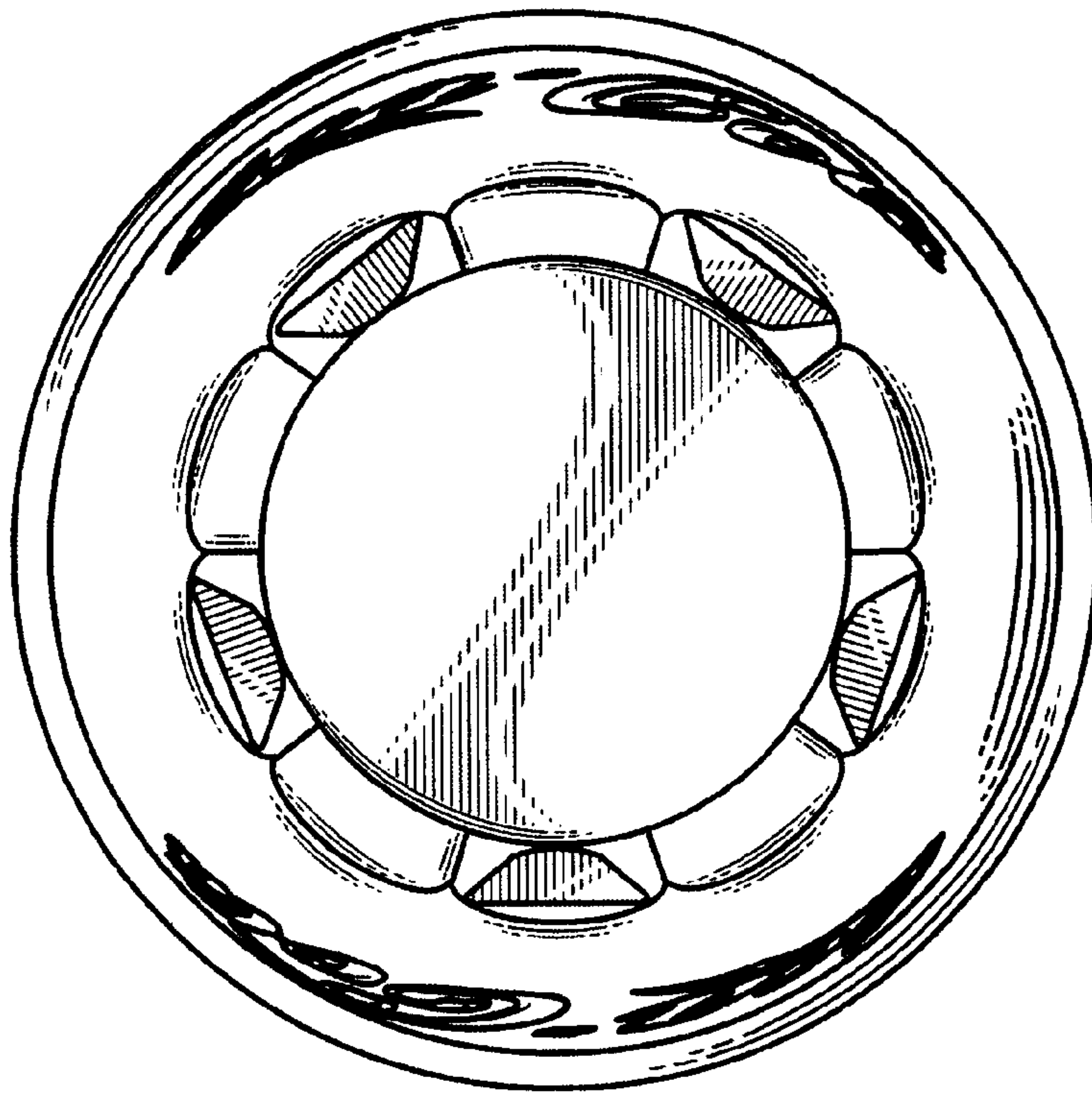

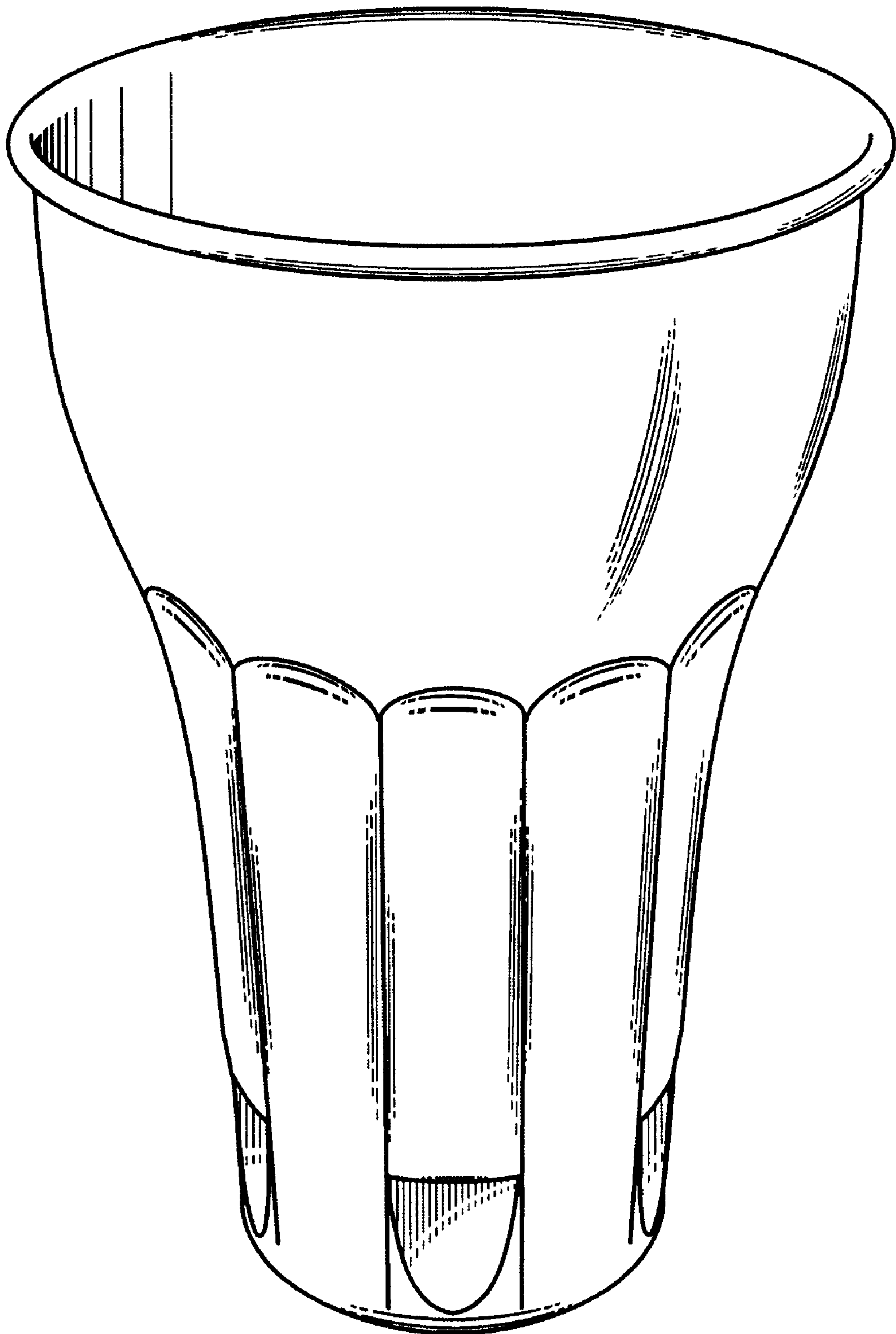

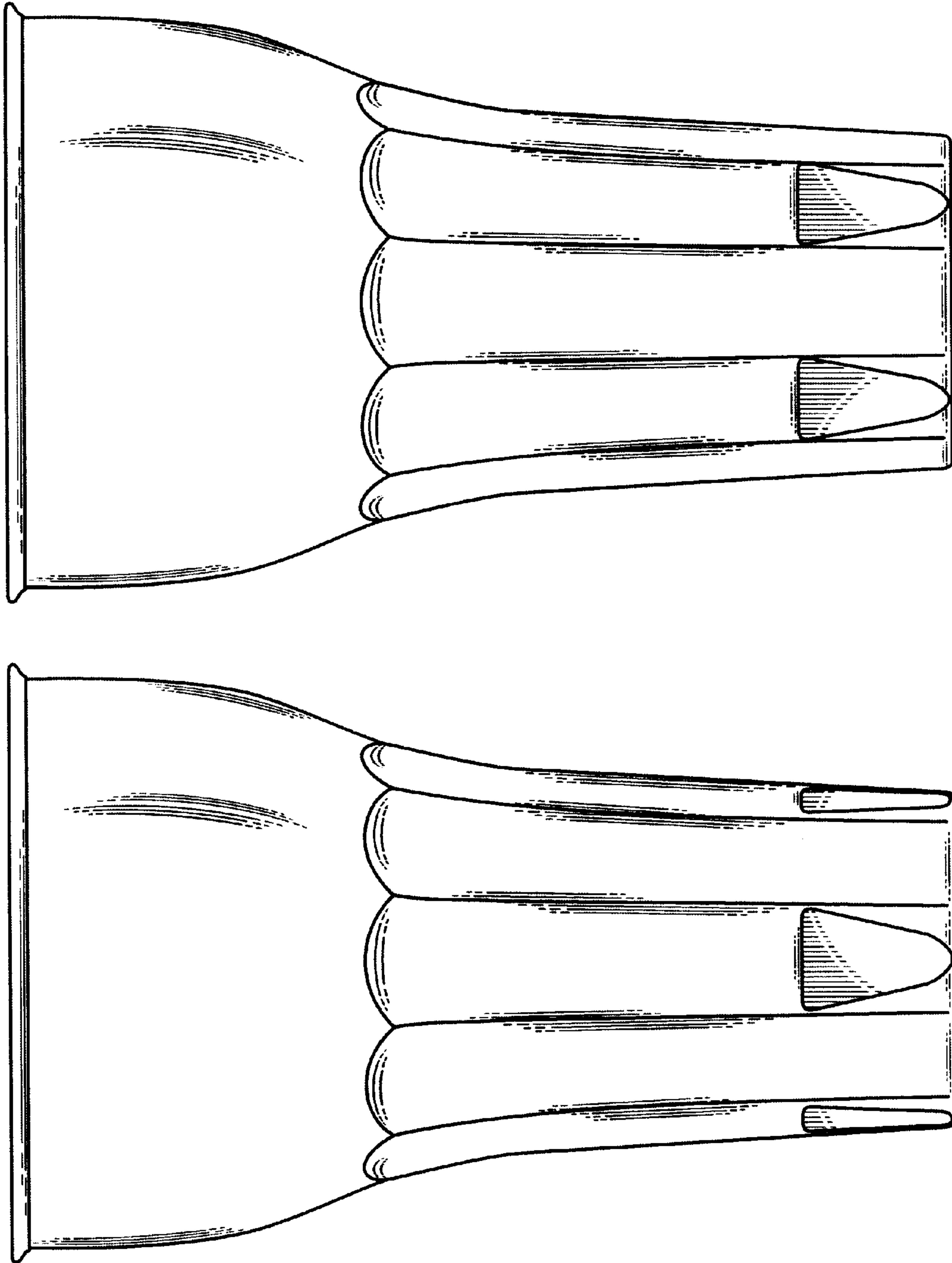

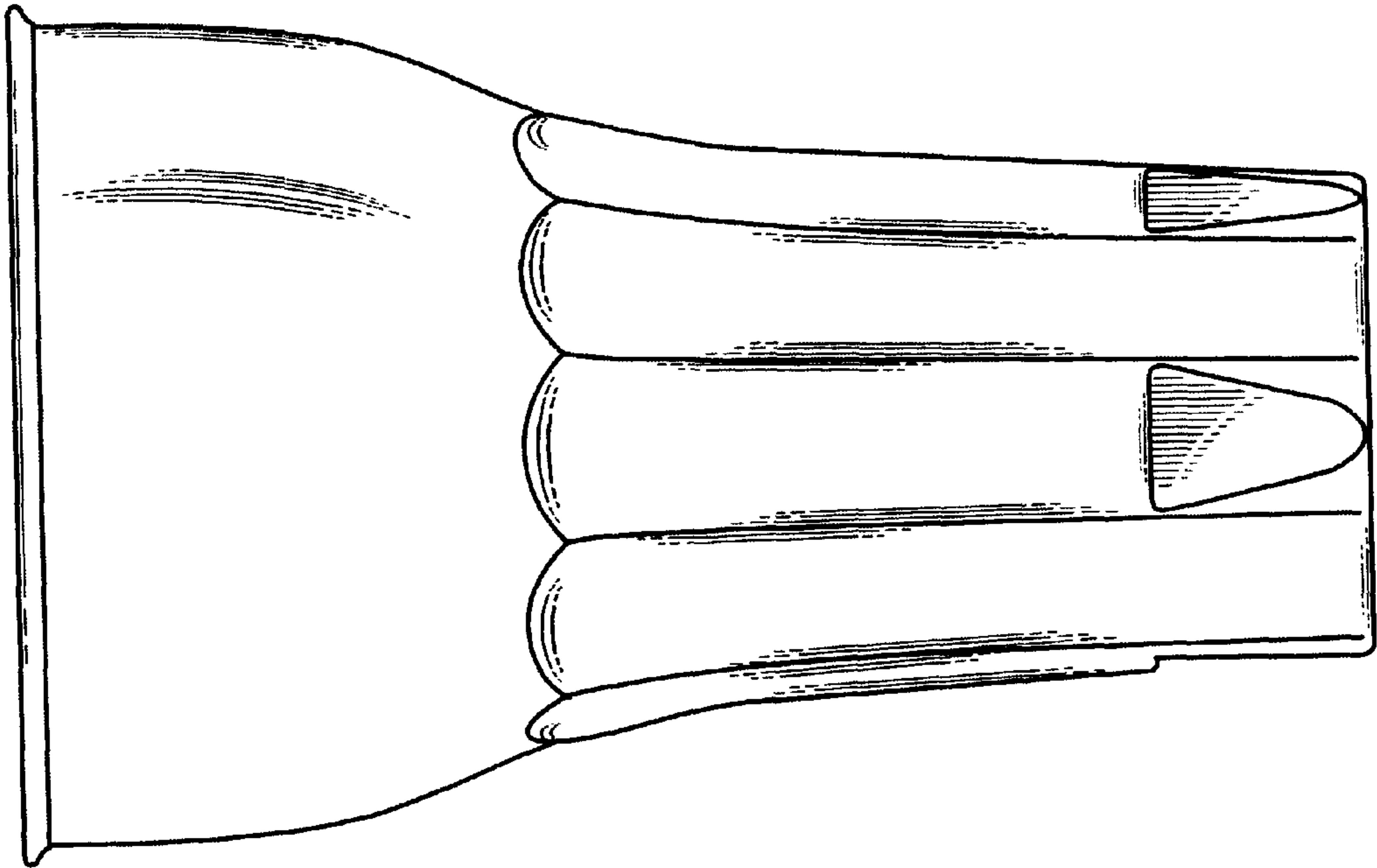

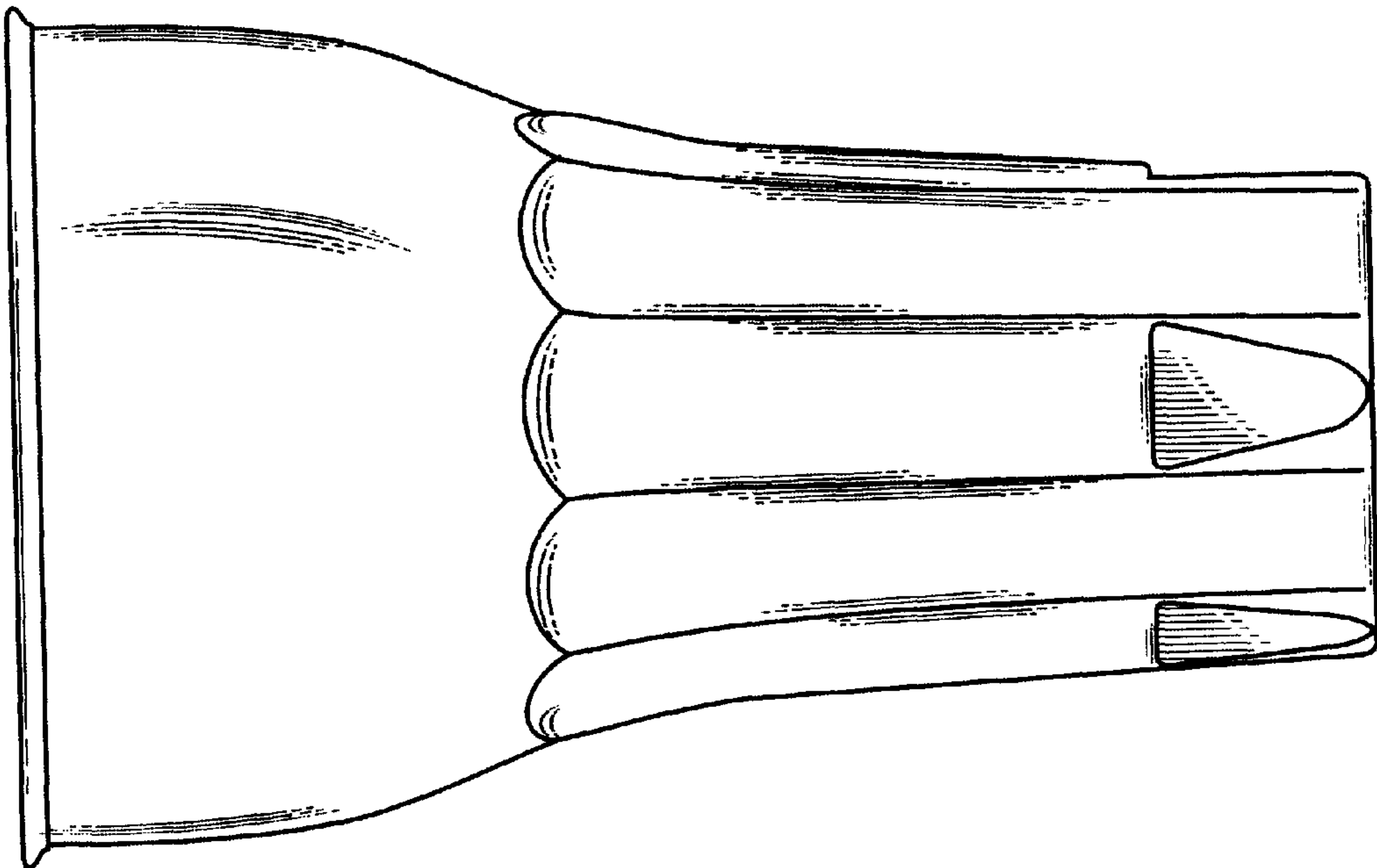

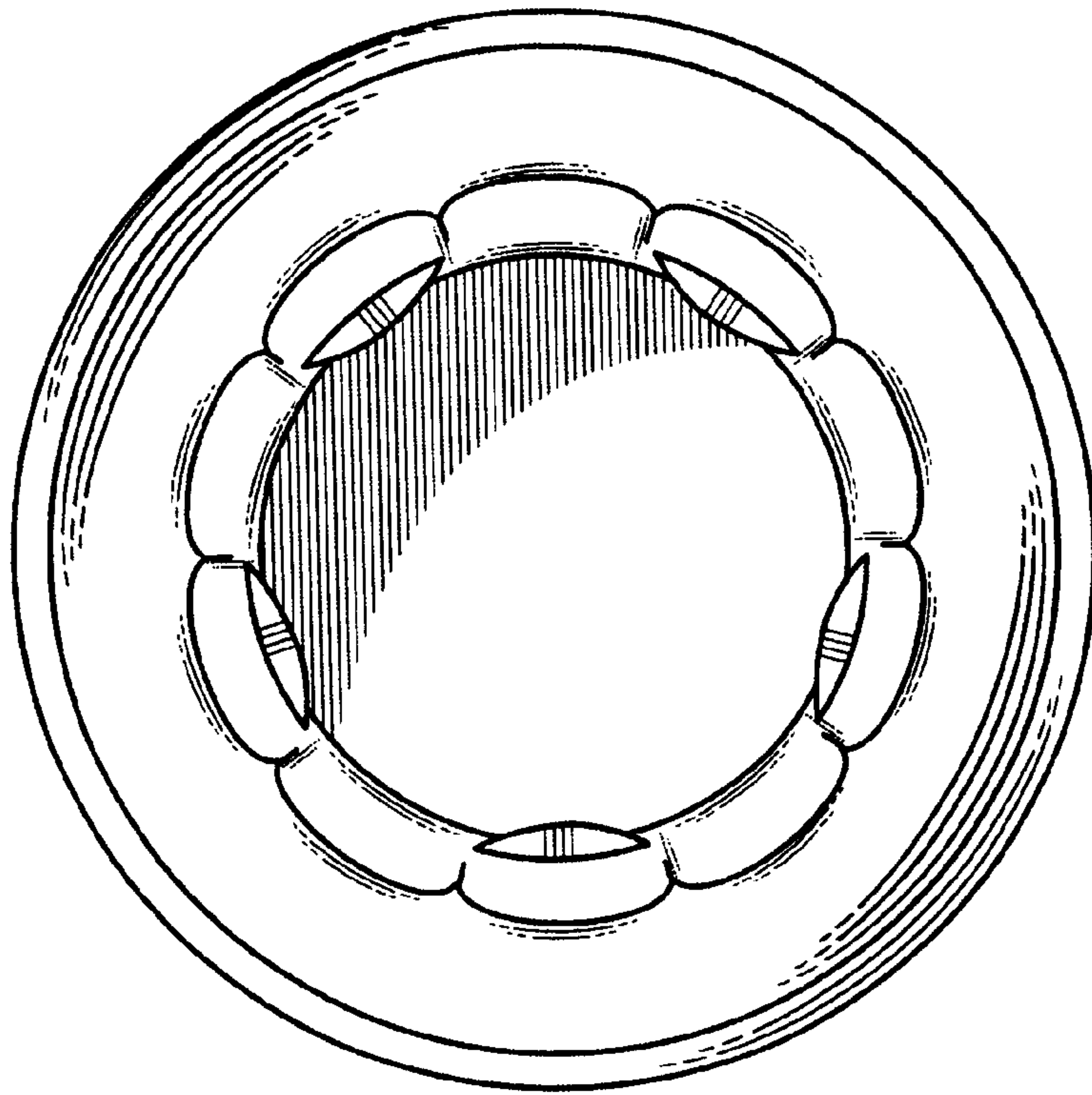

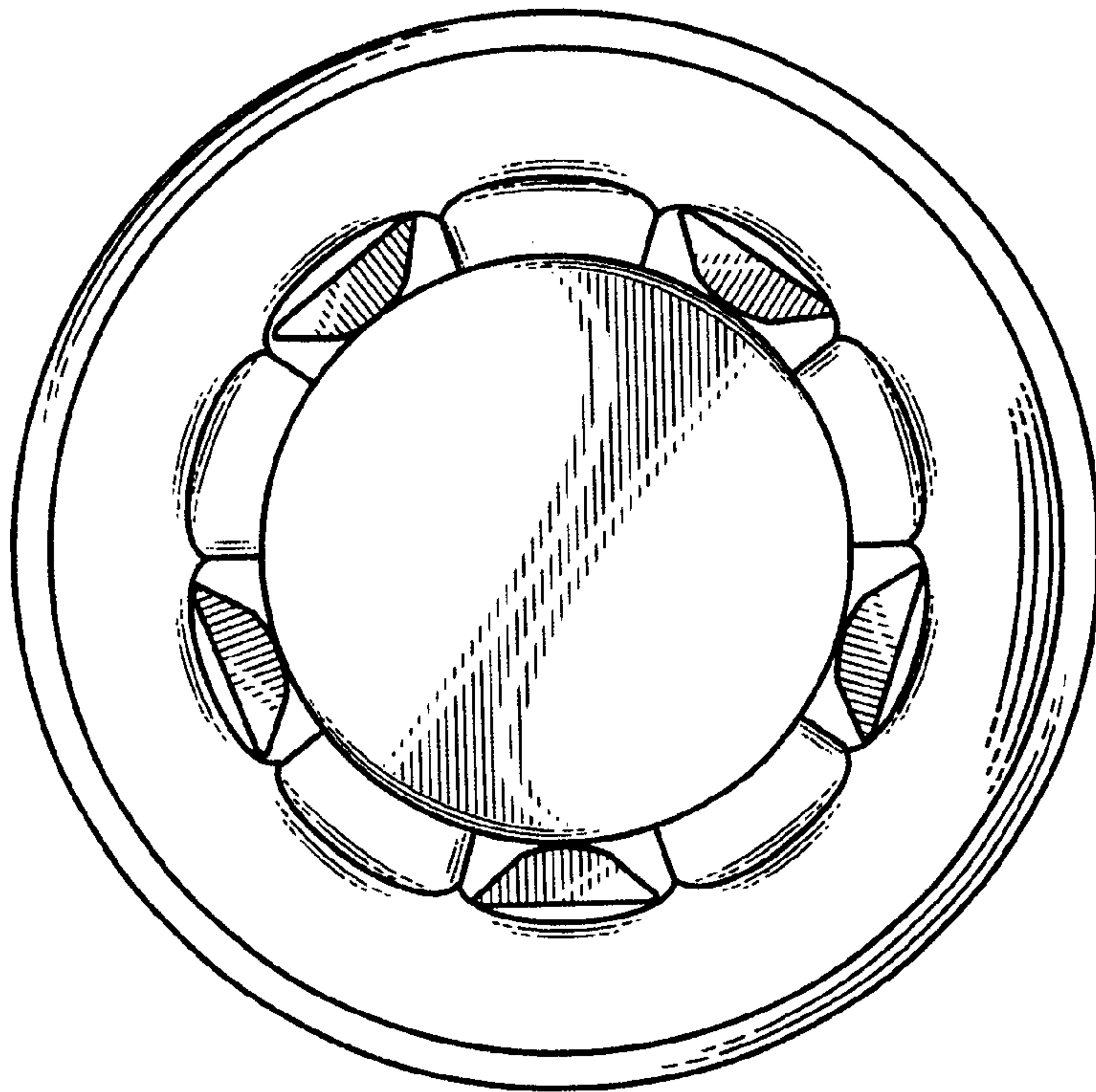
