FIG. 1 is a perspective view of a kit for converting a pair of steel posts with inwardly turned nubbs into a combination pesticide duster and scratcher for livestock showing my new design;

FIG. 3 is an end elevational view thereof, the elevational view of the opposing end being substantially identical thereto;

FIG. 4 is a top plan view thereof;

FIG. 5 is a bottom plan view thereof; and,

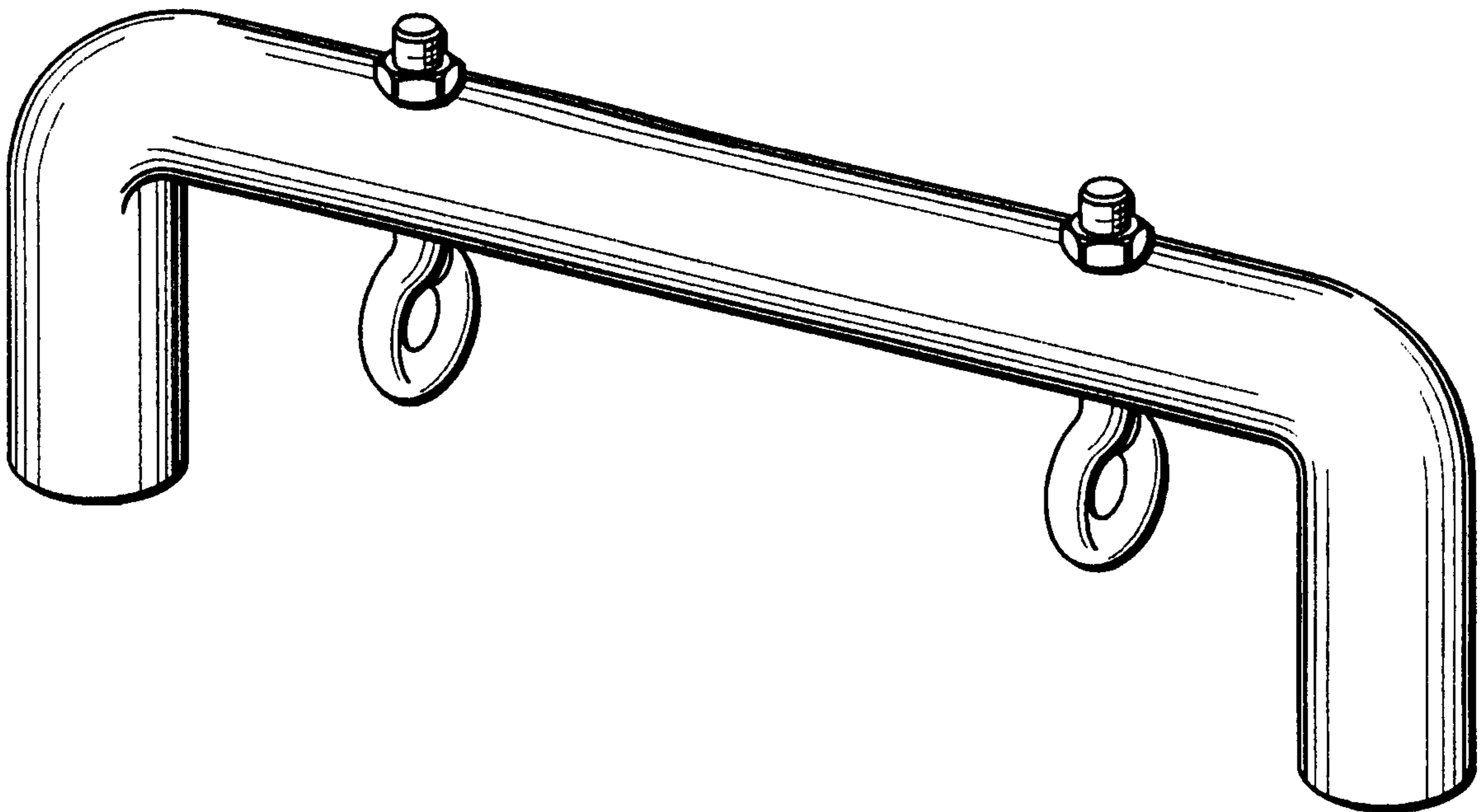

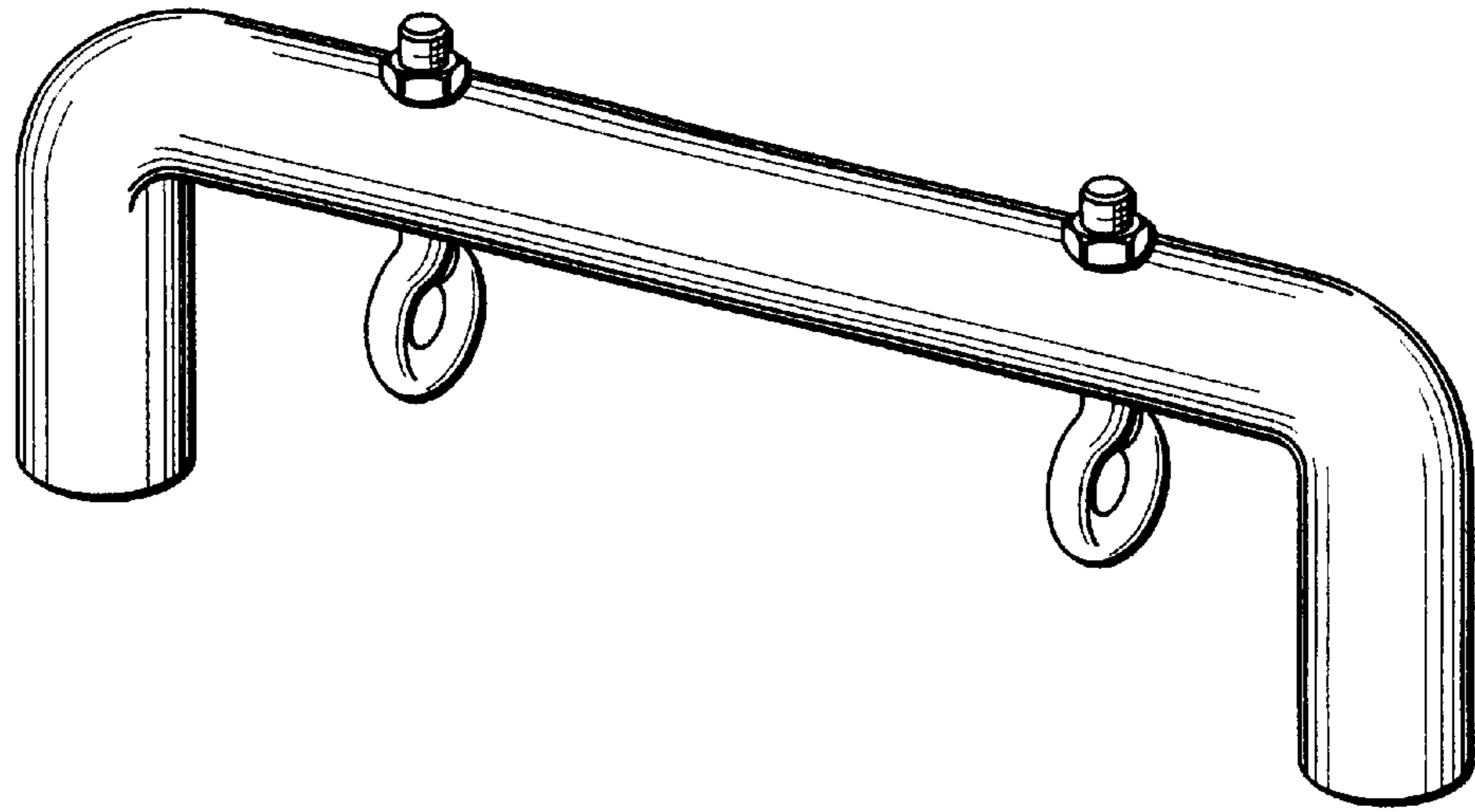

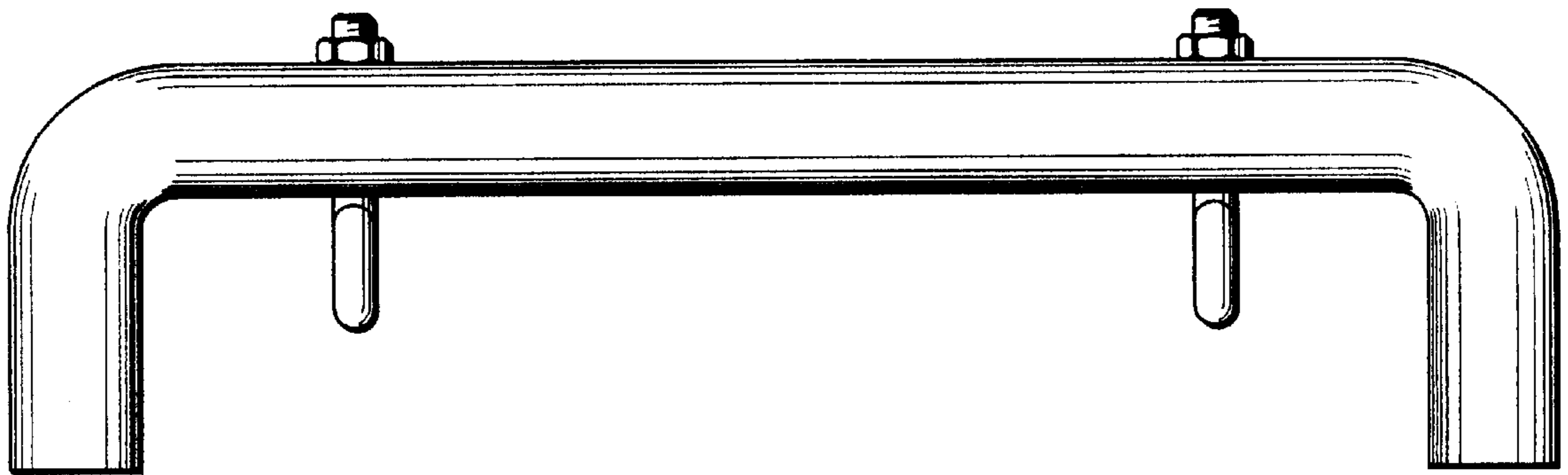

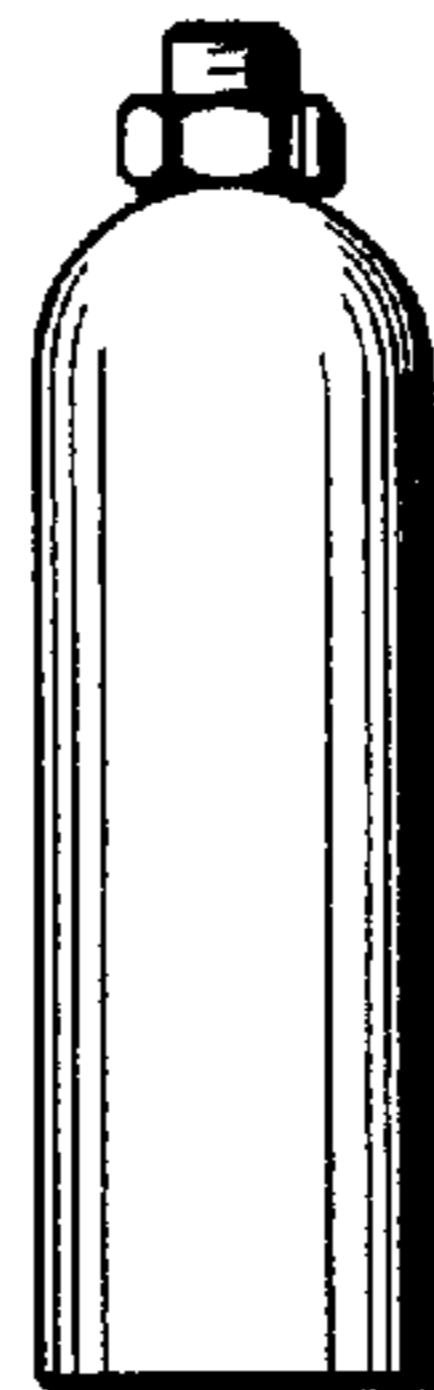

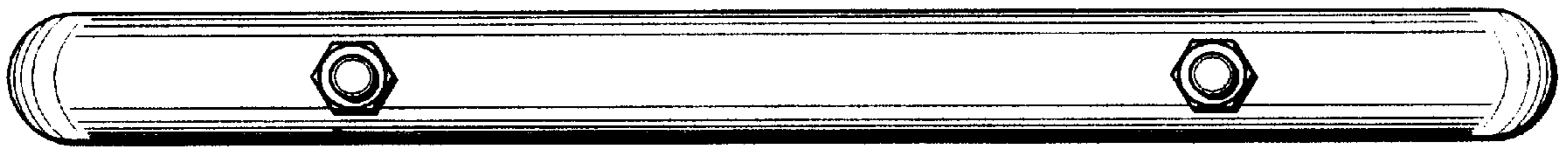

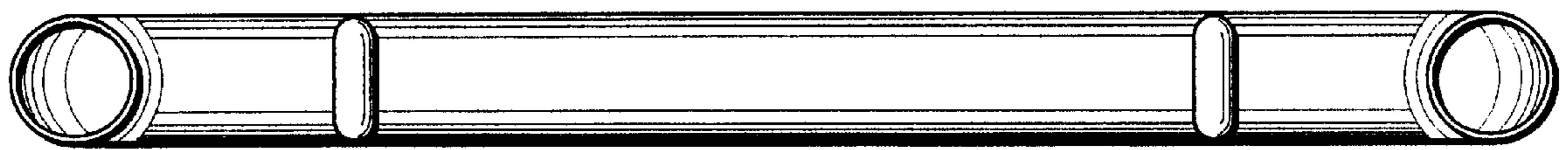

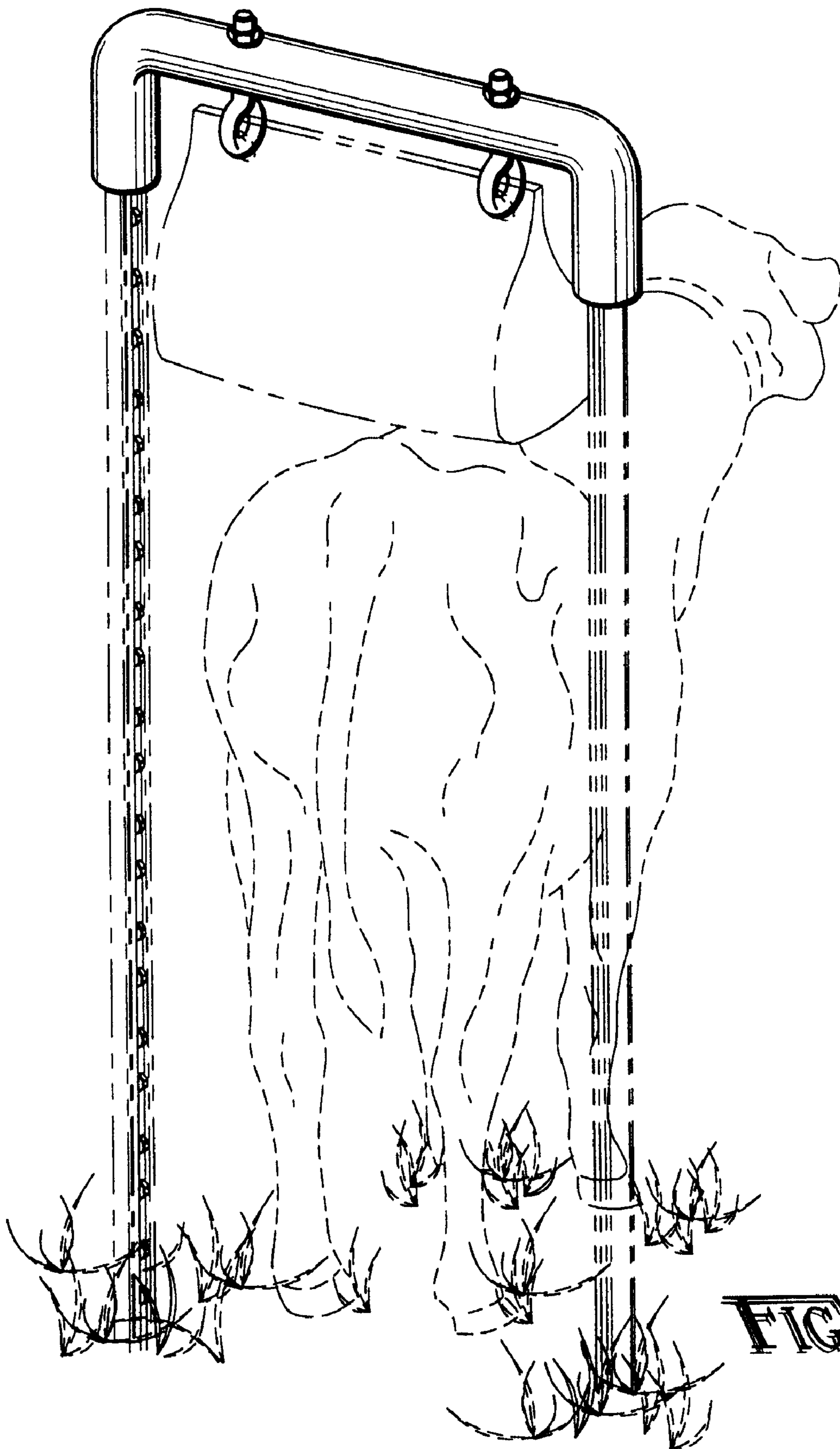
