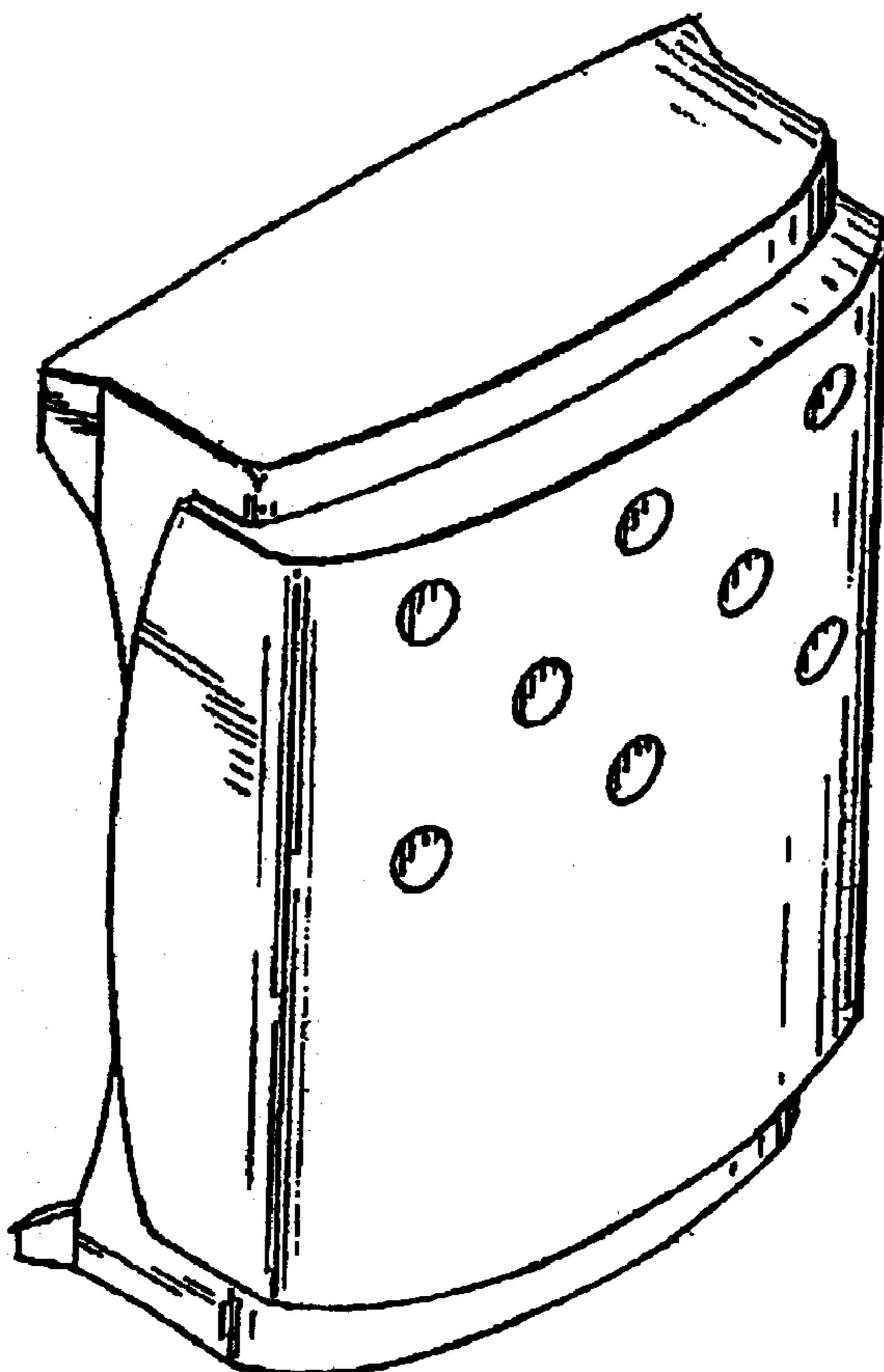
(57) **CLAIM**

The ornamental design for a packaging container for a lighter, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a packaging container for a lighter in the closed position showing our new design; FIG. 2 is a front elevational view thereof; FIG. 3 is a left side elevational view thereof, the right side elevational view being a mirror image thereof; FIG. 4 is a top plan view thereof, the bottom plan view being identical to the top plan view; FIG. 5 is a rear elevational view thereof; and, FIG. 6 is a perspective view thereof, shown open.

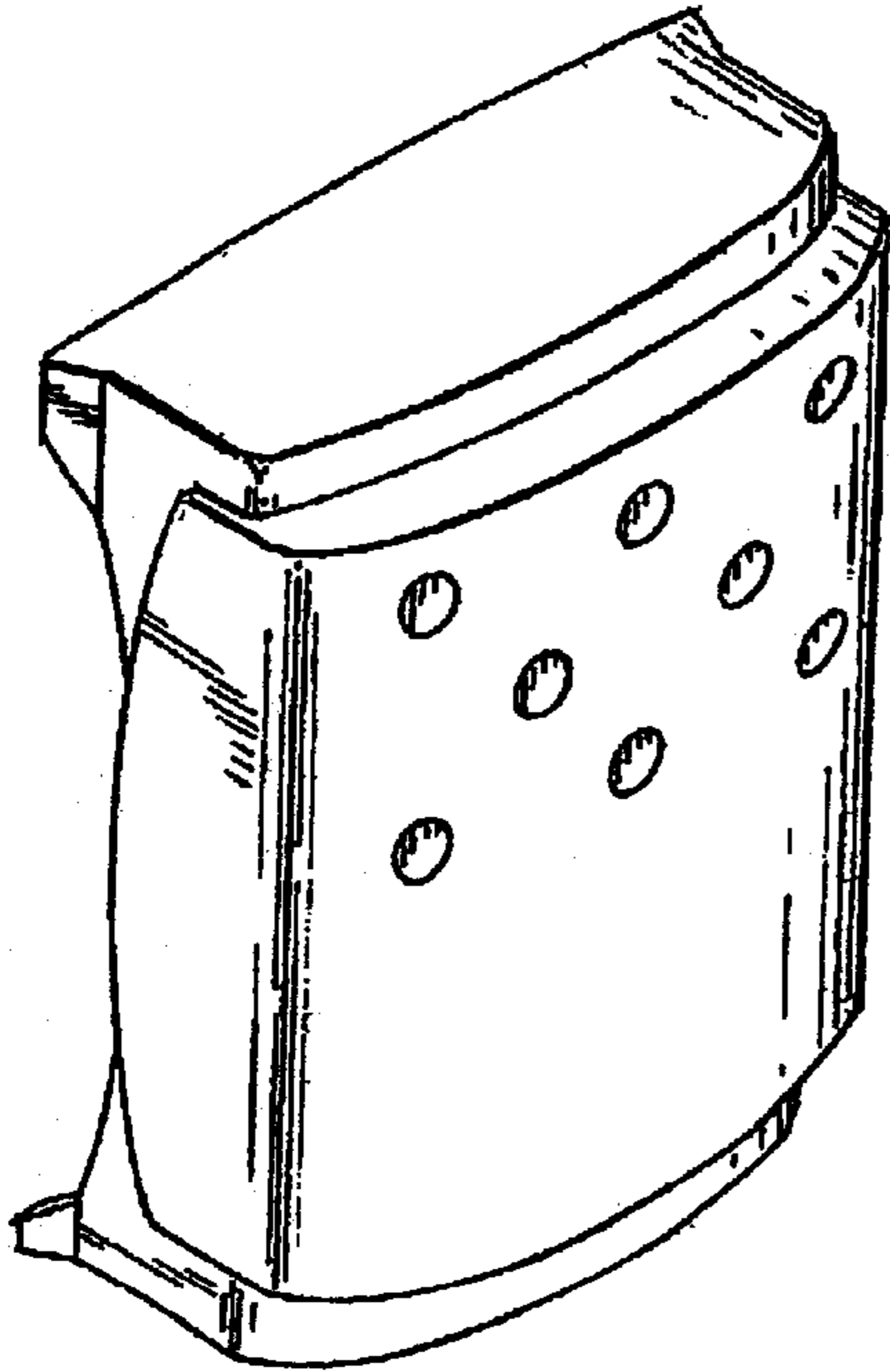

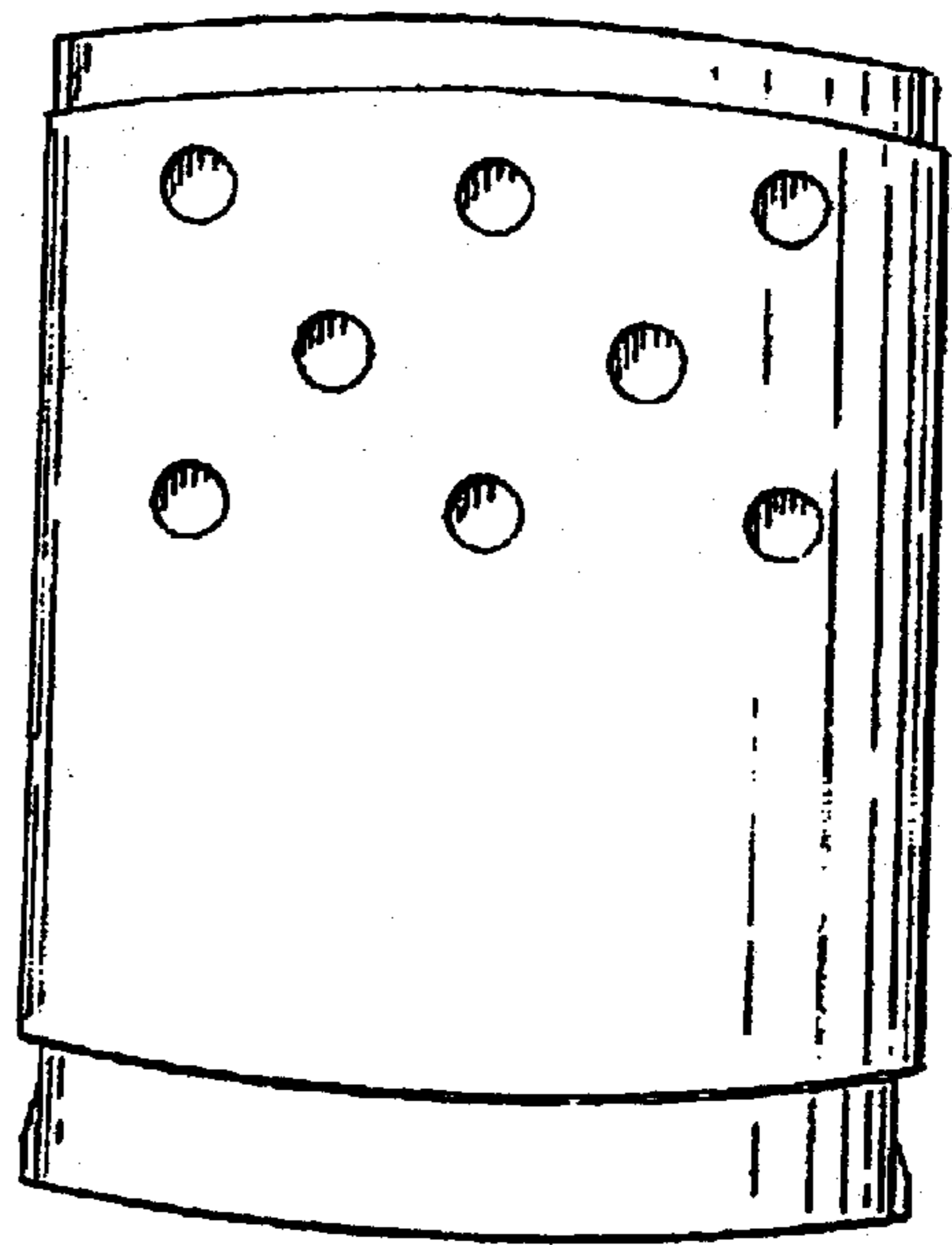

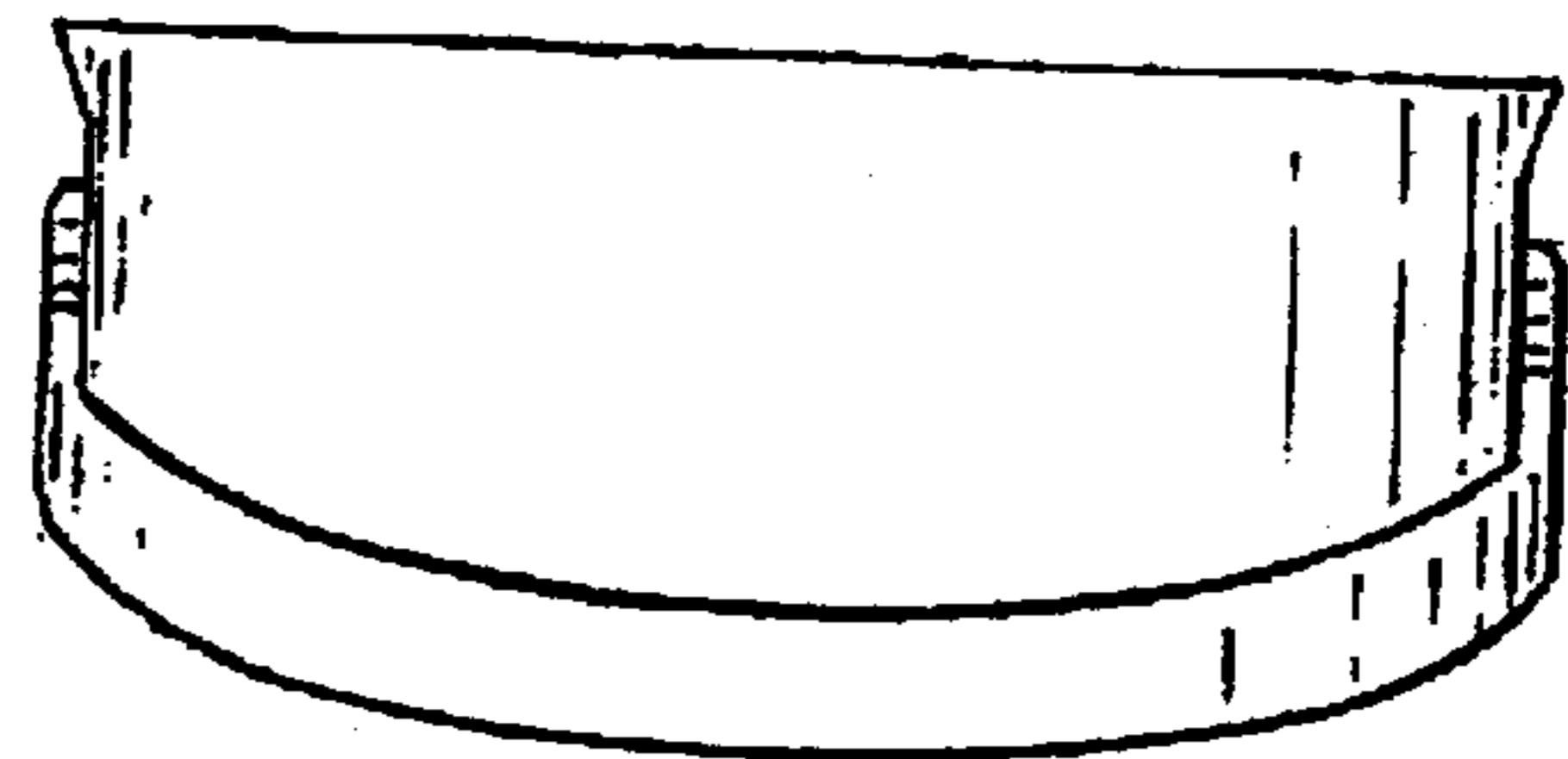
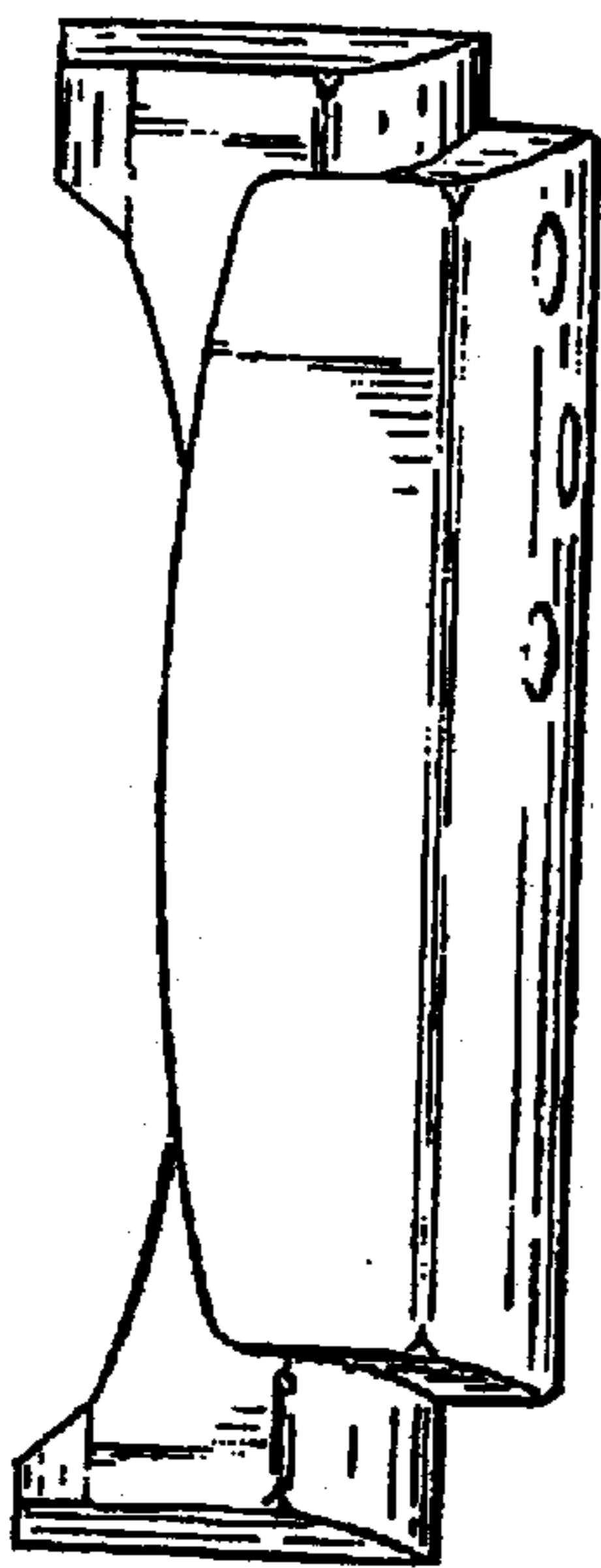

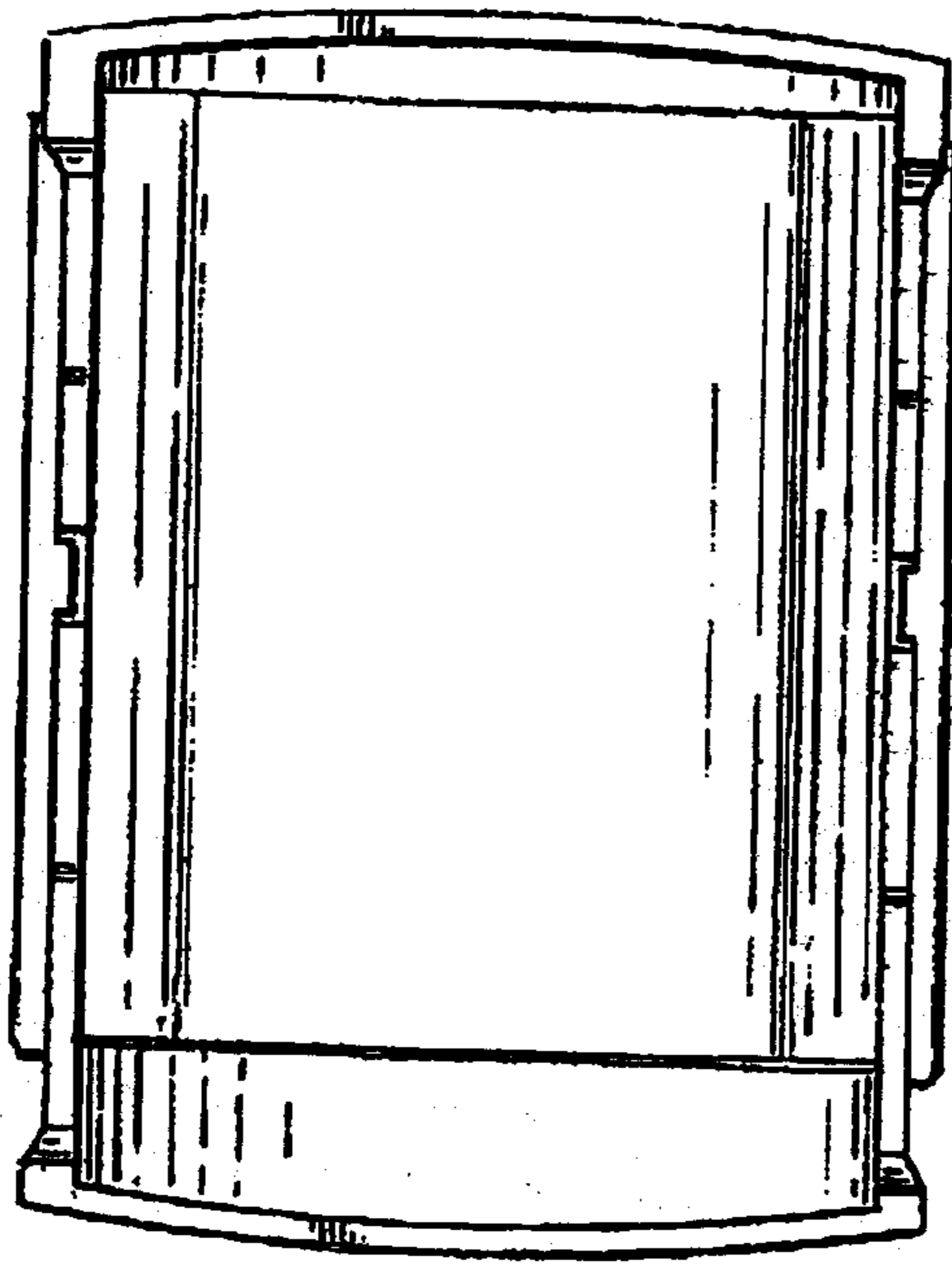

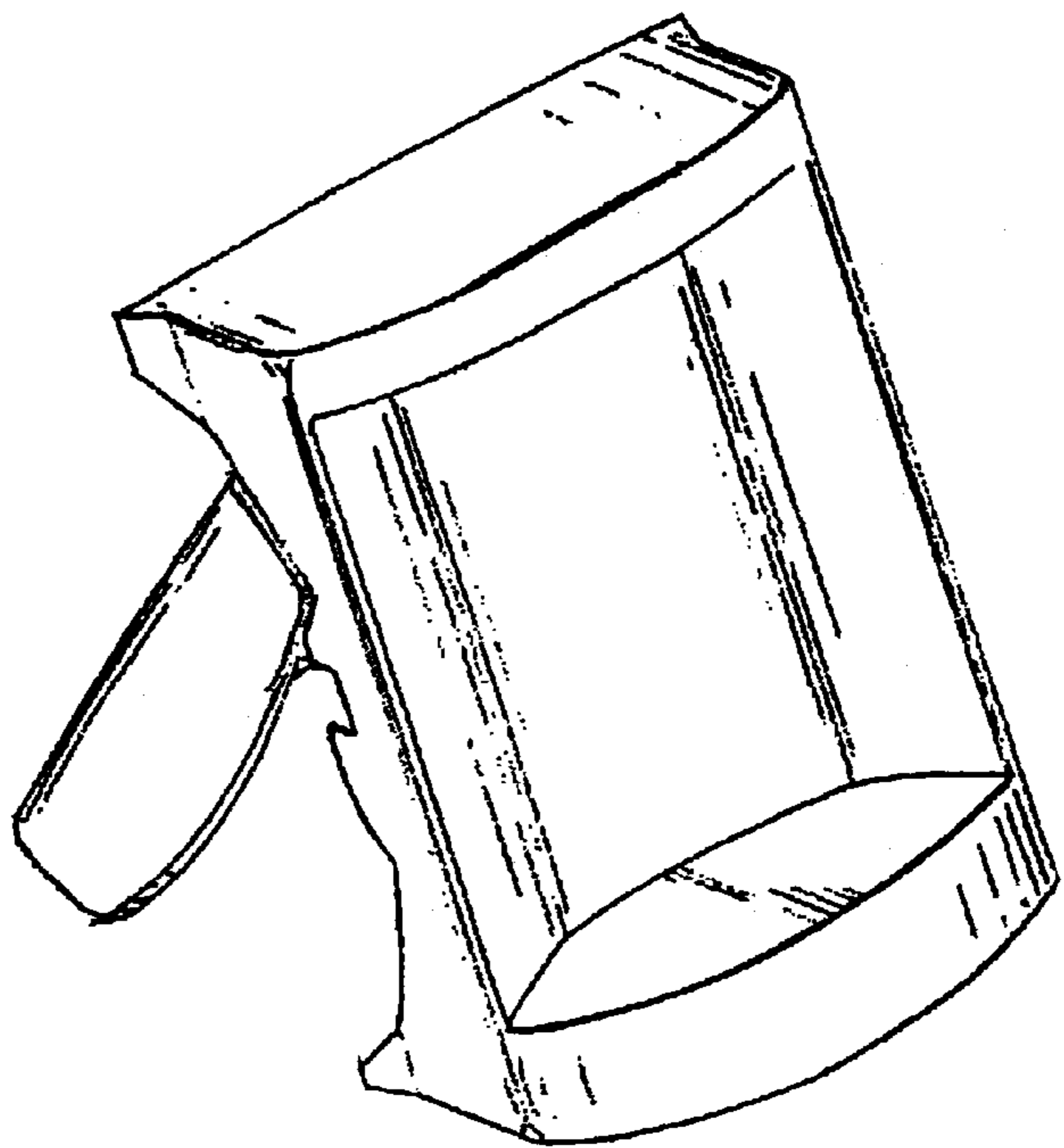
