FIG. 8 is an enlarged perspective view of the necklace viewed from the bottom; and,

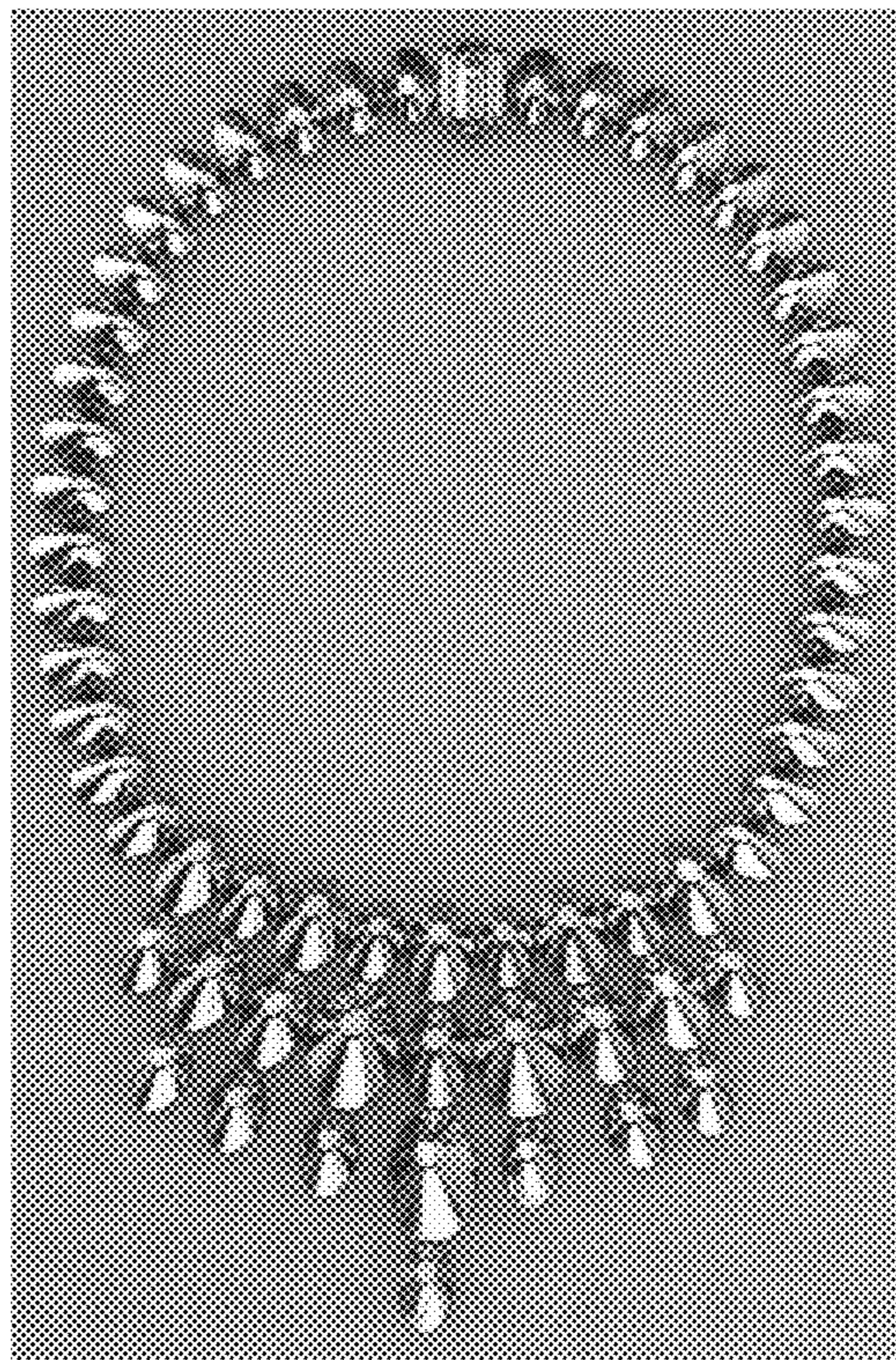
FIG. 9 is a perspective view of the necklace viewed from the lower right.

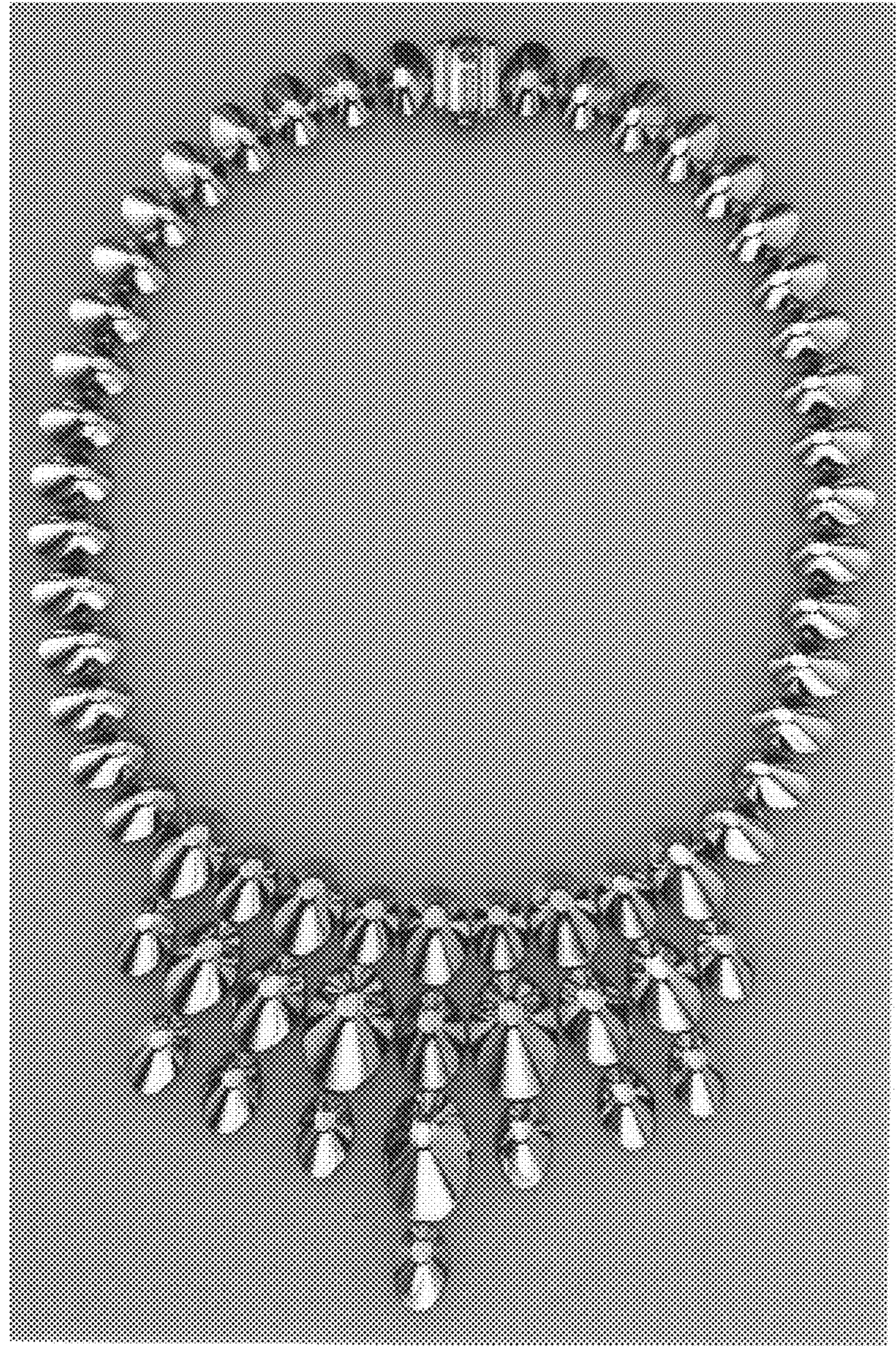

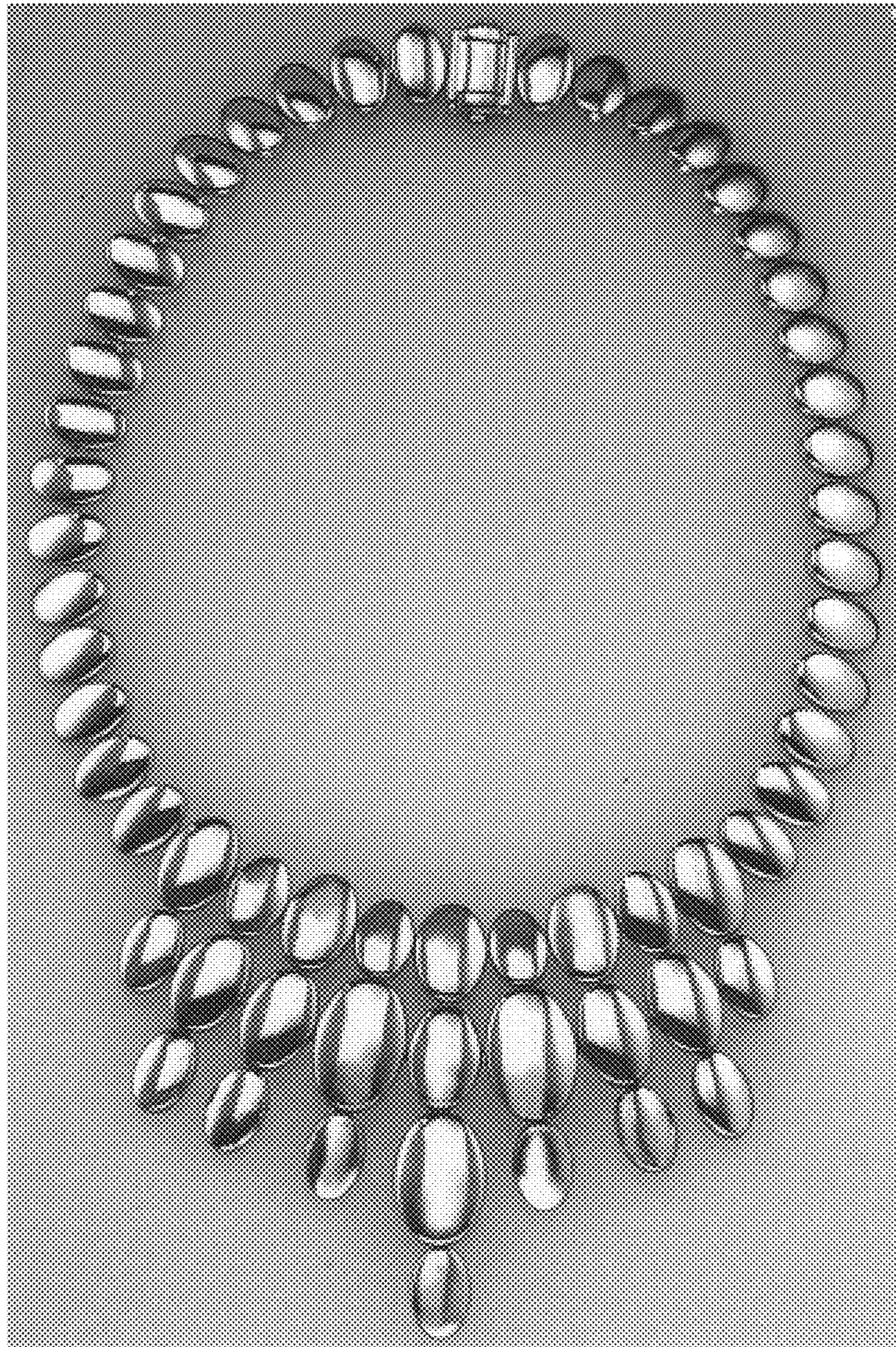

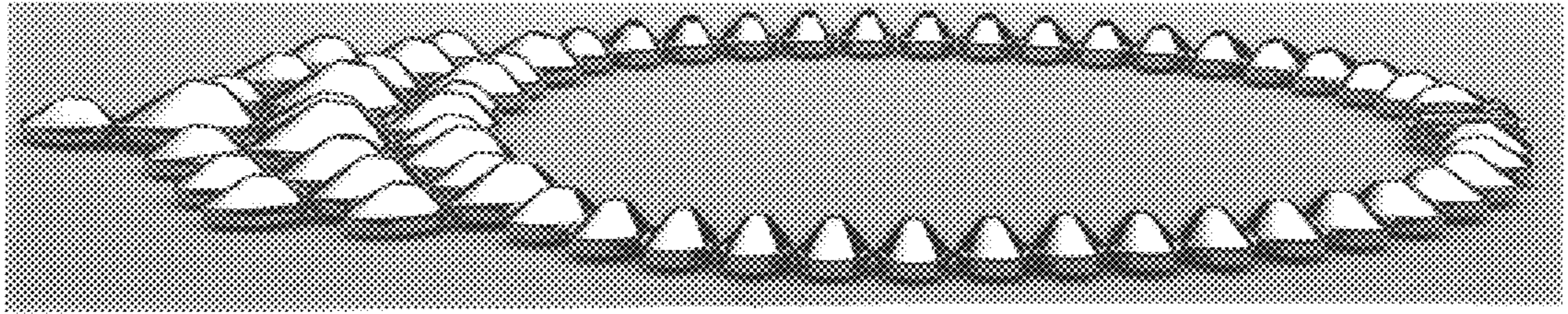

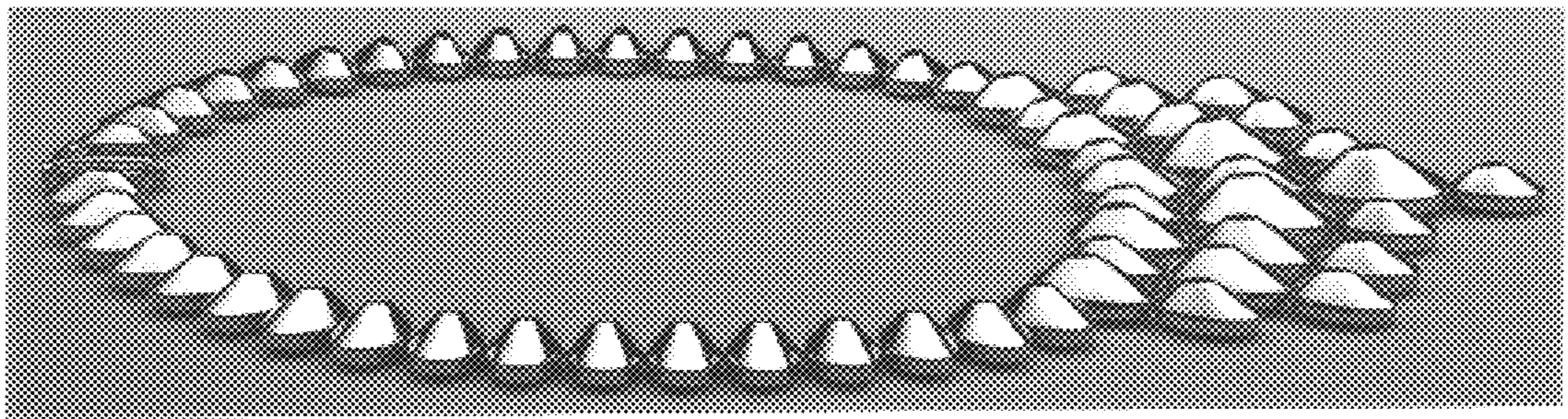

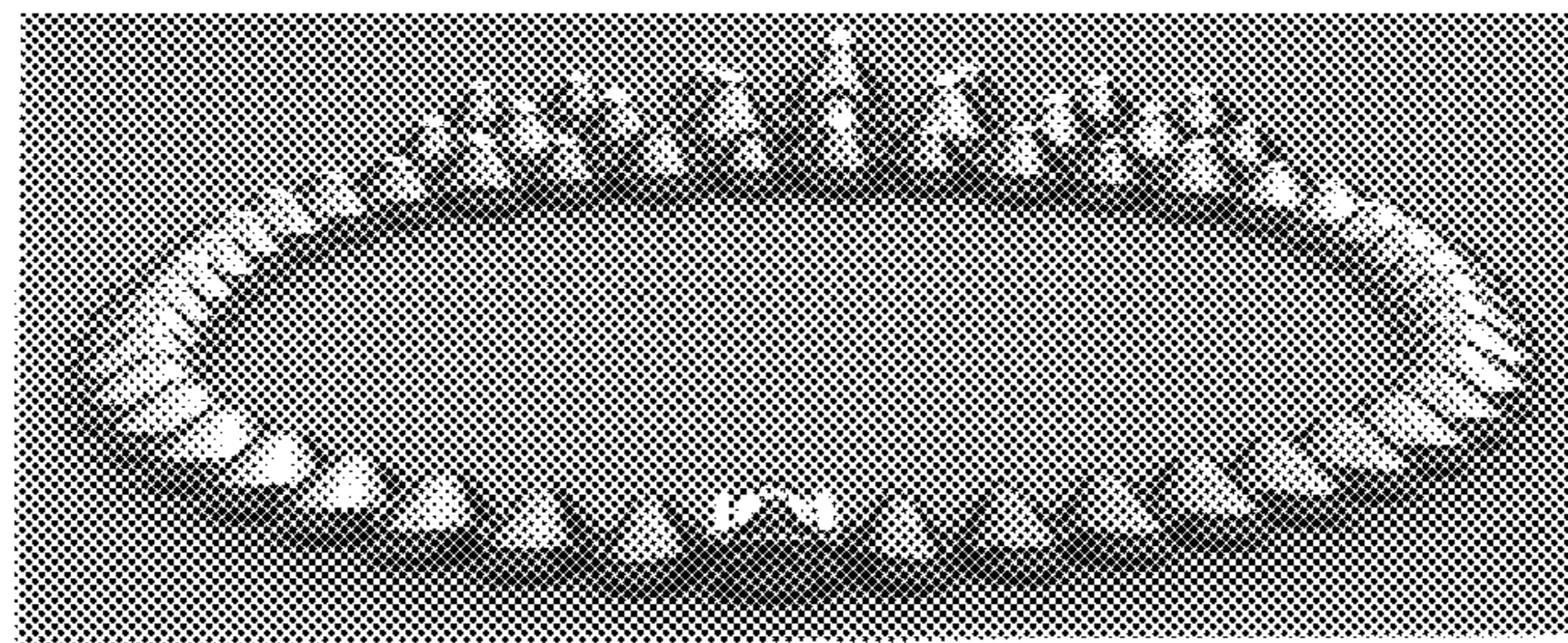

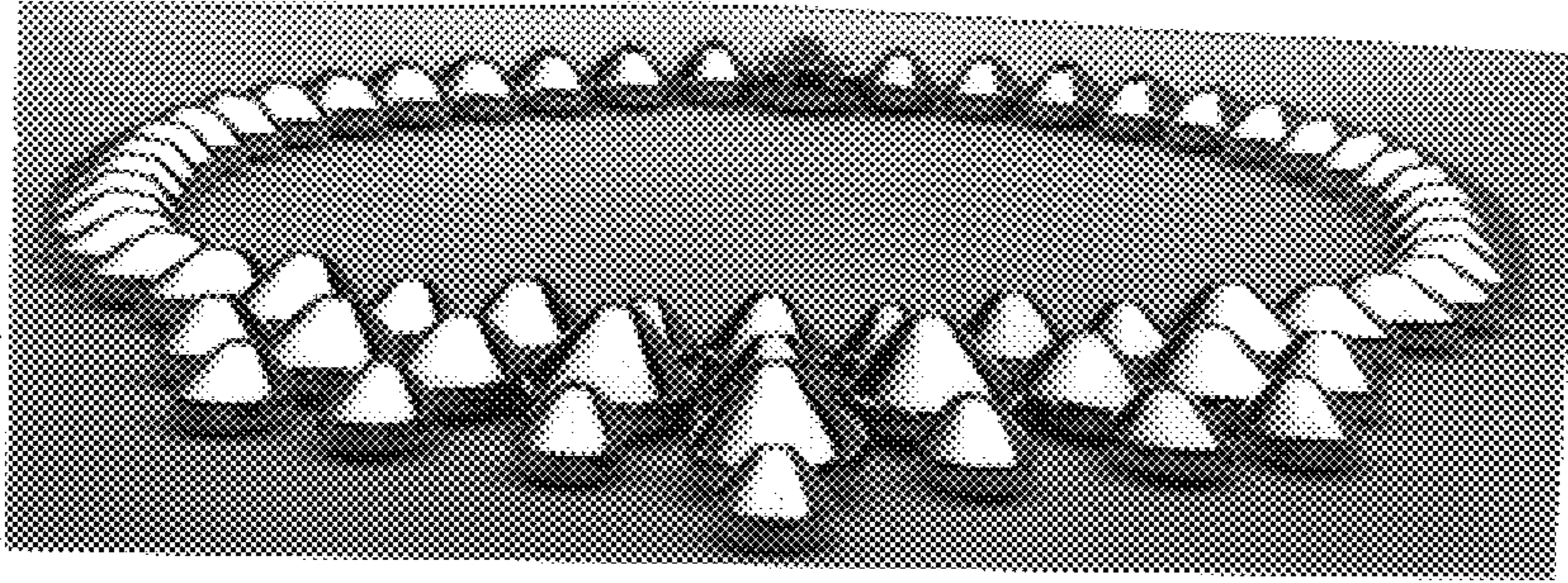

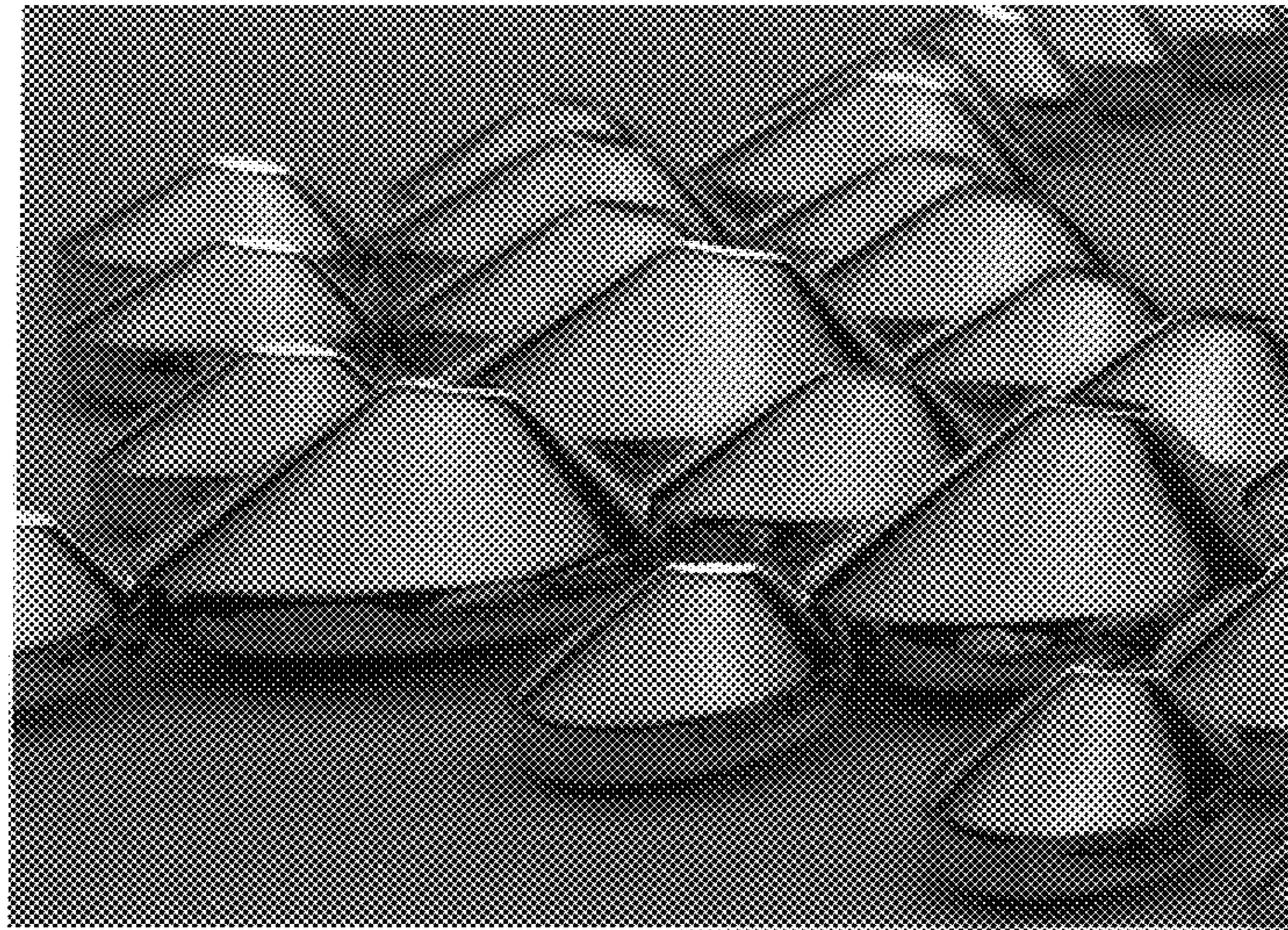

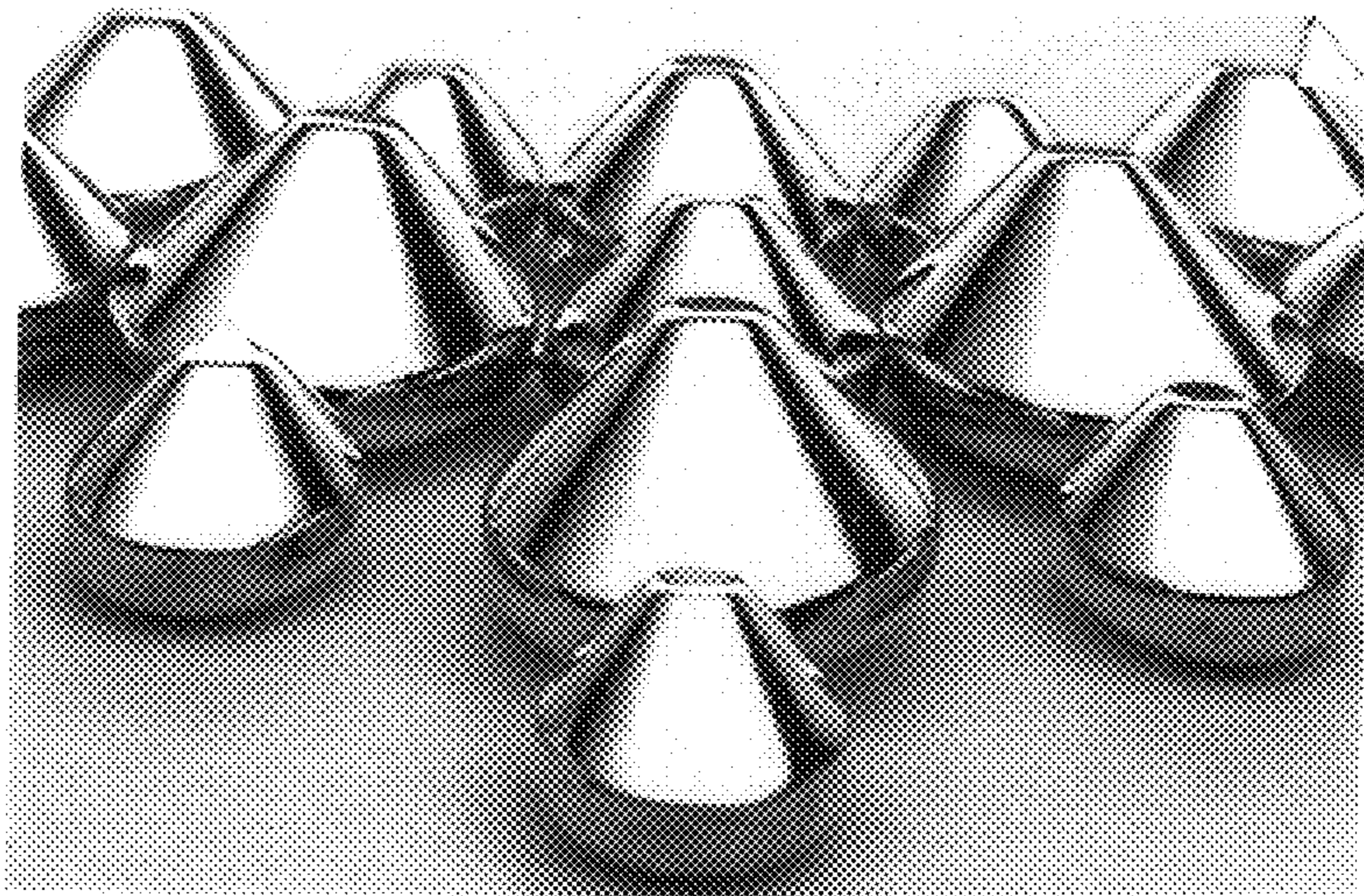

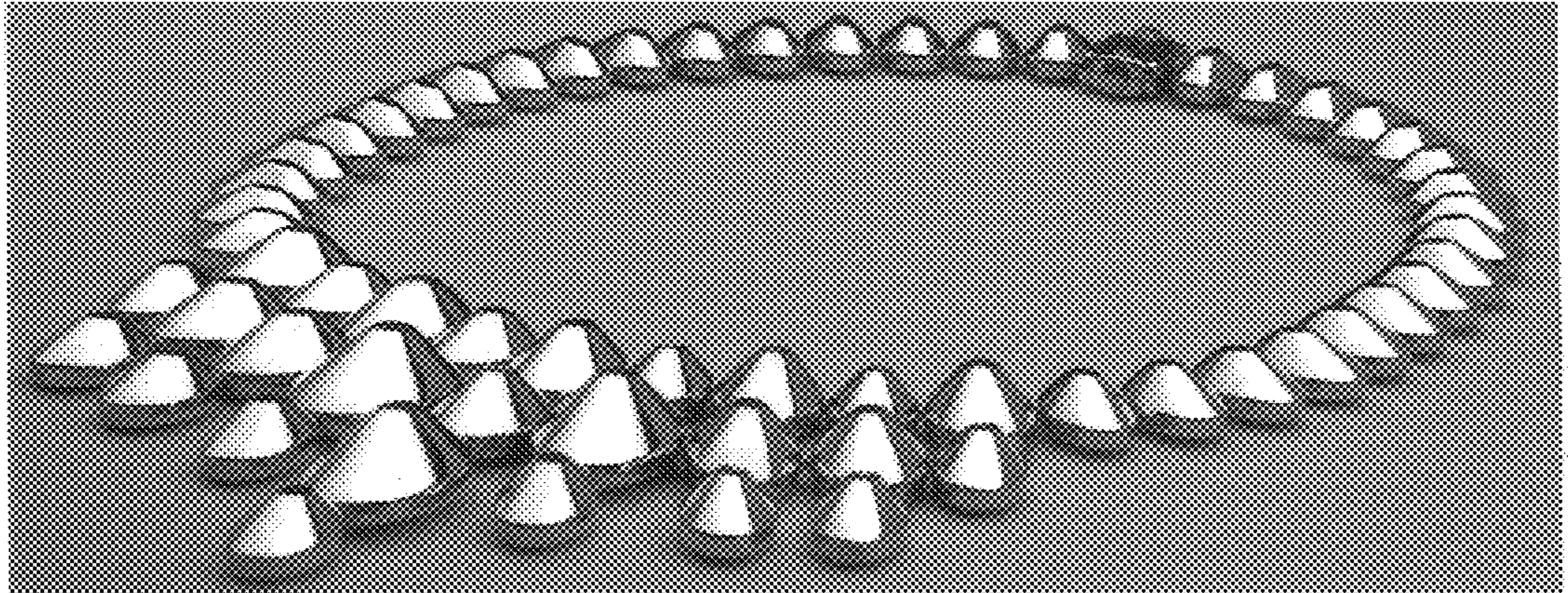
