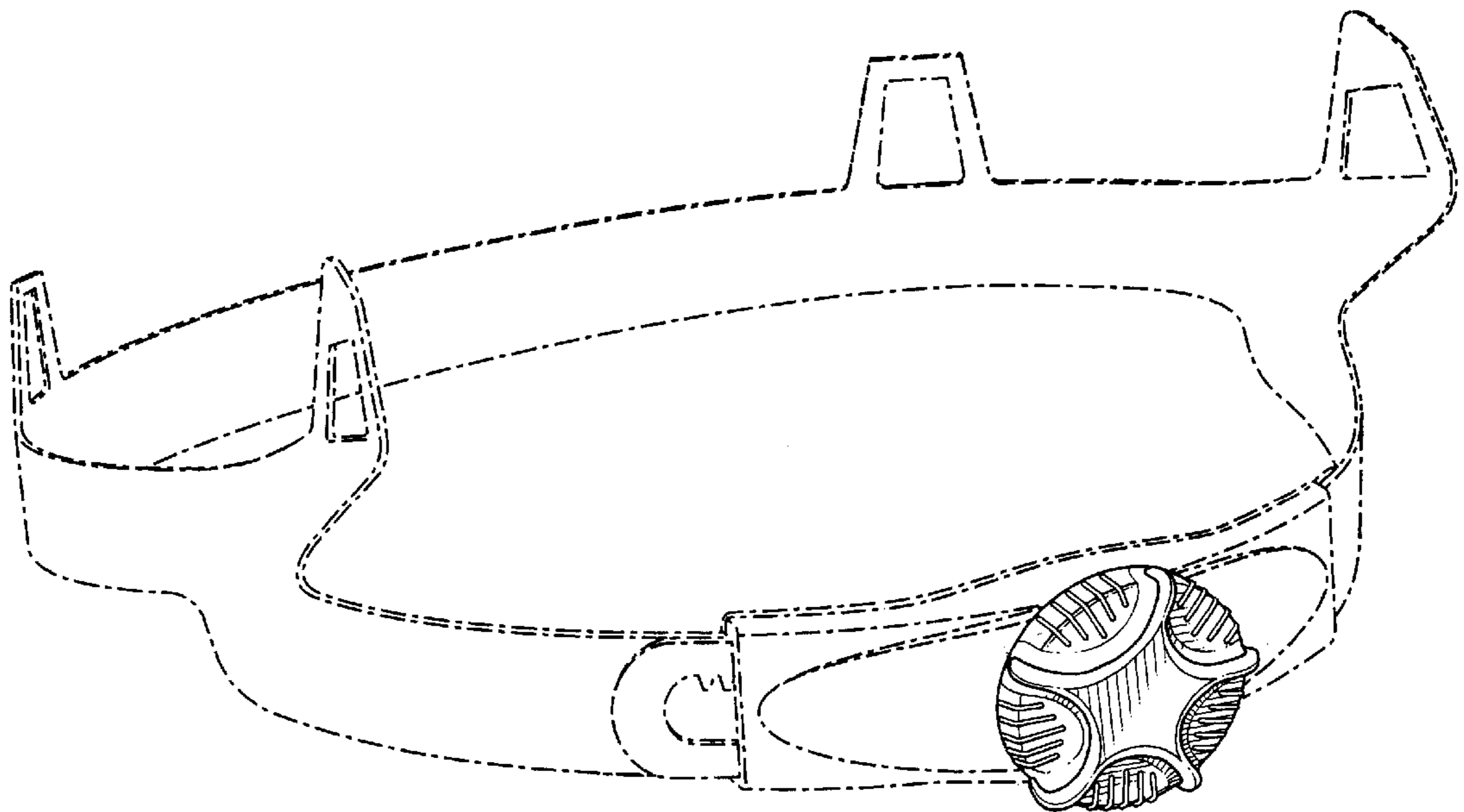
(57) **CLAIM**

I claim the ornamental design for a knob for a length adjustment mechanism for a strap, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a knob for a length adjustment mechanism for a strap according to the present design; FIG. 2 is a top plan view of the knob for a length adjustment mechanism for a strap of FIG. 1; FIG. 3 is a front elevational of the knob for a length adjustment mechanism for a strap of FIG. 1; FIG. 4 is a bottom plan view of the knob for a length adjustment mechanism for a strap of FIG. 1; FIG. 5 is a rear elevational view of the knob for a length adjustment mechanism for a strap of FIG. 1; FIG. 6 is a right side elevational view of the knob for a length adjustment mechanism for a strap of FIG. 1; and, FIG. 7 is a left side elevational view of the knob for a length adjustment mechanism for a strap of FIG. 1. The broken lines shown in FIGS. 1–7 are for illustrative purposes only and form no part of the claimed design.

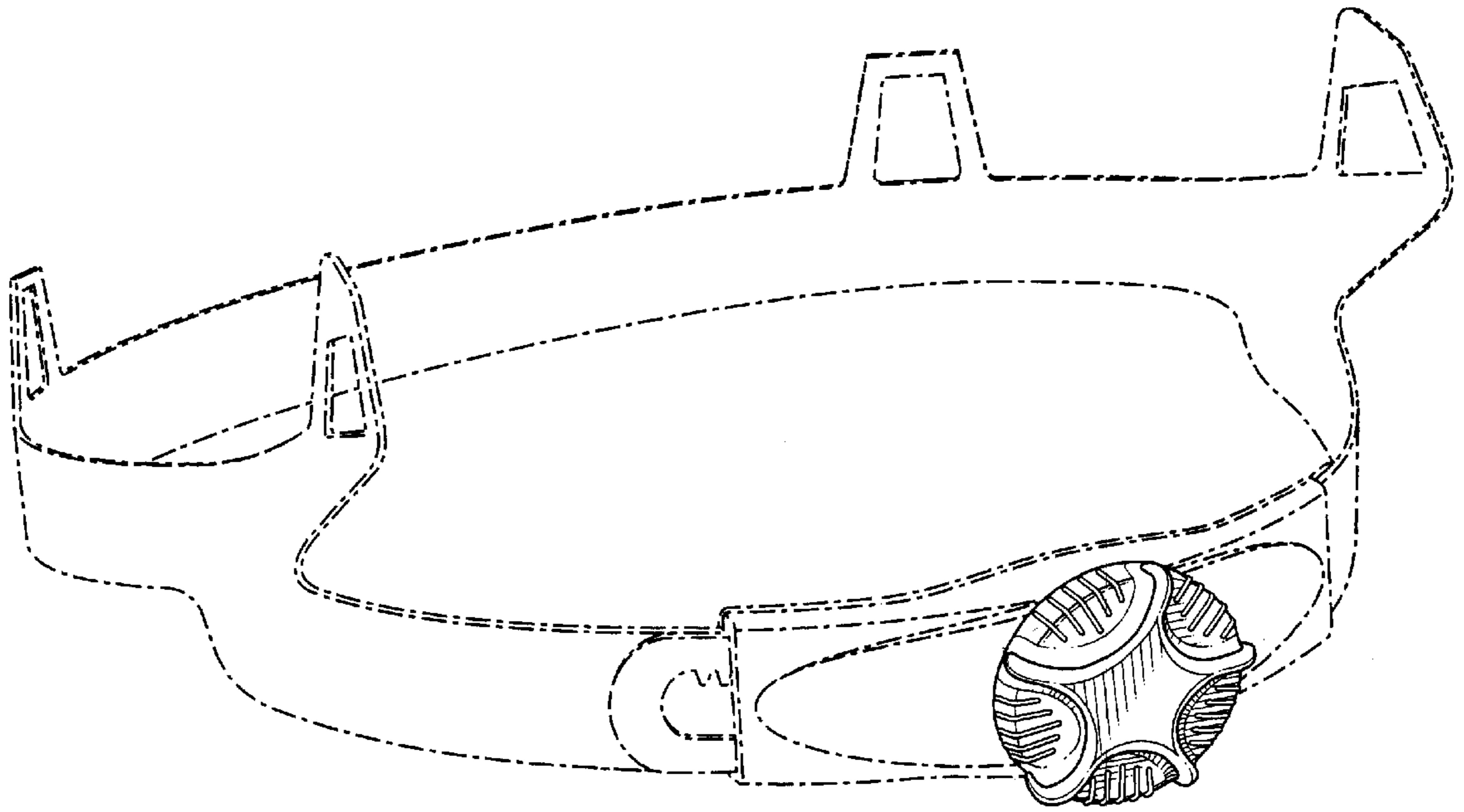

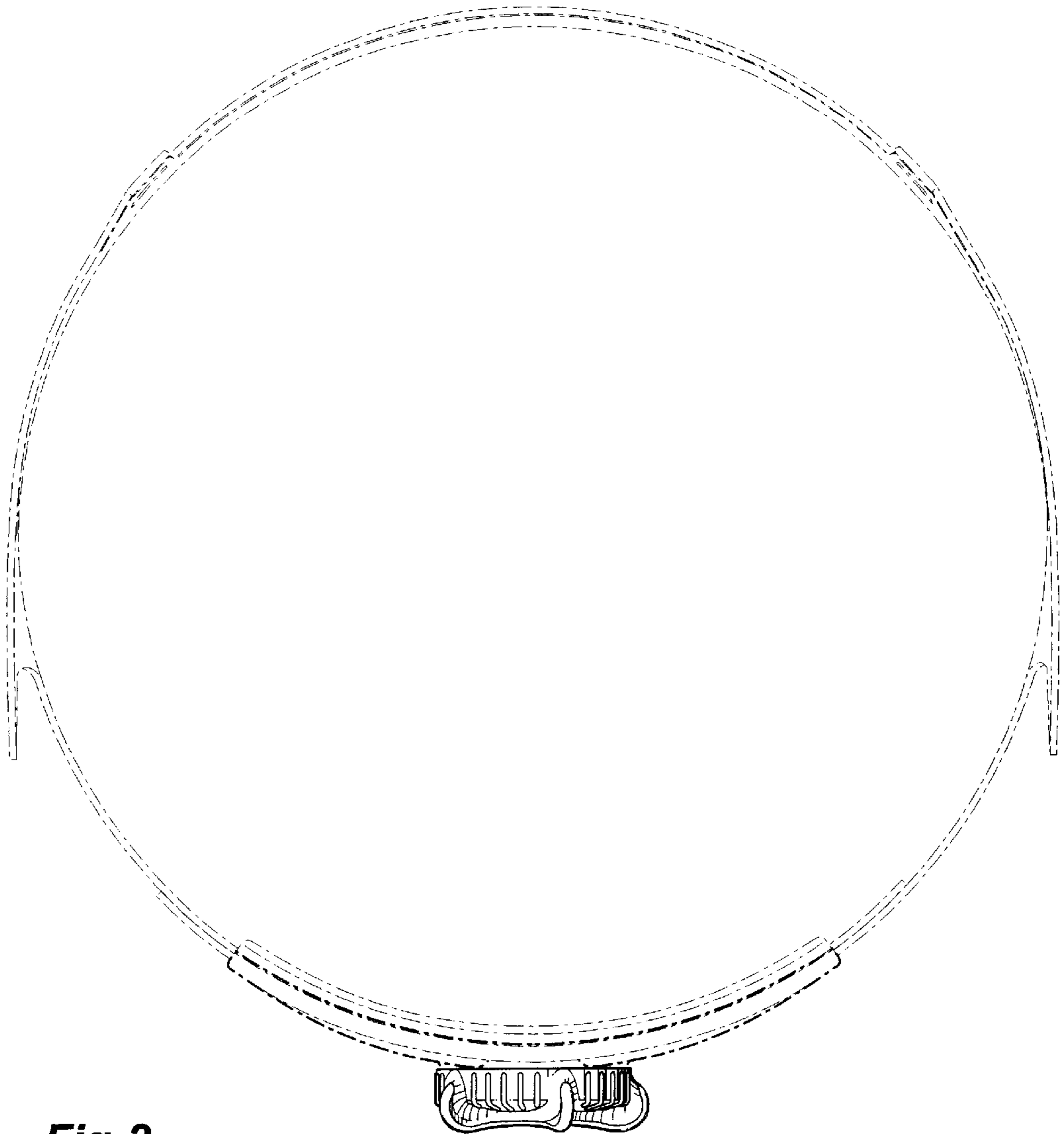

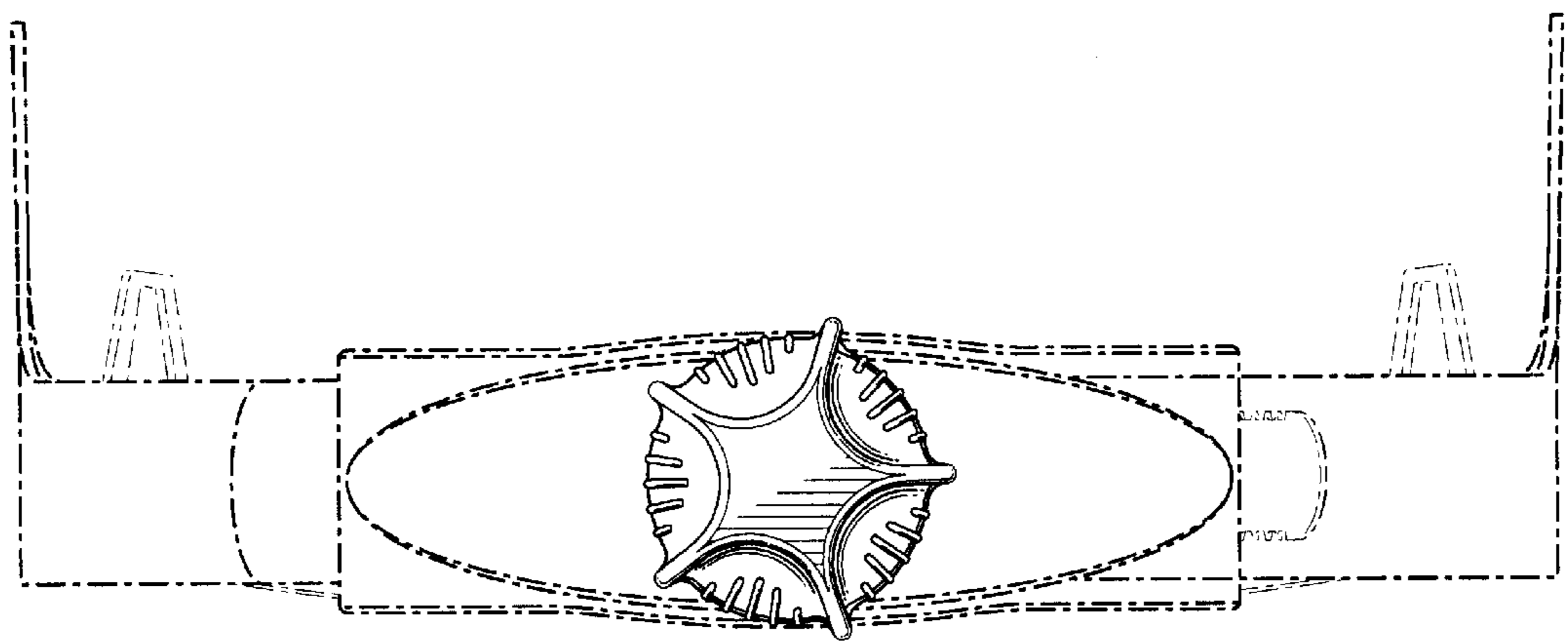

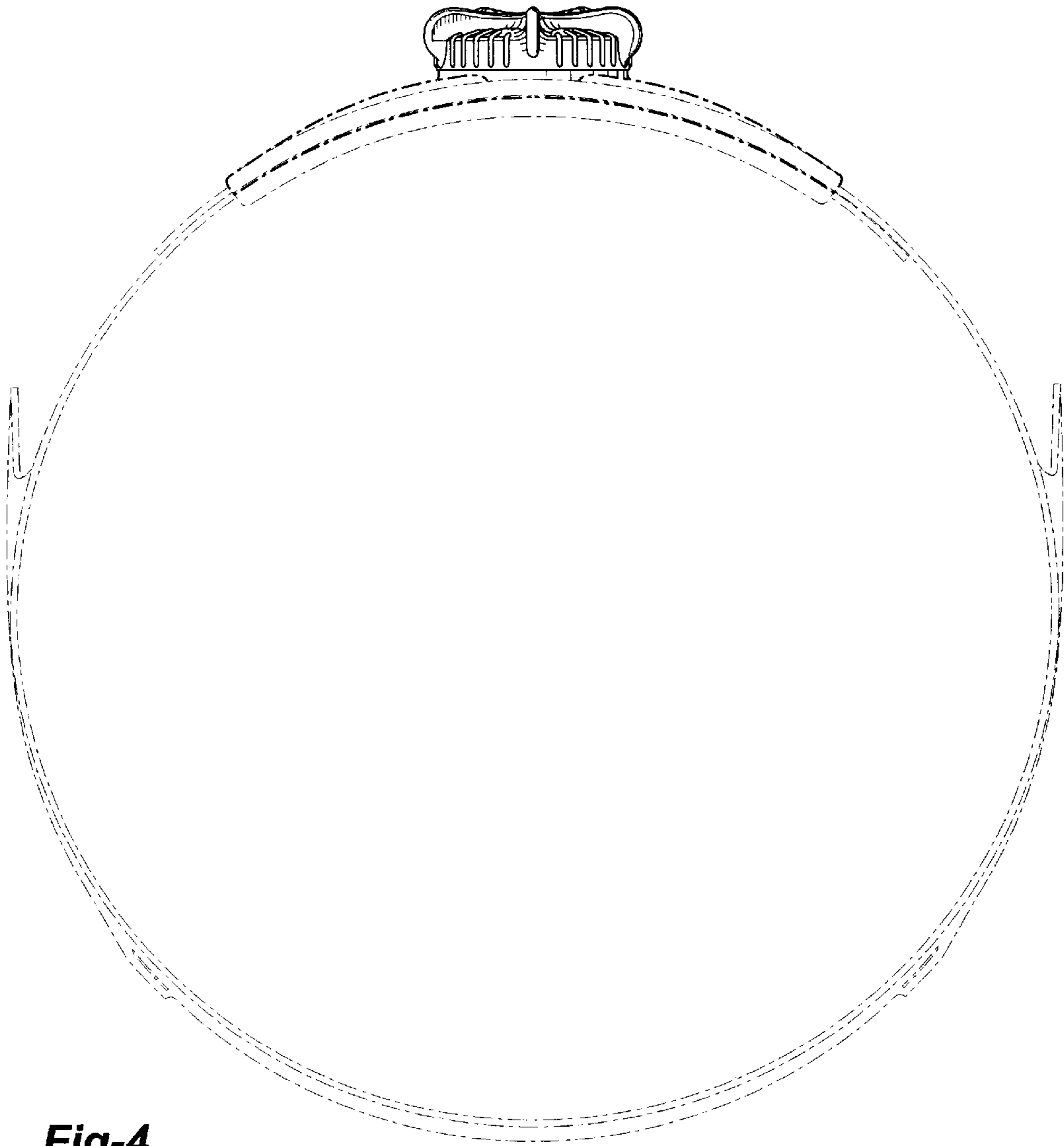

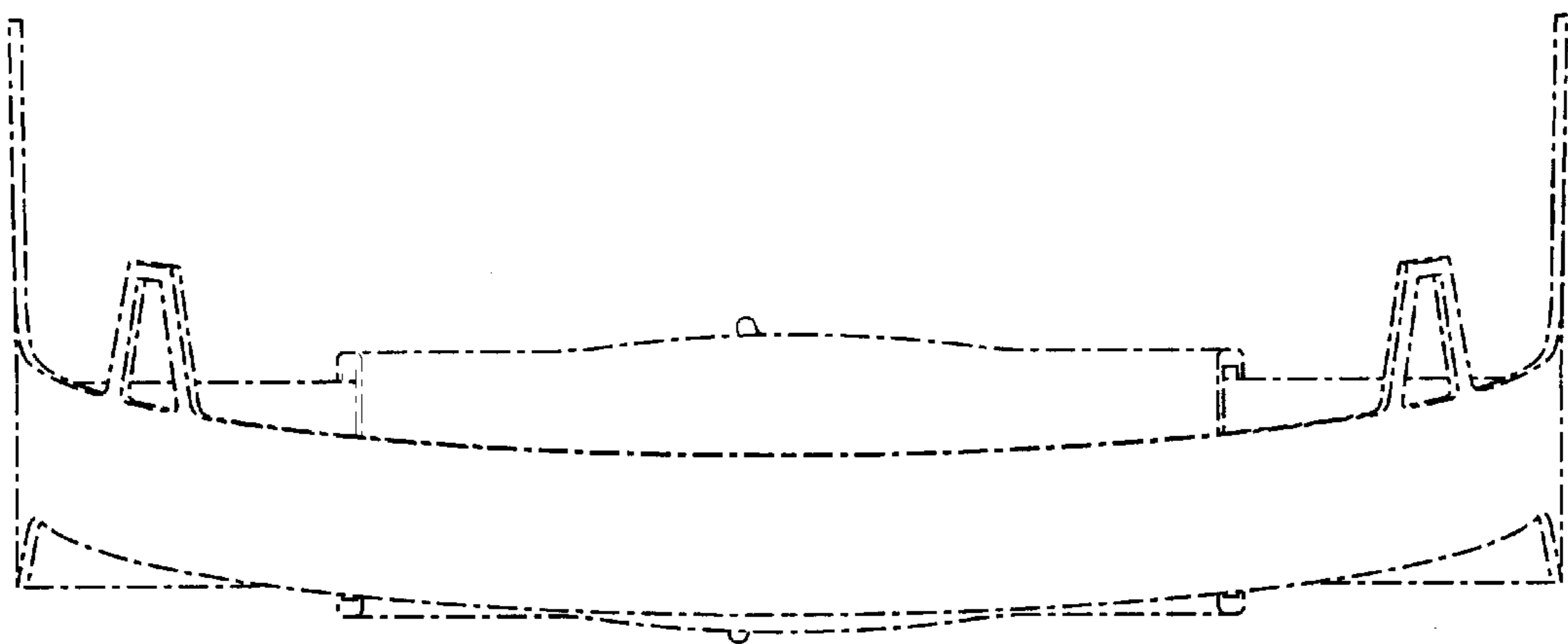

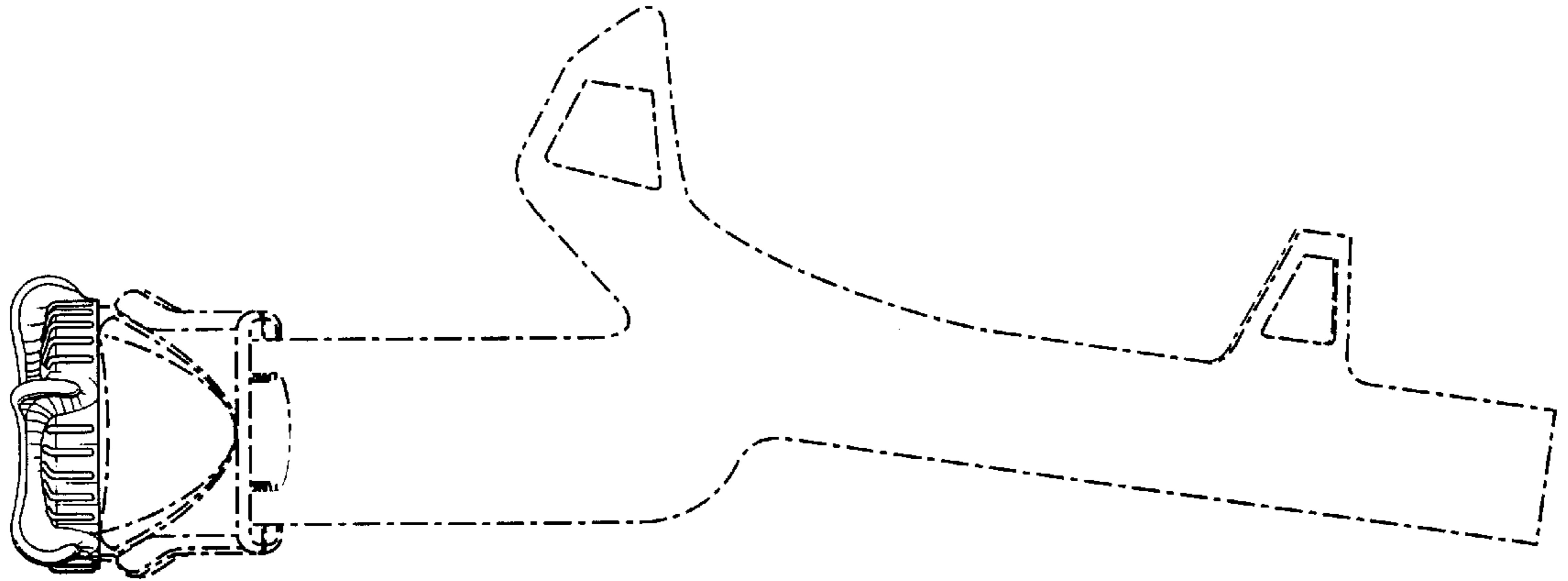

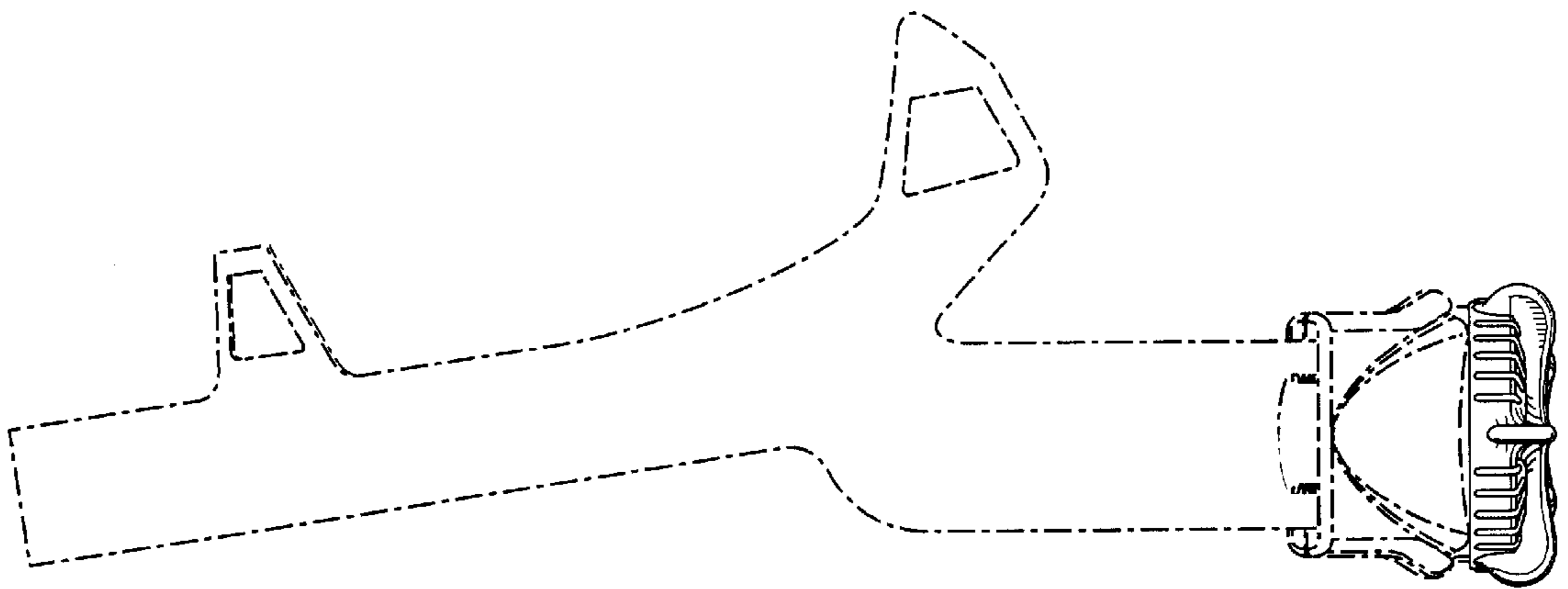
