DESCRIPTION

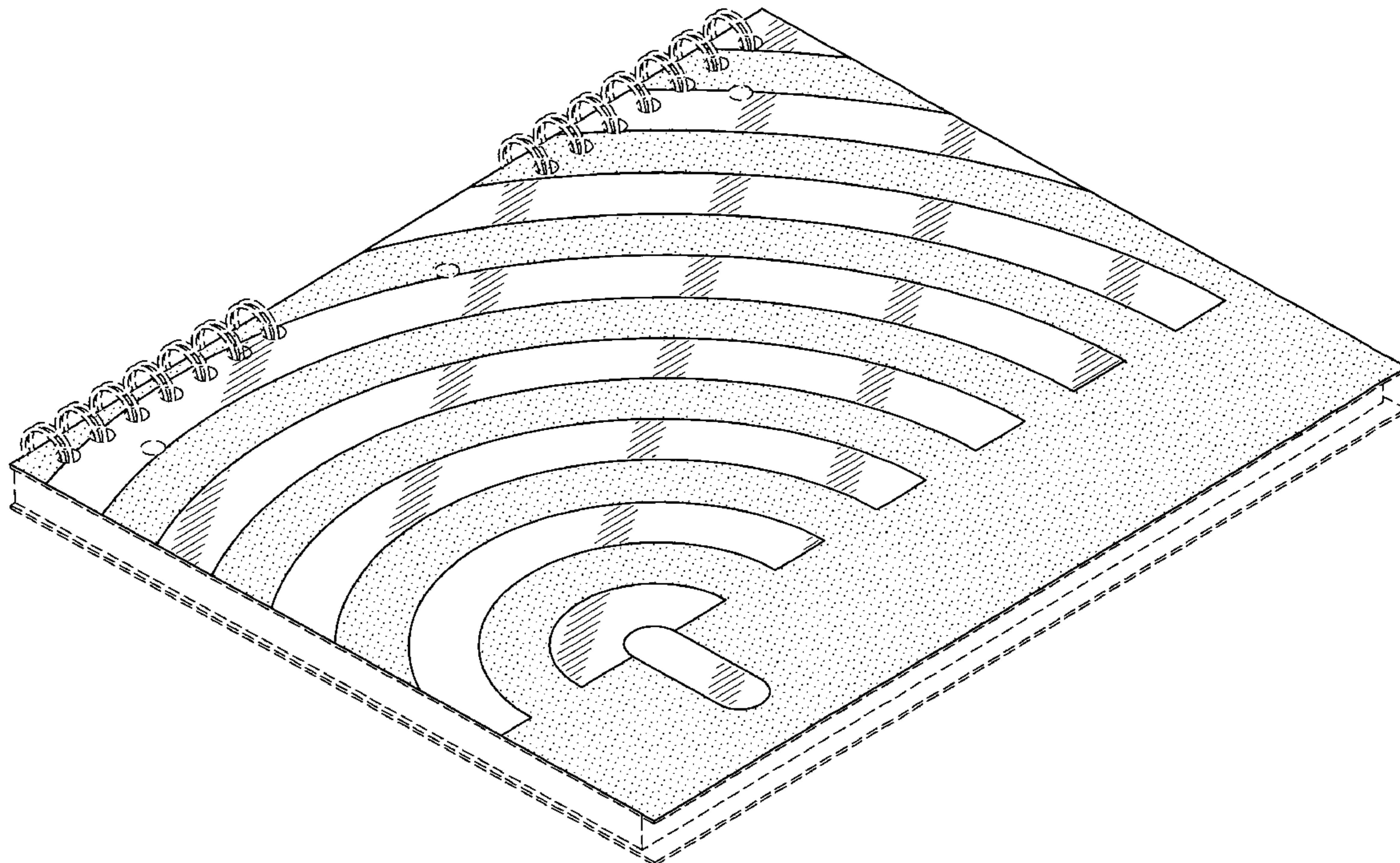
FIG. 1 is a front perspective view of a cover for a binder, folder or notebook showing our new design;

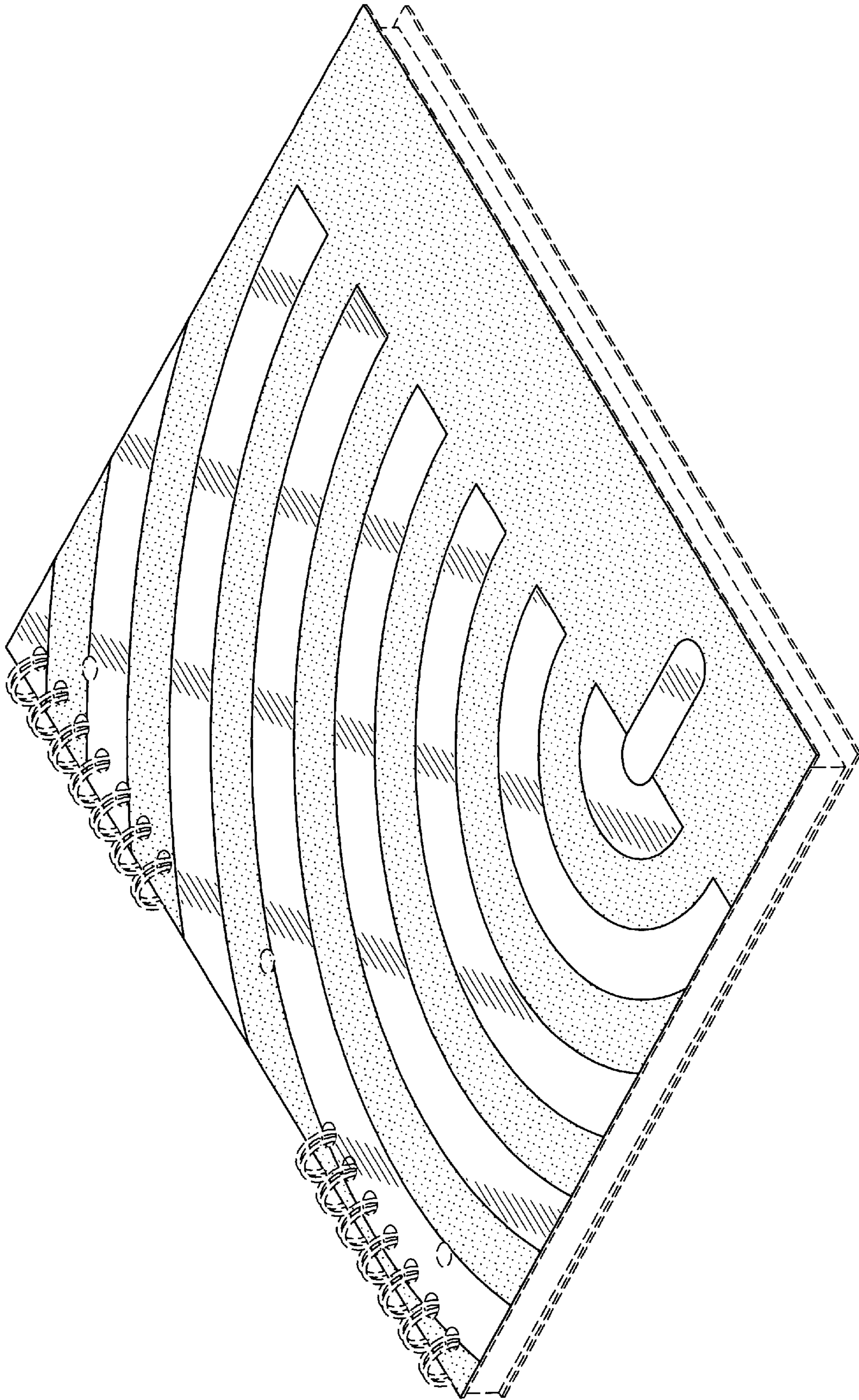

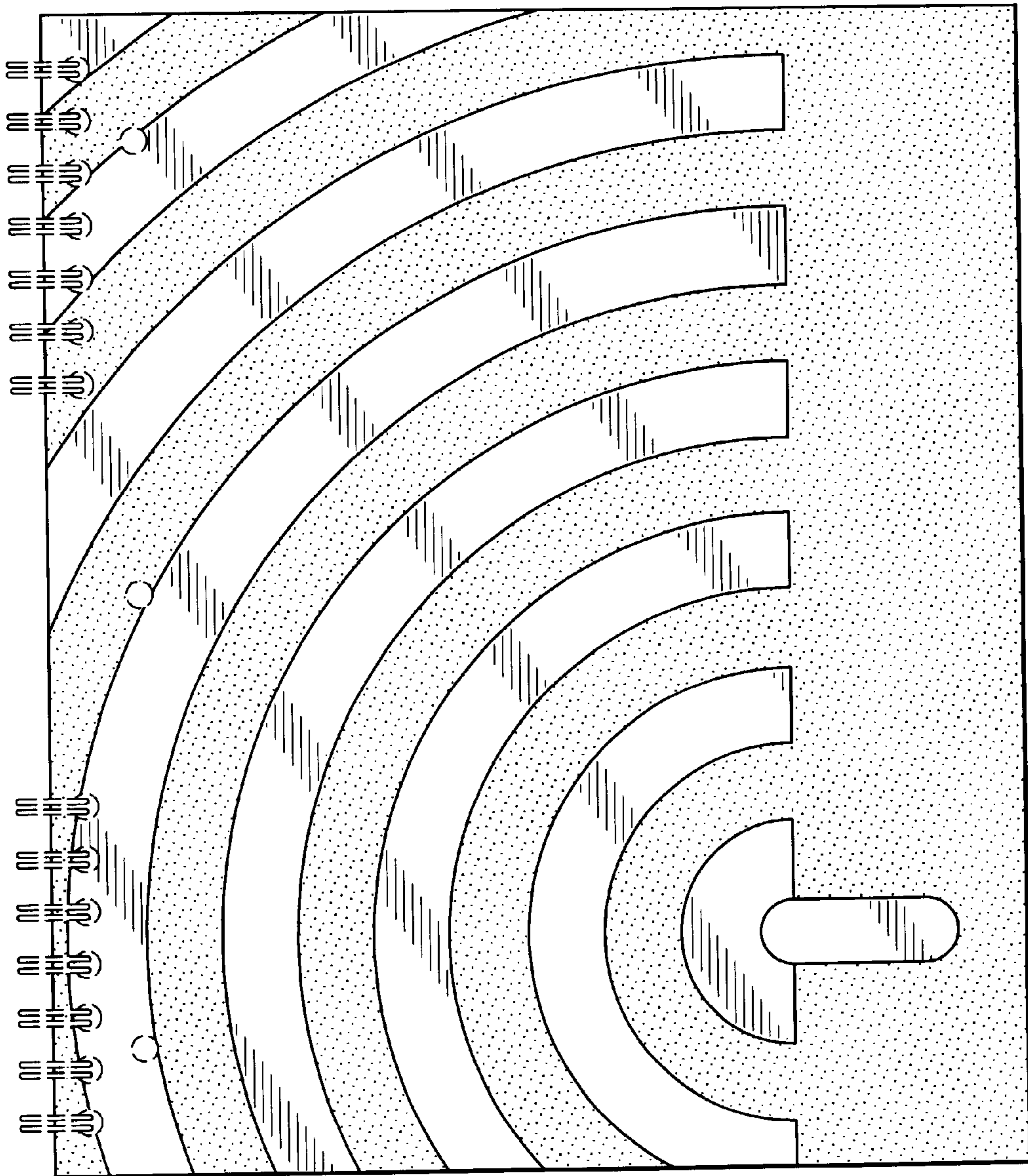

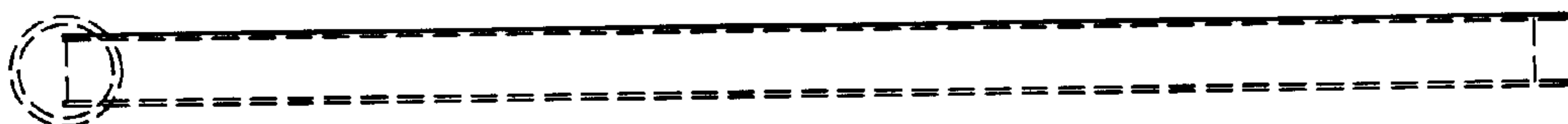

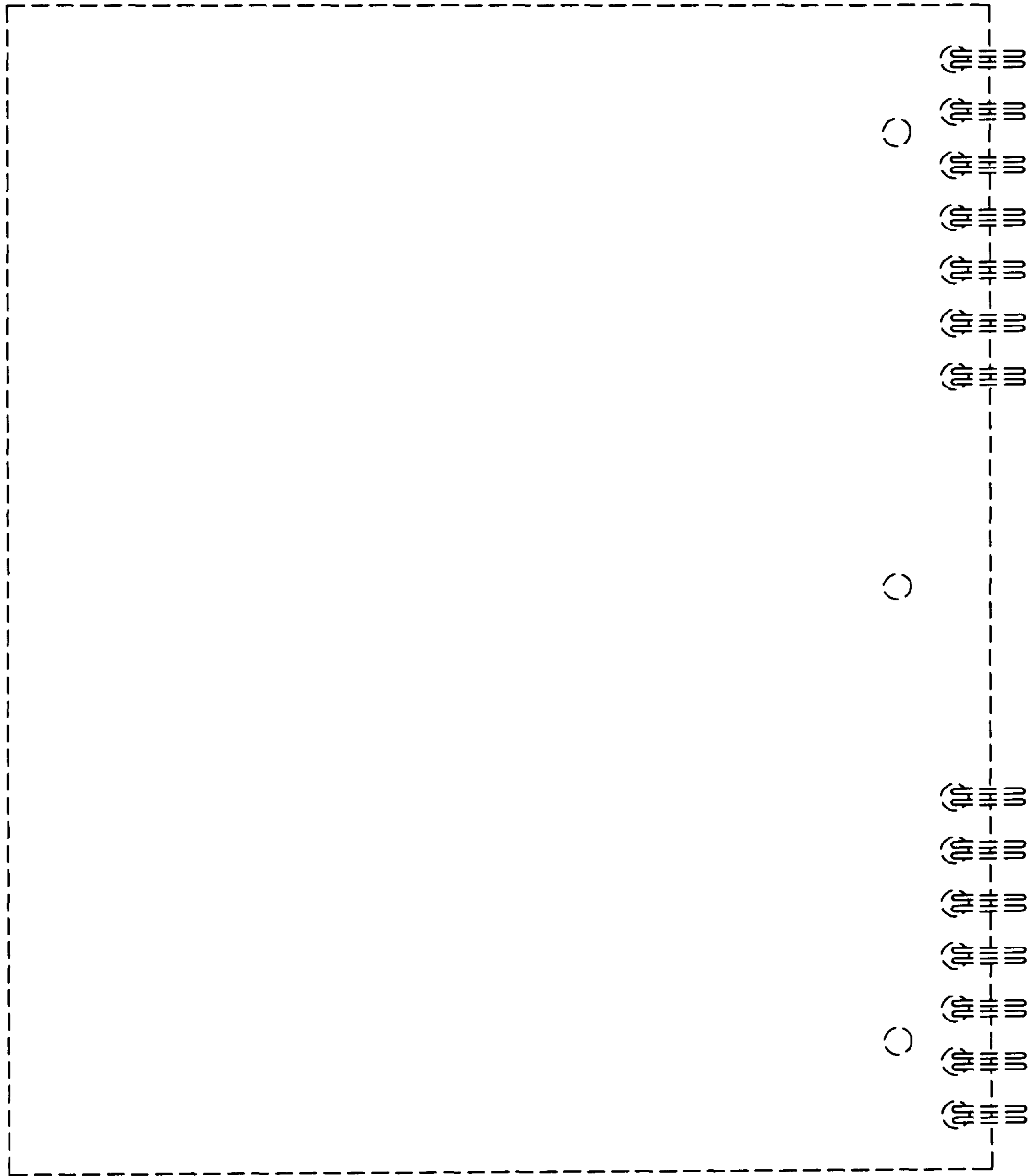

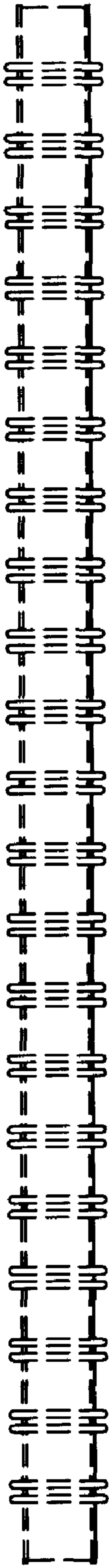

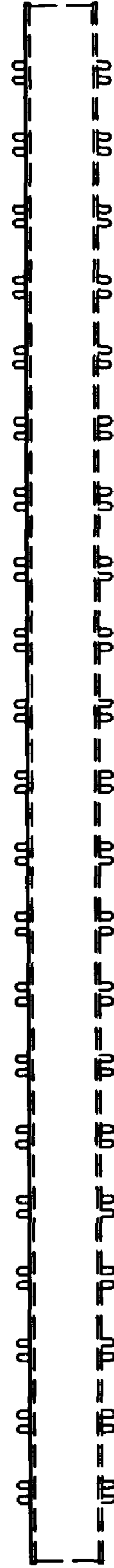

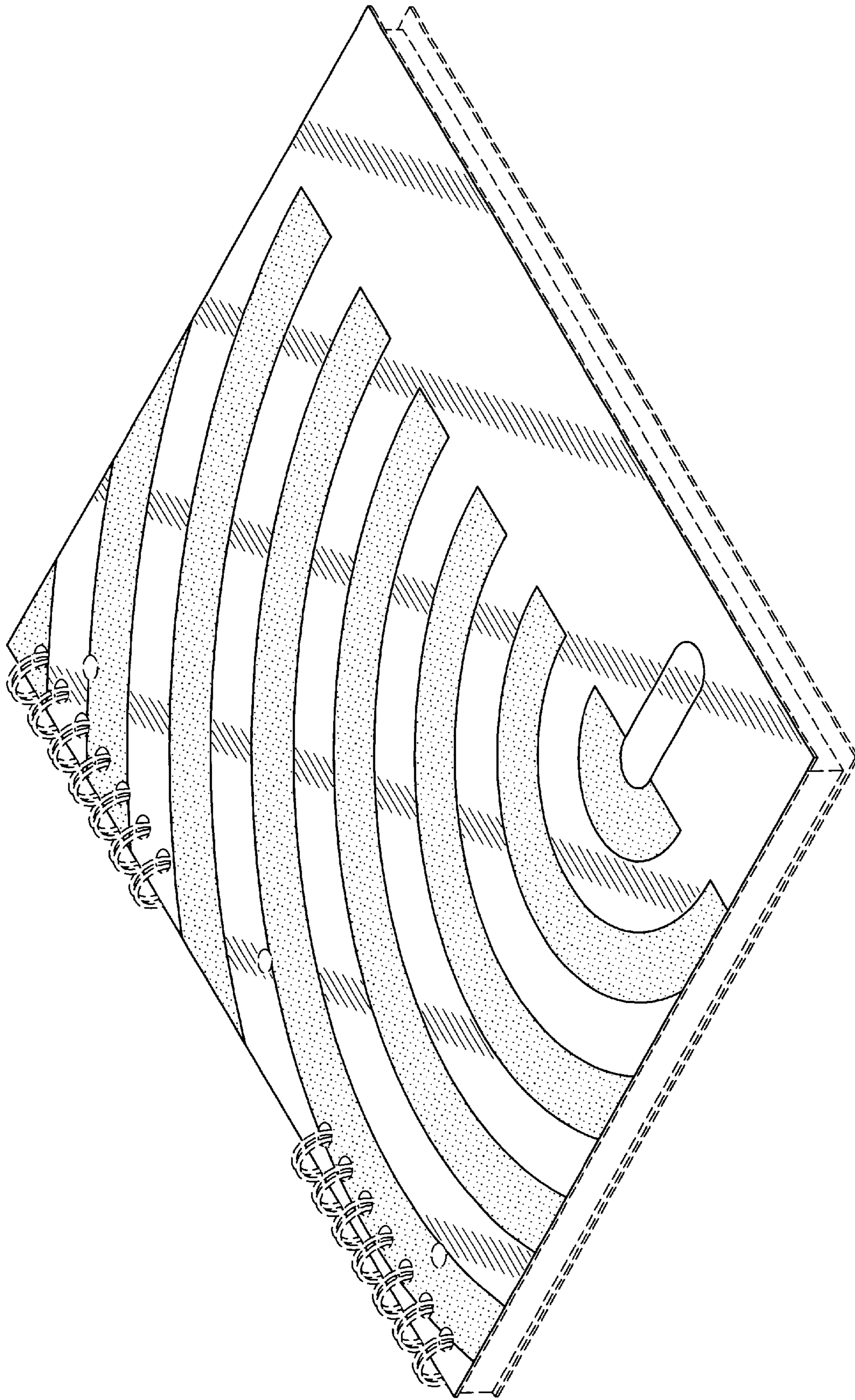

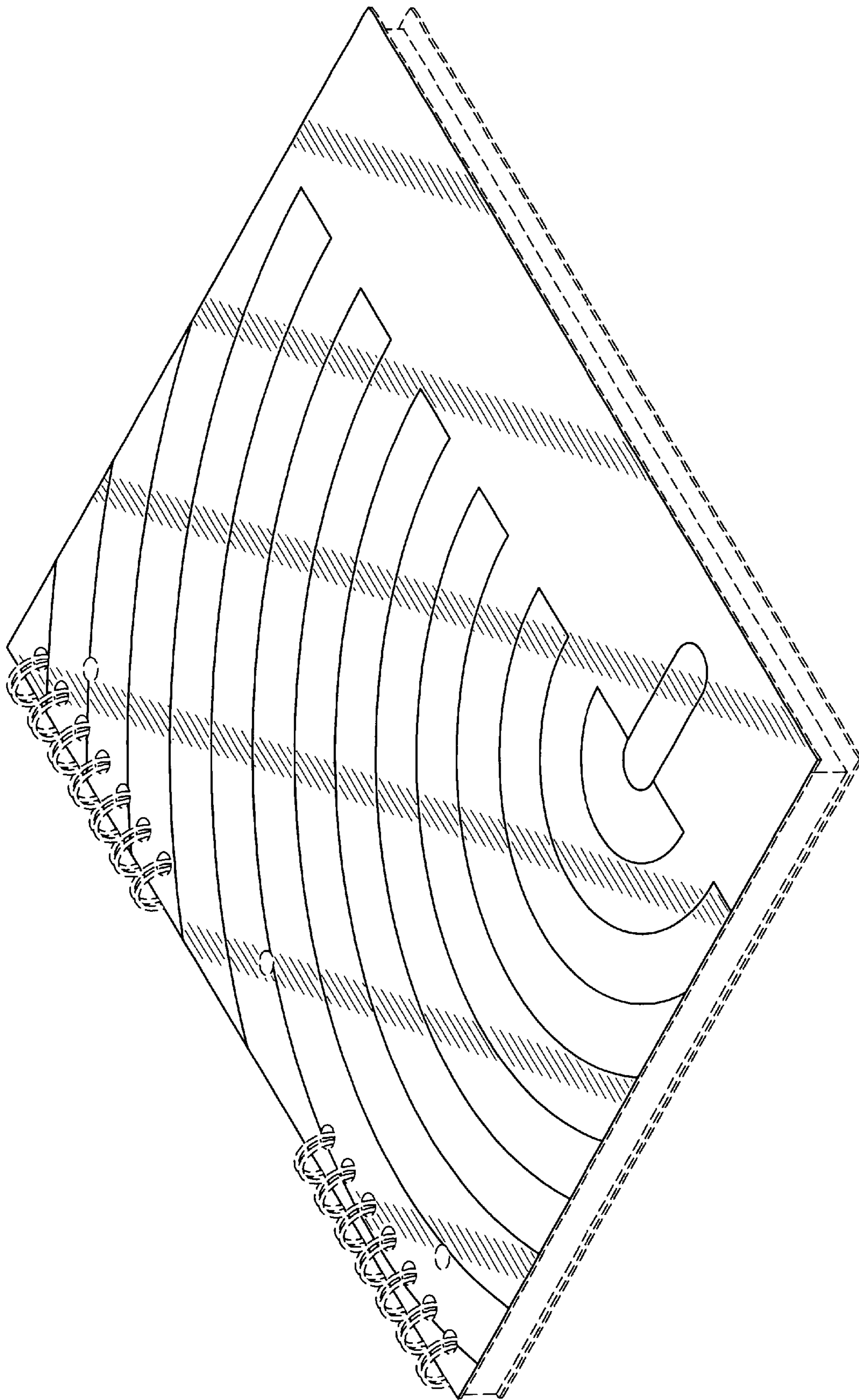

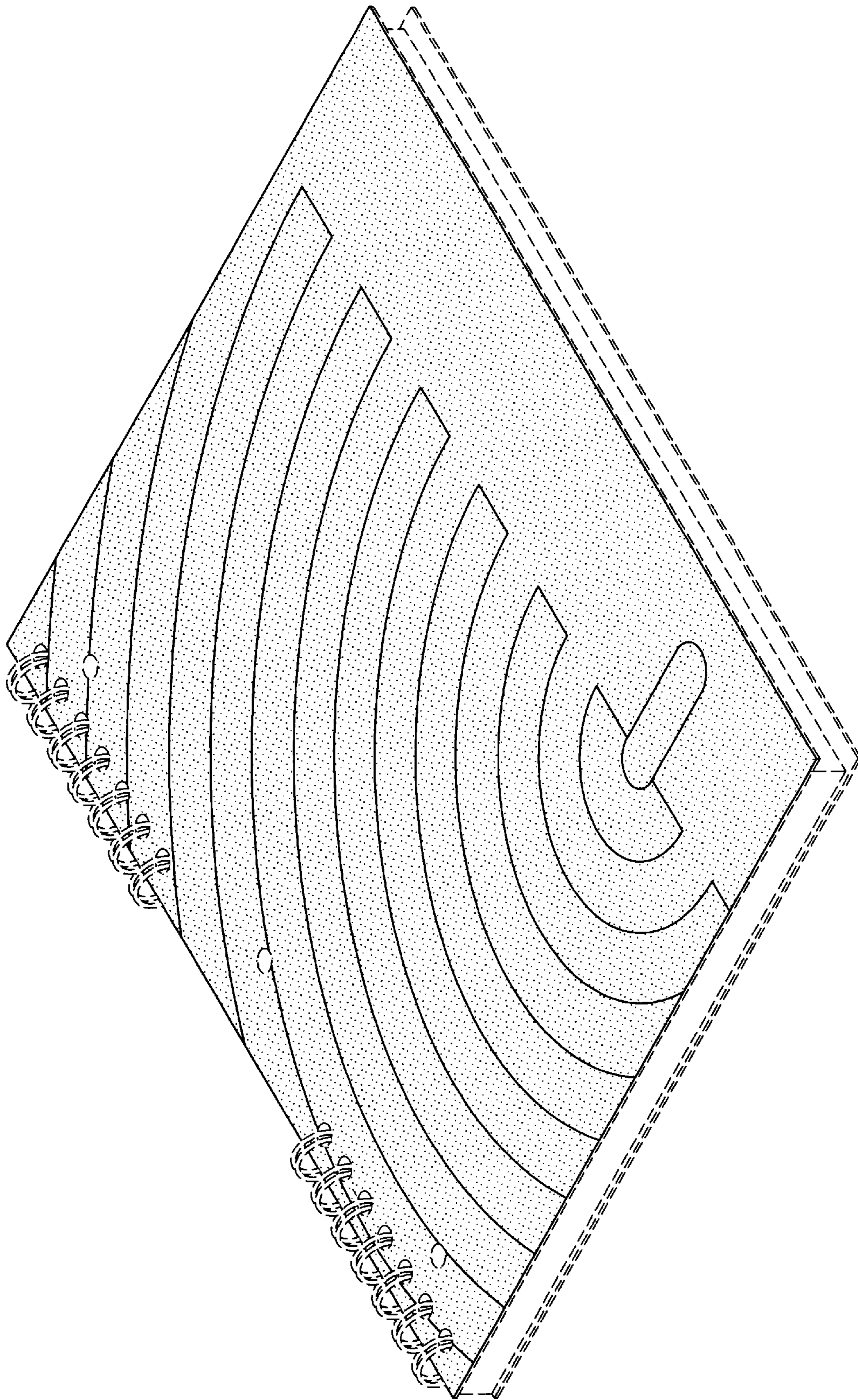
