(57) **CLAIM**

The ornamental design for a sorter for medical image printer, as shown and described.

**DESCRIPTION**

FIG. 1 is a top, front and side perspective view of a sorter for medical image printer, showing our new design;  
 FIG. 2 is a side elevational view thereof;  
 FIG. 3 is a side elevational view thereof from the side opposite that shown in FIG. 2;  
 FIG. 4 is a top plan view thereof;  
 FIG. 5 is a bottom plan view thereof;  
 FIG. 6 is a front elevational view thereof;  
 FIG. 7 is a rear elevational view thereof; and,  
 FIG. 8 is a perspective view thereof, with the broken line showing of the medical image printer being for illustrative purposes only and forming no part of the claimed design.

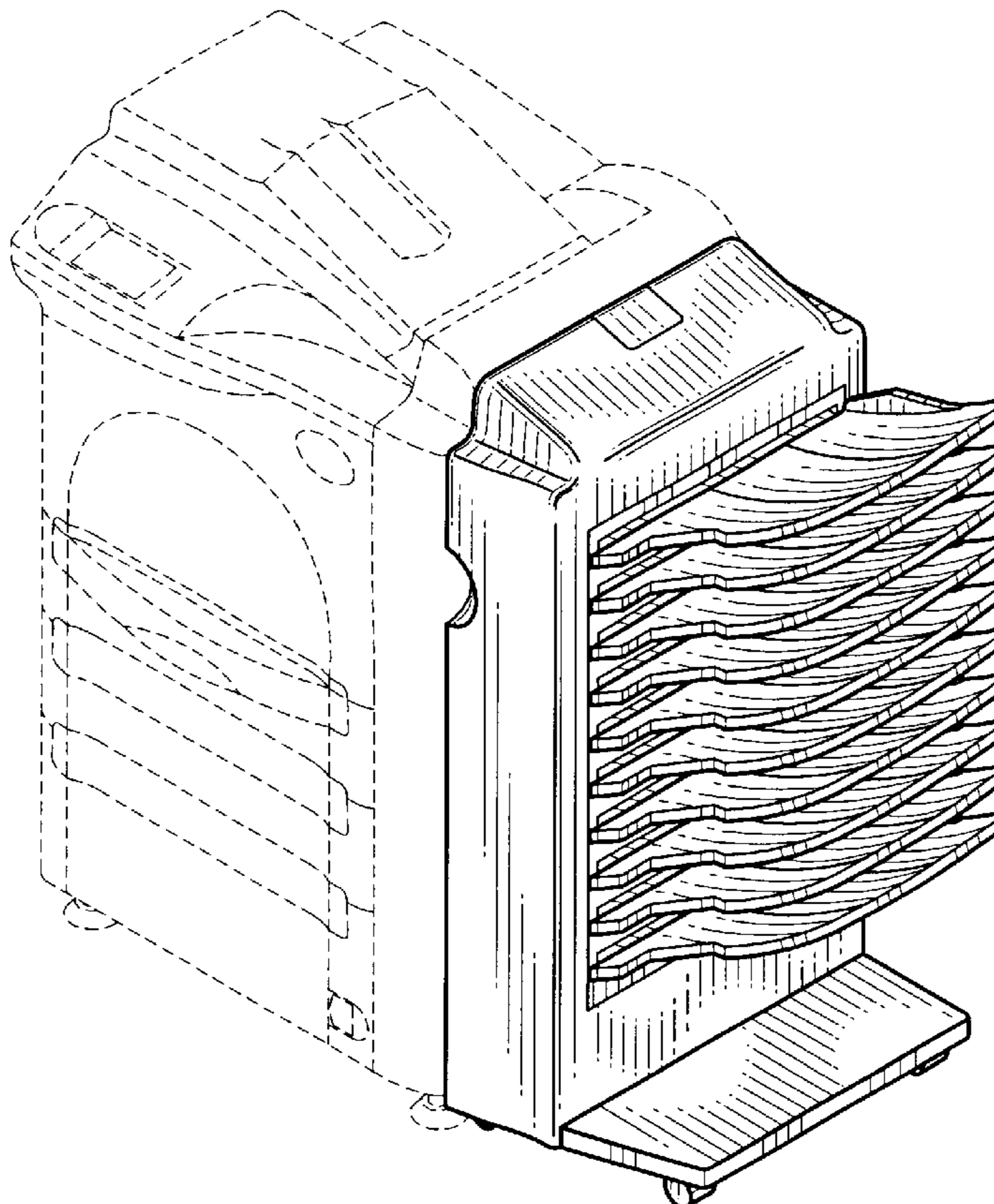

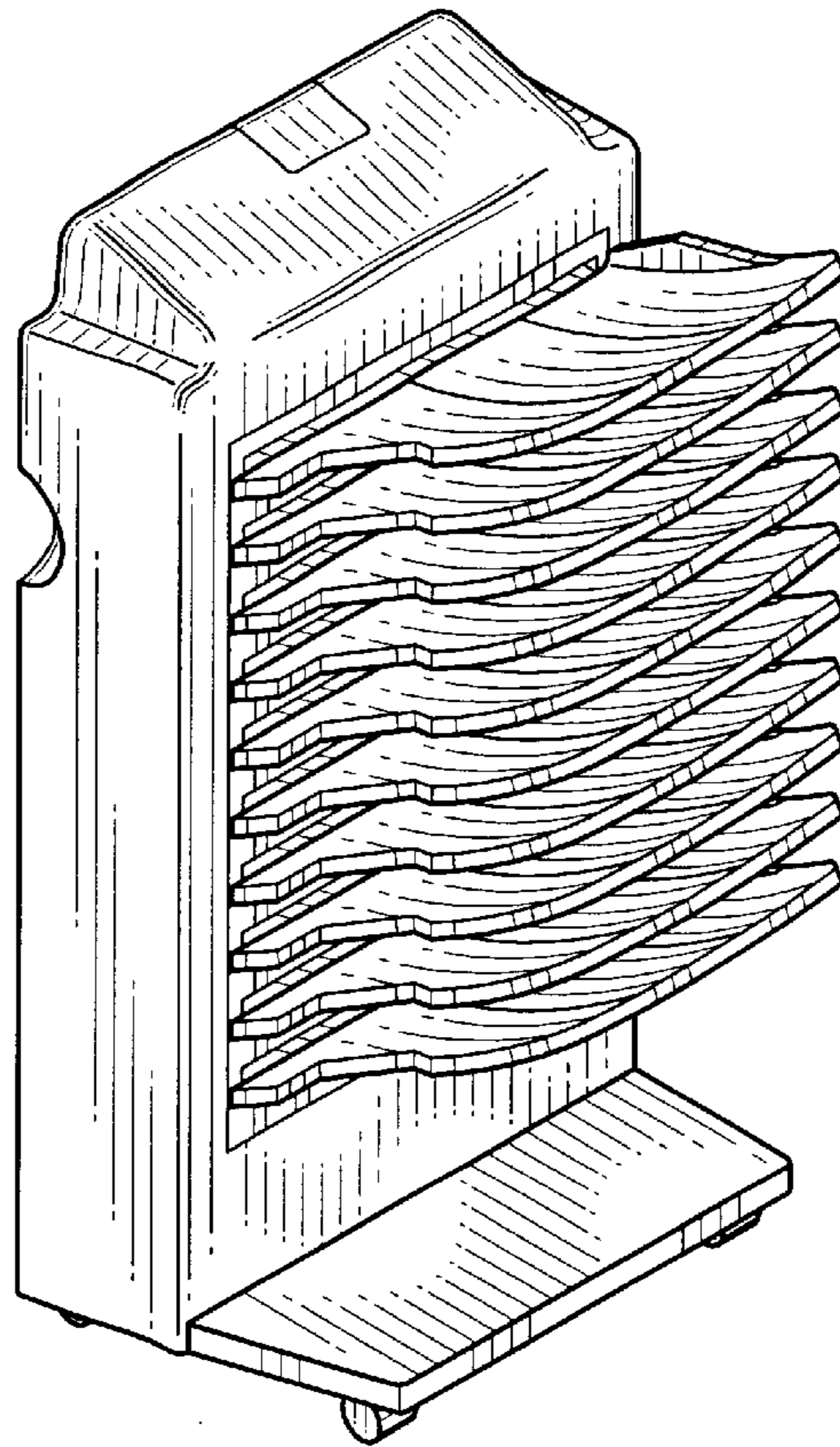

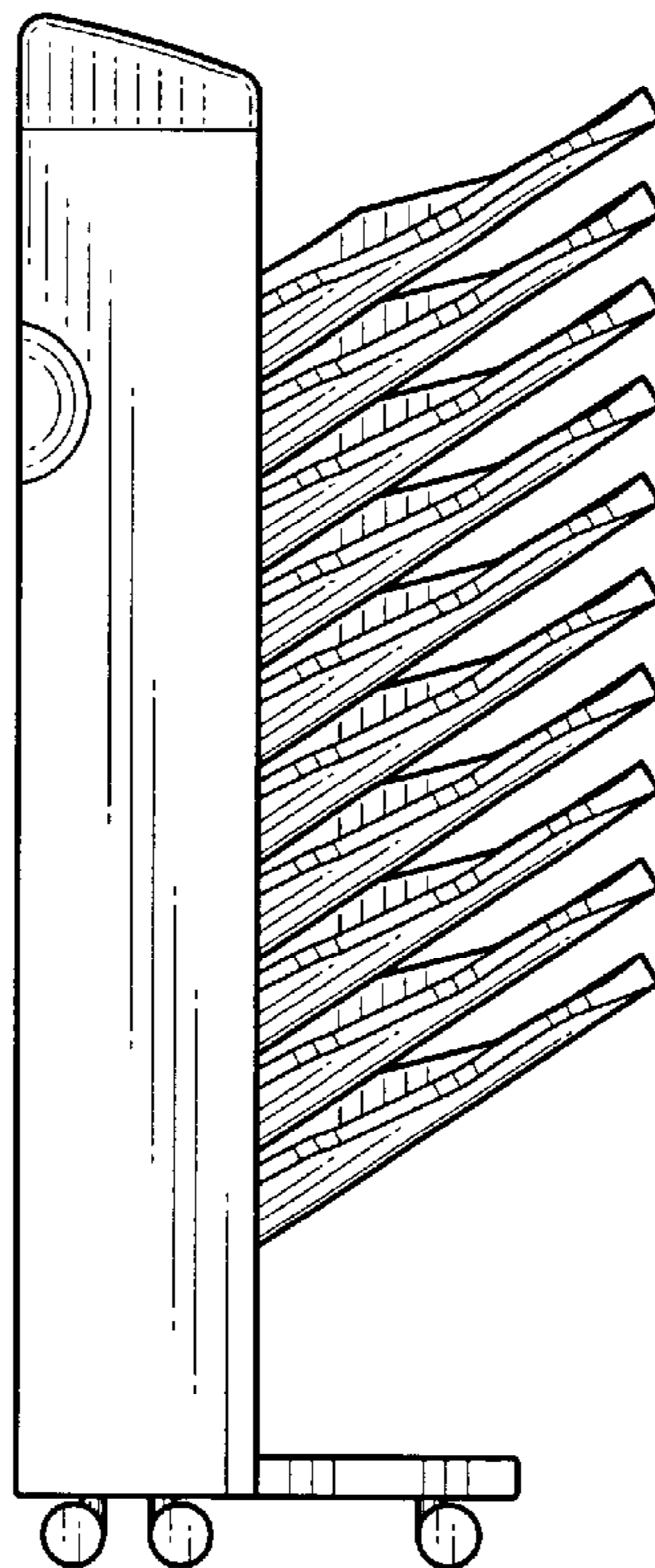

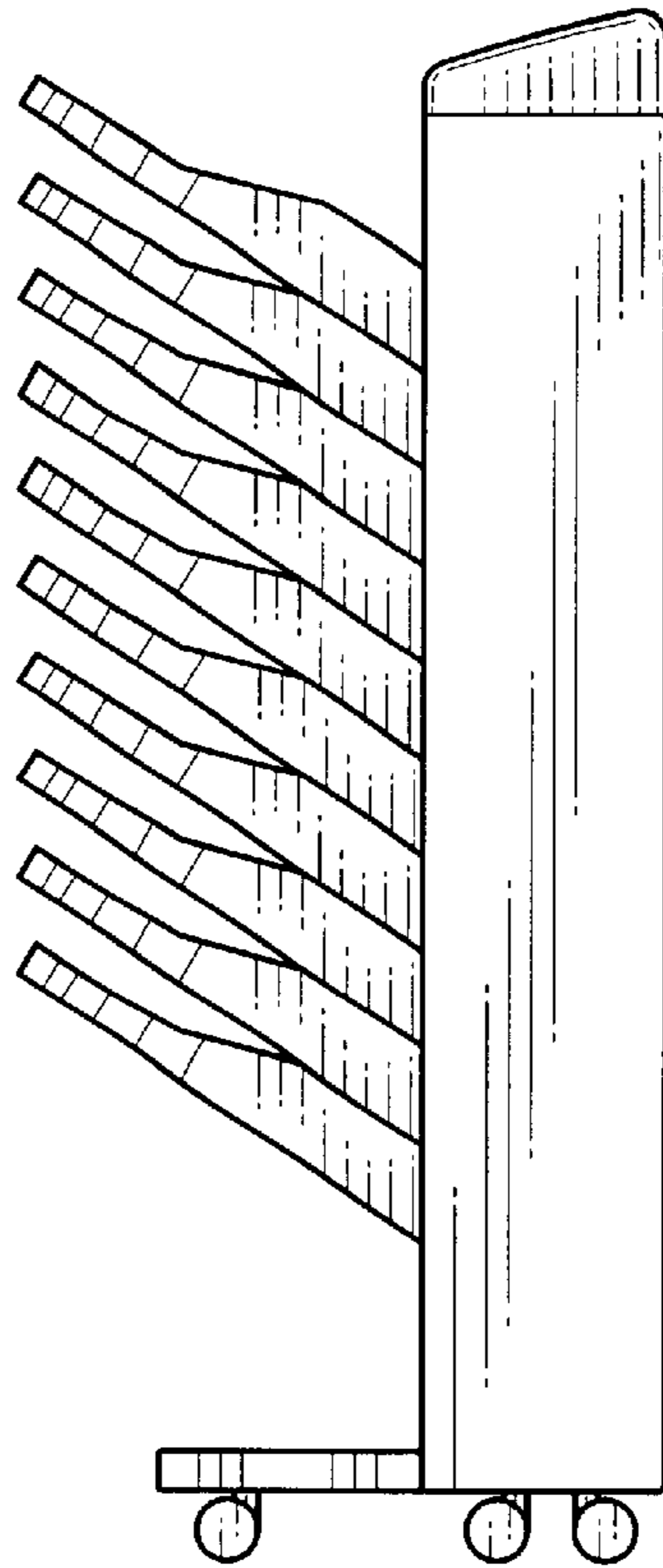

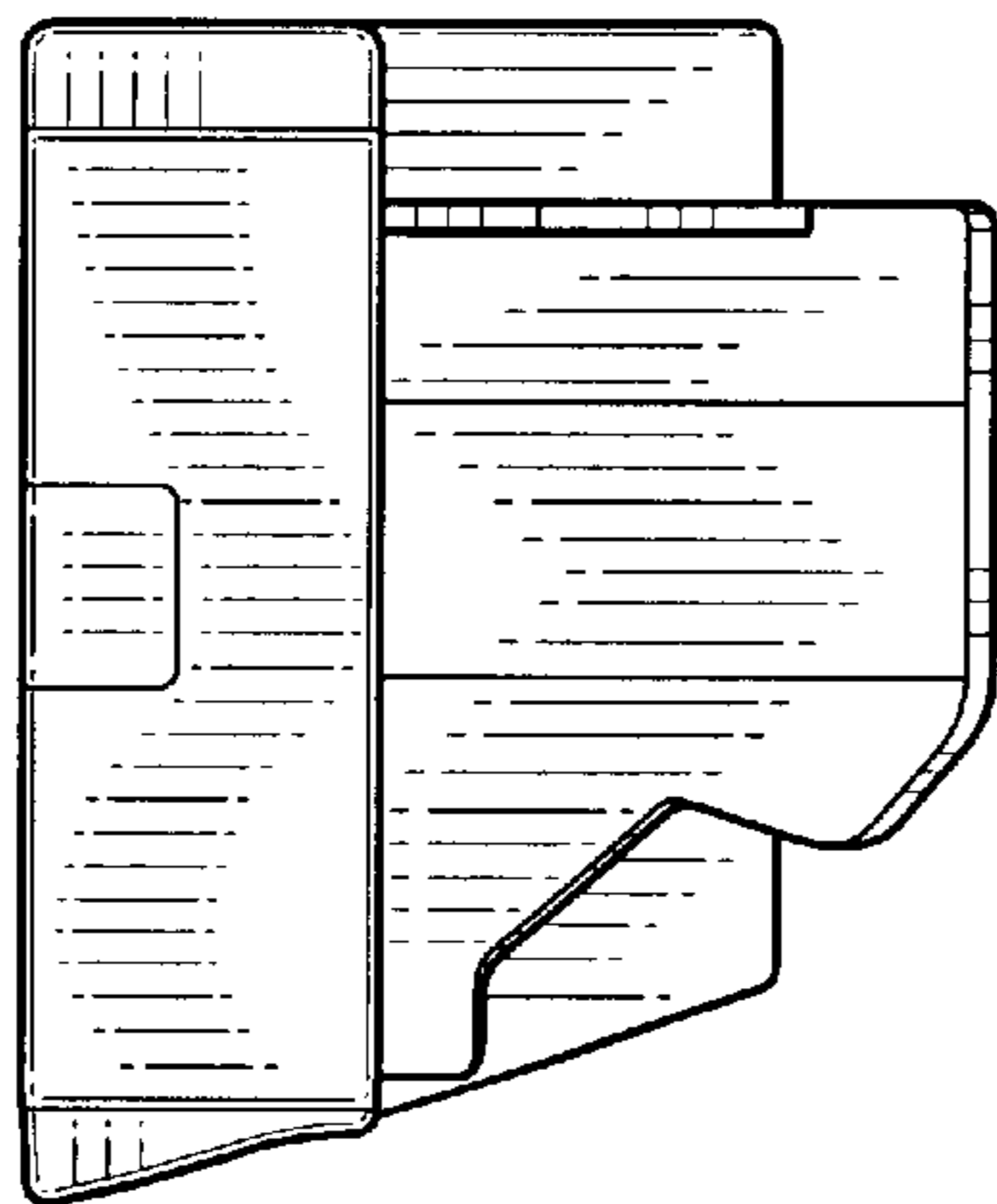

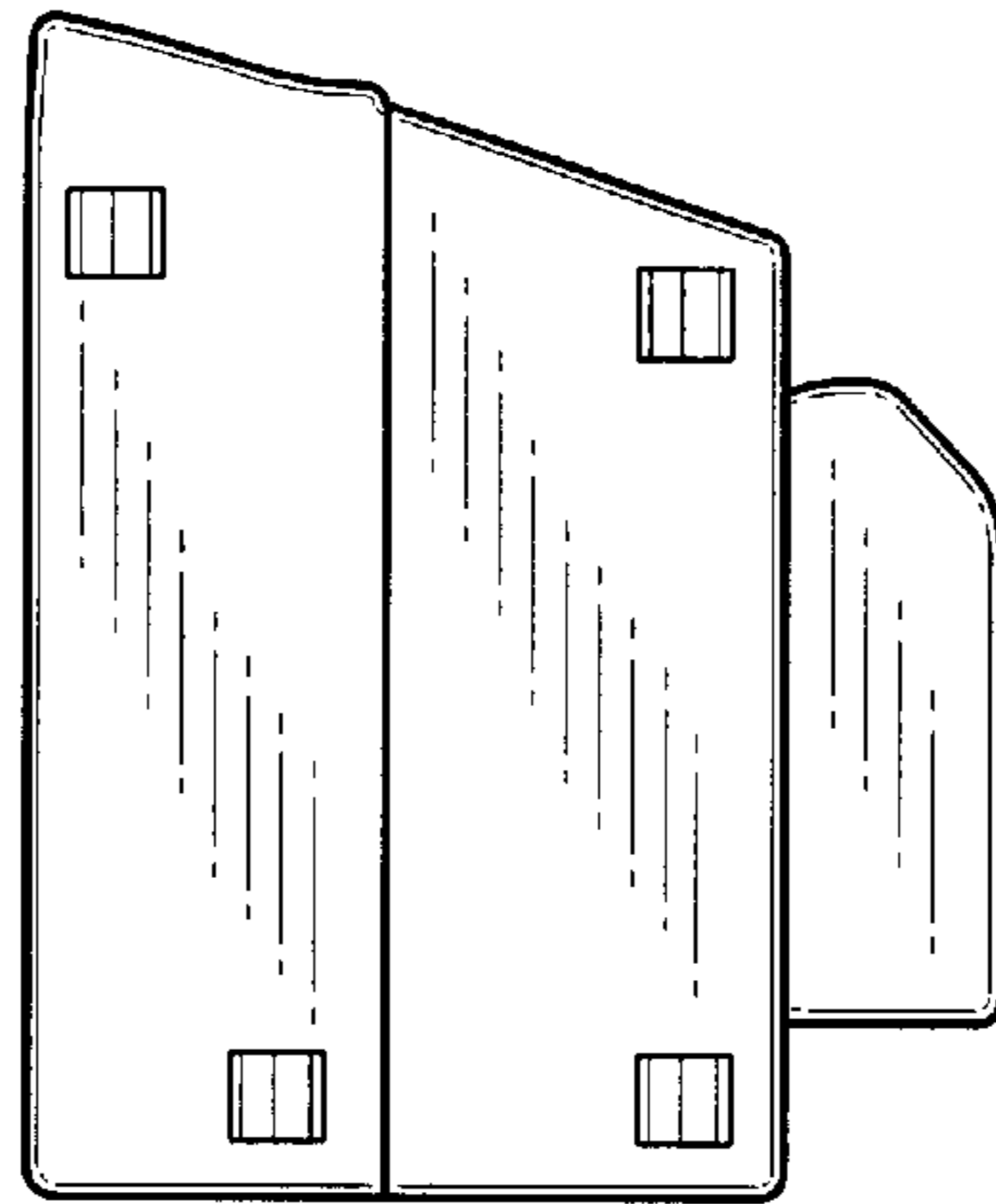

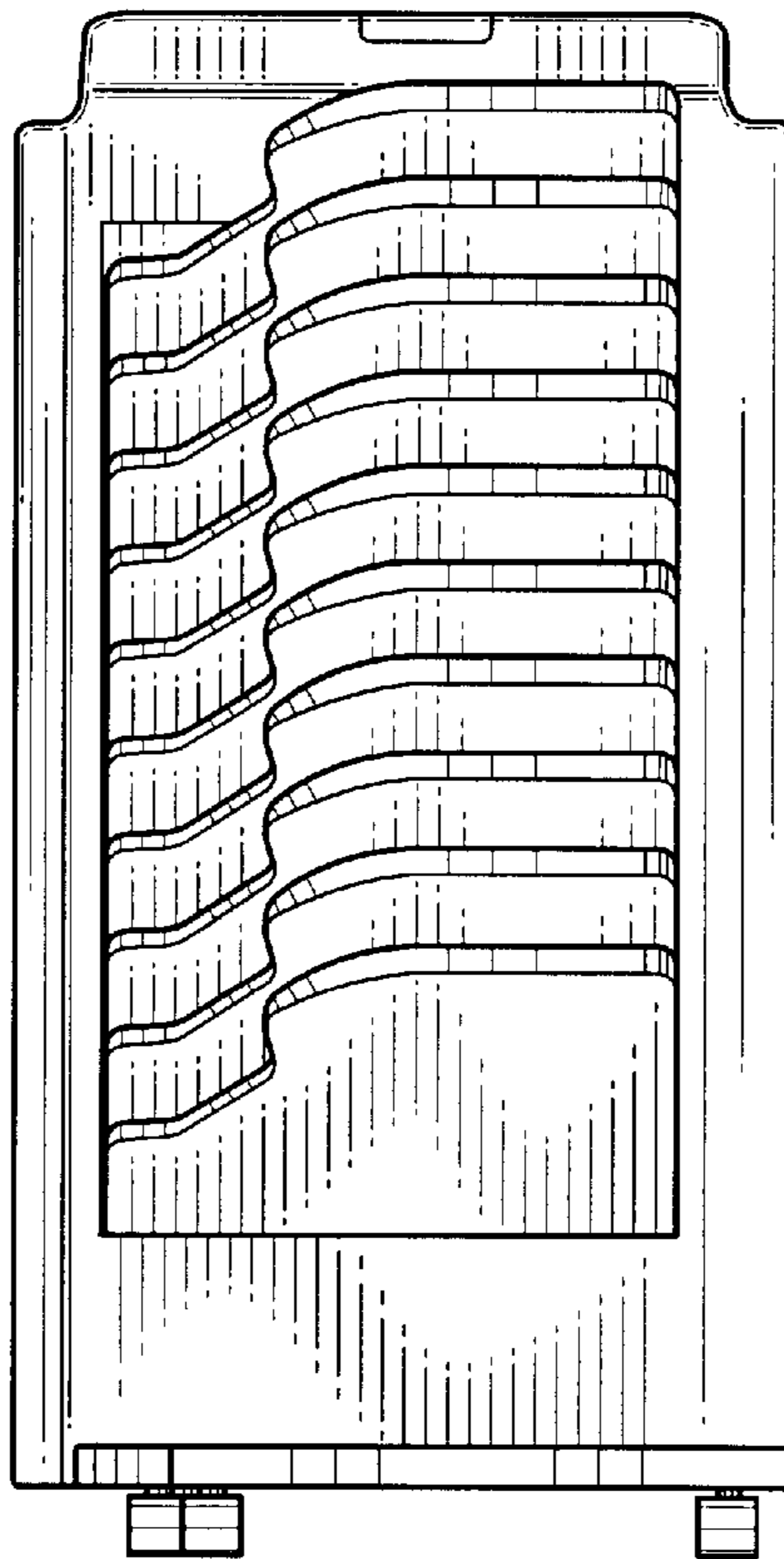

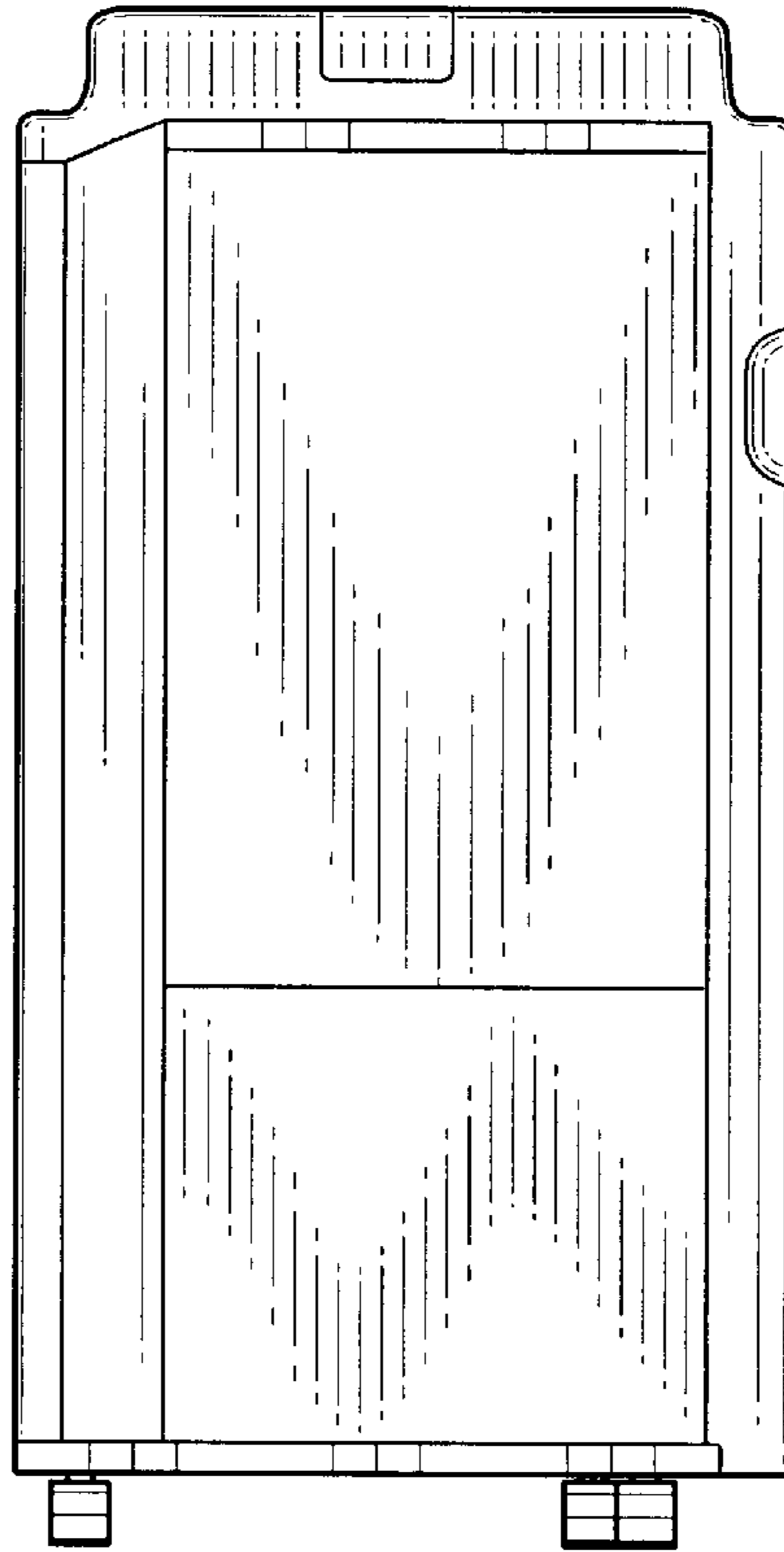
