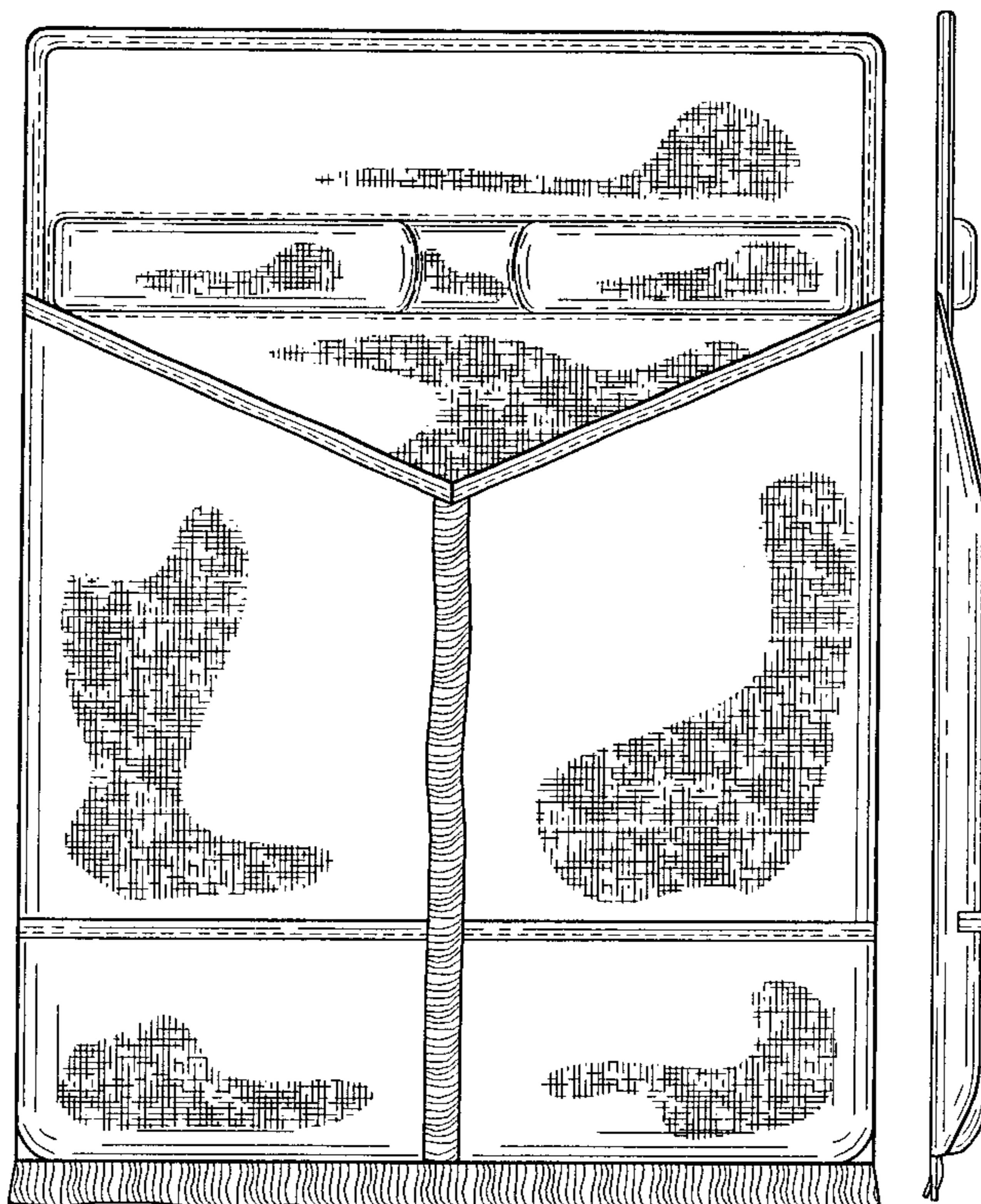
The ornamental design for a infant wrap with pockets, as shown and described.

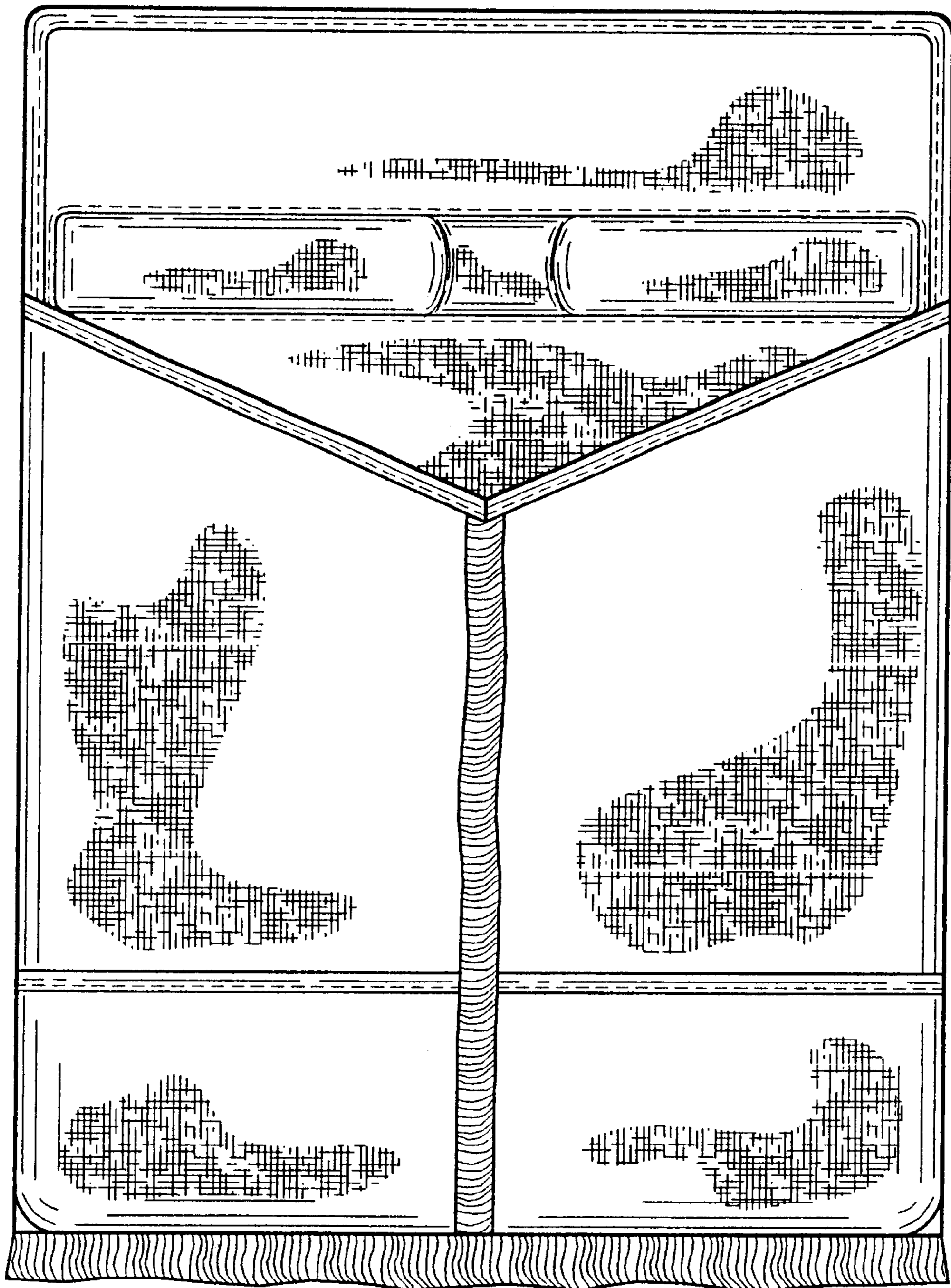

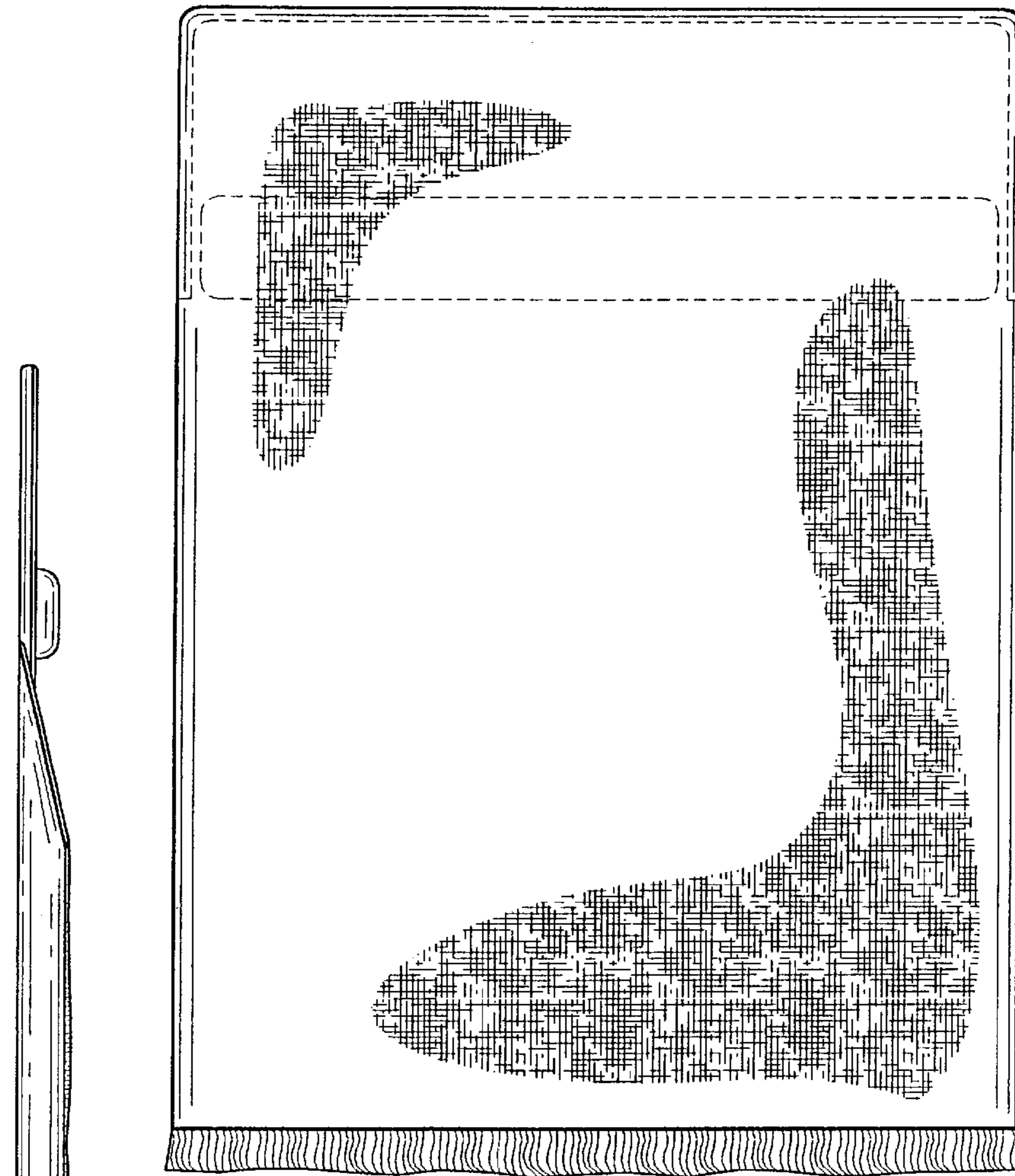

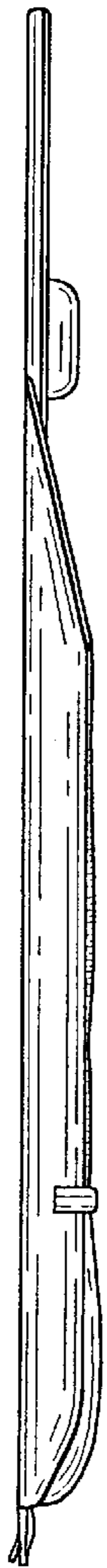
