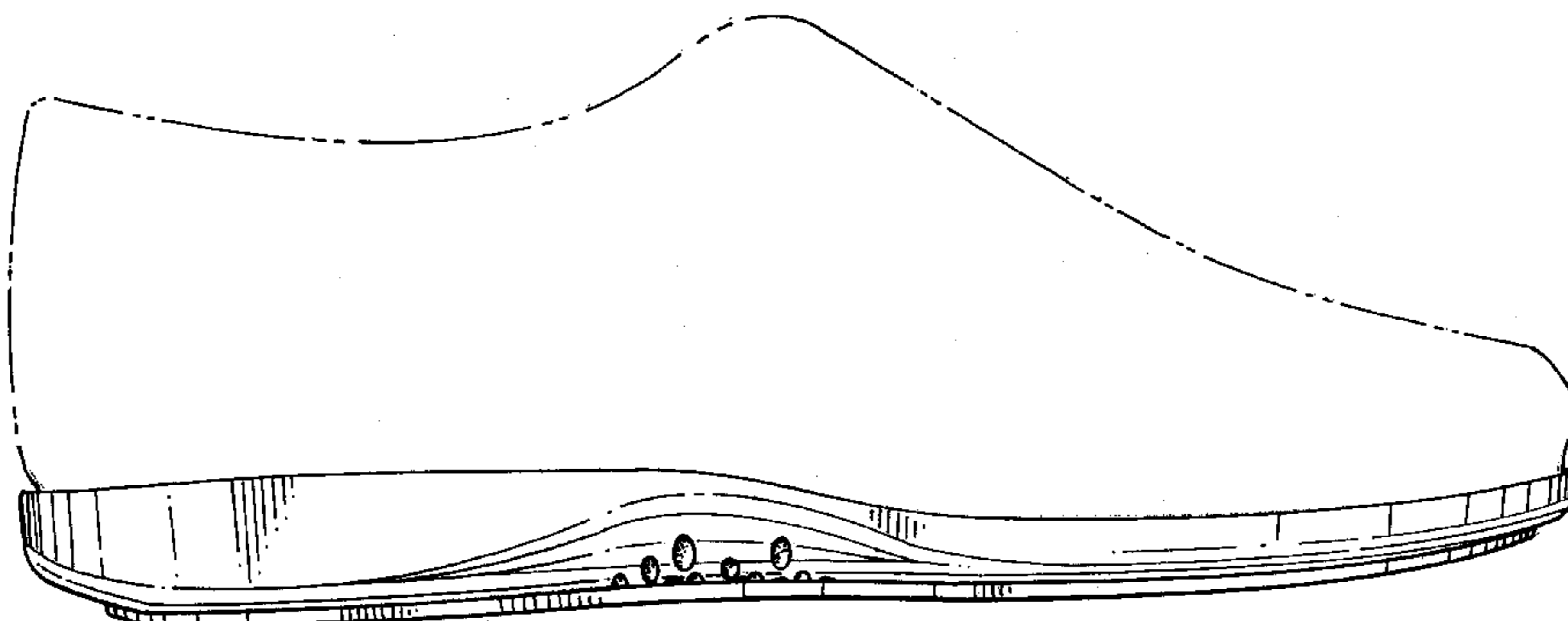
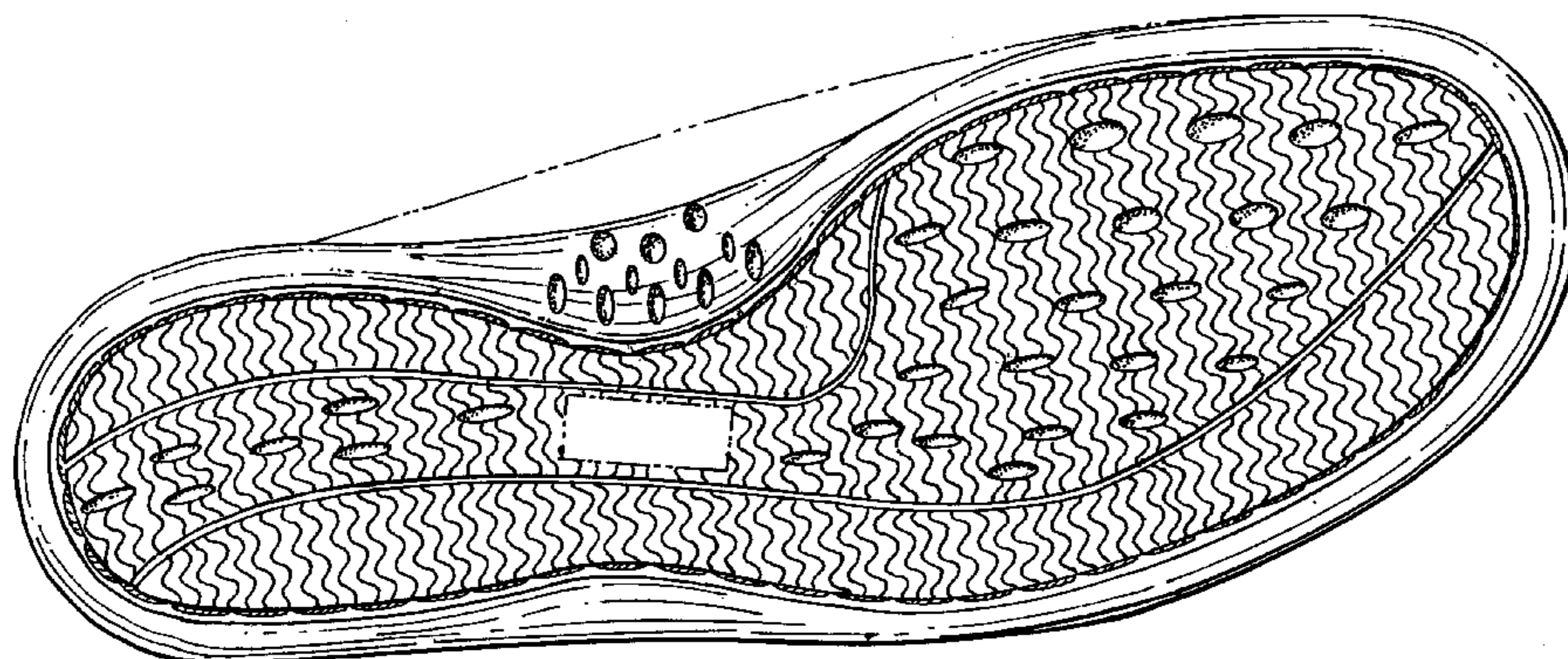
(57) **CLAIM**

I claim the ornamental design for an outsole for a shoe, as shown and described in the drawings.

**DESCRIPTION**

FIG. 1 is a bottom view of an outsole for a shoe in accordance with the new design;  
 FIG. 2 is a right side view of the outsole for a shoe in accordance with the embodiment of the new design shown in FIG. 1;  
 FIG. 3 is a left side view of the outsole for a shoe in accordance with the embodiment of the new design shown in FIG. 1;  
 FIG. 4 is a front view of the outsole for a shoe in accordance with the embodiment of the new design shown in FIG. 1; and  
 FIG. 5 is a back view of the outsole for a shoe in accordance with the embodiment of the new design shown in FIG. 1; and,  
 FIG. 6 is a perspective view thereof.

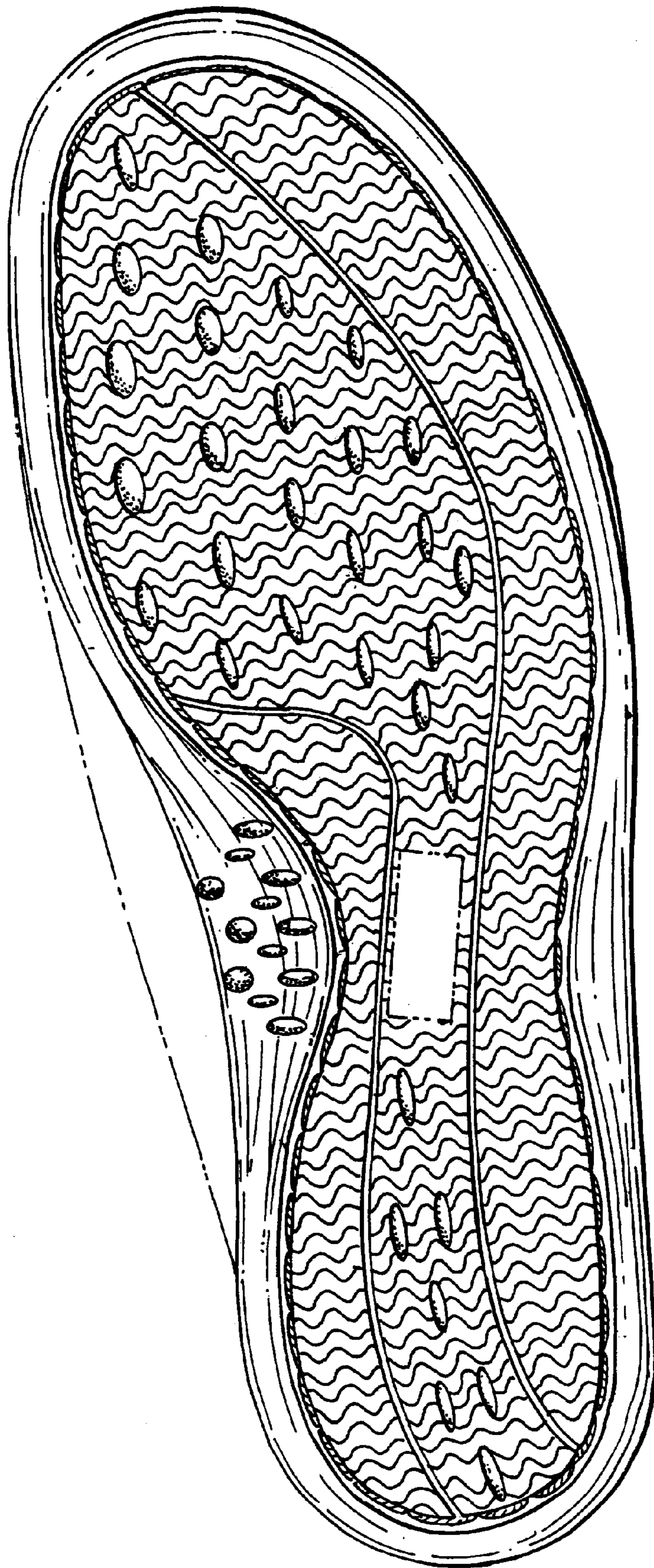

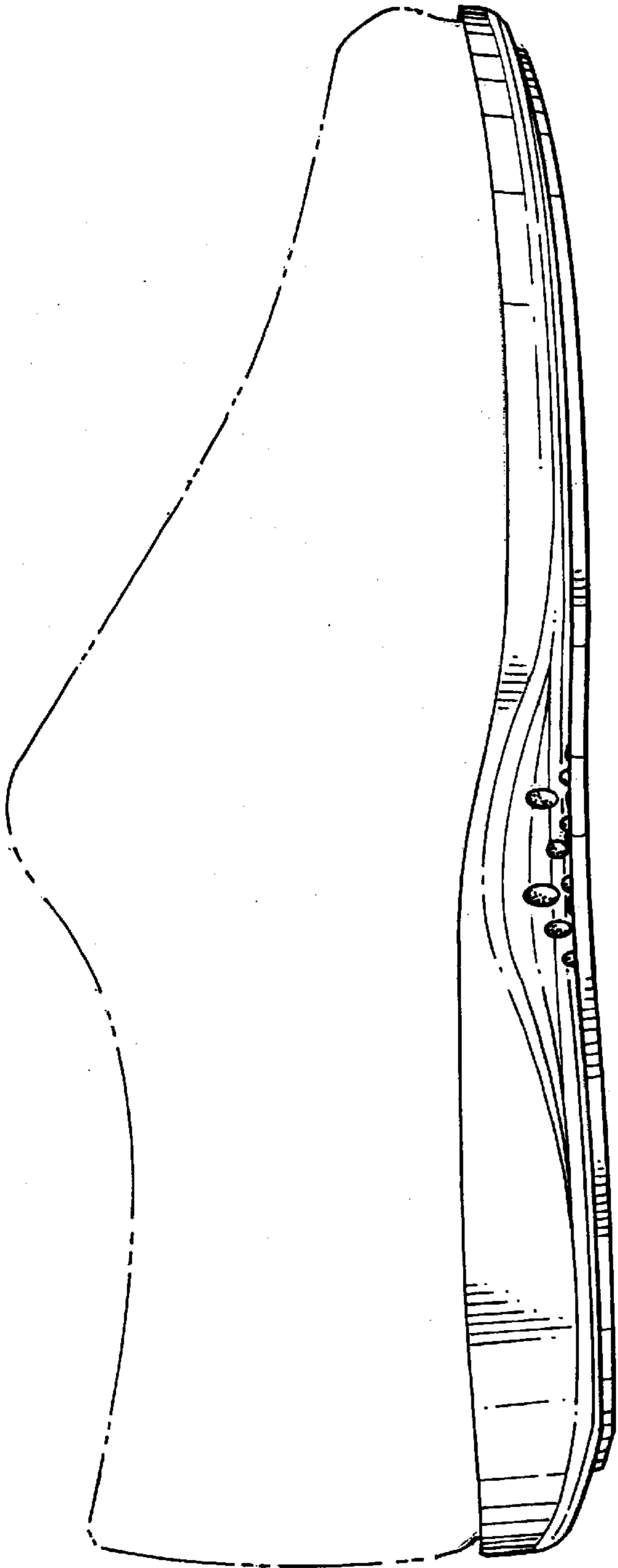

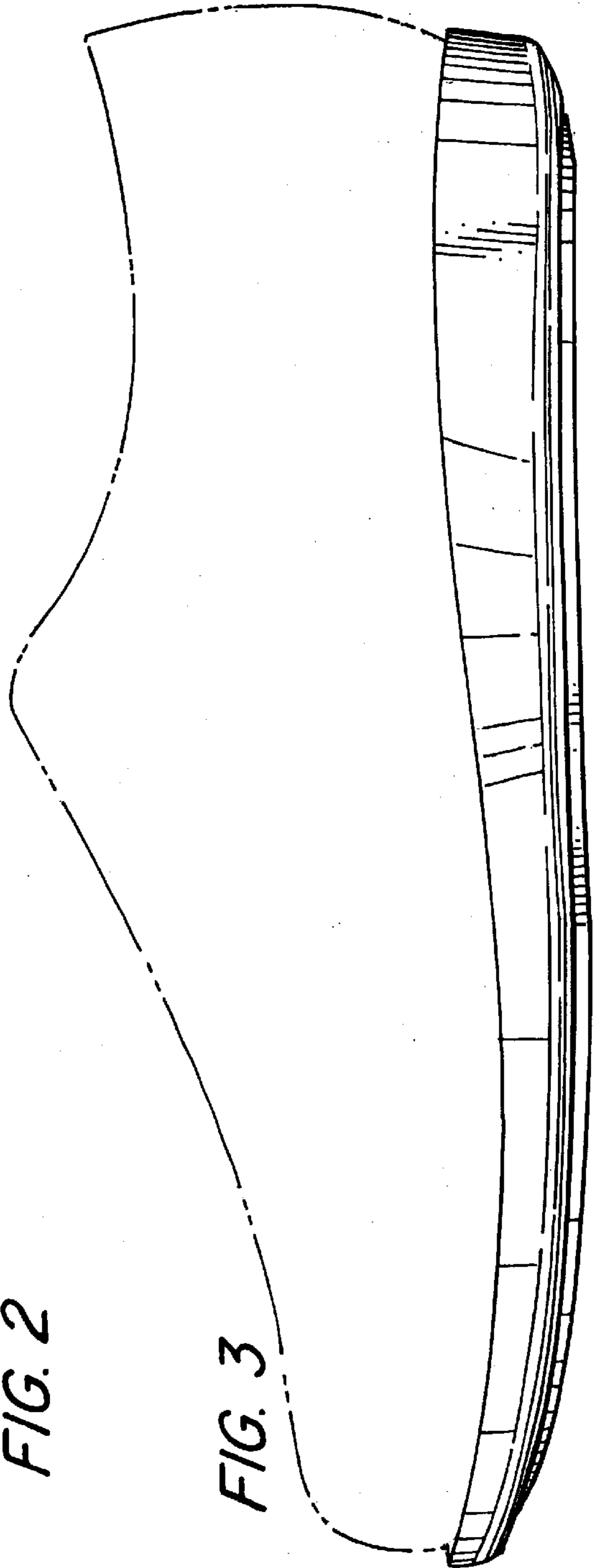
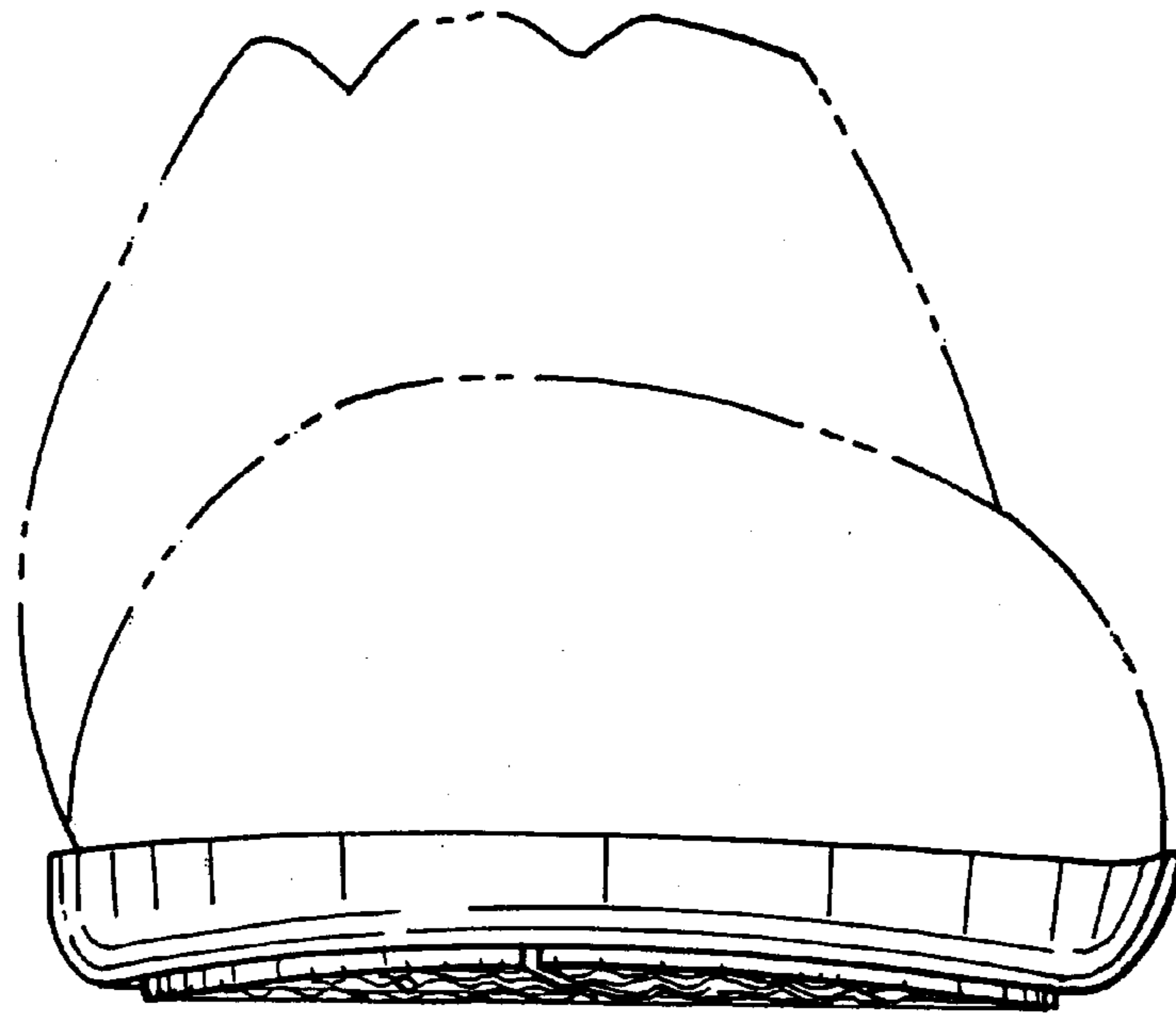
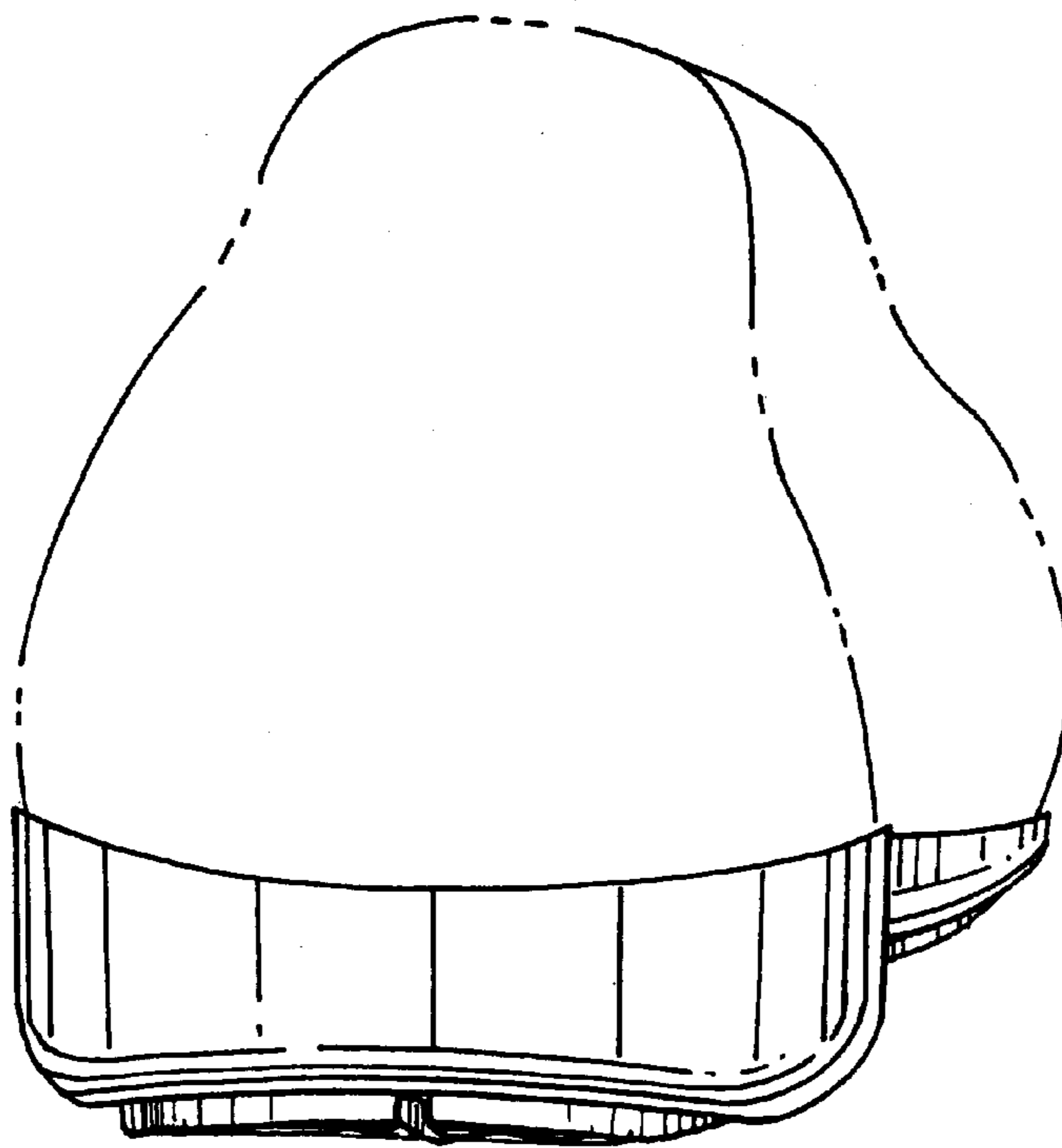


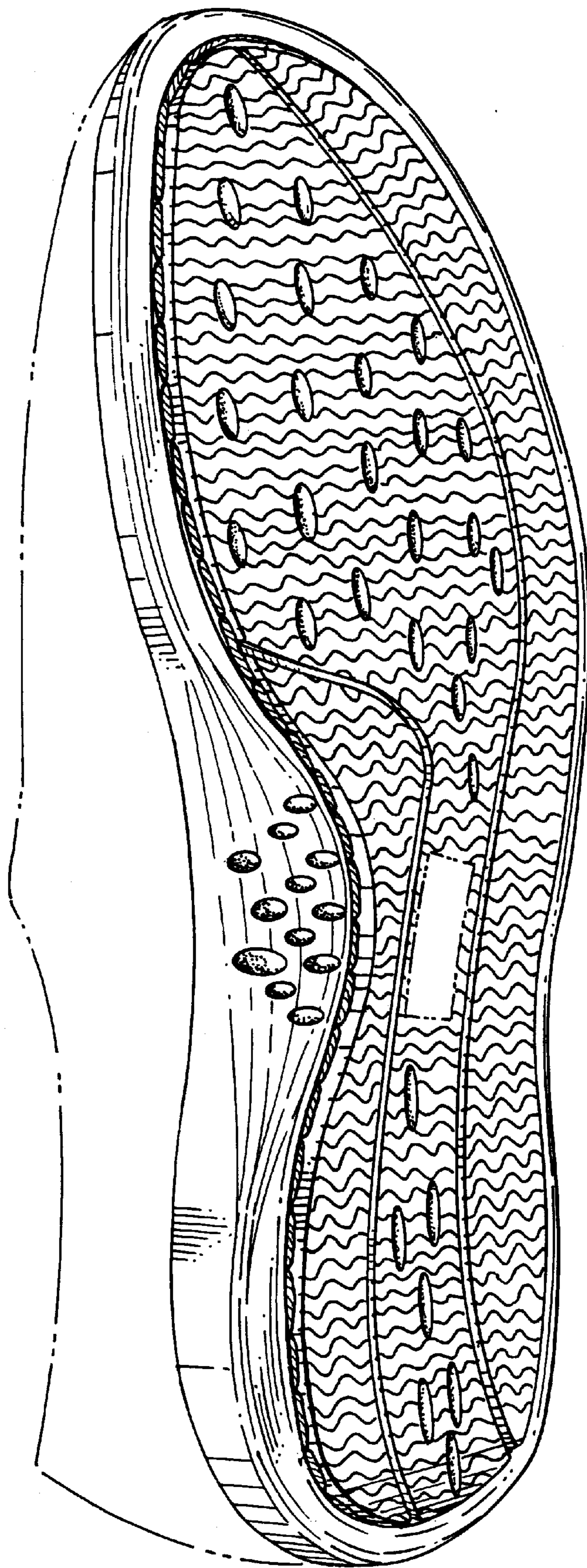
