The ornamental design for a passport carrier, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of the passport carrier showing our new design;
FIG. 2 is a rear perspective view of the passport carrier;
FIG. 3 is a front view of the passport carrier;
FIG. 4 is a side elevation view of the passport carrier;
FIG. 5 is a top plan view of the passport carrier;
FIG. 6 is a rear elevational view of the passport carrier;
FIG. 7 is an opposite side elevational view of the passport carrier; and,
FIG. 8 is a bottom plan view of the passport carrier.

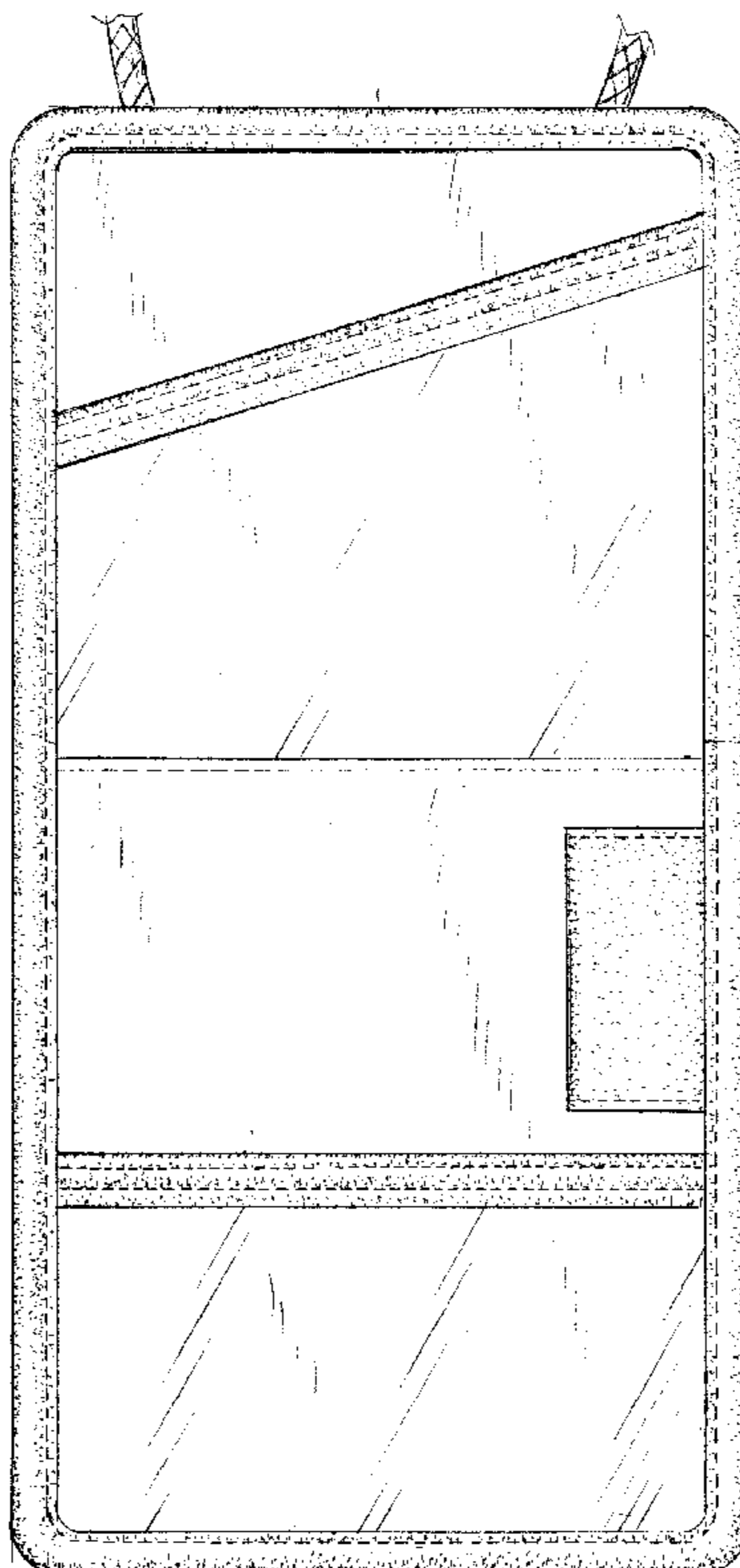

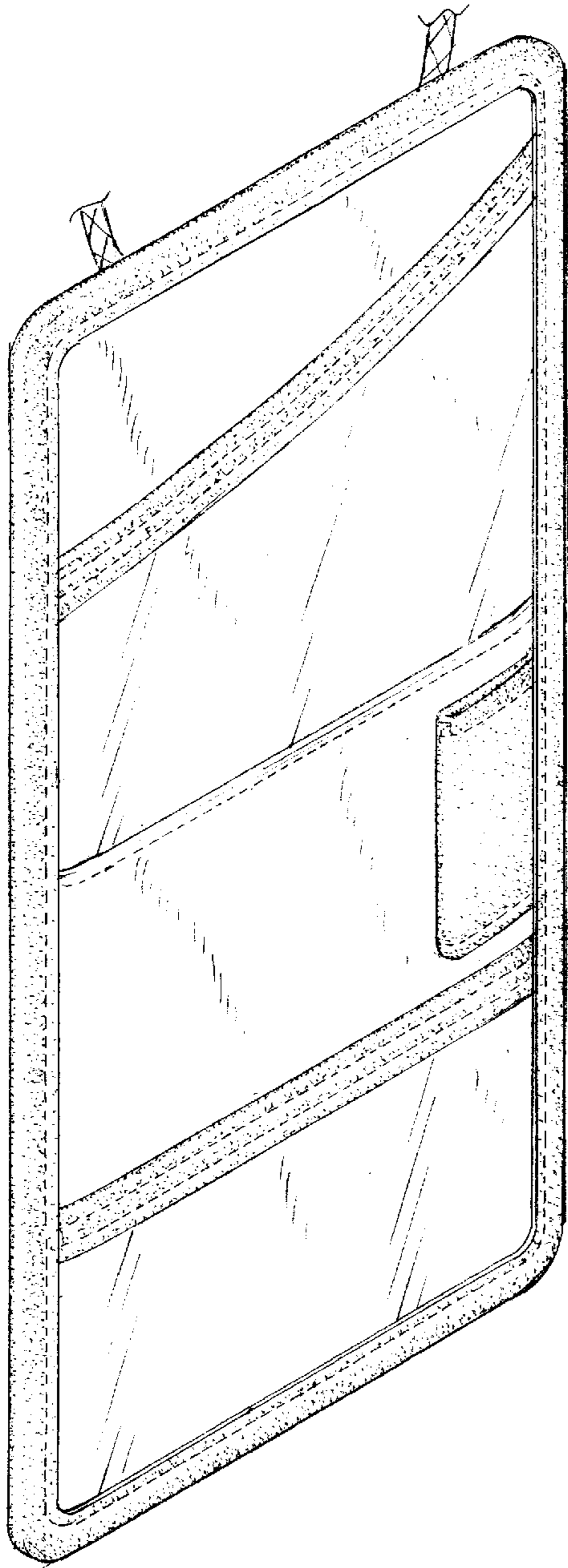

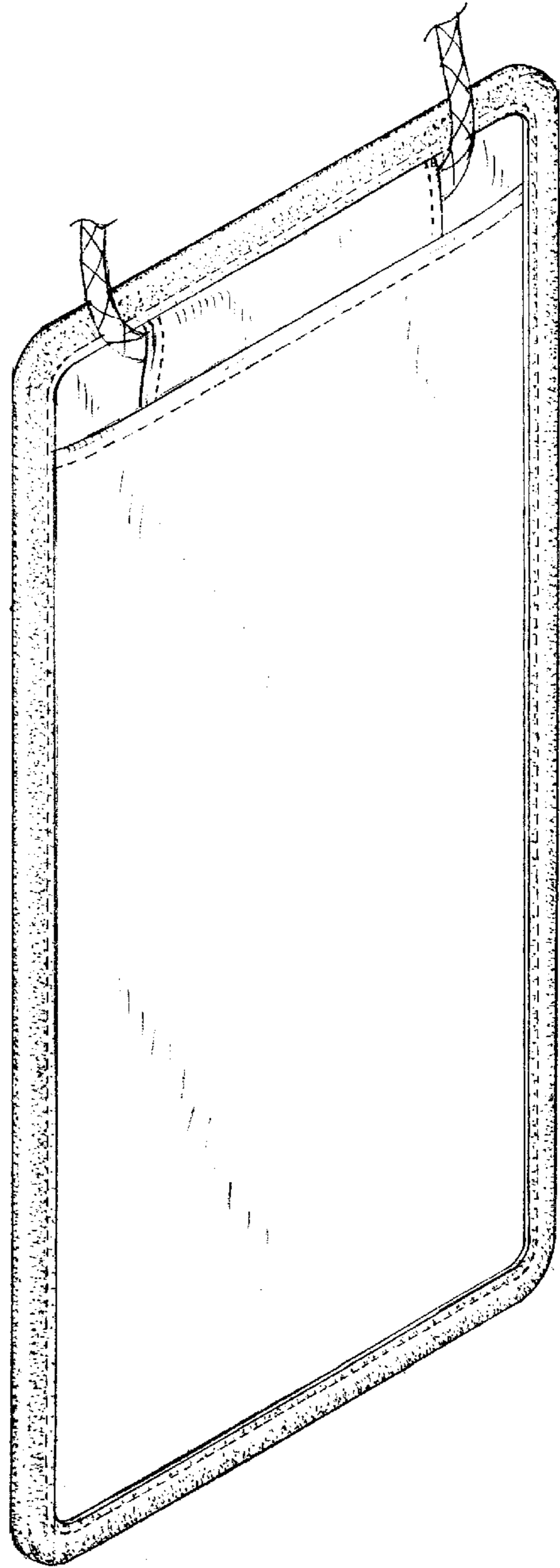

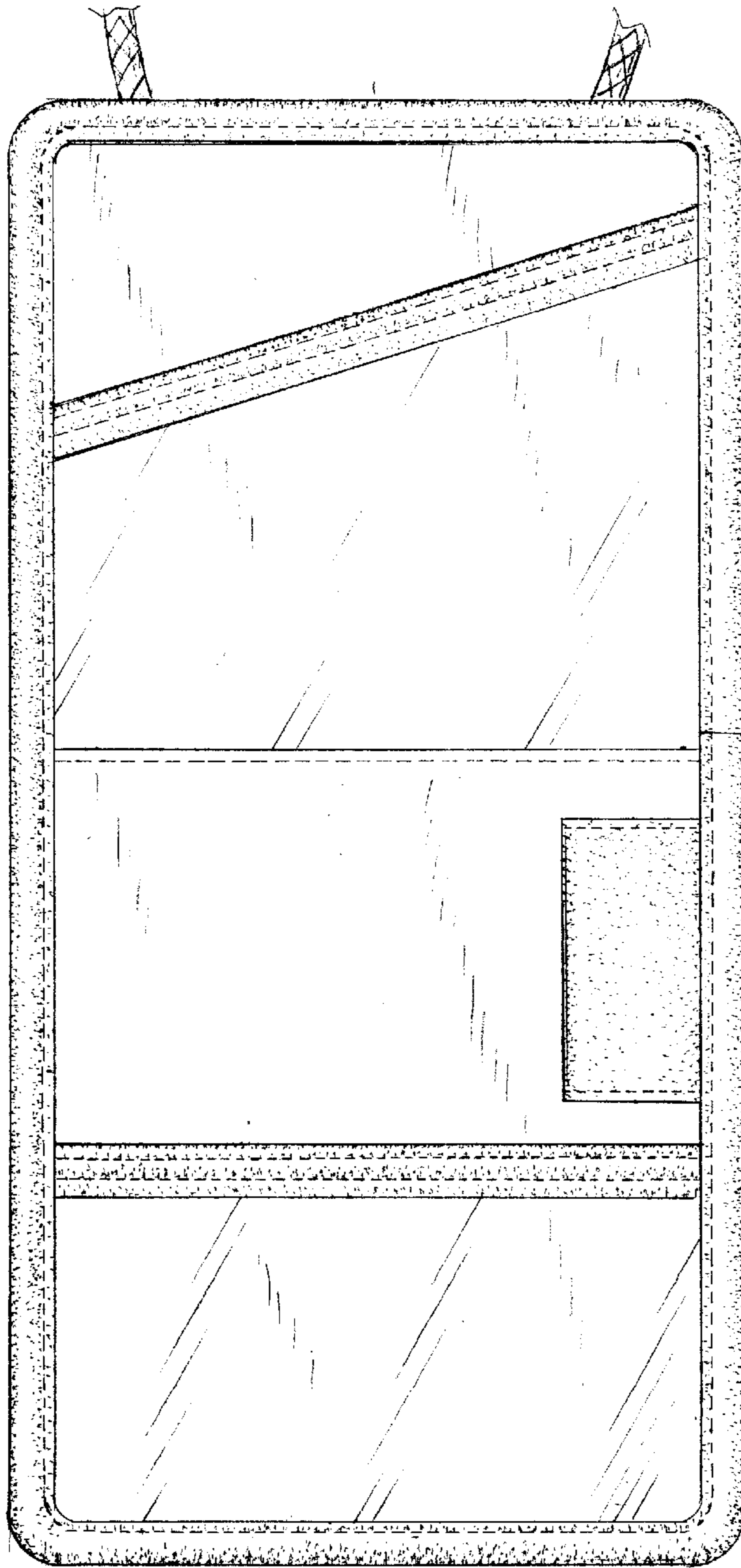

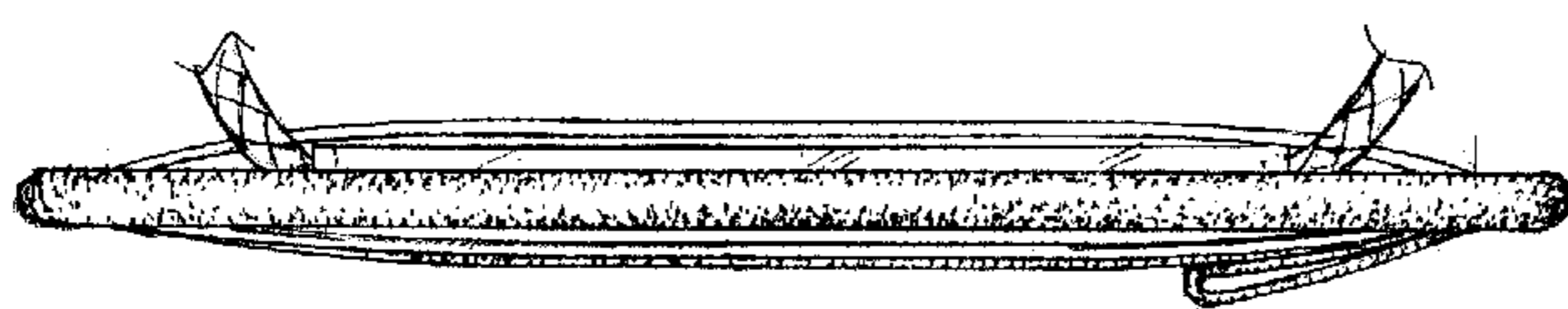
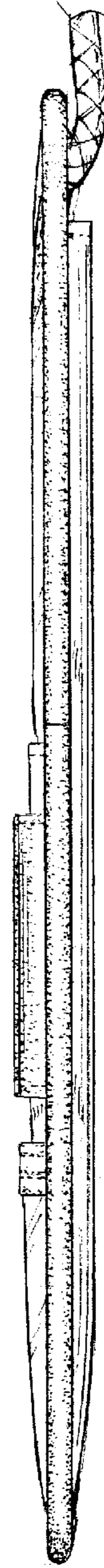

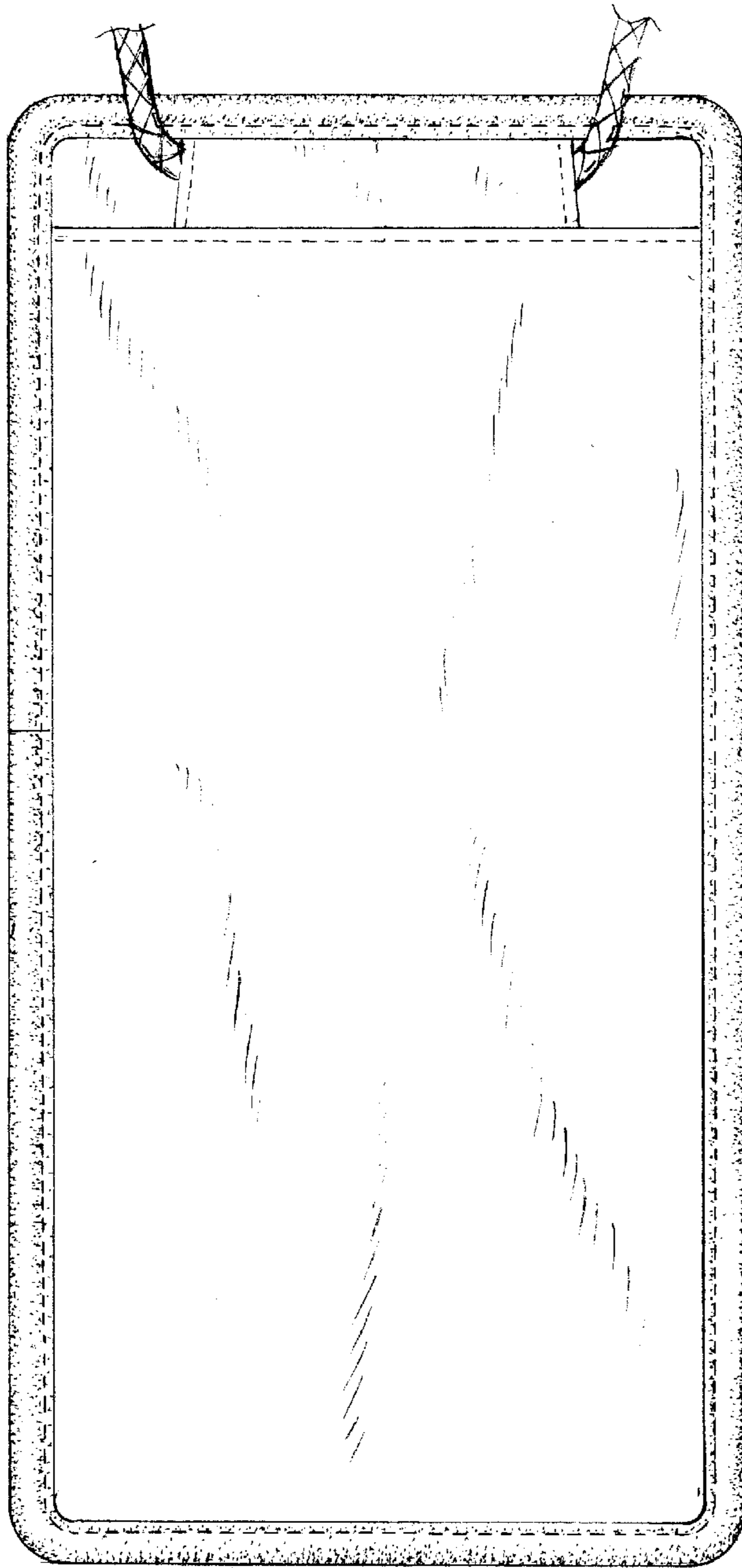

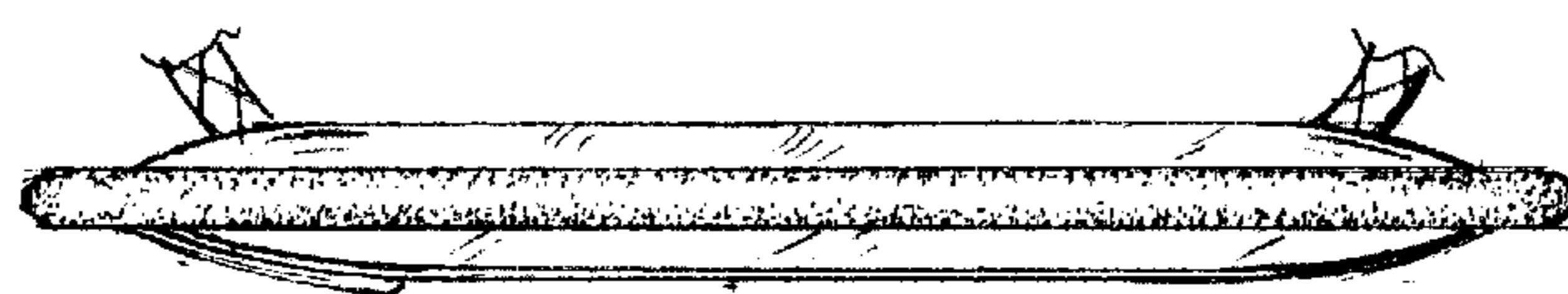
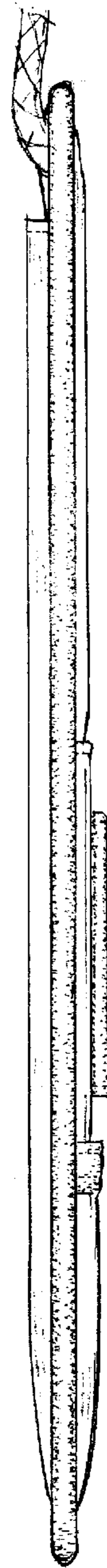
