(57) **CLAIM**

The ornamental design for a foil roaster tent, substantially as shown and described.

**DESCRIPTION**

FIG. 1 is a top perspective view of a folded foil roaster tent showing my new design;

FIG. 2 is a front view of the foil roaster tent of FIG. 1;  
FIG. 3 is a rear view of the foil roaster tent of FIG. 1;  
FIG. 4 is a left side view of the foil roaster tent of FIG. 1 with the right side plan view being a mirror image thereof;  
FIG. 5 is a top plan view of the foil roaster tent FIG. 1;  
FIG. 6 is a bottom plan view of the foil roaster tent of FIG. 1;  
FIG. 7 is a top perspective view of the unfolded open foil roaster tent of FIG. 1;  
FIG. 8 is a front view of the foil roaster tent of FIG. 7 with the rear plan view being a mirror image thereof;  
FIG. 9 is a right side view of the foil roaster tent of FIG. 7 with the left side plan view being a mirror image thereof;  
FIG. 10 is a top plan view of the foil roaster tent FIG. 7;  
FIG. 11 is a bottom plan view of the foil roaster tent of FIG. 7;  
FIG. 12 is a top perspective view of the in use foil roaster tent of FIG. 1;  
FIG. 13 is a top plan view of the foil roaster tent FIG. 12;  
FIG. 14 is a front view of the foil roaster tent of FIG. 12 with the rear plan view being a mirror image thereof;  
FIG. 15 is a right side view of the foil roaster tent of FIG. 12 with the left side plan view being a mirror image thereof; and,  
FIG. 16 is a bottom plan view of the foil roaster tent of FIG. 12.

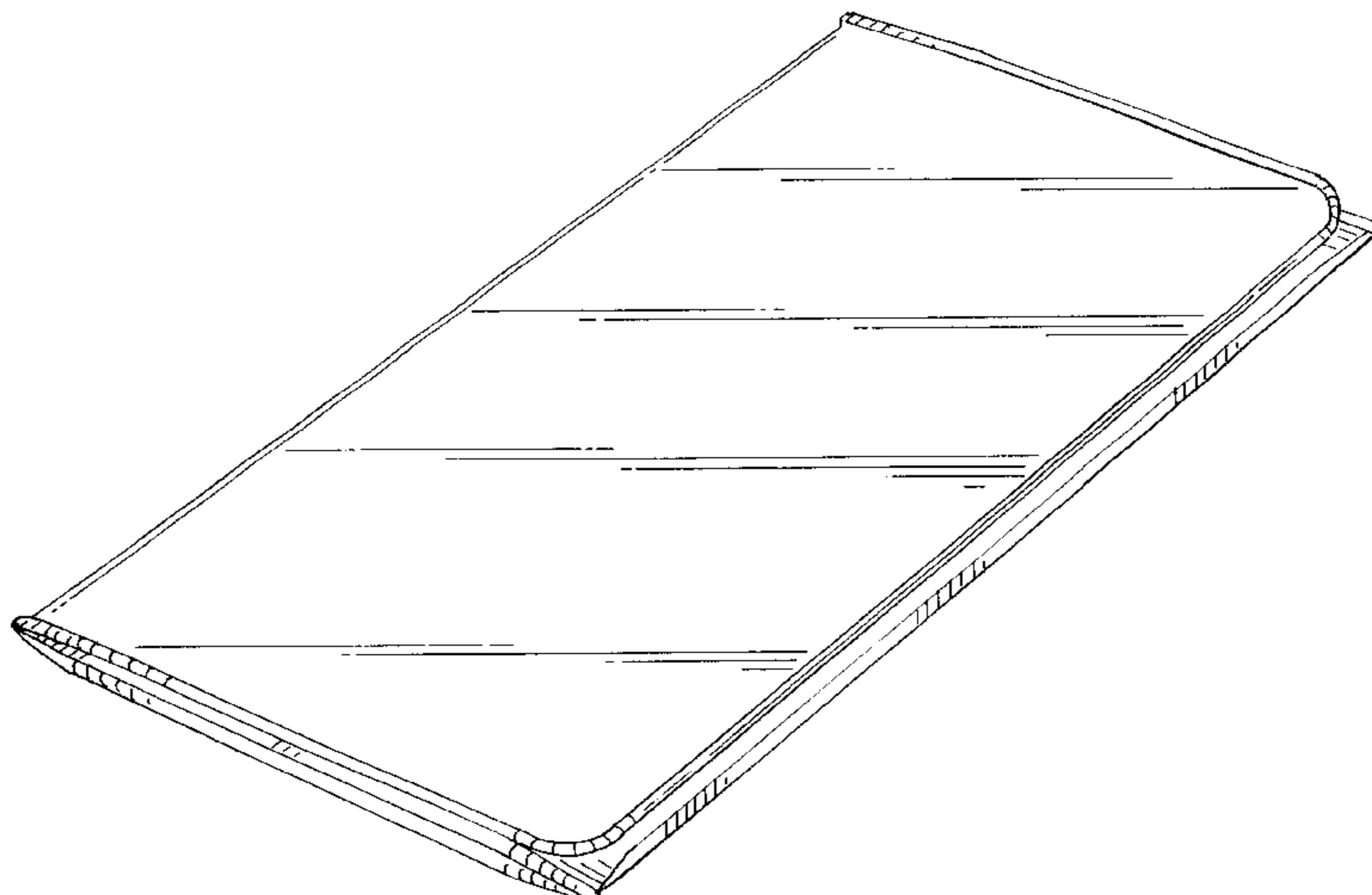

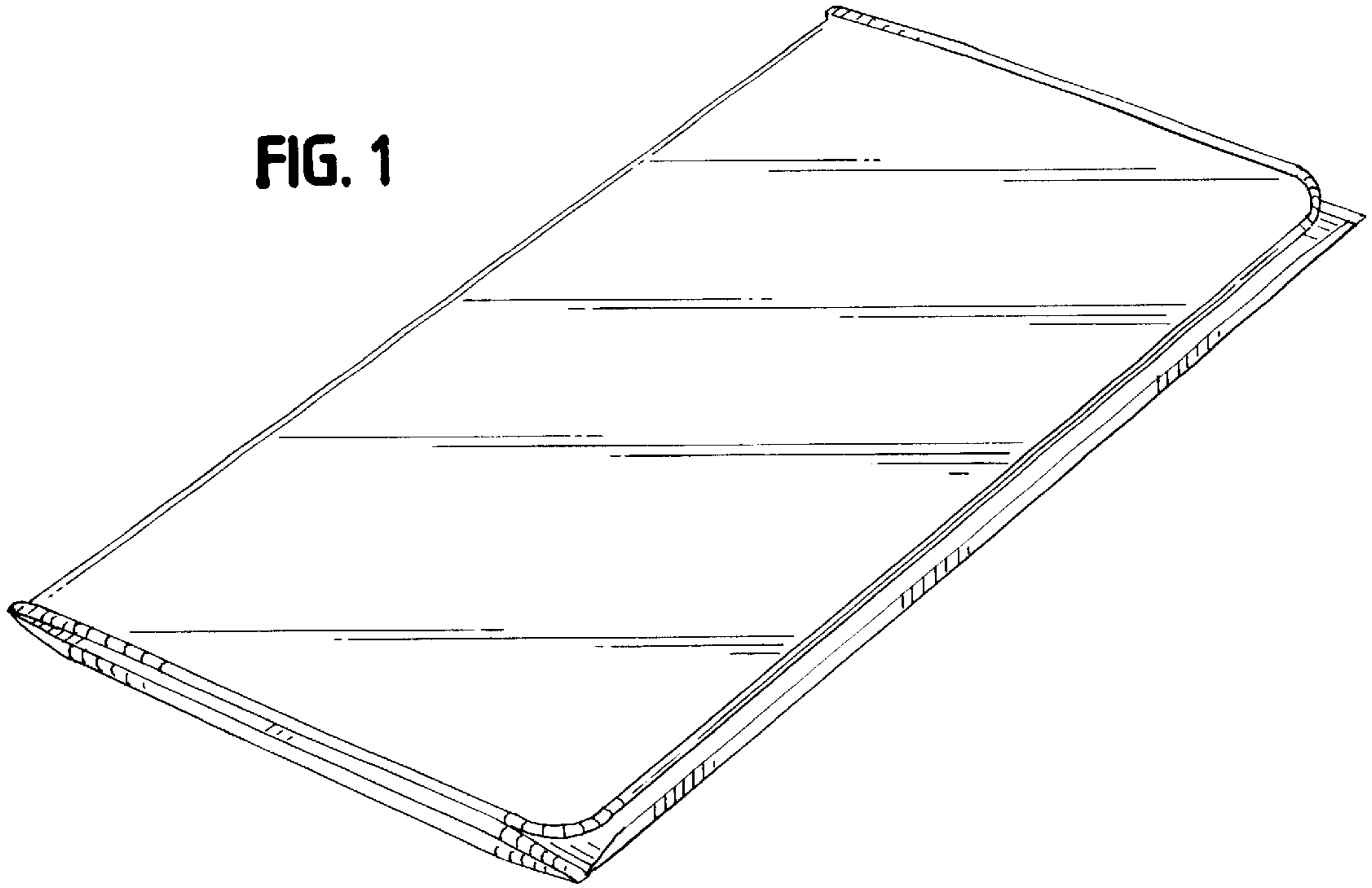

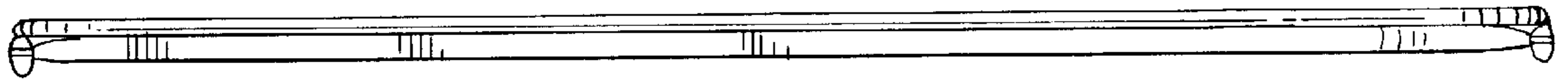

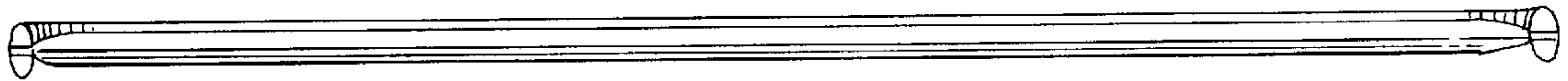

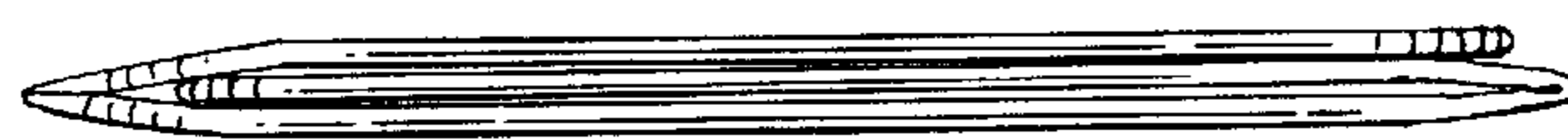

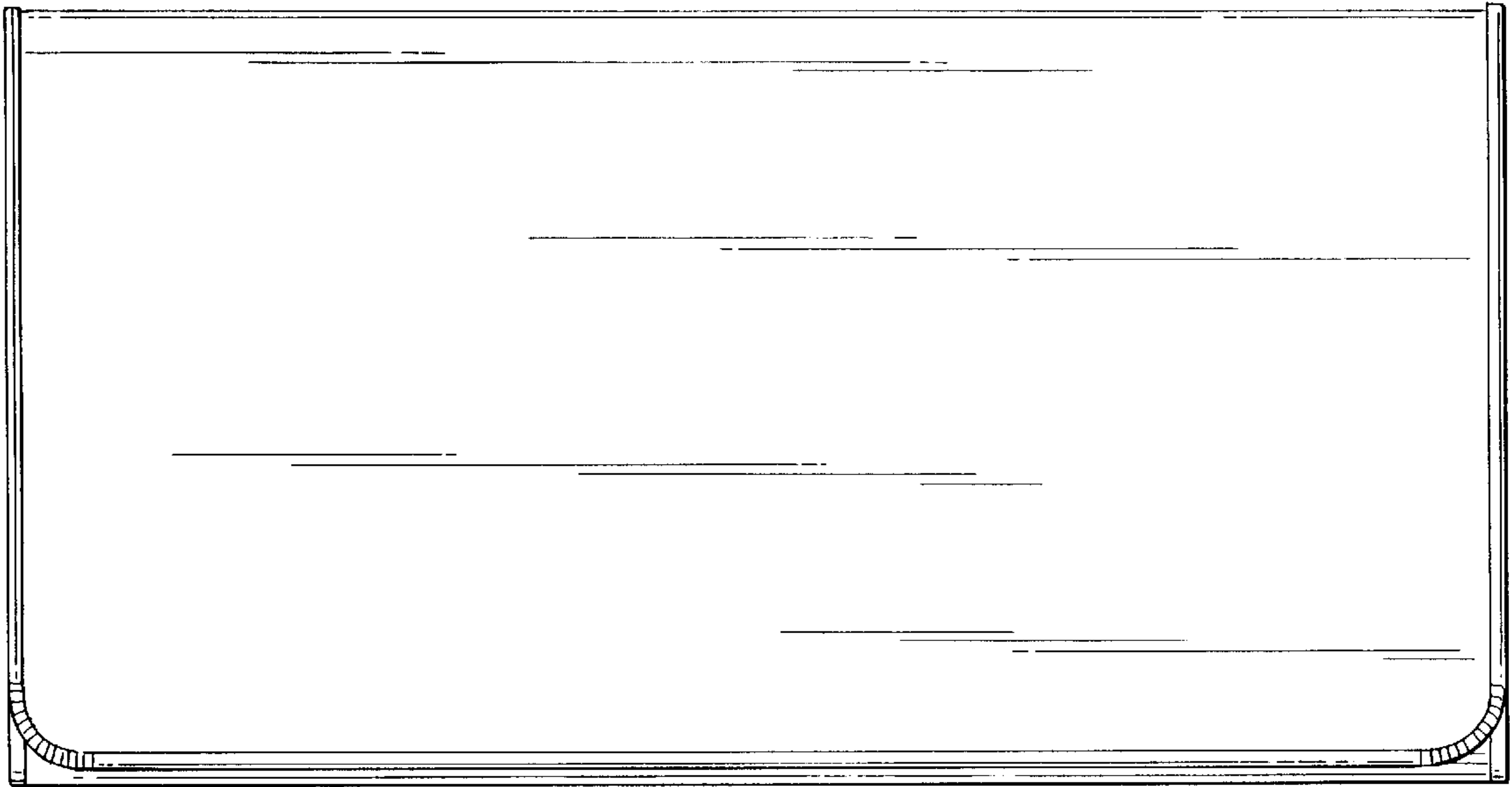

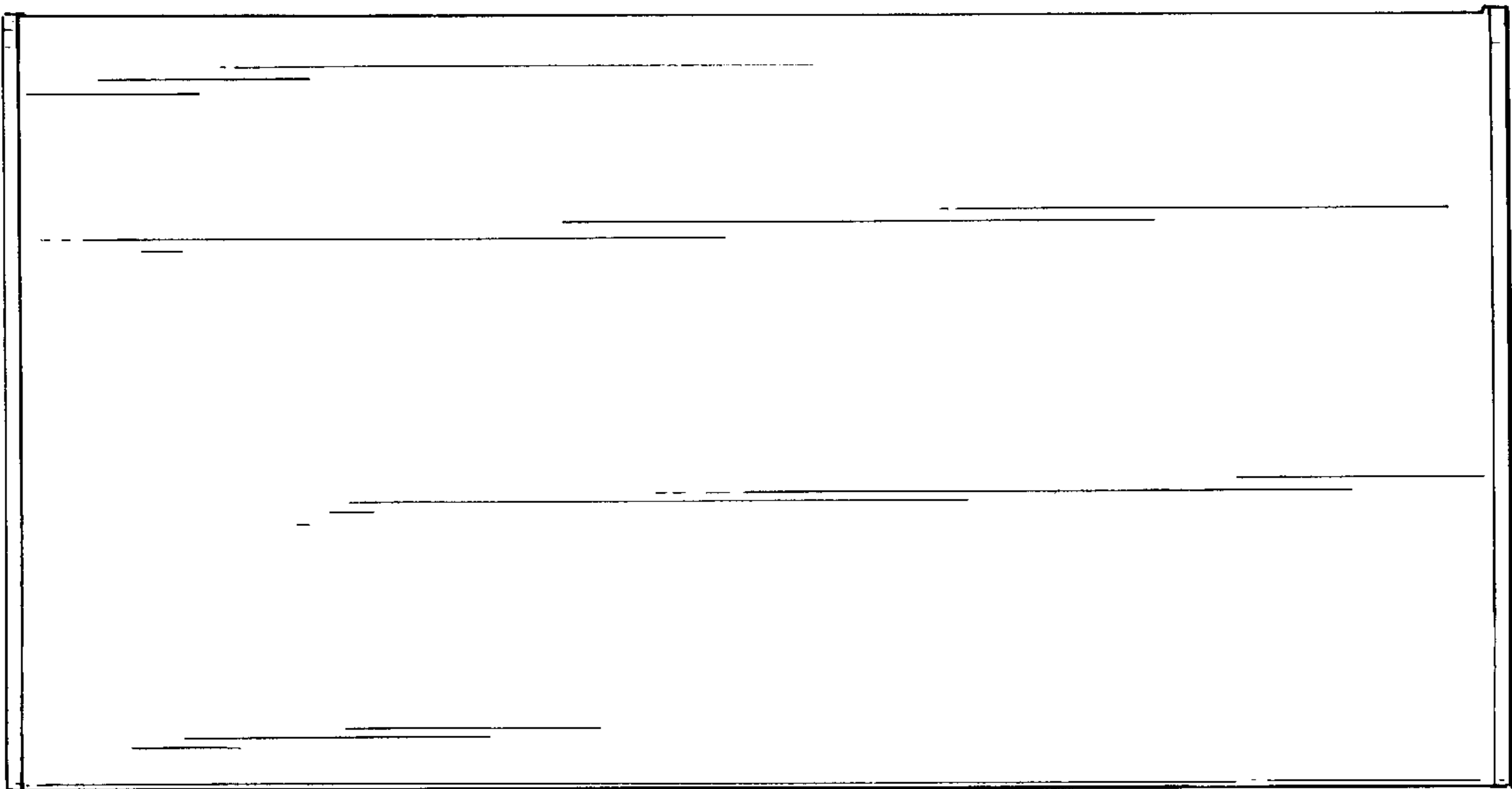

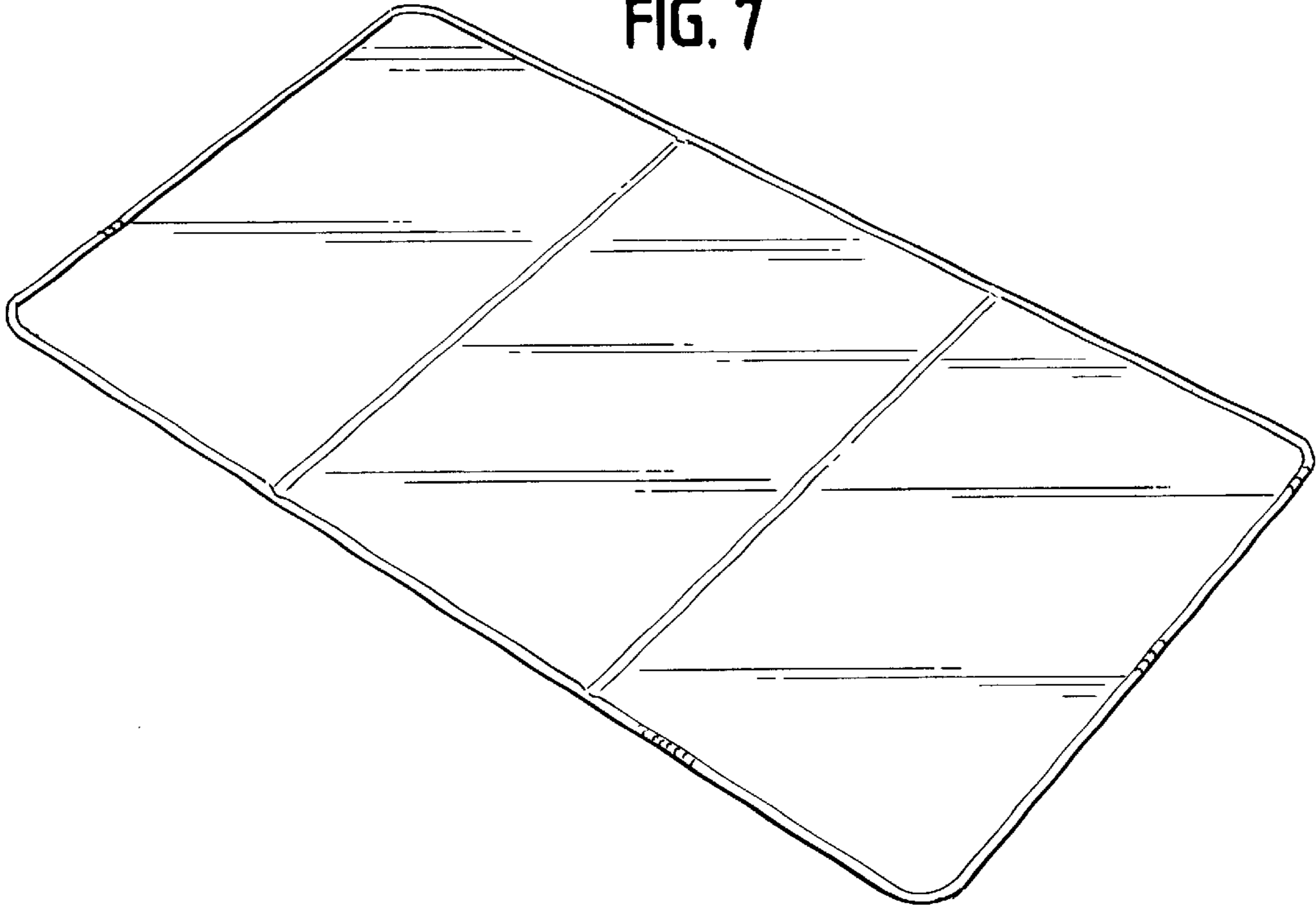

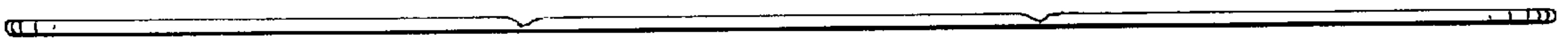

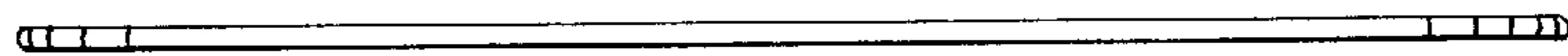

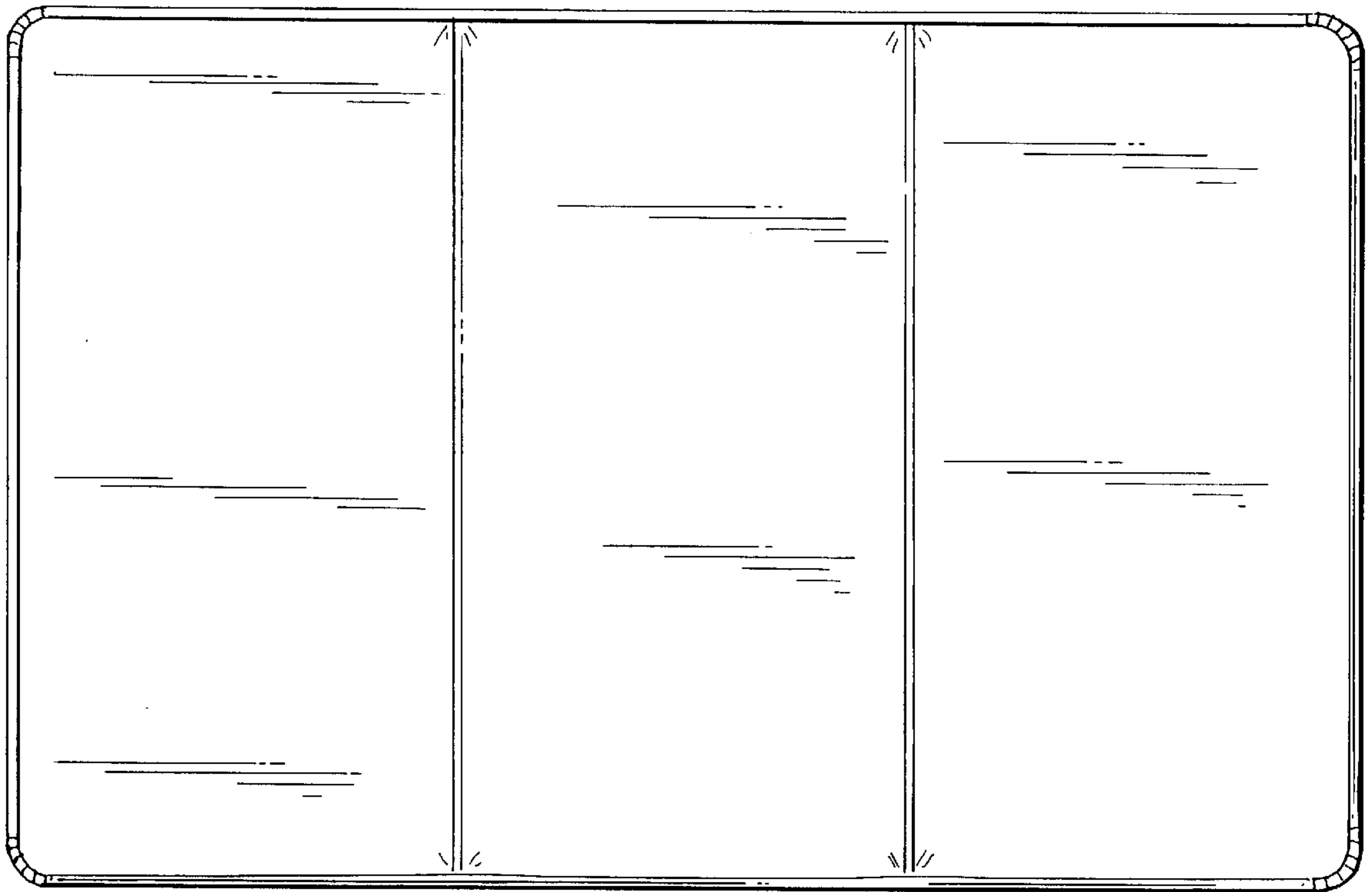

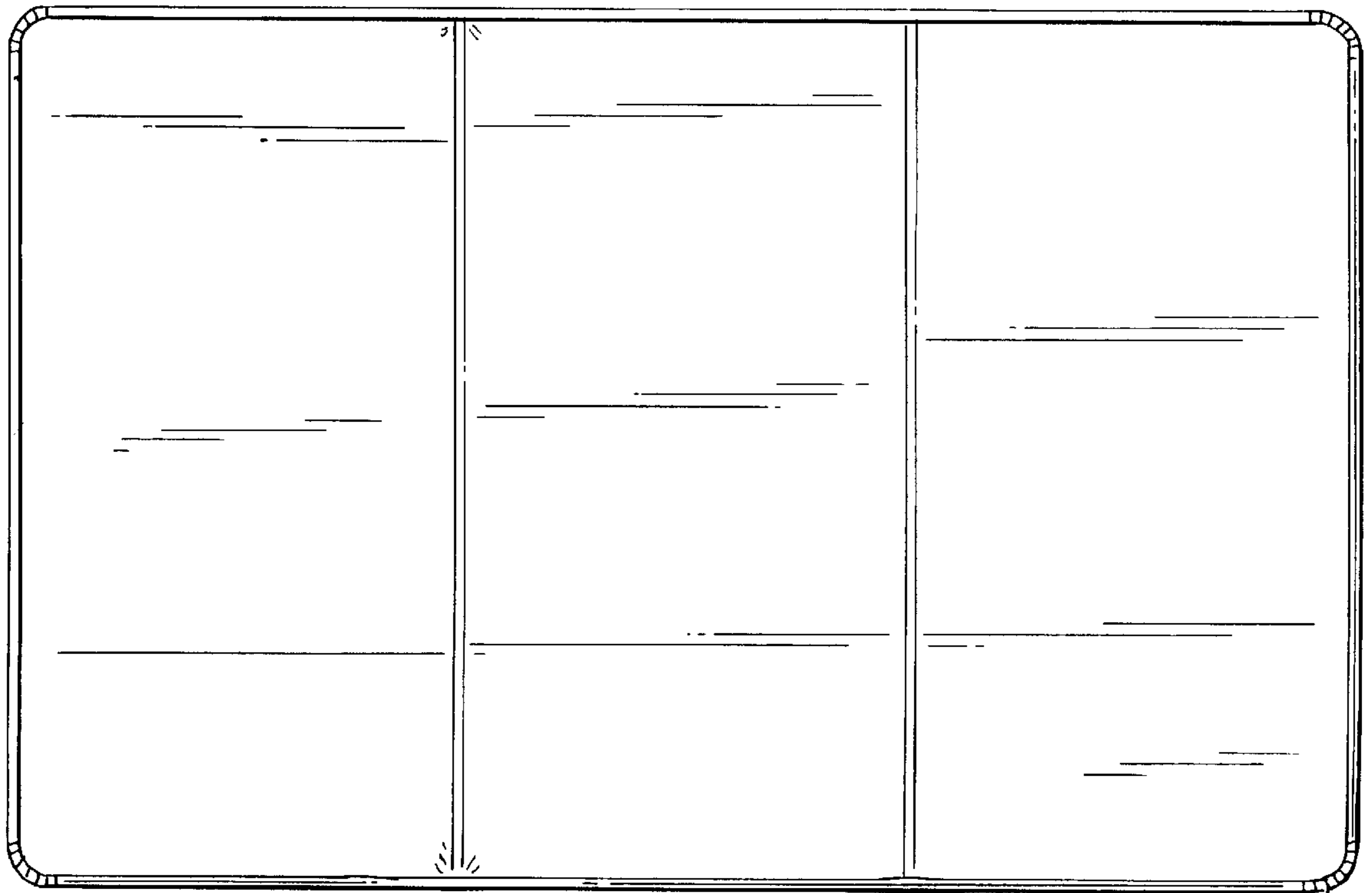

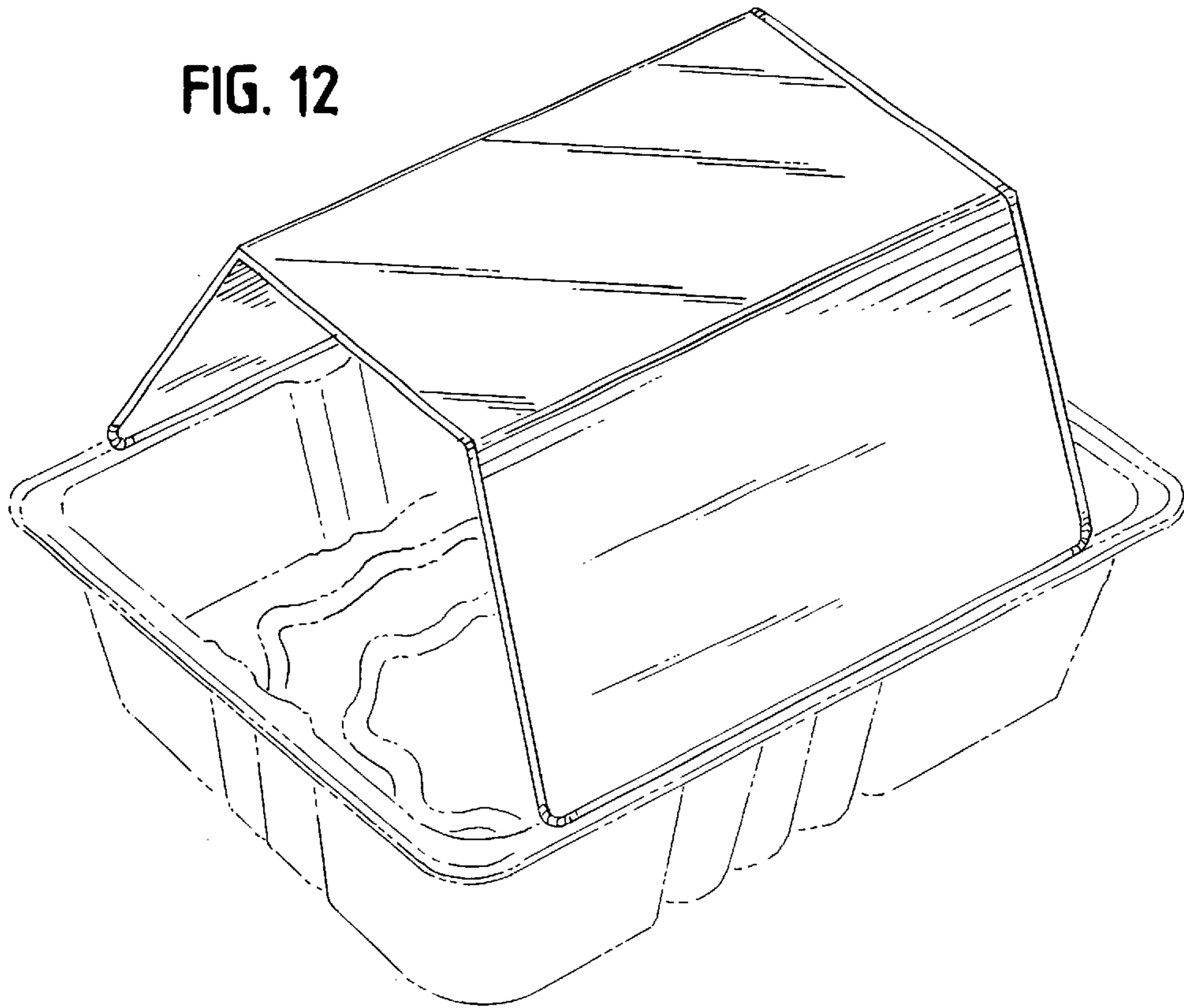

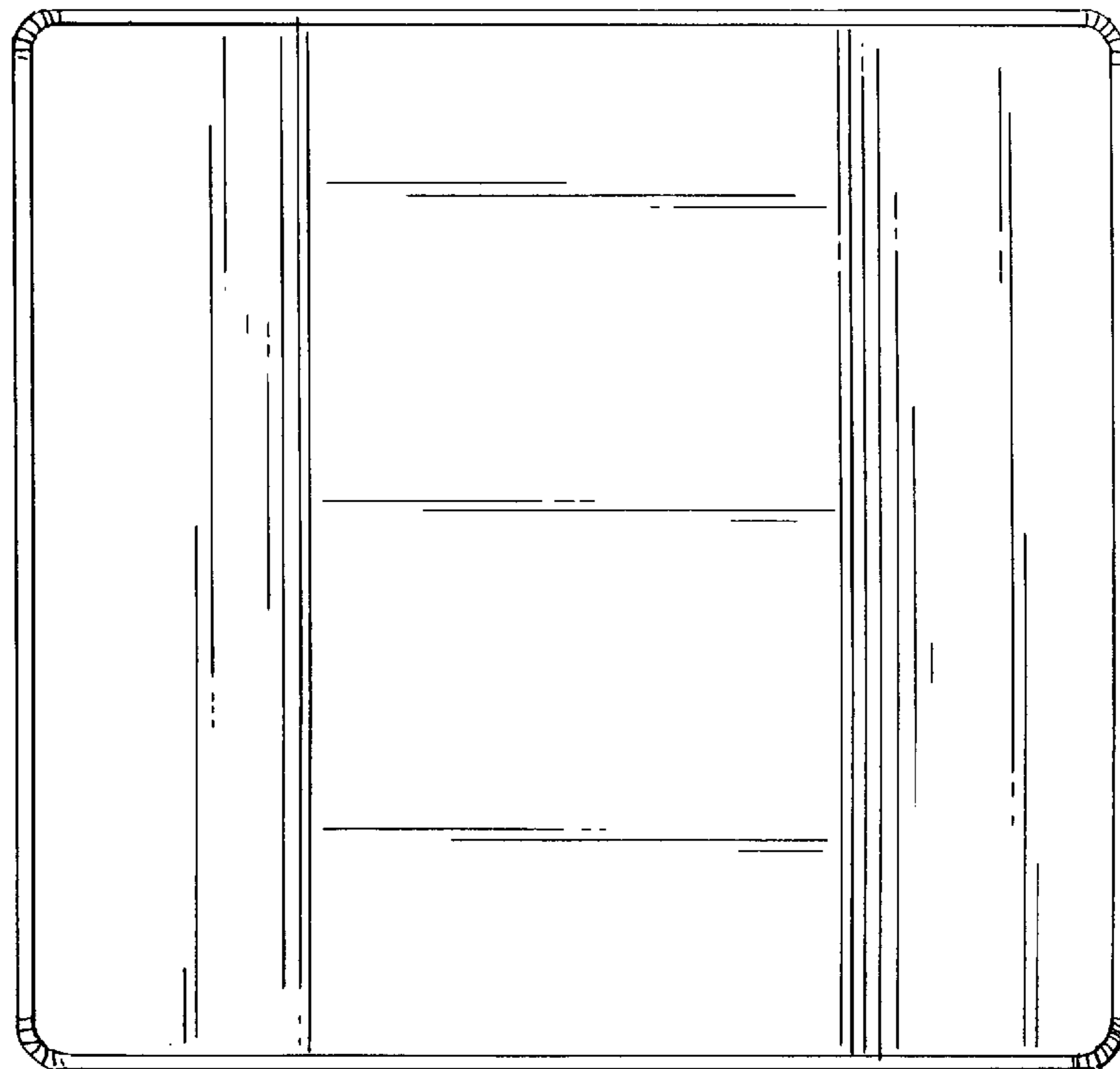

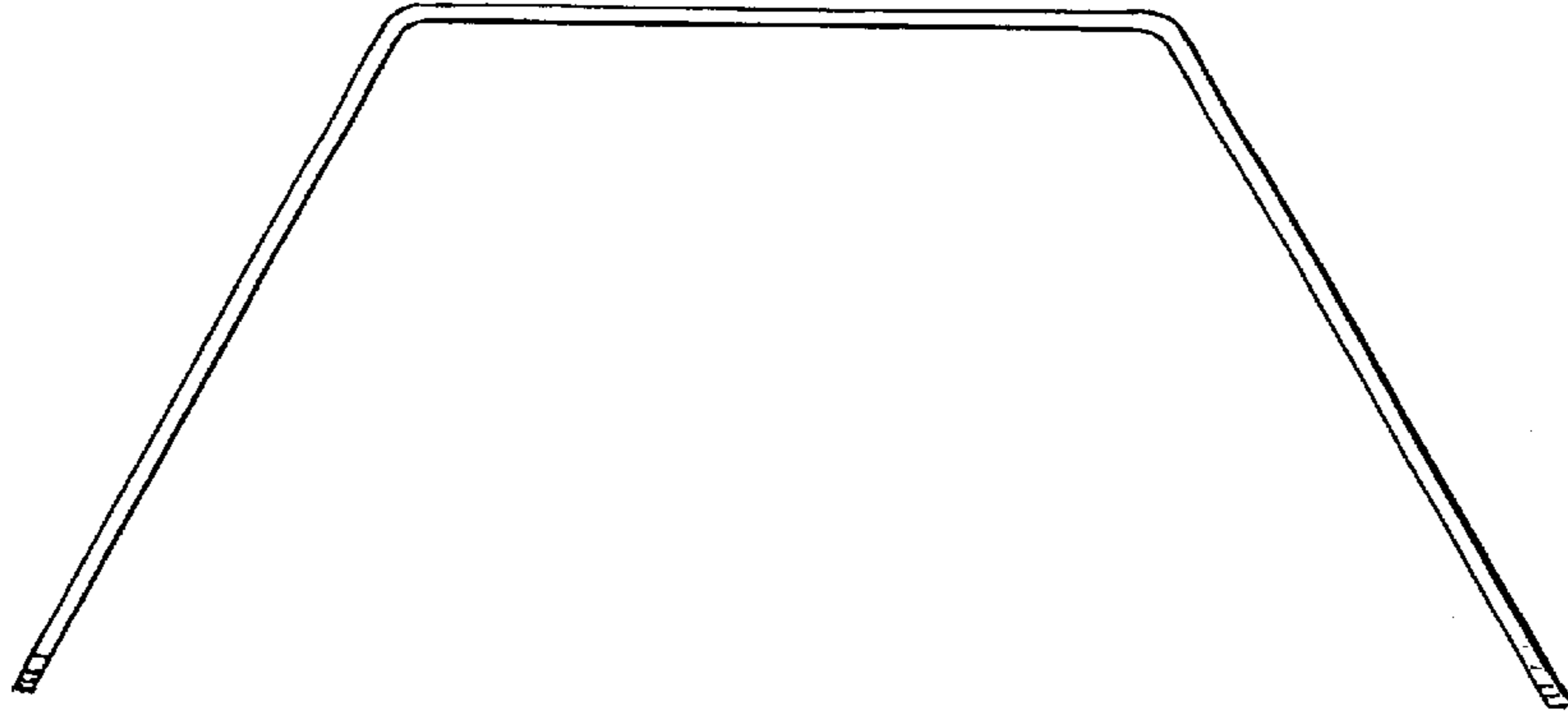

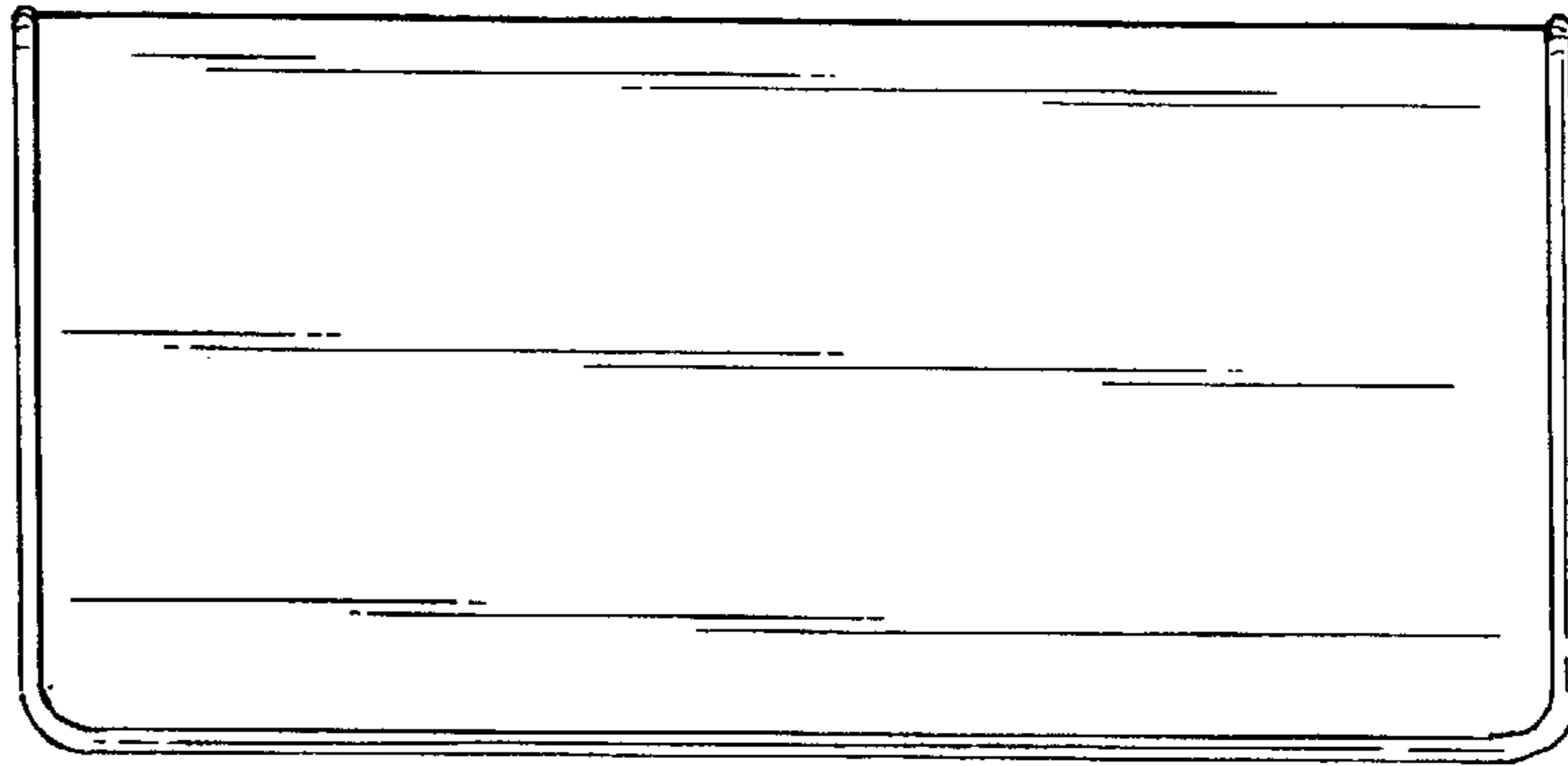
