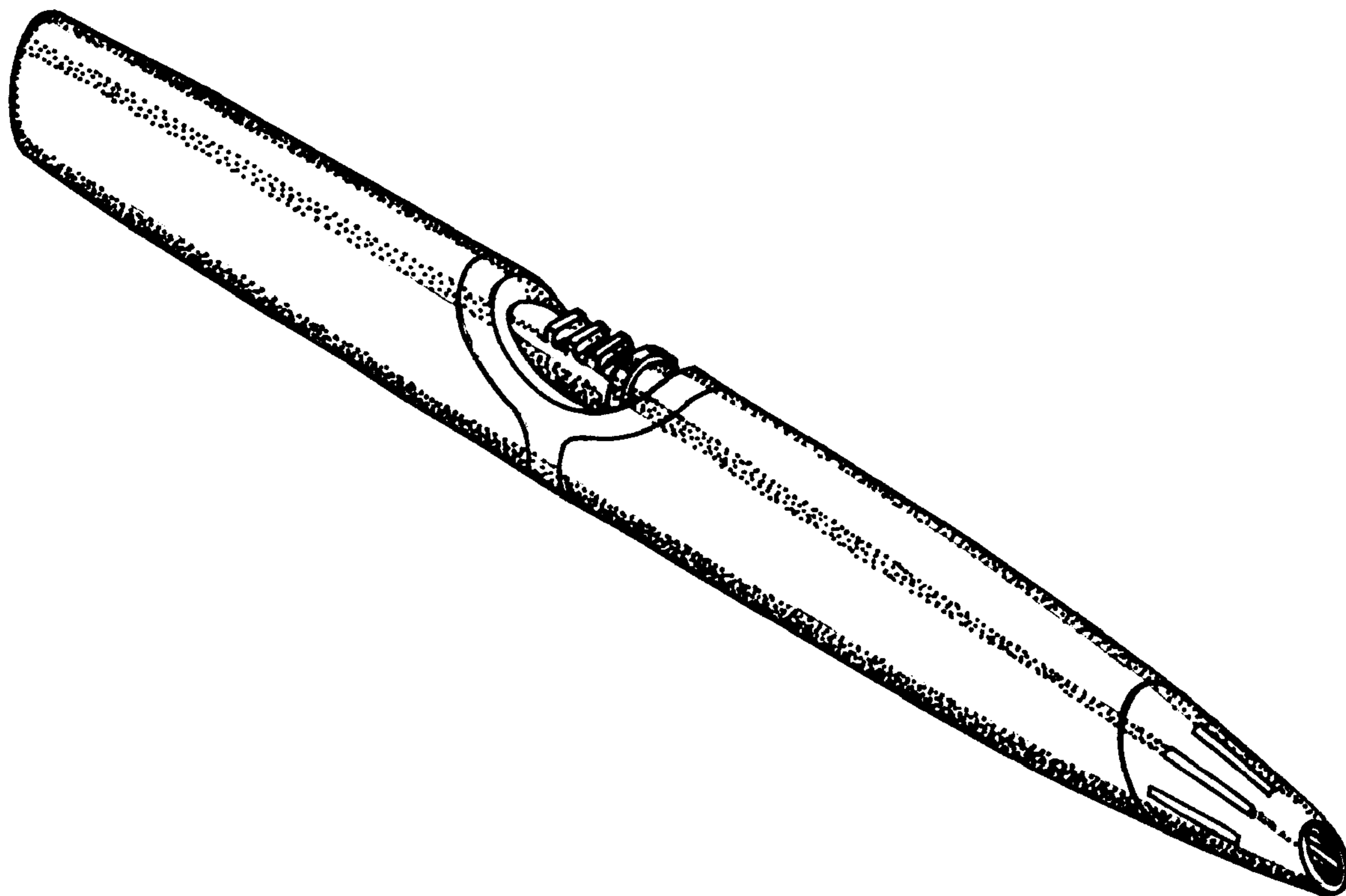
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a left side elevational view of a candle lighter showing our new design;
FIG. 2 is a right side elevational view thereof;
FIG. 3 is a front elevational view thereof;
FIG. 4 is a rear elevational view thereof;

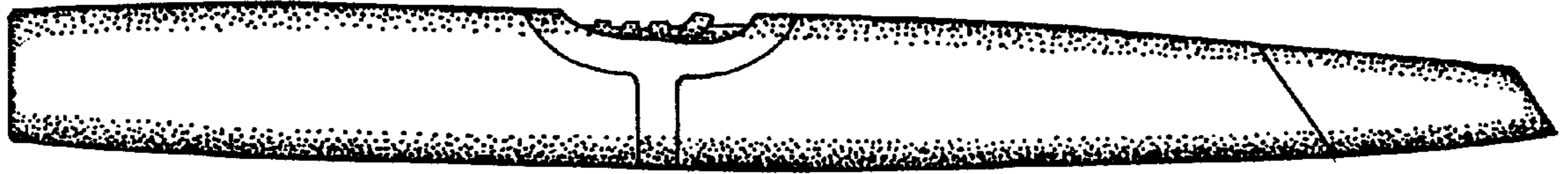

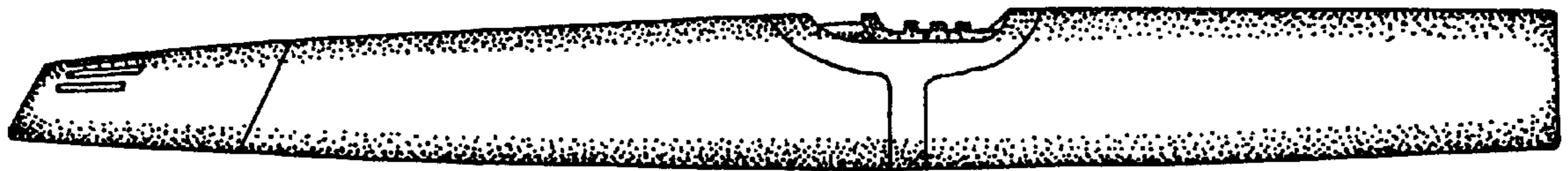

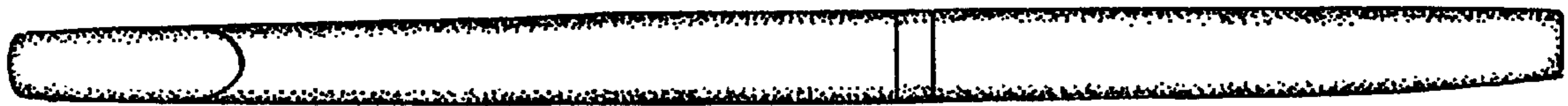

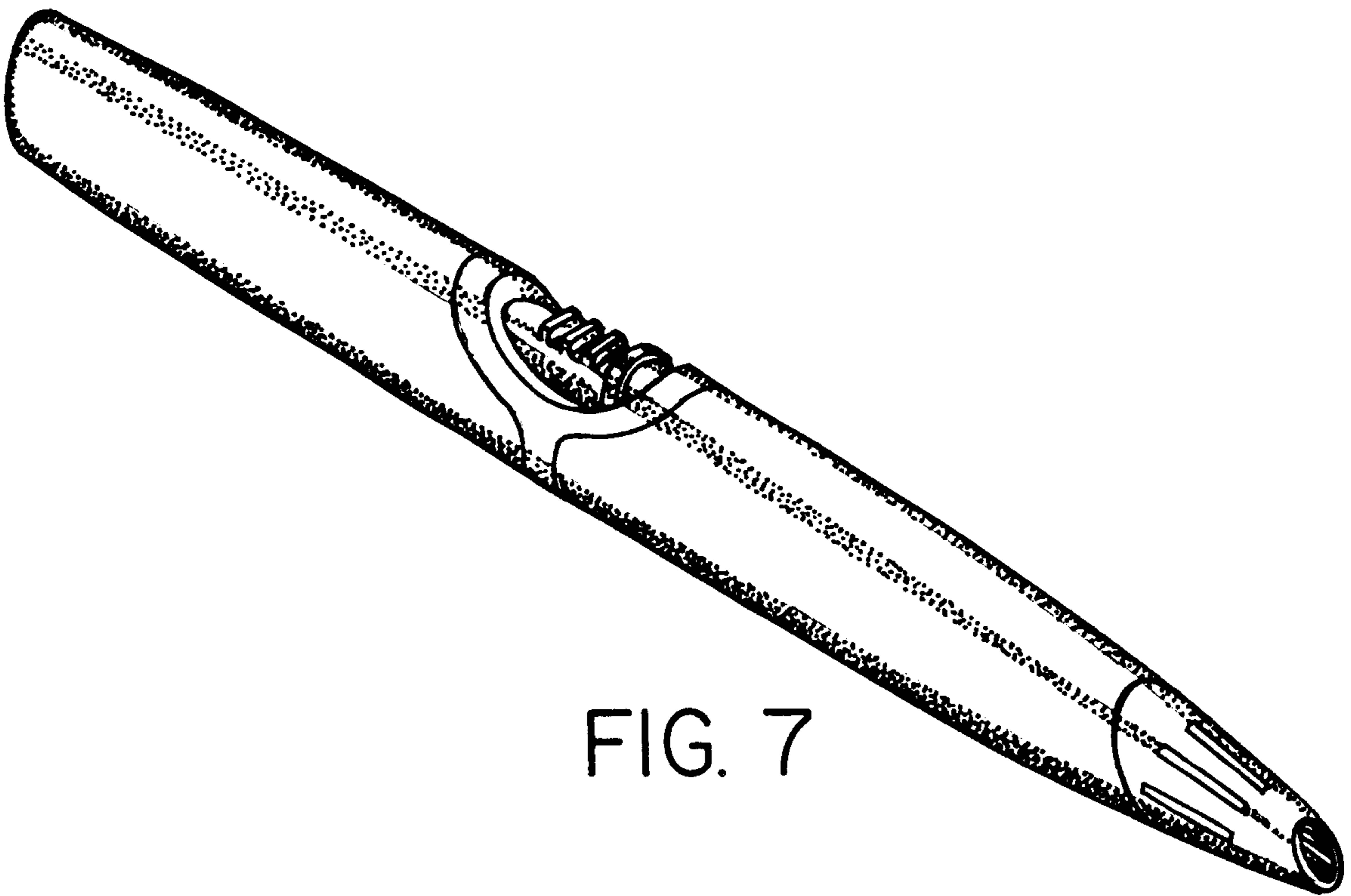
