(57) **CLAIM**

The ornamental design for a carabiner knife, as shown and described.

DESCRIPTION

FIG. 1 is a side view of the carabiner knife with a gate, a knife and two tools, where the gate, the knife and the tools are shown in a closed position according to an embodiment of the present invention.

FIG. 2 is a side view of the carabiner knife of FIG. 1 with the knife shown in an open position.

FIG. 3 is another side view of the carabiner knife of FIG. 1, with the gate shown in an open position.

FIG. 4 is another side view of the carabiner knife of FIG. 1, shown with the two tools in an open position.

FIG. 5 is a view of the opposing side of the embodiment shown in FIG. 1.

FIG. 6 is a top view of the embodiment shown in FIG. 1.

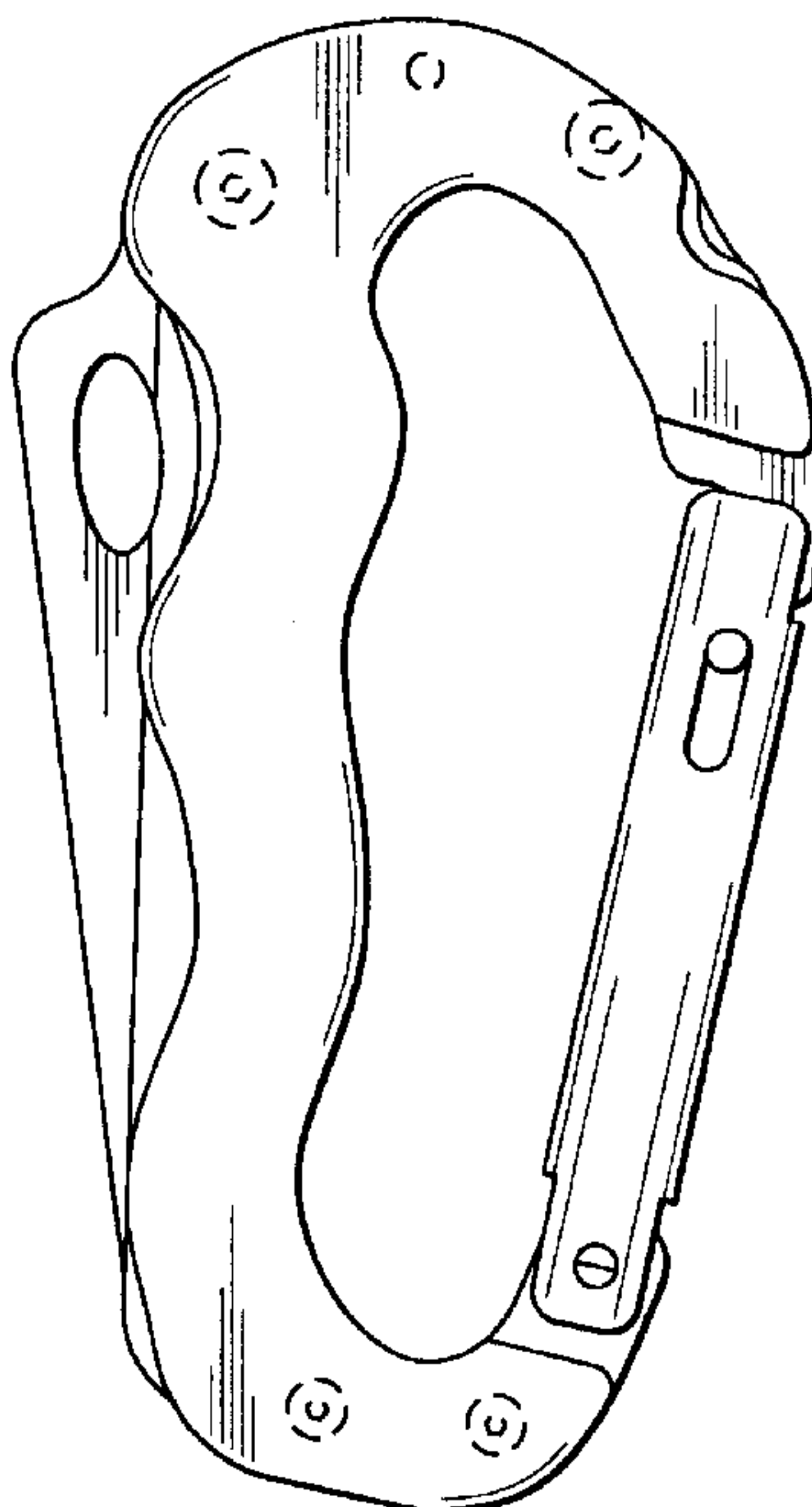
FIG. 7 is a left side view of the embodiment shown in FIG. 1.

FIG. 8 is a right side view of the embodiment shown in FIG. 1; and,

FIG. 9 is a bottom view of the embodiment shown in FIG. 1.

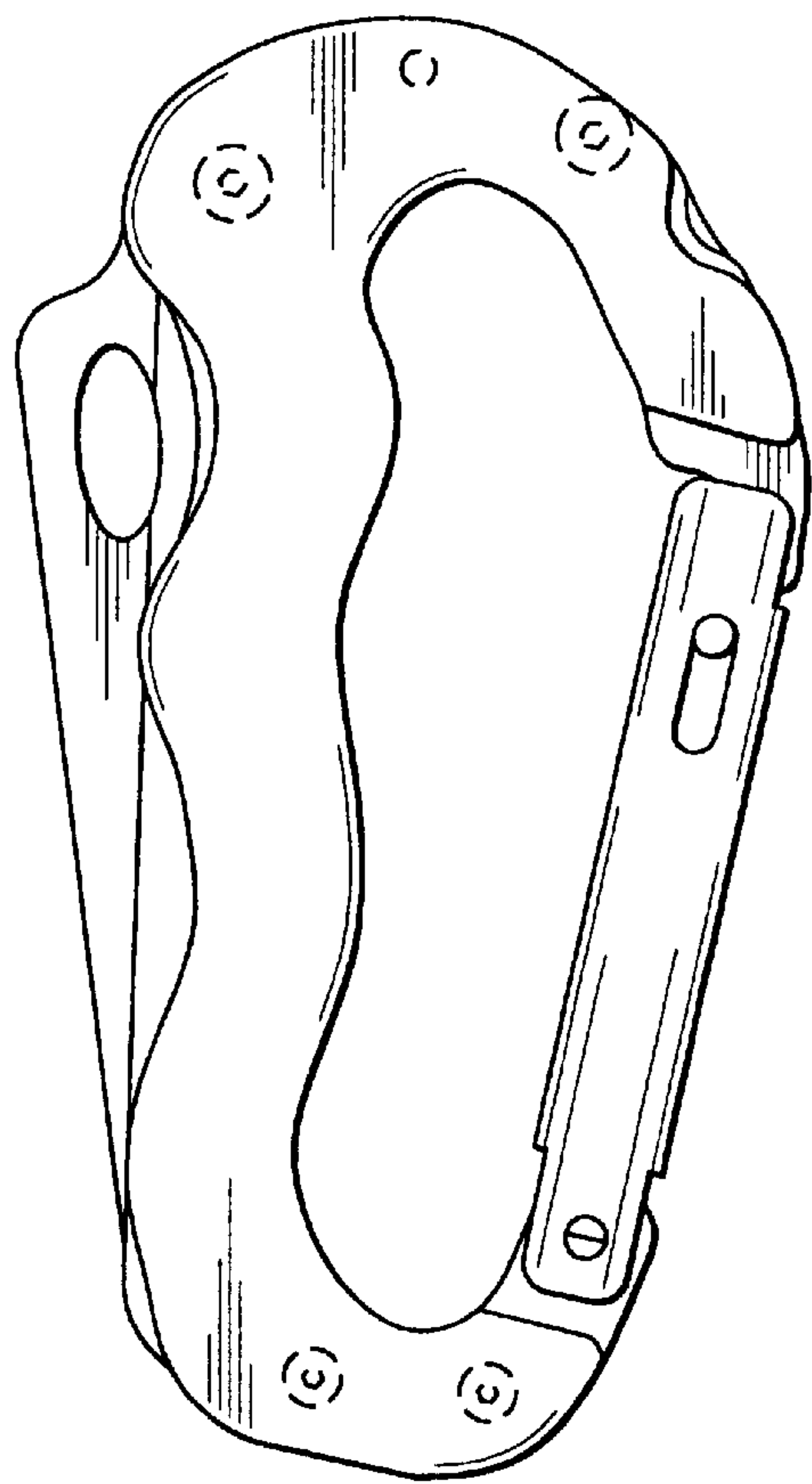

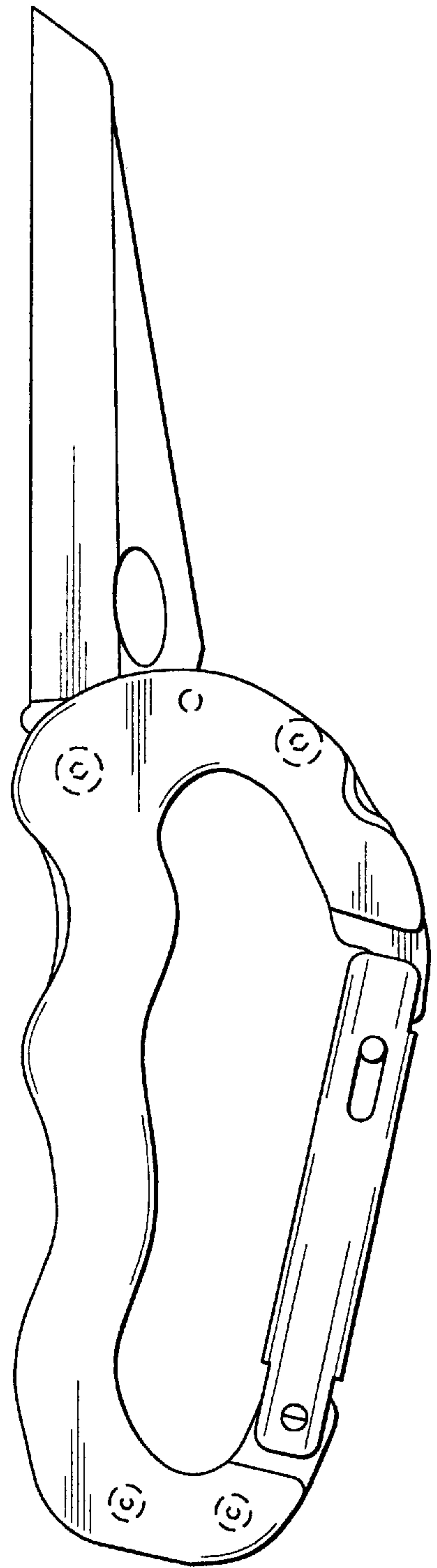

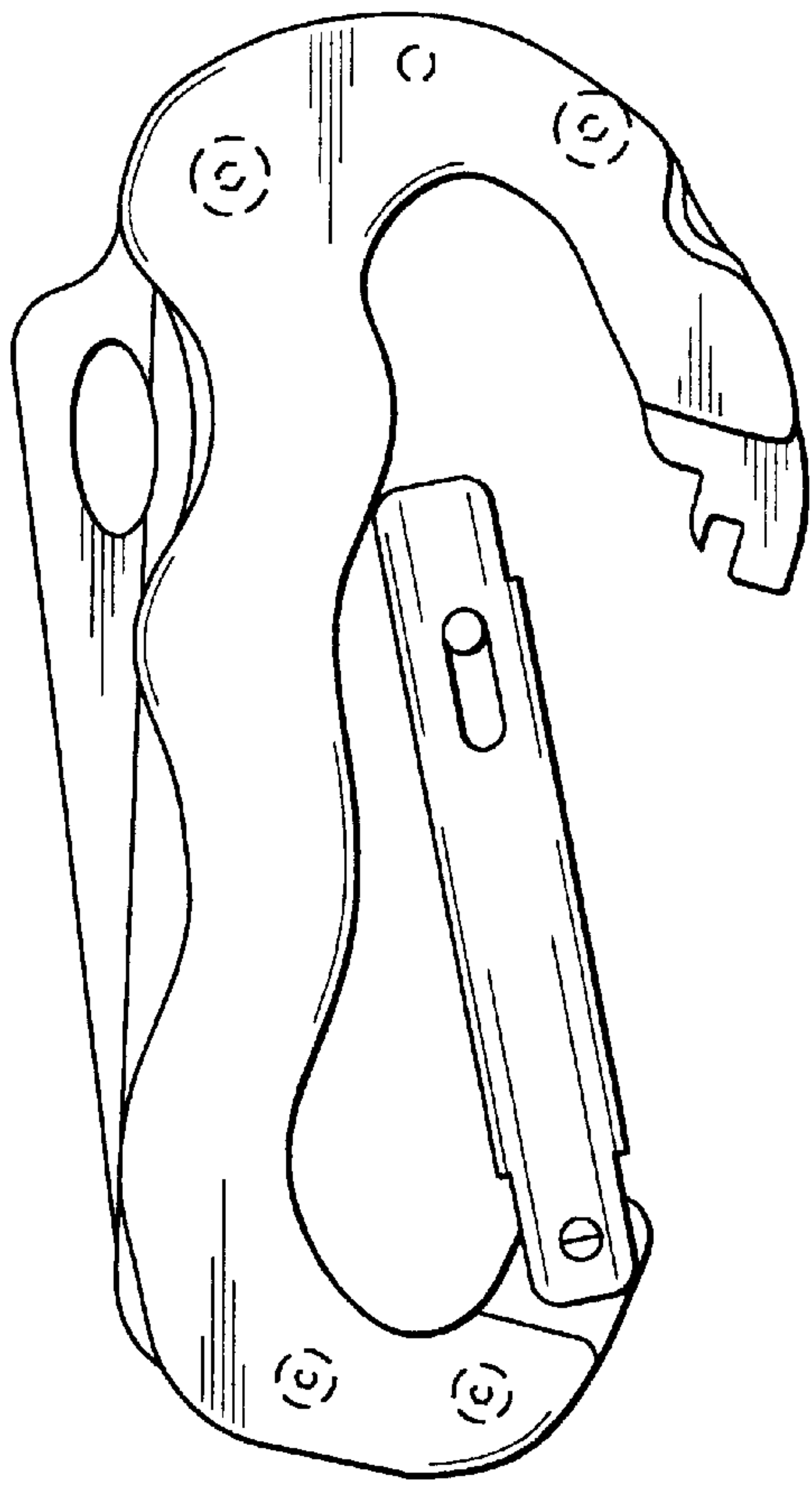

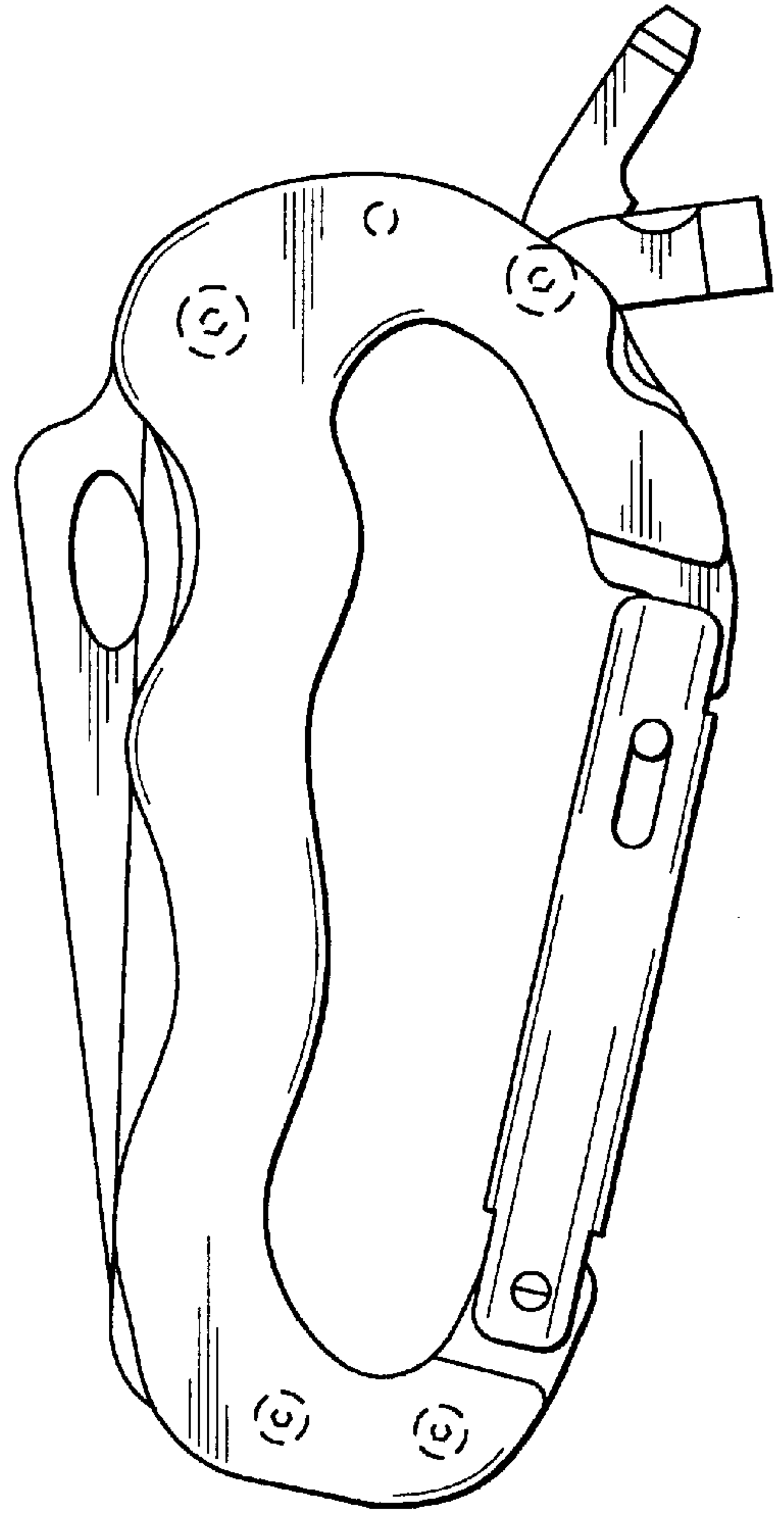

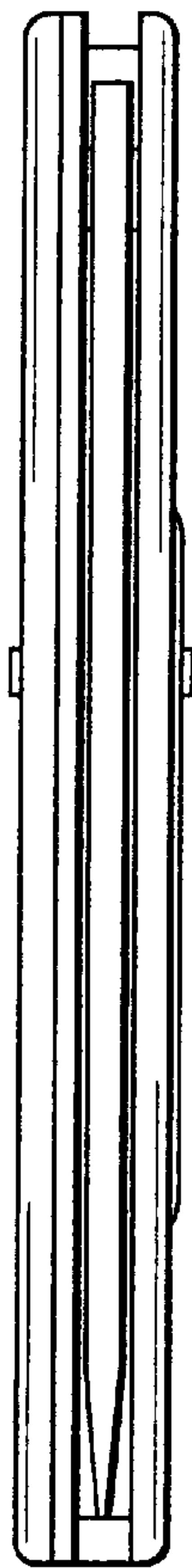
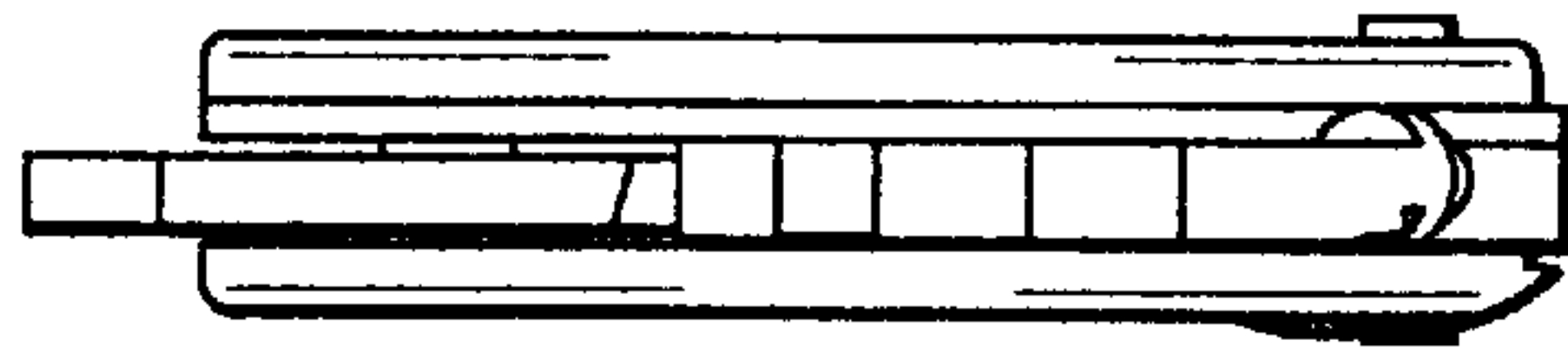

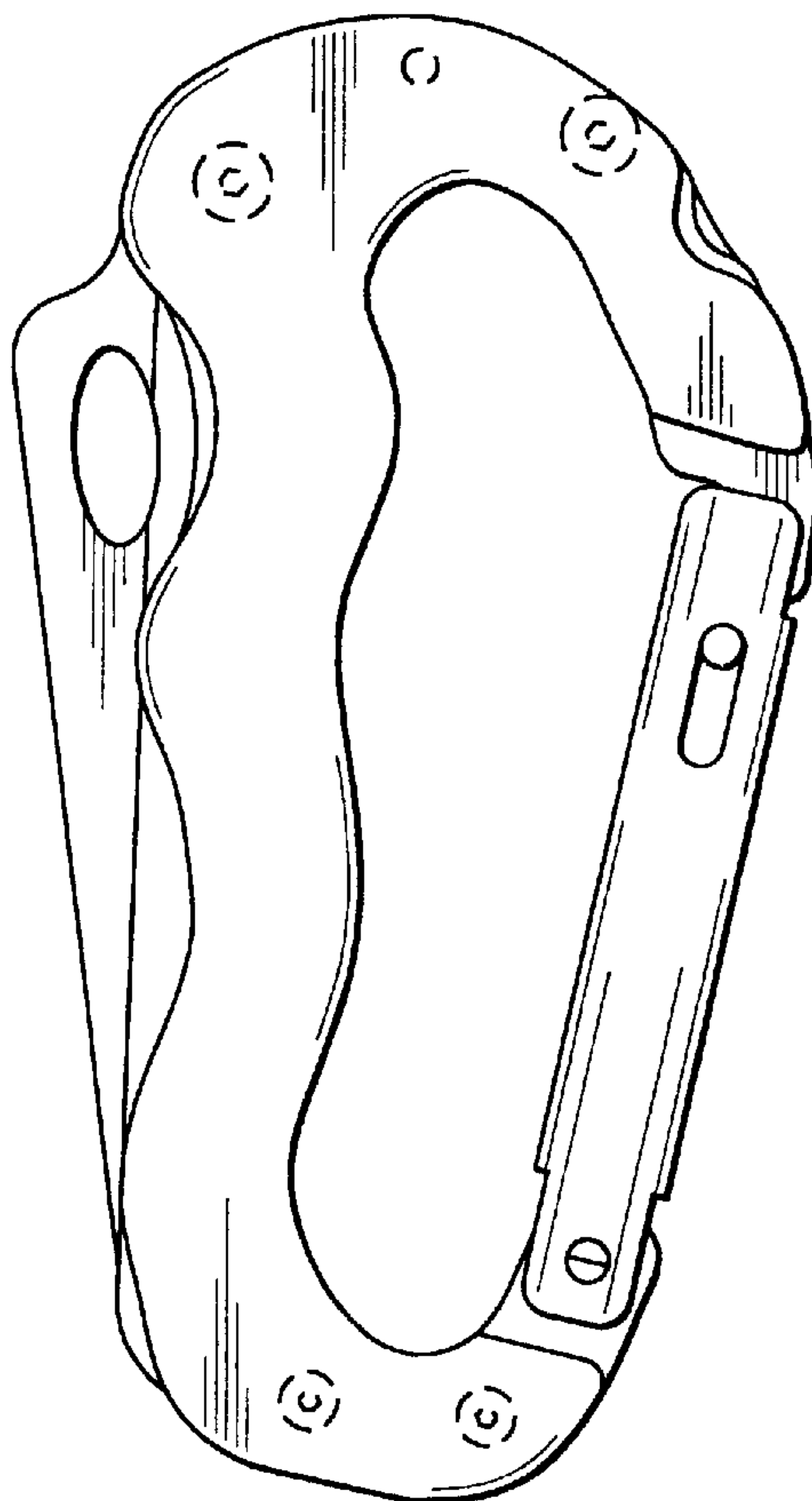

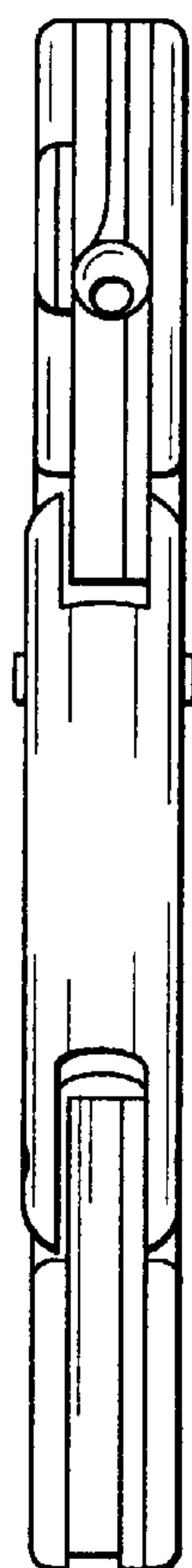
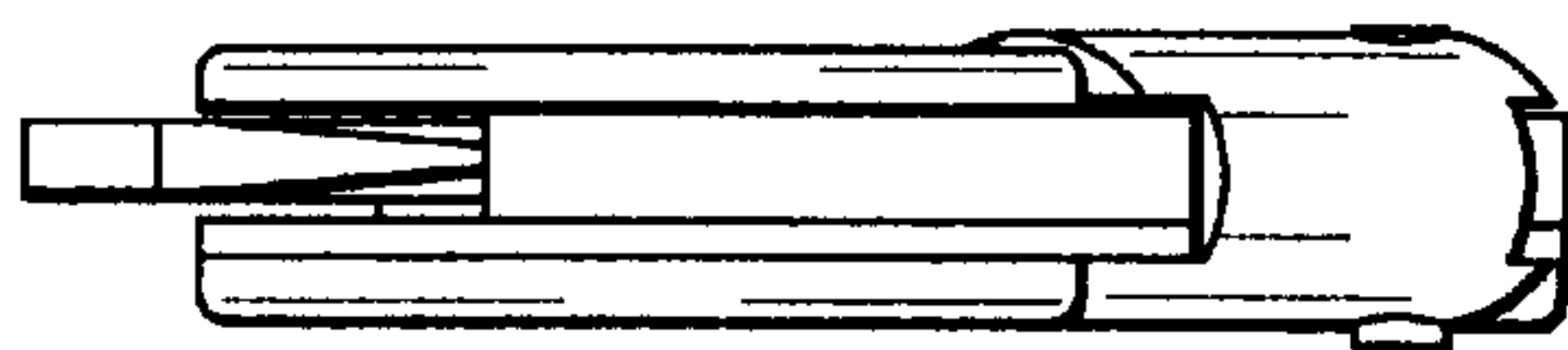
