(57) **CLAIM**

The ornamental design for an anti-rattle rod guide clip, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of an anti-rattle rod guide clip showing the new design;

FIG. 2 is a front elevational view thereof;

FIG. 3 is a side elevational view of one side thereof, the opposite side being the same as this one side;

FIG. 4 is a top plan view thereof; and,

FIG. 5 is a back elevational view thereof.

A bottom view of the invention is not provided because it would not illustrate any of the claimed features. The broken line portions of the disclosure are for illustrative purposes only and form no part of the claimed design.
