(57) **CLAIM**

I claim the ornamental design for an egg tray, as shown and described.

**DESCRIPTION**

FIG. 1 is a front elevational view of my egg tray, in a closed position.

FIG. 2 is a top plan view of FIG. 1;

FIG. 3 is a right side elevational view of FIG. 1. The left side elevational view is a mirror image of FIG. 3.

FIG. 4 is a top rear perspective view of FIG. 1, but in the opened position.

FIG. 5 is a bottom front perspective view of FIG. 1, but in the opened position.

FIG. 6 is a bottom plan view of FIG. 1, in the opened position.

FIG. 7 is a top plan view of FIG. 1, in the opened position.

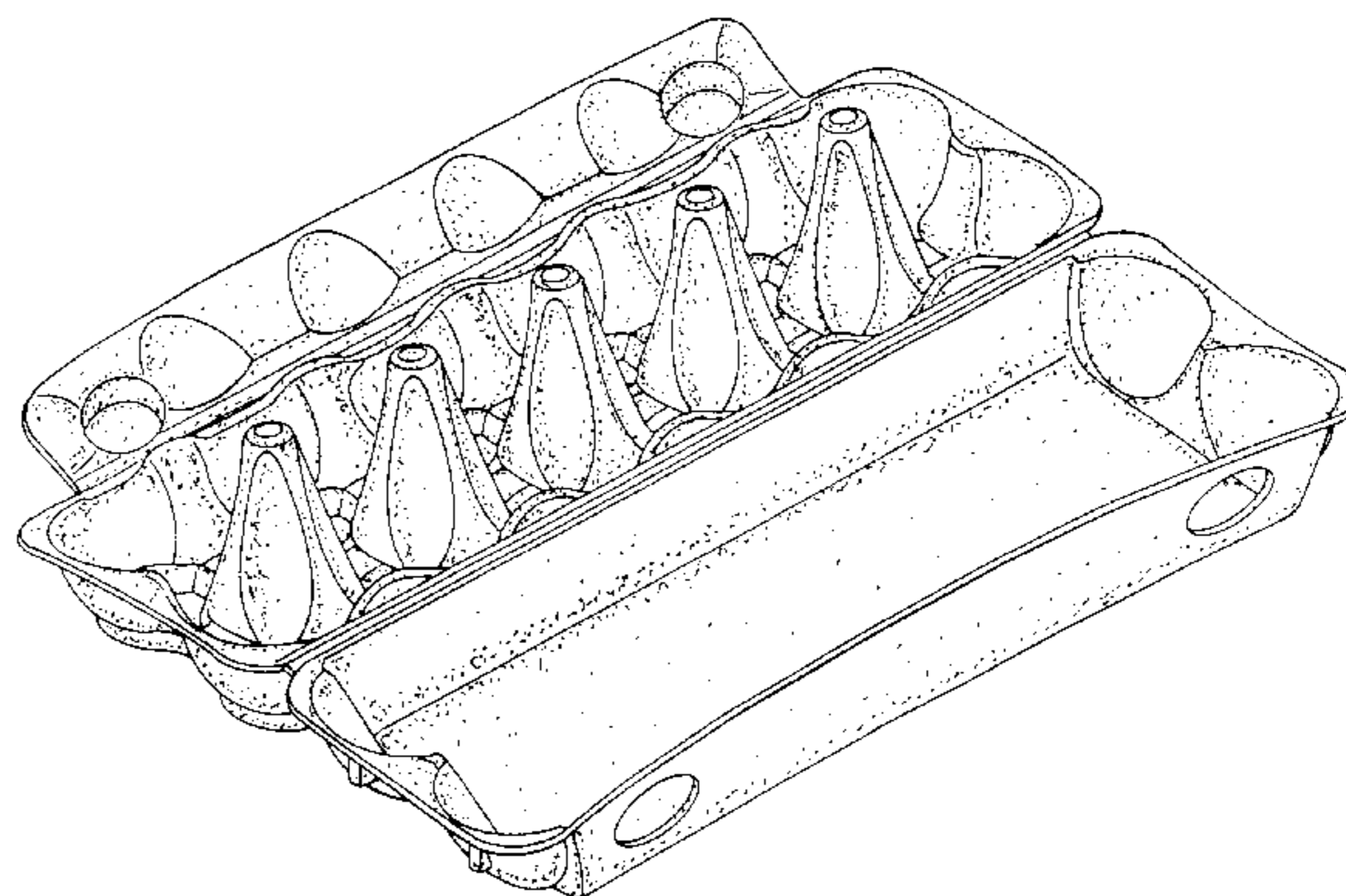
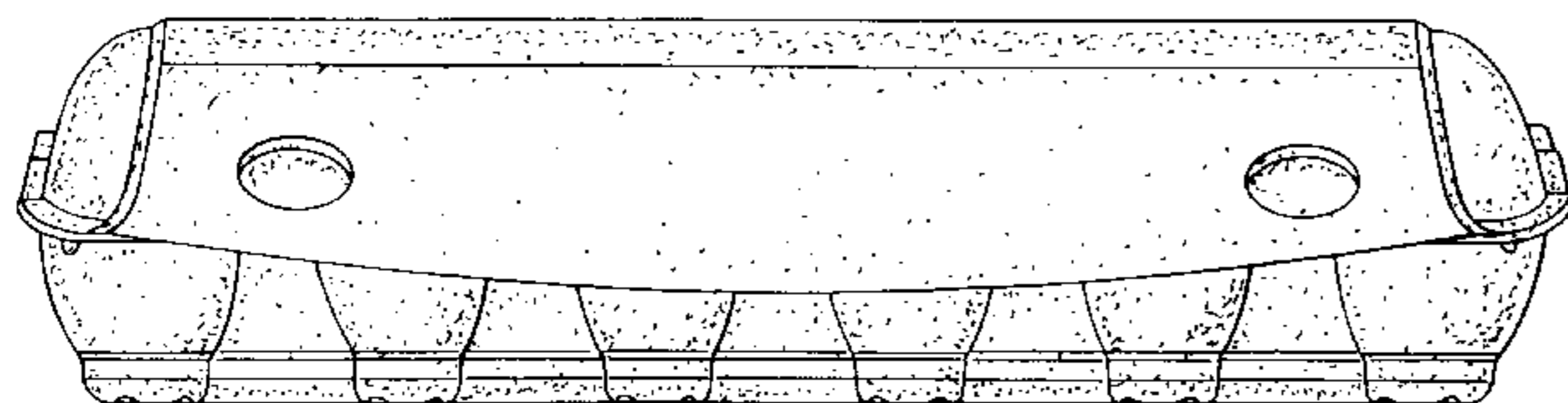
FIG. 8 is a front elevational view of FIG. 7.

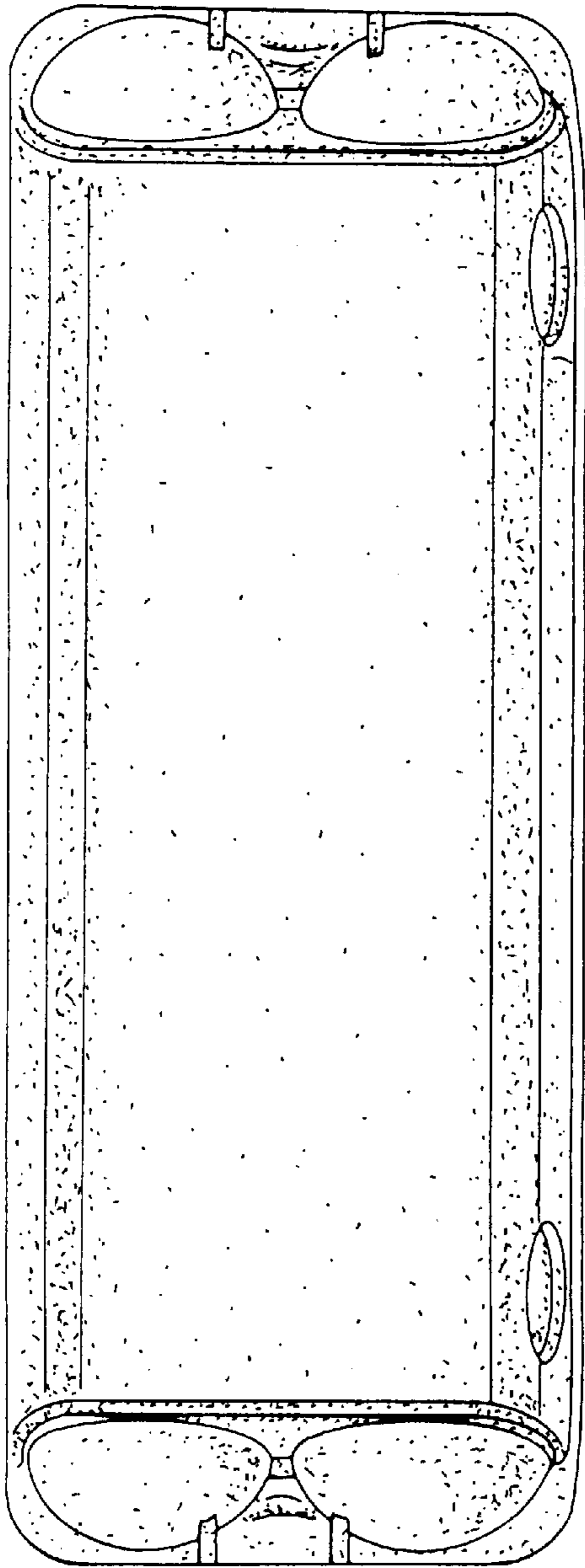

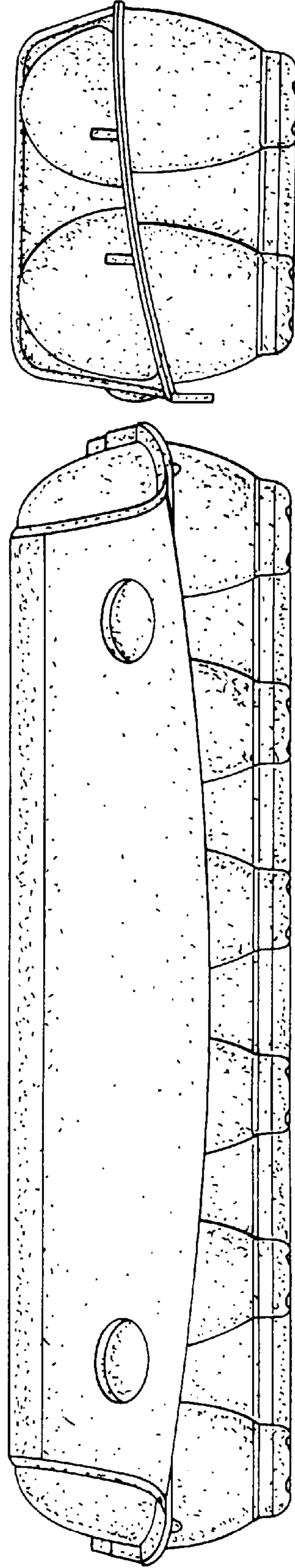
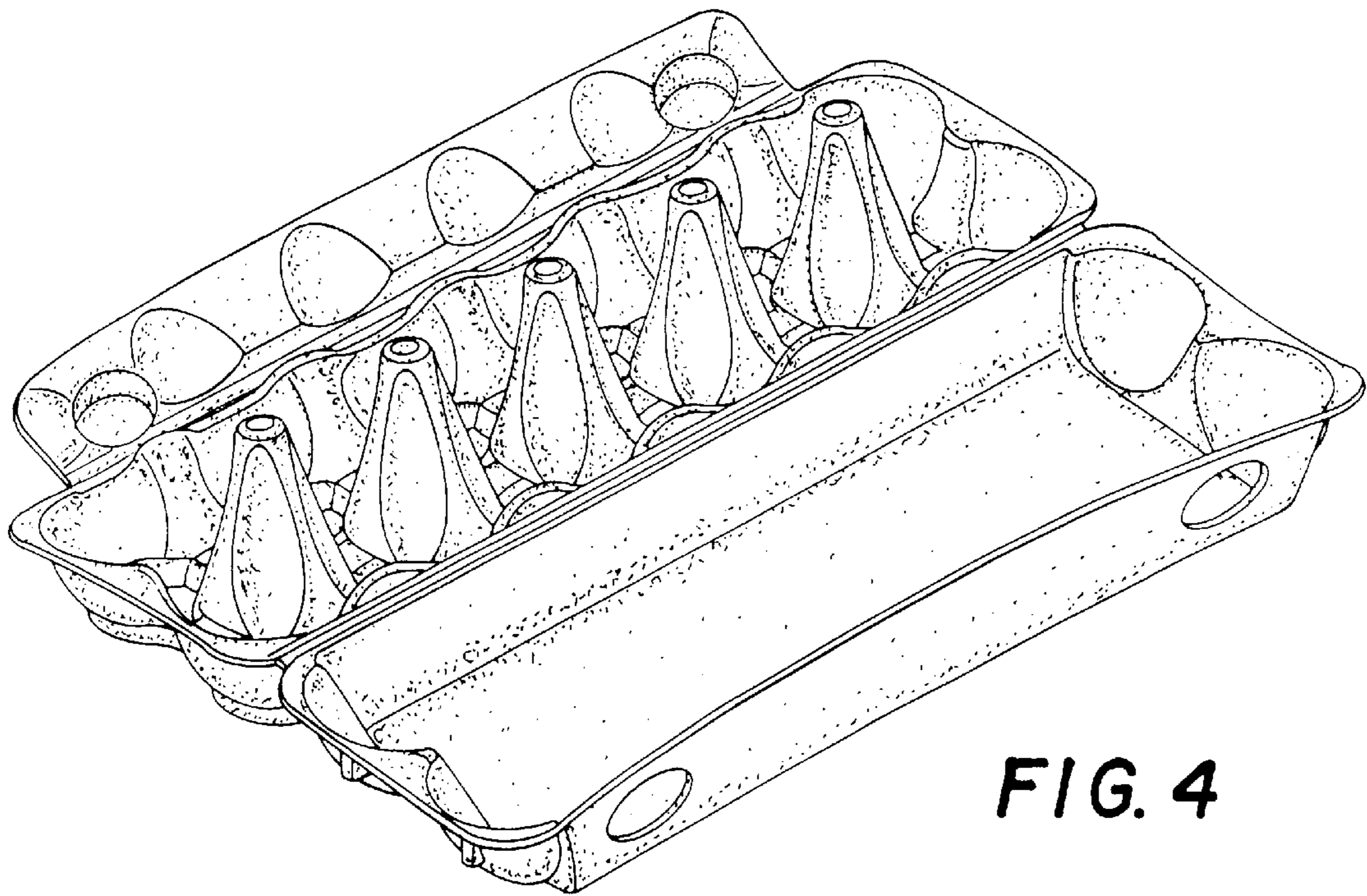
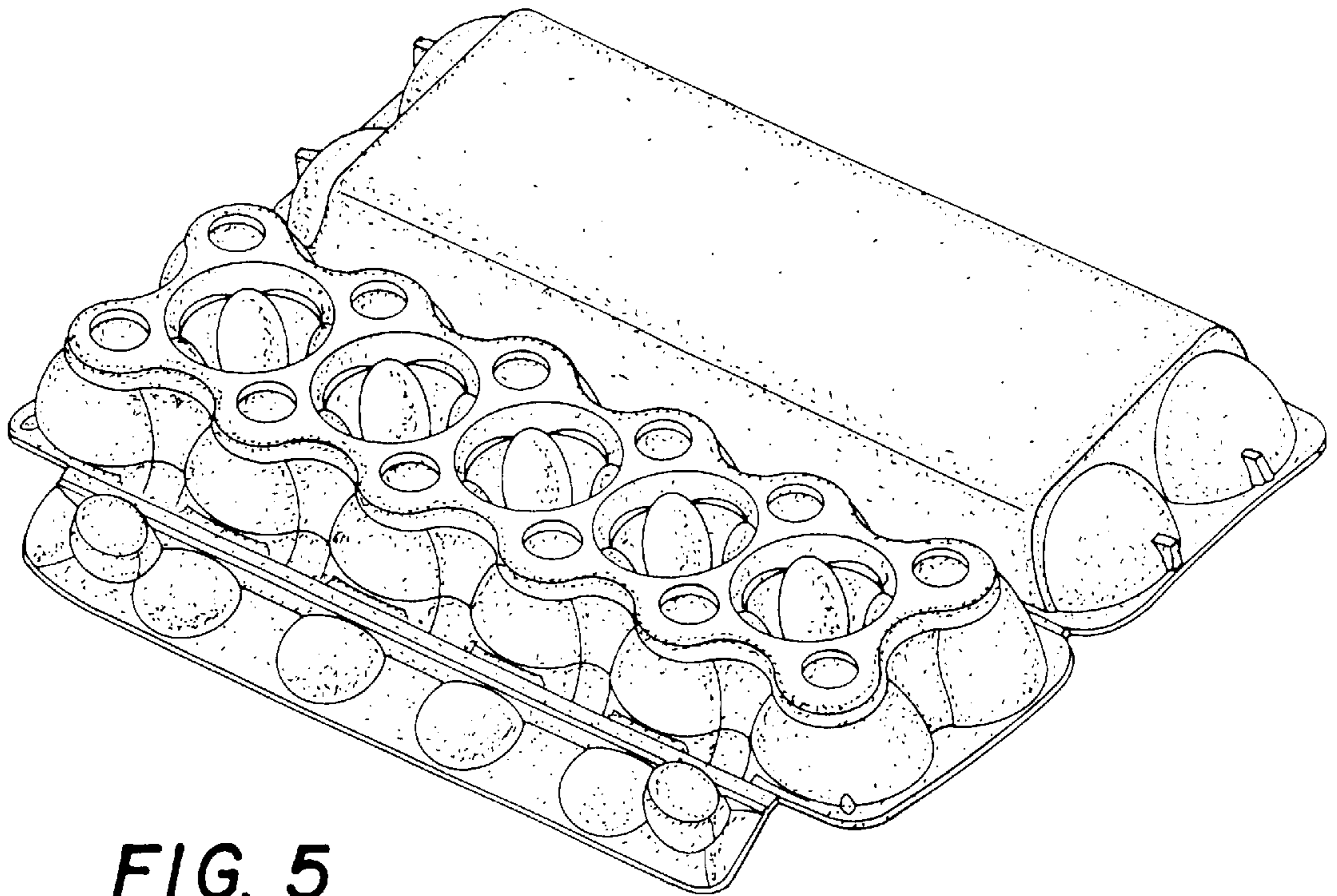

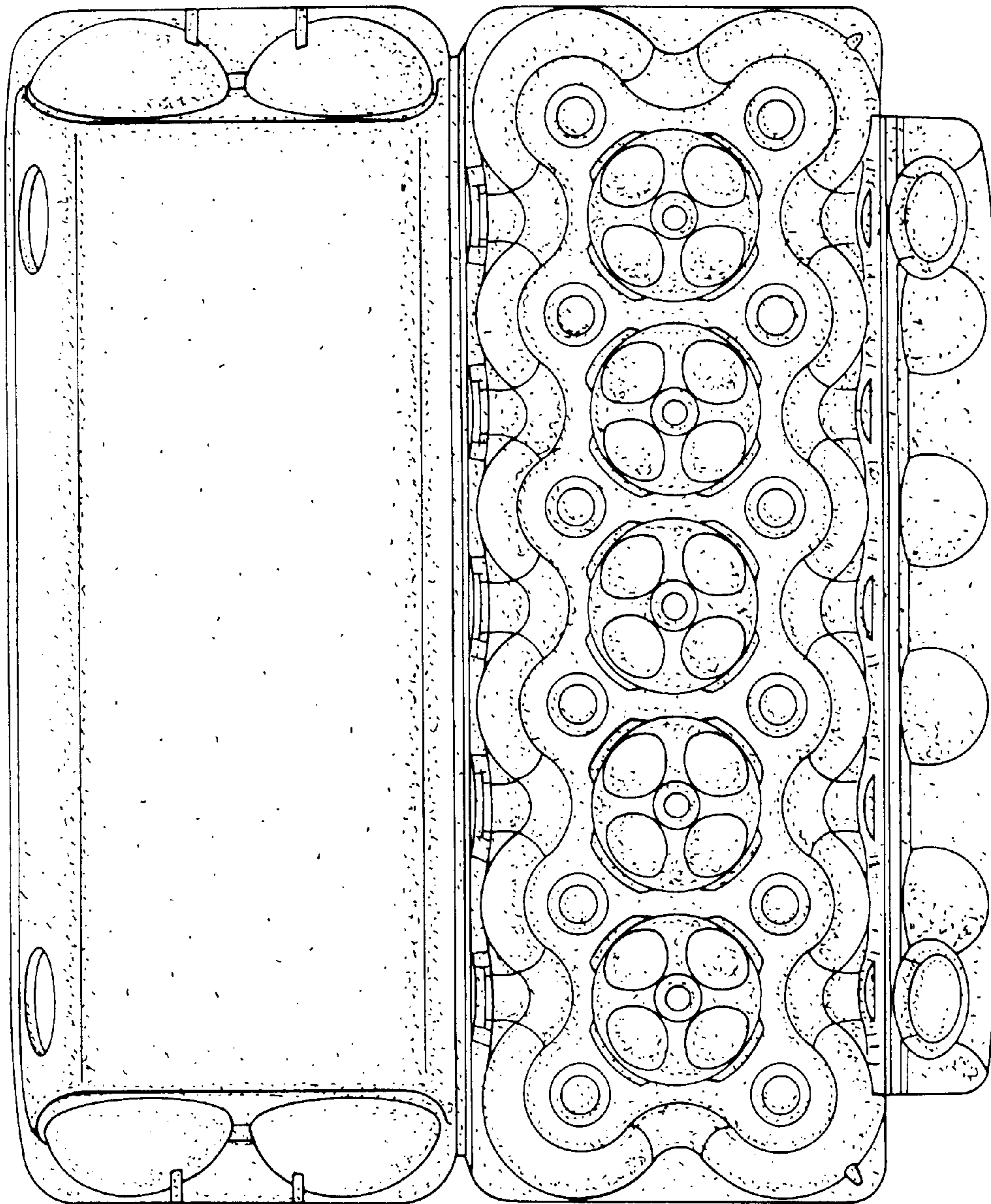

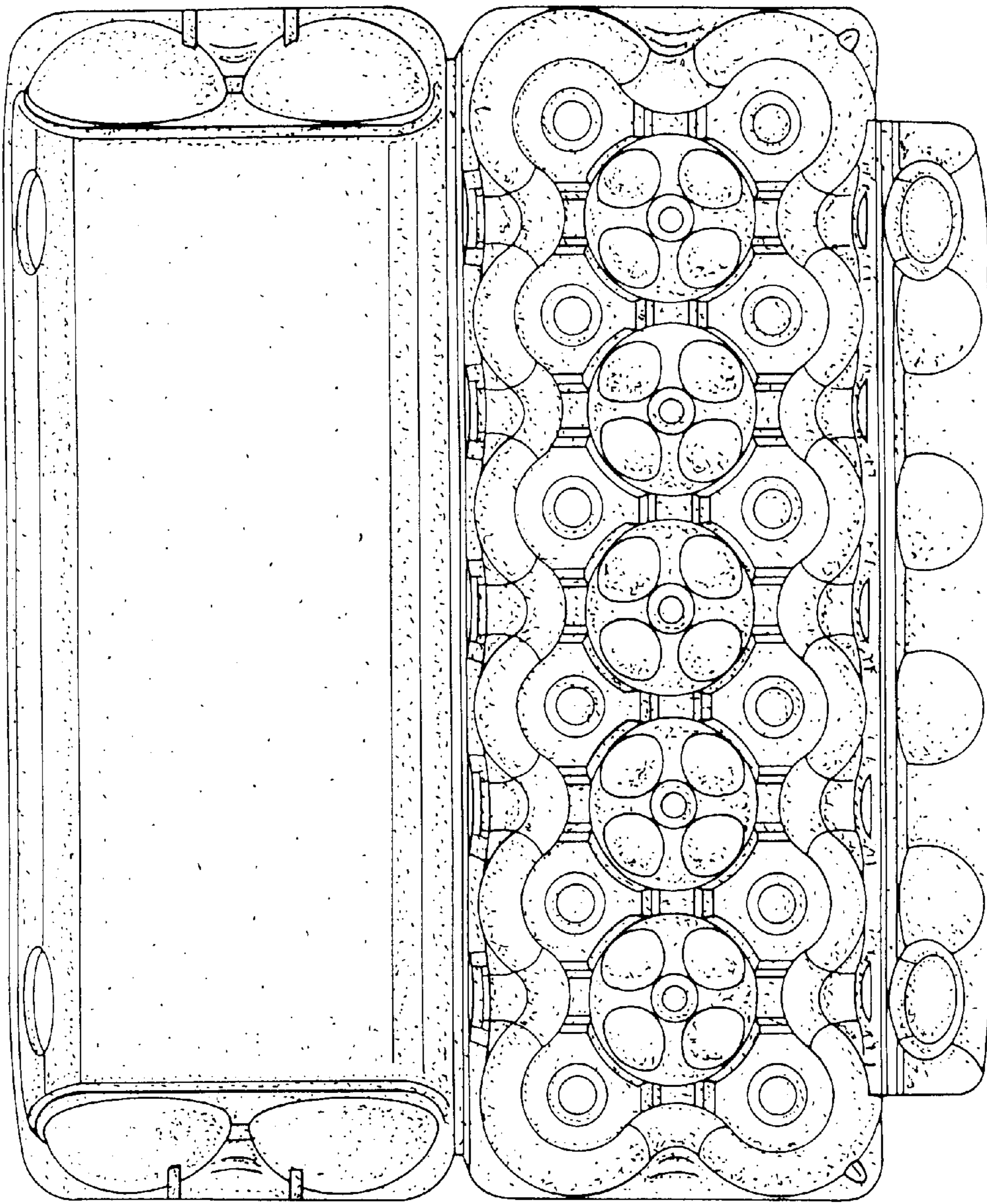
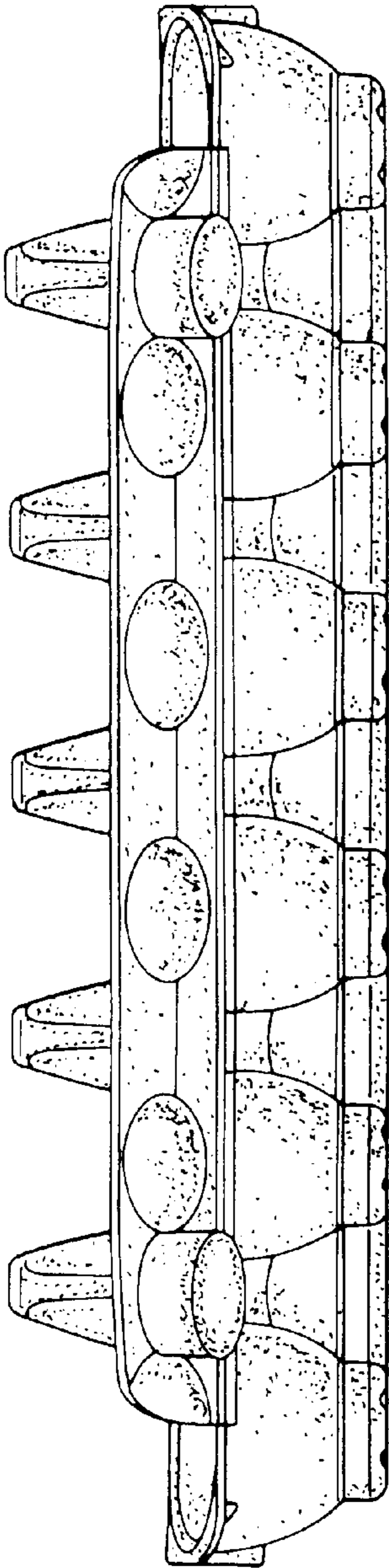
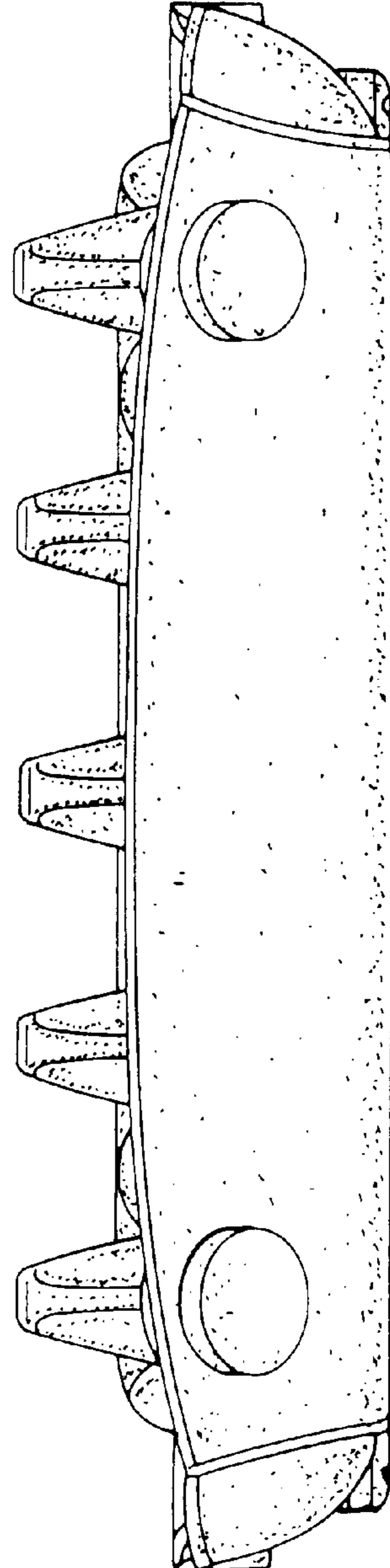


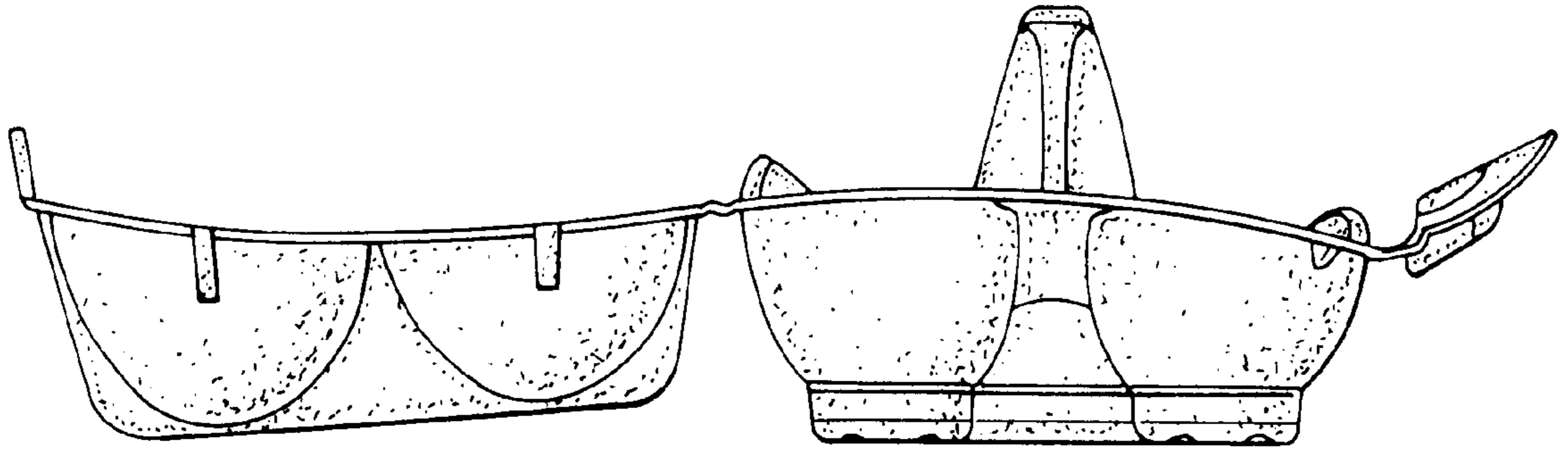

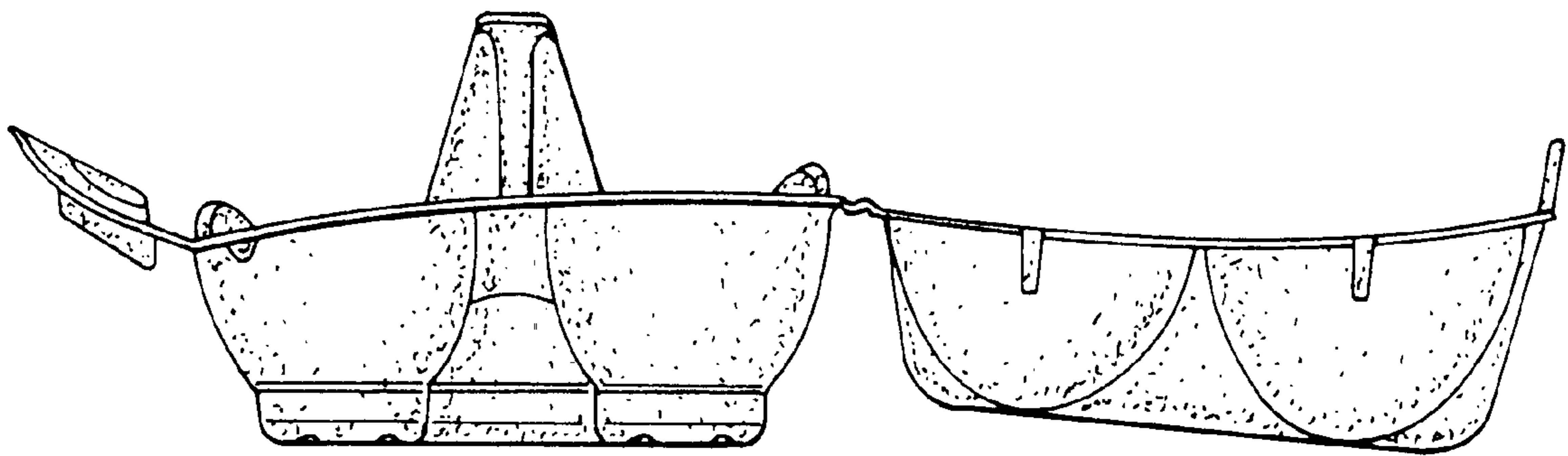
