(57) **CLAIM**

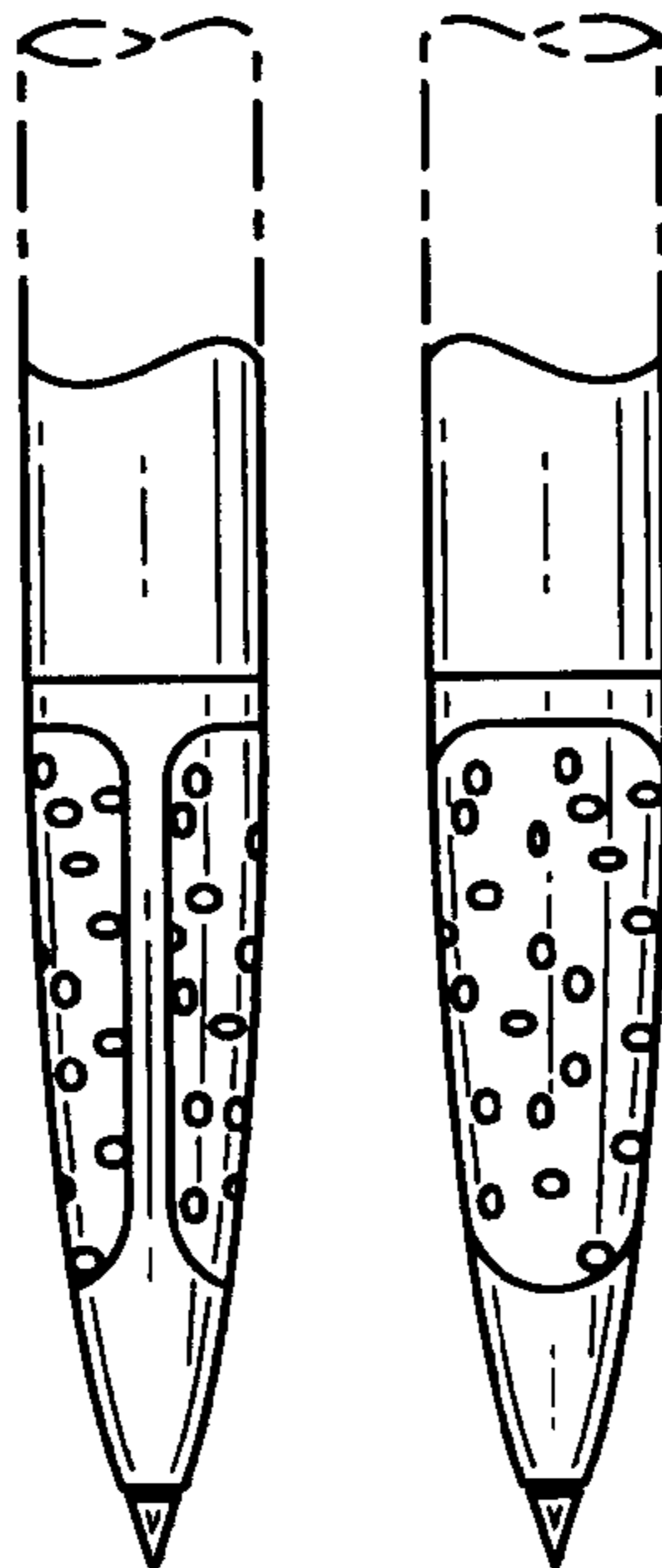
The ornamental design for the writing utensil grip portion,

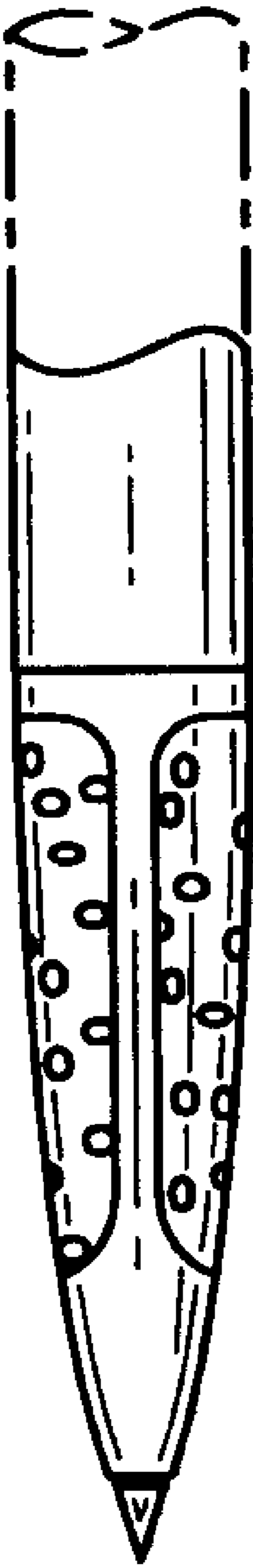

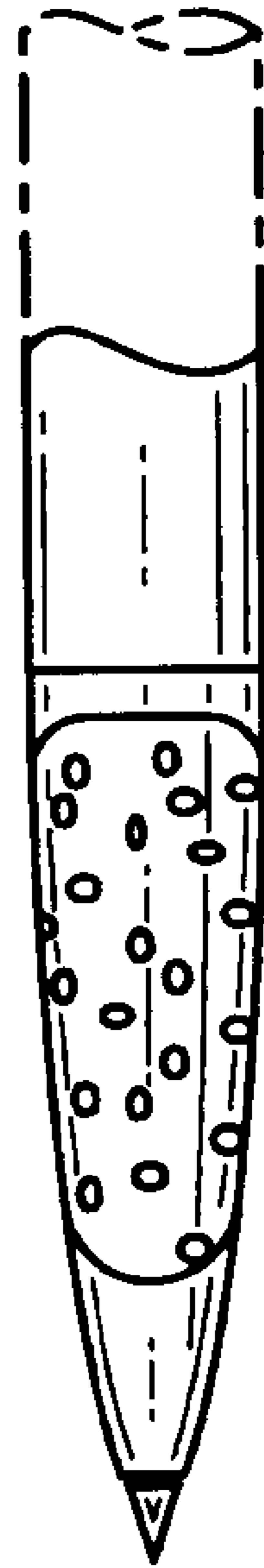
