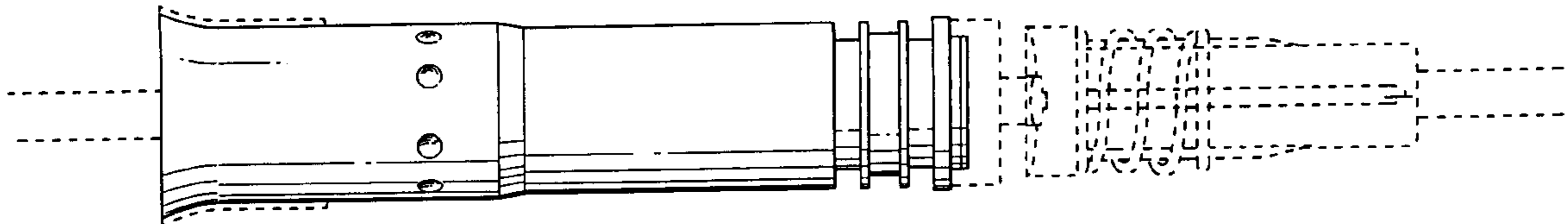

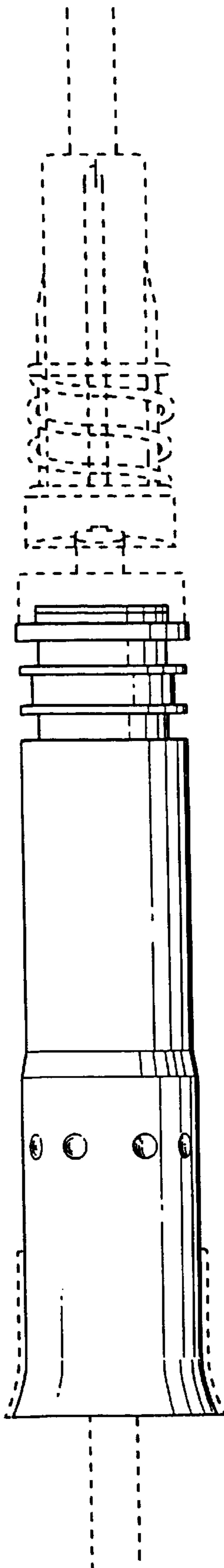
The ornamental design for surgical tool blade holder, as shown and described.

**DESCRIPTION**

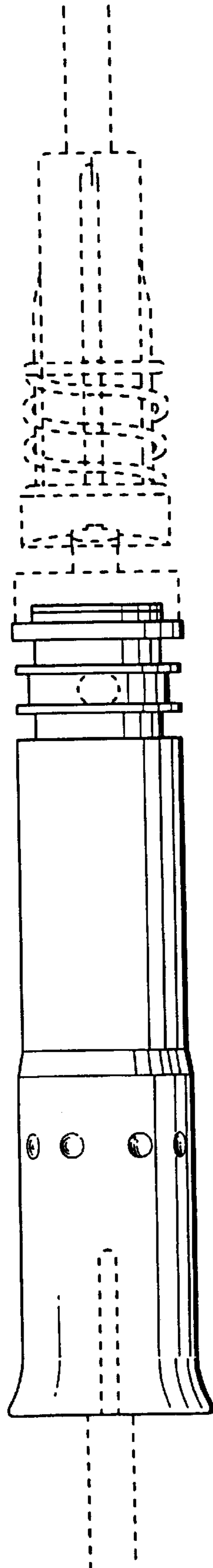
FIG. 1 is a side view of the surgical tool blade holder, the opposite side view being a mirror image;

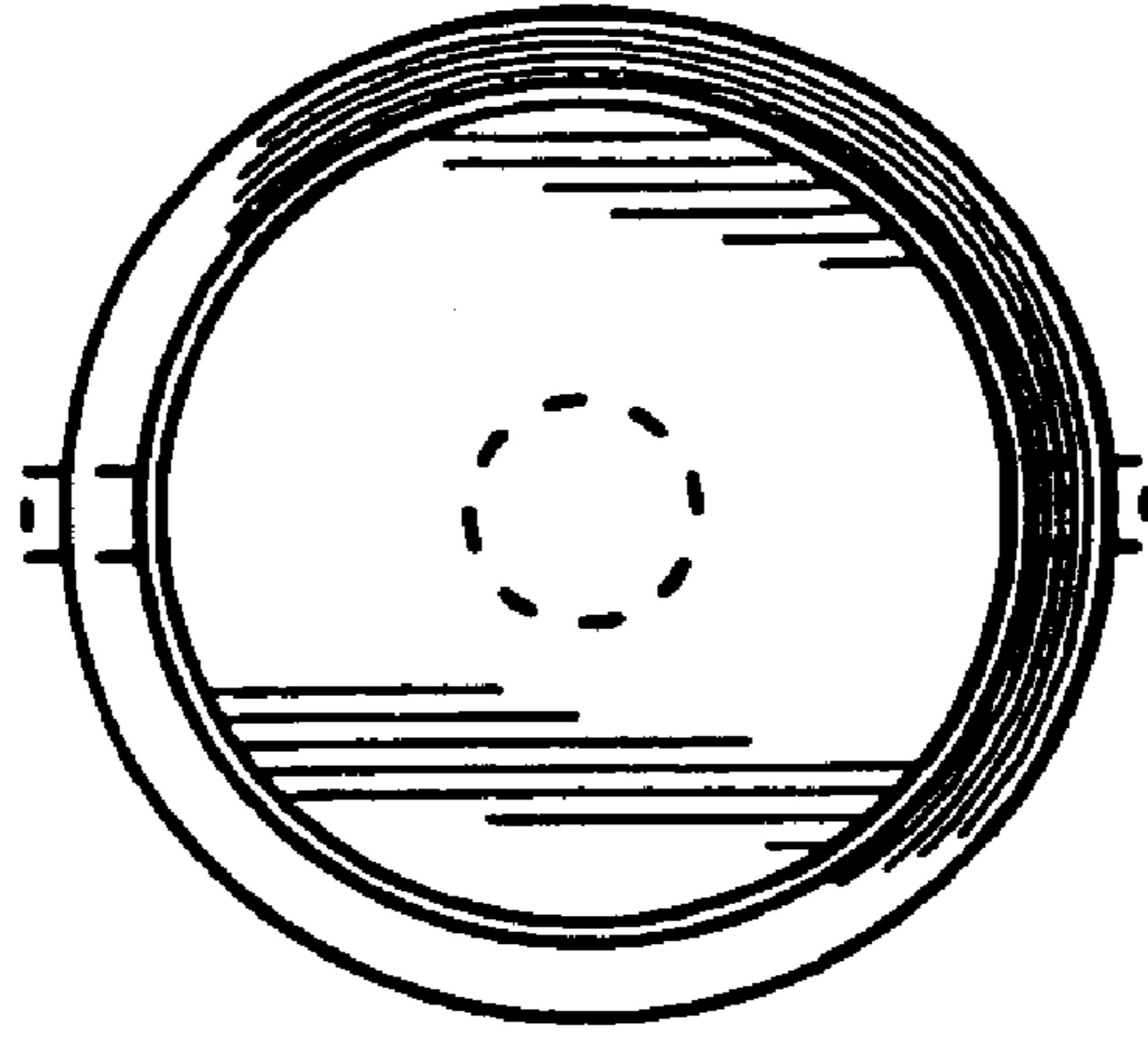




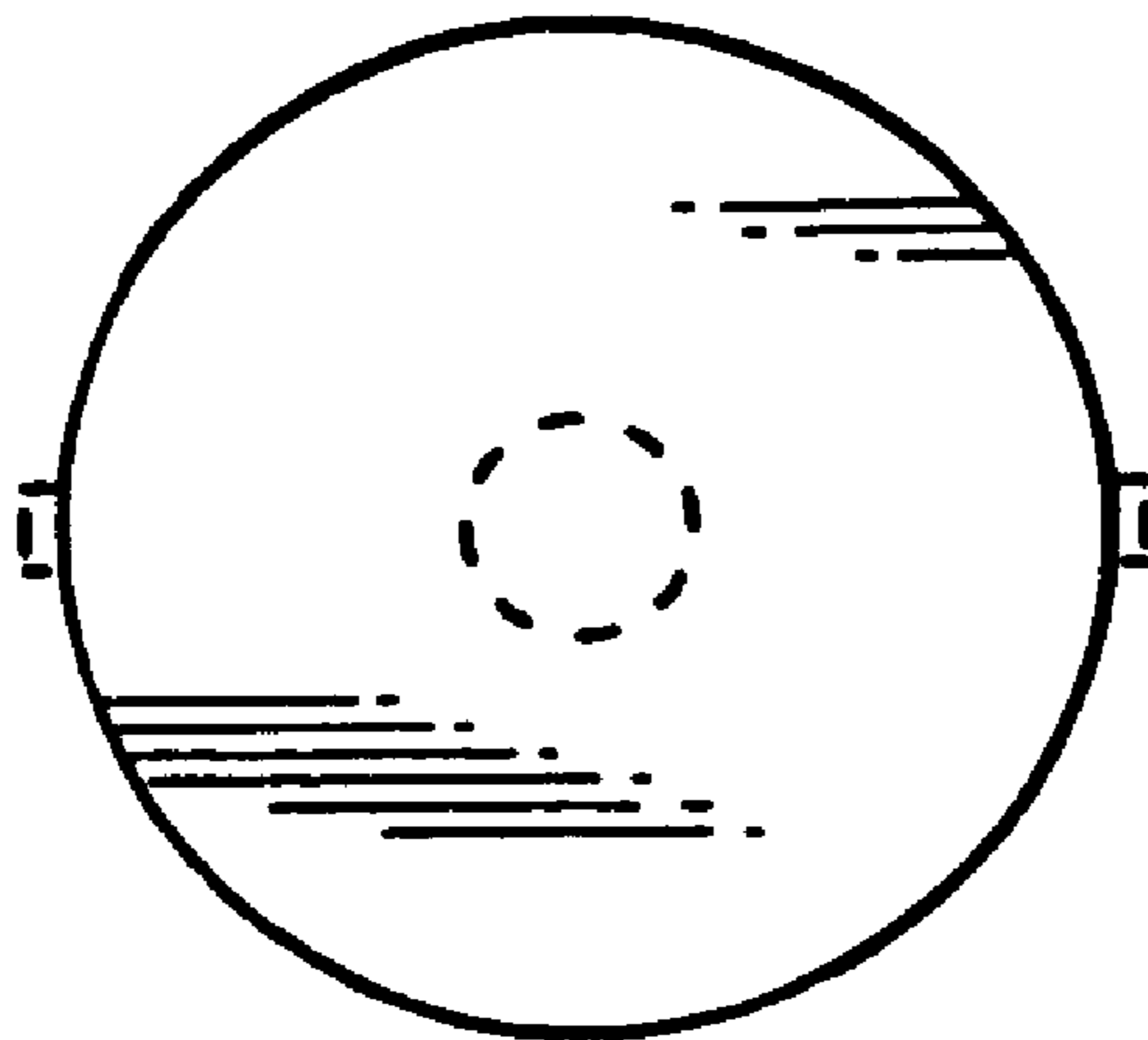
