DESCRIPTION

FIG. 4 is a top view thereof in a closed orientation and a rear view of the opened design in FIGS. 1-3;

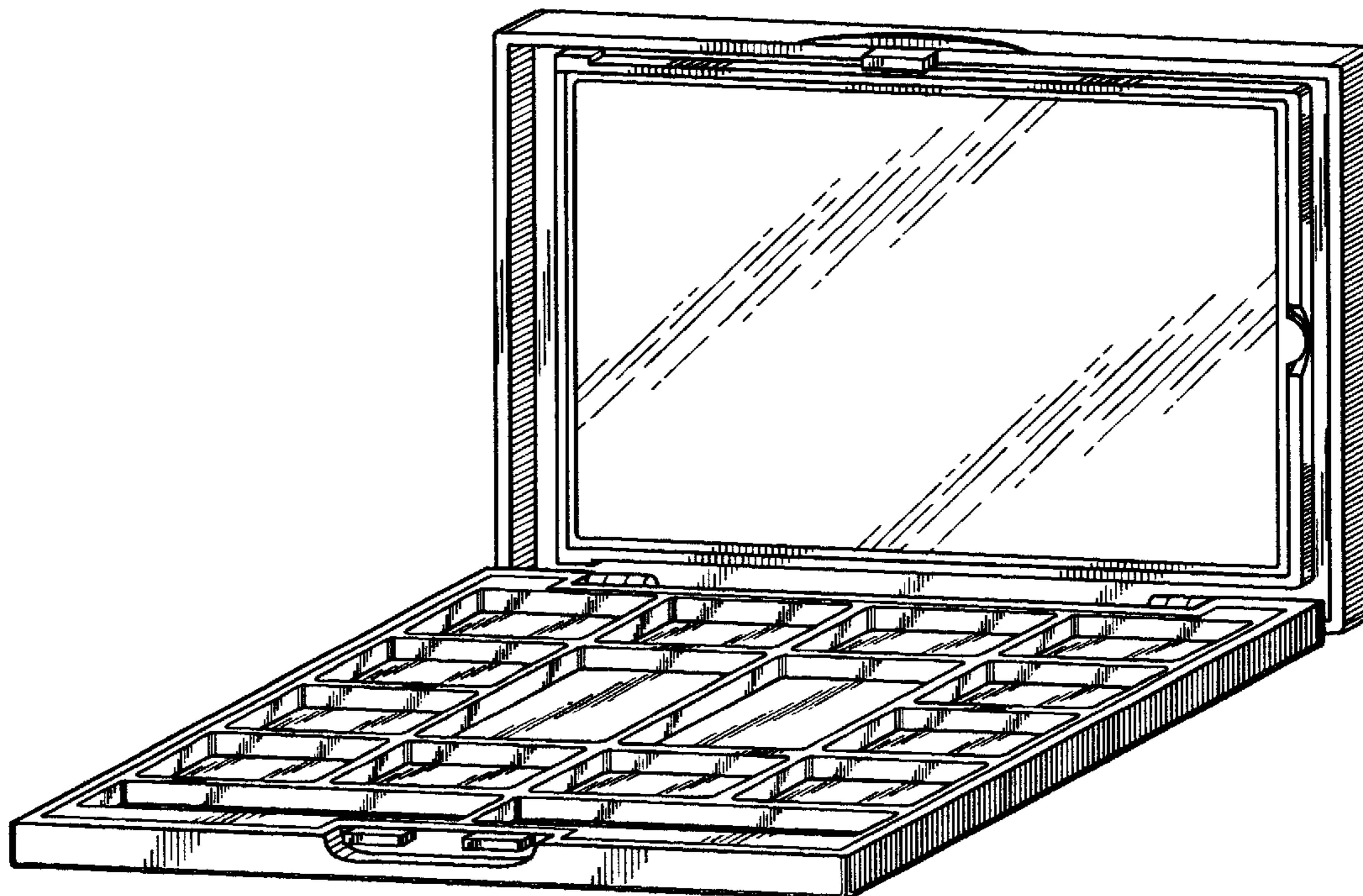
FIG. 5 is a right side view of FIGS. 1-3;

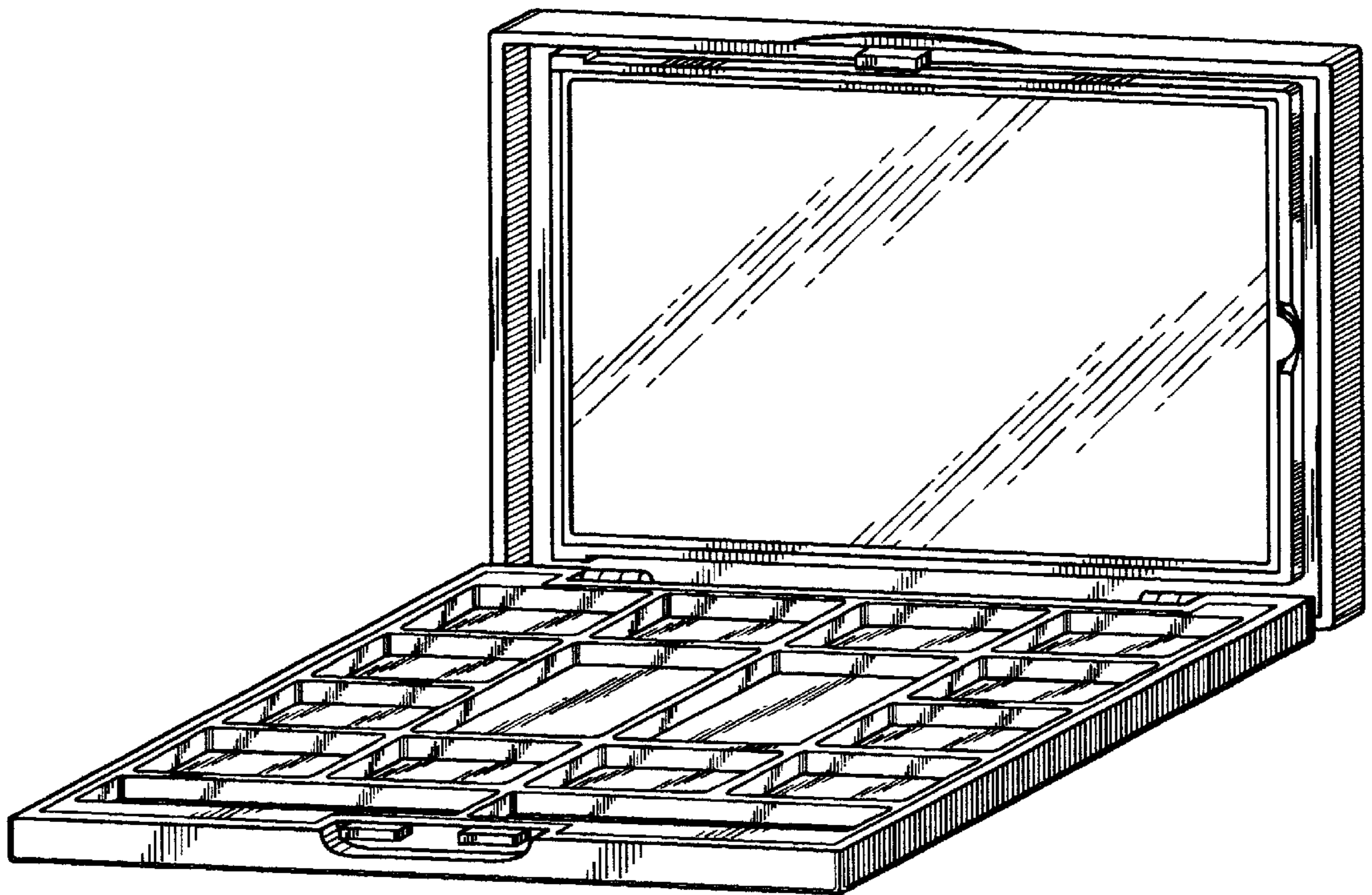

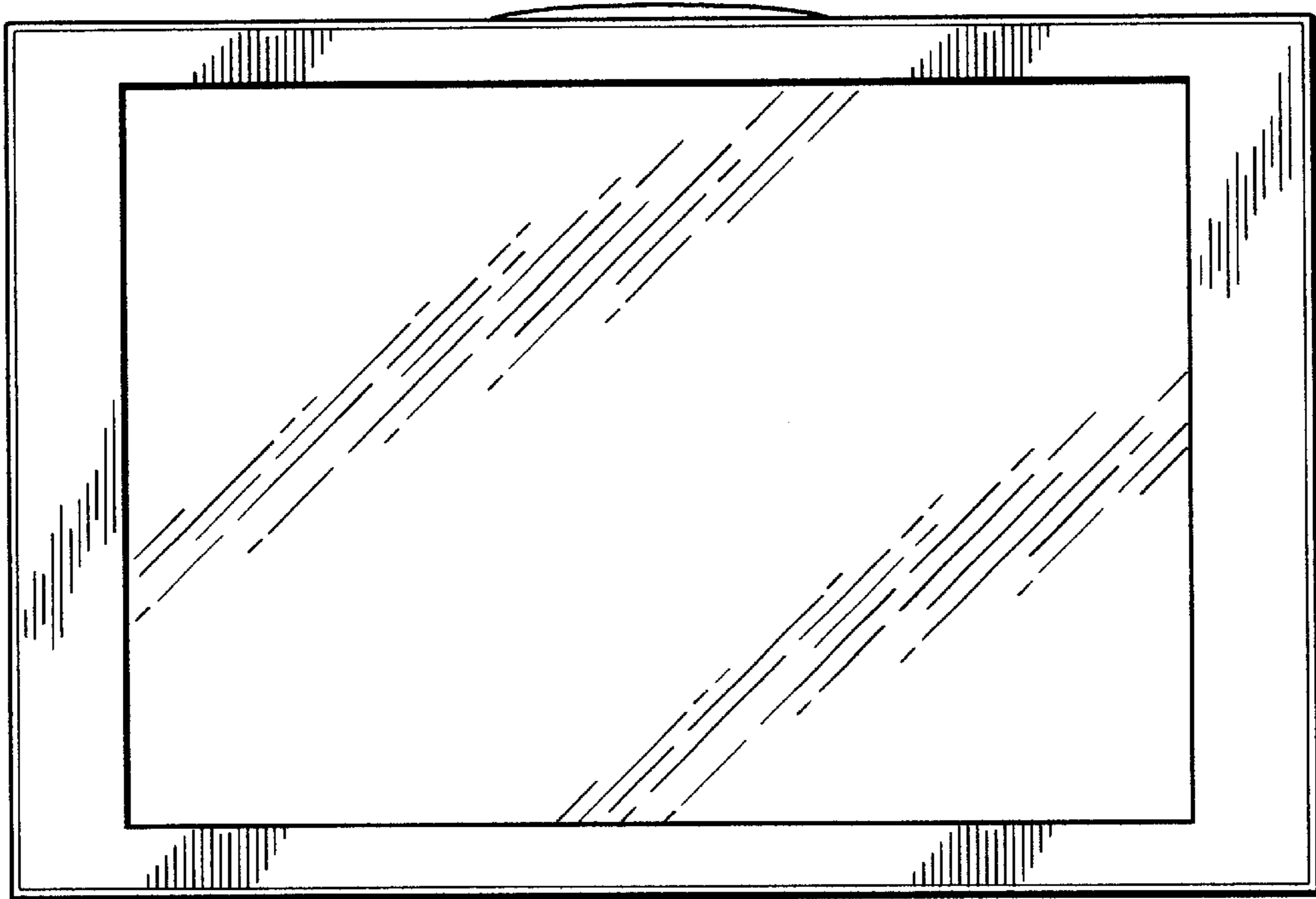

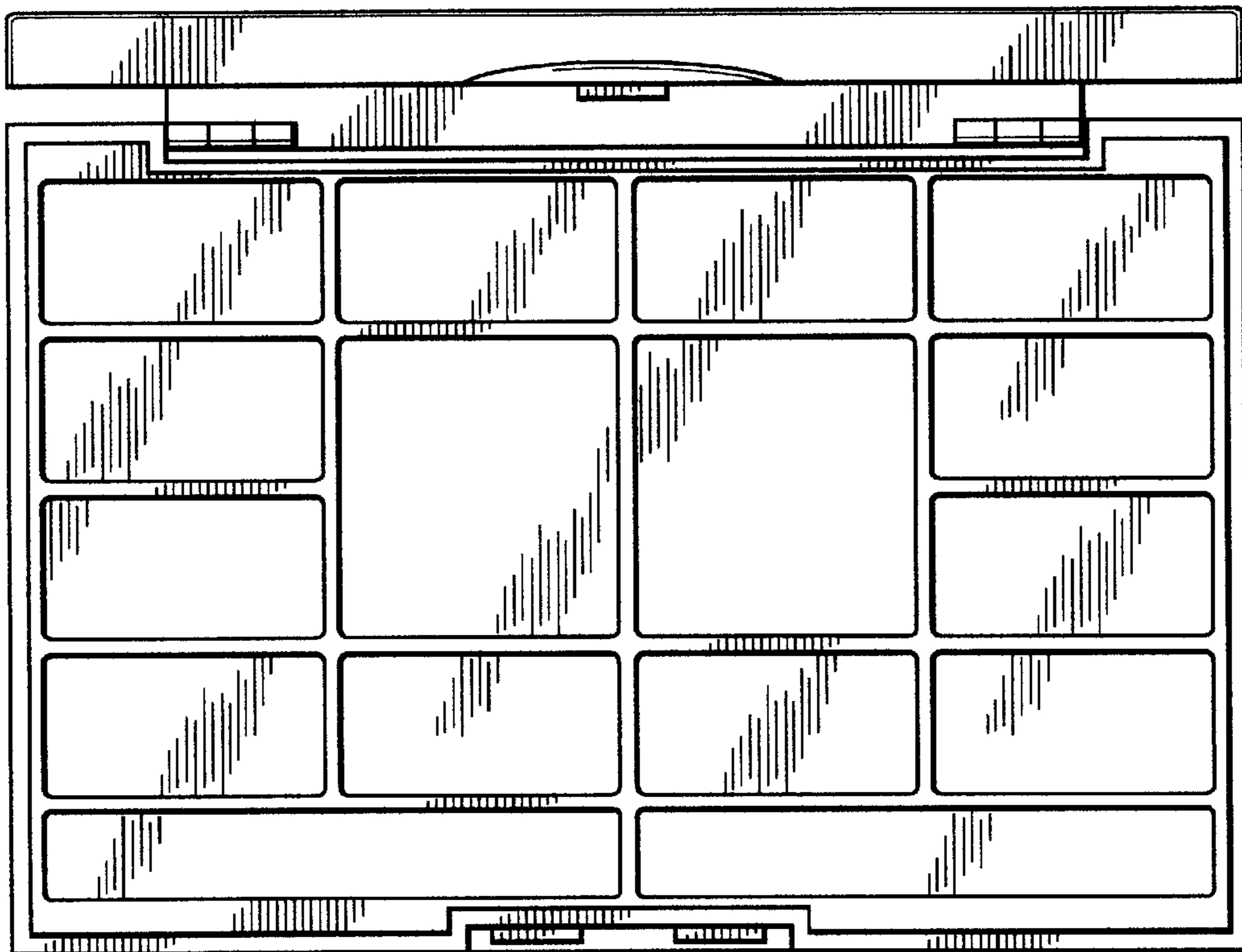

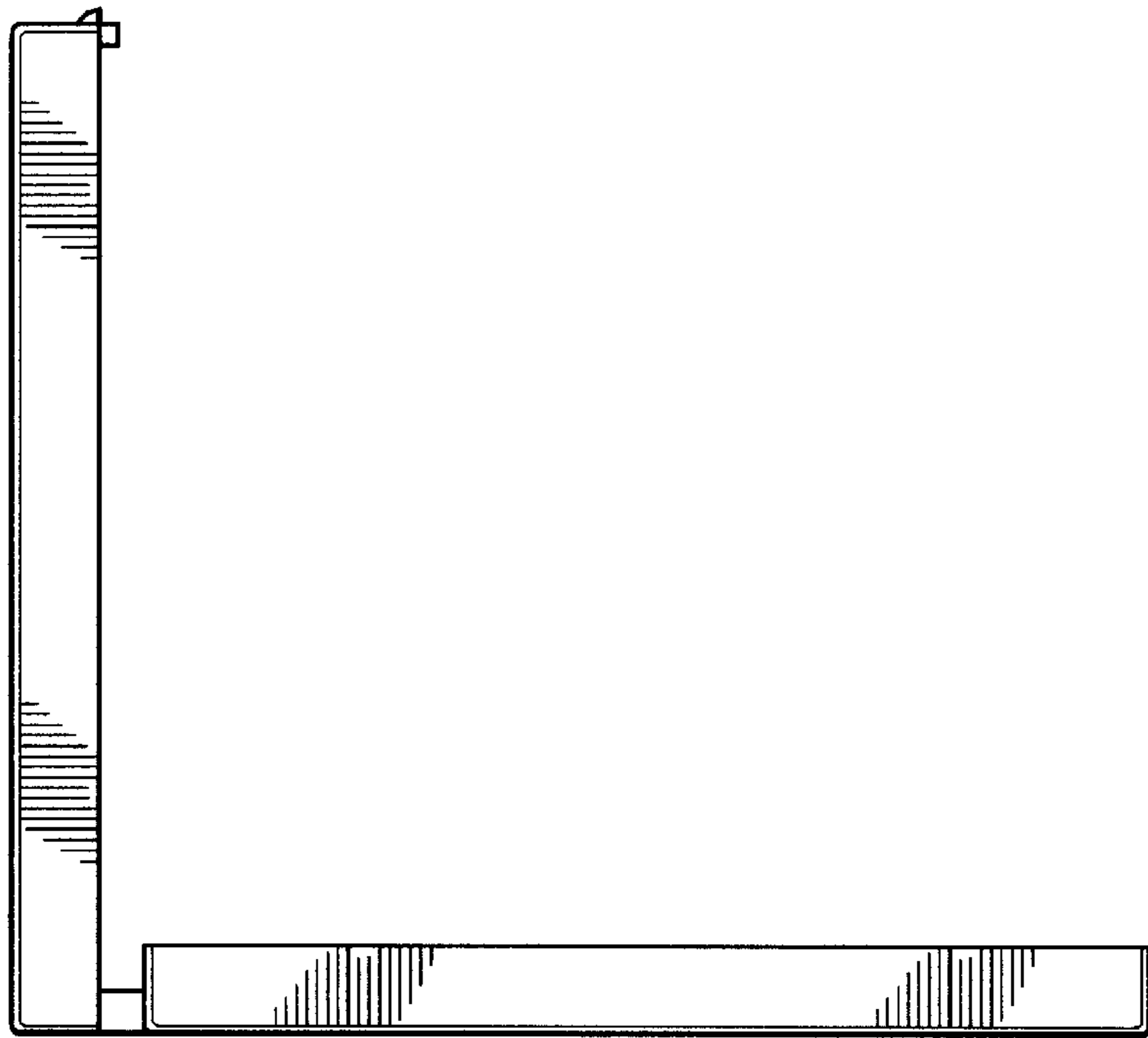

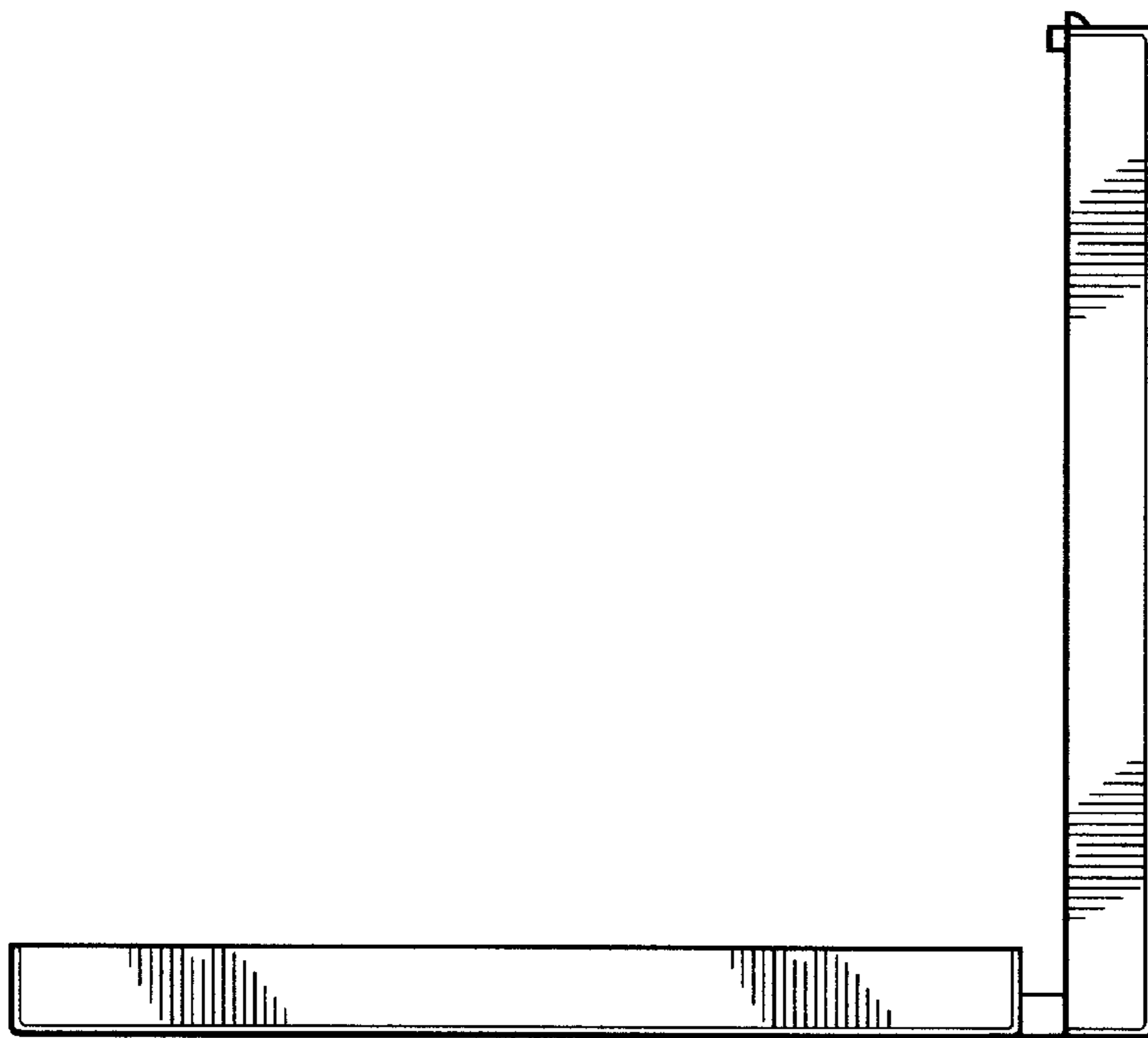

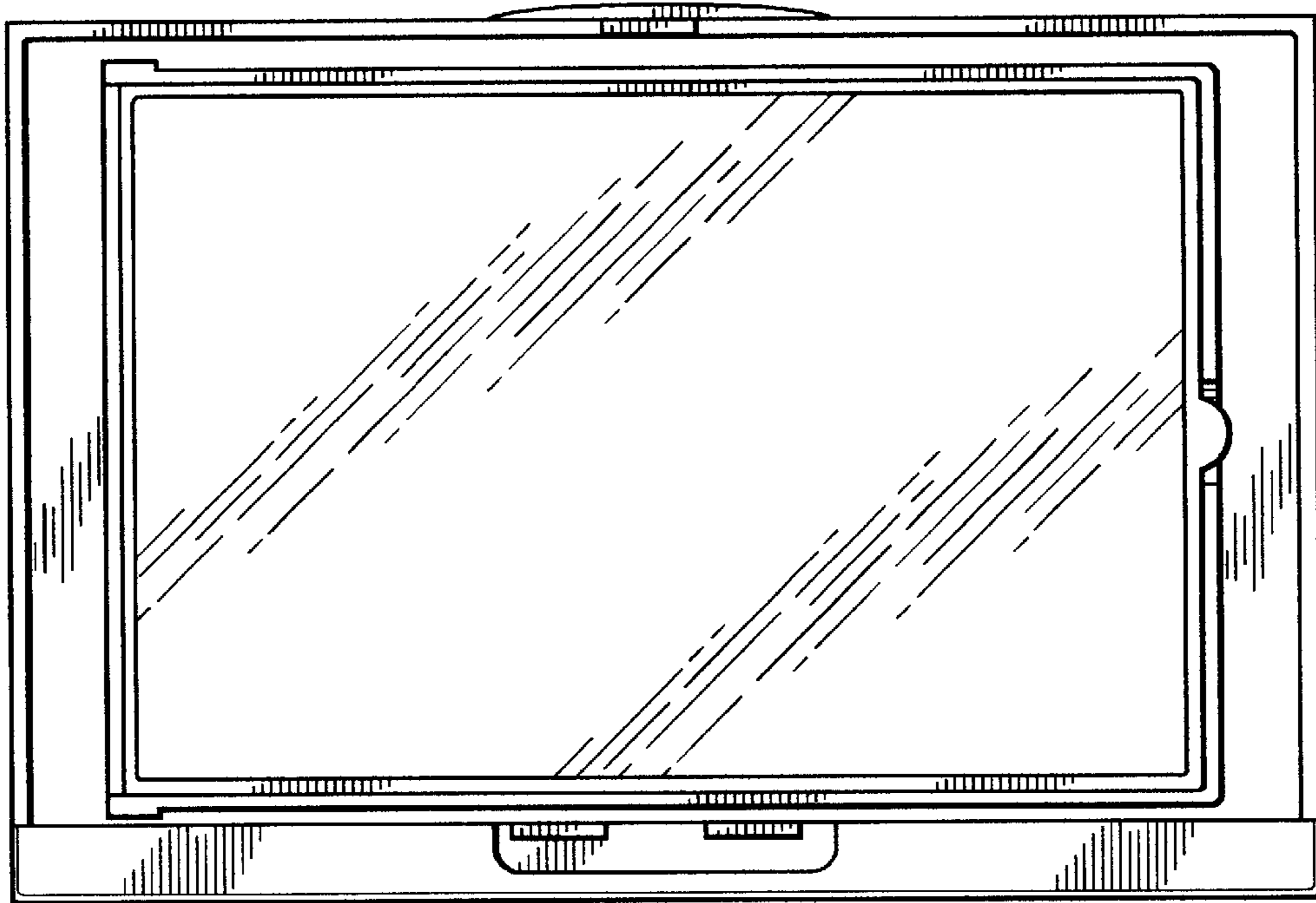

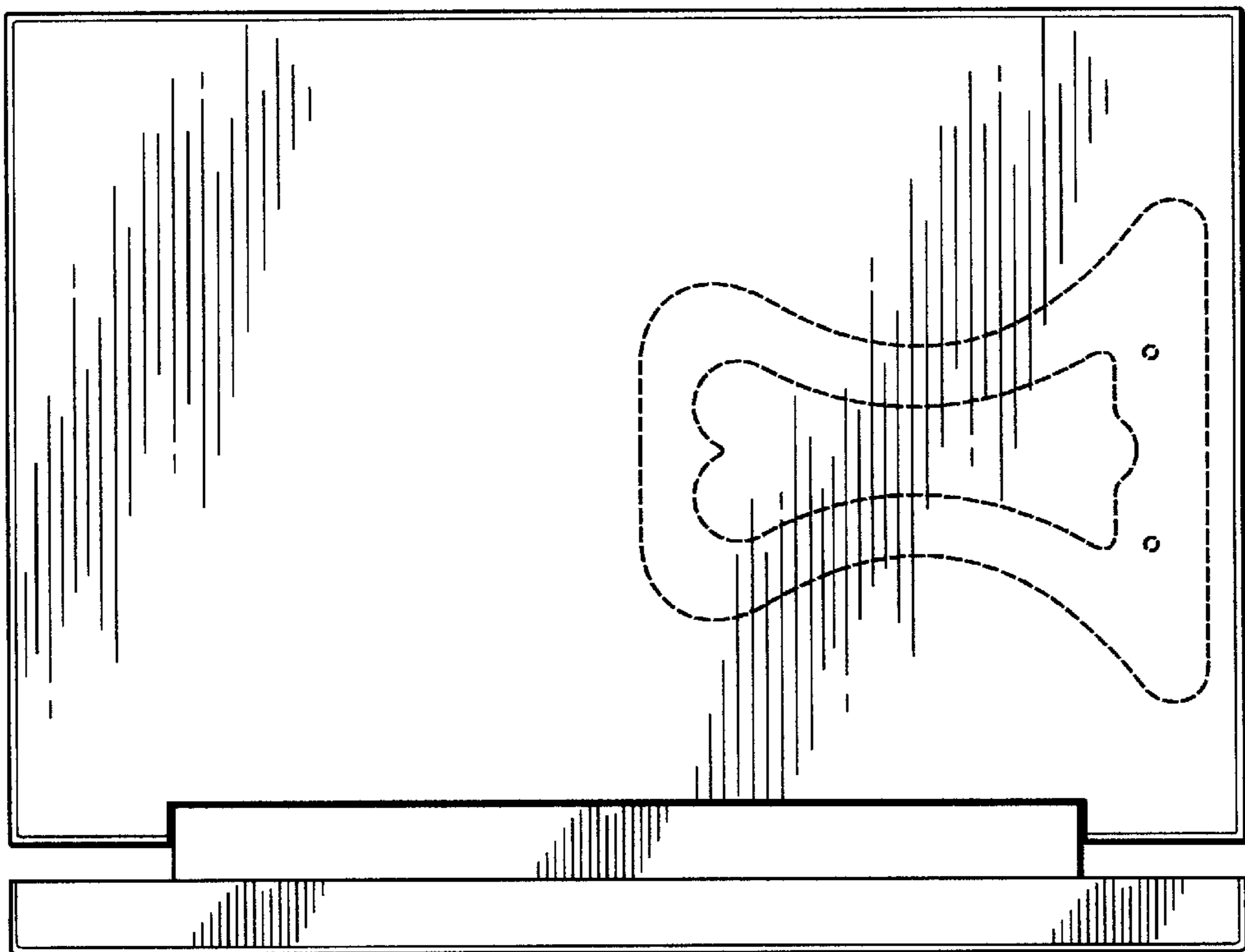
