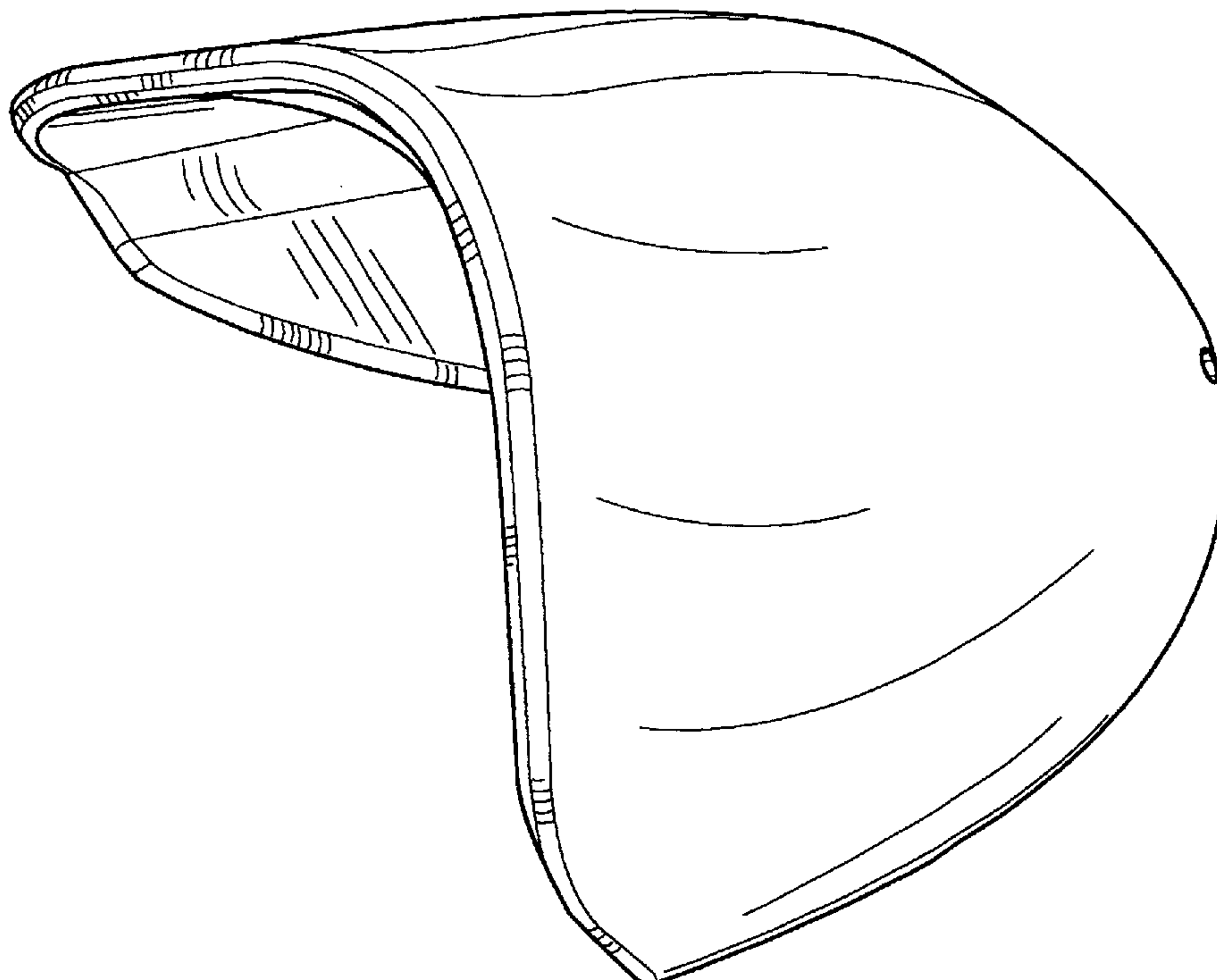
(57) **CLAIM**

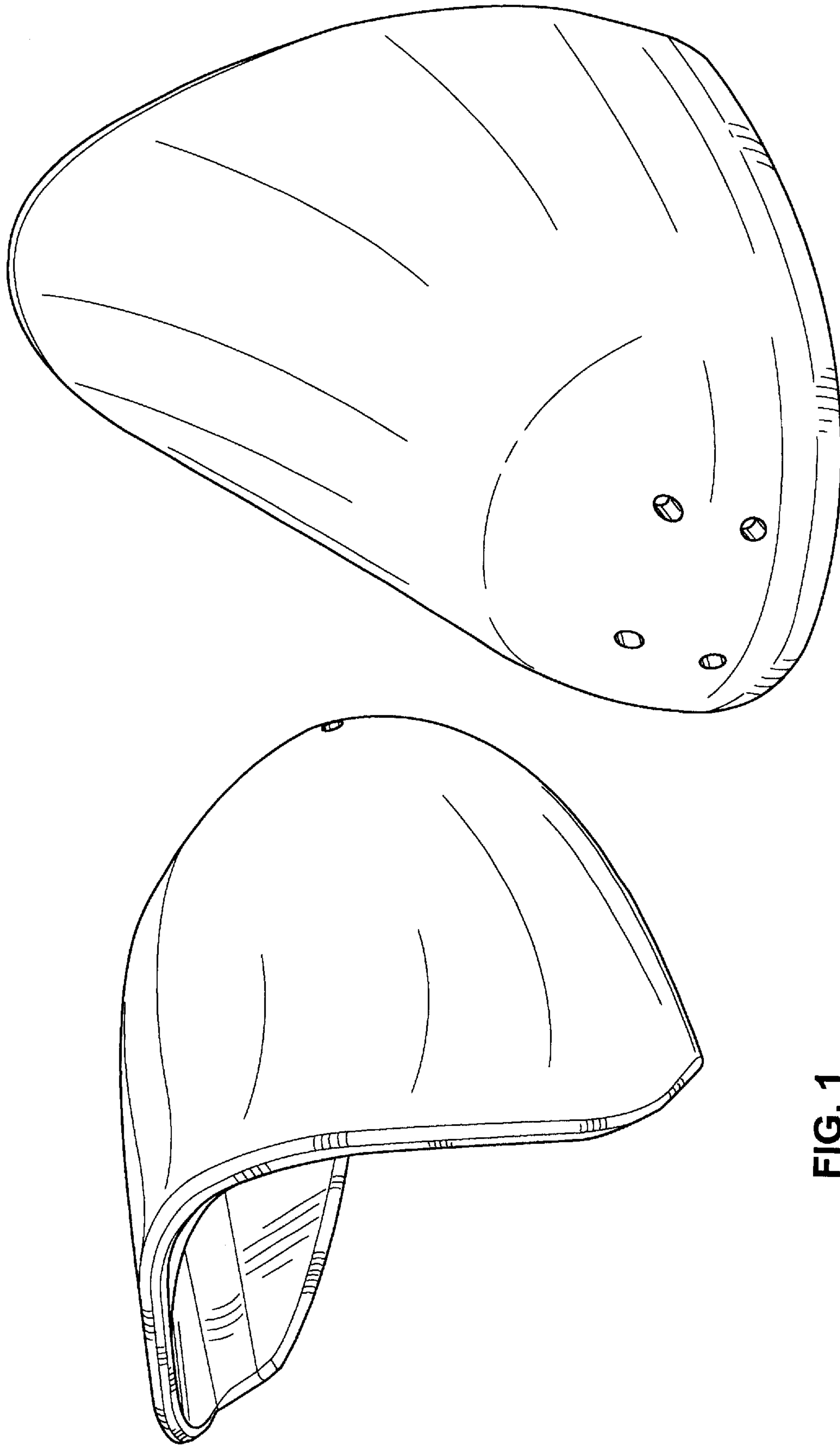
The ornamental design for an integral metatarsal toe protector, as shown and described.

**DESCRIPTION**

FIG. 1 is a back and left side perspective view thereof; FIG. 2 is a front and right side perspective view of an integral metatarsal toe protector showing our new design; FIG. 3 is a top plan view thereof; FIG. 4 is a bottom plan view thereof; FIG. 5 is a rear elevation view thereof; FIG. 6 is a front elevation view thereof; FIG. 7 is a right side elevation view thereof; and, FIG. 8 is a left side elevation view thereof.

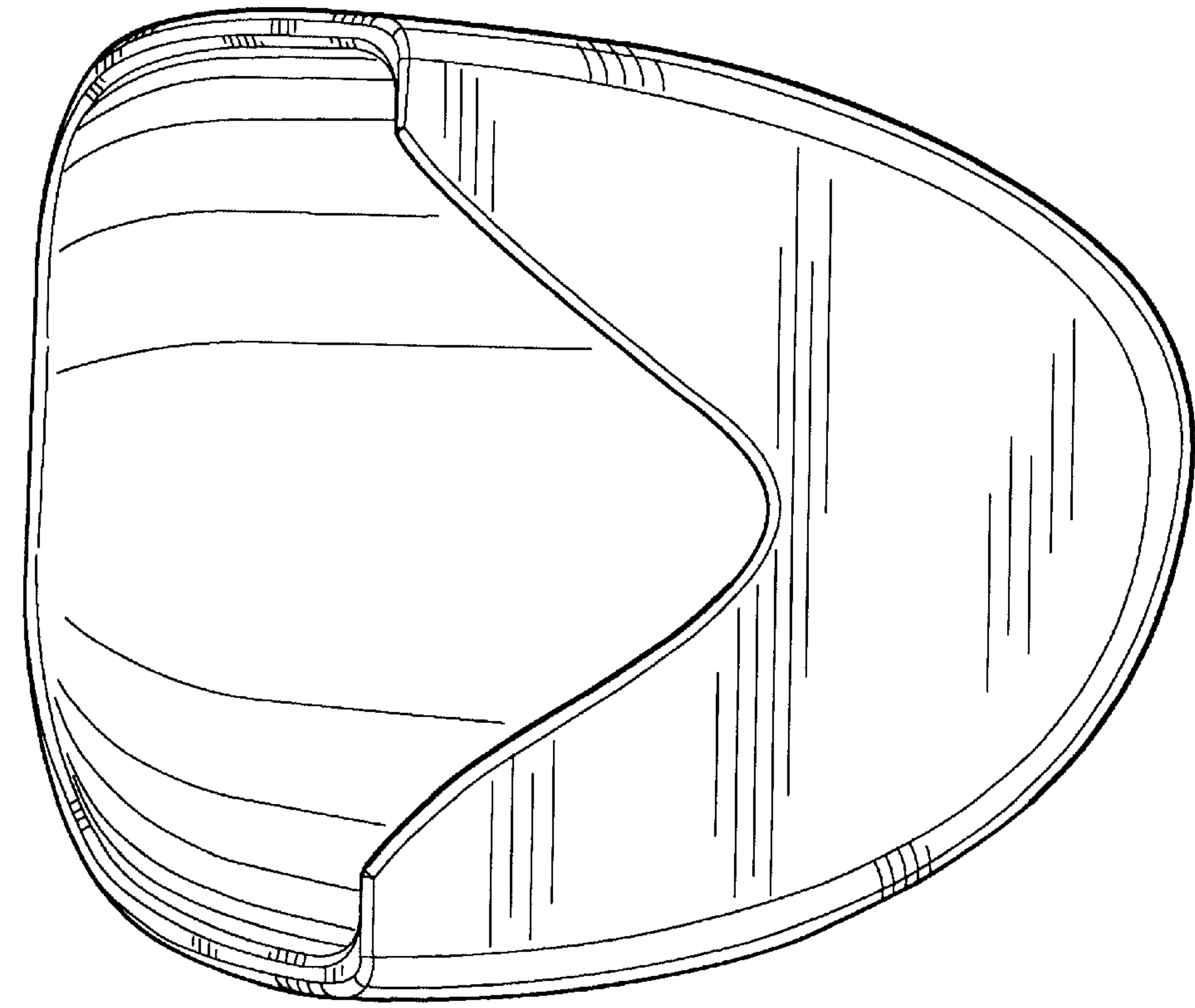

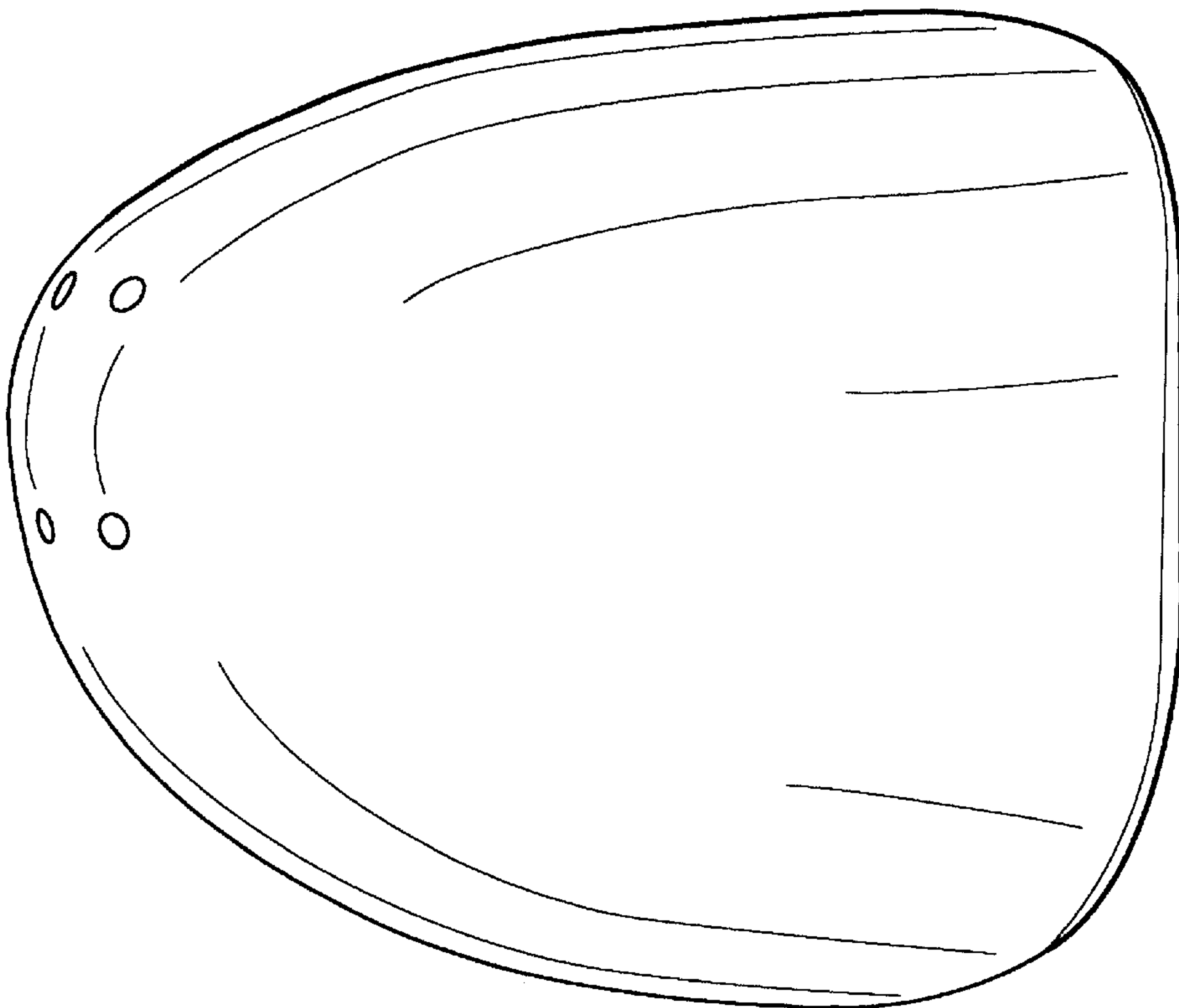

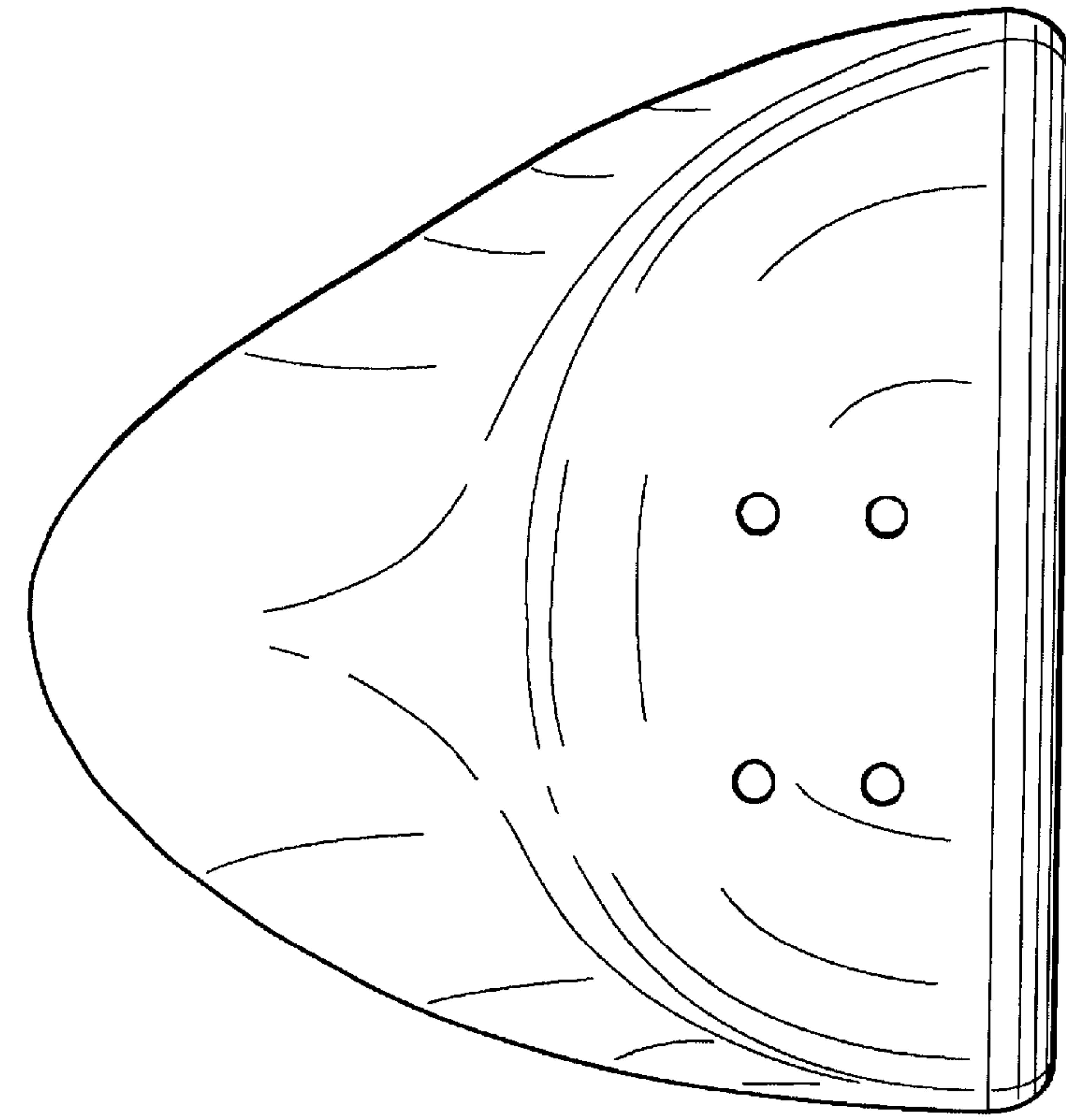

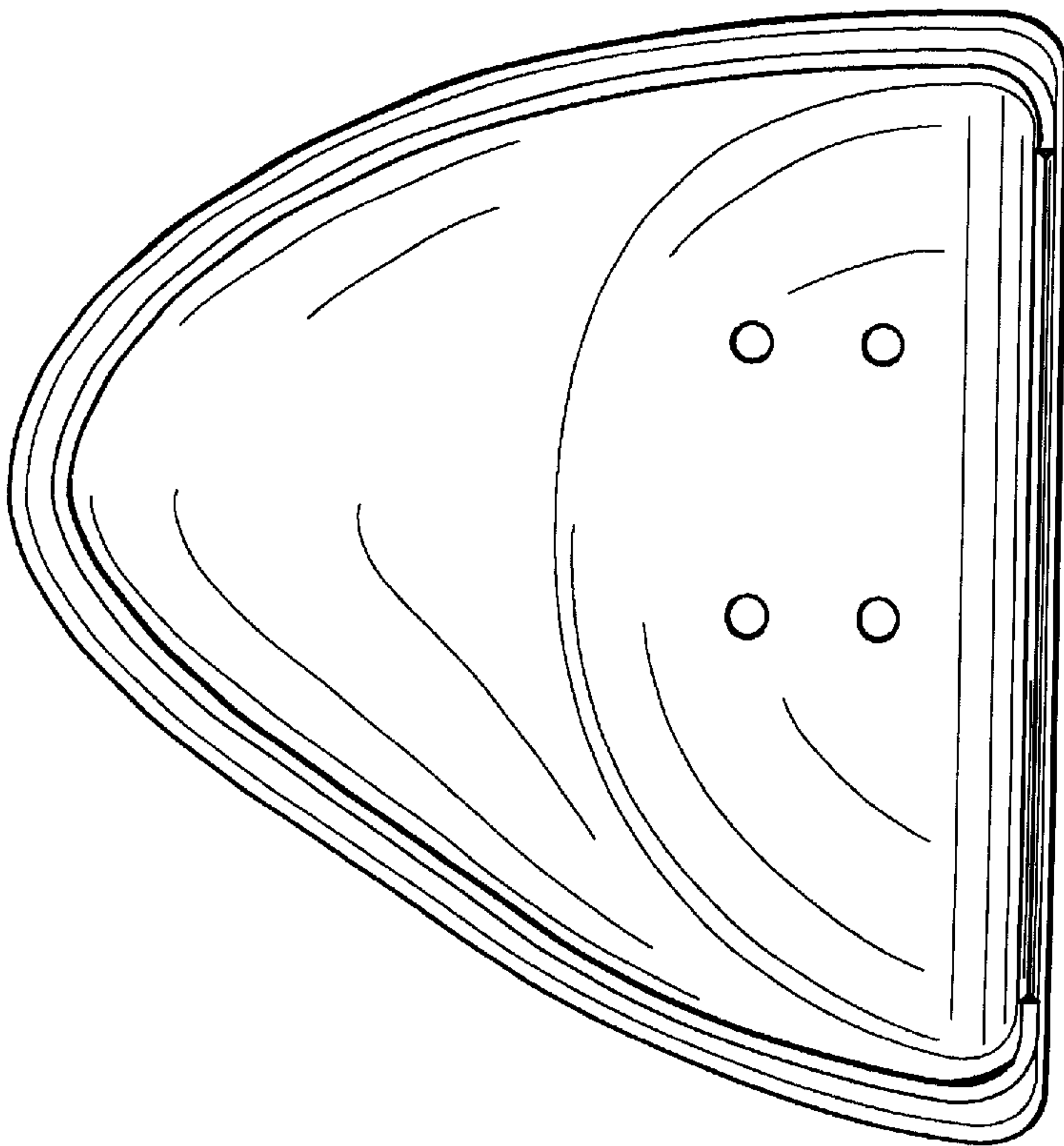

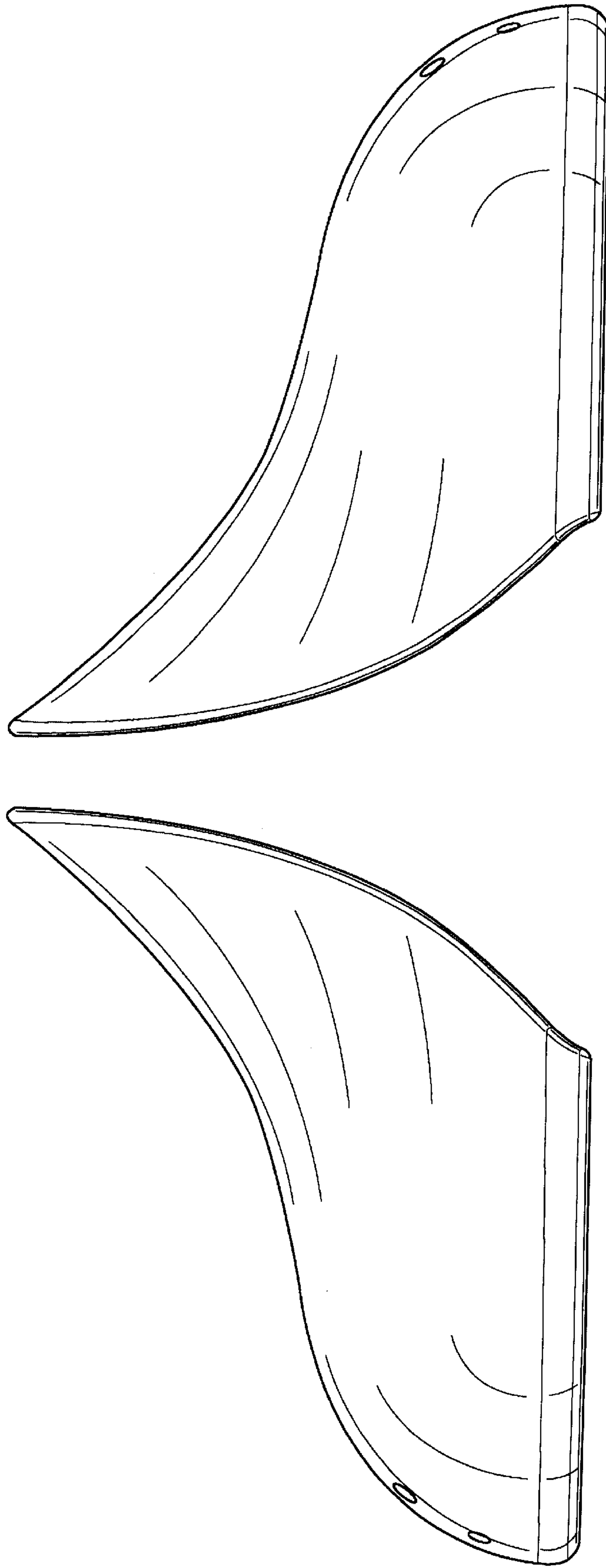
